Theory of one-dim ensional double-barrier quantum pump in two-frequency signal regime.

A one-dimensional system with two—like barriers or wells bi-chromatically oscillating at frequencies! and 2! is considered. The alternating signal leads to the direct current across the structure (even in a symmetric system). The properties of this quantum pump are studied in a wide range of the system parameters.

The quantum pump is a device that generates the stationary current under action of alternating voltage; it is a subject of num erous recent publications (for example, 1,2,3,4,5,6,7,8,9,10 . The quantum pump is essentially analogous to various versions of the photovoltaic e ect studied in details from the beginning of the eighties 11,12,13,14,15. The di erence is that the photovoltaic e ect is related to the emergence of a direct current in a hom ogeneous macroscopic medium (the only exception is the mesoscopic photovoltaice ect), while the pum p is a m icroscopic object. From the phenom enologicalpoint of view, the em ergence of a direct current in the pum p is not surprising, since any asym m etric m icrocontact can rectify ac voltage. However, analysis of adiabatic transport in the quantum -m echanical object leads to new phenomena, such as quantization of charge transport3. Just this, analytically solvable, adiabatic approach was utilized in the most of studies of quantum pum $ps^{4,5,6}$. In the recent papers we have carried out the extensive study of the sim plest model of the one-dimensional quantum pump, containing two delta-like harm onically oscillating barriers/wells. This model demonstrates rich behavior which is ruled by a variety of system parameters. The present paper deals with similar system to which alternating bi-chrom atic voltages are applied. The system can be exemplied by a quantum wire with two narrow gates. The stationary bias between the source and the drain is supposedly absent.

The system has a variety of regimes of the pump operation, depending on the system parameters, e.g. frequency

and am plitudes. The e ect is sensitive to the phase coherence of alternating signals and can exist even in symmetric systems. The stationary current is possible also in the case of dierent am plitudes of alternating elds. We have studied the system both analytically and numerically. The analytical approach is based on the perturbational (with respect to am plitudes (u_{ij}) of a.c. signal) consideration. The current contains independent contributions caused by u_{ij} and an interference term. The elastic, absorption and em ission channels participate in the process. The case of strong alternating signal was studied numerically.

W em ostly concentrate on the case of sym m etric system as m ore interesting by its phase sensitivity.

Basic Equations

The considered model is described by the onedimensional time-dependent potential:

where t is the time, 2d is the distance between -barriers (wells); quantities u_{ij} are measured in units of h=m d (m is the electron mass); p, E, and ! are the momentum, energy, and frequency measured in units of h=d, $h^2=2m$ d^2 , and h=2m d^2 , respectively.

The solution to the Schrodinger equation with the potential (1) is searched in the form

Here, $p_n = \frac{p}{p^2 + n!}$ and $p = \frac{p}{E}$. The wave function (2) corresponds to the wave incident on the barrier from the left. (In the nal form ulas, we mark the directions of incident waves by the indices "! " and " "). The form of solution (2) corresponds to absorption (for n > 0) or em ission (n < 0) of n = 10 quanta by an electron after

the elastic process. Quantities t_n and r_n give the corresponding amplitudes of transmission (rejection). If the value of p_n becomes imaginary, the waves moving away from the barriers should be treated as damped waves, so that $\text{Im } p_n > 0$.

The transm ission amplitudes obey the equations: $t_n =$

and

Here, $g_n = \sin 2p_n = p_n$.

Provided that electrons from the right and left of the pump are in equilibrium, and that they have identical chemical potentials, the stationary current is

where f(E) is the Ferm i distribution function, and (x) is the H eaviside step function. The current is determined by the transmission coe cients with real p_n only.

At a low temperature, it is convenient to di erentiate the current with respect to the chemical potential:

Here G $_0$ = e^2 = h is the conductance quantum and p_F is the Ferm i m om entum . The resultant quantity G can be treated as a two-term inalphotoconductance (the conductance for simultaneous change of chemical potentials of source and drain).

Perturbations theory

In low-amplitude limit the stationary current (its derivative G) is proportional to

Let's consider the case of sym m etric system with $u_{11} = u_{21} = u$; $u_{12} = u_{22} = v$. The system s sym m etry leads to the dependence G / u^2v . This contribution arises

from corresponding terms in the transmission coecients T_0 ; T_1 ; T_2 :

The quantities A_0 , A_1 , B_1 , A_2 , B_2 depend on g_1 , g_2 which contains one—and two-photon singularities. The calculations support this dependence.

N um erical results




FIG. 1: The derivative of the G versus the Ferm im om entum . Here $u_{11}=u_{12}=1$; $u_{21}=u_{22}=1$; !=2. The left delta-function oscillates from the barrier to zero hight, the right delta-function corresponds to well whose depth changes from zero value

The gures 1-5 show typical plots of the derivative of the stationary current with respect to the Ferm i energy $@J=@E_F=G$ $2e^2=h$ as a function of the Ferm im om entum (Figs. 1-3), the am plitude (Fig. 4) and the frequency (Fig. 5).




FIG. 2: The dependence of G on the Ferm im om entum. We set $u_{11}=u_{12}=2$; $u_{21}=u_{22}=1$; !=2.

The gures 1-3 present the quantity G as a function of the Ferm i m omentum for $u_{21}=u_{22}=1$; ! = 2 and $u_{11}=u_{12}=1$ (Fig. 1), 2 (Fig. 2). The peaks of the curves correspond to the multi-photon threshold resonances with zero energy state. The increasing of $u_{11}=u_{12}$ leads to the strengthening of multi-photon sinquarities.

The curve in the Fig. 1 corresponds to antipodal signals with same amplitudes ($u_{12} = u_{22}$), that demonstrate the importance of the phase coherency of the signals (in such conditions the stationary current in the same system under monochrom atic voltage is vanishing⁹). The current oscillates with the Fermin on enturn due to the interference of the electron waves in the structure. Besides, the current possesses singularities caused by the

resonances with the zero energy state and their photon repetitions.

The gure 3 shows the behavior of G for large enough frequency where the only threshold singularity exists in the concerned range of Ferm im om entum values.

The gure 4 depicts G versus u_{11} for the symmetric system ($u_{11}=u_{12}=u_{21}=u_{22}$). These values are chosen so that there should be no current caused by harmonic signals only (if $u_{11}=u_{21} \in 0$; $u_{12}=u_{22}=0$ or $u_{11}=u_{21}=0$; $u_{12}=u_{22} \in 0$).

Besides, the current vanishes in the adiabatic approximation which is commonly used for consideration of quantum pumps. In the adiabatic regime the charge transfer per a cycle is proportional to the area covered by two parameters in the phase space. In our case the parameters are fu₁ (t); u₂ (t)g. If u₁₁ = u₁₂ = u₂₁ = u₂₂ the trajectory in the phase space fu₁ (t); u₂ (t)g is a straight line and covers zero area (see insert). Hence in the adiabatic (! ! 0) approximation G=! ! 0.

At low $u_{ij} G / u_!^2 u_{2!}$. This behavior corresponds to coherent photovoltaic e ect¹⁶. At large u_{ij} the amplitude dependence exhibits distinctive oscillations which




FIG. 3: G versus the Ferm im om entum; $u_{11} = u_{12} = 2$; $u_{21} = u_{22} = 1$; ! = 50 and di event $u_{11} = u_{12}$. The singularity at $p_F = 7$:1 corresponds to the single-photon threshold $p_F = 7$:1.




FIG. 4: The dependence of G on the amplitudes $u_{11}=u_{12}=u_{21}=u_{22}$ for $p_F=0.7$ and dierent signal frequencies. For $u_{ij} ! 0$, G / u_{11}^3 . Insert: trajectory in the phase space fu₁ (t); u_2 (t)g. The enclosed area in the phase space is zero.

are determ ined by the commensurability of the characteristic wavelength of excited electrons with the distance between delta-functions. The curves for dierent frequencies demonstrate splitting and beating of oscillations. Their amplitude decays with $u_{\rm ij}$. The oscillations period changes with the frequency.

The gure 5 dem onstrates the dependence of G on the frequency. The complicated structure of G in the low frequency region is explained by multi-photon resonances reducing for larger frequencies.

Conclusions

The alternating voltage produces the stationary current by pumping electrons between leads x < d and x > d. The e ect is sensitive to the phase coherence of alternating signals and can exist even in symmetric systems. The stationary current is possible also in the case of dierent amplitudes of alternating elds.

We have studied the system both analytically and numerically. The analytical approach is based on the perturbational (with respect to amplitudes of a consistent)




FIG. 5: The dependence of G on the frequency for $u_{11} = u_{12} = 1$, $u_{21} = u_{22} = 1$, $p_F = 0.7$.

consideration. The current contains independent contributions caused by u_{ij} and an interference term . The elastic, absorption and emission channels participate in the

process. The case of strong alternating signal was studied num erically.

Our calculations show that the stationary current is a sophisticated function of the param eters, that re ects the interference e ects, presence of virtual states, and threshold singularities.

The motivation to consider the symmetric case is that in this case the stationary current caused by a single frequency is suppressed. Only two intercoherent frequencies can cause the stationary current. Hence, the system with specially symmetrized barriers can be used for heterodyning of signals with! and 2! frequencies and for frequency binding of similar laser sources. The controllability of the system permits to realize the symmetric conditions intentionally with good accuracy.
