Quantum quenches in a spinor condensate

We discuss the ordering of a spin-1 condensate when quenched from its param agnetic phase to its ferrom agnetic phase by reducing magnetic eld. We rst elucidate the nature of the equilibrium quantum phase transition, which has a multicritical point when the magnetization in the direction of the eld vanishes. Quenching through this transition reveals XY ordering either at a speci c wavevector, or the light-cone' correlations familiar from relativistic theories, depending on the endpoint of the quench. The creation of vortices through grow th of the magnetization uctuations is also discussed. The long time dynamics again depends on the endpoint, conserving the order param eter in zero eld, but not at nite eld, with di ering exponents for the coarsening of magnetic order. The results are discussed in the light of a recent experim ent by Sadler et al.

How does a many-particle system undergo condensation into an ordered state? This question is central to a number of disparate areas of physics, from condensed m atter to cosm ology [1, 2]. O ften we are interested in the processes determ ining the form ation of ordered dom ains and topological defects. The usual approach is to study the coupled dynam ics of the collective (or hydrodynam ic) degrees of freedom, including the order param eter and any conserved quantities. Thus the dynam ics is highly constrained by the presence or absence of conservation law s, with dram atic di erences in the resulting tim e evolution of correlations. Further, there exists the possibility of quenching into an ordered state at zero tem perature through a quantum phase transition [3, 4].

Such a possibility was explored in a recent experiment that studied ferrom agnetic ordering in a Bose-Einstein condensate of ⁸⁷Rb atoms following a sudden reduction in magnetic eld §]. Cold atom ic gases represent an exciting new prospect for the investigation of such quantum quenches. As we will show, they represent a far closer analog of relativistic theories then do the condensed matter systems suggested for 'laboratory cosm ology' by Zurek and reviewed in Ref. [6]

Earlier, mostly numerical work [7, 8, 9, 10, 11] has focused on treating the creation of spin dom ains in condensates as a property of a classical dynam ical system . We will see that the uctuation region where this kind of mean-eld treatment fails is very small for systems currently realized, so such treatm ents are certainly valid. Our goal in this Letter, on the other hand, is to rst explain the character of the equilibrium quantum phase transition, and then to discuss the associated dynam ics as a problem of phase ordering. In particular, this will lead us to carefully distinguish di erent quenches in term s of the conservation law s obeyed, and the resulting dynam ics of topological defects (vortices in the m agnetization). It will also allow us to compare the predictions for quenches proceeding at a nite rate to known results in the cosm ological literature [6].

The existence of an ordering transition in the ferro-




FIG.1: Zero tem perature phase diagram of a spin-1 condensate in terms of the linear and quadratic Zeem an energies. The shaded area corresponds to the region of XY ordering. The experiment of Ref. [5] involved a quench through the multicritical point (red dot) from the param agnetic region.

m agnetic spin-1 Bose gas is readily understood on the basis of a variational G ross-P itaevskii calculation [12]. The second-quantized H am iltonian is [13]

The index m = 1;0;1 gives the z-component of total spin of the corresponding state, and we have set ~ and the atom icm ass to unity. F_{mn}^{i} are the spin-1 m atrices for i = x;y;z. $U_{ext}(r)$ is a spin-independent potential and E_{m}^{Z} is the Zeem an energy of the m-component, de ned below. For a ferrom agnetic system the spin interaction parameter c_{2} is negative.

Ignoring $U_{ext}(r)$ from now on, we implement the Gross-Pitaevskii approximation by treating the mascnumbers m! 'm and writing 'm = $\frac{P}{n}$ m'm in terms

In fact the coe cient p in Eq. (2) is the sum of the linear Zeem an term and a Lagrange multiplier enforcing conservation of F_z . We should minimize Eq. (2) and then use the true value of the magnetization hF_z to

x p. Thus with zero total magnetization we will have p = 0. In this case it is straightforward to see that for $q > q_0$ 2jg in the spinor state $^{y} = (0;1;0)$ m inimizes the energy, while for $q < q_0$ the 1 states become populated, leading to a transverse magnetization density f_2 (r) $f^x(r) + if^y(r)$, where $f^i(r) = \int_m^y (r)F_{mnnn}^i(r)$. In the general case $p \in 0$ [14]

showing that $\underline{hf}_{?}$ i is nonzero between the lines $\dot{p}_{j} = q$ and $\dot{p}_{j} = q(q q)$ (see Fig. 1). Thus the mean-eld calculation predicts a sym metry-breaking quantum phase transition (note the usual square root grow th in the order parameter below the transition). For $p \in 0$, there is also a perpendicular magnetization in this region

and the ordered phase is a canted XY ferrom agnet [15].

W e now ask in m ore detailwhat kind of quantum phase transition we are dealing with. This is more than a formal question, as the dynamics of the order parameter at the transition will be crucial in determining the behavior following a quench. We start by considering the Bogoliubov theory of the paramagnetic phase. Shifting the elds m in Eq. (1) by $'^{y} = (0; n; 0)$ we nd that in the quadratic part of the H am iltonian the 1 states decouple from the 0 state to give

where E_s ; $(k) = E_s(k)$ p, with the spin wave dispersion $E_s^2(k) = ("_k + q) ("_k + q + 2c_2n)$. One of these dispersions passes through zero when $jr = p_c$ q(q q), the same instability of the param agnetic phase that we found before. Except at p = 0 the transition to the ordered state proceeds by lling of either the particle' or hole' band in Eq. (5), and may be viewed as the bose condensation of m agnons. When p = 0, the transition occurs through closing of the bandgap.

To make a connection to the general theory of quantum phase transitions, we rewrite the Ham iltonian Eq. (5) using the (com plex) canonical coordinates and conjugate momenta

Eq. (6) is recognized as the Hamiltonian of a twodimensional particle in a uniform perpendicular magnetic eld and harm onic oscillator potential.

How do we interpret the eld z? The Fourier modes of the transverse magnetization density $f_{?}$ (r) may be written in terms of z_k as

where the dotted lines denote higher order term s. At low k the two are simply proportional, as one would hope.

Below the transition, the higher order terms dropped from the Ham iltonian Eq. (4) are required to saturate the growth of f_2 (r). Close enough to the transition a quartic term is su cient. The derivation of this term within the Bogoliubov theory is slightly subtle as it involves the partial cancellation of the direct' quartic interaction neglected in Eq. (4) against the interaction induced by phonons [16]. We write the nal result as an elective action valid near the transition, and for length scales long compared to q ¹⁻² and time scales [26].

To obtain the quadratic part of Eq. (7) from Eq. (6) we have approximated the spectrum as

 $\rm S_e$ is identical to the elective theory describing the super uid-insulator transition in the Bose-Hubbard model. As in that problem, the point $\rm p=0$ is identi-

ed as a multicritical point where the transition, instead of being of the bose condensation type, lies in the universality class of the (d + 1)-dimensional XY model [17]. It is relevant to ask whether the deviations from mean

eld critical behavior in plied by this identi cation will be seen in experiment. For a two-dimensional condensate a standard calculation gives the G inzburg criterion for the breakdown of mean eld behavior [6]

where L_2 is the transverse dimension. Since for the system in Ref. [5] the prefactor is of order 10⁴, the mean eld theory is an excellent approximation.

W ith this mind, we now proceed to describe the evolution of a system that is quenched suddenly through the transition. A system with nite hF_z i is always ordered at zero temperature, so to cross the transition we must consider the case p = 0 of zero magnetization, as in Ref. [5]. For $q < q_0$ we have a band of unstable modes with $E_s^2(k) < 0$. The occupancy of these modes begins to grow exponentially, as they are populated with pairs of atom s scattering from the m = 0 state. The quadratic H am iltonian Eq. (5) describes this process adequately until the populations are such that the anham onic interactions between the modes become s important. W riting $!_k^2 = E_s^2(k;q_f)$ we not the solution of the Heisenberg equations of motion for the elds z using Eq. (6)

The calculation of the correlation function of the transverse magnetization is then staightforward

revealing the exponential growth of the magnetization. The initial uctuations of the oscillator modes are 27]

Eq. (9) and Eq. (10) are general form ulae valid for an instantaneous quench between any points $q_i > q_0$ and $q_f < q_0$ [28]. In the following we will make the simpli – cation of taking $q_i = q_0$, which gives

Now we wish to focus on two particular values of q_f to illustrate the dimension of two particular values of q_f to illustrate the dimension of unstable modes is $\binom{2}{k} = \texttt{"}_k (q_0 \texttt{"}_k)$, which has a maximum at $k = \binom{p}{q_0}$. The correlation function is therefore dominated by the uctuations on this scale that grow at a rate q_0 . Taking into account only the unstable modes, we may not for the asymptotic behavior of the real space correlations

The Bessel function is just an angular average of plane waves of wavevector $q_0^{1=2}$. The result is a growing random spin texture of typical scale $q_0^{1=2}$, as observed in R ef. [5]. Note that the vanishing of the mode grow th rate at zero wavevector is a consequence of the conservation of all three spin components in zero eld.

Very di erent behavior results if q is only just below q_0 . In this case the spectrum of unstable modes rejects the relativistic form of Eq. (8)

valid when the exponent is large. The correlation function Eq. (11) displays a striking growth of correlations along a light cone' originating at a point halfway between r and r⁰ and propagating at the spin wave velocity c_s . This is a familiar feature of spinodal instabilities in relativistic theories [18]. The crossover between these two types of behavior occurs at the value $q_f = q_0=2$,

where the maximum in the spectrum of unstable modes $k_{max} = \frac{p}{q_D} - \frac{2q}{2q}$ goes to zero.

N ext we discuss what happens if the quench is not instantaneous, but rather crosses the transition in some nite time. For concreteness we take $q(t) = q_0 (1 = t_0)$, where $_Q$ measures the duration of the quench, and the transition is crossed at t = 0. The result may be obtained exactly in terms of A iry functions, but the following integral representation is more useful

where we have introduced $t_{K\,Z}$ $_Q$ =q_0^2 $^{1=3}$. This expression can then be evaluated in the saddle-point approximation. At jr $r^0 j = 0$ we get an exponential factor exp $\frac{4}{3}$ (t=t_{K\,Z})^{3=2}. At this point we have to invoke for the rst time the e ect of the anharmonic interactions between modes. Very crudely, their e ect is to cut-o the exponential growth of the magnetization. We shall not try to discuss this process in detail, but the key point is that it occurs at a time / $t_{K\,Z}$, where the constant of proportionality may contain $t_{K\,Z}$, but only logarithm ically. The we readily see that the associated scale is

This result is consistent with the general arguments of K ibble and Zurek, which in ply a domain size scaling as $(_Q)^{\frac{1}{z}+1}$, with the mean eld values z = 1 and = 1=2 for the dynamic and correlation length exponents respectively [6].

The growth of the transverse m agnetization is associated with the appearance of vortices. As the population of the unstable m odes becomes large, the eld f_{i} (r) can be treated as an electively classical G aussian stochastic variable, with variance given by the correlation functions calculated above [19]. Then the density of vortices can be estimated using the Halperin-Liu-M azenko formula to calculate the density of zeroes of this classical eld n_{i} [20, 21]

Vortices may be hard to resolve in this case, however, having a core size of the same order as the scale of the m agnetic order. For a quench to just below the transition, on the other hand, the asymptote Eq. (11) gives

This behavior continues until the growth is saturated by the anhamonic term s, which happens when $jf_2 \ j^2$ 2n (q₀ q) = q_2 . Finally, in the case of the nite time quench, we have $n_V \ / \ ^2$ (t_{K Z}).

In closing, we brie y discuss the long-time behavior of the system, once the transverse magnetization is comparable to its equilibrium value. This regime is characterized by the growth of the characteristic ordering scale and the annihilation of topological defects, usually called coarsening. One can distinguish two universality classes depending on whether or not the order parameter is conserved [1]. In the rst case the dom ain size increases as

(t) / $t^{=2}$ [29], while in the second a $t^{1=3}$ law is obeyed. In our system these two cases correspond to a nalvalue $q_f \in 0$ or $q_f = 0$ respectively. Note that in Eq. (12) we get the $t^{1=2}$ behavior already at the linear level.

Things are not guaranteed to be this simple, how ever. Coarsening is usually studied using models of dissipative dynam ics, where energy is not conserved. On the other hand, coarse-graining of a purely H am iltonian system can give rise to such dynam ics, at the expense of introducing a conserved energy density to which the order parameter is coupled [22]. For the case of a real scalar non-conserved order parameter, Ham iltonian coarsening was examined Ref. [23], with the conclusion that the $t^{1=2}$ law was preserved (this case corresponds to M odel C in the classi cation of Ref. [22]). On the other hand, Ref. [24] studied coarsening in the Gross-Pitaevskii equation, where energy and additionally particle number are conserved (M odel F), and found results consistent with (t) / t. The dynam ics described by Eq. (7) corresponds to M odel F, except at the particle-hole sym m etric point p = 0 that has been our main concern, a special case called M odel E. To my know ledge, there are no studies of coarsening in this problem .
