D ichotom y in underdoped high T_c superconductors and spinon-dopon approach to $t-t^0-t^0-J$ m odel

W e studied underdoped high $T_{\rm c}$ superconductors using a spinon-dopon approach (or doped-carrier approach) to $t\!+\!t^0\!+\!t^0\!-\!J$ m odel, where spinon carries spin and dopon carries both spin and charge. In this approach, the m ixing of spinon and dopon describes superconductivity. We found that a nonuniform m ixing in k-space is most e ective in lowering the t^0 and t^0 hopping energy. We showed that at m ean-eld level, the m ixing is proportional to quasiparticle spectral weight Z. We also found a simple monte-carlo algorithm to calculate Z from the projected spinon-dopon wavefunction, which con rm s the mean-eld result. Thus the non-uniform m ixing caused by t^0 and $t^{\rm m}$ explains the di erent electron spectral weights near the nodal and anti-nodal points (i.e. the dichotom y) observed in underdoped high $T_{\rm c}$ superconductors. For hole-doped sam ple, we found that Z is enhanced in the nodal region and suppressed Z in the nodal region and enhanced in the anti-nodal region, in agreem ent with experim ental observations.

I. IN TRODUCTION

One powerful experimental technique to study high-T_c material is the Angular Resolved Photoem ission Spectroscopy (ARPES) [1]. ARPES study for the pseudogap region showed a strong anisotropy of the electron spectral function in momentum space [2, 3]. Basically it was found that in the nodal direction, excitations are more quasi-particle like; while in the anti-nodal direction, excitations have no quasi-particle peak. This is the so-called dichotom y. If one lowers the tem perature to let the material to go into superconducting phase, it was found that anti-nodal direction also has a sm all quasi-particle peak. Tunneling experiments show that the underdoped sam ples are inhom ogeneous [4 [6]. Due to this inhom ogeneity, it is possible that the underdoped sample can be separated into optim al doped regions and underdoped regions, and the quasi-particle peak only com es from the optim aldoped region. With such a point of view, it is possible that even the superconducting phase can have a very anisotropic electron spectral function in m om entum space.

Exact diagonalization on $t+0^{-}t^{0}-J$ model (t^{0} and t^{0} stand for next nearest neighbor and next next nearest neighbor, respectively) with 32 sites has been done[7,8] for hole-doped case (one hole doped). It was found that if $t^{0} = t^{0} = 0; J = 0.3t$, then the quasiparticle weight Z is alm ost a constant along the direction (;0)-(0;): Z = 0.311 at (=2; =2), and Z = 0.342 at (;0). However if one put in $t^{0} = 0.3t; t^{00} = 0.2t; J = 0.3t$, which is an optimal parameter thing for SgCuO₂Cl₂, then there is a strong dichotom y feature: Z = 0.353 at (=2; =2), and Z = 0.029 at (;0). This suggests that

the dichotom y can be a result of t^0 and t^{00} hopping.

Exact diagonalization was also done for the electron doped case (a few electrons doped on 32 sites) [8], where Z_+ was measured. Due to the particle-hole symmetry at half-lling, we know that if $t = t^0 = 0$, Z_+ and Z_- are equal up to a momentum shift of (;). Therefore Z_+ are also at along the direction (;0)-(0;) in pure t-J model. But when we put in $t^0 = 0.3t; t^0 = 0.2t; J = 0.3t$, the particle-hole symmetry was broken. Z_+ was found to develop a strong anisotropy along (;0)-(0;): $Z_+ = 0.005$ at (=2; =2), and $Z_+ = 0.636$ at (;0).

W hat mechanism can destroy the quasi-particle coherence in the anti-nodal region? The sim plest thing com es into one's mind is that we need some other things to destroy it. For example, neutron scattering experiments indicate that there are some low energy magnetic

uctuations[9{12], and it was proposed [2, 3] that m agnon scattering process can destroy the quasi-particle coherence in anti-nodal region. In this paper, however, we propose a physically di erent scenario: The dichotom y is due to the t^0 and t^0 hopping term s. The quasiparticle spectral weight Z_k is naturally suppressed in some region in k-space to lower the t^0 and t'' hopping energy. This contradicts a naive thinking that hopping always enhance Z_k . U sing the $t+t^0-t^{0}-J$ m odel, we will show that the new scenario can explain the distribution of Z_k for both hole-doped and electron-doped samples in a uni ed way.

If we believe that the dichotom y is driven by the t^0 and t^0 hopping term s, then there is an important issue: Is there a mean- eld theory and the corresponding trial wavefunction that captures this mechanism?

O ne way to understand high- T_c superconductors is to view them as doped M ott-insulators. Under Zhang-R ice singlet m apping [13], the m inim alm odel which includes the essential M ott physics is t-J m odel on square lattice. O n the analytical side, a powerfulm ean- eld theory for

t-J m odel, the slave-boson approach, was developed [14{ 16]. This approach emphasizes the fractionalization picture of the doped M ott insulator: electron is splited into a spinon (a ferm ion with spin and no charge) and a holon (a boson with charge and no spin), which characterize the low energy excitations of the doped M ott insulator. This m ean- eld approach also successfully predicted the pseudogap m etal for underdoped sam ples. On the num erical side, the same physics picture gives rise to the projected BCS wavefunction [17] (pBCSwf), which turns out to be a very good trial wavefunction for t-J m odel. How ever, m ore detailed studies of pBCSw f[18, 19] indicate that the slave-boson approach fail to explain the dichotom y. So a m om entum dependent quasiparticle weight Z_k rem ains to be a big challenge for slave-boson theory.

In this paper, we will use a new spinon-dopon approach [20] and the corresponding trial wavefunction to study the underdoped samples. Instead of using spinons and holons, in the new approach, we use the spinons and the bond states of spinons and holons to describe the low energy excitations. The bond states of spinons and holons are called dopons which are chargespin- $\frac{1}{2}$ ferm ions. The spinon-dopon approach leads to a new trial wavefunction, the projected spinon-dopon wave function (pSD w f). The new trial wave function turns out to be an improvement over the old projected BCS wavefunction (pBC Sw f).

The holon condensation in slave-boson approach correspond to spinon-dopon mixing. However, in the spinondopon approach, the mixing can have a momentum dependence, which is beyond the mean- eld slave-boson approach. If we set the mixing to have no momentum dependence, then the pSD wf turns out to be identical to the old pBC Swf. So the pSD wf is a generalization of the pBC Swf.

Now the question is, why the mixing wants to have strong momentum dependence? The answer is that the wavefunction with momentum dependent mixing can m ake the hopping m ore coherent, and therefore gain hopping energy. Roughly speaking, the pSD w fw ith m om entum dependent mixing is the sum mation of the old projected BCS wavefunction together with hopping terms c^y_ic_i acting on it. Here one should notice that the old pBC Sw f, with uniform mixing, already has a pretty good t hopping energy. But to have a good t^0 and t^{00} hopping energy, the mixing needs to have a momentum dependence, along the direction from (;0) to (0;). Our M onte C arlo calculation shows that pSD w fw ith m om entum dependent mixing is indeed a better trial wavefunction in energetic sense. To get a quantitative sense how big is the improvement, we nd that the energy of a doped hole in pSD wf is about 0:4t lower than that of a doped hole in pBCSwf. This is a very big im provem ent, indicating that the spin-charge correlation (or more precisely, the spin con guration near a doped hole) is much better described by pSD w f than pBC Sw f.

C an one measure the momentum dependence of mixing? The answer is yes. In this article we will show that the mixing is directly related to Z , the quasi-particle weight, which is measurable in ARPES.Roughly speaking, mixing is proportional to Z . We have also developed a M onte C arb technique to calculate Z . The calculation shows that m om entum dependent mixing pSD wf indeed has strong anisotropy in m om entum space, and consistent with the observed dichotom y.

C om paring pBC Sw f and pSD w f, we like to point out two wave functions have similar background spin-spin correlation and similar spin energy. However, that pBC-Sw f does not capture the detailed charge dynamics. The new trial wavefunction, pSD w f, contains more correct spin-charge correlation. As a result, the energy of doped holes/electrons is much lower in the pSD w f. The holes/electrons in the pSD w f reproduce the correct momentum dependence of quasi-particle spectral weight. W e also expect our pSD w f to have a strong momentum dependence in quasi-particle current, which may explain the tem perature dependence of super uid density of H igh T_c superconductors [21].

II. SPINON-DOPON APPROACH AND PSDW F

A. Slave-boson Approach and Projected BCS W avefunction { W hy the approach fails to capture k-dependent features?

W hy would we want to introduce the spinon-dopon approach to t-J m odel? Let us nstly look into the previous mean eld approach, m ore speci cally, slave-boson approach. The generalt-J m odel can be written in term s of electron operator:

Here the projection operator P is to ensure the Ham iltonian is acting within the physical Hilbert space: one each site, the physical states are j"i, j#i or Di, ie., no double occupancy.

Slave-boson approach [14, 15] emphasizes the spincharge separation picture. In that approach, one splits electron operator into spinon and holon operators:

where f is spinon, carrying spin 1=2 and charge 0, i labels site and labels spin; b is holon, carrying spin 0 and charge 1. This splitting enlarges the H ilbert space. To go back to physical H ilbert space, a local constraint is needed:

Due to spin interaction, spinons form a d-wave paired state. The superconducting phase is realized through an additional holon condensation at momentum k = 0. W ithin such a construction, the quasi-particle weight Z is proportional to doping x everywhere in k-space, in both nodal and anti-nodal region. To see this, one can simply look at the mean-eld G reen function of electron:

Therefore x is the residue of quasi-particle pole and Z = x is independent of k.

Slave-boson approach is supposed to capture the physics of spin-charge separation. It has successfully generated the phase diagram of H igh- T_c superconductor. But this approach, at least at m ean- eld level, could not capture som e m ore detailed features, such as m om entum dependence of quasi-particle w eight or the quasi-particle current. O ne can argue that including gauge uctuation, those detailed features m ay be reproduced, but here we w ill try to develop another approach which can capture these features at m ean- eld level.

Before we go into the new spinon-dopon approach, let us see how far one can go using slave-boson approach. O ne can actually try to build a trial wavefunction based on slave-boson mean- eld approach. We know that the mean- eld approach enlarged the H ilbert space, and the resulting wavefunction lies outside the physical H ilbert space. O nly when one includes the full gauge uctuations can one go back to the physical H ilbert space.

So one way to include the full gauge uctuations, is to build the mean-eld ground state rst, and then do a projection from the enlarged H ilbert space to the physical H ilbert space. The wavefunction after projection would serve as a trial wavefunction for the physical H am iltonian. This projected wavefunction is supposed to incorporate the e ect of gauge uctuation of the slave-boson approach, and m ay answer the question that, after including gauge uctuation, whether slave-boson approach can capture the detailed features like dichotom y.

The m ean- eld ground state for underdoped case can be constructed as follows. Let N_h be the num ber of holes, N_f is the num ber of spinons, and N = N_h + N_f is the total num ber of sites. The slave-boson m ean- eld ground state is then given by

Here is the chemical potential to give the correct average number of spinon $h_{i}f_{i}^{y}f_{i}$ i = N_f; and

are mean-eld parameters which have been found to be - = 2 [22] at half-lling, and - decreases to zero at doping around J=t.

Now one can do a projection to go back to the physical H ilbert space. The constraint for physical H ilbert space is Eq.(3). This constraint ensures that the total num ber of spinon must be N_f and there is no double occupancy of spinon: spinon num ber $n_{f;i}$ at site i has to be either 0 or 1. One can easily see that the resulting wavefunction is the usual P rojected d-wave BCS W avefunction (pBC-Swf):

where in the rst line, $P_N^{S\,B}$ is the projection into xed total number of particles, i.e., N_h holons and N_f spinons; while $P_D^{S\,B}$ is the projection into physical H ilbert space, i.e., removing all states not satisfying constraint Eq.(3). In the second line, P_N is the projection into xed total number of electrons, which has to be N_f, P_D is the projection which removes all double occupancies. a (k) is de ned as a (k) = $\frac{v_k}{u_k}$.

P rojected BSC wavefunction turned out to be a surprisingly good trialwavefunction for t-J m odel[17]. How – ever num erical studies[18, 19] showed that the quasiparticle weight is alm ost a constant along the direction from (;0) to (0;), i.e., it fails to reproduce the dichotom y. The quasiparticle current of pBC Sw f is also pretty sm ooth in the k space[18]. It is because pBC Sw f is unable to capture the momentum dependence properties that we need a new approach to underdoped high T_c superconductors.

B. How to capture k-dependence features? { Spinon-dopon approach and projected spinon-dopon wavefunction

Rebeiro and W en [20] developed this new m ean-eld approach trying to capture the spinon-holon recom bination physics. In the following we brie y review their work. We know that at low tem perature, spinon and holon recom - bine pretty strongly to give electron-like quasi-particle. So it is natural to introduce dopon operator { a bound state between a spinon and a holon { to describe low energy excitations. Note that a dopon has the same e quantum number as an electron and describes a doped electron (or hole). But the M ott and spin-liquid physics at half lling should also be addressed. So one should also keep the spinon operator. As a result, two types of ferm ions are introduced here: spinon f and dopon d. Spinon carries spin 1=2 and no charge, and dopon carries spin 1=2 and charge 1. By introducing these two types

of ferm ions one enlarges the H ilbert space: now there are 16 states per site, among them only three are physical. The three physical states on site i can be represented in term s of spinon and dopon ferm ions as:

Here please notice that the constraints are two-fold: rstly there must be one f spinon per site, secondly d dopon has to form a local singlet with the spinon.

O ne can do a self-consistent mean-eld study. The mean-eld H am iltonian takes the form :

Here $H_{m ean}$ can be divided into three parts: spinon part, dopon part and spinon-dopon interaction. The spinon part describes the usual d-wave paired ansatz: $= Jhf_k^y f_k i$, $= Jhf_{k^n}f_{k\#}i$. The dopon part is simply a free dopon band, with $_k$ determined by high energy ARPES measurement. Note that $_k$ is not taken as tunable mean- eld parameter. Finally the spinon-dopon interaction is described by a k-dependent hybridization, roughly speaking $_k = {_k}hd_i^y f_i i$. One can see that $d_i^y f_i$ is a bosonic eld carrying charge 1 and spin 0. Its nonzero average value corresponds to holon condensation in slave-boson approach, which leads to superconductivity.

is the chem ical potential required to tune the doping. A long this line R ebeiro and W en did a m ean- eld phase diagram, and successfully t to ARPES data and tunneling data [23, 24]. Here we try to emphasize that the main lesson we learned from this new mean- eld approach is that one can have a k-dependent hybridization at mean- eld level (in Eq.(12) this hybridization is controlled by $_{\rm k}$ and energy spectrum of spinon band and dopon band.), which is roughly the counterpart of holon condensation in slave-boson approach. This is why one can study detailed features like dichotom y in this new approach.

Several open questions naturally arise in this new approach. It seems there are two types of excitations, spinon and dopon, what do they look like? We also know that mean-eld approach is not very reliable, so it would be nice to understand the physical trial wavefunction corresponding to the new mean-eld approach, from where we would know exactly what we are doing. In the follow-ing we try to answer these questions.

Let us construct trial wavefunctions based on this spinon-dopon m ean- eld approach. O ne can simply take a m ean- eld ground state wavefunction, then do a projection back into the physical H ilbert space, just like the way we did in the slave boson case:

Here P_N is the projection into xed number of spinon and dopon, which gives the correct doping; and P_{SD} is the projection into to physical H ilbert space Eq.(11). $j_{SD,m\,ean}i$ is the ground state wavefunction of some mean- eld Ham iltonian in the form of Eq.(12). Suppose we know how to do this projection numerically, one can do a variational study of the these P rojected Spinon-D opon W avefunctions (pSD w f), to see what is the low estenergy ansatz. In general, how ever, the full projection is not doable, so we develop a simple numerical technique to do a local projection to have some rough idea about what kind of wavefunction is energetically favorable (See Appendix A). W hat we found is that the best trialwavefunction for underdoped case has the following form :

Here f form a d-wave paired state and the superscript SC m eans this wavefunction is superconducting. b(k) and k are some real functions and we assume k = k to respect time reversal symmetry. For this particular ansatz, full projection is doable in low doping limit. In section IV we develop the numerical method to do the full projection and we will see that this wavefunction is a even better trial wavefunction than pBC Sw f.

Note that the total number of f and d ferm ions is N + N_h. A lso P_{SD} requires one f-ferm ion per site, so totally N f-ferm ions. Therefore we must have N_h d-ferm ions, which gives the correct doping.

C. How does pSD wf capture the k-dependent features? { properties of wavefunction before projection j $_{\text{SD}}^{\text{SC}}$ m ean i: Z_k at m ean-eld level.

The form of j_{PSD}^{SC} i books very similar to pBC Sw f, basically we are constructing a pairing wavefunction based on hybridized ferm ion f_k . In the next section we will see that j_{PSD}^{SC} i and pBC Sw fare indeed closely related. For the moment let us have a closer book at the wavefunction j_{SD}^{SC} mean i before projection. The idea is that physical properties may not change drastically after the projection. In this case the mean-eld level understanding will give us insight of the wavefunction after the projection.

First of all it is obvious that this wavefunction is superconducting. That is because the nonzero $_k$ signals the m ixing between spinon and dopon $hf_k^y d_k i \in 0$, and thus signals breaking of charge conservation. It is natural to believe the superconductivity survives after projection.

Let us introduce the other combination of f and d ferm ions:

The mean-eld Hamiltonian which can generate $j_{SD_{gm} ean}^{SC}$ i as ground state is simply:

with f(k); f(k) > 0. Later we will see that there are physical reasons that f(k) > f(k), meaning f band is lowest energy excitation, and d band is fully gapped, f(k) > 0 for any k.

We can express f and d ferm ions in term s of and đ ferm ions:

W e know that the mean- eld wavefunction should give one f-ferm ion and $x=\frac{N\,h}{N}$ d-ferm ion per site on average:

Now let us understand how to calculate $Z_{\ }$ and $Z_{\ }$ on this mean- eld wavefunction. $Z_{\ }$ and $Z_{\ }$ are dened to be:

where N 1;ki (N + 1;ki) are the low est-energy N 1 (N + 1) electron states which have nonzero overlap with $q_k j_{GS}^{N} i (q_k^{V} j_{GS}^{N} i)$.




FIG.1: Plot of u_k^2 (left) and v_k^2 (right) within one quarter Brillouin Zone, k_x and k_y range from 0 to .

parameters leads to a pBC Sw fwith lowest average energy at half lling.

The $Z_{+;k}$ and $Z_{-;k}$ for the pBCSwf after the projection tion were also calculated [18]. Roughly speaking what was found is that the Z k pro le after projection is similar to that before the projection. There is a quasi ferm i surface, which is roughly along the diagonal direction, Z :k is large inside the ferm i surface and decreases very fast when you go outside ferm i surface; while $Z_{+,k}$ is large outside ferm i surface, and decreases fast when you go into ferm i surface. But there is one big di erence, which is a reduction factor. For the $Z_{+,k}$, this reduction factor was found to be proportional to x. But for Z_{ik} , this reduction factor depends on k and is nite (around 0.2) for k = (0; 0) even at low -doping lim it. From slave-boson approach Eq.(4), we already see that Z / x at mean eld level. Basically at half lling, Z = 0 and we have a M ott insulator instead of a band insulator.

Notice that along diagonal direction (;0) (0;), the Z_k^{BCS} is dispersionless: $Z_k^{BCS} = 0.5$, which does not have dichotom y feature; A fler projection, there is a factor x reduction, but Z_k is still alm ost a constant along the diagonal direction [18, 19].

To compare the calculated Z from the BSCwf and SDwf, we note that the projected wave functions, pBC-Swf and pSDwf, are closely related (see section IID). M ore precisely:

It is easy to understand this identication at half-lling, since both wavefunctions simply give the same spin-liquid (usually referred to as staggered ux spin liquid in literatures), characterized by and . Now in the pSD wf f = f, with no mixing with d-ferm ion. It is simply a particle-hole transformed pBCS wf, by which u_k transformed into v_k and vice versa. The important message is that u_k ; v_k and v_k ; v_k characterize the spin dynamics, but $_k$ characterizes the charge dynamics.

W ith this identication in m ind, from Eq.(33,34) and (40) we immediately know that when k = 0 these two wavefunctions give the sam e m ean- eld Z_k pro le except that SD wf has an extra x factor, because ${2 \atop k} = {2 \atop 0} / x$ in low doping limit. However, when ${}_k$ has a strong k-dependence, Z $_k$ from the two approaches can be very di erent.

Let us think about whether or not these wavefunctions can capture dichotom y in low doping lim it. W hat did we learn from these mean- eld result? We learned that it is impossible to capture dichotom y by BC Sw f, because in order to capture the k-dependence along (0;) { (; 0), one has to tune u_k; v_k. Because d-wave u_k; v_k are constant along (0;) { (; 0), one has to destroy the d-wave ansatz to have a k-dependent u_k; v_k along (0;) { (; 0). This leads to a higher J energy. On the other hand, it is possible to capture dichotom y by SD w f, because one can tune _k to have a strong k-dependence while keeping w_k; w_k to be d-wave ansatz. This will not destroy the spin background. Based on our experience of projection, we expect that even after projection, the above statem ent is qualitatively true.

D . W hymixing $_k$ has a strong k-dependence? {Relation between pBCSwf and pSD w f

In the last section we see that pSD wf can potentially capture the dichotom y through a k dependent $_k$. Now the issue is, why does the $_k$ want to have a k dependence that can explain the dichotom y in Z_k ? W hy does such k-dependent $_k$ lead to a pSD wf which is energetically m ore favorable? To understand this, we need to know what a pSD wf looks like in real space.

The discussion below for identifying the relation between pSDwf and pBCSwf is rather long. The result, however, is simple. Let <u>us present</u> the result here rst. We introduce $\tilde{k} = k = \frac{1}{k} \frac{1}{k}$. In low doping limit, $_k$. Therefore to lower the hopping energy, nite i's are naturally developed. This is why k with a proper k dependence is more energetically favorable.

Before we look into pSD wf, let us review what a pBC -Swf looks like in real space. One can do a Fourier transform ation:




FIG.2: pSD wfw ith only \sim_0 . The site 0 is empty.f-ferm ions are represented by green spin, and d-ferm ion is represented by red spin. B lack valence bonds are bonds with of f-ferm ions, while red valence bond has a d-ferm ion. The two gures are two contributions of the overlap between pSD wf and a spin basis jl=3·2#4#0_{em p}i, and they correspond to the sam e term in determ inant Eq.(52). The two gures give rise to states: left: j"_{1f}#_{0f}"_{3f}#_{2f}"_{0d}#_{4f}i= j"_{1f}"_{3f}#_{2f}#_{4f} (#_{0f}"_{0d})i and right: j"_{1f}#_{0d}"_{3f}#_{2f}"_{0f}#_{4f}i= j"_{1f}"_{3f}#_{2f}#_{4f} ("_{0f}#_{0d})i The m inus sign m eans that the two gures contribute additively.




FIG. 3: pSD wf with only $\tilde{1}$. The site 0 is empty. fferm ions are represented by green spin, and d-ferm ion is represented by red spin. Black valence bonds are bonds with of f-ferm ions, while red valence bond has a d-ferm ion. Notice that the position of d-ferm ion is shifted by $\circ p \tilde{1}_1$ term e ect (red dotted line). The two gures show the two contributions of the overlap between pSD wf and spin basis $jl \cdot 3 \cdot 2_{\#} 4_{\#} 0_{em} p i$, with spin of f-ferm ion on site 2 and spin of d-ferm ion on site 0 are parallel. They give rise to states: left: $j \cdot 1_{1f} \#_{0d} \cdot 3_{f} \#_{2f} \cdot 0_{0f} \#_{4f} i = j \cdot 1_{1f} \cdot 3_{f} \#_{2f} \#_{4f} (\#_{0d} \cdot 0_{0f}) i and$ $right: <math>j \cdot 1_{1f} \#_{2f} \cdot 3_{f} \#_{0d} \cdot 0_{0f} \#_{4f} i = j \cdot 1_{1f} \cdot 3_{f} \#_{2f} \#_{4f} (\#_{0d} \cdot 0_{0f}) i$ The minus sign means the two gures contribute subtractively, i.e., they cancel exactly.

To have an overlap with spin basis $fR_{i^{"}}$; $R_{j^{"}}$; $R_{k;0}$, the d-ferm ion on empty site $R_{k;0}$ can also come from a bond connecting a spinful site and $R_{k;0}$ + , which is the γ_1 term e ect. Let us consider the case = 2. We can also assume the spin state on size $R_{k,0}$ + is spin down. Now it appears that we have two ways to construct the empty site on $R_{k,0}$: $j''_{f} #_{d}$ i or $j''_{d} #_{f}$ i. We study the two cases separately. Firstly if the empty site is constructed by $j"_f \#_d i$, shown in Fig.3, careful observation tells us that the contribution to the overlap is exactly cancelled by ferm ion statistics. On the other hand, if the empty site is constructed by $j''_d #_f i$, we have the case in F ig.4. A fler careful observation, we know that this type of contribution is $\frac{1}{2}$ times the overlap between j_{PSD}^{SC} (°) i and the spin basis that diers from $fR_{i"}$; $R_{j\#}$; $R_{k;0}$ g by a hopping along \hat{y} . Later we will see that for n_h holes, the number of Slater determ inants for the overlap is $(1 + n_{shift})^{n_h}$, which means numerically one can only do few holes.




FIG.4: pSD wfwith only $\tilde{}_1$. The site 0 is empty.f-fermions are represented by green spin, and d-fermion is represented by red spin. B lack valence bonds are bonds with of f-fermions, while red valence bond has a d-fermion. Note that the position of d-fermion is shifted by $\circ p$ by $\tilde{}_1$ term e ect (red dotted line). This gure shows another contribution to the overlap between pSD wf and spin basis $jl_* 3_* 2_{\#} 4_{\#} 0_{em p} i$, with spin of f-fermion on site 2 and spin of d-fermion on site 0 are anti-parallel. It gives rise to state: $j''_{1f} \#_{0f} "_{3f} #_{2f} "_{0d} #_{4f} i =$

To summarize, we have the following identi cation: f-type excitation corresponds to the low energy quasiparticle excitation, i.e., a state constructed by putting c_p operator inside the projection; d-type excitation corresponds to the bare hole excitation, i.e., a state constructed by putting c_p operator outside the projection.

IV. NUMERICALMETHODSAND RESULTS

We use Variational M onte Carlo (VMC) m ethod to calculate the ground state energy (of 2 holes), the excited state energy (of 1 hole) of pSD w f and pBC Sw f and the spectral weight Z_{ik}.

O ur pBC Sw f calculation is mostly traditional. Nevertheless the previous calculation of Z [19] is indirect and having uncontrolled error bars inside the ferm i surface. We developed a straightforward technique to calculate Z. Let us recall the de nition of Z Eq.(31). Since both hsigpi and hsighi are Slater determ inant or sum of Slater determ inants (see Eq.(64) and Eq.(74)), the above two quantities can be calculated by M etropolis program in a straightforward fashion. Then the product of the two gives the Z $_{;k}$. This algorithm works for nite doping case, too.

For pSD wf, because we include k-dependent mixing, in each step of M etropolis random walk, we need to keep track of all the $(1 + n_{\rm shift})^{n_{\rm h}}$ matrices, which lim it the calculation for few holes.

A. Ground state at half lling and 2 holes

The calculation is done for $t^{-1}t^{0}-t^{0}$ m odelon 10 by 10 lattice, where $t = 1, t^{0} = 0.3, t^{00} = 0.2$ and J = 0.3. We choose periodic boundary condition in x-direction, and anti-periodic boundary condition in y-direction. For variational parameters, we choose the lowestenergy ansatz in Eq.(7) [26] with parameters

The energy for half- lling ground state is listed in Table I.

For two holes, we com pare the energy of ground states of pBC Sw f and pSD w f. For pSD w f, to low er the t hopping energy, since t < 0, by Eq.(59), the sign of $\tilde{}_1$ should be negative. Sim larly since t⁰ > 0;t⁰⁰ < 0, the parameters low ering t⁰ and t⁰⁰ hopping energy have signs $\tilde{}_2 > 0$ and $\tilde{}_3 < 0$. We did a variational search for the optim al values of $\tilde{}_1$. The results are listed in Table II, where we also com pare it with pBC Sw fw ith longer range hoppings (see Section IV E).

We nd that the energy of the best pSD w f is lower than the energy of the best pBC Sw f. We note that the pSD w f and pBC Sw f are identical at half lling. So the

energy di erence between the two states is purely a doping e ect. C om paring the rst and the last line in table II which have the same spin correlation, we see that the totalenergies of the two states di er by 0:0046 200 since the the 10 by 10 lattice has 200 links. This energy di erence is due to the presence of two holes. So the energy of a hole in pSD wf is 0:46t low er than that of a hole in pBC Sw f. This energy di erence is big, indicating that the charge-spin correlation is much better described by pSD wf than pBC Sw f.

B . Hole doped case, quasi-particle excitations and $$\rm Z$$.

In this section we study the excitations of t-t⁰-t⁰-J m odel, which is one hole on 10x10 lattice. We also compare pSD wf with pBC Swf. We know from Eq.(72) that the pSD wff-excitation state goes back to pBC Swf quasi-particle excitation state when all non-localm ixings $\sim = 0.$ A lso from Eq.(72), one can see that to lower the t, t⁰ and t⁰ hopping energy, we should also have $\sim_1 < 0$, $\sim_2 > 0$ and $\sim_3 < 0.$ A ctually in the low doping limit, one should expect the non-localm ixing \sim for quasi-particle excited states (f-excitation) to be same as the ground state. Here we adopt the values of \sim from our study of 2-hole system ground state.

O ur VM C calculation shows that the pSD w f or pBC – Sw fhas nite Z deep inside the ferm isurface even in the low doping limit x ! O. This is physically wrong because deep inside ferm i surface there is no well-de ned quasiparticle, and the idea of calculating Z by a single particle excited state is also incorrect. N evertheless, because the low energy excitation ism ore and m ore quasi-particle like as one approaches the ferm i surface, we expect that




FIG.5: Shapes of functions $\cos k_x \ \cos k_y \ (up)$ and $\cos 2k_x \ + \ \cos 2k_y \ (down)$ along diagonal direction from (;0) to (0;).

the Z calculation remains valid close to ferm i surface, roughly speaking, along the diagonal direction from (;0) to (0;).

From Eq.(33), we know that at the mean-eld level, the modulation of Z is controlled by 2_k . It is important to study the shapes of 2_k for various cases. In Fig. 5 we plot the shapes of functions $\cos k_x \cos k_y$ and $\cos 2k_x + \cos 2k_y$ along the diagonal direction. If ${}_k = {}_0 + 2 {}_1 (\cos k_x + \cos k_y)$, 2_k remains constant along the diagonal direction. If ${}_k = {}_0 + 4 {}_2 \cos k_x \cos k_y$, for small ${}_2 > 0$, 2_k is reduced at the anti-nodal point. If ${}_k = {}_0 + 2 {}_3 (\cos 2k_x + \cos 2k_y)$, for small ${}_3 < 0$, 2_k is enhanced at the nodal point and suppressed at the anti-

nodal point. Let us remember this trend: positive $_2$ and negative $_3$ drive the modulation of Z in the way consistent with dichotom y for hole doped samples.

For small values of k we know that $\tilde{k} = k \cdot \text{Eq.}(33)$ suggests that along the diagonal direction

But as a mean-eld result, one should expect that the above equation is only valid qualitatively. In fact to crudely t the relation of the modulation of Z and \sim , we found it is better to have some order of unity extra factor in front of \sim term s, and \sim_1 also contributes to the modulation of Z as a uniform shift.

For t-J m odel without t^0 and t^0 , there is no reason to develop a nite value of $_2$ and $_3$ since there is no longer range hoppings. As a result, one expects that Z remains alm ost constant along the diagonal direction.

For t+0+0-J m odelw ith $t > 0, t^0 < 0, t^{(0)} > 0$, we know that $\sim_2 > 0$ and $\sim_3 < 0$ have to be developed to favor longer range hoppings. So one expect Z should develop dichotom y shape along the diagonal direction.

In Fig.6 we compare the Z $_{;k}$ of pBCSw f and pSD w f. O ne can see that pSD w f shows strong dichotom y.




FIG. 7: Quasi-particle spectrum for one hole on 10 by 10 lattice. t = 1, $t^0 = 0.3$, $t^{00} = 0.2$ and J = 0.3. The black square shows the spectrum of d-wave pBCSwfwith = 1 and = 0.55, and the red diam ond shows the spectrum of pSD wf with = 1, = 0.55, $\frac{x_1}{x_0} = 0.3$, $\frac{x_2}{x_0} = 0.3$ and $\frac{x_3}{x_0} = 0.1$. One can see the rst hole doped to (=2; =2). The energy of a doped hole in pSD wf is 0.38t lower than that of a hole in pBCSwf.

In Fig.7 we compare the energy dispersion of one-hole quasi-particle excitations of pBCSwf and pSDwf. The energy of a doped hole in pSDwf is 0:38t lower than that of a hole in pBCSwf.

C. Electron doped case

In electron-doped case, one can do a particle-hole transformation, then multiply a (1) for the odd lattice electron operators. By doing so, the original electron-doped t-J model with parameters $t;t^0;t^0;J$ transformed

into hole-doped t-J m odel with parameters t; t^0 ; t^{00} ; J, together with a (;) shift in momentum space.

The approach outlined in Eq.(79) and Eq.(80) still applies here. But because of the particle-hole transform ation, we are calculating Z_+ of the original electron-doped system. Because $t^0 > 0$ and $t^0 < 0$, to favor longer range hoppings, we must have $\tilde{z}_2 < 0$ and $\tilde{z}_3 > 0$, which differ from hole-doped case by a sign ip. As a result, the Z_+ now will be suppressed at nodal point, but enhanced at the anti-nodal point. This is exactly what people observed in exact diagonalization [8].

W e did a variational search for the optim al variational parameters for pBCSwfwith longer range hoppings ⁰ and ⁰⁰, and pSDwfwith non-local mixings. In Table III we compare the energy of pBCSwf and pSDwfwith 2 electron doped on 10 by 10 lattice. In Fig.8 we plot the Z_+ map of pSDwf, one can see pSDwf has spectral weight of anti-dichotom y shape.




FIG. 9: Quasi-particle spectrum for one electron on 10 by 10 lattice. $t = 1, t^0 = 0.3, t^{00} = 0.2$ and J = 0.3 (one can map it into a hole-doped model with $t = 1, t^0 = 0.3, t^{00} = 0.2$ and J = 0.3 with a (;) shift in momentum space.). The black square shows the spectrum of d-wave pBC Sw f with = 1 and = 0.55, and the red diam ond shows the spectrum of pSD w f with = 1, = 0.55, $\frac{x_1}{x_0} = 0.5, \frac{x_2}{x_0} = 0.3$ and $\frac{x_3}{x_0} = 0.3$. One can see the rst electron doped to (;0). The energy of a doped electron in pSD w f is 0.25t lower than that of an electron in pBC Sw f.

In Fig.9 we compare the energy dispersion of oneelectron quasi-particle excitations of pBC Sw fand pSD w f. The energy of a doped electron in pSD w f is 0.25t lower than that of an electron in pBC Sw f.

D. A prediction

In hole-doped and electron-doped case, t > 0 and t^0 have opposite signs, and as a result Z develops strong k dependence along diagonal direction. W hat if t^0 and t^0 have the same sign? If both $t^0 > 0$ and $t^0 > 0$, one expects that $\tilde{}_2 < 0$ and $\tilde{}_3 < 0$ to favor longer range hoppings. But they drive the modulation of Z in opposite ways. As a result, one expects that for certain ratio of values of $t^0 > 0$ and $t^0 > 0$ of order 1, their e ects canceland Z remains constant along the diagonal direction, but w ith an enhanced value of Z than the case of pure t-J m odel. Sim ilarly for certain ratio of values of $t^0 < 0$ of order 1, Z remains constant along the diagonal direction, but w ith a suppressed value of Z than the case of pure t-J m odel. These predictions can be checked by exact diagonalization.

E. pBCSwfwith longer range hoppings

One can view pSD w f as an improved pBCSw f. We choose the d-wave pairing wavefunction b(k) with only nearest hopping and pairing parameters. Then 2 and 3 encode some second-neighbor and third-neighbor correlations. The price to pay is to include more than one Slater determ inants in spin basis. One may naturally ask, suppose we insist working on pBCSw f, if one puts in longer range hopping parameters like ⁰ and ⁰⁰ in the pairing wavefunction b(k), one also encodes some second-neighbor and third-neighbor correlations, which may lower the second-neighbor and third-neighbor hopping energies. But in this way one can still work with a single Slater determ inant. If our pSD w f w ith no-local

m ixing is physically sim ilar to pBCSw fwith longer range hoppings, why should one bother to work with many

Slater determ inants?

W ewant to emphasize that ourpSD w fisphysically different from pBCSwfeven after we include longer range hoppings 0 and 00 . We note that, in the in nite-lattice $\lim {\rm i} t \, {\rm w} \, {\rm i} {\rm th}$ a few holes, the pBC Swf cannot have longer range hoppings (i.e. $^{0} = ^{0} = 0$). O therw is we are considering som e other spin wavefunction instead of dwave wavefunction, which will increase the spin energy by a nite amount per site. Therefore 0 and 00 have to vanish in low doping limit. In contrast, for our pS- $D \le f$, the the spin energy is not a ected by nite i in the zero doping lim it. Thus in the low doping lim it, the spin energy is perturbed only slightly by a nite 2 and $_3$. On the other hand a nite $_2$ and $_3$ make the hopping energy much larger than that ofpBCSwf. So in the in nite-lattice limit with a few holes, i will be nite and the energy of one hole will be low ered by a nite am ount by turning on a nite i.

P hysically this means that $_2$ and $_3$ characterize the charge correlations, while 0 and 00 characterize the spin correlations. The above claim is supported by 2-hole system on larger lattice, i.e., by lower the doping. In Table IV we list the energies of pBC Sw fw ith longer range hop-

ping and pSD w f on 14 by 14 lattice. Comparing with Table II one can see the spin energy for pSD w f is low ered further than that for pBC Sw f.

A nother way to see that these two wavefunctions are di erent is by calculating Z . Num erical results show that pSD wf has dichotom y whereas pBC Swf does not. A ctually on the mean- eld level, a negative ⁰ and/or positive ⁰⁰ even make the Z larger on the anti-nodal point than on the nodal point. A fter projection, we observe that Z still remains alm ost constant along the diagonal direction for pBC Swf with longer range hoppings. In Fig.10 we plot the Z map of pBC Swf with longer range hopping ⁰ = 0:4.

V. CONCLUSION

In this paper we studied a new type of variational wavefunction, pSD w f. It can be viewed as an improved pBC Sw f, and the improvement is that pSD w f correctly characterizes the charge dynam ics and the correlation be-

tween the doped holes/electrons and the nearby spins. This physics was missed by the previous pBCSwf. As a result, pSD wf correctly reproduces the dichotom y of hole-doped and electron-doped M ott insulator.

In pSD w f, we introduced two types of ferm ions, spinon f and dopon d. Spinons f carry spin but no charge. They form a d-wave paired state that describes the spin liquid background. Dopons d carry both spin and charge and correspond to a bare doped hole. The mixing between spinons and dopons described by $_0$, $_1$, $_2$ and $_3$ leads to a d-wave superconducting state. The charge dynam ics (such as electron spectral function) is determined by those mixings. 0 is the on-site mixing (or local mixing), and 1, 2 and 3 are non-local mixings corresponding to mixing with rst, second and third neighbors respectively. If pSD wf has only local mixing, it is identical to pBCSwf.W ith non-localm ixings, pSD wf corresponds to pBCSwfwith hopping term sacting on it. Therefore the wavefunction develops nite non-local mixings to lower the hopping energies. In particular, for the hole-doped case, to low er t^0 and t^{00} energies, the m ixing is described by $_2 > 0$ and $_3 < 0$.

The pSD wf can also be obtained by projecting the spinon-dopon mean- eld wavefunction into the physical subspace. Therefore, one expects that some properties of pSD wf can be understood from the mean- eld theory. In the mean- eld theory, it is clear that the modulation of Z $_{jk}$ in k space is controlled by the non-local mixings. O ur num erical calculation of Z $_{jk}$ shows that the above mean- eld result is valid even for the projected wave function. We nd that $_2 > 0$ and $_3 < 0$ give exactly the dichotom y of Z $_{jk}$ observed in the hole doped sam ples. Because $_2 > 0$ and $_3 < 0$ are driven by t⁰ and t⁰⁰. Thus to low er the hopping energy, the spectral weight is suppressed in some region in k-space. This result conduction is a specific term.

naive guess: to lower the hopping energy, the excitation should be m ore quasi-particle like. We also predict that the dichotom y will go away if t^0 and t^{00} have the same sign and similar magnitude. In summary, we found a m ean-eld theory and the associated trial wavefunction capturing the dichotom y physics.

Traditionally, in projected wavefunction variational approach, for example pBCSwf, people use wavefunctions which in real space correspond to a single Slater determ inant. The reason to do so is simply to make the com putation easier. Our study shows what kinds of im portant physics that m ay be m issed by doing so. In real space, the pSD wf is sum of $(1 + n_{\text{shift}})^{n_{\text{hole}}}$ num ber of Slater determ inants, because each hole can either do not hop, or hop into one of n_{shift} sites. So our calculation is lim ited to few-hole cases. How ever, the idea of introducing m any Slater determ inant is quite general. For exam ple, one can study another im proved pBCSwf, which allow s each hole to hop once but forbids two holes hopping together, therefore the num ber of Slater determ inant is $(1 + n_{shift})n_{hole}$ and many-hole cases are computationally achievable. This new improved pBCSwf is the rst order approximation of pSD wf and remains to be studied. For a long time there is a puzzle that doped M ottinsulator (ie the spin disordered m etallic state) seem s to be energetically favorable only at high doping x > 0.3. For x < 0.3 the doped spin density wave state have a lower energy. Our pSD wfm ay push this lim it down to low doping which agrees with experiments better. This is because that including m any Slater determ inants can lower the energy per hole by a signi cant am ount (about 0:4t).

A swe have stressed, pSD wfprovides a better description of spin-charge correlation, orm ore precisely, the spin con guration near a doped hole. This allows us to reproduce the dichotom y in quasiparticle spectral weights observed in experiments. The next question is whether the better understanding of the spin-charge correlation can lead to new experimental predictions. In the following, we will describe one such prediction in quasi-particle current distribution.

We know that a nite supercurrent $J_{\rm s}$ shifts the superconducting quasiparticle dispersion E $_k$. To the linear order in J $_{\rm s}$, we have

where c is the speed of light and we have introduced the vector potential A to represent the supercurrent: $J_{\rm s} = \frac{n_{\rm s} e^2}{m \ c} A$. j_k is a very in portant function that characterizes how excited quasiparticles a ect super uid density $_{\rm S}$. We call j_k quasiparticle current. A coording to the BCS theory

where k is the normal state dispersion which is roughly given by $k = 2t[\cos(k_x) + \cos(k_y)]$.

The previous study [18] of quasi-particle current for pBCSw f shows that the quasi-particle current is roughly given by the BCS result (84) scaled down by a factor . Such a quasi-particle current has a smooth distribution in k-space. Here we would like to stress that since the charge dynam ics is not capture wellby the pBCSw f, the above result from pBCSw fm ay not be reliable. We expect that the quasi-particle current of pSD w f should has a strong k-dependence, ie a large quasi-particle current near the nodal point where Z_k is large and sm all quasi-particle current near the anti-nodal point where Z_k is sm all. Such a quasi-particle current distribution m ay explain the tem perature dependence of super uid density [21].

Indeed, the mean- eld spinon-dopon approach does give rise to a very di erent quasi-particle current distribution which roughly follows Z_k . For more detailed study in this direction and possible experimental tests, see Ref. [27].

APPENDIX A: A SIM PLE ALGORITHM TO DO LOCAL PROJECTION

Suppose the wavefunction before projection is the ground state of some ferm ionic quadratic H am iltonian. O ne can always diagonalize the H am iltonian so that all two-point correlation functions of ferm ion operators can be calculated exactly. For our SD w f, that m eans quantities like $h_i^{y} f_{ji}$, $h_i^{d} f_{ji}$, $h_i^{d} d_{ji}$... can be calculated.

P rojection is supposed to rem ove the unphysical states. For a site i, the following operator rem oves the unphysical states.

It obviously ensures that $n_{f,i} = 1$, $n_{d,i} \notin 2$ and f and d fermions form local singlet. To calculate energy, we do local projection on the relevant sites. For example, to calculate the J term energy, one actually calculates

The denominator accounts for the wavefunction normalization due to projection. One can write operators $P_iS_i \ S_jP_j$ and $P_iS_i \ S_jP_j$ in terms of ferm ion operators.

By W ick's theorem, the expectation values of these operators reduce to a sum of products of ferm ion two-point correlation functions, which are known. Sim ilarly for t term energy, one calculates for example,

where $h_i^y = \frac{1}{p_2} (f_{i''}^y d_{i\#}^y - f_{i\#}^y d_{i''}^y)$ is the operator that creates a hole at site i.

O ne m ay ask whether we can do local projections on m ore and m ore sites, then the result will be closer and closer to the one of full projection. Unfortunately this cannot be done, because the num ber ofterm s in the sum - m ation when we expand $P_{11}P_{12}:::P_{1n}$ increases exponentially fast as we increase n. Therefore we are limited to few sites. The above method can only be viewed as some renormalized mean-eld approach.
