Coarse-grained computations of dem ixing in dense gas- uidized beds

We use an \equation-free", coarse-grained computational approach to accelerate molecular dynamics-based computations of demixing (segregation) of dissimilar particles subject to an upward gas ow (gas- uidized beds). We explore the coarse-grained dynamics of these phenomena in gently uidized beds of solid mixtures of di erent densities, typically a slow process for which reasonable continuum models are currently unavailable.

Particulate ows, even for experimental systems of small size (10 cm), consist of a very large number of discrete dissipative particles. M olecular dynam ics (M D) simulations often serve as a quantitative modeling tool for such ows; however, such simulations for realistically large tem poral and/or spatial scale problem s are challenging even with m odern com puters. N avier-Stokes-like, m acroscopic continuum m odels have been developed by m any authors based on the kinetic theory of granularm aterials (see Refs. [1, 2] and references therein); however, quantitative continuum models for realistic particles (accounting for frictional interactions, heterogeneity am ong particles, and/or other inter-particle forces, such as van der W aals forces) in m any regim es of practical interest (e.g. dense and/or cohesive ows where enduring contacts between particles occur) are currently unavailable.

In this paper, we consider well-known phenomena for which the derivation of continuum models is still in ux; mixing and demixing (segregation) can occur when dissim ilar particle m ixtures of di erent sizes and/or densities are subject to a strong enough upward uid ow 3[. A few di erent continuum models, more phenom enological or m ore rigorous, have been proposed [4, 5], which often reproduce the phenomena in a qualitatively correct m anner; how ever, quantitative agreem ent is generally elusive [5]. Furtherm ore, kinetic theory-based continuum models for binary mixtures are much more com plicated than those for uniform particles, and num erical simulation becomes more time-consuming (e.g. by an order of m agnitude in Ref. [5]). A coelerating the com putation using (quantitative) m icroscopic m odels would therefore be invaluable for such problem s. The objective of this paper is to demonstrate a multi-scale com putational approach enabling accelerated integration of M D -based m icroscopic simulations of dense particulate OW S.

M odel. The particles are m odeled as uniform -sized soft spheres (which can have di erent m ass), whose interparticle contact force F_{cont} is determined following a m odel of C undall and Strack [6]. The gas phase hydro-

dynam ics is accounted for in a volum e-averaged way [7]. This approach has been used to study size di erencedriven dem ixing [8]; here we consider density-driven dem ixing.

We deliberately choose dem ixing occurring in narrow beds (cross sectional area of $15d_p$ 15d_p with periodic boundary conditions for both lateral directions, where d_p is the particle diam eter) as a test problem, so that the exact results can readily be computed and used to critically test the coarse-grained computations. These are quasi-1D ow s, where the coarse-grained gas ow is e ectively 1D, while particle simulation is fully 3D. Dem ixing becom es m ore pronounced [9] in such narrow beds. The equation of m otion for each particle can be simplied to be [10]:

where m $_{\rm p}$ and v $_{\rm p}$ are individual particle m ass and velocity, respectively; g is the gravitational acceleration; V $_{\rm p}$ is the volum e of each particle; is the locally-averaged solid phase volum e fraction; is the interphase m om entum transfer coe cient [11, 12]; u $_{\rm s}$ is the coarse-grained solid phase velocity; and U $_{\rm s}$ is the super cial gas ow velocity, in the direction opposite to that of the gravity. In our study, the R eynolds num ber based on the particle size is generally very sm all (< 0:1), and is approximately matched to be

where $_{g}$ is the gas phase viscosity. We nondimensionalize quantities by using $_{s}$, d_{p} , gd_{p} and $d_{p}=g$ as characteristic density, length, velocity, and time scales, where $_{s}$ is the solid phase mass density of the lighter particles. M ore details of the model can be found in Refs. [10, 13].




FIG.1: (Color online) Snapshots of a gas- uidized bed of a binary mixture of identical size but di erent density particles, undergoing spontaneous demixing, shown at times equally separated by t = 100: Light-colored (yellow) particles are twice as dense as the dark-colored (red) ones (coe cient of restitution (friction) = 0.9 (0.1); $k_n = 2.0$ 10^5 ; $U_s = 0.41$; $d_o = 100$ m; s = 0.90 g/cm³).

D irect simulations. Dem ixing is typically a slow process, whose occurrence and duration depend on the density di erence and the gas ow rate. D irect simulation with a su ciently large U_s (jU_sj), starting from a homogeneously mixed, packed (static) state (Fig. 1), illustrates that particles of di erent densities gradually dem ix

spontaneously. When U_s is well above the minimum

uidization rate of both species (as in Fig.1), the bed exhibits 1D traveling waves (TW s) [13], and dem ixing occurs superposed on the persistent oscillatory motion driven by 1D-TW s. A typical computation of an entire dem ixing process in the above $\pm 10^7$ integration steps of 12 500 particles shown in Fig.1) takes nearly two days, or more than a week for smaller gas

ow rates, on a single-processor PC with 1.7 GHz CPU. O btaining an ensemble of long simulations for statistical averaging purposes can be extremely time-consum ing.

Coarse-grained description and \observables". In the literature, the degree of mixing/demixing is offen characterized by various lum ped indices (or \order parameters") [3, 14, 15, 16] such as the so-called Lacey mixing index [14] (e.g. see its use in Ref. [8]). Here we seek coarse-grained variables (or \observables") that could be used in continuum descriptions.

As in the two- uid modeling approach [], it is natural to think of hydrodynam ic variables as candidate coarse observables. From direct simulations, we observe that in the course of dem ixing in quasi-1D beds, the process strongly depends on the local density, which makes the 1D volume fraction pro les them selves su cient coarse observables; when we suddenly random ize only the individual particle velocities (hence the granular tem perature as well) and continue the simulation, the dem ixing progresses essentially undisturbed. We further recognize that cumulative particle distribution functions (CDFs, and more precisely, their inverses which are bounded by 0 and 1) are more convenient coarse observables: CDFs are sm oother than volume fraction pro les, su er from less noise, and facilitate the lifting (see below) procedure.




FIG. 2: (Color online) D irect, full integration (thin lines) and coarse projective integration (patches of thick lines), using evenly discretized CDFs as coarse observables. (a) Slow dem ixing at $U_s = 0:19$, where the bed hardly expands and no 1D-TW s form. Projective steps of t = 80 were taken through forward Euler, after direct integration for t = 20(the latter half of data were used to estim ate the local slope). (b) In the presence of 1D-TW s ($U_s = 0:41$); t = 30, and t = 2T, where T is the average period estim ated during short bursts of direct integrations; the last two periods of the locally oscillating data were used to estim ate the coarse slope.

W e consider both discretized inverse CDFs (ICDFs; Fig. 2) and their compact parametric representations (nite element or expansion coe cients in convenient polynom ial sets; Fig. 4) as our actual coarse observables. For a narrow range of U_s 's slightly above the

m inimum uidization rate, the time evolution of ICDFs does not exhibit any waviness (thin lines in Fig. 2 (a)), and dem ixing occurs very slowly (complete dem ixing is hardly achieved). In the presence of 1D-TW s at larger U_s's, ICDFs locally oscillate at a fast time scale (Fig. 2 (b)); these oscillations can be smoothed through ensemble-averaging. Once the coarse observables are chosen, governing equations for their time evolution need to be derived for further computation. We will follow an equation-free approach, circum venting the derivation of such equations, assuming they do exist conceptually, but are not available explicitly.

An equation-free approach. When the time series of coarse observables (obtained by direct integration of the m icroscopic simulator) are smooth and slow ly varying, one can estimate their local time derivatives and then project the values at a future time (e.g. using forward Euler orm ore sophisticated schemes). We recognize that if one can initialize the m icroscopic simulator consistent with the future (projected) values of the coarse observables, one can actually accelerate the overall computation. This simple idea underpins coarse projective integration [17, 18].

In equation-free computations, traditional continuum num erical techniques are directly applied to the outcom e of appropriately initialized short bursts of m icroscopic simulation, and the macroscopic equations are \integrated" or \solved" without ever being written down [19, 20, 21]. The essential steps are: (i) Identify coarse observables (which are discretized ICDFs or their param eterization coe cients in our study). For convenience, we denote the microscopic description (here the individual particle positions) by x, and the m acroscopic description (here the ICDFs) by X. (ii) Choose an appropriate lifting operator L, which maps X (ICDFs) to one (ormore, for the purposes of variance reduction and ensem ble-averaging,) consistent description (s) x (here, particle positions). Figuring out an e cient lifting operator is essential. (iii) Starting from lifted initial condition (s) x (t₀) = $_{\rm L}$ (X (t₀)), run the detailed simulator for some time horizon $(T_h > 0)$ to obtain x $(t_0 + T_h)$. (iv) Use an appropriate restriction operator M $_{\rm R}$ which m aps the m icroscopic state(s) to the m acroscopic description X $(t_0 + T_h) = M_R (x (t_0 + T_h))$, resulting in time series of the coarse observables (ICDFs), or a coarse tim e-stepper T_{h} for them : X (t₀ + T_{h}) $T_{\rm h}$ (X (t₀)). (v) Apply desired num erical techniques (forward Euler, in our study) to the coarsely observed results in step (iv), and repeat.

Lifting. Given an ICDF as the coarse observable, we need to construct particle con gurations consistent with it. A manging particles (i.e. sphere packing) in threedimensional space with an arbitrarily prescribed ICDF (or local volum e fraction, especially dense) pro le is nontrivial and generally time-consuming [22], as excessive particle-particle overlap has to be avoided; it would be less di cult for dilute particulate ows. In our study, the total height of a bed remains virtually the same, even in the presence of 1D -TW s (see the second and later fram es in Fig. 1). Therefore, we do not reassign particle locations from scratch in each lifting step. Instead, we utilize particle locations which are already obtained from an earlier step, and switch only particle indices (or \colors", whether \red" or \yellow ") until the prescribed ICDF becom es satis ed. W hen a system of polydisperse particles is considered, this scheme should be modi ed; this would be a subject of future research.

Our lifting operator for single realization computations requires additional consideration when 1D -TW s are present: particle locations obtained from earlier simulation at the same \phase angle" during the wave propagation have to be used. In ensem ble-averaged com putations, the oscillatory motion becomes smoothed, requiring no special attention.

Coarse projective integration. We choose discretized ICDFs of the lighter particles as the coarse observables, and accelerate the demixing computation using coarse projective forward Eulerscheme [17, 18]. For sm aller U_s , where the bed hardly expands and ICDFs do not oscil-




FIG. 3: (Color online) Evolving inverse CDFs (ICDFs) for the same case as in Fig.1, averaged over 10 realizations: (A) ICDF of particles physically located in the upper half of the bed, and (B) ICDF of the lighter particles, which are shown at t = 150. Solid lines with negative slopes are snapshots of the di erence between (A) and (B) at di erent times; com pare with the functional t shown as dashed lines; see Eq. §).

late, the projection step size is determ ined by only the tem poralsm oothness (accuracy of the local linearization) of ICDF evolution. The dem ixing occurs very slow ly in this case (Fig. 2 (a)), and these computations can achieve high computational speedup. Excessively large projection steps can cause inaccuracies, sim ilar to large time steps in norm al integration. In the presence of 1D-TW s, the projection step size is chosen to be an integralm ultiple of the local oscillation period (Fig. 2 (b)).

Projectively integrated values (thick lines in Fig. 2) follow the trajectories of direct, full integrations (thin lines in Fig. 2) well, con m ing that these coarse observables are good continuum variables. Ensem ble-averaging of ICDFs over di erent realizations (of di erent phase angles during wave propagation) sm oothens local oscillations arising from 1D-TW s. Projective integration of ensem ble-averaged ICDFs, both in the presence and absence of 1D-TW s, can be applied in the sam e way.

A more compact description. The di erence between the ICDF of particles located in the upper half of the bed (irrespective of their densities) and that of the lighter ones can serve as a useful coarse observable; ICDFs of the lighter particles are bounded by those of the (total) top half particles, and their di erence is positive de nite (Fig.3). Furtherm ore, once nearly-full local dem ixing occurs, the ICDF di erence there becom es virtually zero. The di erence of the two ICDFs can be t by the following sim ple functional form (dashed lines in Fig.3):

where A (t); B (t); C (t), and D (t) are our new coarse observables, determ ined on the y by functional tting, and x and y represent the abscissa and the ordinate in Fig. 3 respectively. O ther basis functions, such as high-order polynom ials also can t the functional form reasonably w ell, but they require m any m ore term s and the tim e evo-




FIG. 4: (Color online) Comparison between direct, full integrations (solid lines) and coarse projective integrations (groups of dots), using the four coarse observables in Eq. (3).

lution of their expansion coe cients is not generally slow. Lifting for these new coarse observables involves a m inor interm ediate step: m apping between these four variables and an ICDF discretization through the functional form in Eq. (3).

We use these four coarse observables to perform ensemble-averaged coarse projective integration over a number of realizations (Fig. 4). These observables vary slow by and sm ooth by in time (occasional oscillations disappear for larger ensembles); in a sense, this is a pseudospectral solution of the unknown governing equations for ICDF evolution.

Conclusions. We have used an \equation-free" coarse-

grained approach to accelerate (by a factor of two to ten; the lifting step in our study involves m inimal com putational e ort) computations of dense particulate ow s and, in particular, of dem ixing occurring in gas- uidized beds of dissim ilar particles. This approach holds prom ise for the prediction of coarse-grained behavior at practically relevant spatial and tem poral scales.

We deliberately considered a quasi-1D illustrative problem in our study, in order to demonstrate the viability of the approach. As a consequence of the problem considered in this study, the coarse observables were onedimensional discretized ICDFs. For systems involving higher dimensional ows, candidates for coarse observables may include marginal and conditional ICDFs [23]. More work for such systems has to be done to identify proper coarse observables and an e cient lifting operator, vital components of this approach. Ensemble averaging reduces uctuations among the realizations, giving better quantitative representations; the computation of each realization readily parallelizes across com putational nodes.

More sophisticated equation-free algorithms (e.g. coarse xed point algorithm s 20) can be used to nd stable as well as unstable steady states; quantify their stability; and perform num erical bifurcation analysis. Exploiting such tools to investigate the coarse-grained dynam ics of m ixing and dem ixing (and other particulate ow problem s) is the subject of current research.
