# Chiral scattering in com plex m agnets

#### A bstract

G eneral properties of the chiral scattering of polarized neutrons are considered for two possible axial vector interactions: Zeem an energy and non-alternating D zyaloshinskii-M oriya interaction. Behavior in m agnetic eld of helical m agnetic structures is discussed for M nS i and m agneto-electric m aterials. The dynam ical chiral uctuations in m agnetic eld are considered brie y. The chiral uctuations in m aterials with the D zyaloshinskii-M oriya interaction are discussed and an assumption is m ade that above the transition tem perature they have to be incom m ensurate.

## 1 Introduction

Spin chirality (SC) is determined as a vector product  $S_R = S_R \circ$ . It enters in the right-hand side of the expression for the time derivative  $dS_R = dt$  and known also as spin current. Its study is very important for complete understanding of som e magnetic systems. For example the SC along with the spin density are relevant variables for the second order phase transition in frustrated triangular-lattice antiferrom agnets (1). This theoretical suggestion was experimentally con rm ed in (2), (3) (see also (4), (5)).

There are two kinds of the spin chirality: i) Static chirality which displays itself as helical structure in ordered magnets. ii) The chiral uctuations. However the last are described by the four spin correlation function  $h[S_R \quad S_R \circ]; [S_{R_1} \quad S_{R_1}^\circ]$  i. Unfortunately it can not be measured by existing methods.

However using polarized neutrons one can study uctuations in the chiral channel which are described by vector chirality (4), (5)

connected to the antisymmetric part of the magnetic susceptibility:

The chiral contribution to the magnetic neutron scattering is given by (4), (5)

where  $\hat{Q} = Q = Q$ , P is the neutron polarization and the factor N<sub>0</sub> is the same as in conventional magnetic scattering.

The scattering intensity and P are a scalar and an axial vector respectively. So C has to be an axial vector also. It is possible if the system has an intrinsic axial vector too. There are following possibilities: i) Constant magnetic eld or the sam ple magnetization. ii) N on-alternating D zyaloshinskii-M oriya interaction. iii) M agnetic helical structure with de nite sense of the spin rotation. W e consider all these possibilities below.

## 2 Static chirality

We begin with simple ("ferrom agnetic") helix (4), (6) (7) where for the lattice spin we have

where  $A = (\hat{x} \quad i\hat{y})=2$  and  $\hat{x}_i\hat{y}_i\hat{z}$  are orthogonal unit vectors. If = 0 and = -2 we have plain helix and ferror agnet respectively.

Replacing  $\hat{z}$ !  $\hat{z} \cos k_{AF}$  R and k!  $k + k_F$  we get antiferrom aghetic helix which becomes an antiferrom agnet if = =2.

For the simple helix the scattering intensity is given by

where K is the reciprocal lattice point. For the AF helix in these equations we must replace K  $\,!\,$  K  $_{\rm AF}$  .

The sum I + I<sub>+</sub> changes sign if k ! k. In centrosymmetrical crystals the helical structure is degenerated in respect of sign of the vector k and real sample consists of dom ains with opposite k directions. In the case of equal dom ain population the chiral scattering disappears. Unequal population m ay be accidental as was observed in C sM nB r<sub>3</sub> (3) or articially prepared by cooling the sample below  $T_N$  at an inversion symmetry breaking condition. In the case of Z nC r<sub>2</sub>S e<sub>4</sub> the single dom ain state was attained by cooling in crossed electric and magnetic elds (8). In H o unequal dom ain population was obtained using elastic torsion (9). In both these cases the external action works as the intrinsic D zyaloshinskii-M origa interaction which xes a single k structure and leads to strong chiral scattering.

To the best ofm y know ledge the non-centrosym m etric cubic M nS i helim agnet was the only compound where the static chirality was studied throughout (10), (11), (12), (13). In M nS i we have k = (2 = a) [; ; ] where ' 0.017, a = 0.4558nm and the spins rotate in the perpendicular plane (10), (11). In complete agreement with Eq.(4) the polarized neutrons allow to suppress one of the k satellites of the Bragg scattering [1].

However in the magnetic eld new features were found: i) Ferrom agnetic spin con guration takes place in the eld H  $_k$  along the vector k if H  $_k >$  H  $_{Ck}$  ' 0:6T (15). A coording (16) we have  $H_{Ck}$  '  $Ak^2$  where A is the spin-wave sti ness. This expression is in agreement with existing experimental data. Below  $H_{Ck}$  we have  $\sin = H_k = H_{Ck}$ . O by by above  $H_{Ck}$  the static chirality disappears but it has to rem ains in the spin-wave channel (16). ii) In the low perpendicular eld H<sub>2</sub> the second harm onic  $k_2 = 2k$  appears with corresponding chiral contribution.W ith increasing of  $H_2$  the vector k rotates toward the eld and at H 0:1T where is the spin-wave gap it turns along the eld. Simultaneously the second harm onic disappears (12), (13). This behavior was explained in (16) as a consequence of mixing spin-waves with momenta q and k in perpendicular eld and Bose condensation of the spin-waves with q m om enta q = 0 and k.Sim ilar phenom ena were observed in B a<sub>2</sub>C uG e<sub>2</sub>O<sub>7</sub> [(17) and references therein]. However in these papers the chirality has not been studied.

We discuss in such details the M nSi helical structure transform ations in magnetic eld having in m ind new magneto-electric materials RM nO<sub>3</sub> (R = G d; T b; D y), N  $i_3V_2O_8$  etc. where helical magnetic structure and the DM interaction appear simultaneously with the inversion symmetry breaking transition (18), (19), (20), (21), (22).

As the static chirality takes place in any helical magnets its experimental study in these magneto-electrics can elucidate real magnetic structures and their transformations in magnetic eld di erently directed relative the crystal axes. Preliminary theoretical consideration of the related problems will be

published soon (23).

#### 3 Chiral uctuations; general properties

Properties of the chiral uctuations including the spin-wave scattering are determined by the symmetry properties of the axial vector responsible for the chirality. This problem was considered throughout in (4) for two cases i) Magnetic eld and ii) Non-alternating DM interaction. We present here the nalresults only.

i) D ynam icalchirality. M agnetic eld ist-odd: it changes sign at time rejection t! tand Im C (Q;!) is even function both ! and Q. In classical lim it when ! Twe can replace the Bose factor in Eq.(2) by T=!. As a result the chiral scattering changes sign with ! in agreement with experiment (2), (3), (24) and has to be zero at ! = 0. So we have hot static chirality in magnetic eld. In this approximation the ! integrated chiral scattering is zero.

ii) The DM chirality. The DM interaction between two spins has the form

It can not change if 1, 2. So we have

or in momentum space  $D_Q = D_Q$ . Besides the Dzyaloshinskii vector is teven. As a result Im C (Q;!) is the odd function of both Q and !. Particular in the classical limit the ! integrated DM chirality is not zero but changes sign with Q.

In noncentrosymmetric crystals in magnetic eld the function Im C has not simple symmetric properties. As an example the spin-wave scattering in cubic magnets with the DM interaction in strong eld was considered in (16), and in antiferrom agnets (25).

In the centrosymmetric crystals below  $T_N$  the spin-wave chiral scattering have the same symmetry as in the DM case if one has the single domain sample.

4 D ynam ical chirality

W e do not give here detailed survey of the of the dynam ical chirality as in may be found in (4), (5) and mention only recent achievements in this eld.

In (26) the chiral scattering in spin-singlet quasi-1D compound  $Sr_{14}Cu_{24}O_{41}$  was studied. The singlet triplet transitions with dimensions of the triplet spin were examined.

Sm all-angle critical chiral scattering in ferrom agnet E uS was studied in (27). In weak magnetic eld this scattering is described by the three spin correlation function with the neutron and the eld momenta Q and zero respectively. A coording theory (so called Polyakov-K adano -W ilson operator algebra (29), (30), (31)) if in multi-spin correlation function the momentum Q >> inverse correlation length and other momenta the Q dependence appears as a factor  $Q^{(5+1=)}$  where is the correlation length exponent. As a result the chiral scattering becom es proportional to (T T<sub>c</sub>) (see (4) and references therein). For ferrom agnets ' 0:67. This nontrivial theoretical prediction was checked = 0.67(7). Corresponding result for E uS is for iron with = 0:64(5). So for the second order phase transition the operator algebra is now con med experim entally.

#### 5 DM chirality

To the best of my knowledge up to now the DM chiral uctuations were studied in M nSi only (32) (33). I know also an attempt to observe them in C sC oC  $l_3$  (9). In (33) the data of the sm all angle polarized neutron scattering above  $T_N$  are mainly in agreement with simple mean eld theory which takes into account the following interactions (34): conventional exchange, isotropic DM interaction and anisotropic exchange. Corresponding expression for the scattering intensity is given by (33)

where k is approximately equal to the helix wave-vector at low T (see Sec. II),  $[\hat{Q}^4] = \hat{Q}_x^4 + \hat{Q}_y^4 + \hat{Q}_z^4$  is a cubic invariant, g is a constant proportional to the strength of the anisotropic exchange and is an inverse correlation length. U sually near the second order phase transition (T T). In the mean eld theory = 1=2. How ever it was found that = 0:62(1). Moreover it was found that the last term in the denom inator has to be replaced by  $([\hat{Q}^4 \ 1=3])^{0.22(5)}$ . These new critical exponents dem and theoretical explanations.

General form of the critical scattering is unusual also. The last  $g^2$  term in the denom inator is very sm all. Neglecting it for P = 0 we obtain that the critical scattering is maxim al at the sphere Q = k instead of to be maxim al at the positions of the B ragg peaks below  $T_N$ . For the fully polarized neutrons the chiral term in Eq.(7) suppresses the scattering at Q = P and the scattering

intensity has form of halfm oons depending on sign of P as was observed in (33). The intensity is peaked at the B ragg positions very close to  $T_N$  where becomes comparable with gk.Expression  $[\hat{Q}^4]$  1=3 has minimal equal to zero along cubic diagonals and if gk we have conventional critical uctuations in these directions.

For M nSi we have incommensurate critical uctuations. Apparently it is a general situation in the case of the non-alternating DM interaction. This statement is con rm ed by exact solution of the 1-D chain with the DM interaction and 3-D mean eld calculations (35) (4).

In this respect the mean eld results for the critical uctuations in weak ferrom agnets such as M nCO<sub>3</sub> are very instructive. In this case there are three principal interactions: isotropic exchange, easy plain anisotropy and the DM interaction in perpendicular z direction. A fler sim ple calculations (cf. (4), (33), (35)) we have

where is proportional to the strength of the DM interaction, vector q is the distance to the nearest antiferrom agnetic B ragg point and the functions G  $_z$  and G  $_2$  are given by

where  $[Aq]^2 = A_2 q_2^2 + A_z q_z^2$ ,  $T_0$  is the transition temperature if one neglects both the anisotropy and DM interaction,  $T_z = T_0$  where is the strength of the anisotropy and  $T_2 = T_0$   $^2=(4A_z)$ .

We see that there are two mean eld transition temperatures and incommensurate uctuations in the perpendicular and chiral channels. At the same time the low T weak ferrom agnets are commensurate structures. So there are two possibilities: i) There is the rst order transition to the weak ferrom agnetic state; ii) the critical uctuations suppress the incommensurability. The problem dem ands further experimental and theoretical investigation.

## 6 Conclusions

The spin chirality is an important complem entation to conventional magnetic neutron scattering if the system as whole has an intrinsic axial vector such as the magnetic eld and the non-alternating DM interaction.

The static chirality (helical magnetic structure) is sensitive to external magnetic eld and its study may be useful for understanding som e features of new magneto-electric materials.

The D ynam ical chirality has provided nontrivial information in dierent elds of magnetism and became an usual tool of magnetic neutron scattering.

The study of the DM chiral uctuations is now at very beginning but prom ises unusual results.
