The Ferm ion M onte Carlo revisited

Abstract

In this work we present a detailed study of the Ferm ion M onte C arlo algorithm (FM C), a recently proposed stochastic m ethod for calculating ferm ionic ground-state energies. A proof that the FM C method is an exact method is given. In this work the stability of the method is related to the di erence between the lowest (bosonic-type) eigenvalue of the FMC di usion operator and the exact ferm i energy. It is shown that within a FMC fram ework the lowest eigenvalue of the new di usion operator is no longer the bosonic ground-state eigenvalue as in standard exact D i usion Monte Carlo (DMC) schemes but a modied value which is strictly greater. A coordingly, FMC can be viewed as an exact DMC method built from a correlated di usion process having a reduced Bose Fermigap. As a consequence, the FMC method is more stable than any transient method (or nodal release type approaches). It is shown that the most recent ingredient of the FM C approach MH.Kalos and F.Pederiva, Phys. Rev. Lett. 85, 3547 (2000)], namely the introduction of non-symmetric guiding functions, does not necessarily in prove the stability of the algorithm. We argue that the stability observed with such guiding functions is in general a nite-size population e ect disappearing for a very large population of walkers. The counterpart of this stability is a control population error which is di erent in nature from the standard Di usion M onte C arlo algorithm and which is at the origin of an uncontrolled approximation in FMC.We illustrate the various ideas presented in this work with calculations perform ed on a very simple model having only nine states but a full \sign problem ". A lready for this toy m odel it is clearly seen that FM C calculations are inherently uncontrolled.

I. IN TRODUCTION

In theory quantum M onte Carlo (QMC) techniques [1] are capable of giving an exact estim ate of the energy with an evaluation of the error: the statistical error. Unfortunately, such an ideal situation is not realized in practice. Exact results with a controlled nite statistical error are only achieved for bosonic systems. For ferm ionic systems, we do not have at our disposal an algorithm which is both exact and stable (statistical uctuations going to zero in the large simulation time regime). This well-known problem is usually referred to as the \sign problem ". The usual solution to cope with this di culty consists in de ning a stable algorithm based on an uncontrolled approximation, the so-called Fixed-Node approximation. [2, 3, 4, 5, 6, 7] In practice, the xed-node error on the energy is sm all when one uses good trial wavefunctions and, thus, QMC methods can be considered today as reference m ethods to com pute groundstate energies as shown by a large variety of applications [5, 8, 9, 10, 11, 12, 13]. However, the accuracy of the results is never known from the calculation, it is known only a posteriori, for example by comparison with experimental data. Exact methods, which are basically transient methods [14, 15, 16, 17] including the nodal release m ethod [14], have been applied with success only to very speci c m odels (sm all or hom ogeneous system s) for which the sign instability is not too severe (sm all Bose-Ferm i energy gap).

Recently, K alos and coworkers [18] have proposed a method presented as curing the sign problem, the so-called Ferm ion M onte C arlo method (FM C). This work makes use of two previously introduced ingredients, a cancellation process between \positive" and \negative" walkers introduced by A mow et al. [19] and a modi ed process correlating explicitly the dynamics of the walkers of di erent signs.[20] The new feature introduced in [18] is the introduction of non-symmetric guiding functions. The method has been tested on various simple systems including free ferm ions and interacting systems such as the ³He uid.[18, 21] The results are found to be compatible with the assumption that the method is stable and not biased. However, this conclusion is not clear at all because of the presence of large error bars. The purpose of this work is to present a detailed analysis of the algorithm and a de nitive answer to this assumption.

The content of this paper is as follows. In section II we give a brief presentation of the \sign problem ". The sign instability in an exact DMC approach comes from the blowing up

in in aginary time of the undesizable bosonic component associated with the lowest m athem atical eigenstate of the H am iltonian (a wavefunction which is positive and symmetric with respect to the exchange of particles). The uctuations of the transient energy estim ator grows like $e^{t(E_0^F - E_0^B)}$, where E_0^F is the ferm ionic ground-state energy (here and in what follows, the superscript F stands for \Ferm ionic") and E_0^B , the lowest m athem atical eigenvalue of the H am iltonian (the superscript \B" standing for Bosonic). In Sec. III we brie y recall them ain elements of the standard DM C m ethod, the basic stochastic algorithm simulating the imaginary-tim e evolution of the H am iltonian. In section IV, we describe the FM C m ethod as a generalization of the DM C m ethod and we show that FM C is an exact m ethod, that is, no system atic bias is introduced. This section is made of two parts. In a rst part we introduce the notion of positive and negative walkers to represent a signed wavefunction in DM C. This will help us to view the FM C m ethod as a generalization of the DM C m ethod, the FM C introducing two important m odi cations with respect to DM C : a correlated dynam ics for positive and negative walkers and a cancellation process for such pairs whenever they m eet.

In section V we study the stability of the algorithm . We prove that the FMC method is in general not stable, the uctuations of the transient estim ator of the energy growing exponentially like $e^{t(E_0^F - E_0^B)}$ where E_0^B is the low est boson ic-like eigenvalue of the generalized di usion process operator associated with FMC whose expression is given explicitly. It is shown that FMC is more stable than the standard nodal release DMC method because $E^{\,B}_{\,0} > E^{\,B}_{\,0}$. In section VIwe illustrate our theoretical results using a toy model, a \m in im al" quantum system having a genuine sign problem (two coupled oscillators on a nite lattice). The di erent aspects of the FMC method are highlighted in this application. In the case of non-sym metric wavefunctions introduced recently in Ref.[18] it is shown that, in contrast with DMC where the population control error decays linearly as a function of the population size, the FM C decay displays a much more slower power law. As a consequence, one needs a very large population of walkers to rem ove the control population error and to observe the instability of FM C. Let us emphasize that observing such a subtle nite population e ect for a genuine many-ferm ion system is actually in possible. Here, to illustrate this in portant point num erically, we have been led to consider a very simple system having only a few states. For this system, a large population of walkers -eventually much larger than the dimension of the quantum Hilbert space itself-can be considered. The results obtained in that regime

con m our theoretical ndings, in particular the fact that the stability of the algorithm presented elsewhere [18] is only apparent. As an important conclusion, we emphasize that the FMC control population error is an uncontrolled approximation for realistic ferm ion system s.

II. FERM ION INSTABILITY IN QUANTUM MONTE CARLO

We consider a Schrodinger operator for a system of N fermions,

where we note $R = (r_1 ::: r_N)$ the 3N coordinates of the N particles in the three dimensional space. In this expression, the rst term is the kinetic energy (r² is the Laplacian operator in the space of the 3N coordinates). The second term, V, is the potential. DMC techniques are based upon the evolution of the H am iltonian in imaginary time. We express this evolution using the spectral decom position:

where $_{i}$ are the (norm alized) eigenfunctions of H, E_i are the corresponding eigenvalues and E_T is a so-called reference energy. The fundam ental property of operator (2) is to liter out the lowest eigenstate $_{0}$. To understand how it works, we consider the time evolution of a wavefunction f₀ (R)

and calculate the overlap with an eigenstate i

From this expression it is easily seen that the component on the lowest eigenstate $_0$ is growing exponentially faster than the higher components. In DMC methods the function f_t is generated using random walks. For t large enough the lowest eigenstate

is produced. This asymptotic behaviour makes DMC an accurate method for computing the properties of $_0$, in particular the energy E_0 . Unfortunately, for ferm ionic systems the

physical groundstate ${}_0^F$, which is antisymmetric with respect to the exchange of particles, is not ${}_0$, but som e \m athem atically" excited state because ${}_0$ is positive and symmetric for a Schrödinger operator (bosonic ground-state). For the sake of clarity, we shall denote from now on this bosonic ground-state as ${}_0^B$ and its energy, E_0^B . The necessity of extracting an exponentially sm all component to evaluate E_0^F or any fermionic property is at the origin of the fermion instability in quantum M onte C arlo.

We now give a quantitative analysis of this instability. Since the asymptotic behaviour of f_t is not useful to compute the ferm ionic energy, we consider the transient behaviour of the evolution of f_t . Basically, exact m ethods [14] Her out ${}_0^F$ by projecting the transient behaviour of f_t on the antisymmetric space. Introducing the antisymmetrization operator A, one obtains the physical groundstate for t large enough

since the components of f_t over the higher antisymmetric eigenstates are decreasing exponentially with respect to the component on ${}_0^F$. In practice, the fermionic energy E_0^F is calculated using an antisymmetric function ${}_T$ and using the fact that, at large enough t, one has

In the long-time regime the stochastic estimation of the R H S. of Eq.(7) is unstable. In essence, the signal, the antisymmetric component of f_t , mettons des virgules.... decreases exponentially fast with respect to f_t , Eq.(5). The signal-over-noise ratio behaves like e $t(E_0^F - E_0^B)$ and, thus, an exponential growth of the uctuations of the DMC estimator, Eq.(7), appears.

Now, let us give a more quantitative analysis by writing this estimator and evaluating the variance. In a standard di usion M onte C arb calculation, the time-dependent distribution f_t is generated by a random walk over a population of walkers fR $_i$ g. Formally f_t is given in the calculation as an average at time t over D irac functions centered on the walkers and weighted by some positive function $_G$

In this expression, h:::i denotes the average over populations of walkers fR $_{i}$ g obtained at the given time t. The function $_{G}$ is usually called the importance or guiding function.

Replacing f_t in (7) by its expression (8), the estim ator of the energy reads for large enough t

In practice, both numerator and denominator are computed as an average over the N $_{\rm S}$ walkers produced by the algorithm at time t. As a consequence, the energy is obtained as

The ratio $\frac{N}{D}$ is an estimator of the energy for N_S large enough, when the numerator and denominator have small uctuations aroung their average. Now, let us evaluate the uctuations of this ratio in the limit of a large population N_S

Here, we have used the hypothesis that the uctuations of the denom inator and the num erator are very sm all. U sing the fact that N and D are statistical averages over independent random variables with the same distribution one obtains

W e can replace these averages by integrals over the distribution f_{t-G} , Eq.(8)

which con rms quantitatively that the statistical error grows exponentially in time. Let us emphasize that this problem is particularly severe because the Bose-Ferm i energy gap, $_{B}$ $_{F}$ E_{0}^{F} E_{0}^{B} , usually grows faster than linearly as a function of the number of particles. In practice, one has to nd a trade-o between the system atic error coming from short projection times t and the large uctuations arising at large projection times.

III. THE DIFFUSION MONTE CARLO METHOD

The FMC method is a generalization of the well-known DMC method. Presenting this algorithm is a useful preparation for the next section about Ferm ion Monte Carlo. The

DMC method generates the function f_t following the imaginary time dymamics of H

where f_0 is a positive function. The imaginary time dynamics is produced by iterating many times the short-time G reen function e $(H = E_T)$ where is a small time step. The distribution f_{t^0} at the time t^0 t + is then obtained from f_t as follows

where the density f_t is sampled by the population of walkers fR $_i$ g. U sing the D irac ket notation, f_t given by Eq.(8) is rewritten as

where $_{G}$ is some positive function, the so-called guiding function. Let us show how the density f_{t^0} is generated from the distribution (16). Replacing in (15) the function f_t by the R H S. of (16) one has

The operator L is the sum of the so-called Fokker P lanck operator (22) and a local operator (23). Using this decomposition, the vector e^{L} jR_ii appearing in the average (19) can be rewritten for small enough time step as follows

The action of e^{L} on jR_{i} is sampled as follows. The short-time dynamics of the Fokker Planck operator (26) is performed by the way of a Langevin process,

where runs over the 3N coordinates (three space coordinate for each ferm ion), and $_{\rm i}$ are independent gaussian random variables centered and norm alized

The averaged Langevin process (28) is equivalent to apply the short-time dynamics of the Fokker Planck operator (26):

being a normalization term, called the branching term. The new walker R_i^0 is duplicated (branched) a number of times equal to w_i in average. This process is a birth-death process since some walkers can be duplicated and some can be removed. The population of walkers uctuating, one has to resort to control population techniques. [22, 23, 24] W ith these two processes, di usion and branching a new population of walkers fR $_i^0$ is produced, representing in average the desired result :

From (19) and (32) one can see that the distribution f_{t^0} is sampled by the new population of walkers fR 0_1 g according to (16)

In summary, by iterating these two simple operations, namely the Langevin and branching processes, the DMC method allows to simulate the imaginary time dynamics of the Ham iltonian, thus producing a sample of f_t , Eq.(16). Various properties of the system can be computed from this sample, e.g. ground-state bosonic energies, [2, 3, 25] excited-state energies, [16, 17] and various observables. [26, 27, 28, 29, 30, 31, 32]

For the vast majority of the DMC simulations on fermionic systems, only an approximation of the exact fermionic ground-state energy is computed, namely the so-called Fixed-Node energy. [3, 5, 8, 33, 34, 35] In a xed-node DMC calculation the guiding function is chosen as $_{\rm G} = j_{\rm T} j$ where $_{\rm T}$ is some fermionic antisymmetric trial wavefunction. With this choice, the guiding function vanishes at the nodes (zeroes) of the trial wavefunction and the drift vector diverges. As a consequence, the walkers cannot cross the nodes of $_{\rm T}$ and are conned within the nodal regions of the conguration space. It can be shown that the resulting DMC stationary state is the best variational solution having the same nodes as $_{\rm T}$. In other words, the \Fixed-Node" energy obtained from the R H S of (9) or (10) is an upper bound of the exact ferm i energy, $E_0^{\rm FN} > E_0^{\rm F}$. [33, 34] Note that, in practice, $E_0^{\rm FN}$ is in general a good approximation of the true energy. [8, 35]

In the present work, we are considering \exact" DMC approaches for which the exact ferm ionic energy calculated from expression (9) is searched for. A s discussed in the previous section, such exact DMC calculations are fundam entally unstable. A fam ous example of an exact DMC approach is the nodal release m ethod of C eperley and A kler.[14, 34] B asically, nodal release m ethods are standard DMC m ethods where the xed-node distribution (sam – pled w ith a standard F ixed-N ode DMC) is chosen as initial distribution f₀. In exact m ethods the guiding function $_{\rm G}$ is strictly positive everywhere, so that the walkers can cross the nodes of the trial wavefunction. Exact ferm im ethods are client in practice only when the convergence of the estimator is fast enough, that is, when it occurs before the blow ing up of uctuations, Eq. (13). In practice, two conditions are to be satisted. First, the xed-node wavefunction $_{\rm O}^{\rm FN}$ m ust be already close enough to the exact solution $_{\rm O}^{\rm FN}$. For this reason the choice of the trial function $_{\rm T}$ (quality of the nodes of $_{\rm T}$) is crucial. Second, the B ose-

Ferm i gap, $_{B}_{F} = E_{0}^{F} = E_{0}^{B}$, which drives the asymptotic behaviour of the uctuations, Eq. (13), must be small. The quantity $E_{0}^{F} = E_{0}^{B}$ depends only on the Ham iltonian at hand; there is no freedom in the nodal release method to modify the asymptotic behaviour. We will de ne in the next section the Ferm ion M onte C arb method (FMC) as a generalization of the DMC method and show in sections V and VI that, in contrast with the nodal release method, the FMC method can improve substantially the asymptotic behaviour, Eq.(13).

IV. THE FMC METHOD

A. Prelim inary: Introducing positive and negative walkers in DM C

In Ferm ion M onte C arb a dynam ics on a signed function f_t is performed. In what follows, we show that DMC can be easily generalized to the case of a signed distribution f_t and, thus, FMC can be viewed as a simple generalization of DMC. If f_t carries a sign, it can be written as the di erence of two positive functions

To sample these expressions, two independent DMC calculations can be carried out. The positive part f_t^+ is then sampled by a population of walkers fR $_i^+$ g (called \positive" walkers). The distribution f_t^+ is related to fR $_i^+$ g as in Eq.(16)

Note that we consider here the general case where the guiding functions associated with the positive and negative walkers, $_{g}^{+}$ and $_{g}$, are di erent. Finally, the dynam ics of positive

and negative walkers is described by the DMC-like di usion operators

B. The detailed rules of FM C

In a few words, the FMC method is similar to a DMC method on a signed function, except that the positive and negative walkers are correlated and can annihilate whenever they meet. The Langevin processes are correlated in such a way that positive walkers and negative walkers meet as much as possible. A cancellation procedure is then performed when a positive walker and a negative walker meet. We will see in the next section that this cancellation procedure is at the origin of an improved stability of the algorithm. In this section we give a complete description of the algorithm and show that this algorithm does not introduce any system atic bias.

In FMC the guiding functions $_{G}^{+}$ and $_{G}$ are not arbitrary, they are related under any permutation P of two particles as follows

Various choices are possible for the guiding functions. Here, we consider the form proposed by K alos and Pederiva, [18] namely

where $_{\rm S}$ is a symmetric (Bose-like) function, $_{\rm T}$ an antisymmetric trial wavefunction, and c some positive mixing parameter allowing to introduce some antisymmetric component into

Having in m ind this choice for the guiding functions we will show how the two DMC processes over the two populations of walkers fR $_{i}^{+}$ g and fR $_{i}$ g can be replaced by a di usion process over a population of pairs of walkers f(R $_{i}^{+}$; R $_{i}$)g. We rst show how the DMC process can be modiled to maintain as many positive and negative walkers during the simulation. In the DMC dynamics, the branching terms associated with the positive and negative walkers are in general dilement. As a consequence, the number of positive walkers N $_{s}^{+}$, can be dilement from the number of negative walkers N $_{s}^{-}$. At time t the DMC density f_t reads

This form ula is obtained by replacing in equation (34) the expressions (37) and (38) for f_t^+ and f_t , respectively. If N_s^+ and N_s^- are di erent, we will replace f_t^- (48) by a new function g_t^- sampled with an equal number of positive and negative walkers. Such an operation does not introduce any bias if the antisymmetric components of the future evolution of f_t^- and $g_t^$ are identical. Indeed, only the antisymmetric component of f_t^- contributes to the estimator of the energy, Eq. (7). At time $t^0 > t$ the two densities are given by

This condition is satisfied whenever A $(f_t g_t) = 0$. The important conclusion is that one can replace f_t by any function g_t such that the difference $g_t f_t$ is orthogonal to the space of antisymmetric functions. Let us now show how this property can be used to impose a common number of walkers in the positive and negative populations.

Let us consider the case where there are more positive walkers than negative walkers, $N_s^+ > N_s$. In this case one can substract from f_t , Eq.(48), the following vector

This possibility of transfering one walker from one population to the other one allows to keep an identical number of walkers for the two populations at each step. Now, thanks to this possibility, it is possible to interpret the two populations consisting of the N_s positive walkers R_i⁺ and the N_s negative walkers R_i (i 2 [1:N_s]) as an unique population of N_s pairs of walkers f (R_i⁺; R_i)g. Following this interpretation, the density f_t (48) can be then rew ritten as an average over a population of pairs of walkers

(i) Langevin step The Langevin processes (44) are simulated as in DMC, except that the gaussian random variables of the positive and negative walkers are no longer independent. The positive walker R_{i}^{+} and the negative walker R_{i}^{-} are m oved according to Eq.(44)

D i erents ways of correlating positive and negative walkers can be considered. We shall employ here the approach used in Refs.[18, 20] which consists in obtaining the vector \sim_i , representing the 3N coordinates \sim_i , from \sim_i^+ by relaxion with respect to the hyperplane perpendicular to the vector R⁺_i R⁻_i.

This relation between the gaussian random variables makes the move determ inistic along the direction R_i^+ R_i . Such a construction insures that the walkers within a pair will meet each other in a nite time (even in large-dimensional spaces). This aspect will be illustrated numerically in the last section. Form ally, the two correlated Langevin processes can be seen as one Langevin process in the space of pairs of walkers

This density is the sum of two contributions. The rst contribution, Eq.(67), com es from a pair of walkers (R_{i}^{+} ; R_{i}) and carries the weight w_{i} . The second, Eq.(68), com es from a single positive walker R_{i}^{+} and carries the weight w_{i}^{+} w_i. This single walker R_{i}^{+} can be replaced by a pair as follows. First, this single walker can be replaced by two positive walkers R_{i}^{+} with half of the weight, $\frac{1}{2}(w_{i}^{+} - w_{i})$. One of these two positive walkers carrying half of the weight can be transferred to the population of negative walkers by exchanging two particles. Finally, this single walker R_{i}^{+} can be replaced by a pair (R_{i}^{+} ; PR_{i}^{+}) carrying the weight $\frac{1}{2}(w_{i}^{+} - w_{i})$. The resulting process just described is a branching of the pair (R_{i}^{+} ; R_{i}) with the weight w_{i} and the creation of the pair (R_{i}^{+} ; PR_{i}^{+}) with the weight $\frac{1}{2}(w_{i}^{+} - w_{i})$. O f course, if one has $w_{i}^{+} < w_{i}$, then, the pair (R_{i}^{+} ; R_{i}) is branched with the weight w_{i}^{+} and the pair (PR_{i} ; R_{i}) is created with the weight $\frac{1}{2}(w_{i} - w_{i}^{+})$.

Both cases, $w_i < w_i^+$ or $w_i > w_i^+$, can be summarized as follows. The pair of walkers $(R_i^+; R_i)$ is branched with the weight

This is a cancellation procedure because a pair $(R_1^+; R_1^+)$ with a multiplicity 1 has been transformed into a pair with a multiplicity smaller than one. Note that, when $_G^+ = _G^-$, the multiplicities (73) or (74) reduce both to zero. In other words, there is a total cancellation of the pair whenever the walkers meet. A swe shall see in the next section, the cancellation step is at the origin of the improved stability. The basic reason is that this procedure removes pairs which do not contribute to the signal but only to the statistical noise. A rigorous analysis of this point is provided in the next section.

V. STABILITY OF THE FMC METHOD

A. Criterium for stability

We have just seen that the FMC method is a generalization of the DMC approach and we have shown that FMC preserves the evolution of the antisymmetric component of the sampled density. Now, having shown that FMC is an exact method, it is necessary to study the stability of the method. For that purpose, we consider the estimator of the energy, Eq. (58), in the large-time regime

If the pairs of walkers are not independent this expression is only modiled by a correlation factor independent on the time and the population size N_s provided that N_s and t are large enough. Finally, up to a multiplicative factor, the variance of the energy estimator has the following asymptotic behaviour

In expression (83) we note that the behaviour of (76) at large times t is related to the value of E_0^F and the asymptotic behaviour of the number of pairs of walkers N_s (t). We can already understand physically the interest of the cancellation process: this process limits the grow th of N_s (t) the number of pairs of walkers, thus limiting the grow th of C (t) (83) and the variance (82). Let us now precise this criterium more rigorously by evaluating the asymptotic behaviour of N_s (t). For that purpose we introduce the density of pairs $_t(R_1^+;R_1)$, this density obeys a di usion equation we write down

The number of pairs N $_{\rm S}$ (t) behaves as the normalization of $_{\rm t}$, and consequently grows like e $^{\rm t(E'_{0}^{\rm B}-E_{\rm T})}$. Note that in practice one adjusts the reference energy E $_{\rm T}$ to E $_{0}^{\rm B}$ during the simulation to keep a constant population of average size N $_{\rm S}$ along the dynam ics. Such a procedure is referred to as a control population technique [24] and will be discussed later. Finally, the asymptotic behaviour of the variance of the FMC estimator of the energy is

This expression is analogous to (13) except that the lowest energy of the Ham iltonian operator H has been replaced by the lowest energy of the operator D_{FMC} . In conclusion the stability of the algorithm is related to the lowest eigenvalue of the FMC di usion operator, E_0^B . It is clear from (86) that the higher this eigenvalue is, the more stable the simulation will be. In the next section, we will discuss the allowed values of E_0^B . This will prove that FMC is not a stable method in general, but is more stable than any standard transient method. B. Stability of the Ferm ion M onte Carlo algorithm

In this section we prove that the lowest eigenvalue of the FMC operator, \mathbf{E}_0^{B} , has the following upper and lower bounds

>From the expression of the variance, Eq. (86), one can easily understand the meaning of these two inequalities. The st inequality indicates that FMC is not a stable method, the stability being achieved only in the lim it $E_0^B = E_0^F$. Note that, even for very simple system s, this stability is in general not obtained. This important point will be illustrated in the next section. The second inequality shows that FM C is more stable than any standard transient DMC method (nodal release method). Indeed, the exponent associated with the explosion of uctuations, Eq. (86), is smaller than in the standard case, Eq.(13). Before giving a m athem atical proof of these two inequalities, let us rst present som e intuitive argum ents in their favor. The rst inequality, Eq. (87), takes its origin in the fact that the signal-the antisym m etric component of f_t , Eq.(6) is extracted from the population of pairs of walkers, Eq.(57), and, consequently, cannot grow faster than the population of pairs itself, Eq.(85). The second inequality can be understood as follows. W ithout the cancellation process, the FM C method reduces to two correlated DM C algorithm s. The number of walkers grows as in a standard DMC, namely $e^{(E_0^B - E_T)t}$. The cancellation process obviously reduces the grow th of the population of walkers, Eq. (85), and, thus, we should expect that $E_0^B > E_0^B$. Now, let us give some more rigorous proofs. For that purpose we compare the Fermion M onte Carlo operators with and without cancellation process. W ithout the cancellation process the FM C di usion operator reads

The term in Eq.(90) is a coupling term between the moves of positive and negative walkers taking into account the correlation of the gaussian random variables $^+$ and . The quantities c (R $^+$; R) introduced in Eq.(90) are nothing but the covariance of these variables

The three last contributions describe the branching processes at work in FM C. One recognizes in Eq.(91) the branching of a pair, Eq.(69). The two following contributions, Eqs.(92) and (93), correspond to the creation of pairs (R^+ ; P R^+) and (P R^- ; R), with the respective weights given by (70) and (71). Note that in Eqs.(92,93) the operator $e^{(P R_- R^+)r^+}$ is written in a symbolic form representing a translation of the vector R^+ to P R^- , the action of this operator on the pair (R^+ ; R^-) being indeed to create the pair ($P R^-$; R^-).

Now, let us prove that the lowest eigenvalue of D is E_0^B (bosonic ground-state). For that purpose, it is convenient to introduce the operator R which transforms a distribution of pairs of walkers into a distribution of walkers and then to de ne the following reduced density #

To simplify the notations let us suppose that we are in the symmetric case for which $_{G}^{+} = _{G} = _{G}$ (the common guiding function is symmetric under permutation of particles). This particular case is much simple because when walkers meet, there is a full cancellation and no residual branching. From an operatorial point of view the cancellation step consists in introducing a projection operator, P_{c} , at each step of the dynamics

It is important to realize that the D_{FMC} operator dened via P_c and D (Eqs.(102) and (93)) represents indeed an equivalent operatorial description of the stochastic rules of FMC

described in section IV B (Langevin, branching and cancellation steps). Note also that using the expression (103) of D_{FMC} , we have a simple alternative way of recovering the proof just presented above that FMC is a bias-free approach. Since this is an important point of this work, let us present this alternative proof. In the case of the energy, the estimator can be written as a function of the reduced density as follows

Indeed, the action of P_c present in the de nition of D_c , Eq.(103), consists in removing positive coe cients within the extradiagonal part of D. As well-known, a consequence of such a matrix (or operator) manipulation is to increase the energy of the lowest eigenvalue of

the matrix. Expressed in a more physical way, the cancellation process reduces the growth of the population of pairs: $e^{(E_0^B - E_T)t} < e^{(E_0^B - E_T)t}$.

To sum marize, we have shown that FMC reduces the instability of ferm ion simulations. The signal-over-noise ratio decreases as $e^{iE_0^B - E_0^T it}$, where E_0^B is the lowest eigenvalue of the FMC operator, D_{FMC} . Because of the inequality (108), this ratio decreases slower in FMC that in any standard transient DMC or nodal release methods. We have shown that the cancellation process is at the origin of this in provement; however, as we shall see in the next section, the cancellation process is e cient (i.e., we have a small difference $E_0^B - E_0^F$) only if the correlation between walkers described by the coupling term s c is introduced. This feature is in portant, particularly in high-dimensional spaces where the probability of meeting and cancelling becomes extremely small for independent walkers. As a result, the correlation of positive and negative walkers is a fundamental feature of FMC. The quantitative e ect of the correlation on the stabilization of the algorithm is not easy to study theoretically and to optim ize in the general case. In the next section we will give a numerical illustration, for a simple system, of the interplay between cancellation and correlation (via the c parameters), and also of the role of the choice of the guiding functions, $\frac{1}{6}$ and $\frac{1}{6}$.

VI. NUMERICAL STUDY

A. The model: 2D -harm onic oscillator on a nite grid

In this section we study the FMC method on a very simple model on a lattice. For this model it is possible to calculate E_0^F (ferm ionic ground-state energy), E_0^B (bosonic ground-state energy), and E_0^B the lowest eigenvalue of the FMC operator by a standard determ inistic method (exact diagonalization). The results obtained for this simple model will provide us with a well-grounded framework to interpret the Ferm ion M onte Carlo simulations. The second motivation is that, using such a simple model, it is possible to study the limit of large number of walkers, large with respect to the dimension of the H ilbert space considered. This possibility turns out to be essential to better understand the FMC algorithm.

Our model is based on the discretization of a system describing two-coupled harmonic oscillators

This Ham iltonian is symmetric with respect to the inversion P of center O = (0;0).

A sa consequence, the eigenfunctions are either sym metric or antisym metric under P.W e are interested in the energy E_0^F of the lowest antisym metric eigenstate, ${}_0^F$. Even for this simple system, we are confronted with a sign instability and a genuine \sign problem ". Indeed, the sign of ${}_0^F$ for each grid point cannot be entirely determined by symmetry. Symmetry implies only that ${}_0^F$ vanishes at the inversion center and that the two-dimensional pattern of positive and negative values for ${}_0^F$ is symmetric by inversion. The precise delimitation between positive and negative zones of the wavefunction (analogous to \nodal surfaces" for continuous system s) is not known.

Let us now introduce the trial functions $_{T}$ and $_{S}$. $_{T}$ has to be an (antisymmetric) approximation of $_{0}^{F}$ and $_{S}$ some symmetric and positive approximation of the lowest eigenstate, $_{0}^{B}$. We have chosen them as discretizations of the exact solutions of the initial

continuous model. To not these solutions we perform a diagonalization of the quadratic form of the potential

Note that, in the lim it of a very large system the trial functions, $_{\rm T}$ and $_{\rm S}$ reduce to two exact eigenstates of H; however, this is not the case for nite system s.

B. FMC on the lattice

Before presenting our results, let us say a few words about the implementation of the FMC on the lattice. The same ingredients as in the continuum case hold, except that in the lattice case the Langevin process is realized through a discrete transition probability matrix. The probability for a (positive or negative) walker i to go to j, after a time step is

Let $(i_1; i_2)$ represents a given pair of positive and negative walkers $(R_{i_1}^+; R_{i_2})$. In a standard di usion M onte C arb (no correlation and no cancellation of positive and negative walkers), the density of pairs of positive and negative walkers $(k_{i_1})_{i_1,i_2}^{(k)}$ evolves as follows in one time-step

where W is the Feynman-Kac weight, Eq.(45). To build the FMC algorithm, one rst correlate the two stochastic processes P⁺ and P , Eq.(122). The way it is performed here is the counterpart of the correlation term introduced by Liu et al. [20] in the continuum case, Eq.(63). W ith such a choice, the positive and negative walkers of a pair tend to get closer or to move away in a concerted way. For the lattice case it is done as follows. The positive walker j_1 is connected by P⁺ to a nite number of states j_1^c (here, maximum ve) with probability P⁺ (j_1 ! j_1^c). The negative walker j_2 is connected to a nite number of states j_2^c with the probability P (j_2 ! j_2^c). The states j_1^c are ordered taking as criterium the distance to the negative walker j_2 , $\Re_{j_1^c} = \Re_{j_2} j$. We do the same for the states i_2^c ordered by their distance with respect to the positive walker. An unique random number uniform ly distributed between 0 and 1 is then drawn and the repartition functions of the two probability measures, $p(j_1^c) = P^+(j_1 + j_1^c)$ and $p(j_2^c) = P^-(j_2 + j_2^c)$ are then sampled using this common random number. The new pair $(j_1^c; j_2^c)$ is drawn accordingly. Such a procedure de nes a correlated transition probability in the space of pairs

whose role is to enhance the probability of having positive and negative walkers m eeting at the same site. Note that, by construction, the correlation introduced via P_c does not change

the individual (reduced) densities associated with each type of walker (positive/negative). Now, let us write down explicitly the FMC rules in our lattice case, that is, the one time-step $(k \ ! \ k + 1)$ evolution of the density of pairs $j_{j_1 j_2}^{(k)}$:

The operations (128,129,130,131,132,133) describe the one time-step dynamics of the sim – ulation. At iteration k, the distribution of pairs $^{(k)}(i_1;i_2)$ is obtained and the transient estimator of the energy (58) can be computed from

This estimator converges to $E_0^{\ F}$ when $k \ ! \ 1$.

Now, it is important to realize that the FMC rules just presented have, in principle, no stochastic character at all. For a nite system the FMC rules can be viewed as simple determ inistic matrix manipulations between nite vectors of the Hilbert space (here, the multiplications to be perform ed have been explicitly written). At the beginning of the sim – ulation (iteration k = 0) some arbitrary starting vector ${}^{(0)}_{i_1 j_2}$ is chosen and, then, iterations are perform ed up to convergence. This important remark will allow us to organize our discussion of FMC results into two parts. In a rst part (Section VIC), we perform explicitly the matrix multiplications involved and any stochastic aspect is removed from the results. Stated di erently, this procedure can be viewed as performing a standard FMC simulation with an in nite number of walkers (the distribution at each point of the con guration space is exactly obtained, no statistical uctuations are present). In a second part (Section VID), we implement the usual stochastic interpretation of the FMC rules using a nite number of walkers. This second part will allow to discuss the important consequences of the niteness of the number of walkers and, in particular, the role played by the use of population control techniques.

C. FM C using an in nite number of walkers: the determ inistic approach

1. No system atic error: FMC is an exact m ethod

In this section we verify on our simple example that the FMC rules do not introduce any system atic error (bias). The energy expression (134) has been computed by iterating the applications of the elementary operators de ned by (128,129,130,131,132,133). In practice, this corresponds to iterate a matrix G_{FMC} (). The distribution $^{(k+1)}$ at iteration k + 1 is obtained from $^{(k)}$ as follows

The operator G_{FMC} () has been applied a large number of times on some initial density ⁽⁰⁾_{j1j2} (a N⁴ component vector, N being the linear size of our lattice) and the energy (134) has been computed at each iteration k. We have checked that the energy converges to the exact value, E_0^F , corresponding the lowest antisymmetric state, with all decimal places. We have veried that this is true for several cases corresponding to N ranging from 4 to 17. For this specie problem these results conmunicately that FMC is an exact method.

2. Meeting time between positive and negative walkers

Here, we want to illustrate quantitatively the fact that the correlation introduced via the probability transition helps greatly to lower the meeting time between positive and negative walkers. The in uence of the choice of the quiding functions (here, parameter c in Eq.(125)) on the meeting time is also exam ined. The meeting time is de ned and evaluated as follows. We start with a conguration consisting of a positive walker located at a corner of the lattice and a negative walker located at the opposite corner. The positive and negative walkers are m oving stochastically with the transition probability de ned in (122). We test the two cases cases corresponding to uncorrelated and correlated m oves. The average time hT i (num ber of M onte C arlo steps times) before the walkers meet is computed. Our results are presented in Table I and are given for di erent linear sizes of the grid. In this rst case the guiding functions are chosen with a large antisymmetric component, c = 4. The results indicate clearly that more than one order of magnitude is gained by correlating the moves of the two stochastic processes. In Table II the same calculations are done, except that a symmetric guiding function c = 0 ($_{G}^{+} = _{G} = _{S}$) is employed. The average meeting time is found to be much lower than in the non-symmetric case, c = 4, by nearly two orders of magnitude. This is true whether or not the stochastic processes are correlated. This behaviour of the m eeting time as a function of c is not surprising. W hen c is large the two functions $_{\rm G}^+$ and $_{\rm G}$ are localized in the nodal pockets of $_{\rm T}$. In the large-c lim it $_{\rm G}^+$ is zero whenever $_{\rm T}$ is negative and $_{\rm G}$ is zero whenever $_{\rm T}$ is positive. In this lim it the overlap between the two distributions $_{\rm G}^+$ and $_{\rm G}$ is zero and we have a sim ilar result for the probability that walkers meet. >From these preliminary results the introduction of non-symmetric wavefunctions

3. Stability in time of FM C

We know from section V that the stability in time is directly related to the magnitude of the reduced Bose-Ferm i energy gap

seems to deteriorate the stability, this property will be con med in the next section.

where E_0^B is the lowest eigenvalue of the FMC di usion operator. The greater this gap is, the faster the signal-over-noise ratio of the M onte C arlo simulation deteriorates, the full stability

being obtained only when this gap vanishes. The ultim ate goal of an elicient FMC algorithm is to reduce the Bose-Ferm i gap from its bare value $_{B_{F}} = E_{0}^{F} = E_{0}^{B}$ to a value very close to zero (ideally, zero). The energies E_{0}^{B} and E_{0}^{F} can be calculated by exact diagonalization of the Ferm ion M onte C arb operator, G_{FMC} . In practice, we have chosen here to extract this inform ation from large-time behaviour of the denom inator of the energy, Eq. (134). In this regime the denom inator behaves as in Eq. (78) where the reference energy is adjusted to keep the number of pairs constant, $E_{T} = E_{0}^{B}$.

The gap $E_0^F = E_0^B$ has been extracted from the large-k values of D (t = k), a quantity calculated determ inistically by iterating the matrix G_{FMC} . The results for dimensional values of c are reported in Table III. For both the correlated and uncorrelated processes it is found that the gap increases with c. The minimal gap is obtained for c = 0, that is when the guiding functions are symmetric $_{G}^{+} = _{G} = _{S}$. This result is easily explained from the fact that there are two factors which favour the cancellation of walkers. First, as we have already seen, the average meeting time is minimal. Furthermore, a full cancellation between the walkers is precisely obtained when c = 0. In conclusion, the greatest stability is obtained for a symmetric guiding function.

In Table IV the gaps obtained at c = 0 for di erent linear sizes N are reported. This table shows that, in the limit of large grids, that is for a system close to the continuous model, the FMC algorithm reduces the gap by a factor 20. Such a result corresponds to a huge gain in the stability since projection times about twenty times larger than in a standard nodal release method can be used.

D. FMC using a nite number of walkers: the stochastic approach

In the previous section the Ferm ion M onte C arb m ethod has been discussed and im plem ented by m anipulating the exact Ferm ion M onte C arb di usion operator w ithout m aking reference to any stochastic aspect (as already m entioned it is form ally equivalent to use an in nite num ber of walkers). O f course, for non-trivial system s it is not possible to propagate exactly the dynam ics of the FM C operator. A coordingly, a nite population of walkers is introduced and speci c stochastic rules allowing to simulate in average the action of the FM C operator are dened. Now, the important point is that in practice -like in any DM C methodone does not sample exactly the dynamics of the FM C operator because of the population control step needed to keep the nite number of walkers roughly constant. [22, 23, 24] This step introduces a smallm odi cation of the sampled di usion operator which is at the origin of a system atic error known as the population control error. For a bosonic system, the error on the ground-state energy behaves as $\frac{1}{M}$ (M is the average size of the population) and an extrapolation in $\frac{1}{M}$ can be done to obtain the exact energy. For a ferm ionic system, as we shall see below, this behaviour is qualitatively di erent and, furtherm ore, depends on the population control error is fundam ental since, in practice, it is essential to be able to reach the exact ferm i result using a reasonable number of walkers. A swe shall see later, this will not be in general possible with FMC.

In this section the Fermion Monte Carlo simulations are performed using Eqs.(128,129,130,131,132) which allow to propagate stochastically a population of M walkers. The population is kept constant during the simulation by using the stochastic reconguration M onte Carlo (SRMC) method.[23, 24] In short, the SRMC method is a DMC method in which a reconguration step replaces the branching step. A conguration step consists in drawing M new walkers among the M previous ones according to their respective Feynman-K ac weight (for the details, see the references given above).

In Figure 1 the tim e-averaged energy de ned as

is ploted as a function of K. In this form ula N (k) and D (k) represent the num erator and denom inator at iteration k of the estim ator (75) evaluated as an average over the population of pairs. In Figure 2 we plot the time-averaged denom inator given by

The time dependence of this quantity is interesting since it can be used as a measure of the stability of the algorithm .[18] As we have shown above, the algorithm is stable only when the reduced Bose-Ferm i energy gap, $\sim_{B_F} = E_0^F = E_0^B$ is equal to zero. Equivalently, the denom inator (139) must converge to a constant di erent from zero. In our simulations

the number of walkers was chosen to be M = 100, a value which is much larger than the total number of states of the system (here, nine states). Of course, such a study is possible only for very simple systems. As seen on the Figures 1,2, and 3 the results obtained in the case c = 0 (symmetric quiding function) and $c \in 0$ are qualitatively very dimensional event. F igure 1 shows that, within statistical error bars, there is no system atic error on the energy when a symmetric quiding function is used, c = 0. However, the price to pay is that the statistical uctuations are very large. This point can be easily understood by looking at the behaviour of the denom inator, F ig 2. Indeed, this denom inator vanishes at large times, thus indicating that the simulation is not stable. In sharp contrast, for c = 4 (non-symmetric guiding functions), the statistical uctuations are much more smaller (by a factor of about 40) but a system atic error appears for the energy. Furtherm ore, the denom inator ploted in Fig.2 is seen to converge to a nite value. The stability observed in the case c = 4seems to con in the results of K alos et al. [18] for non-symmetric guiding functions (c \in 0). However, the situation deserves a closer look. Indeed, the existence of this nite asymptotic value seems to be in contradiction with our theoretical analysis: the denom inator should converge exponentially fast to zero, and the algorithm should not be stable ($_{B}^{r}$ > 0). In fact, as we shall show now, the asymptotic value obtained for c = 4 and the corresponding stability result from a population control error. To illustrate this point, we have com puted the average denominator as a function of the population size M. Results are reported in Fig.3. On this plot we compare the population dependence of the denominator (139) for c = 4 and for a much smaller value of c = 0.5. The values of M range from M = 100 to M = 6400. A rst remark is that the population control error can be quite large and is much larger for c = 4 than for c = 0.5. In the Appendix it is shown that the theoretical asymptotic behaviour of the error as a function of M is expected to be in 1=M . In the c = 0.5 case, the denominator is clearly seen to extrapolate to zero like $\frac{1}{M}$ In the c = 4 case, we can just say that the data are compatible with such a behaviour but even for the largest M reported in Fig.3 (M = 6400) this asymptotic regime is not yet reached. Much larger populations would be necessary. This result illustrates the great di culty in reaching the asym ptotic regim e, even for such a sim ple system having only nine states. Stated di erently, the stability observed when using non-symmetric guiding functions disappears for a large number of walkers, thus con ming that the stability obtained at nite M is a control population artefact. Note that a large population control error on the denom inator is not surprising. Indeed, when $c \in 0$, the local energies of the guiding functions, Eq.(43), have strong uctuations because _G is far from any eigenstate of H (_G contains a symmetric and an antisymmetric components). In the case of a symmetric guiding function (c = 0), the distribution of walkers is also symmetric at large times and, thus, the average of this distribution on the antisymmetric wavefunction _T must necessarily be zero. Consequently, in the c = 0 case there is no control population error on the denominator, Fig 2.

An example of the behaviour of the energy as a function of the population size M is presented in gure 4. Some theoretical estimates of the energy bias dependence on M are derived in the Appendix. Let us summarize the results obtained. W hen c = 0 (use of a symmetric guiding function), the system atic error behaves as in a standard DMC calculation for a bosonic system

However, the statistical uctuations are exponentially large since the calculation is no longer stable. Now, when c > 0 the system atic error has a radically dimension. For a population size M the control population error grows exponentially as a function of the projection time t

where \sim_{B} _F is the reduced Bose-Ferm i energy gap. This dependence of the control population error as a function of the projection time is of course pathological and is a direct consequence of the use of non-symmetric guiding functions. Now, because of the form (141) it is clear that a population size exponentially larger than the projection time is necessary to remove the system atic population control error. In practical calculations, for a given population of walkers M, one has to choose a nite projection time, t. This time has to be small enough to have a small nite population control error but, at the same time, large enough to extract the exact ferm ionic groundstate from the initial distribution of walkers. The best comprom ise is easily calculated and leads to the follow ing expression of the system atic error as a function of the number of walkers (for more details, see the Appendix)

and _F is the usual Fermigap (energy dierence between the two lowest fermionic states).

In gure 4 some numerical results for the c = 4 and c = 0.5 cases are presented. The number of walkers considered are M = 100;200;400;800, and M = 1600. No data are shown for the symmetric case, c = 0, because of the very large error bars, see Fig.1. The calculations have been done for the smallest system, N = 3 (recall that the nite con guration space consists of only nine states) and for very large numbers of M onte C arlo steps (m ore than 10^8). As it should be, the system atic errors are found to be larger for the c = 4 case than for the c = 0.5 case (note that the data corresponding to M = 800 and M = 1600 m ust not be considered because of their large statistical noise). The concavity of both curves con rm s our theoretical result, < 1, Eqs.(142,143). However, it is clear that to get a quantitative estimate of this exponent is hopeless because of the rapid increase of error bars as a function of M. The only qualitative conclusion which can be drawn by looking at the curves is that c= 4 < c= 0.5, in agreem ent with our form ula, Eq.(143). Finally, let us insist on the fact that, despite these very intensive calculations for a nine-state con guration space, no controlled extrapolation to the exact energy is possible.

To sum marize, when $_{\rm G}$ has an antisym metric component, the error is expected to decrease -for M large enough-very slowly as a function of the population size [algebraically with a (very) small exponent], while in the symmetric case the bias has a much more interesting $\frac{1}{M}$ -behaviour. However, in this latter case the price to pay is the presence of an exponential grow th of the statistical error. In both cases, and this is the fundam ental point, the number of walkers needed to get a given accuracy grows pathologically. In addition, as illustrated by our data for the very simple model problem treated here, the asym totic regimes corresponding to the 1=M -behaviour appear to be very di cult to reach in practice (very large values of M are needed).

VII. CONCLUSION AND PERSPECTIVES

The FM C m ethod di ers from the DM C m ethod by correlating the di usion of the walkers and introducing a cancellation procedure between positive and negative walkers whenever they meet. In this work we have shown that the Ferm ion M onte C arb approach is exact but in general not stable. FM C can be viewed as belonging to the class of transient DM C m ethods, the m ost fam ous one being probably the nodal release approach. [14, 34] H ow ever,

in contrast with the standard transient m ethods, FM C allows to reduce in a system atic way the ferm i instability. The importance of this instability is directly related to the magnitude of som e \e ective" Bose-Ferm i energy gap, $\sim_{B} _{F} = E_{0}^{F} - E_{0}^{B}$, where E_{0}^{F} is the exact Ferm i energy and E_0^B some e ective Bose energy. We have seen that this gap is intimately connected to the the cancellation rate, that is to say, to the speed at which positive and negative walkers cancel. We have shown that $E_0^B < E_0^B < E_0^F$, where E_0^B is the standard bosonic ground-state energy. As an important consequence, the closest $E_0^{\,B}$ is from the exact ferm ionic energy, the sm oother the sign problem is. For the toy m odel considered, the reduction obtained for the instability is very large (orders of magnitude). For large dimensional systems, there are strong indications in favor also of an important reduction. A rst argument is purely theoretical. In FMC the walkers within a pair $(R_i^+; R_i)$ are correlated in a such a way that R_i^+ R_i^- makes a random move only in one dimension. As a result there is a high probability that the walkers meet in a nite time even if they move in a high-dimensional space. The second argument is numerical. As shown by previous authors, the impact of correlating walkers on the average meeting time is important even for much larger system s.[18, 21]

We have shown that the recent introduction of nonsymmetric guiding functions in FMC introduces a large system atic error which goes to zero very slow ly as a function of the population size $[1=M, = F=(\tilde{B}_{B}+F)]$ and $F=E_{1}^{F}=E_{0}^{F}$ is the usual fermionic gap]. For an in nite number of walkers, this system atic error is removed and the algorithm recovers the Fermi instability. Morever, we have shown that using such guiding functions does not in general in prove the stability. For a large enough number of walkers, the simulation can be less stable than the simulation using a symmetric guiding function. Finally, it is important to emphasize that the conclusion of this work is that the FMC algorithm is not a solution to the sign problem. However, it is a promising way toward \improved" transient methods. As a transient method, FMC is expected to converge much better than a standard nodal release method. We are presently working in this direction.

APPENDIX: POPULATION CONTROLERROR IN FMC

FMC, like any M onte Carlo m ethod using a branching process, su ers from a so-called population control bias. This system atic error appears because the branching rules (creation/annihilation of walkers) are in plemented using a population consisting of a large but nite number of walkers. Nothing preventing the population size from implosing or exploding, a population control step is required to keep the average number of walkers nite. A standard strategy to cope with this di culty consists in introducing a time-dependent reference energy whose e ect is to slightly modify the elementary weights of each walker by a common multiplicative factor (close to one) so that the total weight of the population remains nearly constant during the simulation. This step, which introduces som e correlation between walkers and, therefore, slightly modi es the stationary density, must be perform ed very smoothly to keep the population controlerror as small as possible. In practice, for standard DMC calculations done with accurate trial wavefunctions and population sizes large enough, the error is found to be very small, in general much smaller than the statistical uctuations. As a consequence, the presence of a population control bias is usually not considered as critical. Here, the situation is rather di erent. In FMC the use of bosonic-type quiding functions introduces very large uctuations of the local energy and the cancellation rules a very sm all signal-over-noise ratio for ferm ionic properties. In this case, it is not clear whether the bias can be kept small with a reasonable number of walkers.

In this section we present an estimate of the population control bias in FMC. As we shall see our estimate shows that the sign problem is actually not solved but attenuated in FMC (an exponentially large number of walkers is needed to maintain a constant bias as the number of electrons is increased). The derivation presented in this section is very general: it is valid for any exact ferm ion QMC method based on the use of a nodeless bosonic-type reference process and some projection to extract the Ferm i ground-state. A coordingly, we have chosen not to use the speci c fram ework and notations of FMC but, instead, notations

of a general DMC algorithm (transient method). O fcourse, we do not need FMC to introduce nonsymmetric guiding functions. The adaptation of what follows to FMC is straightforward.

In quantum M onte C arb we evaluate stochastically the following expression for the lowest eigenstate of energy E $_0^{\rm F}$

where f_0 is some positive initial distribution and $_T$ an approximation of the eigenstate with energy E_0^F . Here, we deal with a ferm ionic problem so $_T$ must be antisymmetric. The expression (144) gives the exact energy E_0^F only when taking the limit t ! 1. In practice for a nite t, there is a systematic error

This is our basic formula expressing the system atic error at time t resulting from the use of a nite population. Now, let us evaluate this expression in the large time t and large M

regimes. First, we consider the two denom inators appearing in the R H S.ofEq.(159). Let us begin with the denom inator of the second ratio:

This denom inator is the usual quantity evaluated during the simulation. It is an approximate quantity since it does not include the corrective weights. The asymptotic behaviour of D_a depends on $_{\rm G}$. We distinguish two cases:

(i) If $_{G}$ is symmetric (c = 0), the stationary density (t large enough) is symmetric. Consequently, D_a, which is the average of an antisymmetric function, converges to zero exponentially fast at large times. For M large enough, in a regime where the dynamics is close to the exact dynamics of the Ham iltonian, we know that the convergence is given by

Finally, we have just proved that, when the guiding function is not symmetric, the asymptotic behaviour of the denominator is $D_a / \frac{1}{M}$. This important result is in agreement with the numerical data shown in gure (3). Using exactly the same arguments, the asymptotic behaviour (large M, large t) of the difference of the two numerators in the R H S. of expression (159) is found to be the same as $D_a - D_e$

This is true because no error compensation are present, E_{F}^{t} and E_{F}^{M} being generally of the same sign (both positive). Our numerical results on the toy model give an illustration of this property. >From both equations (174) and (145) one can deduce the simulation time corresponding to such a system atic error

Let us make some important comments. First, note that in this formula the dependence on the guiding function is not included in the exponent, only in the prefactor. Second, this formula shows that the FMC algorithm reduces the systematic error by lowering the exponent. As already mentioned, the gap is equal to $E_0^F = E_0^B$ in a standard release node method and equal to $E_0^F = E_0^B < E_0^F = E_0^B$ in FMC. Third, in the zero-limit gap, the $\frac{1}{M}$ behaviour of the systematic error is recovered. This formula shows that the number of walkers needed for a given accuracy, , grows exponentially with respect to the number of electrons. Indeed, although the gap is indeed reduced by FMC, there is no reason not to believe that it will still be proportional to the number of electrons. In consequence, the \sign problem " fully remains in FMC.

Finally, let us write the system atic error as a function of the nite population M by inverting the preceding equation (177)

This latter equation shows very clearly the respective role played by the Ferm igap, $_{\rm F}$, and the reduced Bose-Ferm igap, $\sim_{\rm B}$ $_{\rm F}$.




FIG.1: N = 3 Energy estimator as a function of the projection time (number of iterations K). Comparaison between c = 0 (large uctuations) and c = 4 (sm all uctuations). The exact energy is $E_0^F = 1.86822$:. Number of walkers M = 100. Number of M onte Carlo steps: $4:10^7$.




FIG. 2: N = 3 Denom inator as a function of the projection time (number of iterations K). Comparaison between c = 4 (upper curve) and c = 0 (bwer curve). Number of walkers M = 100. Number of M onte Carlo steps: $4:10^7$.




FIG.3: N = 3, time-averaged denominator, Eq.(139), as a function of 1=M.




FIG.4: N = 3 Energy, Eq.(134), as a function of 1=M for the c = 0 and c = 4 cases. Exact energy: E $_0^F = 1.86822...$ (horizontal solid line)
