O scillatory vortex interaction in a gapless ferm ion super uid with spin population im balance

U sing e ective eld theory approach we study a hom ogeneous super uid state with a single (gapless) Ferm i surface, recently suggested as a possible phase for an ultracold Ferm i gas with spin-population in balance. We nd an unconventional form of the interaction between vortices. The presence of gapless ferm ions gives rise to an additional, predom inantly attractive, potential oscillating in space, analogous to the RKKY m agnetic interaction in metals. Our study then leads to an interesting question as to the nature of the vortex lattice in the presence of the com petition between the usual repulsive logarithm ic C oulom b and the ferm ion-induced attractive oscillatory interactions.

Recently a beautiful array of vortices has been observed in the M IT experiment of ultracold Fermigases, providing a denitive evidence for super uidity in this class of systems. [1] When fermionic excitations are either fully gapped or located at a few nodal points such as in a d-wave superconductor, the physics of vortices belongs to the universality class of the X Y m odel where the phase of the super uid order parameter plays the dom inant role. In this case, the vortex sector of the X Y m odel is described by the logarithm ic C oulom b interaction between the vortices.

The developm ent of imbalanced (spin-polarized) cold Ferm i gases is set to alter this standard picture in a fundam ental fashion, with a number of exotic super uid states recently proposed or revisited [2, 3, 4]. One of those states commonly found in various theoretical approaches [5, 6, 7] is a hom ogeneous gapless ferm ion super uid with a single Ferm i surface (FS) on the molecular side of the Feshbach resonance (the BEC regime). We will call this phase BP1 (breached-pairing state with a single Ferm i surface) after Ref. [8] (also dubbed as m agnetized super uid" and denoted SF_M in [6]). Two recent experiments on the polarized Fermi gases have brought the subject to the frontier in the cold atom physics [9]. Several theoretical works have found an analogue of the BP1 in the trap - the super uid-norm alm ixture phase. [10] It is then of great interest to exam ine properties of this novel super uid.

In the present work, we study the e ect of gapless ferm ionic excitations on the vortices in the BP1 phase by explicitly incorporating these excitations in the low – energy e ective eld theory. The resulting interaction between vortices is no longer of the pure C oulom b form, but contains an additional ferm ion-induced contribution that is attractive (between the vortices with the same vorticity) and oscillates on a length scale set by the spin polarization, analogous to the R uderm an-K ittel-K asuya– Yosida (RKKY) m agnetic interaction in m etals. The Bogoliubov-quasiparticle energy spectrum in a system of two ferm ion gases with an equal mass and unequal chemical potentials is given by [2] (~ 1)

Since our treatment concerns the super uid phase realized on the BEC side of the Feshbach resonance, < 0 in what follows. For de niteness, we assume that > 0. is su ciently large (i.e., if =2 > $^{2} + ^{2}$), the If lower branch E, of the above dispersion is gapless, with a single e ective FS. For brevity, we hereafter denote it as "k. W hen linearized in the vicinity of the e ective FS, this gapless dispersion adopts the generic form $"_{k} =$ v_b (jkj k_b), parameterized by the \Fermi velocity" v_b and the radius $k_b = [6^2 n_b]^{1=3}$ of the \breached-pairing Ferm i ball" in momentum space, where $n_b = n_{\#}$ n" (here $n_{\#} > n_{"}$, as follows from > 0).

In the present context, the super uid phase eld represents the phase of the complex Cooper pair am plitude (h " $_{\#}i = h$ " $_{\#}ie^{i}$) and can be separated into a (singular) vortex part and a smoothly uctuating eld viar (x;) = a + r (x;), where a is the vortex gauge eld. Let us consider a static con guration of vortex lines of unit winding number, all parallel to the z-axis, with a \vortex charge" density distribution $^{(2)}$ (x x). The gauge eld a is re-(x) = 2lated to by the standard equation r = a = a₀ (x)ê_z, where $_0 = \sim = m$ (~ restored for clarity) is the circulation quantum. In momentum space this reads q $a_{q} =$ $i_0 \sim (q) \hat{e}_z$, where q is a two-dimensional wave-vector $(q e_z = 0)$ of the phase uctuations and $\sim (q)$ the Fourier transform of (x). For convenience, we adopt the Coulom b gauge r a = 0 in which the vector eld a is purely transverse (q = 0).

We start from a low-energy e ective Lagrangian for

the gapless branch of the B ogoliubov quasiparticles (described by the eld (x)) and the super uid phase eld. This Lagrangian obeys two globalU (1) symmetries, one of which corresponds to the total atom number conservation (U_c(1)), and the other one to the conservation of spin population in balance (U_s(1)). Son and Stephanov [7] rst constructed an elective Lagrangian of this kind for the case of small gapless ferm ion density (corresponding to small spin population in balance) to obtain a phase

to small spin population imbalance) to obtain a phase diagram. Here, we extend their approach to an arbitrary spin population imbalance. [11]In the imaginarytime path-integral form alism, our elective Lagrangian reads

' stands for higher-order derivative terms of where ' the eld; j= (r r)=(2m $_{\rm p}$ i), where m $_{\rm p}$ = 2m is the mass of the Cooper pair; "(ir) is the gapless ferm ion dispersion, written in the coordinate representation. The phenom enological parameters c_1 , c_2 , and c_3 are not constrained by the U (1) sym m etries, but can be determ ined from the Galilean-invariance of the ferm ionindependent part of the above Lagrangian ; $c_1 = 0n=0$ (where $n = n_{*} + n_{\#}$), while c_2 and c_3 are related to the super uid density in a manner to be described shortly. An alternative e ective theory, formulated in terms of majority-species original ferm ions rather than Bogoliubov quasiparticles, is given in Ref. [12].

B ecause the Lagrangian has to be invariant under the $U_c(1)$ particle number symmetry ! + , it contains the coordinate and time derivatives of , but not itself. Recast in terms of and a, it adopts the form

We derive an elective phase-only action S[] S [;a] by integrating out the ferm ionic degrees of freedom: $e^{S[]} = D(;) e^{S[;]}$, where S[;] = 0 d dx L is the Euclidean action corresponding to $(k_{\rm B} T)^{-1}$). In order to acthe last Lagrangian (complish this, we rst note that the ferm ion eld enters the Lagrangian (3) through a quadratic form K = $(G_0^{1} + X)$, where $G_0 = [0^{(ir)}]^{1}$ is the noninteracting ferm ion propagator, and $X = X^{(1)} + X^{(2)}$ where X (1) = $c_3 i \theta$ + $\frac{1}{2m_p i}$ (r a) r and X $^{(2)}$ = $\frac{c_3}{2m_p}$ (r a)² are respectively of the rst and second order in elds and a. Integrating out the elds gives

rise to the ferm ion contribution to the action S[;a]:

We expand (4) to rst order in X $^{(2)}$ (tree level) and to second order in X $^{(1)}$ (one-loop order). The elective phase-only action S [;a] is then obtained by gathering S_F [;a] and the ferm ion-independent term s of the original action. In momentum -frequency space (q (q;i!_1))

where the rst and second term s correspond to the propagating G oldstone m ode and the topological vortex part of the broken $U_c(1)$ sym m etry, respectively. [Sum m ation over repeated indices in the last equation is im plicit.] Here (q) is the ferm ion density polarization bubble, while

represent the longitudinal and transverse current-current correlation functions, respectively, with k_2 being the transverse component of the three-dimensional vector k with respect to q.

It is important to point out that there is no RPA -type correction from the interaction vertex j r to the transverse current-current correlation function; this is manifest in our choice of the C oulom b gauge for the topolog-ical gauge eld a.

The magnitude of wave-vector q of the phase uctuations has an upper cuto of order k = $(2m)^{1=2}$, a momentum scale corresponding to the pairing gap. This choice of momentum cuto is a consequence of the BP1 phase being realized in the strong-coupling regime on the BEC side of the Feshbach resonance, where is related to the binding energy of a Feshbach molecule. It is also important to emphasize that typical jj is not necessarily small with respect to $k_{\rm b}$; the latter is controlled by the spin imbalance and can be arbitrarily small.

It is straightforward to show that $R_{ij}(q) = R(q)_{ij}$. Consequently, the phase-only action in Eq. (5) in the zero-tem perature static lim it reduces to

where P_q^0 and R_q^0 are the zero-tem perature static lim its of P (q) and R (q), respectively.

The super uid mass density $_{s} = n_{s}m_{p}$, which plays the role of rigidity in the present problem (\spin-wave" sti ness in the XY-m odel term inology), can be identied from the long-wavelength (q ! 0) lim it through the relation

This equation constraints the coe cients c_2 and c_3 , which reduces the phase-only action in Eq. (8) to

which is free of the phenom enological param eters of the original theory.

Integrating out the phase eld in the action (10), taking account of the fact that $R_{q=0}^{0} = P_{q=0}^{0}$, leads to the following elective action for vortices

(Since the vortex gauge eld belongs to the classical sector of the theory, the derived e ective action contains only the $!_1 = 0$ part). The last result, combined with the identity $\sim (q) \sim (q) = (q^2 = \frac{2}{0})(a_q = a_q)$, yields the e ective vortex interaction potential:

T hus besides the conventional long-range component proportional to $1=q^2$, we have an additional component

induced by the gapless ferm ions.

R esponse function P_q^0 has to be calculated num erically. Yet, prior to num erical com putations, P_q^0 can be reduced to a two-dim ensional principal-value integral

where momenta k and q are expressed in units of $k_{\rm b}$. For smallq (jqj< 0:1k), numerical evaluation becomes troublesome because of the strongly singular character of the integrand in Eq. (14). However, in the limiting case jqj! 0, by replacing dispersion "_k with its linearized form ("_k ! v_b(jkj k_b)) we can derive the analytical result $P_{\rm q}^{\rm O}$! $k_{\rm b}^{\rm t}=(6\ ^2v_{\rm b})$. Since $v_{\rm b}=j$? "_k=0kj_{kj=k_{\rm b}}, the last result can be expressed as




FIG.1: Transverse current response function P_q^0 as a function of dimensionless momentum, for m = 1:0 and =j j = 2:0. Values of k_b are given in units of k.

Some typical results of numerical evaluation of the response function P_q^0 for $j\!\!\!/ j\!\!\!/ 0.1k$ are displayed in Fig. 1 (where $2k_b < k$). The salient characteristic of these results is a knee-like feature at $j\!\!\!/ j\!\!\!/ j\!\!\!/ = 2k_b$, which rejects the existence of an elective FS of diam eter $2k_b$. It bears analogy to the $2k_F$ -feature of the param agnetic spin susceptibility in 3D, responsible for the RKKY indirect-exchange interaction in metals, albeit the $2k_b$ -feature found here comes from the current-current correlator so that it is not directly related to the RKKY interaction. The values of P_q^0 obtained analytically in $j\!\!\!/ j\!\!\!/ j\!\!\!/ 0$ lim it dier just slightly from numerical values at $j\!\!\!/ j\!\!\!/ j\!\!\!/ 0.1k$, indicating that P_q^0 can be approximated as a constant in this numerically-inaccessible region $0 < j\!\!/ j\!\!/ j\!\!< 0.1k$.

By exploiting the rotational invariance of the induced potential in momentum space, in real space we obtain

where $J_0(x)$ is the zeroth-order Bessel function of the rst kind. Our num erical calculations for di erent values of relevant param eters (k_b ;) show that the induced potential has RKKY-like oscillating behavior, with attractive character ($dV_{\rm ind}$ =dr > 0) at short distances. To

calculate the e ective vortex interaction potential, given by the sum of V_{ind} and the repulsive logarithm ic part $V_0(\mathbf{r}) = ({}_0^2 n_s = 2m_p) \ln (\mathbf{k} \mathbf{r})$, we have computed the super uid density by adapting the method of Ref. [13] to the special case of a single gapless FS.

In order to elucidate the realm of validity of our e ective theory and make contact with experiments, it is useful to estimate the physical healing length = $(8 n_{s}a_{m})^{1=2}$ (a_{m} being the molecular scattering length), with the inverse of the momentum scale k . It is known that in the strong-coupling BEC regime of a super uid Ferm i gas with equal populations of two hyper ne spin components the molecular scattering length is given by $a_m = 0.6 a_f$ (a_f being the scattering length between ferm ionic atom s). [14] For a polarized Ferm i gas, as shown by Sheehy and Radzihovsky, am decreases m onotonously as a function of the polarization and vanishes at the boundary of rst-order phase transition to the phase separated state. Therefore, right at the boundary to phase separation and in the immediate vicinity of it the coherence length becomes much greater than k¹, thus making the quantitative implications of our theory not directly applicable in this special case. Taking $a_m (P = 0)$ in place of a_m , together with typical values of $n_s = n \text{ and } = F (F = k_F^2 = (2m), \text{ where } k_F = (3^2 n)^{1-3}$ is the momentum scale set by the total ferm ion density) in the BEC regime, we estimate that is of the same order as k¹ when j j 1-100. By taking into account the fact that $=k^{1} / (a_{m} = a_{f})^{1=2}$, we can infer that the above estimate is just slightly modied as a result of am decreasing in the vicinity of the phase separation line.

As our calculations dem onstrate, the e ective vortexvortex interaction shows three characteristic types of behavior, i.e. three polarization-dependent regimes. The critical polarizations corresponding to the boundaries between these di erent regimes are not universal but depend on the actual location in the part of the phase diagram pertaining to the BP1 phase.




FIG.2: E ective vortex interaction potential in real space (in units of), for m = 1:0 and =j j= 2:0. Values of k_b in both plots are expressed in units of k : (a) $k_b = 0.623; 0.724;$ 0.846 correspond to polarizations P = 0.155; 0.227; 0.314, and (b) $k_b = 1.500; 1.352; 1.205$ correspond to polarizations P = 0.763; 0.702; 0.626, respectively.

In the regime of relatively low polarization, the total potential is dom inated by the conventional repulsive logarithm is part; the elective vortex interaction is repulsive ($dV_e = dr < 0$) at all distances. The resulting vortex phase is accordingly expected to be conventional, with triangular vortex arrangement. An example is shown in Fig. 2a.

In the other extrem e - the regim e of high polarization, the induced potential plays a dom inant role at short and interm ediate distances. This renders the total potential attractive at short distances, with pronounced oscillating features resembling the RKKY interaction, as illustrated in Fig. 2b.

The attractive nature of two-body interaction already at short distances suggests an instability of the vortex lattice. However, whether this instability really occurs is still an open question for the following reasons. The physics at distances shorter than the healing length (to be discussed in the next section) is not captured by our e ective theory ; also, the multi-vortex interactions, not considered here but certainly allowed as higher orders in the e ective vortex action, may support unusual vortex phases.




FIG.3: E ective vortex interaction potential in real space (in units of), form = 1:0 and =j j= 1:0. k_b = 1:022 (in units of k) corresponds to P = 0:504.

Apart from these two extreme regimes, in a narrow window of parameters the total potential is repulsive at short distances (r $(2 \ 3)k^{-1}$) and becomes attractive at intermediate ones (Fig. 3).

Due to the nite range of the RKKY-like induced potential, the truly long-distance dependence of the e ective potential (for all polarizations) is governed by the in nite-range repulsive logarithm ic interaction.

In sum m ary, we have found that the vortex interaction potential has a rem arkable form in the gapless ferm ion super uid (BP1), a recently proposed phase for a resonantly interacting in balanced Ferm i gas in the BEC regime. The vortex interaction found here contains an attractive ferm ion-induced potential with the RKKY – like oscillating character, in addition to the usual repulsive C oulom b potential. In the conventional superuids, the point vortices with the repulsive logarithm ic (2D C oulom b) potential would form the triangular lattice. [15] O ur nding of the novel vortex interaction,

therefore, opens up an intriguing question about the vortex lattice structure in the spin-imbalanced gapless ferm ion super uid state.
