Generalized information-entropy measures and Fisher information

A bstract

We show how F isher's inform ation already known particular character as the fundam ental inform ation geom etric object which plays the role of a metric tensor for a statistical di erential manifold, can be derived in a relatively easy manner through the direct application of a generalized logarithm and exponential form alism to generalized inform ation-entropy measures. We shall not shortly describe how the generalization of inform ation-entropy measures naturally comes into being if this form alism is employed and recall how the relation between all the inform ation measures is best understood when described in terms of a particular logarithm ic K olm ogorov-N agum o average. Subsequently, extending K ulback-Leibler's relative entropy to all these measures de ned on a manifold of param etrized probability density functions, we obtain the metric which turns out to be the F isher inform ation matrix elements times a real multiplicative deform ation param eter. The metrics independence from the non-extensive character of the system , and its proportionality to the rate of change of the multiplicity under a variation of the statistical probability param eter space, emerges naturally in the frame of this representation.

1 Introduction

In a previous paper (18), using a form alism based on K olm ogorov-N agum o m eans and generalized logarithms and exponentials, we wrote down the set of entropy functionals, from Boltzam ann-G ibbs entropy through R envi and T sallis, up to Sham a-M ittal (25) and a new entropy m easure, we called the "supra-extensive entropy", so that the increasing generalization of entropy m easures from arithm etic to non-arithm etic m eans, and from extensive to non-extensive systems became particularly compact and visible in its hierarchical structure. Sham a-M ittalm easure was already developed in 1975 but has been investigated in generalized therm ostatistics only recently by Frank, D a ertshofer and N audts ((12), (13) (20)). We showed that Sham a-M ittal's m easure is how ever only one of two possible extensions that unify R envi and T sallis entropy in a coherent picture and described how it com es naturally into being together with another "supra-extensive" m easure if the form alism of generalized logarithm and exponential functions is used. M oreover, we could see how the relation between these inform ation m easures is best understood when described in terms of a logarithm ic K olm ogorov-N agum o average.

In this paper we shall further investigate in particular the power of the deform ed logarithm -exponential form alism with regards to the relationship of generalized entropy measures and F isher inform ation.

F isher inform ation was originally conceived in the 1920s (4), m any years before Shannon's notion of entropy, as a tool of statistical inference in parameter estimation theory. It must be emphasized that F isher's functional is an information, but not an entropy measure. There is nevertheless a strong connection between F isher inform ation and entropy. This relationship has been outlined in m any occasions since R ao (21), already in 1945, laid the foundations of statistical di erential geom etry, called also inform ation geometry (for a m ore recent review of the subject see e.g. Am ari & N agaoka (1)). R ao outlined how a statistical model can be described by a statistical di erential manifold which can be considered as a R iem annian m anifold of parametrized probability distributions (PD) or probability density functions (PDF) with the m etric tensor given by the F isher inform ation m atrix (FIM). The FIM determ ines a R iem annian inform ation m etric on this parameter space, and is therefore called also the F isher m etric. This has been the subject of renewed interest m ore recently also in other branches of inform ation theory, in applications of in age processing, econom etrics and received some attention in theoretical physics, especially in regards to its, still not entirely understood, role in quantum m echanics and perhaps also quantum gravity (see e.g. B R . Frieden's work (5) which tries to derive the laws of physics from a F isherian point of view , or R . C arol's review (2) of some other sin ilar attem pts and references therein).

Less has been done to highlight the links between F isher inform ation and generalized m easures and non-extensive statistics. Som e attempts in this direction were m ade for instance by F. Pennini and A. Plastino (6), M. Portesi, F. Pennini and A. Pennini (7), S. Abe (8), J. N audts ((9), (10)), P. Jizba (11), just to mention some examples. However, we feel that a clear exposition is lacking about the place that the F isher information m easure has in the frame of a generalized statistics. The aim of this paper is to highlight in a synthetic way the relationship that exists between F isher information and the two-parametric generalized entropy m easures here mentioned (R enyi, T sallis, Sharm a-M ittal and the supra-extensivem easure which expands further the picture as a consequence of the q-deform ed form alism) in the sense that diagram of page 14 illustrates, what role the two parameters play in evaluating the F isher information matrix, and how it can be retrieved using a deform ed exponential form alism . W e will focus our attention on how precisely F isher information (except a realmultiplicative factor) emerges naturally as a universal statistical metric tensor for every generalized information-entropy m easure de ned on a manifold of PDFs (i.e. for a continuous version of the above mentioned entropies), and to obtain in a relatively sim plem anner this result using a representation based on generalized logarithm and exponential functions within the frame of a KN form alism .

It should also be mentioned that Renyi entropy is not Lesche-stable (14), isn't convex and does not possess the property of nite entropy production. Therefore any extension of Renyi's entropy, cannot in general possess these properties either. There is some controversy if this is supposed to have its therm odynam ical implications, or not. How ever, the theoretical fram ework we are going to construct here has to be intended in a more general context, it can still have its meaning and applications in inform ation theory, cybernetics or other elds not necessarily restricted to a generalized therm ostatistics. It is with this point of view in mind that we will proceed.

2 The generalized inform ation-entropy m easures

Just to make this paper selfcontained let us brie y sum up the aspects of a generalized informationentropy measure theory which will be relevant to the understanding of the next sections.

2.1 The Boltzm ann-G ibbs entropy and Shannon's inform ation m easure

As is well known the Boltzm ann-G ibbs (BG) entropy reads¹

with p_i the probability of the system to be in the i-th m icrostate, k the Boltzm ann constant. BG entropy becomes the celebrated Shannon information measure (24) if k = 1 (as we will do from now on) and uses the immaterial base b for the logarithm function (we will maintain the natural logarithm b = e)

BG and Shannon's measures are additive, i.e. given two systems, described by two PDs A and B, we have

 $S_{S}(A \setminus B) = S_{S}(A) + S_{S}(B A);$

with S_s (B Å) the conditional entropy. These systems are called extensive systems. This is the case where the total entropy behaves as the sum of the entropies of its parts and applies to standard statistical mechanics. The additive property is rejected in the logarithm function.

2.2 T sallis' entropy

Nature is how ever not always a place where additivity is preserved. This is the case of nonlinear com plex systems, in fractal-ormultifractal-like and self-organized critical systems, or where long range forces are at work (e.g. in star clusters or in systems with long range microscopicm emory), etc. These non-extensive systems have been investigated especially in the last two decades (27).

T sallis generalized Shannon's entropy to non-extensive system s as (26)

with q a real parameter. This is now widely known as T sallis entropy. A coording to a current school of thought at least som e non-extensive systems can be described by scaled power law probability functions as p_i^q , so called q-probabilities. For q ! 1 it reduces to Shannon's measure. T sallis entropy extends additivity to pseudo-additivity

In order to describe T sallis sets the generalized q-logarithm function

turns out to be particularly useful. In a sim ilar way, its inverse, the generalized q-exponential function is

The classical N apier's logarithm and its inverse function is recovered for q = 1. The importance of the q-logarithm in this context is realized if we understand that it satis as precisely a pseudo-additive law

 $^{^{1}}$ Here we begin to introduce a more general symbolism according to which every type of inform ation measure is labeled with $S_{nam e}$ (fP g; fqg) or $S_{nam e}$ (fP g; fqg), where P or P stands for the family fp_ig of PDs or PDFs and S or S for the discrete and continuous cases respectively, while q is a scalar or vector parameter which meaning will become clear in the following sections.

Exploiting this generalized logarithm and exponential form alism T sallis entropy 2.2 can be rew ritten

as

which is sometimes also referred to as the q-deformed Shannon entropy.

Note that $\log_q x \in \log_q x$ when $q \in 1$. This is the reason why, if one thinks in term s of averages, it is more meaningful to write entropy measures with the inverse of the PD, as in the rhs. of 2.6, and why we will prefer this form alrepresentation.

2.3 Renyi's entropy

By looking at the structure of the rh.s. of 2.1 and 2.6 one can de ne an information measure as an average of the elementary information gains

where, what is common to both, is the underlying arithmetic-, or linear mean $I = \frac{1}{1} p_i I_i$.

However, A N.K olm ogorov and M.Nagum o ((17), (19)) showed, already in 1930 but independently from each others that, if we accept K olom ogorov's axiom sas the foundation of probability theory, then the notion of average can acquire a more generalm eaning as what is called a quasi-arithmetic or quasi-linear mean, and can be de ned as !

with f a strictly monotonic continuous function, called the Kolm ogorov-Nagum o function (KN-function). Renyi instead showed (22) that, if additivity is imposed on information measures, then the whole set of KN-functions must reduce to only two possible cases. The rst is of course the linear mean associated with the KN-function

Renyi's information-entropy measure is per de nition a measure where the single information gains are averaged exponentially, and writes

2.4 The Sharm a-M ittal and Supra-extensive entropy

The next step in the generalization process consists in nding a measure which is non-extensive and non-additive but contains T sallis' and R envi's entropies as special cases. One possible way to obtain this goes through an extension of the KN-m ean. This leads to what is known as the Sham a-M ittal entropy (SM) (25). How ever it is only by exploiting the generalized logarithm and exponential representation one retrieves in a compact and fast manner both SM entropy measure and what we used to call the "supra-extensive" (SE) entropy. By using the q-deform ed logarithm and exponential form alism one could easily arrive at a further generalization of R envi and T sallis entropies.

The starting point is the relationship between T sallis and R envientropies

2.16 is SM 's pseudo-additive measure, while 2.17 is a new type of entropy measure we called "supraextensive" because it generalizes to a measure which is neither additive nor pseudo-additive. We could see (18) how the decisive dimensione between these two information-entropies is that SM 's measure can be obtained also through the KN-mean as a two parameter extension of 2.13 (with f(x) = $\log_q e_r^x$ on $I_i = \log_r \frac{1}{p_i}$), while the SE measure does not have such kind of generalization. It can also be shown that for two systems A and B for Sharm a-M ittalentropy (instead of 2.3) one has

This indicates that it is the magnitude of parameter rwhich stands for the degree of non-extensivity, and q stands for a PD deform ation parameter. When r! q the deform ation parameter q of the PD merges into the non-extensivity parameter r(which is the reason why in T sallis entropy it is q instead of r that appears for the non-extensive character of the system).

The supra-extensive entropy 2.17 how ever emerges naturally as a symmetric counterpart of 2.16 when generalized logarithms and exponentials are used. Further mathematical-physical investigations which will clarify the standpoint of the supra-extensive entropy, what kind of statistics it expresses, if any, and its relationship with other measures, is of course desirable and still necessary. A nyw ay, something can be already said. W hat we are going to do here is that we can show how this new entropy also shares a common status in regards to F isher information with all the other measures too.

2.5 The multiplicity

To introduce ourselves to this, note st of all how we can rew rite the quantity

Rewriting things in the language of this representation and using the KN logarithm ic mean one can see more straightforwardly how Sharm a-M ittal's entropy generalizes Renyi's extensive entropy to nonextensivity, and how the new measure does the same for non-extensivity generalizing it to a 'generalized non-extensivity', we called supra-extensivity.

The quantity

is well known to have a physical interpretation in statistical mechanics: the multiplicity of the system, i.e. the number of all possible microstates compatible with its macroscopic state.

3 Generalizing to relative entropy-inform ation m easures

S.Kullback and R.A.Leibler (15) introduced the notion of relative entropy.

Given a random variable X with x a specic (scalar or vector) value for X on a continuous event space, consider continuous di erentiable PDFs, $p(x;) 2 C^2$, with a (scalar or vector) parameter. Let be H₁ the hypotheses that X is from the statistical population with PDF $p_1(x;)$ and H₂ that with PDF $p_2(x;)$. Then it can be shown (16) that applying Bayes' theorem, $\log \frac{p_1(x;)}{p_2(x;)}$ m easures the di erence between the logarithm of the odds in favor of H₁ against H₂ before a measurement gave X = x. Kulback's relative entropy, or our "mean capacity for discrimination" in favor of H₁ against H₂, was originally de ned as

with S_{sp} the entire sample space.

If $p_2(x;) = 1$ (we "discrim inate" against certainty), the negative Shannon information (in its continuous form) is recovered. The di erent signature is due to the fact that Shannon's information, as all the measures we are dealing with here, account for the amount of information we still need to gain complete knowledge, i.e. the uncertainty about the message. Let us therefore call K ulback-Leibler relative information-entropy measure, or simply K ulback's measure

Relative entropies can be used to generalize all inform ation measures either in their continuous as in their discrete version. Let us start rst with discrete PDs.

From 3.5 (3.6) we recover R enyi's (T sallis') measure 3.4 (3.3), if r ! 1, and T sallis (R enyi's) measure 3.3 (3.4), if r ! q. Notice how it is much easier to recognize the limits in the logarithm ic-exponential representation.

Straightforwardly we can now extend to continuous PDFs over parameter spaces and . The continuous T sallis, R enyi, Sharm a-M ittal and supra-extensive relative information-entropy measures become

The role of F isher inform ation for generalized entropy m ea-4 sures

4.1 The Fisher information measure

We are now ready to proceed towards the real aim of this paper. We begin with a brief introduction to Fisher information.

In 1921, R. A mold Fisher de ned an information measure which could account for the "quality" or "e ciency" of a measurement. Calling e cient estimator or best estimator, the best unbiased estimate b(x) of after many independent measurements on a random variable x such that $\langle b(x) \rangle = \sum_{i=1}^{n} p(x; i)^{b}(x) dx = i$, Fisher de ned the e ciency or quality of a measurement, I_{F} , the quantity which satis es

4.2 The Fisher inform ation m atrix as a m etric tensor

W e will not go into the details in what would be a much too long exposition of inform ation geom etry and shall highlight only in an introductory manner the status of the F M as a metric tensor for a statistical manifold (for a more rigorous account of the subject see e.g. (1), (3), (28), (23), and references therein).

Consider a fam ily of C^2 di erentiable PDFs with N-dimensional continuous vector random variables x, parametrized by an M-dimensional continuous real vector parameter space on an open interval I R^M

The notion of a di erential statistical manifold is identied in the fact that the parameters can be conceived as providing a local coordinate system for an M-dimensional manifold M which points are in a one to one correspondence with the distributions $p \ge F$.

Since inform ation-entropy measures are log-probability functionals de ned on M , it is convenient to consider also the function l:M ! R on the manifold M de ned as l() logp(x;). This is com – m only called the log-likelihood function. Labelling the manifold's tangent space T (M), the directional derivatives of l() along the tangent vectors $\mathbf{b}_i \ge T$ (M) at a point in M with coordinates are (use the shorthand $\mathbf{e}_i = \frac{\mathbf{e}_i p(x;)}{\mathbf{e}_i} \mathbf{b}_i$:

FIM 4.1 can also be seen as the expectation value with respect to $p(x; \cdot)$ of the partial derivatives of 1(), which is the reason why in the literature it is frequently written as

This is a symmetric, non-degenerate, bilinear form on a vector space of random variables $@_il()$. But a Riemannian metric g is per de nition a symmetric non-degenerate inner product on the manifold's tangent space T (M), and one can therefore consider the FIM as the statistical analogue of the metric tensor for a statistical manifold.

By the way, it is worth mentioning that Corcuera & G ium mole showed (3) that the FIM has also the unique properties of being covariant under reparam etrization of the param eter space of the manifold, and invariant under reparam etrization of the sam ple space (see also W agenaar (28) for a review). This is an appealing aspect which possibly suggests that F isher inform ation m ight play some role in future quantum spacetime theories.

Now, the metric tensor tells how to compute the distance between any two points in a given space. Here we are considering the distance between two points on a statistical dierential manifold mapped on a measure functional, i.e. the informational dierence between them. This idea can be introduced regarding K ulback's relative information measure to account for the net dissimilarity between two families of PDFs with parameters, and . Intuitively one can imagine this as measuring a "distance" between these two families. However, strictly speaking, this is not a metric distance because it is neither symmetric nor satis es the triangle inequality (on statistical manifolds one has to consider an extended version of Pythagora's law). The sym m etry condition how ever can be restored if instead of the single inform ation m easure we use the divergence D of two PDFs, p_1 and p_2 , de ned as³

This is a very important and known result from information geometry. It is in this sense that g_{ij} can be seen as a metric tensor which measures a "distance" on a statistical manifold in a Riemannian space. In this sense F isher information can be said to be a sort of "mother information measure".

5 The Fisher metric for generalized information-entropy measures

W e can generalize this result of inform ation geom etry. The F isher m etric for T sallis, R envi, the Sharm a-M ittal and the supra-extensive m easures can be obtained considering the relative entropy m easures as de ned in 3.7, 3.8, 3.9 and 3.10 respectively (with $p_1 = p(x;), p_2 = p(x;)$), from their respective symmetric divergence

de ned on F $% \mathcal{F}$.

W hat we need is the evaluation of 4.3 for each inform ation measure 3.7 to 3.10. One can of course compute directly the (somewhat fuzzy) second derivatives $\frac{\theta^2 S(\cdot; \cdot)}{\theta_{-i}\theta_{-i}}$ each time (and for each ! parameter exchange). However, the q-deformed generalized logarithm and exponential formalism and the KN-representation make this task easier since it needs only the evaluation of T sallis' entropy, the rest follows alm ost automatically.

The nal result will be that g_{ij}^{KL} remains still the fundamental quantity, but for these more general (supra-extensive, Sharm a-M ittal, Renyi and T sallis) relative entropies the statistical metric tensor

This shows also that while g_{ij} depends from the q-deforming parameter it is independent from the rextensivity parameter. This is quite natural since Fisher information accounts for the "quality" of a measure, or so to say, our "di erential capacity to distinguish" locally between two neighboring PDFs, and this in turn depends from the "form" of the PDF (the q-scaling), but is independent from the extensive, non-extensive or supra-extensive character, since these are global features of the system. We shall see how it is the normalization condition in posed on PDFs that leads to this independency (and recover the known fact that this is also the same reason why g_{ij} is symmetric). Moreover, it will also become clear how Fisher information measures the rate of change of the multiplicity under a parameter variation.

5.1 Fisher from T sallis inform ation

First of all consider the derivation rules

Evaluating T sallis' derivatives is indispensable but, once established, we don't need to m ake any direct derivative anym ore for all the other m easures if we work with generalized logarithm s and exponentials. W e don't even need to repeat the derivation for the symmetry considerations.

In fact, 4.3 for R envis measure can be obtained from 2.14. From 5.2 we obtain (the arguments (x;) or (x;) of the measures, the PDFs or of the FM, shall be om itted if it is not needed otherwise)



Therefore, since the second order of the multiplicity is the leading one, we can say that Fisher information accounts (times a negative parameter multiplicative deformation factor) for the change of multiplicity (the change of number of microstates of a system) under a statistical parameter variation. This is another way to interpret the fundamental connection between Fisher information and entropy measures.

6 Conclusion

U sing the notion of K ulback-Leibler's relative entropy, generalizing it to allentropies, we showed, as it was already known for K ulback's measure, that once again the FIM appears as the same statistical metric tensor 5.1 for T sallis, R enyi, Sham a-M ittal and the supra-extensive measures too. The di erentialgeom etric properties of the divergence for each measure are independent from the extensive, non-extensive or supra-extensive character of the system, but depend only from the q-deforming parameter. This independency and the symm etry of g_{ij} are guaranteed by the normalization condition. We could also see how F isher information has to be interpreted as a quantity proportional to the change of the information multiplicity under the statistical parameter variation. Generally, the derivation of F isher information proved to be easier to obtain by exploiting the q-deformed logarithm and exponential form alism or the KN-representation of information-entropy measures. The overall global picture of the generalization process we have undertaken so far can be nally summarized in the diagram of the following page (where p_1 and p_2 can be both PD s or PDF s).
