# A bsence of logarithm ic attraction betw een colloids trapped at the interface of droplets

The possibility of long \{ ranged attractions betw een colloids trapped at uid interfaces is a topic of current interest. Ref. 1 proposes an intriguing $m$ echanism of geom etrical nature for the appearance of a logarithm ic capillary attraction betw een colloids on a droplet. In this respect we note that such an attraction w as already proposed in Ref. 2 w ith essentially the sam e physical interpretation as the one given in Ref. 1, i.e., an unbalance betw een the forces on the particle and on the curved interface, respectively. H ow ever, follow ing a different approach it was shown that such an unbalance does not arise [3]. W thout being exhaustive, here we correct only those $m$ istakes in Ref. 1 which a ect the $m$ ain conclusion. $W$ e dem onstrate that there is no logarithm ically varying interfacial deform ation and consequently no logarithm ic capillary attraction. Incidentally, this Com m ent provides an independent con $m$ ation of the conclusions obtained in Ref. $3^{11}$.
(a) The de nition of ${ }_{1}$ : For an isolated droplet in equilibrium, the electrical force $\mathrm{K}=$ $K n_{Q}$ acting on the particle is com pensated by tension exerted by the interface at the contact line $=0$. In Ref. 1 , the e ect of this line tension is $m$ odelled by a pressure term
1 acting along the norm al $n_{0}$ of the undeform ed interface. The value 1 of this $m$ odel $m$ ust be determ ined by Eq. (9), i.e., N ew ton's law of action \{reaction. Exploiting rotational sym $m$ etry, Eq. (9) can be pro jected onto the unit vector $e_{z}\left(=n_{Q}\right)$ and evaluated $w$ th Eq. (11):

This corrects the de nition of 1 in Eq. (10) by a factor $1=c o s^{2} 0$. The origin for this discrepancy is that the force\{balance condition (9) actually $m$ eans that the projection of 1 onto $\mathrm{n}_{Q}\left(=e_{z}\right)$ m ust equal $K$, whereas $R$ ef. 1 im poses that the projection of $K$ onto $n_{0}$ $m$ ust equal 1 , which violates the action \{reaction principle.
(b) A useful interm ediate result: G iven the rotational sym m etry, Eq. (5) can be rew ritten as

while for $0 \quad{ }^{0}$ it has this same form butwith and ${ }^{0}$ exchanged.
(c) The solution $u_{L}()$ is given by Eq. (III) with $P_{L}()$ de ned in Ref. 1 above Eq. (12):

where $0<$ and the constant A depends on 0 . This expression corrects Eq. (12) in two aspects: (i) the presence of a term / cos , which how ever does not a ect the am plitude of a possible logarithm in the range $0<$, and (ii) the am plitude of the logarithm, which has an additional factor cos 0 as well as the opposite sign as the one given in Ref. $12 \sqrt[2]{2}$.
(d) The solution $u_{A}()$ : A pplying again Eq. (II) w ith the stress $P \quad P_{L}$, we nd

In the integral term, a logarithm ic dependence is given by

A ll other contributions are either m anifestly unim portant or do not yield logarithm ic term s if ( ) decays rapidly enough. To leading order in 0 , the am plitude of the logarithm is canceled by the term / 0 in Eq. $(\mathbb{V})$, but there still rem ains a logarithm with an am plitude $O\binom{2}{0}$. The key point is that the am plitude of the logarithm in Eq. IV) is also O ( $\left.\begin{array}{l}2 \\ 0\end{array}\right)$, so that the solution $u_{A}()$ has to be expanded up to and including $O\binom{2}{0}$ in order to com pare it $w$ ith $u_{L}()$ consistently. Therefore Eq. (17) is $m$ issing a logarithm ic term $w$ ith an am plitude which is com parable to that of the logarithm in Eq. (12).
(e) T he total deform ation is given by Eqs. (IV), (V), and (VI) :

ignoring term swhich do not contribute to a logarithm ic dependence for . From Eq. (II) we conclude that the am plitude of the logarithm vanishes. This is a general, exact result which holds to all orders in 0, in agreem ent with Ref. 3.
