From the fundam ental requirem ent of causality, we derive a rigorous criterion of negative refraction (left-handedness). This criterion imposes the lower lim its on the electric and magnetic losses in the region of the negative refraction. If these losses are elim inated or signi cantly reduced by any means, including the compensation by active (gain) media, then the negative refraction will disappear. This theory can be particularly useful in designing new left-handed materials: testing the expected polarizabilities of a medium against this criterion would check the compliance with the causality and verify the design feasibility.

There has been recently a signi cant attention devoted to the so called left-handed materials (LHM), which are also called negative-refraction  $m edia^{1,2,3,4,5,6,7,8,9,10,11,12,13}$ . In such materials, the directions of energy transfer and wave-front propagation are opposite. This leads to remarkable electrom agnetic (optical) properties such as refraction at surfaces that is described by a negative refraction index n. This, in tum, causes a at slab of a left-handed material with n = 1 to act as a \perfect lens creating, without re ections at the surfaces, a non-distorted im age. This is a so-called Veselago lens<sup>14</sup>. M oreover, such a lens can also build an image in the near eld<sup>5</sup>. Optical losses in LHM s are detrimental to their performance. These losses for LHM s in the near-infrared and visible region are signi cant<sup>8,9,10,11</sup>, which drastically limits their usefulness. There have been proposals to compensate these losses with optical gain<sup>16,17</sup>, which appears to be a way to resolve this problem . In this Letter, we show that compensating the optical losses, which im plies signi cantly reducing the im aginary part of the dielectric perm ittivity " and m agnetic perm eability , will necessarily change also the real parts of these quantities in such a way that the negative refraction disappears. This follows from the dispersion relations, i.e., ultimately, from the fundamental principle of causality.

A proposal to add a gain medium to a metal nanosystem to create a nanoplasmonic counterpart of laser (spaser) in the near-infrared and visible spectral region has been introduced in Refs. 18,19. Earlier, a THz quantum cascade laser with surface-polariton resonator has been created<sup>20</sup>. A possibility to compensate a small fraction of optical losses in plasm onic propagation by gain as a rst step toward creation a spaser has been experimentally show  $n^{21}$ . Using optical gain to com pensate losses in the plasm onic \perfect lens" has been proposed<sup>22</sup>. The interest to the compensation of losses in the metal plasm onic systems by the optical gain has attracted recently a great deal of attention in conjunction with the form idable problem of creating LHM s in the near-infrared and visible spectrum with low losses 16,17,23. This compensation of losses in LHM s by gain appears to be very attractive since the existing in plem entations of the LHM s in the optical region su er from large optical losses: jIm kj  $\Re$  ekj where k is the wave vector, so a wave propagates just a few periods in such a medium before extinction reduces its intensity several times<sup>8,9,10,11</sup>. A part from the active approach based on the gain media, there is also a possibility to use di erent materials or to nanostructure a medium to lower the optical losses.

However, it is in possible to reduce the optical losses without a ecting the real part of the dielectric and m agnetic responses because of the requirements of causality leading to the familiar K ramers-K ronig dispersion relations (see, e.g., Ref. 24). In this Letter, we derive similar dispersion relations for the squared refractive index. U sing them we show that a signi cant reduction in the optical losses at and near the observation frequency will necessarily eliminate the negative refraction.

The Kramers-Kronig relations follow from the causality of the dielectric response function in the temporal dom ain. Then one can prove that in the frequency domain perm ittivity "(!) does not have singularities in the upper half-plane of the com plex variable !. From this and the  $\lim it "(!) ! 1$  for ! ! 1, one derives the conventional K ram ers-K ronig dispersion relation for the dielectric function. For the same causality reason, magnetic perm eability (!) does not have singularities in the upper half-plane of com plex !. Since also (!) ! 1 for !! 1, permeability (!) satis es a similar dispersion relation. Note the requirement of the response linearity is essential: nonlinear and saturated polarizabilities generally do not satisfy the K ram ers-K ronig relations.<sup>25</sup> Wewill below consider systems including gain media; in those cases we assume that the optical reponses to the signal (observed) radiation are linear. This of course requires the signal to be weak enough to ensure the linearity of the responses to it and the applicability of the K ram ers-K ronig relations.

We consider a material to be an elective medium characterized by macroscopic permittivity "(!) and permeability (!). The squared complex refraction index  $n^2$  (!) = "(!) (!) has exactly the same analytical properties as "(!) and (!) separately:  $n^2$  (!) does not have singularities in the upper half plane of complex ! and  $n^2$  (!) ! 1 for ! ! 1. Therefore, absolutely similar

to the derivation of the K ram ers-K ronig relations for the perm ittivity or perm eability (see, e.g., Ref. 24), we obtain a dispersion relation for  $n^2$  (!),

where P denotes the principal value of an integral.

p  $\frac{N}{n^2}$  m ay possess singularities in the upper halfplane and thus is generally not causal; this is true, in particular, when optical gain is present<sup>26</sup>. The refractive index n per se does not enter the M axwell equations; it is not a susceptibility, and it does not have to obey the causality, while n<sup>2</sup> does. This theory is based on n<sup>2</sup>, not n; the non-causality of n is irrelevant for its purposes.

Now we assume that at the observation frequency ! the material is transparent (e.g., the losses are compensated by gain), i.e., Im  $n^2$  (!) = 0 with any required accuracy. Then the principal value in the right-hand side of Eq. (1) can be omitted. Multiplying both sides of this equation by  $!^2$  and di erentiating over ! (one can di erentiate under the integral over ! as a parameter, because the point  $!_1 = !$  is not singular anym ore), we obtain

The left-hand side of this equation can be expressed in terms of the phase velocity  $v_p = (k=k)! = k$ , where wave vector k = !n (!) = c and c is speed of light, and group velocity  $v_g = (k=k) @! = @k$ . In this way, we obtain

where "<sup>0</sup> = Re", "<sup>0</sup> = Im " and, similarly, <sup>0</sup> = Re , <sup>0</sup> = Im ; Im n<sup>2</sup>(!) = "<sup>0</sup>(!) '(!) + <sup>0</sup>(!)"<sup>0</sup>(!).

In the case of the negative refraction, the directions of the phase and energy propagation are opposite, therefore  $v_p v_g < 0.$  Consequently, we obtain from Eq. (3) a rigorous criterion of the negative refraction with no (or low) loss at the observation frequency ! as

This criterion directly in poses the lower bounds on the dielectric losses  $[\Pi^{00}(!_1) > 0]$ , overlapping with the magnetic plasm onic behavior  $[ \ ^0(!_1) < 0]$  and the magnetic losses  $[ \ ^{00}(!_1) > 0]$  overlapping with the electric plasm onic behavior  $[\Pi^0(!_1) < 0]$ . The denominator  $(!_1^2 \ !^2)^2$  m akes the integral to converge for  $j!_1 \ !j$  large; it would have diverged at  $j!_1 \ !j! \ 0$  if the integrand did not vanish at that point. Thus, the major contribution to Eq. (4) comes from the lossy, overlapping electric and magnetic resonances close to observation frequency !.

The stability of the system requires that no net gains are present at any frequency, i.e., "<sup>00</sup>(!) 0 and <sup>00</sup>(!) 0 everywhere.<sup>24</sup> There is a known condition of negative refraction<sup>27</sup> Im n<sup>2</sup>(!) < 0. This condition is always satised in the region of left-handedness where <sup> $\theta$ </sup>(!) < 0 and <sup>0</sup>(!) < 0. Thus, this condition is trivial: in contrast to Eq. (4), it does not in pose a lower lim it on the losses.

In the absence of magnetic resonances, in the optical region  $^{0} = 1$  and  $^{00} = 0$ . Then it is obvious than the integral in the left-hand side of Eq. (4) is strictly positive and this criterion is not satis ed, i.e., the negative refraction is absent. In the presence of a magnetic resonance, in a part of its region  $^{0} < 0$  and  $^{00} > 0$ ; thus the criterion (4) can, in principle, be satis ed. However, this requires non-zero losses:  $^{00} > 0$  and/or  $^{00} > 0$ .

To satisfy the transparency requirement at the observation frequency,  $\operatorname{Im} n^2(!) = 0$ , one may attempt to add a gain to exactly cancel out the losses at this frequency<sup>17,23</sup>. Is it possible from the positions of causality? Because the loss should now here be negative, it is obvious that it must have the zero minimum at frequency !. The corresponding resonant contribution to the permittivity close to resonance frequency !<sub>r</sub> has the form

Here (!) is the relaxation rate that depends on frequency due to the loss compensation. At the observation frequency this loss is completely compensated, (!) = 0, and it has a minimum: (!) = 0 and (!) = 0 and (!) = 0. However, it follows from this equation that "r (!) has an extra pole at a complex frequency

This pole is situated in the upper half plane, which violates causality. Because the form of Eq. (5) is rather general close to the resonance, we conclude that in this manner it is in possible to compensate the losses.

It is still possible that both the magnetic resonance and electric plasm onic behavior are present, but their losses are compensated by an active-medium gain. However, such compensation must take place not only at the observation frequency !, but for the entire region of such resonances assuming their hom ogeneous nature. This means that in Eq. (4) whenever  $^{0}(!_{1}) < 0$ , we have  $^{00}(!_{1}) = 0$  and  $^{000}(!_{1}) = 0$ . However, in this case the contribution of this region to the integral in Eq. (4) vanishes, and the contribution of the region of norm alopticalm agnetic behavior ( = 1) is always positive. Consequently, the negative-refraction criterion is violated, which in plies the absence of the negative refraction.

To obtain the negative refraction, the losses in the magnetic resonance region not only should be present, but they should be signi cant not only to overcome the positive contribution of the non-resonant region to the integral in Eq. (4), but actually to make it less than

1. Thus, signi cantly reducing by any means, passive

or active (by gain), the losses of the negative refraction resonances will necessarily elim inate this negative refraction itself. Fundam entally, this stem s from the fact that the imaginary part and real part of the squared index of refraction are not independent but must satisfy the requirem ents imposed by the principle of causality.

O ne has to explore also a possibility to satisfy the criterion (4) with low losses at the working frequency ! by having a left-handed resonance som ewhere else at som e resonance frequency  $!_r$  rem ote from ! to satisfy Eq. (4). The contribution of such a rem ote resonance to the integral in Eq. (4) can be approxim ated as

Here  $n_r^2(!_1)$  is the resonant contribution to the squared index. It is assumed that it decreases rapidly enough when  $j!_1 !_r j! 1$ , which is the expression of its resonant behavior. In this case, it is possible to extend the integral in this equation over the entire region, as indicated. As required by the causality,  $n_r^2(!_1)$  does not have any singularities in the upper half plane of  $!_1$ . This integral can be closed by an in nite arc in the upper halfplane, which gives the zero result due to this absence of the singularities there. Hence, the distant resonances do not contribute to the negative-refraction criterion (4). This com pletes the proof that zero (or, very low) losses at and near the observation frequency are incom patible with the negative refraction.

W e point out that in reality these losses do not have to be zero to elim inate the negative refraction. If they are merely much smaller that the losses in the adjacent regions that result in the positive contribution to the integral in criterion (4), then the negative refraction will be absent. In them icrow ave region, these losses can actually be quite small, but not so in the optical region.

Simple, exactly solvable, and convincing illustrations of the above theory are provided by the negative refraction of surface plasm on polaritons (SPPs) in Im s with nanoscale thickness. Note that it is a two-dimensional refraction but our consideration is based on the principle of causality and is general, applicable to refraction in spaces of arbitrary dimensions. We emphasize the the examples to follow do not provide a proofbut servemerely as illustrations of the above-given proof.

Consider a at layer with nanoscale thickness d m ade of a material with dielectric permittivity  $"_2$  embedded between two half-spaces of materials with permittivities  $"_1$  and  $"_3$ . The dispersion relation, i.e., wave vector k as a function of ! or vice versa, of the waves (SPPs) bound to the nanolayer can be found from an exact, analytical transcendental equation

As the rst example, we mention a sem i-in nite metal (silver) covered with a nanolayer of dielectric with a




FIG.1: D ispersion relations for thin silver lm in vacuum. The symmetric and antisymmetric modes are displayed with solid and dashed lines, respectively. (a) Real part of dispersion relation: frequency ! as a function of Rek. (b) Im aginary part of the dispersion relation: dependence of Im k on rek. Thickness of the silver lm is d = 30 nm.

half-space of another dielectric covering it.<sup>28,29</sup> T his system possesses an extended spectral region of negative refraction<sup>29</sup>; how ever, in this region the SPP losses are so high that the propagation is actually absent, in accord with the above-presented theory.

Another exactly solvable example of negative refraction also described by Eq. (8) is given by SPPs in a metal lm of a nanoscopic thickness embedded in a dielectric. There are two metal-dielectric interfaces and, correspondingly, two modes of SPPs in this system . Because there is symmetry with respect to the re ection in the middle plain, these SPP modes are classi ed according to their magnetic-eld parity: symmetric and antisymmetric. As an example, we consider a silver lm with thickness d 10 nm in vacuum. The corresponding dispersion relations are shown in Fig. 1. As we see from panel (a), the symmetric SPPs have regions of both the positive refraction (Rek < 210<sup>5</sup> cm<sup>-1</sup>) and negative refraction (Rek > 2  $1^{\circ}$  cm<sup>-1</sup>), while the antisymmetric SPP spossess only the positive refraction. The optical losses are shown in Fig. 1 (b). For most of the positiverefraction region of the symmetric SPPs and in the entire spectral range of the antisym m etric SPPs, these losses are relatively very small: Im k Rek.However, for the symmetric SPPs (the solid line) close to the negativerefraction region, the losses dram atically increase by orders of m agnitude. Inside the negative-refraction region, they are extremely high, jm kj & Rekj so the propagation is overdam ped and actually absent, in the full agreem ent with the conclusions of the present theory.<sup>32</sup>




FIG.2: (a) For a thin (d = 10 nm ) dielectric layer with " $_d$  = 3 embedded in thick m etal (silver), dispersion relation of SPPs displayed of as dependence of frequency ~! on the real part Rek of wave vector. (b) For the same system, dependence of the wavevector in aginary part Im k on its real part Rek. For both panels, the solid lines pertain to the antisym m etric SPP m ode, and the dashed lines denote the sym m etric SPP m ode.

Yet another system that supports the negativerefraction SPPs is a dielectric nanolayer embedded in a metal<sup>30</sup>. This system is also symmetric and possesses twometal-dielectric interfaces. Therefore it supports two branches of SPPs that are characterized by parity. The corresponding dispersion relations are displayed in Fig. 2. The real parts of these dispersion relations as functions ! (Rek) for these two types of modes are shown in panel(a). From it we see that in the entire spectral region the symmetric SPPs (dashed line) have normal, positive refraction ( $v_g > 0$ ), while the antisymmetric SPPs (solid line) are negative-refracting ( $v_q < 0$ ). The corresponding

losses are displayed in Fig.2(b). We note that the losses of the positive-refraction, symmetric mode (dashed line) are relatively small in the entire region, Im k Rek. In a sharp contrast, for the antisymmetric, negativerefraction mode (solid line), the losses for small wave vectors are very high, jim kj & Rek, so the wave propagates through only a few periods before it dissipates. The apparent discontinuity of the corresponding curve at sm all m om enta is due to the failure of the num erical procedure to nd a root of characteristic equation (8), which a consequence of the fact that a good, propagating SPP m ode in this spectral region does not exist.

To conclude, from the fundam ental principle of causality, we have derived a dispersion relation (1) for the squared refraction index. From it, assuming a low loss at the observation frequency, we have derived a criterion (4) of the negative refraction. We have shown that the low loss at and near the observation frequency is incompatible with the existence of the negative refraction<sup>33</sup>. While at the THz region the losses may not be signi cant, they are very large in the optical region. The loss compensation or signi cant reduction will necessarily lead to the disappearance of the negative refraction itself due to the dispersion relation dictated by the causality.
