## Gauge e ects on phase transitions in superconductors

#### A bstract

Classic and recent results for gauge elects on the properties of the normal-to-superconducting phase transition in bulk and thin lm superconductors are reviewed. Similar problems in the description of other natural systems (liquid crystals, quantum eld theory, early universe) are also discussed. The relatively strong gauge elects on the uctuations of the ordering eld at low spatial dimensionality D and, in particular, in thin (quasi-2D) lms are considered in details. A special attention is paid to the uctuations of the gauge eld. It is shown that the mechanism in which these gauge uctuations a ect on the order of the phase transition and other phase transition properties varies with the variation of the spatial dimensionality D. The problem for the experimental conmation of the theoretical predictions about the order of the phase transitions in gauge systems is discussed.

#### 1 INTRODUCTION

# 1.1 Superconductivity and gauge e ects

A remarkable example of gauge theory in condensed matter physics is the Ginzburg-Landau (GL) functional of superconductivity [1, 2]. The latter is invariant towards both global U (1) rotations of the order parameter eld (x) and local gauge transformations (rotations) of the same eld and the vector potential X(x) of the magnetic induction B. These two properties of gauge invariance dene the global and local U (1) symmetries of the GL theory. In both cases the gauge group is a one-dimensional Abelian continuous group, U (1). The spontaneous breaking of these global and local symmetries below the phase transition point allows for the appearance of the superconducting phases: the uniform Meissner phase and, under certain circum stances, the mixed (Abrikosov vortex [3]) phase.

While the Meissner phase [h] if 0, here is a mere product of the breaking of the global U (1) symmetry, the vortex phase [h] (x) if 0, here is 0], where the equilibrium eld con gurations of both the order parameter eld (x) and magnetic induction [h] (x) are spatially nonuniform, is a result of the spontaneous breaking of local U (1) symmetry. The local gauge is important also for the description of the magnetic eld penetration in both Meissner and vortex phases. This penetration is described by an additional characteristic length, the London penetration length [h], which is dierent from zero only when the symmetry is broken, i.e., in the ordered phases, where the equilibrium value of is dierent from zero. The local U (1) symmetry is present when the superconductor is in external magnetic eld, or, when this eld is equal to zero but magnetic uctuations exist and give sense of the vector potential A (x) as purely uctuating eld.

The uctuations of the relevant elds, (x) and  $\tilde{A}(x)$  in usual superconductors are small and can be neglected. This means that the GL functional can be investigated in the lowest order mean eld (MF) approximation (alias, \tree approximation" [4,5]). This is the usual way of treatment of the GL free energy, in particular, the investigation of the GL equations [1, 2, 3]. Within the tree approximation, the phase transition from normal to superconducting state in zero magnetic eld is of second order [1, 2, 4]. For a long time this phase transition has been considered as one of the best examples of second order phase transitions, which has an excellent description within MF.But in 1974 Halperin, Lubensky and M a (HLM) [6] showed that the magnetic uctuations change the order of the superconducting phase transition in a zero external magnetic eld ( $H_0 = \frac{1}{2} T_0 = 0$ ), i.e., the order of the phase transition from normal-to-uniform (Meissner) superconducting state at  $T_{c0} = T_{c} (H_{0} = 0)$  (see, also Ref. [7]). Since then this uctuation change of the order of normal-to-superconducting phase transition (HLM e ect) has been under debate. A fter 1974 an overwhelm ing am ount of theoretical research on this topic has been performed but up to now there is no complete consensus about the order of this phase transition. In this review we shall consider some aspects of this problem but we shall not be able to discuss or mention all relevant contributions. However, it is important to em phasize that the investigation of the properties of the superconducting phase transition is in portant for other areas of physics, too. Here we shall brie y enum erate and discuss several exam ples.

## 1.2 Quantum eld theory and other problems

In elementary particle physics the gauge invariant theory similar to the GL theory of superconductivity is called Abelian Higgs Model [8, 9, 10, 11, 12, 13]. The same global U (1) and local U (1) gauge symmetries are present but the phenomenon of spontaneous breaking of symmetry occurs only for imaginary mass of the Higgs ( ) eld, which is the analog of the eld describing the Cooper pair in a superconductor. In the absence of spontaneous symmetry breaking this model would describe an ordinary electrodynamics of charged scalars, but the situation becomes more interesting when the mentioned mass is

im aginary and the breaking of sym m etry occurs. Now the sym m etry breaking phenom ena receive other names and another physical interpretation. The breaking of both global and local gauge symmetries ensures a mechanism of transformation of the two initial scalar elds { analogs of the components  $^{0}$  and  $^{0}$  of the complex eld =  $^{0}$  + i  $^{0}$ , and two massless photon elds { analogs of the two independent components A i of the vector potential  $\tilde{A} = fA_{j}; j = 1; 2; 3; r \tilde{A} = 0g$  in a superconductor, to four massive particle elds: the so-called Higgs boson, which is analog of the spontaneous order j j> 0 in a superconductor, and three massive vector eld components, i.e. a massive three dim ensional vector eld. The mass of this new vector eld is proportional to the electric charge jaj and magnitude j jof the Higgs eld and, as a matter of fact, this is exactly the way, in which the London penetration length in a superconductor depends on the electron charge is jand the modulus j jof the superconducting order parameter . Thus the spontaneous breaking of the local gauge sym m etry leads to the form ation of m assive particles without spoiling the gauge invariance of the theory. This is called the Higgs m echanism ". The latter plays a fundam ental role in the uni ed theory of electrom agnetic, weak and strong interactions (see, e.g., Ref. [12, 13]).

It is easy to see that there is som ething quite com m on between the phenom ena of spontaneous breaking of the continuous sym m etries in superconductivity theory and in quantum eld theory. The superconducting phase j j> 0 is the exact analog of the H iggs boson in the Abelian-H iggs model, whereas the appearance of a massive vector eld has its analog in the nite London penetration length, mentioned above. Of course, there is no obstacles in interpreting the phenomena of spontaneous sym metry breaking in quantum eld theory as phase transitions by taking the H iggs mode mass as tuning parameter. The phase transition will occur at zero mass of the H iggs boson.

A similar phenomenon of spontaneous breaking of both global U (1) and local gauge symmetries is possible also within the scalar electrodynamics due to mass insertions from the radiation corrections, as shown in Ref. [14]. The radiation corrections, analog of the magnetic uctuations in a superconductor, generate an imaginary mass to the initially massless scalar eld in this theory and the latter becomes very like the Abelian-Higgs model. Here the symmetry breaking leads to the appearance of a massive scalar and vector elds describing neutral scalar meson and vector meson, respectively [14]. The radiation corrections to the Lagrangian of the massless scalar electrodynamics [14] resembles very much, in particular, in their mathematical form at D=4, the magnetic uctuation corrections to the GL free energy of 4D superconductors [7]. The interrelationships between the superconductivity theory and the gauge theories of elementary particles has been comprehensively discussed in Ref. [15]. Note also the interrelationship between the GL functional of superconductivity and the CP  $^{\rm N}$  on nement model (see Ref. [16]) and extensions to non-Abelian theories [17].

The gauge theories, m entioned so far, and their extensions have a wide application in the description of the Early Universe [15, 18]. Another interesting gauge theory is that of the nem atic-to-sm ectic A phase transition in liquid crystals. A coording to the K obayashi-

M cM illan-de G ennes theory [19, 20, 21] the smectic-A order is described by two order param eters: the nem atic director vector and the complex scalar describing the center of masses of the long molecules. When a description, quite analogous to that of superconductors, is introduced, as suggested by de G ennes [21], the director vector is substituted with a gauge vector eld, which is quite similar to the vector potential A in the GL functional. Apart from some specific features intended to take into account the liquid crystal anisotropy, the elective free energy of the smectic A looks very like the GL free energy of superconductors (see, also, Refs. [22, 23, 24]). Another gauge theory in condensed matter physics that has some (but not very close) similarity with the GL free energy of superconductors is the Chem-Simons-G inzburg-Landau (CSGL) elective functional of the quantum Hall liquid state, in particular, in the description of the phase transitions between the plateaus in the quantum Halle ect [25, 26, 27, 28]. Let us mention also the liquid metallic hydrogen, where the problem of the superconducting-to-super uid phase transition [29] is also related to the topics, discussed in this review.

# 1.3 About the investigation of the uctuation-driven rst order phase transition in superconductors

Now we shall focus on the uctuation elects on the properties of the normal-to-superconducting phase transition in zero external magnetic eld, which is the subject of the present review and in particular cases we shall refer to related topics in other natural systems. We shall consider in more details the HLM elect in 2D and quasi-2D superconductors with a special emphasis on the problem of the theoretical predictions reliability. Following Ref. [6] we shall use two theoretical methods.

In Sec. II we use the MF like approximation of Ref. [6] where the spatial uctuations of superconducting order parameter are neglected, and the magnetic uctuations are taken into consideration. This treatment was justied for well established type I superconductors, where the London penetration length is much smaller than the coherence (correlation) length . Due to the neglecting of spatial uctuations of , the results of such MF treatment should be valid outside the Ginzburg critical region [4]. A weakly rst order phase transition occurs as a result of new small j = 3-term, which appears in the excive free energy of 3D superconductors within the fram ework of the MF like approximation [6]. But this HLM e ect was found to be very small and experimentally unobservable even for well established type I bulk (3D -) superconductors, such as Al, where the GL number  $= 10^{2}$ 1. It has been recently shown [30, 31, 32, 33, 34, 35, 36] that the HLM e ect is much more strong in quasi-2D superconductors than in bulk (3D) samples. Moreover, as shown in this series of papers, the e ect appears by a term of type j jinj j in the e ective free energy, and essentially depends on the thickness L $_0$  of quasi-2D superconducting Im s. These circum stances provide a real opportunity for an experim ental veri cation of the e ect { a topic of discussion throughout the present review, and in particular, in Sec. II.

We must emphasize that MF results are not valid for them odynamic states in the G inzburg critical region ( T)<sub>G</sub> =  $J_{G}$   $T_{c0}$   $J_{Tc0}$  around the equilibrium phase transition point  $T_{c0}$ . In certain classes of high-tem perature superconductors the G inzburg region exceeds 0:1K whereas in usual low-tem perature superconductors it is very narrow, ( T)<sub>G</sub>  $10^{-12}$   $10^{-16}$  K, and the respective critical states are experimentally unaccessible (see, e.g., [4]). If the metastability states, which go along with the weakly rst order phase transition predicted by MF, extend over temperature intervals larger than the size of the G inzburg region, one may conclude that the MF prediction of the HLM e ect is reliable. In Sec. II we justify the MF analysis reliability for element superconductors as Al, W, In. We will show that the condition for enough wideness of metastability regions is quite strong and, perhaps, irrelevant in experiments. We will also demonstrate that the magnitude of the critical magnetic eld is crucial for the observability of the HLM e ect in thin superconducting lms (see also the discussion in Sec. II.9).

In Sec. III we review some results for the HLM e ect obtained with the help of the renormalization group (RG) method [4, 5]. The latter allows simultaneous treatment of both superconducting and magnetic uctuations in the asymptotically close vicinity of the phase transition point. The lack of xed point of the one-loop RG equations for conventional superconductors in zero external magnetic eld was interpreted as a signal for a uctuation-driven rst order phase transition [6]. This result shows that the local gauge magnetic uctuations are relevant also in the G inzburg region of strong - uctuations and under certain circum stances they can change the order of the phase transition to a weakly rst order, as is outside the critical region. The RG investigations of the superconducting phase transition order in zero magnetic eld has been recently reviewed in Ref. [37]. While the latter review emphasizes the investigation of the HLM e ect in high orders of the loop expansion [4, 5], here we lay stress on RG results for the e ects of an isotropy, quenched disorder and extended sym metries of the Higgs - eld on the phase transition properties. The RG study of unconventional superconductors will also be discussed. In the remainder of this paper we shall consider mainly the phase transition to the superconducting state but results for other systems and related topics will also be mentioned in brief; see Sec. III 3 - III 5.

#### 2 MF STUD IES

#### 2.1 General GL functional

The GL free energy [2] of D-dim ensional superconductor of volume  $V_D = (L_1 ::: L_D)$  is given in the form

In Eq. (1) the rst Landau param eter  $a=_0$  (T  $T_{c0}$ ) is expressed by the critical tem perature  $T_{c0}=T_c$  (H = 0) in zero external magnetic eld (H = jH ), b> 0 is the second Landau param eter and e jej is the electron charge. The square  $B^2$  of the magnetic induction B = (H + 4 M), is given by the vector potential  $A (x) = fA_j(x)$ ; j = 1; ...; D g in the form

here the vector potential A(x) obeys the Coulomb gauge A(x) = 0. For 3D superconductor the relation B = r A(x) can be used and when  $B = B_0$  is uniform along the z-axis, the Landau gauge  $A(x) = B_0$  (x = 2; x = 2; 0) can be applied. This representation can be generalized for D > 2 -dimensional systems, where the magnetic induction  $B_0$  is second rank tensor [38]:

If we use the notation  $\mathbf{x} = (\mathbf{x}_1; \mathbf{x}_2; \mathbf{r})$ , where  $\mathbf{r}$  is a (D 2) – dim ensional vector, perpendicular to the plane  $(\mathbf{x}_1; \mathbf{x}_2)$ , in the 3D case we will have  $\mathbf{r} = (0; 0; \mathbf{z})$ , and

where  $_{jkl}$  is the antisym metric Levi-C ivita symbol. The Landau gauge and Eqs. (3) - (4) can be used for uniform  $\mathcal{B} = \mathcal{B}_0$  when  $\mathcal{B} -$  uctuations are neglected. In the prevailing part of our study we shall apply the general Coulomb gauge of the eld  $\mathcal{K}(x)$ , which does not exclude spatial dependent magnetic uctuations  $\mathcal{B}(x)$ .

In nonmagnetic superconductors, where the mean value hM i=M M) of magnetization M is equal to zero in the normal state in zero external magnetic eld, the magnetic induction in presence of external magnetic eld takes the form:

(x) of the ordering eld (x) above (T >  $T_{c0}$ ) and below (T <  $T_{c0}$ ) the normal-to-superconducting transition at  $T_{c0}$ . Note, that the non-uctuation part  $A_0 = [A(x) \quad A(x)]$  corresponds to the regular part  $B_0 = (H_0 + hM) = 0$  of B in nonmagnetic superconductors (hM i = 0) in zero external magnetic eld (H $_0 = 0$ ). Then we can set  $A_0(x) = 0$  and, hence, A(x) = A(x), so we have an entirely uctuation vector potential A(x), which interacts with the order parameter (x). This interaction can be of type j A and j A and generates all e ects discussed in the paper.

We accept periodic boundary conditions for the superconductor surface. This means to ignore the surface energy including the additional energy due to the magnetic eld

penetration in the surface layer of thickness equal to the London penetration depth (T) =  $_0 \ j_0 \ j^{1=2}$ ;  $t_0 = jT$   $T_{c0} \ j_T T_{c0}$ ;  $_0 = (m \ c^2 b = 8 \ e^2 \ _0 T_{c0})^{1=2}$  is the \zero-tem perature" value of . This approximation is adequate for superconductors of thickness  $L_0$  (T)  $a_0$ , where  $a_0$  is the lattice constant and  $L_0 = m \inf L_i$ ; i = 1; ...; Dg. As we suppose the external magnetic eld to be zero (H  $_0 = 0$ ) or very small in real experiments, the requirement  $L_0$  (T) can be ignored and we have the simple condition  $L_0$   $a_0$ .

In m icroscopic m odels of periodic structures the periodic boundary conditions con ne the wave vectors  $\aleph_i$  =  $fk_i$  =  $(2 n_i = L_i)$ ; i = 1; ...; D g in the rst B rillouin zone [ ( = $a_0$ )  $k_i < ( =<math>a_0$ )] and the expansion of their values beyond this zone can be made either by neglecting the periodicity of the crystal structure or on the basis of the assumption that large wave numbers k = fk have a negligible contribution to the calculated quantities. The last argument is widely accepted in the phase transition theory, where the long-wavelength limit ( $ka_0$  1) can be used. In particular, this argument is valid in the continuum limit ( $V_D = a_0^D$ ! 1). Therefore, for both crystal and nonperiodic structures we can use the cuto ( = $a_0$ ) and afterwards extend this cuto to in nity, provided the main contributions in the summations over k come from the relatively small wavenumbers (k ). This is in fact a quasimacroscopic description based on the GL functional (1), which means that the microscopic phenomena are excluded from our consideration.

The GL free energy functional takes into account phenom ena with characteristic lengths  $_0$  and  $_0$  or larger ( and ), where (T) is the London penetration length mentioned above and (T) =  $_0$  tj  $^{1=2}$  is the coherence length [2]; here  $_0$  =  $(\sim^2$ =4m  $_0$ T $_{c0})^{1=2}$  is the zero-tem perature coherence length. In low-tem perature superconductors  $_0$  and  $_0$  are much bigger than the lattice constant  $a_0$ . Having in mind this argument we will assume in our investigation that  $(=a_0)$ . Whether the upper cuto is chosen to be either

1=0 or 1=0 is a problem that has to be solved by additional considerations. A coording to arguments presented in Ref. [30] and Sec. II.6, we will often make the choice  $\frac{1}{2}$ .

discussion in Sec. I, we have to investigate the spontaneous breaking of these sym m etries, that is, the ordered phases and the phase transitions in the superconductor. The HLM e ect, on which we are going to focus the attention, is one of the results of the local U (1) sym m etry breaking.

### 2.2 Notes about the MF like approximation

While the e ect of the superconducting uctuations (x) on the phase transition properties is very weak, as in usual superconductors, and is restricted in a negligibly small vicinity ( $t_0$ j 10 12 10 16) of temperature  $T_{c0}$ , we will assume that (x) = 0, i.e.,

h (x)i; from now on we will denote h (x)i by . So we apply the mean-eld approximation with respect to the order parameter (x). Within this approximation we will take into account the A(x)-uctuations for  $B_0 = 0$ , i.e., A(x) = A(x). Furthermore, the A(x)-uctuations can be integrated out from the partition function, de ned by:

The integration is over all possible con gurations of the eld X(x); the -function takes into account the Coulomb gauge.

The partition function Z ( ) corresponds to an elective free energy F  $_{\rm D}$  of the D -dim ensional system :

The magnetic uctuations will be completely taken into account, if only we are able to solve exactly the integral (8). The exact solution can be done for a uniform order parameter. The uniform value of is dierent from the mean-eld value of , because the uniform uctuations of (x) always exist, so we should choose one of these two possibilities  $\beta 0$ , 35]. The problem of this choice arises after calculating the integral (8) at the next stage of consideration when the elective free energy  $F_D$  is analyzed and the properties of the superconducting phase ( > 0) are investigated. The elective free energy is a particular case of the elective therm odynam is potential in the phase transition theory [4, 5] and we must treat the uniform in the way prescribed in the eld theory of phase transitions. It will become obvious from the next discussion that we will use a loop-like expansion, which can be exactly summed up to give a logarithm is dependence on j j.

Due to the spontaneous symmetry breaking of the global U (1) continuous symmetry of the ground state  $\theta$  0, the elective free energies discussed in this Section depend on the

m odulus j jofthe com plex num ber = j = i but not on the phase angle , which rem ains arbitrary. That is why we will consider the modulus j jas an \e ective order parameter" does not play any role in the phenomena investigated in this Section. The quantity j jrem ains undeterm ined up to the stage when we de ne the equilibrium order parameter j<sub>0</sub> jby the equation of state  $[P_D]$  ( )=0. This equation gives the equilibrium value  $_0$  of and the dierence  $_0$  = ( $_0$  - ) can be treated as the uniform (zero dim ensional) uctuation of the eld (x). The x-dependent uctuations been neglected because of the uniform ity of  $\,$ . The solution  $\,$   $_{0}$  will be stable towards the uniform uctuation , provided the same solution  $_0 = j_0 \dot{p}^{i_0}$  corresponds to a stable (norm alor superconducting) phase; the phase angle  $_0$  remains unspecied. We begin our investigation by setting uniform but at some stage we will also ignore the uniform and deal only with the equilibrium value  $_0$  of . The equilibrium value will be calculated after taking into account magnetic uctuations, so it will be dierent from the usual result  $j_0 j = (ia + b)^{1-2}$  [2] where both magnetic and superconducting uctuations are ignored. This simplest approximation for the equilibrium value of obtained from the GL free energy (1), provided e = 0 and the gradient term is neglected. Hereafter we will keep the symbol j  $_0$  j for the equilibrium order parameter in the more general case when the magnetic uctuations are not neglected and will denote the same  $j_0 (e = 0) j = (j_0 + b)^{1=2}$ . quantity for e = 0 by

The above described approximation neglects the saddle point solutions of GL equations, where h (x)i is x-dependent. Therefore, the vortex state that is stable in type II superconductors cannot be achieved. This is consistent with setting the external magnetic eld to zero, so the vortex state cannot occur in any type superconductor. These arguments can be easily verified with the help of GL equations [2] for zero external magnetic eld; the only nonzero solution for in this case is given by  $= (j_3 j_{-} b)^{1-2}$  although the magnetic uctuations A(x) = A(x) are properly considered.

In conclusion we can argue that the described method will be convenient for both type I and type II superconductors in zero external magnetic eld, if the - uctuations have a negligibly smalle ect on phase transition properties  $T_{c0} = T_c$  (H  $_0 = 0$ ), where  $T_c$  denotes the phase transition line for any H  $_0$  0. For type II superconductors in H $_0 > 0$ , two lines  $T_{c1}$  (H  $_0$ ) and  $T_{c2}$  (H  $_0$ ) should be defined, usually given by H  $_{c1}$  (T) and H  $_{c2}$  (T) [2].

## 2.3 E ective free energy

When the order parameter is uniform the functional (1) is reduced to




Figure 1: D iagram m atic representation of the series (24); represents the -vertex in (13) and (17), and the solid lines represent bare correlation functions  $h_i^2A_i$  (K)  $f_i$ .

However, from a purely calculational point of view we have found more convenient to consider particular dimensions of interest separately and then to compare the results in order to demonstrate the relevant dimensions between the bulk (3D) and thin  $L_0$  properties. This approach is applied below.

#### 2.5 E ective free energy for particular dim ensions

 $(1=a_0)$  for the wave numbers  $k_i$  is a matter of additional investigation [30]. In order to justify this de nition of quasi-2D system one can use the 2D-3D crossover description presented in Sec. 2.4. The sum mation over the wave number  $k_0 = (2 n_0 = L_0)$  in Eq. (36) cannot be substituted with an integration because  $L_0$   $L_1$  and the dimension  $L_0$ does not obey the conditions, valid for  $L_j$ , (j = 1; 2) [41, 42, 43]. Therefore, for such 3D system we must sum over  $k_0$  and integrate over two other components ( $k_1$  and  $k_2$ ) of the wave vector k (see Sec. 2.4). This gives an opportunity for a systematic description of the 2D-3D crossover as shown in Sec. 2.4. In the limiting case of very small thickness the 2D-3D crossover theory (Sec. 2.4) leads to a result, which is obtained more simply in an alternative way, namely, by ignoring all terms corresponding to  $k_0 \in 0$  in the sum in Eq. (32). This corresponds to the supposition that the quasi-2D Im thickness cannot exceed 2 . A ssum ing this point of view the real physical size of the quasi-2D thickness will depend on the choice of the cuto. It is certain at this stage that because the (quasi)phenom enological GL theory does not account phenom ena for size less than o. The upper cuto of wave numbers can be de ned in a more precise way at next stages of consideration; see Sec. II.6 - II.8).

Thus  $f_2$  (),  $f_4$  ( ), and f ( ) - the free energy density corresponding to the quasi-2D  $\,$  lm s, contain logarithm ic term s, which should be kept in their original form in the further treatment of the function  $f_D$  () in the Landau expansion. The analysis has been performed [35] in two ways: with and without Landau expansion of  $f_D$  (). These variants of the theory are called \exact" theory (ET) and \Landau" theory (LT), respectively [33]. It has been shown [35] that these two ways of investigation give the same results in all cases except for quasi-2D  $lm s w ith relatively small thicknesses (<math>L_0$ 0). It seems important to establish the di erences between two variants of the theory because the HLM e ect is very sm all and any incorrectness in the theoretical analysis may be a cause for an incorrect result. By same arguments one can investigate the elect of the factor T in  $f_D$  ( ) on the therm odynam ics of quasi-2D  $\,$  lm s. This factor can be represented as T =  $T_{c0}$  (1 +  $t_0$ ) and one m ay expect that the usual approxim ation T  $T_{c0}$ , which is well justified in the Landau theory of phase transitions [2, 4], m ay be applied. This way of approximation can be m ade by neglecting term s in the therm odynam ic quantities sm aller than the leading ones. On the other hand practical calculations lead to the conclusion that this approximation cannot be made without a preliminary examination because for some quasi-2D produces a substantial error of about 10% [35]. LT, in which the factor T is substituted by  $T_{c0}$  is referred to as \sim pli ed Landau expansion" - SLT . All three variants of the theory, ET, LT and SLT have been investigated in Ref. [35].

## 2.6 Lim itations of the theory

The general result (29) – (32) for the elective free energy f ( ) has the same domain of validity [2] as the GL free energy functional in zero external magnetic eld. When we neglect a sub-nano interval of temperatures near the phase transition point we can use Eq. (1), provided  $\mathbf{j}_0 \mathbf{j} = \mathbf{j} \mathbf{T} = \mathbf{T}_{c0} \mathbf{j} \mathbf{T}_{c0} < 1$ , or in the particular case of type I superconductors,  $\mathbf{j}_0 \mathbf{j} < 2$  [2]. Note, that the latter inequality does not appear in the general GL approach.

It comes as a condition for the consistency of this approach with the microscopic BCS theory for type I superconductors [2].

Taking the continuum  $\lim$  it we have to assume that all dimensions of the body, including the thickness  $L_0$ , are much larger than the characteristic lengths—and—. The exception of this rule is when we consider thin—Im s. Substantially larger cuto s  $( = _0)$ , for example,  $( = _0)$  for type I superconductors with 1 lead to contradiction between this BCS condition and the requirement  $( = _0)$ .

provided j  $T_{cj} = JT_{c0}$   $T_{eq}$  j  $T_{c0}$ . Further we will see that the condition j  $T_{cj}$   $T_{c0}$  is valid in real substances. The second term in rhs. of Eq. (61) is a typical negative uctuation contribution whereas the positive third term in rhs. of the same equality is typical of rst-order transitions [4].

To obtain the jumps s and C at T  $_{\rm eq}$  we have to put the solution j  $_{\rm 0}$  j found from Eq. (56) in Eqs. (58) - (60). The result will be:

where  $b_{3c}$  and  $q_{3c}$  are the parameters  $b_3$  and  $q_3$  at  $T = T_{eq}$ . As  $j T_c j = j T_{c0}$   $T_{eq} j T_{c0}$  we can set  $T_{eq}$   $T_{c0}$  in rhs. of Eqs. (62) and (63) and obtain  $q_{3c}$   $q (T = T_{eq})$   $q (T_{c0})$  and  $b_{3c}$   $b (T_{c0})$ .

The latent heat  $Q = T_{eq}$  s of the rst order phase transition at  $T_{eq}$  can be calculated from Eq. (62). If we neglect the second and third terms in the rhs. of Eq. (62) and the second term in the rhs. of Eq. (63) we shall obtain a result for the ratio

which is similar to that presented in Ref. [6]. Here we should mention that Eq. (63) gives the jump C at the equilibrium phase transition point of the rst order phase transition, described by j j term [4], while the speci c heat jump considered in Ref. [6] is equal to the speci c heat jump at the standard second order transition  $C = \begin{pmatrix} 2 & 1 & 1 \\ 0 & 1 & 1 \end{pmatrix}$  and is four times smaller. Therefore, we obtain  $(T)_{eq}$  four times smaller than the respective value in Ref. [6].

#### 2.7.2 Results for Al

In order to do the num erical estim ates we represent the Landau param eters  $_0$  and bw ith the help of the zero-tem perature coherence length  $_0$  and the zero-tem perature critical magnetic eld H  $_{c0}$ . The connection between them is given by formulae of the standard G L superconductivity theory [2]:  $_0^2 = (^2=4m \ _0T_{c0})$  and H  $_{c0}^2 = (4 \ _0^2T_{c0}^2=b)$ . The expression for the zero-tem perature penetration depth  $_0 = (^2=2eH_{c0}\ _0)$  is obtained from the above relation and  $_0 = (b=_0T_{c0}\ _0)^{1=2}$ . We will use the following experimental values of  $T_{c0}$ , H  $_{c0}$  and  $_0$  for Algiven in Table 1. The experimental values for  $T_{c0}$ , H  $_{c0}$  and  $_0$  vary about 10–15% depending on the method of measurement and the geometry of the samples (bulk material or lms) [44] but such deviations do not a ect the results of our numerical investigations.

Setting = 1 corresponds to the cuto  $_1 = (=_0)$  (Sec 2.6). For =  $(1=)_{A1} = 10^2$ , which corresponds to the much higher cuto  $= (=_0)$  we have  $b_3$  b. i.e., the  $_0^2$  -term in  $b_3$ , given by Eq. (52), can be neglected. However, as we can see from Eq. (66), for = 1 the same  $_0^2$ -correction in the parameter  $b_3$  is of order 0:1b and cannot be automatically ignored

in all calculations, in contrast to the supposition in Refs. [6, 7]. However, the more important uctuation contribution in 3D superconductors comes from the term in Eq. (5) for the parameter  $a_3$ . This term is of order  $10^4$  for 1 and this is consistent with the condition  $b_0 > 10^4$  but for  $b_0 > 10^4$  for the validity of BCS condition for Al (Sec. 2.6).

These results demonstrate that for our theory to be consistent, we must choose the cuto = (= 0), where is not a large number (! 1 10). To be more concrete we set = (= 0) as suggested in Ref. [30].

The tem perature shift  $t_{eq} = t_0 \, (T_{eq})$  for bulk Alcan be estimated with the help of Eq. (61). We obtain that this shift is negative and very small:  $t_{eq}$  10<sup>4</sup>. Note, that the second term in the rhs. of Eq. (61) is of order 10<sup>4</sup>, provided (1=0) whereas the third term in the rhs. of the same equality is of order 10<sup>5</sup>. Once again the change of the cuto to values much higher than (=0) will take the system outside the tem perature interval, where the BCS condition for Alis valid. Let us note, that in Ref. [31] the parameter the corresponds to our present notation  $t_0$ . But the numerical calculation of the free energy function  $f_3$  () in Ref. [31] was made for the SLT variant of the theory and the shifted parameter ( $t_0$  + 0:972 10<sup>4</sup>) was incorrectly identified with the analytic lead to the wrong conclusion for its positiveness at the equilibrium phase transition point  $T_{eq}$ . As a matter of fact, the shifted parameter ( $t_0$  + 0:972 10<sup>4</sup>) is positive at  $T_{eq}$  but  $t_{eq}$   $t_0$  ( $T_{eq}$ ) is negative, as retly noted in Ref. [35].

Having in m ind these remarks, when we evaluate sand C for bulk Alwe can use  $\sin pli$  ed versions of (62) and (63) which means to consider only the rst terms in the rhs and to take  $q_{3c}$  q and  $b_{3c}$  b at  $T_{co}$ . In this way we obtain

The results are consistent with an evaluation of C for Alas a jump ( $C = {}^2_0T_{c0} = b$ ) at the second order superconducting transition point [6] that, as we have mentioned above, is four times smaller than the jump C given by Eq. (68).

A complete numerical evaluation of the function  $f_3$  () and the jump of the order parameter at  $T_{eq}$  for bulk Alwas presented for the strtime in Ref. [31]. The results there cone me that the order parameter jump and Q for bulk type I superconductors are very small and can hardly be observed in experiments.

We will nish the presentation of bulk Alwith a discussion of the ratio 64). It can be also written in the form

authors use a hypothetic specie cheat jump (C) at the standard second order phase transition point. From Eq. (69) we obtain

To obtain Eqs. (71) – (72) we have set  $= (=_0)$  and introduced the notation  $'=_j \neq_0$ ; o is defined in Sec. 2.5. Some of the properties of free energy (71) were analyzed in Ref. [32] for Al lms and in Ref. [33] for lms of Tungsten (W), Indium (In), and A luminium (Al). Here we will briefly discuss the main results.

The equilibrium order parameter  $'_0 > 0$  corresponding to the M eissner phase can be easily obtained from the equation @f(') = @' = 0 and Eq. (71):

The logarithm ic divergence in Eq. (73) has no chance to occur because  $\prime_0$  is always positive and does not tend to zero.

The largest terms in the entropy jumps and the specisc heat jump C at the equilibrium rst order phase transition point  $T_{eq}$  are given by [32, 33]

The latent heat of the phase transition [4] is given by  $Q = T_{eq}$  s and Eqs. (73)-(74). Since the tem peratures  $T_{eq}$  and  $T_{c0}$  have very close values, the dierence between the values of Q, s, and C at  $T_{c0}$  and  $T_{eq}$ , respectively, can also be ignored, for example,  $j C (T_{eq}) C (T_{c0}) \neq C (T_{c0})$  1 and we can use either  $C (T_{c0})$  or  $C (T_{eq})$  [32].

The equations (71) { (73) corresponding to quasi-2D  $\,$  lm s are quite di erent from the respective equations for bulk (3D -) superconductors but it is easily seen that the relatively large values of the order parameter jump  $^{\prime}$  in thin  $\,$  lm s again correspond to relatively small values of the

GL parameter . That is why we consider element superconductors with small values of and study the elect of this parameter, the critical magnetic eld  $H_{0}$  and the  $M_{0}$  magnetic on the properties of the uctuation-induced rst order phase transition.

We use experimental data for  $T_{c0}$ ,  $H_{c0}$ , 0 and for W, Al, and In published in Ref. [44] (see Table 1). In some cases the GL parameter—can be calculated with the help of the relation = (0 = 0) and the available data for 0 and 0. In other cases it is more convenient to use the following representation of the zero-tem perature penetration depth:




Figure 2: O rder parameter pro le'( $t_0$ ) of All lms of dierent thicknesses: L  $_0$  = 0:05 m (\+"-line), L  $_0$  = 0:1 m ( ), and L = 0:3 m ( )3\bar{a}].

The order parameter dependence on the reduced temperature dierence  $t_i$  is shown in Fig. 2 for Al Ims of dierent thicknesses. It is readily seen that the behavior of the function  $t_0(t_0)$  corresponds to a well established phase transition of rst order. The vertical dashed lines in Fig. 2 indicate the respective values of  $t_{eq} = t_0(T_{eq})$ , at which the equilibrium phase transition occurs as well as the equilibrium jump  $t_0(T_{eq}) = t_{eq}$  for dierent thicknesses of the Im. The parts of the  $t_0(t_0)$ -curves which extend up to  $t_0 > t_{eq}$  describe the metastable (overheated) Meissner states, which can appear under certain experimental circum stances (see in Fig. 2 the parts of the curves on the rhs. of the dashed lines). The value of  $t_0(t_0)$  and the metastable region decrease with the increase of the Im thickness, which shows that the rst order of the phase transition is better pronounced in thinner Ims and this conims a conclusion in Ref.32].




Figure 3: The free energy f (t\_0) for Al lms of thickness: L\_0 = 0:05 m (\+"-line), L\_0 = 0:1 m ( ), L\_0 = 0:3 m ( )3\Bar{1}].

These results are con  $\mbox{ m ed by the behavior of the free energy as a function of $\mathfrak{t}$. We used Eqs. (71){(73) for the calculation of the equilibrium free energy f ['0 (t_0)]. The free energy for Al <math>\mbox{ lm s w ith di erent thicknesses is shown in Fig. 3. The equilibrium points $\mathfrak{T}_q$ of the phase transition correspond to the intersection of the f ('0)-curves w ith the t_0-axis. It is obvious from Fig. 3 that the temperature domain of overheated M eissner states decreases w ith the increase of the thickness <math>\mbox{L}_0$ .




Figure 4: O rder parameter pro le ' ( $t_0$ ) of lm s of thickness L  $_0$  = 0:05 m:W (\+ "-line), Al ( ), and In ( 33I.

The result is shown in Fig. 4. The vertical dashed lines in Fig. 4 again indicate the respective values of  $t_{\rm eq} = t_0$  ( $T_{\rm eq}$ ), at which the equilibrium phase transition occurs as well as the equilibrium jump  $'_0$  ( $T_{\rm eq}$ ) =  $'_{\rm eq}$  in the di erent superconductors.

The order parameter jump at the phase transition point of In (the In curve is marked by points in Fig. 4) is relatively smaller than for W , and A l, where the G L parameter has much lower values. The same is valid for the metastability domains; see the parts of the curves in Fig. 4 on the left of the vertical dashed lines. It is obvious from Fig. 4 and Table 2 that the equilibrium jump of the reduced order parameter  $^\prime$  eq of W has a slightly smaller value than that of A lalthough the G L number—for W has a tentimes lower value compared with—of A l. Note, that in Fig. 4 we show the jump of  $^\prime$  eq, but the inportant quantity is j  $_{\rm eq}$  = j  $_{\rm 0}$  j  $_{\rm eq}$ . U sing the data for L  $_{\rm 0}$  = 0.05 m from Tables 1 and 2 we nd for j  $_{\rm eq}$  the following values: 0:1  $10^{11}$  for A l, 0:05  $10^{11}$  for In, and 0:02  $10^{11}$  for W . This result shows that the value of the critical led H  $_{\rm c0}$  is also in portant and should be taken into account together with the smallness of G L number when the maximal values of the order parameter jump are looked for. Thus the value of the order parameter jump at the uctuation—induced phase transition is maximal, provided small values of the G L parameter—are combined with relatively large values of the critical ed H  $_{\rm c0}$ . In our case A lhas the optimal values of these two parameters.

The importance of the zero-tem perature critical magnetic eld H  $_{\rm c0}$  for the enhancement of the jumps of the certain thermodynamic quantities at the equilibrium phase transition point  $T_{\rm eq}$  becomes obvious from Eqs. (74), (75) and (77). Eq. (77) shows that the order

param eter jum p j  $\frac{1}{2}$  = j  $\frac{1}{2}$  eq is large for large values of H  $_{c0}$  and  $_{0}$ . This is consistent with the requirement for relatively small values of the GL parameter as shown by Eq. (76). Therefore, the unm easurable ratio Q = C discussed in Ref. [6] does not depend on the value of the critical eld H  $_{\rm c0}$  but the quantities Q and C them selves as well as the order parameter jump j  $\mathbf{j}_{eq}$  depend essentially on H  $_{c0}$ . The values of the reduced order param eter jum p  $^{\prime}$  eq for  $\mbox{lm}$  s of A  $\mbox{l}$ , In and W of the sam e thickness have the sam e order of magnitude while the respective order parameter jump j ika is one order of magnitude higher for Althan for W , as shown above. The e ect of the critical magnetic eld H  $_{\rm c0}$  on the latent heat Q is, however, much stronger and, as is seen from Table 2, the latent heat In s is very small and can be neglected while in A land In In sit reaches values, which could be measured in suitable experiments. This is so because the latent heat is proportional to the dierence  $[H_{c0}^2]=8$  $bj_0f$ ] between the energies of the ground state (superconducting phase at T = 0) and the normal state. It is consistent with the fact that the uctuation contribution to the free energy, i.e., the C  $\,$  term in the rhs. of Eq. (71) is generated by the term of type  $j \int_{0}^{\infty} d^{D} x \Lambda^{2}(x)$  in the GL free energy. At T = 0 this free energy term is also proportional to the mentioned dierence between the free energies of the ground and normal states.

The shift of the phase transition tem perature  $t_{\rm eq}=j(T_{\rm eq}-T_{\rm c0})$  j=T<sub>c0</sub>, the reduced value  $'_{\rm eq}$  of the equilibrium order parameter jump j j<sub>eq</sub>, and the latent heat Q of the equilibrium transition are given for lms of dierent thicknesses and substances in Table 2. This table shows that the shift of the phase transition temperature is very small and can be neglected in all calculations and experiments based on them. The values for  $'_{\rm eq}$  for dierent L<sub>0</sub> and those for j<sub>0</sub> j given in Table 1 con rm the conclusion, which we have made for lms of A l, In, and W with L<sub>0</sub> = 0:05 m. The latent heat Q has maximal values for In, where the critical eld is the highest for the considered materials.

#### 2.9 Final remarks

Our analysis shows that the MF studies of the HLM e ect have a well de ned domain of validity for both 3D - and quasi-2D superconductors. Our conclusion is that the MF theory of the magnetic uctuations in superconductors and, in particular, the MF prediction for the uctuation driven weakly rst order phase transition in zero external magnetic eld in bulk superconductors [6] and quasi-2D superconducting lms [30, 32, 33] is reliable and can be tested by experiments. While the HLM e ect in bulk systems is unobservingly small, in quasi-two dimensional superconductors this e ect is much stronger and might be observed with available experimental techniques.

Our consideration of quasi-2D superconductors is highly nontrivial in view of the relevance of the dependence of the excitive Landau parameters on the thickness of the  $\,$ lm s, L  $_0$ . We have justified this dependence by  $\,$ sim ple heuristic arguments and by a reliable consideration of the 2D-3D crossover. In contrast to initial expectations [6] that  $\,$ lm s m ade

of superconductors with extremely small GL parameter—such as Aland, in particular, W will be the best candidates for an experimental search of the HLM e ect, our careful analysis (rstly published in Ref. [33] denitely gives somewhat dierent answer. The Alms still remain a good candidate for transport experiments, through which the jump of the order parameter at the phase transition point could be measured but surprisingly the W lms turn out inconvenient for the same purpose due to their very low critical eld H $_{\rm c0}$ . The importance of the critical magnetic eld H $_{\rm c0}$  for the clearly manifested rst-order phase transition has been established and discussed, too. Although In has ten times higher GL number—than Al, the In—lms can be used on equal footing with the Al lms in experiments intended to prove the order parameter jump. Here the choice of one of these materials may depend on other features of experimental convenience. As far as caloric experiments are concerned, the In—lms seem to be the best candidate due to their high latent heat.

As shown in this review, experiments intended to search the HLM elect can be performed by both type I and type II superconductors. In experiments the external magnetic eld cannot be completely eliminated. Then vortex states may occur for  $H = \frac{1}{1} = \frac{1}{1} > 0$  below  $T_c = T_c(H)$   $T_{c0}$  in type II superconducting  $T_{c0}$  in sand this will obscure the HLM elect. Note, that in both type I and type II superconductors the external magnetic eld H generates additional entropy jump at the phase transition point  $T_c(H)$  and this elect can hardly be separated from the entropy jump (74) caused by the magnetic uctuations in the close vicinity of  $T_{c0}$ . Therefore, in experiments intended to the search of HLM elect the external magnetic eld should be minimized as much as possible. For quasi-2D superconductors, where the HLM elect is relatively strong and the latent heat can exceed several ergs, one should ensure external elds less than 100 elect, in more reliable experiments, less than 10e [35].

The temperature range around  $T_{c0}$ , where the HLM e ect is signicant has been estimated in Ref. [6] to a few microdegrees, and later, this estimate has been con med in a more accurate way [45]. According to our point of view, the possibilities for the observation of the e ect are related mainly with its magnitude, because the range of temperatures where it occurs always exists, even in the critical region of strong - uctuations, as the RG studies indicate (Sec. III). The review of the results for Al, In, and W in Sec. II shows that the metastability domains (of overheating and overcooling) are much larger than the G inzburg critical region. This result con rms the reliability of the MF treatment. As one may see from Figs. 2-4 the metastability temperature interval is relatively larger for sm aller values of the GL number , but in order to ensure large values of som em easurable therm odynam ic quantities as, for exam ple, the latent heat Q and the speci cheat capacity C we must choose a material with large critical eld H c. The experimental veri cation of the order parameter jump can be made by transport experiments. As we see from Figs. 2-4 and Table 2, this quantity has maximal values for W, where the parameter is very small. Having in mind also the large metastability regions in this material, one may conclude that W is a good candidate for a testing the HLM e ect by transport experiments (m easurem ents of the superconducting currents), provided som e speci c disadvantages of this m aterial (quite low  $T_{c0}$ , etc.) from the experim ental point of view do not contradict to this our conclusion. A nother e ect, which is relevant to the present discussion, is the known variation of the GL param eter with the variation of the thickness  $L_0$  (see, e.g., Ref. [46]. The param eter  $< 1 = \frac{1}{2}$  of a type-I bulk superconductor m ay change up to values corresponding to a type-II superconductor with the decrease of the thickness  $L_0$  below 10  $^7 \mathrm{m}$ .

In Ref. [47] a very interesting intermelationship between the rst order phase transition and the vortex uctuations in type-I2D superconductors has been analyzed by both analytical and numerical methods. A recent investigation [48] of HLM e ect in superconducting Ims has been proven wrong in our comment [49]; see, also, the Corrigendum [50] to the work [48]. In further papers the same authors and co-workers con rm [51,52] our results, published in Ref. [30, 31, 32, 33, 34, 35], and discussed in this Section. Another paper has been intended to the treatment of gauge e ects in superconductors with the help of a Gaussian elective functional [53], which gives results quite near to mean—eld ones, and is wrong within the present discussion.

#### 3 RG STUDIES AND OTHER TOPICS

#### 3.1 Notes about RG

The RG methods are intended to investigation the strong uctuation interactions in the critical region of second order phase transitions and multi-critical phenomena [4, 5]. In studies of complex systems with several orderings or with in uence of additional gauge elds, as in Eq. (1), usually the k space RG methods are used because of their wider applicability. The methods dier from each other in special technical details but all of them lead to the same predictions about the phase transition properties. The common feature is that the mentioned methods are based on the so-called loop expansion [4, 5, 12]. The RG equations are, in fact, in nite asymptotic series, which are truncated at one-, two-, or, in rare cases, higher orders in the loop expansion. The total in nite series can be summed only in case of trivial (usually exactly soluble) models and in some very exceptional cases as, for example, the RG series for interacting realbosons in the quantum limit T! 0 [54].

For the simple <sup>4</sup> theory the RG series can be derived and analyzed to high orders in the loop expansion whereas for more complex models this can be practically done within the one—and two—loop approximations. As the RG series are asymptotic, normally, the one—and two—loop orders give all important features of the species system of interest: (i) the presence of stable xed points (FP) of the RG equations and the associated with them types of critical behavior, and (ii) the lack of stable FPs and related conclusions about the lack of standard critical or multi-critical behavior. The higher orders of the theory

are m ore relevant to investigations of the asymptotic properties of the loop series than for obtaining of qualitatively new critical behavior, or, other new qualitative characteristics of the system. The latter are reliably obtained within the one-and two-loop approximations.

#### 3.2 The order of the phase transition

In Ref. [6] the simultaneous e ect of - and A { uctuations in the uctuation Hamiltonian (1) has been investigated by one-loop RG and = (4 d)-expansion 4] for the general case of n=2-component complex vector eld = f; = 1; :::; n=2g; note, that this eld is equivalent to a n-component real vector eld. It has been shown [6] that a stable FP exists below four dimensions d = (4)) only for sym m etry indices n 365:9, which are far above the real sym m etry index n = 2 for usual superconductors and num bers n = 4;6corresponding to superconductors with certain unconventional Cooper pairings [55]. For n < 365:9 real FP does not exist at all. Besides, the 1=n-expansion has been used for the calculation [6] of the critical exponents in the so-called large-n lim it (alias \H artree lim it") [4, 5], where (n > 365:9) the phase transition is de nitely of second order.

A coording to the usual interpretation of RG results, the lack of stable FP is an indication for a lack of standard second order phase transition. But usually, additional (non-RG) argum ents are needed to determ ine the actual order of the phase transition. In the present case, the lack of stable FP could be a result of the same mechanism that produces a uctuation-driven weakly rst order phase transition in MF approximation (Sec. 2). As RG takes into account both uctuations of and A, one can conclude that the result for the weakly-rst order phase transition in zero external magnetic eld is valid for both type I and II superconductors. Of course, the size of the e ect (the size of jumps of energy, latent heat, order param eter) will depend on the specic substance. This path of investigations has been further developed in the paper [7], and several problems opened in the short Ref. [6], have been solved.

In Ref. [40], where both 2D and 3D superconductors are considered, the HLM e ect has been con med in one-loop order (annealed disorder [40]) as well as the availability of second order phase transition for largen has been proven in another variant of the H artree lim it (n! 1).

Next, the e ect has been con med in a RG investigation of the equation of state below the phase transition point  $T_{c0}$  [56, 57]. These investigations show that the e ect may occur under quite restricted conditions for the vertex param eters e and b of the functional (1), in particular, the e ective charge je jexceeds som e value. A strong restriction on the HLM e ect, but in an opposite direction - a requirement for a su ciently smalle ective electric charge je j has been found also by a Monte Carlo (MC) study [58] of a lattice version of the model (1). A nother M C study [59] concludes that at xed e ective charge ( $\dot{r}e^2$  j = 5) the HLM e ect strongly depends on the GL param eter = = : it is well established for

1, becomes very weak for 1 and vanishes for large . On the basis of this picture

a proposal is made [59] for the existence of a tricritical point at som e \tricritical" value of . As is related with the charge e, this proposal seems to be in a conformity with other investigations. Note, that the rst prediction for change of the phase transition order with the variation of and for the possibility of \tricritical point\ to appear at some value of , has been made in Ref. [60] on the basis of duality arguments [61] and analytical calculations; see further development of this approach in Refs. [62, 63, 64, 65]. A further MC study [66] of type II superconductors indicates that these systems undergo a second order phase transition of universality class 3D XY rather than a weakly rst order phase transition. The two-loop RG studies [67, 68] show that the account of higher orders of the loop expansion allows a low ering of the critical value  $n_c = 365.9$  but the RG equations still have no real FP at D = 3 and n = 2 (conventional 3D superconductors), except for a treatment by Pade analysis [68] (see, also, the review [37]). In 2+ dim ensions, the m odel exhibits a second-order phase transition for all values of n > 0 [69]. Owing to this result one may suppose that the critical value no vanishes at some dimension 2 < d < 4, as m entioned in Ref. [70]. RG studies [71, 72] at xed dimension d have also been carried out with the aim to determ ine the phase transition order (see, also. Ref. [70] for a com m ent).

#### 3.3 Disorder e ects

Here we will discuss mainly disorder described by Gaussian distributions [4]. The e ects of annealed and quenched disorder in classical versions of Abelian-Higgsmodels, equivalent to the GL model (1) have been investigated by Hertz [73, 74] in the context of the theory of spin glasses in case of D zyaloshinskii-M oriya interaction. The speci c feature of this approach is that the disorder is associated with the vector gauge eld A (x) and can be used to describe superconductors in random, uncorrelated, or, which is the same, shortrange ( -) correlated magnetic elds rather than usual ones. In high energy physics this approach makes contact with gauge elds where a Higgs eld is coupled to a random color eld. It is natural to expect, as has been proven [40, 73], that the annealed gauge model will bring a uctuation-driven rst order phase transition at usual symmetry indices and a second order phase transition in the Hartree limit (n ! 1). In Ref. [40] the phase transition in case of quenched impurities has been predicted to be of second order in a calculation to one-loop order, in contradiction to the conclusion for a lack of stable nontrivial FP of the RG equations within the same one-loop order [73]. The origin of this discrepancy is clear from the argument that the lack of stable FP may result without any change of the Hamiltonian structure, whereas the conclusion for a second order of the transition in Ref. [40] has been made, perhaps, incorrectly, based on the argument of the absence of j = 1 term for D = 3 and of the absence of j = 1 in j = 2.

M ore usual case of quenched disorder in Abelian-Higgs models has been considered in Refs. [75, 76]. This is the case when the parameter a in (1) has a random part, which obeys a Gaussian distribution. This disorder is of type random in purities, or, what is the

same, \random critical temperature [4]. In case of the so-called \uncorrelated\, or, ( $\rightarrow$  short range correlated quenched impurities, the system exhibits a spectacular competition between the impurities and gauge e ects. The RG equations have a new stable FP of focal type [76] for dimensions D < 4, which exists for symmetry indices n > 1 and has a physical meaning at dimensions D > D c (n) = 2 (n + 36)=(n + 18) [76]. In the impure superconductor, the new focal FP occurs exactly in the domain of symmetry indices n < 365:9, where the HLM analysis [6] yields a lack of FP for the respective pure system. Having in mind the asymptotic nature of the -expansions within the RG approach [4,77], one may conclude that this focal FP governs the critical behavior at the real dimension D = 3 in conventional superconductors (n = 2), although the direct substitution of n = 2 in the above expression for the \lower critical" dimension D c (n) yields D c (2) = 3:8. This problem has been further investigated in Ref. [78]. Long-range quenched disorder within the same RG approach to the model (1) has been considered in Ref. [79].

The e ect of another relevant type of disorder, the so-called \random eld disorder", on the phase transitions described by the G L functional (1) as been considered in R ef. [80]. In both short-range and long-range random eld correlations [4,81,82] a new stable FP has been obtained [80]. For short range random correlations this FP is stable below the upper critical dimension D  $_{\rm U}$  = 6 and for symmetry indices n > n  $_{\rm c}$  = 10. This FP describes a quite speci c critical behavior. The situation for long range random correlations is more complicated and here we will advice the reader to follow the discussion in Ref. [80]. In general, the annealed disorder leaves the phase transition properties almost identical to those in the pure Abelian-Higgs model (1) whereas the quenched disorder gives a lower critical values of the symmetry index n, below which the weakly instituted racts in a direction of \sm earing \ the uctuation-driven instituted ransition, i.e. the HLM elect seems to be much weaker in such systems.

## 3.4 Liquid crystals

The rst theoretical study of the HLM e ect on the properties of the nem atic-smectic A phase transition in liquid crystals has been performed in Refs. [22, 23]. The main result of these investigations is the conmation of the HLM e ect in a close vicinity of this liquid crystal phase transition. Perhaps, because of the liquid crystal anisotropy, which explicitly enters in the propagator of the gauge eld [23], here the critical value  $n_c = 38:17$  of the symmetry index n, below which the weakly rst order transition occurs, is lower than in pure superconductors ( $n_c = 364:9$ ) but it is still quite above the real value n = 2. Thus the RG predictions in Refs. [22, 23] in seventies of the previous century were in favor of a weakly rst order phase transition whereas the experimentalists [83, 84] at the same time claimed that the same nematic-smectic A phase transition is of second order (for triple and tricritical points in nematic-smectic A-smectic-C systems, and the interrelationship to the present problem, see Ref. [85]), as well as later papers [86,

87]. While in 3D superconductors the HLM e ect is very weak and unobservable with available experimental techniques, the size of the same eet in 3D liquid crystals allows an observation in case of very precise experiment and elimination of obscuring eets as, for example, neighborhood to tricriticality and liquid crystal anisotropy. Experiments [88, 89] consistent with the HLM eet has been carried out but, as noticed in Ref [90], these experiments are at their resolution limits and the full implications of the HLM theory remains to be tested. On the other hand, experiments in Ref. [90] demonstrate a discrepancy with the simple approximation ( = const) for the smectic-A led within the mean-eld like approach (Sec. II).

#### 3.5 Miscellaneous

Quantum e ects. The rst account of quantum correlations (\ uctuations") [4, 91, 92] on the properties of the phase transition to superconducting state has been performed in Ref. [93]. It has been shown [93] that the dynamical critical exponent z produced by the quantum correlations at nite temperatures (T > 0) is given by z = 2 + 18 = n. This is purely gauge result because, as shown in ref. [94], the critical dynamics of a superconductor in case of neglecting the local gauge e ects (A = 0) is identical to that described by the time dependent GL = 0 model (TDGL) in case of lack of conservation laws [95]; a prediction of the latter result has been given for the rest time in Ref. [91]. A nother study [96] of a gauge model of type (1) is intended to the study of the quantum phase transition ( $T_{c0} = 0$ ) in granular superconductors. The simultaneous elect of the local T = 0 in the duantum uctuations has been considered in the study [97, 98] of disordered electronic systems at T = 0. The problem was further extended to the treatment of quantum phase transitions in underdoped high-temperature superconductors [99, 100].

Complex systems. The RG investigation [101] of systems with superconducting and other (non-m agnetic) orderings shows that the gauge eld A (x) leads to a drastic modi cation of the critical behavior in close vicinity of bicritical and tetracritical points (for such points, see, e.g., Ref. [2, 4]). Near these multicritical points the superconducting uctuations can be enhanced by the uctuations of another ordering eld and, hence, the HLM e ect in such complex systems seems to be stronger than in the simpler case discussed so far [102]. The coupling between the superconducting eld and the magnetization mode M (x) in models of ferrom agnetic superconductors intended to describe the coexistence of superconductivity and ferrom agnetism in ternary compounds has been investigated by RG in Ref. [103, 104]. It has been shown again that the gauge eld A (x) produces a weakly rst order phase transition enhanced by the M - uctuations. The sam e problem has been further opened in Ref. [105] by a lattice version of the GL model and dual argum ents [61] with the conclusion that under certain circum stances the phase transition from the disordered phase to the phase of coexistence of ferrom agnetism and superconductivity should be, at least in type II superconductors, of second order in contrast to the RG prediction [103, 104]. A nother investigation of coupled magnetic and superconducting order

param eters, where the gauge e ects are also relevant, is intended to describe a state of vortex solid in rear-earth and borocarbide compounds [106, 107].

Unconventional superconductors. A nother interesting problem is the behavior of unconventional superconductors [55, 108] where the eld is a complex vector: = f ; = 2;3g, i.e., n = 4 or 6, depending on the type of the unconventional Cooper pairing. It has been shown [109], that the HLM FP in this case is unstable towards the parameters, describing the anisotropy of the Cooper pair and the crystal anisotropy, and the new FP points that appear in the theory are unstable for usual values of the symmetry index (n = 4;6). It has been shown by analytical calculations [109] that one of the FP points that appear in the RG equations exists for  $n > n_c = 10988$  and is stable for some values above  $n_c$ , at least, in the Hartree limit (n ! 1 ). Owing to these results, and mainly due to very high value of  $n_c$ , a conclusion has been made that the HLM e ect should be more pronounced in unconventional superconductors [109]. A next step along this path of RG studies has been made in Ref. [110], where unconventional superconductors with quenched in purities have been considered.

External elde ect. In real experiments the external magnetic eld can hardly be completely eliminated. The study [38] of the HLMe ect in the wider context of nonzero external magnetic eld Hobban shows that the weakly rst phase transition discussed so far can be obtained in Landau gauge from a renormalized theory of the equation of state in one loop order; see also Ref. [45]. The phase transition at the second critical magnetic eld Hobban studied by a = (6 - d) expansion within the one loop approximation with the conclusion that the magnetic uctuation elects should produce a uctuation induced rst order phase transition [111]. Further investigations of this problem have been performed in the Hartree limit (n! 0) [112, 113], and in higher orders of the loop expansion [114, 115]; for comments, see Refs. [116, 117].
