M om ent equations in a Lotka-Volterra extended system with time correlated noise

A spatially extended Lotka-Volterra system of two competing species in the presence of two correlated noise sources is analyzed: (i) an external multiplicative time correlated noise, which m in ics the interaction between the system and the environment; (ii) a dichotomous stochastic process, whose jump rate is a periodic function, which represents the interaction parameter between the species. The moment equations for the species densities are derived in Gaussian approximation, using a mean eld approach. Within this formalism we study the elect of the external time correlated noise on the ecosystem dynamics. We not that the time behavior of the $1^{\rm st}$ order moments are independent on the multiplicative noise source. However the behavior of the $2^{\rm nd}$ order moments is strongly a ected both by the intensity and the correlation time of the multiplicative noise. Finally we compare our results with those obtained studying the system dynamics by a coupled map lattice model.

1. Introduction

Real ecosystems are in uenced by the presence of continuous external uctuations connected to the random variation of environmental parameters such as temperature and natural resources, which a ects the system dynamics by a multiplicative nonlinear interaction [1]. The spatio-tem poral behaviour and the form ation of spatial patterns became recently an important topic in hydrodynam ics system s, nonlinear optics, oscillatory chem ical reactions and in theoretical ecology [2]-[4]. During the last three decades a new approach, based on the use of moments, has been exploited to describe the behaviour of spatially extended system in population dynamics, quantum systems in the context of nonlinear Schrodinger equations, and kinetic m odels of polym er dynam ics [5]-[7]. In this paper, by using the form alism of the moments, we study the spatio-temporal behaviour of a two-dimensional system formed by two competing species subject to random uctuations. The system is described by generalized Lotka-Volterra equations in the presence of two noise sources: (i) a multiplicative time correlated noise with correlation times c, modeled as an 0 mstein-Uhlenbeck process [8], which takes the environment uctuations acting on the species into account; (ii) a noisy interaction parameter which is a stochastic process, whose dynamics is given by a periodic function in the presence of a correlated dichotom ous noise, with correlation time d. We de neatwo-dimensional spatial domain considering in each site a system of two Lotka-Volterra equations coupled by an interaction term [9]. Afterwards, using a mean eld approach, we study the dynamics of the system by the moment equations, within the Gaussian approximation [10, 11], getting the time behavior of the 1st and 2nd order m om ents of the species concentrations. Finally we compare our results with those obtained within the formalism of the coupled map lattice (CM L) m odel [12].

2. The model

Our system is described by a time evolution model of Lotka-Volterra equations, within the Ito scheme [13]-[15], with disciple terms in a spatial lattice with N sites

where $x_{i;j}$ and $y_{i;j}$ denote respectively the densities of species x and species y in the lattice site (i;j), is the growth rate, D is the diusion constant, and indicates the sum over all the sites except the pair (i;j). Here

is the interaction parameter. $^{1}(t)$ (l=x;y) are statistically independent colored noises, i. e. exponentially correlated processes given by the 0 mstein-U hlenbeck process [8]

and $^1(t)$ (l = x;y) are Gaussian white noises within the Ito scheme with zero mean and correlation function h $^1(t)$ m (t0)i = 2 (t t0) $_{lm}$. The correlation function of the processes of Eq.(3) is

2.1. The interaction parameter

The value of the interaction parameter—is crucial for the dynamical regime of the ecosystem investigated. In fact, for < 1 both species survive and a coexistence regime takes place, while for > 1 one of the two species extinguishes after a certain time and exclusion occurs. These two regimes correspond to stable states of the Lotka-Volterra's deterministic model [13]. Moreover periodical and random driving forces connected with environmental and climatic variables, such as the temperature, modify the dynamics of the ecosystem, a ecting both directly the species densities and the interaction parameter. This causes the system dynamics to change between coexistence (< 1) and exclusion (> 1) regimes. To describe this dynamical behavior we consider as interaction parameter (t) a dichotom ous stochastic process, whose jump rate is a periodic function




Fig. 1. Time evolution of the interaction parameter (t), driven by time correlated dichotom ous noise with correlation time d = 43.5. (t) jumps between down = 1.50.94 and $_{\rm up}$ = 1.04. The initial value is (0) = $_{\rm up}$ = 1.04. The values of the other param eters are: A = 9.0, $! = (2) = 10^{-2}$, $_0 = 2 \cdot 10^{-2}$.

Here t is the time interval between two consecutive switches, and $_{\rm d}$ is the delay between two jumps, that is the time interval after a switch, before another jump can occur. In Eq. (5), A and ! = (2)=T are respectively the amplitude and the angular frequency of the periodic term, and $_{\rm 0}$ is the jump rate in the absence of periodic term. Setting $_{\rm dow\,n}$ = 0:94 < 1 and $_{\rm up}$ = 1:04 > 1, the dichotom ous noise causes (t) to jump between two values, $_{\rm dow\,n}$ and $_{\rm up}$. The value $_{\rm d}$ = 43:5 for the delay corresponds to a competition regime with switching quasi-periodically from coexistence to exclusion regimes [11] (see Fig. 1). This synchronization phenomenon

is due to the choice of the d value, which stabilizes the jumps in such a way they happen for high values of the jum p rate, that is for values around the maximum of the function (t). This causes a quasi-periodical time behaviour of the species concentrations x and y, which can be considered as a signature of the stochastic resonance phenom enon [14].

3.M ean eld model

In this section we derive the moment equations for our system. A ssuming N! 1, we write Eqs. (1) and (2) in mean eld form

where $\langle x \rangle$ and $\langle y \rangle$ are average values on the spatial lattice considered, that is the ensemble average in the therm odynamics $\lim it. W = set f_x(x;y) =$ y), $g_x(x) = x$, $f_y(x;y) = y(1 y x)$, $g_y(y) = y$. By site averaging Eqs. (6) and (7), we obtain

By expanding the functions $f_x(x;y)$, $g_x(x)$, $f_y(x;y)$, $g_v(y)$ around the 1st order m om ents < x > and < y >, we get an in nite set of simultaneous ordinary di erential equations for all the moments. This equation set is truncated by using a Gaussian approximation, which causes the cumulants above the 2nd order to vanish. Therefore we obtain




Fig.2. T in e evolution of the $1^{\rm st}$ and $2^{\rm nd}$ orderm on ents for $^{\rm c}$ = 1. The time series of (a) < x (t) > and < y (t) > , and (b) $_{2;0}$ and $_{0;2}$ respectively, are completely overlapped. The values of the multiplicative noise intensity are: = 0;10 12 ;10 6 , from top to bottom. Here $_{\rm d}$ = 43.5, = 2, and D = 0.05. The initial conditions are: $^{\rm x}$ (0) = $^{\rm y}$ (0) = 0, < x (0) > = < y (0) > = 0.1, $_{20}$ (0) = $_{02}$ (0) = $_{11}$ (0) = 0. The values of the other parameters are the same of Fig.1.




Fig.3. Time evolution of the $1^{\rm st}$ and $2^{\rm nd}$ order moments for $^{\rm c}$ = 10. Here (a) < x(t) > and < y(t) > , and (b) $_{2;0}$ and $_{0;2}$ respectively, are overlapped. The values of the multiplicative noise intensity are: = 10^{-12} ; 10^{-6} , from top to bottom. The values of the other parameters and the initial conditions are the same of Fig.2.




Fig. 4. Time evolution of the $1^{\rm st}$ and $2^{\rm nd}$ order moments for $^{\rm c}$ = 100. Here (a) < x(t) > and < y(t) >, and (b) $_{2;0}$ and $_{0;2}$ respectively, are overlapped. The values of the multiplicative noise intensity are: = 10^{-12} ; 10^{-6} , from top to bottom. The values of the other parameters and the initial conditions are the same of Fig. 2.

The dynam ics of the two species is analyzed through the time behavior of 1st and 2nd order m om ents according to Eqs. (10)-(14), for di erent values both of intensities (= $_{x}$ = $_{y}$) and correlation time c (= $_{x}$ = $_{y}$) of the multiplicative colored noise. The results are reported in Figs. 2-4. The results shown in Fig. 2, obtained with a low value of the correlation time c reproduce the same time behavior obtained for uncorrelated white noise sources in Ref. [11]. The value of the time delay is d = 43.5, which determines a quasi-periodic switching between the coexistence and exclusion regimes. The values of the other parameters are: = 2, D = 0.05. The initial conditions are: x(0) = y(0) = 0, x(0) > 00:1, $_{20}(0) = _{02}(0) = _{11}(0) = 0$. These initial values for the moments correspond to uniformly distributed species on the considered lattice. In Figs. 2a, 3a, 4a we note that the 1st order m om ents undergo correlated oscillations around 0.5. This behaviour is independent both on the intensity and the correlation time of the multiplicative noise. On the other hand the behavior of the 2nd order m om ents depends strongly both on the intensity and the correlation time of the external multiplicative noise. In the absence of noise 20, 02, 11 maintain their initial values. For very low levels of multiplicative noise (= 10 12) quasi-periodical oscillations appear with the same frequency of the interaction parameter (t), because the noise breaks the sym m etry of the dynam ical behavior of the 2nd order m om ents (see Figs. 2b, 3b, 4b). About the variances of the two species, the time series of $_{20}$ and $_{02}$, which coincide all the time, show an oscillating behaviour characterized by small (close to zero) and large values. However the negative values of the correlation 11 indicate that the two species distributions are anticorrelated. In particular, we nd a time behavior characterized by anticorrelated oscillations, whose amplitude increases with the multiplicative noise intensity and it is reduced as the correlation

time becomes bigger (see Figs. 2b, 3b, 4b). This anticorrelated behaviour

indicates that the spatial distribution in the lattice will be characterized by zones with a maximum of concentration of species x and a minimum of concentration of species y and viceversa. The two species will be distributed therefore in non-overlapping spatial patterns. This physical picture is in agreement with previous results obtained with a dierent model [15]. A further increase of the multiplicative noise intensity (= 10^{-6}) causes an enhancement of the oscillation amplitude both in $_{20}$, $_{02}$ and $_{11}$. This gives information on the probability density of both species, whose width and mean value undergo the same oscillating behavior. The anticorrelated behavior is enhanced by increasing the noise intensity value. We note that the amplitude of the oscillations is of the same order of magnitude of the

noise intensity , that is the am plitude of the oscillations is enhanced as the noise intensity increases. The periodicity of these noise-induced oscillations shown in Figs. 2-4 is the same of the interaction parameter (t) (see Fig. 1). Moreover the right-hand side of Figs. 2-4 shows that the multiplicative colored noise a ects the time evolution of the $2^{\rm nd}$ order moments introducing a delay: the amplitude of the oscillations reaches its highest value after a time interval whose length increases as $^{\rm c}$ becomes bigger. In fact by comparing the rst gures in Figs. 2b-4b with $= 10^{-12}$, for example, the maximum is reached approximately at $^{\rm c}$ 110 for $^{\rm c}$ = 1, and at $^{\rm c}$ 330 for $^{\rm c}$ = 100.

4. Coupled M ap Lattice M odel

Our results, obtained by using moment equations in Gaussian approximation, can be checked studying the dynamics of the system by a dierent approach, namely the CML model

which represents a discrete version of the Lotka-Volterra equations.

Here $x_{irj}^{(n)}$ and $y_{irj}^{(n)}$ denote respectively the densities of preys x and y in the site (i; j) at the time step n, is the growth rate and D is the di usion constant. The interaction parameter (n) corresponds to the value of (t) taken at the time step n, according to Eq. (5). $_{i;j}^{\times (n)}$ and $_{i;j}^{y(n)}$ are independent Gaussian colored noise sources above dened in Eq. (3). Finally indicates the sum over the four nearest neighbors. To evaluate the $1^{\rm st}$ and $2^{\rm nd}$ order moments we dene on the lattice, at the time step n, the mean values < x > $_{\rm CML}^{(n)}$, < y > $_{\rm CML}^{(n)}$,




Fig.5. (a) Mean values: < x $>_{\text{CML}}$, < y $>_{\text{CML}}$, and (b) variances: var_x , var_y and cov_{xy} of the two species, as a function of time for $^c = 1$. The values of the multiplicative noise intensity are: = 0;10 12 ;10 6 , from top to bottom. The initial values of the species concentrations are $x_{ij}^{(0)} = y_{ij}^{(0)} = 0$:1 for all sites (i;j). The values of the other param eters are the same of Fig.2.

and the covariance $cov_{xy}^{(n)}$ of the two species

where N = 100 100 is the number of lattice sites. We note that < x $>_{\text{CM L}}$, < y $>_{\text{CM L}}$ and varx, vary, covxy, corresponding respectively to < x >, < y >, and $_{20}$, $_{02}$, $_{11}$ obtained within the mean eld approach, are the 1^{st} and 2^{nd} order moments dened within the scheme of the CM L model. The time behavior of these quantities, for three dierent values of the multiplicative noise intensity, and for three dierent values of the correlation time is reported in Figs. 5-7. Comparing these results with those shown in Figs. 2-4, we note that the time behaviour obtained for the 1^{st} and 2^{nd} order moments by the CM L model is in a good qualitative agreement with




Fig.6. (a) M ean values: < x $>_{\text{CML}}$, < y $>_{\text{CML}}$, and (b) variances: varx, vary and covxy of the two species, as a function of time for $^{\text{C}}$ = 10. The values of the multiplicative noise intensity are: = 10 12 ;10 6 , from top to bottom. The values of the other param eters and the initial conditions are the same of Fig.5.




Fig.7. (a) M ean values: $\langle x \rangle_{\text{CML}}$, $\langle y \rangle_{\text{CML}}$, and (b) variances: var_x , var_y and cov_{xy} of the two species, as a function of time for $^{\text{c}}$ = 100. The values of the multiplicative noise intensity are: = 10 12 ;10 6 , from top to bottom. The values of the other param eters and the initial conditions are the same of Fig.5.

those found using the mean eld approach. In particular we note the role played by the multiplicative noise: higher noise intensity causes the 2nd order m om ents to increase (see in Figs. 5-7 the enhancem ent of the oscillation m axim a as the multiplicative noise intensity increases). This indicates both a spread of the two species concentrations and a spatial anticorrelation between them. These results agree with those found within the formalism of the m om ent equations. We observe that the time behaviour of var, var, cov_{xv} is characterized by the presence of oscillations whose maximum amplitude is reached after a time delay. This peculiarity is the same of that found within the mean eld approach (see paragraph 3). The discrepancies in the oscillation intensities are due to: (i) the Gaussian approximation in the mom ent form alism; (ii) the fact that the species interaction in the CM L m odel is restricted to the nearest neighbors; (iii) the di erent stationary values of the species densities in the considered models. Specically, using for an average value, aver = (up + down)=2, we get: $x_{st} = y_{st} = 1 = (1 + aver) ' 0.5$ for the m ean eld model, and $x_{st}^{\text{CM L}} = y_{st}^{\text{CM L}} = (1 1 =) = (1 + \text{aver}) ' 0.25$ for the CM L m odel.

5. Conclusions

By using the moment formalism in Gaussian approximation, we describe the time behavior of two competing species inside a two-dimensional spatial domain in the presence both of a multiplicative colored noise and a dichotom ous noise. We not that the 1st order moments of the two species densities show correlated oscillations, whose amplitude is independent on the multiplicative noise. However, the behavior of the 2nd order central m om ents depend strongly both on the intensity and the correlation time of the multiplicative noise. In particular, the behavior of the 2nd order m ixed moment 11 indicates that higher values of the multiplicative noise intensity push the two species towards an anticorrelated regime characterized by oscillations whose maximum amplitude is reached after a delay time: this delayed behaviour depends on the correlation time c. W e nd a good qualitative agreem ent between these results, obtained within the mean eld approach, and those found by the CML model. In view of some applications of our model, to describe and to predict the behaviour of biological species, we note that in real ecosystems the uctuations are characterized by a cut-o. Therefore experimental data [16], whose dynamics is strongly a ected by noisy perturbations and stochastic environm ental variables, can be better modeled using sources of colored noise.
