## Pairing in Asymmetrical Fermi Systems with Intra- and Inter-Species Correlations

We consider inter- and intra-species pairing interactions in an asymmetrical Fermisystem. Using equation of motion method, we obtain coupled mean-eld equations for super uid gap functions and population densities. We construct a phase diagram across BCS-BEC regimes. Inclusion of intra-species correlations result in stable polarized super uid phase on BCS and BCS sides of unitarity at low polarizations. For larger polarizations, we not phase separations in BCS and BEC regimes. A super uid phase exists for all polarizations deep in BEC regime. Our results should be apply broadly to ultra-cold fermions, nuclear and quark matter.

Pairing in two-species Ferm i systems with unequal population is of great current interest and importance across a wide range of elds and systems. Examples are unequal density mixtures of ferm ionic cold atoms [1, 2]; arbitrarily polarized liquid <sup>3</sup>H e; superconductors in external magnetic eld [3], in strong spin-exchange eld [4, 5, 6], or with overlapping bands [7, 8]; isospin asymmetric nuclear matter [9] and dense quark matter exhibiting color superconductivity [10]. Unequal density cold ferm ions serve as prototypical systems, providing an unprecedented window into exploring super uidity with tunable repulsive and attractive interactions. These are attained by sweeping across with sorp-wave Feshbach resonances, thereby allowing the study of ferm ion ground states in both BCS and BEC regimes.

Among the outstanding questions in asymmetrical Ferm i systems is the nature of the ground state in the BCS and BEC regimes, and whether the BCS superuid state can sustain any nite imbalance between the species. Thus, it is important to arrive at a plausible phase diagram as a function of pairing interaction strength and species imbalance. Two-species systems are conveniently characterized as two pseudo-spin system s. It is believed that the BCS ground state in a nite magnetic eld h, is robust against spin polarizations for , (being the superconducting gap); beyond this it becomes unstable to a normal state. For equal population cold atom systems, there is theoretical agreement with experiments that nd super uid states in both BCS and BEC regimes with a \smooth crossover" around the \unitarity lim it" (diverging singlet scattering length as).

For systems with population imbalance, various theoretical scenarios have been proposed [11, 12, 13]. Meaneld calculations [12, 13] and the super uid state to be unstable to phase separation into super uid and normal states or a mixed phase in the BCS regime; a superuid state stabilizes however deep in the BEC regime. Currently there is intense experimentale orts in unequal density cold ferm ion atoms. One experiment [2] observed a transition from a polarized super uid to phase separation at a polarization.




FIG. 1: (Color online) Polarization P vs s-wave coupling,  $1=(k_F\,a_s)$  phase diagram for asymmetrical fermions:(a) with a representative intra-species correlation strength  $g_1=20$ , corresponding to  $1=(k_F^3\,a_t)=1\,25$ ; (b) without intra-species correlations,  $g_1=0$  (also obtained in Ref [13]). Vertical line refers to the unitarity limit; PS1, PS2, PS to phase separated regions; N to normal state.

side. To date, theoretical calculations have mostly considered inter-species s-wave interaction, and have ignored intra-species correlations. Ho et al [14] attempted to incorporate triplet correlations in a som ewhat phenom enological manner; Huang et al [15] recently explored the implications for a FFLO state; Monte Carlo calculations [16] hint at a polarized super uid phase near unitarity.

In this paper, we address the issue of the nature of the zero tem perature (T=0) ground state of an asymmetrical Ferm i system for arbitrary repulsive/attractive interaction strength and polarization. We also exam ine if the BCS super uid state can sustain a nite population imbalance. We hile the unequal density cold ferm ion systems may provide a way to test our results, our paper should have a broader appeal, viz. electronic superconductivity, nuclear and quark matter super uidity, etc. Generally, both inter-species and intra-species correlations may be present in an asymmetrical Ferm i system. These may

arise from the underlying ferm ionic potentials (atom ic, electronic, nucleon-nucleon, quark-quark) or from e ects of the medium, i.e. \induced" interactions [17, 18]. We include the simplest ones allowed by symmetry: s-wave contact interaction between the species, and a p-w ave interaction within the species. Following Leggett [19] and Eagles [20], our discussion is in term s of BCS-type pairing in both the BCS and BEC regimes, with the chemical potentials for the two species determ ined self-consistently with the pairing gaps. We do a detailed stability analysis of the multitude of states obtained from our equations.

Our ndings are dram atically dierent from those without intra-species correlations, 0 ur proposed phase diagram, Fig. 1a, shows that at T=0, for smaller polarizations, and su ciently large intra-species correlations, gapped polarized super uidity (hereafter referred to as SFP) becomes stable on both BCS and BEC sides of the \unitarity" lim it. Depending on the inter-species interaction strength, at some polarization, SFP becomes unstable via a 1st-order transition to phase separation, denoted by PS1. PS1 is characterized by a negative \susceptibility", P = h; P being the spin-polarization, and h the di erence of the chem ical potentials, playing the role of a \m agnetic eld". For a given intra-species interaction, and for su ciently weak inter-species interaction, SFP and PS1 undergo transitions to the normal state on the BCS side. The gapped SFP persists into the BEC regim e, sustaining progressively smaller polarizations. Deeper in the BEC regime, we nd a super uid phase (SF) at all polarizations. In the BEC regime, in addition to PS1, we nd the existence of a som ew hat di erent phase separated state, PS2, characterized by positive \susceptibility", but not satisfying requisite super uid ground state stability criteria.

For our detailed study, we consider a two-species Ferm i system with unequal \pseudo-spin" populations. To allow for both inter-species and intra-species correlations, and noting that pseudo-spin rotation invariance would be broken by unequal chemical potentials, we adopt a pairing Ham iltonian given by

where the pseudospin = "; # denote for example the two hyper ne states of ultracold Ferm i atom s.  $c_k^+$  is the ferm ion creation operator with kinetic energy k; is the chem ical potential of each of the species.  $g_{kk^0}^{""}\text{, and }g_{kk^0}^{\#\#}$  are the interactions between the up and down spins respectively, and V is the volume. The singlet interaction,  $g_{kk^0}^{\text{"}\#}$  is taken to be a constant,  $g_{\text{o}}$  . This is usually expressed in terms of s-w  $_{\text{B}}\text{ve}$  scattering length  $a_s$  using  $(4 h^2 a_s = m)^1 = g_0^1 + \frac{1}{k} (2_k)^1$ . A mean-eld decoupling is attained by introducing three order param eters or gap functions (;  $^{0} = "; #)$  given by,  $_{k^{0}} g_{kk^{0}} < c_{k^{0}+q=2} c_{k^{0}+q=2} > This re$ sults in a mean-eld Hamiltonian given by:

We employ the equation of motion method using imaginary time normal and anomalous Matsubara Green's functions, G o(k; ), F o(k; ), respectively, and our m ean-eld H am iltonian, H  $^{\rm M}$  F . The coupled equations in terms of  $\circ$  are given by  $G \circ (k;)$  and  $F \circ (k;)$ :

is the imaginary time variable. These equations may be Fourier transformed in the usualway with !  $iw_n$ , @ !  $iw_n$ , where  $iw_n = (2n + 1) =$ are the M atsubara frequencies, n being an integer and  $= 1=k_BT$ .

Here we focus on a super uid condensate of pairs with zero center-of-m ass m om entum, q. Thus, we do not consider the q f 0 Fulde-Ferrel-Larkin-Ovchinnikov (FFLO) state [4, 5], but which may also be studied within this scheme. Solving the Fourier transformed equations at q = 0, we obtain the 2-point correlation functions:

where f=2b+2 a b; f=2+4 a can be found by examining the poles of the G reen's functions, yielding the quasiparticle energies,

where is even for l=+, and odd for l=-;  $n_F$  (E  $_{kl}$ ) are the Ferm i functions. Likew ise the three gaps equations are given by (;  $^0=";\#$ ):

The above ve equations are coupled, and can be solved self-consistently for the three gap functions, ; ";  $_{\sharp}$  for either xed particle concentrations,  $n_{\sharp}$ ,  $n_{\sharp}$ , or xed chem ical potentials, ",  $_{\sharp}$ .

We assume equal masses for the two species, and take the particle spectrum to be  $k = h^2k^2 = 2m$ . We adopt standard de nitions: polarization,  $P = (n_1 n_2) = (n_1 + n_2)$  $n_2$ ); m ean chem ical potential = (1 + 2)=2; chem ical  $R_1 \atop 0$   $k_F^3$  f (k=k\_F)  $\frac{d^3(k=k_F)}{(2)^3}$ , we can scale quantities having dim ension of energy to  $_{\rm F}$  . The inter-species interaction  $g_0$  is expressed in terms of coupling constant =  $1=(k_F a_s)$ . For the intra-species triplet interaction, we take the separable form  $g_{kk^0} = g_1! (k)! (k^0) Y_{10} (\hat{k}) Y_{10} (\hat{k}^0)$ , where we have taken  $g_{""} = g_{\#\#}$   $g_1$ . More generally the m = 1 term swould also be present; however this choice allows us to explore the consequences of intra-species correlations while keeping the calculations tractable. As a check, we also consider di erent types of momentum dependence: (i) ! (k) / const; (ii) ! (k) /  $k_0 k = (k_0^2 + k_0^2)$ k2), a generalization of the Nozieres and Schm itt-Rink schem e [21]; (iii) ! (k) / exp [  $(k=k_0)^2$ ], a G aussian interaction; ko being a cut-o m om entum; these give qualitatively similar behavior. The rst two forms of interaction require regularization due to ultraviolet divergence, while the third does not. With regularization, q1 can be expressed in terms of a triplet scattering volume  $a_t$  [22]:  $(4 h^2 k_0^2 a_t = m)^{-1} = g_1^{-1} + \frac{P}{k} w (k)^2 = (2 k)$ . Thus,  $(3n=2_F)g_1$  g<sub>1</sub> in our plots can be easily expressed in term sofa<sub>t</sub>; e.g.  $g_1 = 20$  corresponds to  $1 = (k_F^3 a_t) = 1.25$ .

For arbitrary inter-species s-w ave and and intra-species p-w ave pairing interactions, and population in balances, we obtain self-consistent solutions of the T = 0 gap functions, ; "; #, and chem ical potentials, . On the BCS side, for a given  $g_o$ , the "# gap decreases with increasing intra-species interaction strength  $g_1$ , while at the same time both "; # ( "  $\frac{6}{3}$  #) increases, crossing at some value of  $g_1$ . The suppression of is more pronounced at larger polarizations.

A proper construction of the asym metrical Ferm i system phase diagram requires a determination of stable ground states out of the manifold of paired condensates given by our equations [13, 23]. A coordingly, we carefully consider the stability criteria. The mean-eld ground state energy as a function of the gaps at dierent polarizations, P is given by:




FIG. 2: (Color online) Polarization  $P = \frac{n_* - n_{\#}}{n_* + n_{\#}}$  vs  $h = \frac{n_* - n_{\#}}{n_* + n_{\#}}$  (h acts like a \magnetic eld") for di erent intraspecies strengths  $g_1$  at a xed inter-species coupling = 0.25.

both BCS and BEC regim es, is characterized by  $E_G$  with a global minimum at non-zero gaps and self-consistently determined values of 's, and  $\frac{\text{@P}}{\text{@h}} > 0$ . SFP sustains larger polarizations for progressively larger  $g_1$ .

Sim ilar to the case without intra-species correlations,  $g_1$ , there exists a maximum polarization,  $P_{max}$  on the BCS side, beyond which we nd no solution to the coupled equations; this determ ines the SFP/PS1 \$ N boundary (Fig. 1a). Pm ax is slightly decreased at unitarity by  $g_1$ . It decreases with increasing =  $1=k_F a_S$ . For a xed g<sub>1</sub>, close to both BCS and BEC sides of unitarity, and for sm all polarizations, unlike-spin pairing has appreciable value in the polarized super uid SFP. However away from unitarity on the BCS side, "# decreases, and "" and ## pairing becomes more dominant in SFP, as inter-species interaction becomes relatively weak compared to intra-species interaction. On the BEC side away from unitarity, on the other hand, "# is m ore dom inant, and with " and # becoming negligible, SFP becomes unstable to phase separation, PS2. A SF phase em erges deep in the BCS regime with predom inantly unlike-spin pairing at low polarizations and majority spin pairing at higher polarizations.

The region PS1 in Fig 1a is characterized by negative \susceptibility",  $\frac{\text{QP}}{\text{Qh}}$  and doe not satisfy the stability matrix criteria. For a given P and h, E<sub>G</sub> is a maximum at the non-zero gap solutions, separating two localminima { a feature of phase separation into a normal and a super uid component by 1st-order phase transition. In this context, it is instructive to study P as a function of h= for di erent values of  $g_1$ , for a xed (shown in Fig 2 for = 0.25 (BCS side)). For  $g_1 = g_1^c$  15, the slope is vertical ( $g_1^c$  is the value of  $g_1$  at which maximum polarization,  $P_{max}$  occurs for a given ). For  $g_1 = g_1^c$ , the slope is negative, corresponding to the BCS super-

uid state being unstable to the norm al state for h > but robust against polarization for  $h < .For g_1 > g_1^c$ the singlet super uid state can sustain a nite polarization, which exhibits a behavior over the range given by: P /  $ah + bh^3 + c$ ;  $a_ib_ic$  being constants. The linear behavior is achieved for larger values of g1, and at low polarizations. In examining P vs h= behavior beyond  $P_{max}$ , we nd, for a given  $g_1$ , two solutions of P corresponding to one value of h= . To make a connection to Fig. 1a, obtained for  $g_1 = 20$ , we note that the allowed range of polarizations for SFP in P vsh= considerations corresponds to the = 0.25 vertical line, term inating at the SFP-PS1 boundary (Fig 1a). The same line extended from SFP-PS1 boundary to PS1-N boundary correspond to the polarization range bounded by the two solutions of P at a h = in Fig 2. The region PS2 in BEC regime, though characterized by  $\frac{\text{@P}}{\text{@h}} > 0$ , is not a stable superuid phase, since the stability matrix condition cannot be satis ed. The line separating PS1 and PS2 is probably a metastable line, the position of which depends on the p-w ave interaction strength.

In sum mary, we nd that the inclusion of intra-species correlations in asymmetrical Fermi systems results in a stable polarized super uid phase SFP at low polarizations on both BCS and BEC sides of unitarity. We have discussed the nature of the paired states and transition to phase separated states. The SF phase obtained in the deep BEC regime in the case without intra-species correlations, also em erges here with dom inant unlike-species pairing, accompanied by weakerm a prity-species pairing. Our results should be of broad interest as it should be of relevance to any asym m etrical Ferm isystem, with proper choice of interaction param eters. Here, our choice of param eters appear to agree with cold atom experim ent [2] that found a SF to PS transition around 10% polarization around unitarity on the BEC side. Also, the maxim um polarization 70% at unitarity is in agreement with experiments. Further experiments at low polarizations on both sides of unitarity are needed to test our detailed results. Experim ents that measure dierences in m om entum distributions of two species could provide further test. Finally, our phase diagram indicates a tricritical point (SFP,PS1,N phases) at low polarization on the BCS side, in addition to one on the BEC side at 1. This should lead to interesting study of the evolution of these two tricritical points at nite-T; we are exploring these e ects.
