Quantization of the elastic modes in an isotropic plate

A bstract

We quantize the elastic modes in a plate. For this, we nd a complete, orthogonal set of eigenfunctions of the elastic equations and we normalize them. These are the phonon modes in the plate and their speciet forms and dispersion relations are manifested in low temperature experiments in ultra-thin membranes.

1 Introduction

Now adays, the devices used in many high-sensitivity applications reached such a level of miniaturization, that the wavelength of the quantum quasiparticles used in their modeling is comparable to the dimensions of the device. The examples we are most familiar with are the ultra-sensitive electromagnetic radiation detectors. In a very general way of speaking, such detectors consist of some thin metallic lms, a few tens of nanometers in thickness, deposited on a dielectric membrane. The dielectric membrane is usually made of SiN and has a thickness of the order of 100 nm. To reach the level of sensitivity and speed required for applications, these detectors have to work at sub-Kelvin temperatures and at such temperatures the dominant phonon wavelength is comparable to the devices' thickness [1, 2, 3, 4, 5, 6, 7, 8, 9].

To describe the therm all properties of such membranes or detectors, the electron-phonon interaction, or in general any interaction of phonons with impurities or disorder in the membrane, we have to know the phonon modes in the membrane. For this, we have to not the eigenmodes of the elastic equations and quantize the elastic eld.

For in nite half-spaces, the quantization has been carried out by Ezawa [10].




Figure 1: Typical plate, or mem brane, like the ones used to support mesoscopic detectors. The thickness d is of the order of 100 nm and 1 d. The plate surfaces are parallel to the xy plane and cut the z axis at d=2.

1.1 E lastic eigenm odes in plates with parallel surfaces

The elastic eigenm odes in plates with parallel surfaces have been studied for a long time, mostly in connection with sound propagation and earthquakes (see for example Ref. [11]). To introduce these modes, let us consider a plate of thickness d and area 1^2 , with 1 d. The two surfaces of the plate, or membrane, are parallel to the (xy) plane and cut the zaxis at d=2 (see Fig.1). Throughout the paper we shall use V for the volume of the membrane (or in general of the solid that we describe (see Section 2.1) and @V for its surface. We shall assume that 1 is much bigger than any wavelength of the elastic perturbations considered here. The displacement eld at position r is going to be denoted by u (r) or v (r). The unit vectors along the coordinate axes are denoted by \hat{x} , \hat{y} , and \hat{z} .

The displacement elds obey the dymanic equation

Here, as everywhere in this paper we shall assume summation over repeated indices. Assuming that the medium is isotropic (see for example Ref. [11] for the constraints on the tensor [c]), Eq. The surface is free, so the stress should be zero there. This amounts to the boundary conditions [11, 10]

where \hat{n} is the unit vector normal to the surface, of components n_1 ; n_2 , and n_3 (we shall use this notation throughout the paper.

Applying Eqs. (2) and (3) to the plate we obtain the elastic eigenm odes, which are classi ed in three groups, according to their sym metry or polarization direction: the horizontal shear (h), the sym metric (s) and the antisym metric (a) waves. All these waves are propagating (or decaying, if the wave-vector is complex) along the membrane and have a stationary form in the direction perpendicular to the surfaces. The h wave is polarized parallel to the surfaces and perpendicular to the propagation direction. The s and a waves are superpositions of longitudinal and transversal waves, polarized in a plane that is perpendicular to the surfaces and contains the propagation direction. The difference between the s and the awaves comes from the fact that the displacement eld along the z direction is symmetric for the swave and antisymmetric for the awave, while the displacement eld along the propagation direction is antisymmetric for the swave and symmetric for the awave (see below). Explicitely, the three types of modes are:

where \hat{k}_k is the unit vector along the propagation direction and $k_k=k_k$ \hat{k}_k . In the s and a modes, the wavevector in the z direction takes two values, k_t and k_l , one corresponding to the transversal component of the mode, the other one corresponding to the longitudinal component. The constants N $_h$, N $_s$, and N $_a$ are the normalization constants, which will be calculated in Section 3.

The components of the wavevectors, k_t , k_l , and k_k obey the transcendental equations [11],

A llthe solutions of the elastic equation (2) are given by equations (4a), (4b), and (4c), with m taking all the natural values, 0;1;::;, whereas k_t and k_l are the solutions of Eqs. (5a) and (5b). k_k can be a complex number, but the complete, orthogonal set of phonon modes that we shall use in the quantization of the elastic eld are the ones with k_k running from 0 to 1

The paper is organized as follows: in section 2.1 we show that Γ is self-adjoint even when applied to the displacement eld of an elastic body of arbitrary shape. Therefore, we can form a complete, orthonormal set of its eigenfunctions.

The fact that the elastic modes (4) corresponding to dierent quantum numbers are orthogonal to each other is proved in Section 22, based on the hermiticity of Γ .

The normalization constants are calculated in Section 3 and the formal procedure of quantising the elastic eld is presented in Section 4.

We apply this form alism elsewhere to calculate the phonon scattering in am orphous, thin m em branes.

2 Orthogonality and completeness of the set of elastic eigenmodes

2.1 Self-ad pintness of the operator I

We shall prove the self-adjointness of Γ on an arbitrary volume V. We assume that V has the smooth border, @V. The operator Γ acts on the Hilbert space H which consists of the vector functions dended on V, which are integrable in modulus square. The scalar product on H is dended as usual,

for any function g(r) of class $C^1(V)$ (i.e. g(r) is derivable, with continous rst derivatives on V) and all the integrals on the right-hand side of Eq. (7) exist and are nite.

Returning to our operator, let us rst note that the space D (Σ) includes the space of functions twice derivable, with continous, integrable, second derivatives, C^2 (V), which is dense in H. Therefore D (Σ) is also dense in H, and Σ is a

The adjoint operator Γ^y is defined by the relation Γ^y v = v , for all v that satisfy (8). The functions that satisfy (8) form the domain of Γ^y , denoted D (Γ^y). Since Γ is herm itian, if v; u 2 D (Γ), then hv Γ ui = h Γ v jui is a linear functional, so any function from D (Γ) is included in D (Γ^y). Therefore we can write D (Γ) D (Γ^y). Going back to the plate with in nite lateral extension, we have to nd from the wave functions of the form (4) a complete, orthonormal set. We can do that by using the operator K_k i($\mathbb{Q}_k + \mathbb{Q}_y$), which is also self-adjoint when acting on wave-functions de ned on a plate with in nite lateral extension, or on a nite, rectangular plate, with periodic boundary conditions at the edges. Since \mathbb{E} and K_k commute and they are both self-adjoint operators, if we nd all the eigenfunctions common to \mathbb{E} and K_k , then we have a complete set. But these functions are given by Eqs. (4), with real k_k , and k_t and k_t satisfying (5).

2.2 Orthogonality of the elastic eigenm odes

Now we study the orthogonality of the elastic eigenm odes of the plate. For this, we write the the functions that appear in Eqs. (4a)-(4c) in general as u_{k_k,k_t} ; (r) u_{k_t} ; (z)e^{ik_k}, where we separated the x and y dependence of the elds from the z dependence and we disregarded the time dependence. By we denote the \polarization" h, s, or a. We shall not use k_1 explicitly in the notations below, since it is determined in plicitly by k_t , k_k , and Eqs. (5). The operator \tilde{K}_k has eigenvectors of the form $g(z)e^{ik_k}$, where g(z) is an arbitrary function of z while the eigenvalue k_k , perpendicular on z, has real components along the x and y directions. We analyse the common set of eigenvectors of \tilde{L} and \tilde{K}_k , so in what follows we shall consider only the cases with real wave-vectors k_k . First we observe that

For simplicity we choose $k_k = \hat{x}_k$, so the h waves are polarized in the \hat{y} direction and the s and a waves have displacement elds in the (xz) plane. Since the displacement eld of the h waves are perpendicular to the displacement elds of the s and a waves, any h wave is orthogonal to any s or a wave. Similarly, for the same k_k , the displacement elds of any of the s and a waves, although in the same plane, are orthogonal to each-other due to their opposite symmetries. We conclude that

3 Normalization of the elastic modes

From this point on we shall assume that the plate has nite lateral extensions of area A=1 land the eigenfunctions obey periodic boundary conditions in the (xy) plane. The volume of the plate is V=Ad. As a consequence, the values of k_k are discrete and the scalar product (17) should give




Figure 2: The curves $(k_1(k_k);k_t(k_k))$ for sym m etric (a) and antisym m etric (b) Lamb m odes. On each curve k_k varies from 0 to 1, as we go from its right end to the left. The di erent curves correspond to di erent branches of the dispersion relation, i.e. to di erent values of k_1 and k_t at $k_k=0$. Both, k_1 and k_t m ay take real and im aginary values. The imaginary values of k_1 , denoted by 1 are to the right of the vertical axis and the imaginary values of k_t , denoted by k_t are below the horizontal axis in both gures. As in the rest of the paper, d is the thickness of the plate. For these plots we used $k_t=0$. Both, $k_t=0$ is the thickness of the plate. For these plots we used $k_t=0$. Both, $k_t=0$ is the thickness of the plate. For these plots we used $k_t=0$. Both, $k_t=0$ is the thickness of the plate. For these plots we used $k_t=0$. Both, $k_t=0$ is the thickness of the plate. For these plots we used $k_t=0$. Both, $k_t=0$ is the thickness of the plate. For these plots we used $k_t=0$. Both, $k_t=0$ is the plate of $k_t=0$. Both, $k_t=0$ is the plate of $k_t=0$. Both $k_t=0$ is the plate of $k_t=0$ is the plate of $k_t=0$. Both $k_t=0$ is the plate of $k_t=0$ is the plate of $k_t=0$. Both $k_t=0$ is the plate of $k_t=0$ is the plate of $k_t=0$ is the plate of $k_t=0$. Both $k_t=0$ is the plate of $k_t=0$. Both $k_t=0$ is the plate of $k_t=0$ is the plate of $k_t=0$ is the plate of $k_t=0$. Both $k_t=0$ is the plate of $k_t=0$ is the

For sym m etric Lamb m odes, from Eq. (5b) we calculate k_1 and k_t as functions of k_k . The results are shown in Fig. 2 (a). As expected, for each value of k_k , the wave-vectors k_1 and k_t take only discrete values, but not as simple as the values corresponding to the h m odes (4a). Each curve in Fig. 2 (a) corresponds to a different branch of the dispersion relation, $!_{k_k,k_t,(k_k,m);s}$, where $m=0;1;\ldots$ denotes the branch number. B ranches with bigger m are placed above branches with smaller m .

As k_k increases, $k_1(k_k;m)$ decreases and, after reaching the value 0, turns in aginary. On the other hand, $k_t(k_k;m)$ rst increases with k_k , reaches a maximal value and then decreases monotonically as k_k increases to in nity. Its decrease is bounded for all branches, except the lowest one, where, after reaching zero at some nite k_k , it turns in aginary in the lower-left quadrant of Fig. 2 (a). For the clarity of the calculations, the in aginary values of k_1 and k_t are denoted as i_1 and i_t , respectively, where i_1 and i_t take real, positive values. Both, i_1 and i_t increase without i_t in it as i_t increases to in nity.

Equations (22) are very general. For the phonon m odes (i.e. for real $k_{\rm k}$), $k_{\rm t}$ and $k_{\rm l}$ are either real or imaginary and the normalization constants (20) and (21) can be extracted from (22) by taking the limit of the redundant component of $k_{\rm t}$ and $k_{\rm l}$ going to zero. The normalization constants (19), (20), and (21) are chosen so that $jj_{\rm l}k_{\rm k};k_{\rm t};~jj=1$, for any $j_{\rm k}k_{\rm k}$ and $k_{\rm t}$. In the next section the wave-functions will be multiplied by still another constant, which will give the right dimensions to the phonon eld.

4 Quantization of the elastic eld

For the quantization of the elastic eld we start from the classical Hamiltonian:

(25) we do not take k_1 as a summation variable, since this is either zero (for helds), or is determined by k_k and k_t (via Eq. (5a) or Eq. (5b) for the symmetric and antisymmetric case, respectively).

U sing Eqs. (25), with the proper normalization of f, we can write U $\,$ (23) in operator form,

As expected, the Ham iltonian of the elastic body can be written as a sum of Ham iltonians of harm onic oscillators. These oscillators are the phonon modes of the plate.

We use this form alism elsewhere to describe the interaction of phonons with the disorder in am orphous materials [13, 14].

5 Conclusions

The vibrationalm odes of a thin plate (4) are well known from elasticity theory [11]. The purpose of the paper is to quantize the elastic eld and for this we have to know if these modes, or part of them, form a complete set of orthogonal functions. But since the modes are the solutions of the eigenvalue-eigenvector problem of the operator Γ (2), we showed that they form a complete set by proving that Γ is self-adjoint.

Nevertheless, not all the functions of the form (4) are orthogonal to each other, so to build the complete, orthogonal set of functions, we made use of a generic \m om entum " operator, $K_k = i(Q_k + Q_y)$, which commutes with Γ . Since for a plate with in nite lateral extension or a nite rectangular plate with periodic boundary conditions at the edges the operator K_k is also self-adjoint, Γ and K_k adm it a common, complete set of orthogonal eigenfunctions. The degenerate eigenvalues of K_k are, of course, the wave-vectors parallel to the plate surfaces, k_k , of real components. Therefore, the complete set of eigenfunctions are the ones given by Eqs. (4), with real k_k .

In Section 22, based on the herm iticity of the operator Γ , we showed that these functions (4) are indeed orthogonal to each-other and in Section 3 we calculated the normalization factors.

Having all these ingredients, in Section 4 we presented the form al quantization procedure which is applied elsewhere [13, 14] to calculate the therm all properties of ultra-thin plates at low temperatures, and to deduce some of the observed features of the standard tunneling model in bulk am orphous materials.
