Longest increasing subsequence as expectation of a sim ple nonlinear stochastic PDE w ith a low noise intensity

#### Abstract

W e report som e new observation conceming the statistics of Longest Increasing Subsequences (LIS).W e show that the expectation of LIS, its variance, and apparently the full distribution function appears in statistical analysis of som e sim ple nonlinear stochastic partial di erential equation (SPDE) in the lim it of very low noise intensity.


## I. INTRODUCTION

Last decade is $m$ arked by a breakthrough in the solution of a classicalprobabilistic problem, known as "U lam problem " discussed in the $m$ athem atical literature over the years [1]. The general setting of the $U$ lam problem is as follow s . Take the unit interval $[0 ; 1]$ and pick up from it one after another $N$ random numbers $(\mathbb{N} \quad 1)$ w ith uniform probability distribution. H aving the sequence of $N$ random num bers, one can extract from it the longest increasing subsequence (L IS) of $k$ elem ents. The entries of this subsequence are not obliged to be the nearest neighbors. There are two basic questions of interest: i) what is the expectation $\mathrm{hk}(\mathbb{N}) \mathrm{i}$ of LIS; and ii) what are the uctuations of the $m$ ean length of LIS. T he rst question has been answ ered in 1975 by Vershik and K erov [2] who have show $n$ that $h k(\mathbb{N}) i=2^{N}$ for $N \quad$ 1. They derived this result by $m$ apping the expectation of the LIS to the expectation of the rst row of ensemble of Young tableaux over the $P$ lancherel $m$ easure. If the initial random sequence contains repeated num bers, then the rst line of the Y oung tableau corresponds to the longest nondecreasing subsequence.

The progress in treatm ent of uctuations of LIS was the subject of recent investigations [3, 4, 5, 6, 7, 8]. In these works an exact asym ptotic form of a properly norm alized full lim iting distribution has been established (the so-called Tracy\{W idom distribution) of the rst row of the Y oung tableau over the $P$ lancherelm easure by $m$ apping to the distribution of the largest eigenvalues of som e classes of random $m$ atrioes [B]. In particular it has been show $n$ that the properly norm alized variance of LIS has for $\mathrm{N} \quad 1$ the asym ptotic scaling form $\operatorname{Var} k(\mathbb{N})] \quad k^{2}(\mathbb{N}) \quad h k(N)_{1}^{2}=C N N^{1=3}$, where $c=\quad[\quad h$ if $=0: 8132:::$ and has the Tracy $\{W$ idom distribution for the $G$ aussian U nitary Ensem ble.

[^0]W e would like also to point out a deep connection betw een the distributions of edge states of random ma trices and of statistical characteristics of som e random grow th $m$ odels. In one of the $m$ ost stim ulating work [5], it has been shown that a $(1+1)$ \{dim ensional model of directed polym ers in random environm ent, which is in the KPZ universality class, has the Tracy $\{\mathrm{W}$ idom distribution for the scaled height (energy). A round the sam e tim e the authors of [8] have found an exact $m$ apping betw een a speci c polynuclear grow th (PNG) m odel and the LIS problem. The same Tracy $\{W$ idom distribution was reported in another class of ( $1+1$ ) \{dim ensional grow th m odels called "oriented digitalboiling" m odel [g].

In our work we report some new observation conœeming the statistics of longest increasing subsequences. Nam ely, we show that the expectation of LIS, its variance, and apparently the full distribution function appears in a statistical analysis of som e properly scaled sim ple nonlinear stochastic partial di erential equation (SPDE) in a lim it of very low noise intensity.

The paper is organized as follows. In Section we introduce all the necessary de nitions. In particular, we describe LIS as the hight pro le of some uniform discrete grow th problem w ith nonlocal long \{ranged interactions. In Section III we consider the discrete short $\{$ ranged asym $m$ etric uniform grow th process and derive the corresponding continuous space\{tim e SPDE for the height pro le. In Section IV we show that the properly scaled lim it of an in nitely sm all noise in the derived SP D E adequately describes the grow th w ith long \{ranged interactions, i.e. the statistics of IS . T he discussion and conclusions are collected in Section $V$.

> II. LISASA HEIGHTPROFIE IN A UNIFORMASYMMETRICNON-LOCAL GROWTHPROCESS

The standard construction of a Young tableau for the set of real num bers is realized via the well known

R obinson $\{$ Schensted $\{K$ nuth algorithm (R SK) which can be found in $m$ any textbook on representation theory, and for exam ple, in [10]. The RSK algorithm ensures that the rst row of the corresponding Young tableau would be the Longest Increasing Subsequence (L IS) for a given set of num bers. To be speci c, consider the exam ple of $N=8$ numbers: $4 ; 4 ; 3 ; 6 ; 7 ; 3 ; 4 ; 2$ taken at random $w$ th uniform probability distribution from the support f1;:::;9g. Following the RSK algorithm of the Young tableau construction, we get the Young tableau shown in F ig [1a. Let us describe now m ore geom etrically obvious construction of LIS which refers to the discrete uniform asym $m$ etric ballistic deposition of elem entary cells w th long \{ranged interactions. This construction has appeared for the rst time in [11].

C onsider the ( $1+1$ )D m odel of ballistic deposition in which the colum nar grow th occurs sequentially on a linear substrate consisting of $L$ colum nsw ith free boundary conditions. The tim et is discrete and increases by 1 w ith every deposition event. W e start w the the at initialcondition, i.e., an em pty substrate at $t=0$. At any stage of the grow th, a colum $n$ (say the colum $n m$ ) is chosen at random w th probability $p=\frac{1}{\mathrm{~L}}$ and a "cell" is deposited there which increases the height of this colum $n$ by one unit: $h_{m}$ ! $h_{m}+1$. Once this "cell" is deposited, it screens all the sites at the sam e level in all the colum ns to its right from future deposition, i.e. the heights at all the colum $n s$ to the right of the colum $n m$ ust be strictly greater than or equal to $h_{m}+1$ at all subsequent tim es. Form ally such a grow th is im plem ented by the follow ing update rule. If the site $m$ is chosen at time $t$ for deposition, then

The model is anisotropic and long\{ranged and evidently even the average height pro le $\mathrm{hh}_{\mathrm{m}}$ ( t ) i depends nontrivially on both the colum $n$ number $k$ and time $t$. Let us dem onstrate now the a bijection between the longest nondecreasing subsequence in the sequence of N random numbers uniform ly taken from the support $\mathrm{f1;2;3;:::Lg}$ and the height in the uniform ly grow ing heap with anisotropic in nite\{ranged interactions in a bounding box containing $L$ colum ns.

This bijection is de ned by assigning the rst line in the Y oung tableau to the "m ost top" (or "visible" from the left \{hand side) blocks| see the Fig 11 b . For the conguration shown in $F$ ig. 1 we have the sequence of $N=8$ num bers: $4 ; 4 ; 3 ; 6 ; 7 ; 3 ; 4 ; 2$ taken at random from the set f1;:::;9g (there are $L=9$ colum ns in the box). The "visible" blocks de ne the longest nondecreasing subsequence (LNS): 2;3;4;7. To be exact, if there are few LN Ss, our construction extracts one of them \{ exactly as in the RSK scheme.

As one can see in Fig团, the rst line in the Young tableau (1) exactly $m$ atches the " $m$ ost top" subsequence de ned in ourm odeland the distribution of the maxim al

height of a heap coincides with the distribution of the longest nondecreasing subsequenœ.
III. SHORT\{RANGED ASYMMETRIC BALLISTIC GROW TH AND ITSCONTINUOUS LIM IT

C onsider a one\{dim ensionaldiscrete $m$ odel of ballistic deposition $w$ th asym $m$ etric (one\{sided) next\{nearest $\{$ neighboring (NNN) interactions

The bar denotes averaging over the distribution (2b). Equations (2a) \{ (2d) com pletely describe the updating rules for the NNN discrete ballistic deposition $w$ th the asym $m$ etric interactions show $n$ in $F$ ig 2 .

In the last expression one can easily identify the nite\{ di erence derivatives. D enoting the spatialand tem poral increm ents by $x$ and $t$ and taking into account that $\operatorname{sign}[a z]=\operatorname{sign}[z]$ (for a > 0), we arrive at the follow ing expression

where $\varrho_{t} h(x ; t)$ and $\varrho_{x} h(x ; t)$ denote the partial derivatives of $h(x ; t) w$ th respect to $t$ and $x$ correspondingly. Setting in (5) $t=x=1$ we arrive at the nonlinear stochastic partial di erential equation (SPDE) which is a continuous analog of the discrete A sym $m$ etric B allistic D eposition described by (2a). The noise in (5) is still de ed by 2b) \{ (2d).

It is know $n$ [12] that sym $m$ etric B allistic Deposition $m$ odelw ith NNN interactions in the continuous lim it has som e relevance to K P Z equation [13]. Forbetter com parison of the K P Z equation w ith our SPD E one, rew rite (5) as follow s:

with ( $x$; t) given by 2bl \{ (2d). O ne sees that the stochastic equation (6a) does not contain a di usion term and is very di erent from the KPZ one. H ow ever, as w ill be show $n$ below, the expectation hh ( $x ; t$ )i ofE $q$.(6a) converges fort 1 and $x \quad 1$ to the expectation of LIS for a noise $(x ; t) w$ th very sm all intensity $p\left(p<L{ }^{2}\right)$. $T$ he sam $e$ is valid for the variance, $\operatorname{Var}[h(x ; t)]$, which dem onstrates the K P Z scaling behavior. A ll that allow s us to con jecture that the full distribution of $h(x ; t)$ for
sm allp converges to a Tracy \{W idom distribution of IS . Let us note that the structure of E q. (6b) "ideologically" resem bles the structure of the one\{dim ensional B arenblatt $m$ odel for the eld $u(x ; t)$ w th di erent di usion constants for $\varrho_{t} u(x ; t)>0$ and $\varrho_{t} u(x ; t)<0$ [14].

## IV. SPDE IN THE INFIN ITELY RARE NOISE REGIMEAND LIS

In this Section we show that the lim it of a telegraph \{ like noise $w$ ith sm all intensity in the stochastic partial di erentialequation 6al) forthe "height" function $h(x ; t)$ has LIS statistics. To do that, it is convenient to describe LIS in tem sof ( $1+1$ )D B allistic $D$ eposition (BD ) set by Eq.(1).

Let us begin w th the lim iting case of absence of any noise in (6a). The noiseless equation (6a) is invariant under the scaling transform ation $h(x ; t)!h(a x ; a t)$ for any $a$. Rewriting (6a) in a nite\{di erence form on the lattice, we have:

W e can set $\mathrm{t}=\mathrm{x}=1$ and $\mathrm{x}=\mathrm{j}$ on the interval 0 j L w ithout any loss of generality. The noiseless system de ned by Eq. 7b has a characteristic time scale $L$ of reaching the equilibrium . H ence, after $t$ tim e steps, where $t>$, the system described by Eq. (7) reaches its stationary state generating a nondecreasing staircase\{like pro le from any initial state. This can be seen recursively:

Since (8) is valid for any 0 $j$, after $t \quad L$ time steps, if in the initial state $h(j=L ; t=0)<h(j=$ $1 ; t=0$ ) then the heights at $x=L$ and $x=1$ equalize: $h(j=L ; t)=h(j=1 ; t)$. This signals the appearance of e ective long\{ranged spatial correlations in the system on characteristic tim e scales of $L$.

To show the equivalence of SPDE and LIS in a noisy regim e w ith sm all intensity, it is convenient to introduce the enveloping functions $r_{m}(t)$ and $r(x ; t)$ forlong $\{$ ranged (LR) BD and SPDE correspondingly:

If the intensity, $p$, of the noise $(x ; t)$ is sm all, after each noise event the function $h(x ; t)$ has tim $e$ to reach its relaxed form $r(x ; t)$ before the subsequent noise contribution is added. The corresponding intensity, $p$, can be
easily estim ated. $N$ am ely, the $m$ ean tim e interval, , betw een positive noise events ( $(x ; t)=1)$ for a system of size $L$ and noise intensity $p$ is $\frac{1}{\mathrm{~L} p}$. In $m$ ore details this question is discussed in the A ppendix. Since the fiunction $h(x ; t)$ reaches the relaxed state $r(x ; t)$ at $>L$, we can estim ate p as $\mathrm{p}<\mathrm{L}^{2}$. N ow Eqs.(1) and (6a) can be rew ritten in the uni ed form :

In this form the equivalence between long\{ranged BD and SPD E in a low \{intensity noise regim e is clearly seen.

Thus, relying on the equivalence betw een statistics of LIS and low \{ intensity solutions ofSP D E (6a), and know ing explicitly all the $m$ om ents of the distribution of LIS (see, for exam ple, [5]), we get the follow ing asym ptotic expressions for the expectation, hh $(x ; t) i$, and for the variance, $\operatorname{Var} \llbracket(x ; t)] \quad h(x ; t)^{2} \quad h(x ; t) I^{2}:$

where $h(x ; t)$ is the asym ptotic solution of the equation (6a) w ith the noise distribution (2d). In (12) c $=$
[ h i\} $=0: 8132:::$ and has the Tracy $\{\mathrm{W}$ idom distribution for $G$ aussian Unitary Ensemble. N ote that for $p=\frac{1}{L}$ and $x=t=L$ (L 1) we arrive in (11) at the Vershik \{K erov result for the expectation of LIS, $\mathrm{h} ~(\mathrm{~L}) \mathrm{i}=2 \frac{\mathrm{~L}}{\mathrm{~L}}$. To be rigorous, this expression is beyond our approxim ation since we are lim ited by the noise intensity $\mathrm{p}_{\mathrm{cr}}=\frac{1}{\mathrm{~L}^{2}}$. So, it is m ore convenient to w ork w ith the general expressions (11) \{ (12).

W e con $m$ our analytic predictions (11) \{ (12) by num erical com putations, sim ulating directly the ballistic deposition process (1) and the stochastic partial di erential equation (6al) w ith noise intensity $p=\frac{0: 1}{L}$ and initial condition $h(x ; t=0)=0$. Note that the intensity of the noise in our num erical sim ulations is $\frac{L}{10}$ tim es larger than the upper estim ate $\mathrm{p} \quad \frac{1}{\mathrm{~L}^{2}}$, how ever the agreem ent with theoretical results (11) $\{(12)$ is still very good. In particular, we plot in Fig 3 a the average pro les hh ( $x ; t$ )i for long \{ranged BD and SPDE as a function of $x(0 \quad x \quad L)$ for $L=10$ at time points $t=2 \quad 10^{4} ; 6 \quad 10^{4} ; 10^{5}$. In the same gure we plot the analytic expression (11). In Fig 3 Bb we plot the variance $\operatorname{Var}(\mathrm{h}(\mathrm{x} ; \mathrm{n}))=\mathrm{h}(\mathrm{x} ; \mathrm{t})^{2} \quad \mathrm{hh}(\mathrm{x} ; \mathrm{t})_{1}^{2}$ as a function of $x$ for the same time points $t$. It should be noted that due to the num erical procedure of the de nition of the height, the num erical com putation of the variance leads to the follow ing interpolating expression for $\operatorname{Var} h(x ; t)]=a(t)+c(x p t)^{1=3}$. H ow ever for $x \quad 1$ and $t=$ const we arrive asym ptotically at the expression (12). $T$ hat is why we com pare the expression (12) w ith the nu$m$ erical data for large $x$ only where the term $a(t)$ is negligible. M oreover, the agreem ent betw een long \{ranged
$B D$ and SPDE is very good for the expectation and the variance \| see Fig $2 a, b$.

V. CONCLUSION

W e have shown by the sequence of $m$ appings that the expectation and the variance of the random pro le $h(x ; t)$, described by the stochastic nonlinear partial differential equation (6a) in the lim it of a noise w ith very low intensity, coincides w ith the expectation (11) and the variance (12) of the longest nondecreasing subsequence of the sequence of random integers. This statem ent is also con $m$ ed num erically. On the basis of the obtained results we con jecture that not only the rst $m$ om ents, but the full probability distribution function of the random variable $h(x ; t)$ coincides $w$ th the $T$ racy $\{W$ idom distribution appearing in largest eigenvalue statistics of ensembles of random $m$ atrioes.

Let us note that our analysis of Eq. (6a) is a bit indi-
rect. It would be very desirable to get expectation and variance (11) $\{$ (12) of the random variable $h(x ; t)$ directly from the solution of the Fokker\{P lanck equation which corresponds to the Langevin equation (6a) . H ow ever on this way we have $m$ et som e di culties. $N$ am ely, rew rite Eq.(6a) as follow s

where we have taken into account that $\frac{h}{h}\left[{ }_{x} h(x ; t)\right]=0$.
The Fokker\{P lanck equation (15) corresponds to the stochastic process (6b) which can be visualized altematively as a $(2+1)$ ddim ensional correlated grow th. U sing the nite\{di erence form (7) of (6.b) on the lattice, where we set $x=t=1$ and $x=j$, we arrive at the follow ing stochastic recursion relation

w ith the intial and boundary conditions $\mathrm{h}(\mathrm{x} ; \mathrm{t}=0)=$ $h(x=0 ; t)=0$. C reate now the initial con guration distributing the random variable $(x ; t)$ in the plane $x$ 1;t 1 . Since $(x ; t)$ takes the values 0 or 1 , we can show
$=1$ by black unit segm ents as it is show $n$ in $F$ ig 4 . The initial con guration at $t=1$ is depicted in $F$ ig. 4 a . N ow applying the equation (16) we can constrict recursively the con guration of the eld $h(x ; t)$ at subsequent time $m$ om ents. Few con gurations of the eld $h(x ; t)$ for given initialdistribution of $(x ; t)$ is show $n$ in $F$ ig $4 b-d$ for tim $e$ $m$ om ents $t=2 ; 3 ; 4$ and $x=1 ;:: 5$.

The $(2+1)$ dim ensional stochastic grow th shown in F ig. 4 bijectively corresponds to the short \{ ranged ballistic grow th considered in Section III and, hence, in the lim it of sm all intensity p should correspond to the statistics of LIS. It would be very desirable to sim ulate num erically directly the grow th m odel show $n$ in F ig 4 to check the validity of the con jectured bijection.

In the lim it ofsm allp (p 1) the actualm ean pro le hh $(x ; t)$ i tends to the curve $y(x ; t)=$ tp $+2 \overline{x t p}$. H ow ever for larger values ofp ( $p$ 1) the resulting pro le does not have enough tim e to relax and hence is displaced below the curve $y(x ; t)$. The question which we address here concems the estim ation of the tim e interval, , betw een the subsequent deposition events su cient to approach the stable solution $y(x ; t)$.
$W$ e can estim ate the equilibration time, from the follow ing argum ents. T he slope of the $m$ ean pro le in the stationary state is
