B ipolaron form ation in 1D-3D quantum dots: A lattice quantum M onte C arlo approach

A bstract. Polaron and bipolaron form ation in the Holstein-Hubbard model with harmonic con nement potential, relevant to quantum dot structures, is investigated in one to three dimensions by means of unbiased quantum M onte C arlo simulations. The discrete nature of the lattice and quantum phonon e ects are fully taken into account. The dependence on phonon frequency, C oulom b repulsion, con nem ent strength (dot size) and electron-phonon interaction strength is studied over a wide range of parameter values. C on nem ent is found to reduce the size of (bi-)polarons at a given coupling strength, to reduce the critical coupling for small-(bi-)polaron form ation, to increase the polaron binding permits to consider models with dispersive phonons, anharm onic con nem ent, or long-range interactions.

1. Introduction

Continuous advances in fabrication methods in semi-conductor physics over recent decades have enabled researchers to create nanoscale systems in which carrier motion is conned along one orm ore spatial dimensions. Among these structures are quantum dots [1,2], corresponding to quasi-zero-dimensional systems with some atom-like properties [3], which are of substantial technical interest due to their potential use as lasers [4], in quantum computing [5], as storage devices [6], or as single-photon sources [7,8]. Improvements in experimental techniques now also permit studies of the properties of individual dots rather than ensembles [9], as well as of molecular quantum dots [10].

Apart from strong correlations between electrons, the interaction of charge carriers with the lattice degrees of freedom is of great relevance, especially concerning its role in dephasing and relaxation processes [11{13] as well as transport [14]. Evidence for the existence of polarons (carriers bound to a self-induced lattice distortion) has been given [15], and non-trivial multiphonon e ects and polaron form ation have been proposed to explain the lack of experimental evidence for the phonon bottleneck in quantum dots [11,16]. Form ation of bipolarons (bound electron pairs sharing a phonon cloud) has been proposed as an explanation for pair tunneling from G aAs quantum dots [17]. Besides, (sm all) bipolaron states signi cantly in uence the transport through single molecules [18,19].

The problem of polaron form ation in a quantum dot has received a lot of attention in the past (see $[20{24}]$ and references therein). From this work, the general conclusion is that con nem ent enhances the tendency of an electron to undergo a crossover to a (sm all) polaron so that heavy polaronic quasiparticles may be realised experimentally even in the weak or intermediate electron-phonon coupling regime. Less work has been devoted to understand bipolaron form ation in quantum dots $[17,23{26}]$, with contradictory results on the elect of con nem ent [23,26].

A llexisting work is based on the continuum Frohlich model [27], employing mainly variational approaches of dierent reliability | the above-mentioned conicting results seem to originate from the inadequacy of some of the approaches used. How ever, from a theoretical point of view, the most interesting case is that in which the extension of the lattice displacement attached to the charge carriers is comparable to the con nement length. The Holstein molecular-crystal model has been originally developed [28] to answer the question as to whether a local lattice instability occurs upon increasing the electron-phonon coupling. This problem cannot be addressed in the framework of continuum models, since the local lattice dynamics on the scale of the unit cell has to be taken into account [29].

The need for lattice m odels also stems from the fact that it is now adays possible to fabricate self-assem bled quantum dots with lateral dimensions of less than 4 nm [9], which contain only a sm all number of unit cells in each direction. O by by, in such systems, the discrete nature of the lattice will play an important role, m otivating us to revisit the problem of (bi-)polaron form ation.

The Holstein-Hubbard model considered here is not completely realistic, as it only includes local electron-phonon and electron-electron interactions as well as a coupling to dispersionless optical phonons. However, we are interested in fundam ental e ects arising from the combination of electron-phonon interaction and con nem ent in discrete system s. Besides, many aspects of quantum dots may be understood using e ective models [1].

From num erous studies of H olstein m odels with one (two) electrons on a discrete lattice [30,31], it is well known that the non-linear process of (bi-)polaron form ation represents a complex m any-body problem that m ay not be satisfactorily described by m eans of variational or perturbative approaches. The necessity for a universal allcoupling approach to describe interm ediate-coupling m aterials such as C dTe has been pointed out long ago [21], m otivating the application of unbiased num ericalm ethods.

In this work, we extend the world-line quantum M onte Carlo (QMC) m ethod of [32{35] to include a harm onic con ning potential. The m ethod yields practically exact and unbiased results in any dimension, in principle with no restrictions of system size or parameters. As a consequence, we will be able to study (bi-)polaron form ation over the whole range from weak to strong con nem ent. The m ethod is capable of treating system swith long-range interactions or dispersive phonons, which opens up interesting perspectives for future work. An important nding as compared to previous work (including [36]) concerns the problem of very long autocorrelations times in certain parameter regimes. Finally, in contrast to earlier G reen-function QMC calculations for a continuum m odel [17], the present approach does not rely on a trial wavefunction.

The paper is organised as follows. In section 2, we present the model and brie y discuss the underlying approximations. The QMC method is described in section 3, and section 4 contains a discussion of our results. We end with a summary and an outlook to future work in section 5.

2.M odel

We consider a Holstein-Hubbard model, supplemented by a harmonic con ning potential. U sing dimensionless phonon variables, the Hamiltonian reads

Here c_i^{v} creates an electron of spin on lattice site i, and H _{kin} describes the hopping of electrons between nearest-neighbouring lattice sites hi; ji with hopping integral t. The second term, H _{ee}, accounts for on-site C oulomb repulsion between electrons, where $\mathbf{b}_i = c_i^{v} c_i$. The harm onic con nem ent potential, its strength being m easured by K p is given by H _{con}, r_i denotes the position vector of an electron at site i, and $\mathbf{b}_i = \mathbf{b}_i \cdot \mathbf{H}_{ph}$ constitutes the kinetic (H ^p_{ph}) and potential energy (H ^x_{ph}) of the lattice degrees of freedom, corresponding to independent harm onic oscillators with energy !₀. Finally, H _{ep} m ediates the coupling strength . We use units such that $\sim = k_B = e = 1$, consider D-dim ensional hypercubic lattices of linear size N and volum e N ^D, and assume periodic boundary conditions in real space.

In terms of the coupling parameter , the atom ic-lim it (t = 0) polaron binding energy E_p is given by $E_p = {}^2=(2!_0)$. We denote the usual dimensionless coupling constant = $2E_p = W$, with the free bandwidth W = 4tD. Furthermore, we introduce the adiabaticity ratio = $!_0 = t$, which permits to distinguish between the adiabatic (< 1) and the non-adiabatic (> 1) regimes.

This paper is exclusively concerned with the cases of either one electron, or two electrons of opposite spin forming a spin singlet. O by ously, for N_e = 1, H_{ee} = 0 and spin indices may be dropped. In experiments, the maximum number of electrons in a quantum dot is strongly in uenced by the dot size (set here by K), so that the low-density regime considered here may be relevant in particular for small dots, which are of interest due to their potential use as quantum bits [6]. O ne and two-electron states also play an important role in molecular transistors, corresponding (in the simplest case) to a quantum dot with a single electronic level coupled to a vibrational mode [18,19].

As we are interested in fundamental e ects due to con nement, the Holstein-Hubbard-type model seems a good starting point, especially as a lot of know ledge is available for K = 0 [35,37{40]. A lthough quantitative results for realistic quantum dot system s are beyond the scope of this work, let us brie y discuss the sim pli cations inherent to the H am iltonian (1).

U sing a one-band m odel we ignore the existence of a band gap in sem i-conducting host m aterials. Hence, our considerations are restricted to one or two carriers in the same (either conduction or valence) band. A symmetric, parabolic con ning potential which can be realised experimentally [1] is assumed for simplicity, although m ore general situations m ay be studied.

We restrict ourselves to a simple e ective electron-phonon coupling to a dispersionless (optical) phonon branch. For such local phonon modes, and in the absence of sharp interfaces, the bulk-phonon approximation is expected to be a good starting point. The coupling to optical phonons has been shown to dom in the bipolaron form ation [17].

The H am iltonian (1) only contains on-site interactions, which are not completely justi ed in the case of sem i-conducting m aterials. Long-range interactions will be the subject of future investigations.

3.M ethod

The QMC method used here is a straight-forward extension of [32, 33, 35]. The appealing features of this approach are the analytical integration over the phonon degrees of freedom | enabling us to study the adiabatic regim e| and the fact that the numericale ort is essentially independent of system size. Besides, the form alism treats the cases of one and two electrons on the sam e footing, and is general enough so as to perm it future studies of models with, e.g., dispersive phonons or long-range interactions.

3.1. Partition function

The derivation of the relevant ferm ionic contribution Z^{f} (the bosonic part can be calculated exactly) to the partition function $Z = Tre^{-H}$ is alm ost identical to [33,35]. Dividing the imaginary-time axis [0;] (= (k_BT)⁻¹ is the inverse tem perature) into intervals of length = =L 1 we may write

The result for the partition function reads [33]

Here $N_e = 1$ (2) for the polaron (bipolaron) problem, and the components of the position vector of electron on time slice , $r^{()}$, are denoted as $r^{()}_{;}$ (= 1;:::;D). The ferm ion world-lines are subject to periodic boundary conditions both in real space and in aginary time, and the sum in equation (3) is over all allowed con gurations.

The retarded electron (self-)interaction due to electron-phonon coupling is described by the memory function

3.3. Simulation details

The system described by the partition function (3) is characterised by an additional dimension (imaginary time), as well as by a complicated retarded interaction. As statistical provide the simulated by means of Markov Chain Monte Carlo in combination with the Metropolis Hastings algorithm [41]. To improve convergence for critical parameters, we use both local updates (change of a random component of the position vector on a random time slice of one particle by one lattice site) and global updates (translation of an entire world line by one lattice site) [35].

An important point overlooked in previous work [32{34,36] is the problem of signi cant statistical correlations between successive con gurations due to the local updating. W hereas previous authors perform ed m easurem ents every L steps, we nd that this is by far not su cient to ensure statistically independent m easurem ents, especially at interm ediate electron-phonon coupling. The integrated autocorrelation time in such cases may well exceed tens of thousand of MC steps, so that a careful binning analysis [42] is required for every run to ensure correct results and error bars. Details on this problem will be reported elsewhere. Although autocorrelation times are expected to be generally shorter in continuous-time simulations (see, e.g., [43]), the problem must not be neglected. A QMC algorithm entirely free of autocorrelations has been presented in [40,44], but this approach su ers from restrictions in system size for D > 1 [45]. Another problem of world-line algorithm s is that the acceptance rate for local updates approaches zero in the strong-coupling regime. For K = t & 1and & 1, this becomes also true for global updates. Finally, we also detected convergence problem s in the vicinity of the sm all-(bi-)polaron crossover due to critical slowing down.

The only system atic error in the present calculations comes from the Suzuki-Trotter approximation (equation (2)). It may be eliminated by working in continuous imaginary time [43], or by performing simulations at dierent and exploiting the

²-dependence of the results to scale to = 0. To save som e computer time, here we have simply chosen a single (sm all) value of = 0.05, which ensures that the Suzuki-Trotter error is satisfactorily sm all.

4. Results

We discuss our numerical results in relation to the available knowledge about the Holstein-Hubbard model (equation (1) with K = 0). Similar to the non-conned case, the adiabaticity ratio turns out to have an important elect on the physics, and a comparison of the cases 1 and 1 will be given for the 1D polaron. In higher dimensions, we shall focus on the adiabatic regime 1, as the low-lying optical phonon energies in quantum dot materials are in the range of 10-100 m eV, i.e., substantially smaller than the electron bandwidth.

The 2D (3D) geom etry considered here corresponding to a circular (spherical) quantum dot \mid m ay actually be realised experimentally, whereas the 1D case is mainly of theoretical interest. However, we shall see that the physics is qualitatively similar in D = 1 and D > 1.

All simulations have been carried out using a linear lattice size of N = 31, enough to obtain very well converged results even for K = 0 [33,36]. Since for K > 0 local physics becomes more important, nite-size e ects are negligible. The center of the parabolic potential is located at site i = 0 of each dimension, and the site




Figure 1. (a) K inetic energy E $_{\rm kin}$ of one electron in a 1D system in the adiabatic regime (= 0:1) as a function of electron-phonon coupling strength for di erent values of the con nem ent strength K. Here and in subsequent gures N = 31, t = 15 and = 0:05. Lines are guides to the eye only. (b) E lectron-lattice correlation function C $_{\rm ep}$ (r) as a function of distance r for the sam e parameters as in (a) and = 1. The inset shows C $_{\rm ep}$ (0) as a function of .

indices range over [15;15]. To study ground-state properties, we set the inverse temperature t = 15. The number of Trotter time slices has been xed to L = 300 so that = 0.05. Errorbars are typically sm aller than the linewidth, and are shown only if larger than the symbols used.

A drawback of the present approach (cf [43,46]) is that we can not calculate the quasiparticle e ective mass. Instead, we shall consider the electronic kinetic energy, which includes contributions from incoherent processes. A dditionally, the correlation functions de ned in section 3 perm it us to monitor the size of the (bi-)polaron, and to determ ine the critical coupling for the crossover to a sm all-(bi-)polaron state.

The con nem ent length | offen a directly tunable parameter in previous work | is set by the oscillator strength (K) of the harm onic potential. For two electrons, it may be estimated from the electron-electron correlation function $C_{ee}(r)$ at = 0.

4.1. Polaron

Existing work suggests that the ground state of the Holstein model with one electron (K = 0, U irrelevant) at weak electron-phonon coupling is a large polaron (extending overm ore than one lattice site) in 1D, and a quasi-free electron for D > 1 [47].

W ith increasing coupling , the potential energy due to lattice deformation increases relative to the kinetic energy of the electron. In the adiabatic regime < 1, a small-polaron state (with the electron and the lattice distortion being localised essentially to the same site) is formed if $E_p > W = 2$ (> 1). In contrast, for > 1, small-polaron formation requires a sizeable lattice distortion, leading to the condition $g^2 = E_p = !_0 > 1$. Note that these \critical couplings" are conceptually di erent from those for the occurrence of the Peierls quantum phase transition at half lling [48] since there is no phase transition in the (bi-)polaron problem for > 0 [49].

The sm all-polaron state is characterised by a substantially enhanced e ectivem ass and corresponding sm all quasiparticle weight. Generally, the size of the polaron is sm aller in the non-adiabatic strong-coupling regimed due to the faster lattice response.




Figure 2. As in gure 1 but for the anti-adiabatic regime (= 4).

4.1.1. One dimension Figure 1 (a) shows results for a single electron in a 1D system for = 0:1. For K = 0. starting with the non-interacting value 2t, the absolute value of the kinetic energy is reduced with increasing . The crossover near = 1 is continuous (the same also applies in higher dimensions [49]).

Turning on the con nement, we see that results are very similar for small K = t = 0.1 (weak con nement). Remarkably, in the case of strong con nement| the size of the quantum dot is very small for K = t = 2 | the kinetic energy displays the convex behaviour characteristic of the strong-coupling regime a lready near = 0. This may be understood as a result of squeezing of the polaron state: For weak coupling, the free (K = 0) polaron size is larger than the dot size set by K, so that the kinetic energy is determined mainly by the con nement. In contrast, for strong coupling, the polaron size is smaller than the dot size and the kinetic energy is almost identical to the case K = t = 0. Therefore, all curves tend to the same value 2tI(1)=I(0) as ! 1.

The e ect of the con nement on the polaron size at the critical coupling = 1 (for K = 0) is illustrated by the results for the electron-lattice correlation function $C_{ep}(r)$ in gure 1(b). For small K, the lattice distortion surrounding the electron extends over about two lattice sites (large polaron). The e ect of con nement is to reduce the polaron size, as is well visible especially for K =t = 2.

In the inset of gure 1(b) we present data for $C_{ep}(0)$ as a function of . As pointed out in [50], the small-polaron crossover occurs at the point where the slope of $C_{ep}(0)$ has its maximum, which in the present case con rm s the critical coupling = 1 obtained from energetic considerations (K = 0). Furthermore, numerical di erentiation of the data shown clearly indicates that the critical coupling is reduced by about 50 % in the strong con nem ent regime K =t 1 owing to the smaller non-interacting (= 0) kinetic energy.

Figure 2 shows results for the anti-adiabatic regime (= 4). For K = 0, the kinetic energy in (a) shows a very smooth dependence on the electron-phonon coupling strength. The critical value for the small-polaron crossover is given by $g^2 = 1$ (= 2), but no pronounced changes in E_{kin} are visible. For K > 0, the form of the kinetic energy curve does not change noticeably, because the free polaron size is smaller than the con nem ent length even for $g^2 < 1$.

The electron-lattice correlation function in gure 2(b) con rm s the sm aller size of the polaron at the K = 0 critical coupling (cf gure 1(b)). Consequently, the




Figure 3.As in gure 1 but for a 2D system.

dependence on K is much weaker than in the adiabatic regime. As for = 0.1, the critical coupling for small-polaron form ation is substantially reduced for large K =t, as can be inferred from the slope of $C_{ep}(0)$.


4.1.2. Higher dimensions For the non-con ned case, it is known that the smallpolaron crossover becomes more abrupt as a function of in higher dimensions. This is well visible from the 2D results for E_{kin} shown in gure 3(a), as well as from the inset of gure 3(b).

The e ect of con nem ent is again to reduce the kinetic energy. For K =t = 2, the convex strong-coupling behaviour is seen similar to D = 1. An important di erence to the 1D case is that the curves for di erent K become practically indistinguishable for > 2, whereas in 1D (gure 1(a)) such a collapse occurs for & 3. The origin of this e ect is revealed in gure 3(b). Obviously, the polaron is smaller in 2D than in 1D for the same , reducing the e ect of K. The inset again reveals a reduction of the critical coupling with increasing con nem ent. Similar behaviour is also found in three dimensions (not shown), with an even stronger dependence of E kin and C ep (r) on .

Let us discuss the relation of our results to previous work. The common conclusion is that the connement demobilises the carrier, which manifests itself either in an increase of elective mass, or a decrease of kinetic energy and the polaron size [20{24]. Also in accordance with existing work, we not that the polaronic correction to the total energy is larger for larger K. For example, $E^{f} = [E^{f}_{=0} \quad E^{f}_{=1}] = E^{f}_{=0} \quad 0.54$ for K =t = 0.1, whereas $E^{f} = 1.08$ for K =t = 2.

The reduction of the critical coupling for the existence of a sm all polaron due to con nem ent complies with the growth of the strong-coupling region at the expense of the weak-coupling region in the phase diagram pointed out in [23].

Furtherm ore, we observe a similar dependence of the in uence of connement on dimensionality as for the continuum model [22] (in this work the elective mass was considered). Comparing the values of the kinetic energy at = 1, we not for the ratio E_{kin} (K = 0) = 0.91 (K = t = 0.1), 0.66 (K = t = 1), and 0.53 (K = t = 2) in 1D, and 0.98, 0.82, and 0.72 in 2D. Hence, connement elects are significantly stronger in 1D than in 2D, and this trend extends to D = 3.

4.2. Bipolaron


We now come to the case of two electrons of opposite spin, which can form a bound bipolaron state given su ciently strong electron-phonon interaction. Owing to the Coulom b repulsion, the physics becomes much richer, and we again begin our discussion with the one-dimensional case.

C om pared to the one-electron problem, signi cantly less work has been done on the bipolaron problem in the fram ework of the Holstein-Hubbard model. N evertheless, from existing studies (see [30,39,40,51] and references therein), the basic physics is understood. A sum mary of (approximate) conditions for the existence of the di erent ground states is given in table 1.

4.2.1. One dimension Figure 4 shows results for the simplest case U = 0, in the adiabatic regime (= 0:1). For K = 0, the two electrons form a bound state if $4E_p > 4t$ (> 0:5), where $4E_p$ is the bipolaron binding energy in the atom ic limit and 4t is the free kinetic energy of the two electrons. The corresponding crossover from a large bipolaron (no unbound polarons exist for U = 0) to a small (on-site) bipolaron leads to a noticeable decrease of the (absolute) kinetic energy in gure 4 (a). As for the polaron, the critical value for the crossover m ay be determined from the slope of C_{ep} (0) or C_{ep} (0) (see gure 5).

A part from enforcing polaron e ects, con nem entenhances the probability for the two electrons to occupy the same region of the system (the vicinity of the centre of the harm onic potential). This in turn leads to a stronger pairing tendency. Any K = t > 0 decreases the kinetic energy in the weak-and interm ediate coupling regime. For strong con nem ent, the kinetic energy exhibits the typical strong-coupling dependence on . The reduction of the bipolaron size (the average distance between the two carriers) due to con nem ent is shown in gure 4 (b) for the free critical coupling = 0.5. Finally, gure 5 reveals that the critical coupling for sm all-bipolaron form ation is substantially sm aller in a strongly con ned system.

It is more realistic to consider the case of nite C oulomb repulsion U=t=4. For K = 0, strong-coupling theory predicts a ground state with two unbound (large) polarons for $2E_p$. U. In the vicinity of $2E_p = U$, the so-called inter-site bipolaron exists, with the electrons being most likely to occupy neighbouring lattice sites, and with only slightly enhanced e ective mass as compared to two unbound polarons [37,38,40]. The origin of this state are non-local exchange interaction processes [38] which allow the particles to gain potential energy from the coupling to phonons, and at the same time avoid the penalty due to Hubbard repulsion.

Remarkably, gure 6(a) reveals a critical coupling for the small-bipolaron crossover of $2E_p$ U (1, see also inset of gure 6(b)), which is in a surprisingly good agreem ent with the anti-adiabatic strong-coupling condition despite = 0:1.0 ur ndings extend previous calculations limited either to = 1 [38] or sm all system s [40], and a phase diagram for the important adiabatic regime will be presented elsew here.

As for U = 0, con nem ent leads to a reduction of the kinetic energy and the average distance between the two electrons (gure 6(b)). However, owing to the on-site repulsion, the results for E_{kin} exhibit weak and strong-coupling behaviour even for K = t = 2.

An interesting point concerns the e ect of con nement on the inter-site state. The inset in gure 6(b) shows the electron-electron correlation functions $C_{ee}(0)$ and $C_{ee}(1)$. For K = 0, in the vicinity of = 1, $C_{ee}(1) > C_{ee}(0)$ as characteristic for the inter-site bipolaron. In contrast, for strong con nem ent K = t = 2, the region of existence of the latter is limited to small . Clearly, for su ciently strong con nem ent, the inter-site state will disappear.

In previous strong-coupling calculations in the fram ework of the continuum m odel




Figure 6. As in gure 4 but for U = t = 4. The inset in (b) shows the electronelectron correlation functions C_{ee} (0); C_{ee} (1).

 $[24\{26]$, it has been found that the bound bipolaron state becomes unstable at very strong connement, which was attributed to the increase of the Coulomb interaction energy for two spatially close particles. However, this e ect has been argued [23,26] to be due to the approximations made, and path-integral calculations [23] as well as analytical and QMC calculations [17] suggest that a bound state also exists at weak coupling in a conned system.


P relim inary calculations of the bipolaron binding energy $E^{f} N_{e} = 2$) $2E^{f} N_{e} = 1$) for = 0.1 and U = t = 4 at K = t = 0.1 and K = t = 2.0 in one dimension reveal that a weakly bound bipolaron can indeed become unbound due to con nement. This e ect of on-site C oulomb interaction is expected to be most pronounced in one dimension, and this issue will be further investigated in future work.

It is worth m entioning the relation of our calculations to recent work on m olecular quantum dots [18,19] based on m odels with a single m olecular level and a vibrational m ode, weakly coupled to m etallic leads. In such systems, the bipolaron binding energy can compensate for the Hubbard repulsion U, giving rise to a net attraction and thereby favouring pair tunneling of electrons. Due to the absence of a sizable hopping am plitude, the ground-state properties of such a single-site m olecule are determ ined m ainly by the atom ic-lim it physics of the present m odel. In particular, the inter-site bipolaron state will be strongly suppressed, and the strong-coupling criteria of table 1 are expected to hold. The situation m ay be expected to be di erent for nite-size m olecules.

4.2.2. Higher dimensions Numerical results for the uncon ned Holstein-Hubbard model in D > 1 have been reported before in 2D for = 1 [39], and in 3D for classical phonons [35], but no reliable results are available for the important adiabatic regime

1. We restrict the discussion to the more general case U > 0.

As in the polaron problem, the crossover to a small bipolaron becomes more pronounced in higher dimensions (note the dimensional condinate scales in gures 6 (a) and 7 (a) and (b)). The critical coupling for K = 0 from the strong-coupling approximation is again set by U $2E_p$, corresponding to U=W =. Indeed, for D = 2 (gure 7 (a)), we not the crossover near = 0.5 in agreement with this condition. However, in three dimensions, the crossover occurs slightly above = 0.5, whereas the strong-coupling result yields = 0.33. This deviation may be explained by the larger number of



nearest-neighbour sites in 3D, which may enhance the stability of extended (intersite) bipolaron states.

C on nem ent again leads to a reduction of the critical coupling, as well as to an enhancem ent of bipolaron e ects. As for the a single electron, we can calculate the change of the kinetic energy with con nem ent (relative to K = 0) at = 1. This yields 0.89 in two dimensions, and 0.95 in three dimensions, so that we can conclude that con nem ent e ects are again more noticeable in lower dimensions.

5. Sum m ary and outlook

Unbiased quantum M onte Carlo studies of the Holstein-Hubbard model with additional harm onic con nement on a discrete lattice have been carried out in one to three dimensions, considering the cases of one and two electrons. Technical di culties encountered in simulations using the present world-line method, some of which were overbooked in previous work, have been revealed.

The e ect of con nem ent on the form ation of polarons and bipolarons has been investigated. Despite considerable simplications inherent to the model, we believe that our exact num erical results are relevant for quantum dot systems.

In addition to providing unbiased results for all physically relevant parameter regimes, we have for the st time reported on results for a (multi-site) cluster model of a quantum dot. The latter is particularly important for the very sm all dots which can be fabricated today, as well as for a description of the sm all-(bi-)polaron crossover associated to a local lattice instability. Quantum phonon e ects and electron-electron interaction were fully taken into account.

For one electron, we nd that the basic e ect of con nem ent consists in enhancing polaronic e ects the polaron size and the critical coupling for the existence of a small-polaron both decrease. The in uence of con nem ent is largest in a one-dimensional system in the adiabatic regime, and becomes signi cantly smaller with increasing dimension or phonon frequency. In the strongly con ned regime, the polaron state is squeezed, giving rise to small-polaron physics even for weak or intermediate coupling.

We have presented the staccurate results for the uncon ned Holstein-Hubbard bipolaron in the adiabatic regime in more than one dimension. We nd indications that

con nem ent can counteract bipolaron form ation in the presence of C oulom b repulsion, but this issue needs further investigation also in the fram ework of a m odel with longrange interactions. For nite on-site repulsion, weak-coupling behaviour survives even for strong con nem ent.

Existing work on (bi-)polarons in quantum dots is almost exclusively restricted to equilibrium properties, although most technical applications fall into the nonequilibrium regime. Since the fundamental elects of connement on the ground state are now rather well understood, it is desirable to consider more general situations in the future. Apart from elects due to long-range interactions and anharmonic connement in cluster models, this includes many-polaron elects [52], coupling of electrons or excitons to light [16], as well as transport properties and time-dependent phenomena. Of course, suitable numerical methods will have to be developed to address these problems, and work along these lines is in progress.
