G eneralized F luctuation T heory based on the reparam etrization invariance of the m icrocanonical ensemble

Abstract

The main interest of the present work is the generalization of the Boltzm ann-G ibbs distributions and the uctuation theory based on the consideration of the reparam etrization invariance of the microcanonical ensemble. This approach allows a novel interpretation of som e anom alous phenom ena observed in the non extensive systems like the existence of the negative speci c heats as well as possibilities the enhancing of som e M onte C arb m ethods based on the Statistical M echanics.

I. IN TRODUCTION

Boltzmann epitaph:

W e have been witness in the last years of an important reconsideration of the Foundations of the Therm odynam ics and the Statistical M echanics originated from the interest to use this kind of description in system swhich are outside the context of their traditional applications. A n important area of the now adays developments is found in the Thermo-statistical description of the called non extensive system s.

The non extensive system s are those non necessarily composed by a huge number of constituents, they could be mesoscopic or even small systems, where the characteristic radio of some underlaying interaction is comparable or larger than the characteristic linear dimension of the system, particularity leading to non existence of statistical independence due to the presence of longrange correlations. In the last years a signi cant volum e of evidences of therm odynam ic anom alous behaviors are been found in the study of the non screened plasm as and the turbulent di usion, astrophysical system s, nuclear, m olecular and the atom ic clusters, granular m atter and com plex system s [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11].

It is usual to nd in this context equilibrium them odynam ic states characterized by exhibiting a negative heat capacity, that is, them odynam ic states where an increm ent of the total energy leads to a decreasing of the tem – perature. This behavior is associated to the convexity of the entropy and the corresponding ensem ble inequivalence and can appear as a consequence of the sm all character of the system s (during the rst-order phase transitions in molecular and atom ic or nuclear clusters [12, 13, 14]) or because of the long-range character of the interactions (see in the astrophysical system s [15]).

The existence of such anom alous therm odynam icalbehaviors dem ands new developments within the Equilibrium Statistical Mechanics and the Therm odynamics. An important contribution to the understanding of such phenomena is found in the formulation of the Microcanonical Therm o-statistics by D.H.E.G ross [7], a theory which returns to the original basis of the StatisticalMechanics with the reconsideration of the well-known and allows the study of phase transitions in system s outside the therm odynam ic lim it. Since W is the num ber of m icroscopic states com patible with a given m acroscopic state, the Boltzm ann entropy (1) is a measure of the size of the m icrocanonical ensemble. W ithin C lassical Statistical M echanics W is just the m icrocanonical accessible phase space volume, that is, a geometric quantity. This explains why the entropy (1) does not satisfy the concavity and the extensivity properties, neither dem ands the imposition of the therm odynam ic lim it or a probabilistic interpretation like the Shannon-Boltzm ann G ibbs extensive entropy:

Such geom etric character of the Boltzm ann entropy leads naturally to the developm ent of geom etric form ulations of any statistical form ulation derived from microcanonical basis.

M otived by the successes of the G ross' form ulation [7], we have perform ed in the refs.[17, 18] an analysis about the geometric features of the microcanonical ensemble. Particularly, we have shown in the previous paper [17] that the microcanonical description is characterized by the presence of an internal sym metry whose existence is related to the dynam ical origin of this ensemble, which has been coined by us as the reparam etrization invariance. Such symmetry leads naturally to the developm ent of a non R iem annian geom etric form ulation within the m icrocanonical description, which leads to an unexpected generalization of the G ibbs canonical ensemble and the classical uctuation theory for the open system s, the improvement of M onte Carlo simulations based on the canonical ensemble, as well as a reconsideration of any classi cation scheme of the phase transitions based on the concavity of the m icrocanonical entropy.

I shall continuous in the present paper the study of the geometric aspects related to the existence of the reparametrization invariance. The present work addresses the study of those equilibrium situations characterized by the consideration of several control param eters. The main interest will be focussed in the generalization of the well-known Boltzm ann-G ibbs distributions and the uctuation theory related with the consideration of the reparam etrization invariance ideas. I realize while writing this work that some of the present ideas have been also rediscovered by Toral in ref.[19] by starting from the Inform ation Theory.

II. ISOLATED SYSTEM

Let us consider an isolated dynamical system whose macroscopic description could be carried out by stagting from microcanonical basis. Let us suppose that the eigenvalues of the set <math display="inline">\hat{I}$ belong to certain subset R $_{\rm I}$ of the Euclidean n-dimensional space R $^{\rm n}$.

Let us consider another subset R Rⁿ which is diffeom orphic equivalent to the subset R_I, that is, there exists a di eom orphic bijective map $: R_I ! R$ with a non vanishing Jacobian:

for every point I 2 R_I. It is said that the map ' denes a reparam etrization change of the Euclidean subset R_I. Thenset of functionals derived from the above map , ^= ^1;^2:::^n = Î, determ ines the same m icroscopic Physics of the set Î: every eigenstate j i of Î, Îj i = I_h j i, is also an eigenstate of the set ^, ^j i = Î j i = [I]j i = j i, and the physical quantities ^k are also simultaneously m ensurable, ^k;^m = 0. There is nothing strange that the set ^ determ ines also the same m acroscopic Physics of the set Î. Taking into account the well-known property of the D irac delta function:

The above identity (6) expresses an internal symmetry which will be referred as a reparam etrization invariance of the m icrocanonical ensemble. The reparam etrization invariance of the m icrocanonical distribution function n_m leads to the reparam etrization invariance of the expectation value of any m icroscopic quantity \hat{A} , $A = Sp \ \hat{A}^{\uparrow}m$) A(I) = A(), that is, the expectation values of the m icroscopic observables behaves as scalar functions under any reparam etrization change .

M athem atically speaking, it is said that the Euclidean subsets R_I and R are identical representations of certain abstract space = . The totality of the reparam etrization changes among the admissible representations of the space = constitutes a group, the G roup of D i eom orphism s of the space = . The reparam etrization invariance of the microcanonical ensemble m eans that such description provides the same m acroscopic Physics for all admissible representations of the abstract space = .

The microcanonical partition function denes an invariant measure d = () d (I) d which provides the number of microstates W = d belonging to a small subset of certain coarsed grained partition

of the abstract space = , and allow s us to introduce the Boltzm ann entropy S_B [] = $\ln W$. Hereafter, I will consider that the number of m acrostates W grows exponentially with the increasing of the number n of the degrees of freedom of the interest system, so that the therm odynam ic lim it:

exists and it is independent of the nature of the coarsed grained partition of the space = whenever every subset be small. This hypothesis allows us to take the reduced entropy s as a continuous scalar function dened on the space = . When the interest system is large enough, the number of microstates W can be estimated in the practice by W₁' (I) I₀, where I₀ is a small constant volume. The estimate W₁ di ers from the one obtained in other representation W₂' () $_0$. How - ever these estimations should lead to the same reduced entropy in the therm odynam ic limit n ! 1 :

which imposes the restriction that the Jacobian of the reparametrization can not grow exponentially with n. I shall assume for practical purposes the validity of the approximation S $S_1 = \ln W_1$ ' $S_2 = \ln W_2$ when the interest system is large enough.

III. OPEN SYSTEM

Let us now consider an experimental setup where the interest system is put in contact with certain external apparatus } which controls its macroscopic behavior in a way that the expectation values of the physical quantities \hat{I} are kept xed:

The equilibrium distribution function ! of the interest system under these conditions can be derived from the standard procedure of maxim ization of the entropy:

which leads directly to the following generalized Boltzmann-Gibbs distribution:

The Lagrange multipliers = f $_k$ g are the canonical param eters of the external apparatus $\}$, which will be referred hereafter as a generalized therm ostat or generalized reservoir. I shall show now that the above distribution function provides a suitable generalization of the well-know n B oltzm ann-G ibbs distributions:

which is just a special case of the generalized distribution (12) with \hat{I} \hat{I} . The convention k k ' will be hereafter adopted in order to simplify our notation.

 $\ln Z$ () of the Boltzm ann-G ibbs distribution (13) and the coarsed grained entropy S (I) = \ln [(I) I_0] of the microcanonical ensemble (3). The identity (17) represents that a macrostate of the Boltzm ann-G ibbs ensem – ble (13) with canonical parameter is equivalent in the therm odynamic limit n ! 1 to a macrostate of the microcanonical ensemble (3) whose set I represents the point of globalm inimum of the functional:

where the entropy H essian $_{ij}$ must be a negative de ned m atrix, that is, the entropy must be locally concave in the point I 2 R_I. Such exigency in plies that all those regions of the Euclidean subset R_I where the entropy S is not locally concave will never be equivalent to a m acrostate of the Boltzm ann-G ibbs ensemble (13). This situation is usually referred as an ensemble inequivalence.

Let B_I be the Euclidean n-dimensional subset com – posed by all admissible values of the canonical parameters of the external apparatus leading to a therm odynamic equilibrium of the interest system characterized by the Boltzm ann-G ibbs distribution (13). A coording to the condition (19), such therm odynamic equilibrium is characterized by the identi cation $\sim = \sim$ of the canonical parameters \sim of the external apparatus with the com – ponents \sim of the gradient of the microcanonical entropy, the m ap $_I$:

in the representation R_I of the space = . W hen the entropy is locally concave in certain subset R_I, the map $_{\rm I}$ establishes a bijective correspondence between the subset and certain subset B_I. During the ensemble inequivalence the bijective character of the map

is lost. The set ~2 B_I of canonical parameters of the external apparatus leads to a macrostate with ensemble inequivalence when there exist at least two distinct points I₁ and I₂ 2 R_I, where ~ = $_{\rm I}$ (I₁) = $_{\rm I}$ (I₂). Thus, the ensemble inequivalence can be seen as a therm odynamic equilibrium where exist a competition among all those microcanonical states I_k 2 R_I where $_{\rm I}$ (I_k) = ~.

Let us return to the case of the generalized B oltzm ann-G ibbs ensemble (12). Taking into account the reparametrization invariance of the measure d = (I) dI = () d, the integral (15) can be rephrased as follows Z

which allows a natural extension of the conventional Statistical M echanics and Therm odynamics with a simple reparam etrization change I ! and ! : The Legendre transform ation between the therm odynam ic potentials P () = $\ln Z$ () and S () = $\ln [$ () $_0]$:

where the entropy H essian $_{\rm km}$ in the representation R must be a negative de nite matrix, that is, the entropy S () must be locally concave in the point 2 R . The above results deserve some remarks.

R em ark 1 W hile a reparam etrization change does not alter the m icrocanonical description of an isolated system, for an open system such transformation implies a substitution of the external apparatus $\}$! $\}$ which controls its therm odynam ic equilibrium, and consequently, generalized Boltzm ann-G ibbs ensem bles with different representation R $_1$ and R $_2$ provide in general di erent therm odynam ical descriptions.

R em ark 2 The validity of the Legendre transform ation (22) in plies the local equivalence of the m acrostates of di erent generalized Boltzm ann-G ibbs ensembles in the therm odynam ic lim it n ! 1 whenever they are equivalent to the sam e m acrostate of the m icrocanonicalensem – ble. Such equivalence in plies a relation am ong the canonical parameters of the generalized therm ostat and an ordinary therm ostat: Since S (I) S () when n ! 1, the conditions (19) and (23) lead the following transform m ation rule during a reparametrization change ! I:

Since R_I and R are just two admissible representations of the abstract space =, the above transform ation rules are also applicable to any two admissible representations of = . Equation (24) is just the transform ation rule of the components of a covariant vector within a differential geometry. However, the entropy Hessian does not represent a second rank covariant tensor, since the transform ation rule should be given by:

instead of the rule (25). This result leads to an important third rem ark.

R em ark 3 Since the entropy Hessian is not a second rank covariant tensor, the concavity properties of the entropy may change during the reparam etrization changes. Consequently, the regions of ensemble inequivalence between the Boltzmann-Gibbs ensemble and the microcanonical ensemble in the representation R $_{\rm I}$ does not coincide to the regions of ensemble inequivalence in the representation R $_{\rm I}$.

Let us consider a trivial example taken from our previous work [17]. Let s be a positive realm ap de ned on a sem in nite Euclidean line L, s : L ! R⁺, which is given by the concave function s (x) = $\frac{P}{x}$ in the representation R_x of L (where x > 0). Let ' be a reparametrization change ' : R_x ! R_y given by y = ' (x) = $x^{\frac{1}{4}}$. The map s in the new representation R_y of the sem in nite Euclidean line L is now given by the function s (y) = y^2 (with y > 0), which is clearly a convex function.

The third remark implies a revision of our conceptions about the classi cation of the phase transitions based on the concavity of the entropy and the generalization of som e M onte C arlo m ethods with distribution functions inspired on the Statistical M echanics.

The rst-order phase transitions are closely related with the phenom enon of ensem ble inequivalence. Since the ensem ble inequivalence depends on the nature of the external apparatus controlling the therm odynam ic equilibrium of the interest system, the existence of this anom aly re ects the inability of the external apparatus to control all m icrocanonically adm issible equilibrium states of the interest system, and consequently, this kind of phenom enon can not be relevant within the m icrocanonical description. The interested reader can see a long discussion about this subject in the ref.[17].

The phenom enon of ensemble inequivalence also im plies an important the lost of inform ation about the therm odynam ical properties of a given system during the phase coexistence in regard to the therm odynam ical inform ation which can be derived from the microcanonical description. Such lost of inform ation also leads to the failure of ordinary M onte C arb m ethods based on the B oltzm ann-G ibbs ensemble in the neighborhood of the rst-order phase transitions [20].

The ensemble inequivalence can be successfully avoided by using an appropriate representation R within the generalized Boltzm ann-G ibbs distribution (12). Therefore, the simple consideration of the reparam etrization changes allows a suitable extension of som e M onte C arlo m ethods. This question was discussed in the ref.[18] for the particular case of the G ibbs canonical ensemble. I shall consider below a form al extension of the m ethodology developed in that reference for enhancing the well-known M etropolis im portance sample algorithm [21] by focussing only the most im portant features. The reader could see the ref.[18] for m ore details.

The probability of acceptance of a Metropolis move based on the generalized Boltzm ann-G ibbs distribution (12) can be given by:

Reader can notice that the above de nition is very sim ilar to the transform ation rule (24). The di erence resides now in the fact that the set I does not take the equilibrium value I, but it changes during the M onte Carlo dynam ics. Thus, the present generalized M etropolis algorithm looks-like an ordinary M etropolis algorithm where the canonical parameters \sim = (I;) of the external reservoir exhibits correlated uctuations with the uctuations of the physical quantities I characterizing the interest system around the corresponding equilibrium and I connected by the ensemble equivalence values within the generalized Boltzmann-Gibbs description (12) and the transformation rule (24). As already shown in ref.[18], this feature of the present M etropolis algorithm allows the M onte C arb dynam ics to explore the anom alous regions of the subset R_{T} where the ensemble inequivalence within the Boltzm ann-Gibbs description (13) takes place. The reader can see an example of application of this method in the section V. The above observations lead directly to a fourth remark which clari es us the nature of the generalized therm ostat } .

R em ark 4 W hen the interest system is large enough, the generalized therm ostat or reservoir } leading to the generalized Boltzm ann-G ibbs distribution (12) is alm ost equivalent to an ordinary therm ostat } ~ whose canonical parameters ~ uctuates with the uctuations of the physical quantities I of the interest system according to the rule (29).

The fourth remark is particularly interesting. Conventional Them odynamics usually deals with equilibrium situations where the fundam ental physical quantities I are kept xed when the interest system is isolated (a microcanonical description) or the physical quantities I uctuate and corresponding canonical parameters are kept xed by the therm ostat ("within canonical description"). The generalized Boltzm ann-G ibbs ensemble (12) is just a natural fram ework for consider all those equilibrium situations where both the fundam ental physical quantities I of the interest system and the corresponding e ective canonical parameters ~ of the external therm ostat uctuate as a consequence of their mutual interaction. Thus, the ordinary condition for the therm odynamic equilibrium between the canonical parameters of the interest system ^ and the external apparatus ~ only takes place for their corresponding average values:

The last observation leads directly to the main objective of the present study: the implementation of a generalized uctuation theory based on the reparametrization invariance of the microcanonical ensemble.

IV. GENERALIZED FLUCTUATION THEORY

A. Fundam ental results

Let I = I I and = ~ be dispersions of the fundam ental physical quantities I of the interest system and the e ective canonical param eters ~ of the generalized them ostat respectively. Our aim is to obtain the correlations I^{i} I^{j} , $_{i}$ I^{j} and h $_{i}$ $_{j}$ i within the generalized Boltzm ann-G ibbs description (12) and identify their m utual relationships. It is very important to remark that such correlations depends crucially on the interaction between the interest system and the generalized them ostat, and consequently, the values of these quantities are modiled with the change of the external control apparatus.

Let us began from the correlation $\ \ I^i \ \ I^j$:

The expectation values = ^k and ^k ^m with = within the generalized Boltzmann-Gibbs description (12) can be obtained from the Planck therm odynam ic potential P () in the representation R in complete analogy with the standard Statistical Mechanics:

Since the therm odynam ical variables I and are just an adm issible representation from the reparam etrization invariance view point, the reparam etrization change I ! and ! leads also to the validity of the relations:

A s elsewhere shown [22], the entropy H essian provides in portant inform ation about the uctuations of therm odynam ic quantities during the therm odynam ic equilibrium of an open system. Such connection is usually derived from the Boltzm ann-G ibbs distribution (13) which leads directly within the G aussian approxim ation to the following result:

Thus, the extrapolation of the form ula (54) towards regions of ensem ble inequivalence has no sense within the conventional Them odynam ics. Let us consider a very sim ple exam ple.

Let be a system whose therm odynamical state is determ ined only by the total energy E. The corresponding canonical parameter is the inverse temperature of the G ibbs therm ostat. The relation (54) is given now by:

heat capacity should be nonnegative C 0. As already mentioned, such relation is only applicable during the ensemble inequivalence.

There is nothing wrong in assuming that all those energetic regions with a convex entropy $(^2S \times) = (^2E^2 > 0)$ are just therm odynamical states with a negative heat capacity C < 0. Such anom alous behaviors are well-known since the fam ous Lyndel-Bell work [16] and therm have been also observed recently in experiments involving nuclear or molecular clusters [12, 13, 14]. However, the relation between the heat capacity C with the average energy uctuations (57) has to be generalized in order to attribute some reasonable physical meaning to these anom alous therm odynamical states in terms of a suitable uctuation theory. Such generalization is provided precisely by the form ula:

= 0 in order to control a microcanonical state with a positive heat capacity C > 0, such control parameter can not be kept xed when we deal with microcanonical states with non positive heat capacities C = 0. There h E i 1, which means that the uctuations and I should be correlated in order to ensure the control of such anom alous therm odynamic states, that is, in order to ensure the ensemble equivalence. As a lready commented in the subsection above, this feature is the key for the success of the M etropolis algorithm based on the generalized B oltzm ann-G ibbs ensemble (12).

The heat capacity C is a very simple example of a response function which characterizes how sensible is the system energy E (controlled quantity) during a small change of the temperature T of the therm ostat (control parameter). A nother example of response function is the magnetic susceptibility $_{\rm B}$ = 0M =0B, which characterizes how sensible is the system magnetization M (controlled quantity) during a small change of the external magnetic eld B (control parameter). Thus, the well-known therm odynamical identities:

can be considered as response- uctuation theorem s. As already pointed out, such relations are non applicable during the ensemble equivalence where C or $_{\rm B}$ can adm its negative values, and therefore, such therm odynamic theorem s should nd a natural extension within the present fram ework.

C. M icrocanonical therm odynam ic form alism

The geometric framework developed in the present work constitutes a natural generalization of the therm odynam ic form alism of the conventional Therm odynam – ics. A key for the success is to perform a therm odynam – ical description whose essence be so close to the m acroscopic picture provided by the m icrocanonical ensem ble, which possesses a hierarchical suprem acy in regard to any generalized B oltzm ann-G ibbs description (12).

The totaldi erentiation of the microcanonical entropy:

The reparam etrization invariance in poses some restrictions to the adm issible param eters used in the generalized Boltzm ann-G ibbs canonical description within the present geom etric fram ework. Such status can not be attributed to the ordinary temperature T or the external m agnetic eld B. For example, the G ibbs canonical ensem ble written for a ferrom agnetic system with H am iltonian H^2 under an externalm agnetic eld B directed along the z-axis:

W hile the param etrization (;) is just a covariant vector within a di erential geom etry, such character is not exhibit by the the pair (T; B), and therefore, this last is not a suitable param etrization of the generalized canonical description from the reparam etrization invariance point of view. The above observation inspires a reasonable and necessary rede nition of the concept of response functions in order to preserve the geom etric covariance of the therm odynam ic form alism developed in this work.

The element of the generalized response matrix ^{ij}:

The ensemble equivalence within the generalized Boltzm ann-G ibbs ensemble (12) in the representation R $_{\rm I}$ dem ands the negative de nition of the entropy H essian $_{\rm ij}$, which is equivalent to dem and the positive de nition of the generalized responsematrix $^{\rm ij}$ (64). Thus, regions of ensemble equivalence are just regions with anom alous behavior in the response functions $^{\rm ij}$.

A fundam ental di erence of the above expressions in regard to the conventional result (54) is the presence of a non vanishing correlation matrix $M_i^j = i_i I^j$. Such correlations are not present within the ordinary Boltzm ann-Gibbs distribution (13) since the canonical param eters of the ther-_i I^j = mostat are keep xed, so that 0) h n ji 0. Such limitation does not allow to the Boltzmann-Gibbs description to access to all those regions with a anom alous behavior of the response functions, i.e. regions with a negative heat capacity. As already shown by us in the refs.[17, 18], the only way to access to such anom alous regions with ensem ble inequivalence within a Boltzm ann-Gibbs-like description is by using a generalized therm ostat with a uctuating e ective

canonical parameters $\tilde{} = 0 = 0 \text{ I in order to control}$ the therm odynamic equilibrium of the interest system by keeping xed the averages of the ordinary equilibrium conditions $\tilde{}_i = \hat{}_i$:

The generalized uctuation relations (66) adm it another interpretation. Let us consider a representation R_J where the entropy H essian be a diagonal matrix in a given point J, $_{ij} = _{i \ ij}$, which can be obtained from the representation R_I by using an appropriate orthogonal rotation. W henever an H essian eigenvalue $_i > 0$ (when the interest point belongs to a regions with ensemble inequivalence) the corresponding correlation $_i J^i = 1 + _i J^i^2$, and consequently:

Such inequality looks-like an uncertainly relation which talks about that the physical quantity J^i and the corresponding canonical parameter $_i$ of the generalized therm ostat can not be kept xed when the corresponding eigenvalue $_i$ of the entropy H essian be nonnegative, that is, when the therm odynam ical state of the interest system belongs to a region of ensemble inequivalence. Thus, the quantities $_i$ and J^j can be considered within the present framework as complementary therm odynam ic quantities. This interpretation allow sus to refer the generalized uctuation identities (66) as uncertainly therm odynam ic relations [17].

It is necessary before end this subsection to devote some comments about the phase transitions. The phase transitions within the conventional Therm odynamics are mathematically identied by the non-analyticities of the therm odynamic potential which is relevant in a given application. Within the microcanonical description of an isolated system the only relevant therm odynamic potential is the microcanonical entropy S.

The microcanonical entropy S is always a continuous function, and it is analytical whenever the num ber of degrees of freedom of the interest system n be nite. Thus, as in the conventional Therm odynam ics, the non analyticities of the entropy per particle s = S = n can appear only in the therm odynamic limit n ! 1. Since the microcanonical entropy is a scalar function from the view point of the reparam etrization invariance, its nonanalyticities will appears in any representation R of the abstract space = , and therefore, these m athem atical anom alies are reparam etrization invariant. Thus, the lost of analyticity of the m icrocanonical entropy is identied in the present geom etric fram ework as the mathematical signature of the microcanonical phase transitions. It is said microcanonical phase transitions in order to distinguish them from otherm acroscopic anom alies which are related with the occurrence of the phenom enon of ensem ble inequivalence in an open system . Generally speaking, there exist two generic types of microcanonical phase transitions: them icrocanonical discontinuous phase transitions (associated to a discontinuity in some of the rst derivatives of the m icrocanonical entropy S) and the m icrocanonical continuous phase transitions (associated to lost of analyticity of the m icrocanonical entropy S with continuous rst derivatives).

The dynam ical origin of the m icrocanonical ensemble leads to identify any m icrocanonical phase transition as the occurrence of som e kind of dynam ical anom aly in the m icroscopic picture of the system. The evidences analyzed in the previous work [17] suggest strongly that the m icrocanonical phase transitions are directly related with the occurrence of the ergodicity breaking phenom enon, which takes place when the tim e averages and the ensem – ble averages of certain m acroscopic observables can not be identied due to the m icroscopic dynam ics is e ectively trapped in di erent subsets of the con gurational or phase space during the im position of the therm odynam ic lim it n ! 1 [23].

As elsewhere shown, the convexity of the microcanonical entropy leads to the existence of a lost of analyticity of the P lanck therm odynamical potential P () in the therm odynamic limit via the Legendre transform ation (17). Such discontinuity in some of the rst derivatives of P () is the signature of the rst-order phase transitions in the conventional Therm odynamics. It is necessary to remark at this point that this kind of anomalies can not be microcanonically relevant since they have only sense for the open systems instead of the isolated ones [17]. The rst-order phase transitions are untimely related with the phenom enon of ensemble inequivalence appearing as a consequence of the non negative de nition of the entropy Hessian ij in a given representation R of the abstract space = . Therefore, the existence of the

of the abstract space = . Therefore, the existence of the ensemble inequivalence depends crucially on the nature of the external apparatus controlling the therm odynam ic equilibrium of the interest system . Thus, the rst-order phase transitions can be considered as avoidable therm odynam ical anom alies of the open system s. This last feature can be used for enhancing the available M onte C arlo m ethods based on the Statistical M echanics in order to avoid the ensemble inequivalence by considering the generalized B oltzm ann-G ibbs distributions (12).

I recommend to the interested reader to read the long discussion exposed in the ref.[17] for a better understanding about all these important questions. I shall consider in the section V an example where the existence of a rstorder phase transition in the canonical description hides the occurrence of two microcanonical phase transitions in the therm odynamical description of the q = 10 states P otts m odel system.

where the vanishing of the second term s takes place as a consequence of the stationary conditions (80). This result generalizes the other R immannian interpretations of the Therm odynamics obtained in the past [22]. While the covariant second-rank tensor G_{ij} characterizes the probabilities of the uctuations of the physical quantities $I = I^{i}$ of the interest system, its corresponding contravariant tensor G^{ij} characterizes the probabilities of the uctuations of the conjugated variables $! = f!_{ig}$ in the prephorhood of its expectation ! = h! i =

which provides us inform ation about the unusual therm odynam ic equilibrium between the generalized therm ostat and the interest system. Thus, the conjugated character of the variables ! and I is closely related with the complementary character of the canonical parameters ~ or ^ and their corresponding physical quantities of the interest system I.

V. A FORMAL APPLICATION

Let us reconsider again the example about a ferrom agnetic system under the in unce of an external magnetic eld B directed along the z-axis. Let us to introduce a distinction between the internal H am iltonian \hat{H} (related with the system internal energy U) and the total H am iltonian $\hat{H}_B = \hat{H} = B \hat{M}_z$ (related with the total energy $E = U = B M_z$). As already commented, the Boltzm ann-G ibbs distribution of the system under these conditions:

can be reinterpreted as a Boltzm ann-G ibbs distribution (BGE) with canonical parameters and = B:

The above observation allows to distinguish the usual microcanonical description ($\mathbb{M} \to \mathbb{C}$):

from the detailed m icrocanonical description (DME):

W hile the canonical ensembles (87) and (88) are identical, the microcanonical ensembles (89) and (90) are essentially inequivalent. The above interpretation allows us to consider the modulus of the external magnetic eld B or more exactly, the quantity = В as the canonical control param eter which is therm odynam ically complementary to the magnetization of the system M $_{\rm z}$. Consequently, the macroscopic description provided by ensemble (89) can be considered as an interm ediate description between the DME (90) and the BGE (88), which leads to the following hierarchy among these ensem bles: DME) IME) BGE. This hierarchy presupposes that the description DME contains more inform ation than the $\mathbb{M} \to \mathbb{E}$ description, and at the same time this last one contains more information than the BGE description.

Let us consider the analysis of the above m agnetic system in term softhe therm odynam ic form alism. The total di erential of the m icrocanonical entropy of the detailed ensem ble (90) S (U;M $_z$) is simply given by:

Thus, the consideration of the total energy E instead of the internal energy U corresponds to a reparam etrization where (U;M_z)) (E;B). Reader can notice that such transform ation does not correspond to the di eom orphic transform ation considered by the reparam etrization invariance of the m icrocanonical ensem ble discussed in the present work. Finally, the Planck potential P (;) of the BGE is derived from the DME m icrocanonical entropy S (U;M_z) throughout the Legendre transform ation as follow s:

The relation (99) clari es the precise m eaning of the relation (94), which talks us that the reparam etrization (U;M)! (E;B) in the therm odynam ic lim it is just a kind of projection where it could be involved an important but of therm odynam ic inform ation.

Taking into consideration that = @S=@U and $= @S=@M_z$, the condition (100) is just the relation =

B. On the other hand, the general solution of this stationary condition leads to what could be called as the m icrocanonical magnetization curve at a given magnetic eld B, M = M (U; B). Generally speaking, such m icrocanonical magnetization curve could be a multivaluated function of the internal energy, that is, there could be m ore than one adm issible value of the magnetization M_z at a given value of the internal energy U. How ever, only those points of the m icrocanonical magnetization (101) will be observed within the ME description. Such condition is related with the negative de nition of the entropy Hessian $_{\rm ij}$, which can be rephrased by eliminating the magnetic eld B as follow s:

where the stationary condition (100) was taken into account. Thus, all those points where > 0 can not be observed in the IM E description, and consequently, such possibility involves a lost of therm odynam ic inform ation in regard to the one provided by DM E description. Thus, som e branches of the m icrocanon ical m agnetization curve can disappear within the IM E description, leading in this way to the existence of discontinuities. Such discontinuities can be considered as the signature of m icrocanon ical discontinuous phase transitions within the IM E description because of them represent discontinuities in the rst derivative

of the IM E m icrocanonical entropy S (E;B). The lost of information is more signi cant in the BGE description, which demands now the negative de nition of the entropy H essian:

which is more restrictive than the condition (102), that is, the attainability of the condition (104) leads to the attainability of (102), but the converse is not true.

The picture described above can be observed during the study of the therm odynam ic properties of the q = 10states P otts m odel [24]:

where the sum involves only neighbor-neighbor interactions on a square lattice L L with periodic boundary conditions. The spin variable of the i-th site $_{i}$ =




FIG.1: C om parative study between the M etropolis M onte C arb based on the generalized canonical ensemble (G C M M C) and the Swendsen-W ang (SW) cluster algorithm during the therm odynamical description of the q = 10 states Potts m odel. The SW algorithm is unable to describe the microcanonical states with a negative heat capacity during the rst-order phase transitions since this m ethod is based on the consideration of the G ibbs canonical ensemble. This aim is successfully perform ed by using the G C M M C algorithm, which is able to explore all those energetic regions of ensemble inequivalence. Notice the bim odal character of the energy distribution function within the G ibbs canonical description at

1;2;:::10 are rephrased as bidimensional vector $s_i = [\cos(!_i);\sin(!_i)]$ with ! = 2 = q, which allows to inproduce the m icroscopic magnetization as follows M = $_i s_i$.

The study of this model system with L = 25 by using the Gibbs canonical ensemble (87) is characterized by the existence of a discontinuous phase transition at $_{\rm c}$ ' 1:42 with B = 0, which is recognized by the existence of a plateau in the caloric curve versus " $(" = E = N \text{ is the energy per particle with } N = L^2)$ from $"_1 = 0.319$ to $"_2 = 1.099$ corresponding to a latent heat $q_{lt} = "_2$ "_1 ' 0:78. As already commented, the rst-order phase transition within the G ibbs canonical ensemble is a consequence of an ensemble inequivalence between this description and the IME description (89), which takes place as a consequence of the existence of therm odynam ical states with a negative speci c heat. These anom alous states manifest them selves as a backbending in the caloric curve within the IME microcanonicalensemble (89).




FIG.2: M agnetic properties of the q = 10 states Potts m odel at zero m agnetic eld B within the IM E m icrocanonical description in which is shown the existence of two m icrocanonical phase transitions at "ff' 0:7 (ferro-ferro, discontinuous PT) and "fp' 0:8 (ferro-para, continuous PT). The dash-dot lines indicate the lim it of the energetic region with a negative heat capacity hidden by the ensemble inequivalence.

Reader can see all these behaviors in the FIG 1, which shows a comparative study between two Monte Carlo simulations of this toy system at B = 0: the wellknown Swedsen-W ang clusters algorithm (SW) based on the Gibbs canonical ensemble [20] and the Metropolis Monte Carlo algorithm (GCMMC) based on the generalized Boltzmann-Gibbs ensemble (12) explained in the section III and the ref.[18]. The SW algorithm is unable to describe all those states with a negative heat capacity, a task successfully perform ed by using the GCMMC algorithm. The key for the success of this last M onte C arlo m ethod is precisely the using of a generalized G ibbs thermostat with a uctuating inverse temperature ~. The caloric curve is obtained here by com puting the average $= @s(";B) = @" = ~ and " = h^{n}i$, while the values curvature or entropy Hessian = 0^2 s (";B) = 0^2 can be derived from the unidim ensional generalized uctuation relation:

by computing the correlations h "i and "². Reader can notice that no abrupt change of the energy appear by using the GCMMC algorithm, which illustrates us the avoidable character of the rst-order phase transitions, and therefore, the irrelevance of such anom alies within a m icrocanonical description.

The study of the magnetic properties of this system

within the $\mathbb{I}M \to \mathbb{I}m$ icrocanonical ensemble (89) at $\mathbb{B} = 0$ is shown in the FIG 2. This gure reveals the existence of twom icrocanonical phase transitions which are hidden by the ensemble inequivalence within the G ibbs canonical description. It is easy to show that such anom alies are directly related with the lost of analyticity of the m icrocanonical entropy s (";B) in the therm odynam ic lim it as well as the occurrence of ergodicity breaking in the microscopic picture of the system. The interested reader can see m ore details about this study in the refs.[17, 18]. In spite of the signi cant amount of thermodynamical information provided by the IME description (89) in regard to the BGE (87), the discontinuous character of the magnetization curve is a clear indication about the lost of inform ation of the IME description in regard to the DME one (90) appearing as a consequence of the unattainability of the condition (102) for som e m acrostates. The M onte C arlo simulations shows the existence of several metastable states with dierent m agnetizations in the energetic region $("_{A};"_{B})$ with "A ' 0:7 and "B ' 0:93, which indicates clearly the multivaluate character of the m icrocanonical m agnetization curve M = M (U; B = 0) in the DME description, which should exhibit an anom alous branch characterized by an increasing of the magnetization with the increasing of the internal energy @M = @U > 0.

In complete analogy with the G ibbs canonical ensem ble case, the existence of m etastable states provokes an exponential divergence of the correlation times with the increasing of the system size during the M onte C arlo sim ulations, a dynam ical phenom enon referred in the literature as supercritical slowing down. The existence of this phenom enon is untim ely related with the lost of inform ation associated to the ensemble inequivalence. To avoid this di culty is necessary to perform a therm odynam ic description within the DME ensemble. This aim could be carried out in an appropriated canonical-way within a generalized Boltzmann-Gibbs description (12) whose generalized therm ostat exhibits two uctuating e ective control param eters ~ and ~. This is just an unusual equilibrium situation from the conventional Therm odynam ics view point characterized by a uctuating tem perature T = 1 = and a uctuating external magnetic eld $B^{\sim} = \sim = \sim$.

The components of the entropy Hessian $_{ij} = f_{UU}; UM; MU; MM g$ can be derived from the generalized uctuations relations:

 $\rm U^2$;h U $\rm M_z$ i;h M $_z$ Ui; $\rm M_z^2$. The microcanonical entropy S (U;M $_z)$ can be derived from the direct num erical integration of the canonical parameters (;) and the entropy Hessian $_{\rm ij}$. The possibility of perform such study will be accounted in a forthcoming paper.

As already shown in the subsection IV C, the above generalized uctuation relations can be rewritten by introducing the generalized response matrix $^{\rm ij}$:

The above expressions exhibit the intrinsic reparam etrization invariance of the geom etrical theory developed in the present work. However, conventional Therm odynam ics usually deals with the total energy $E = U = BM_z$ and the external magnetic eld B instead of the internal energy U and the magnetization M_z . This is the reason why it is very interesting to rephrased the above results in terms of E and B.

Let us began with the components of the generalized response matrix, which can be rephrased as:

where it was introduced what can be considered as the components of the response matrix $^{\rm ij}$ = $^{{\rm E}\,{\rm E}}$; $^{{\rm E}\,{\rm M}}$; $^{{\rm M}\,{\rm E}}$; $^{{\rm M}\,{\rm M}}$ in the representation (E;M $_{\rm Z}$). The reader can notice that $^{{\rm E}\,{\rm E}}$ = T $^2{\rm C}$ and $^{{\rm M}\,{\rm M}}$ = T $_{\rm B}$, where C and $_{\rm B}$ are the heat capacity and the magnetic susceptibility respectively. These classical expressions lost their validity when the response functions present some anom alous behavior, like C < 0 or $_{\rm B}$ < 0. As already commented, this problem could be solved within the uctuation theory by considering the generalized response– uctuation relations when $_{\rm H}$ 0 and B $\stackrel{<}{\bullet}$ 0, which can be expressed after some algebra as follow s:

being $Q = E + M_z$ B and = B, where Q characterizes the uctuations of the transferred heat among the interest system and the generalized therm ostat.

The equations (124-127) constitutes the generalized response- uctuation relations in terms of the usual control parameters of the conventional Thermodynam – ics for a magnetic system, (E;M_z; ;B). The corresponding generalized expressions for a uid system is very easy to obtain by considering the correspondence (E;M_z; ;B) (E;p;;V) where p is the pressure and V the volume of the container:

VI. SUMMARY

It has been considered a generalization of the Boltzmann-Gibbs distributions (13) based on the reparam etrization invariance of the microcanonical ensemble. The resulting distribution functions correspond to an equilibrium situation where an interest system is put in contact with a generalized therm ostat in order to keep xed the average values of the quantities ^ = **î** : an external control apparatus becom ing equivalent for the case of a large enough interest system to the ordinary therm ostat with e ective uctuating canonical parameters ~ = Q =QI. It is shown that the ordinary equilibrium condition between the canonicalparam eters of the therm ostat ~ and the corresponding canonical param eters of interest system ^ = @S=@I is only satis ed now in average ~ = ' and these ideas are used for enhance the possibilities of the well-known M etropolis in portance sample algorithm in regions characterized by the ensemble inequivalence.

The generalized Boltzmann-Gibbs ensemble leads in a natural way towards a suitable extension of the classical uctuation theory of the conventional Therm odynam ics by using a non Riemannian geometric fram ework which accounts for the reparam etrization changes within the microcanonical description. Surprisingly, the present approach leads to a novel interpretation of the therm odynam ic states with negative specic heat and other anom alous behavior of the response functions as m acrostates which can be only controlled by an external apparatus with uctuating control parameters ~. Thus, the generalized uctuation relations (66) act as certain kind of therm odynam ic uncertainly relations where the physical observables of the interest system I and the corresponding e ective canonical param eters of the external generalized therm ostat ~ behave as com plem entary therm odynam ical quantities. The above results constitute the basis what could be considered a generalized therm odynam ic form alism within the microcanonical description. A rephrasing the generalized uctuation relations is carried out with the introduction of the concept of the conjugate canonical variables (!; I) where $! = \sim \uparrow$, a representation which possibilities a R iem annian interpretation of the uctuations within the generalized Boltzmann-G ibbs description (12), constituting in this way a natural extension of other geom etric interpretations of the classical uctuation theory developed in the past [22]. As example of application, it was obtained the generalized response-uctuation relations for a magnetic system (and a uid system) in term softhe natural control param eters of the geom etric fram ework, as well as the usual control param eters of the conventional Therm odynam ics.
