Optim alControlofQuantum Rings by Terahertz Laser Pulses

C om plete controlofsingle-electron states in a two-dimensionalsem iconductor quantum -ring model is established, opening a path into coherent laser-driven single-gate qubits. The control scheme is developed in the framework of optim al control theory for laser pulses of two-component polarization. In terms of pulse lengths and target-state occupations, the scheme is shown to be superior to conventional control methods that exploit R abioscillations generated by uniform circularly polarized pulses. Current-carrying states in a quantum ring can be used to manipulate a two-level subsystem at the ring center. C om bining our results, we propose a realistic approach to construct a laser-driven single-gate qubit that has switching times in the terahertz regime.

In recent years there has been wide interest in quantum controlofnanoscale system s. One of the main motivations behind these studies arises from the possibilities of using tailored laser-pulse sequences for logic operations [1]. Sem iconductor quantum dots and quantum rings (QRs) [2] are likely to play an important role in these far-reaching developments. Their atom like properties together with a high exibility in size and shape construct an ideal playground for quantum control.

A fundam ental question in laser control of a general N -level quantum system is controllability, i.e., if the control target such as a certain eigenstate can be reached even in principle. For example, full population transfer in a parabolic quantum dot is not possible (in dipole approximation) [3]. The rst steps towards laser control of QRs were recently taken by Pershin and Pierm arocchi [4], who theoretically analyzed the form ation of currents through population transfer in narrow QRs subjected to a circularly polarized laser pulses. Sim ilar approach has been used also to generate ring currents in circular biom olecules such as Mg{porphyrin [5]. Quantum optim al control theory (OCT) [6] is a powerful tool to nd optim al laser pulses for controlling a quantum system. The iterative scheme developed within OCT [7] converges m onotonically to an optim al laser pulse for reaching the prescribed target, such as a desired nalquantum state, at the end of the pulse.

In this Letter we apply OCT to sem iconductor QRs of nite ring width. We construct optim al two-component laserpulses that drive the QR from a given initial state to any prede ned target state. These terahertz pulses generate the desired transitions in signi cantly shorter times and higher accuracies than previously used circularly polarized continuous waves (CW s) of nite lengths. Finally we sketch how the full control of current-carrying states in QRs enables the construction of a coherent laser-driven single-gate qubit.

The time-evolution of our system is described by the




FIG.1: (a) Shape of the external con ning potential for a quantum ring and an example of a circularly polarized laser eld. (b) Energy-level spectrum of a quantum ring. The transitions are allowed along the dashed line so that l = 1.

tim e-dependent Schrodinger equation

where (t) = (x(t); y(t)) is the two-component laser eld propagating in z direction. The interaction between the eld and the electron ism odeled in the dipole approxim ation (length gauge) with the dipole operator ^ = er. The static e ective H am iltonian for the sem iconductor QR located on the xy plane is written as

where the potential part with $r^2 = x^2 + y^2$ consists of a parabolic con nem ent and a G aussian peak located at the center. Together they determ ine the shape of a twodim ensional Q R which is visualized in Fig. 1. We choose the parameter values ~!_0 = 10 m eV, V_0 = 200 m eV, and d = 10 nm in order to follow the energy and length scales of Q R experim ents [2]. The parameters yield a ring radius of r_0 22 nm. The elective m ass of the electron in G aAs sem iconductor medium is m = 0.067m e. U sing the dielectric constant = 12:7 $_{0}$ for G aAs, the e ective atom ic units [m arked as (a.u.) in the results below] scale as Ha = (m = ²)Ha 11:30 m eV, $a_{\rm B}$ = (m =) a_{0} 10:03 nm, and $u_{\rm t}$ = ~=Ha 58:23 fs.

Figure 1 (b) shows the energy-level spectrum for nine low est states $\frac{1}{1}$, where 1 is the angular momentum and index j = jlj + 1 enum erates the levels in energy. Due to the nite width of the ring, there are other radial bands which, however, appear at higher energies, e.g., the second band appears at E = 5.03. The selection rules allow transitions only between states with consecutive angular m om enta 1 = :::; 2; 1;0;1;2;::; ie., along the dashed line marked in the gure. The transition probabilities between the levels can be calculated as $P_{jk} = jh_k j^j j_j j_j$. For the rst levels shown in Fig. 1 (b) we get relative transition probabilities $P_{12} = 1$, $P_{23} = 1.04, P_{34} = 1.12$, and $P_{45} = 1.24$. Hence, the two-dimensional nature of the ring is reected also in the varying P $_{jk}$: in one-dimensional rings, the dipole matrix elements are constant along the transition lines [4].

W eapply OCT to nd optim al laserpulses for population transfer from the initial state $_i = (t = 0)$ to the target state $_f$, so that both of these states are preselected from the QR eigenstates $_j^1$. In OCT form alism we thus use the projection operator j $_f$ $_f$ j as the target operator, whose expectation value is maxim ized at the end of the pulse (t = T). This corresponds to maxim izing the overlap

We also require that the uence (tim e-integrated intensity) of the laser pulse is as sm all as possible by m inim izing the functional

where the prede ned function (t) acts as a penalty factor, which allows us to impose constraints on the envelope function of the laser pulse [8]. We can apply, e.g., sinusoidal envelope functions as demonstrated in Ref. 9. How ever, in the examples below we have set = 1 (rectangular pulses) in order to simplify the comparison between OCT and CW approaches. As the second constraint, the wave function and its complex conjugate need to satisfy the time-dependent Schrödinger equation. This condition is expressed in a functional form (in a.u.) as

where (t) is the Lagrange multiplier. Now, the minimum of the total Lagrange functional $J = J_1 + J_2 + J_3$ can be determined by setting the variations with respect to , , and independently to zero. This yields a set




FIG.2: (Coloronline) (a) Components $_{\rm x}$ (t) (blue) and $_{\rm y}$ (t) (red) of the optim ized (solid lines) and uniform laser pulses (dashed lines) for ${\rm jl} \rangle$! ${\rm j}^2\rangle$ transition. (b) Spectrum of the optim ized eld. The dashed lines correspond to eigenfrequencies ! 12 and ! 23.

which can be solved iteratively in order to nd the optimized eld (t) at the end of the procedure []. For the forward and backward propagation of (t) and (t) we apply a rapidly converging schemed iscussed in Refs. 7, 9. This computational scheme has been recently included in the octopus code [10].

The advantage of OCT becomes obvious already in the simplest transition from $\begin{pmatrix} 0 \\ 1 \end{pmatrix}$ to $\begin{pmatrix} 1 \\ 2 \end{pmatrix}$ (denoted below as j1 ! j2). Figure 2(a) shows the x and y com ponents of the optimized pulse when the pulse length is xed to T = 100 (5:8 ps) and the penalty factor is = 1. In comparison, the dashed lines show the CW : CW (t) = A $[\cos(!t)\hat{x} \sin(!t)\hat{y}]$, where denotes polarization, and A and ! are the amplitude and frequency of the eld, respectively. Here we choose $! = !_{12}$ and A = R = 12 = 12T, where R is the R abi frequency. These parameters correspond to the -pulse condition. The CW leads to an occupation of 0:99 in the second state which, as dem onstrated below, is insu cient in term softhe controllability of the QR. In contrast, the optim ized pulse produces a value 0:9998 for the sam e pulse length. The underlying reason for the di erence becom es evident from the spectrum of the optim ized pulse shown in Fig. 2(b). Namely, the pulse contains a considerable fraction of the next eigenfrequency 123, preventing the population ow into the third state. If the system is subjected to a CW instead, the occupation loss is inevitable, and becom es pronounced at shorter pulse lengths when the amplitudes are correspondingly higher.




FIG. 3: (Color online) Maximum occupation of the target state in transition $|\mathbf{j}\rangle | \cdot | \cdot | \cdot \rangle$ as a function of the pulse length. The blue open circles correspond to continuous waves and red led circles to the optim al-control result. The insets show the densities j (T = 100) j² when the corresponding achieved occupations are 0.99 and 0.9998 for these pulse types, respectively.

In Fig. 3 the yields of OCT and CW approaches for the jl ! j2 transition are compared for di erent pulse lengths in a logarithm ic scale. Considering the required pulse lengths for desired occupation accuracies, OCT is

clearly superior to the CW approach. The relation between the pulse lengths of these m ethods $T_{CW} = T_{OCT}$ for a certain occupation always doubles when the accuracy is increased by an order of magnitude. For example, the occupation of 0:99 requires T_{CW} 100 or T_{OCT} 25, whereas for an accuracy of 0:999 the CW needs to be increased up to T_{CW} 300 and the optim ized pulse only 35. The main bene t in very high occupato T_{oct} tions achieved by short optim ized pulses is the ability to perform a large number of successive operations (see below). In single transitions we can qualitatively assess the required occupation accuracies by checking the nal densities of the propagated wave function. The insets of Fig. 3 reveal that occupations close to 0:999 are required for the target states in order to preserve a reasonable circular sym m etry of the wave function.

The bene ts of OCT become even more pronounced in multilevel transitions. As shown above, there is only a single excitation path in the lowest radial band of our QR. The path is subjected to strict selection rules that allow transitions only between consecutive levels with 1= 1. Hence, in the CW scheme the intermediate states require full population before occupation of the nal state. Eventually this leads to very slow transition processes sensitive to external perturbations of the realdevice. In OCT approach instead, full population of the interm ediate states is not needed, since the com ponents in the optim ized pulse drive the occupation continuously tow and the target state, still obeying the selection rules. For example, in jl ! j4 transition the maximum occupation required for the interm ediate states 2 and 60 ::: 80%, depending on the pulse length (here ъ is T = 50 ::: 200).

The chirality of a QR state can be changed in multi-




FIG.4: (Color online) Schem atic picture of transitions from l = 1 to l = 1 (a) and from l = 2 to l = 2 (b) (upper panel), optimized elds for these transitions (middle panel), and the occupations of the states (lower panel).

level transitions from 1 to 1 (or vice versa). Figure 4 shows schematic pictures (upper panel) of transitions from $_2^{-1}$ to $_2^{-1}$ (a) and from $_3^{-2}$ to $_3^{-2}$ (b). The optimized pulses given in the middle panel of Fig. 4 are approximately symmetric around the midpoints at t = T=2, and at this point the polarization direction of the eld changes from $_+$ to $_-$ Hence, a backward process can be obtained by applying a pulse where the x and y components are exchanged.

The interm ediate states, which in this case contain the ground state with l = 0, require only partial occupation in the transition process. The interm ediate occupations shown in the lower panel of F ig. 4 reach a maximum of 60% in both l = 1 ! 1 and l = 2 ! 2 transitions. Similar to the pulse shapes, the occupation curves are approximately symmetric around t = T=2. The -nal occupations of the target states are 0:998 and 0:996, respectively.




FIG. 5: (Color online) T in e-dependent electron density $j(r;t)j^2$ [light shade (yellow), low; black, high] and the current j(r;t) (arrows) at di erent times in the transition from l = 1 to l = 1 driven by the optim ized pulse [see Fig. 4 (a)].

In Fig. 5 we plot the tim e-dependent electron densities $j(r;t)j^2$ (colorscale) and the current densities j(r;t) =i~(r r)=2m (arrows) at dierent times in the transition from l =1 to l = 1, corresponding to Fig. 4(a). The circularly symmetric initial state in (a) carries a counterclockwise current of I 0:11 A.During the propagation, the density and current localize st to a single maximum (b). At the midpoint (c) there are two density maxim a along the ring and opposite currents between them along the two paths, arising from the partialoccupations of l= 1. The net current is zero at this point. As expected, the nalstate reached at T = 55 (d) has a symmetric clockwise current.

The circular currents in QRs induce magnetic elds through the ring in accordance with the Biot-Savart law. The current-ipping processes correspond to changes in

magnetic elds as $B \ddagger$ B \ddagger at the center of the ring, where $B = {}_{0}I=2r_{0}$ 3 T for a single electron occupying the state l = 1. If needed, higher elds can be obtained by occupying higher states, by decreasing the ring size, or by changing the sem iconductor host m aterial.

C om bining the results presented above, we suggest the follow ing single-qubit gate construction. First, the accurate experimental shape of the QR and thus the static Ham iltonian (2) have to be determined in order to allow for a full control. This can be done, e.g., by tuning the potential param eters to reproduce the single-electron spectrum obtained in a transport measurem ent [11]. Secondly, the QR is controlled by a sequential master pulse achieving rst the initial excitation from l = 0 to $l = l_m$ (qubit initialization) and then performing l_m l operations at desired times so that the opposite operation is obtained by exchanging x and y components of the current-ipping pulse. The magnetic eld induced at the ring center changes the spin state (up/down) of an applicable subsystem, e.g., a magnetic particle [4] or an attached quantum dot. This is feasible within our picosecond-scale gate operation times, since the characteristic relaxation times are of the order of nanoseconds [4], and the decoherence tim es in quantum dots (of sim ilarphysical parameters) have been measured to be on the millisecond scale [12]. A ctual quantum computation would still require a two-qubit gate and a stable readout scheme, but these developments, as well as detailed experim ental considerations are beyond the scope of this study. However, we point out that terahertz frequency

regine is routinely reached by, e.g., quantum cascade lasers, and the technology of pulse re nem ent is under rapid developm ent [13].

In conclusion, we have shown that a complete control of realistic single-electron quantum rings can be obtained using (quantum) optim al control theory. The optim ized pulses perform the desired operations at signi – cantly shorter times and better accuracies than the continuous waves, and in multilevel transitions they are not restricted by the need to fully populate the intermediate states. This enables a simple construction of a pulse that coherently ips the spin of a subsystem at the center of the ring at preselected times.
