Fine structure of excited levels in a quantum dot with a magnetic ion

The ne structure of excited excitonic states in a quantum dot with an embedded magnetic ion is studied theoretically and experimentally. The developed theory takes into account the C oulom b interaction between charged carriers, the anisotropic long-range electron-hole exchange interaction in the zero-dimensional exciton, and the exchange interaction of the electron and the hole with the d-electrons of a M n ion inserted inside the dot. Depending on the relation between the quantum dot anisotropy and the exciton-M n coupling the photolum inescence excitation spectrum has a qualitatively dimension. It provides a deep insight into the spin structure of the excited excitonic states.

I. IN TRODUCTION

O ptical m icrospectroscopy is a set of powerful opticaltechniques that do not dam age the sam ple and allow one to extract local quantitative information on m icron and subm icron scales. These high spatial resolution opticaltechniques has been used to m easure the photolum inescence (PL) from single quantum dots and study the exchange interaction between a zero-dimensional exciton and a few^{1,2} or a single magnetic ion embedded in the quantum dots (QD)^{3,4,5,6,7}. Theoretically, the ground state energy spectrum of a quantum dot containing a M n ion was studied in Refs. 8,9,10.

In this work we have theoretically and experimentally studied the ne structure of excited excitonic states in such magnetically-doped QDs. We have developed a theory taking into account both direct C oulom b and longrange exchange interaction between an electron and a hole in the zero-dimensional exciton and exchange interaction of the coupled electron-hole pair with the M n d-electrons. The ne structure of the excited state is shown to be determined by an interplay of the anisotropic electron-hole long-range exchange interaction, C oulom b interaction between the charge carriers and the coupling of an exciton with a M n ion.

The developed theory is compared with the PL excitation (PLE) measurements on an individual QD carrying a M n^{2+} ion. The coupling constants of exciton -M n interaction for the ground and optically active excited states are determined. The analysis of the ne structure of the excited states allows us to determ ine the degree of QD anisotropy and make conclusions about the magnetic ion position in a quantum dot. The paper is organized in a following way: Sec. II is devoted to the theoretical analysis of the ne structure of pp-shellexcitonic states in the QD without a M n ion, Sec. III presents the results on the exciton interaction with the magnetic ion, and Sec. IV presents the experimental results and their analysis.

We consider heavy-hole exciton states in a single quantum -well quantum dot. This means that we neglect heavy-light hole mixing and assume an exciton to be formed by a conduction-band electron with the spin s = 1=2 and a heavy hole with the spin (or angularmom entum component) $j = 3=2^6$. For the in-plane connement of free carriers, we choose coaxial parabolic potentials with z as the principal axis. In what follows we concentrate on QDs of sizes sm allenough to have the inplane localization lengths for electrons (a_e) or holes (a_h) sm aller than the two-dimensional (2D) exciton Bohr radius a_B .

To begin with, let us consider an axially (cylindrically) symmetric QD where the exciton ground state (ss-shell) is described by the envelope

where $_{e;h}$ is the electron or hole in-plane radius vector with the components $x_e; y_e$ or $x_h; y_h$ referred to the center of the con ning potential. Similarly, the pp-orbital excited states being the products of electron and hole $P_{x;y}$ orbitals have the form

where the subscripts in D $_{\rm xx}$; D $_{\rm yy}$; D $_{\rm xy}$, and D $_{\rm yx}$ describe the sym m etry of the P -orbitals for an electron and a hole.




FIG.1: Schematic pp-shellenergy-level diagram for the axial (a) and an isotropic QD (b). The energy splittings are shown not to scale.

In the isotropic parabolic potential the four pp-shell states are degenerate. The C oulom b interaction between an electron and a hole lifts this degeneracy, see Fig. 1a. The lowest lying state with the wavefunction

is optically active. The states $\mathcal{P}i = \mathbb{D}_{xx}(e; h)$ $\mathbb{D}_{yy}(e; h) = 2$ and $\mathcal{P}i = \mathbb{D}_{xy}(e; h) + 2$ $\mathbb{D}_{yx}(e; h) = 2$ are degenerate and they are shifted above the state $\mathcal{P}i$ by the energy

where $\{_0 \text{ is the low-frequency dielectric constant and} = a_n = a_e$. The splitting between the pair of states

2i, 3i and the highest state $4i = D_{xy}(e; h)$ $D_{yx}(e; h) \ge 2$ is given by V_C as well. The binding energy of the exciton 3i referred to the unperturbed position of pp-orbitals reads

T he param eters $E_{\,b}$ and $V_C\,$ completely determ ine the direct C oulom b interaction in the parabolic Q D .

We next turn to the slightly elliptical QD where the elective localization radii a_e and a_h are replaced by localization lengths $a_{e;i}; a_{h;i}$ (i = x;y) in the x and y directions. The anisotropy is characterized by the ratios

For simplicity we assume $_{e} = _{h}$ and 1. The anisotropy fully lifts the degeneracy of pp-orbital states. In the case of large anisotropy (the criterion is given below) the splitting between two bright states D_{xx} ($_{e}$; $_{h}$) and D_{yy} ($_{e}$; $_{h}$) is given (to the low est order in) by

where $= m_e = m_h$ characterizes electron-hole mass ratio. The splitting between the dark states, D_{xy} ($_e$; $_h$) and D_{yx} ($_e$; $_h$), arises due to the di erence between carrier m asses and/or localization radii, nam ely,

The transition between the Coulomb-dominated and anisotropy-dominated regimes takes place at $E_a j = V_c$.

The long-range exchange interaction a ecting the bright exciton with m = 1 is described by^{11,12}

where n (or n⁰) is the exciton-state index including both the angular-m om entum component m (orm ⁰) and orbital state, {₁ is the high-frequency dielectric constant, K is the two-dimensional center of m ass wave vector with the components K_x; K_y, K₁ = K_x iK_y, m₀ is the free electron m ass, E_g is the band gap, p₀ is the interband m atrix element of the m om entum operator, and we introduced the 2D Fourier-transform ^e(K) = d e ^{iK} (;) of the exciton envelope function (e; h) taken at the coinciding coordinates, e = h . For the ss-shell, n (;) = S(;) and, for the pp-shell states \mathfrak{P} ; m i, n (;) = D (;) with and nunning through x; y.

In the isotropic Q D the ss-shell radiative doublet is not split by the interaction long-range interaction Eq. (8). W e introduce the characteristic value of the long-range exchange for pp-shell states

For CdTe QD with $a_e = 45 \text{ A}$, $a_h = 90 \text{ A}$, $\{_0 = 10.4, \{_1 = 7.1, 2p_0^2 = m_0 = 17.9 \text{ eV}$, $E_g = 1.6 \text{ eV}$ [see Ref. 11] the Coulomb interaction induced splitting V_C 3 m eV and E 1.5 10^2 m eV . Thus, E V_C and the exchange interaction should be considered as a correction to the direct C oulomb interaction.¹⁸ Therefore, in an axialQD the exchange-induced splitting of the radiative pp-orbital doublet is proportional to $E^2 = V_C$ and can be neglected.

If the QD possesses an anisotropy in the axes x;y the radiative doublet of the ground state (1) is split into a pair of linearly polarized sublevels with the m icroscopic dipole momentum parallel to x and y. This anisotropic splitting is given by

and is proportional to the anisotropy degree entering also into Eqs. (6), (7). If anisotropic splitting, E_a, of the pp-shells D_{xx}, D_{yy} exceeds the Coulom b energy V_c, each shell is additionally split into radiative sublevels p_{xx} ;xi; p_{xx} ;yi or p_{yy} ;xi; p_{yy} ;yi according to

C om paring Eqs.(10) and (11) we conclude that splittings of the ss- and pp-shells di er by 8 .

III. IN TERPLAY BETW EEN EXCITON -M n AND ELECTRON -HOLE EXCHANGE IN TERACTION

The Ham iltonian describing exciton-M n exchange interaction can be conveniently represented in the basis of the certain components s; j; M of the electron, hole and M n-ion spins as

where r_0 is the M n ion position, A_e and A_h are the coupling param eters for conduction and valence band electrons.¹³ In derivation of Eq. (12) we took into account 3=2 hole states and neglected the interaction only i = with the electron in-plane spin since, for the realistic set of parameters, $A_e < A_h = 2$, see Refs. 3,10.

In a QD with an embedded Mn ion, ne structure of the ground-state exciton is determined by the interplay between the QD anisotropy and the exchange coupling with the Mn ion. From now on we consider the most im portant (from both experim ental and theoretical points of view) case where the ground state an isotropic splitting Eq. (10) is negligible as compared with the coupling with a magnetic ion. W ithout the exciton-ion exchange interaction, the ground state of the system \exciton + M n ion" is 4 6-fold degenerate. The interaction H_{Mn} splits this state into 12 doubly-degenerate sublevels half of which, namely, those with the exciton angularmomentum component m s+j= 1, are optically active (or bright). Their energies are given by

where $E_0^{(S)}$ is the ss-shell exciton energy,

 $x_0^2 = x_0^2 + y_0^2$; x_0 ; y_0 and z_0 are the C artesian components of r_0 and the envelope \prime_{e1} (z) or \prime_{hh1} (z) describes the electron or hole con nem ent along z.

The ne structure of the pp-shell exciton excited states is determined by a combined e ect of the exciton-Mn and the electron-hole (long-range) exchange interactions. If the QD anisotropy is small so that $f_a j = V_c$ the only one bright state jlide ned by Eq. β) splits into 6 doublydegenerate sublevels, see Fig. 1a,

are strongly sensitive to the position of the Mn ion. For example, if the M n ion is located exactly in the Q D center the splitting of pp-shell states vanishes.

In highly an isotropic QDs where V_C E_a the ne structure of the D $_{\rm xx}$ and D $_{\rm yy}$ levels is even m ore rich. In general case an overlap between exciton and M n ion is di erent for these two orbitals and one needs to introduce two coupling constants for each type of the carriers, namely,

The eigen energies are determ ined by the interplay of the exciton-M n interaction described by the parameter

and the long-range exchange splitting Eq. (11). For a xed orbital D_{ii} one should observe six doublydegenerated lines with energies

where E_{ii} is the position of the corresponding unperturbed orbital. For E d & 0, the levels are nonequidistant and the crossover between an isotropy dom inated regime with two linearly polarized states (Ed ii) and the regime of dom inant exciton-M n interaction (E_d ii) with six equidistant sublevels takes place.

IV. DISCUSSION AND COMPARISON W ITH AN EXPERIMENT

We usem icro-spectroscopy to analyze the optical properties of individual Mn-doped self-assem bled CdTe/ZnTe




FIG.2: (Color online) Experim entalPL and PLE spectra of M n-doped quantum dot exciton. The spectral features related to the ground and excited states are m arked correspondingly. The inset shows the contour plot of the multi-channelPLE.

QDs. Single M n atom s are introduced in CdTe/ZnTe QDs^{3,4,5} by adjusting, during the growth process, the density of M n atom s to be roughly equal to the density of QDs.¹⁴ The PL of individual QDs is excited with a tunable dye laser and collected through alum inium shadow m asks with 0.2:::1.0 m apertures. The PL is then dispersed by a 2-m additive double monochrom ator and detected by a nitrogen cooled Si charge-coupled device (CCD).




FIG.3: (Color online) PLE contour plots for excited states D_{xx} (upper panel) and D_{yy} (lower panels) obtained for copolarized (left panels) and cross-polarized (right panels) circular excitation.

The experimental ndings for a Mn-doped QD are




FIG. 4: Calculated PLE spectra in co-polarized (left) and cross-polarized (right) con guration. The parameters used are as follows: $E_{yy} = 2117.86 \text{ meV}$, $E_{xx} = 2120.30 \text{ meV}$, $E_d = 0.05 \text{ meV}$, $\stackrel{\sim}{}_{xx} = 0.01 \text{ meV}$, $\stackrel{\sim}{}_{yy} = 0.04 \text{ meV}$, $_s = 0.2 \text{ meV}$ and $E_0^{(S)} = 2086.5 \text{ meV}$. The lines are Lorentzian-broadened with the widths $_s = 0.03 \text{ meV}$ and $_{xx} = 0.06 \text{ meV}$, $_{yy} = 0.03 \text{ meV}$.

summarized in Figs. 2, 3, and 5. This particular QD shows clear linearly polarized excited states. The analysis of the ne structure of other QD s presenting linearly polarized excited states leads qualitatively to the same conclusions. We also note that some QDs dem onstrating the excited states in the same energy range present a very weak or non-detectable linear polarization splitting. Fig. 2 shows PL and PLE spectra of this QD. The ground state PL demonstrates 6 equidistant lines 2086 m eV. These lines correspond to positioned at di erent projections of Mn spin (see Eq. (13)). Their approxim ately equal intensities and regular energy spacing evidence the negligible anisotropic splitting of the ground state. The splitting between these lines suggests 02 meV being in a good agreement with the value s previous studies.³

The rst absorption lines in the measured PLE (Fig.2) lie by 25 meV above the ground state. This energy range corresponds to the LO-phonon energy between C dTe and ZnTe, thus this feature can be identied with the phonon replica of the ground state. The non-trivial PLE pattern coming from the replica is a consequence of com plicated phonon spectra in such QDs system.

Now we proceed with the discussion of the excitedstates ne structure. Two excited states with energies

2117:86 m eV and 2120:30 m eV are seen in Fig.2. W e relate them with the D $_{\rm YY}$ - and D $_{\rm xx}$ -orbital states. The di erence in their intensities can be attributed to (i) the shorter lifetime of the highest energy state and (ii) the C oulom b interaction which, according to E qs. (3) and (4), interm ixes the D $_{\rm xx}$ and D $_{\rm YY}$ states. The latter e ect reduces the oscillator strength of the higher state and, as

a result, the anisotropic exchange splitting of this state.

A value of the ratio between the energy separation of the excited states D_{xx} and D_{yy} and the distance between ground and excited states allows one to estimate from Eq. (6) the quantum dot anisotropy degree to be 0.02 which supports the assumption that the anisotropic splitting of ss-shell state is not observed. Figure 2 clearly manifests the splitting of D_{yy} state into a pair of lines. W e assume this splitting to come from the QD anisotropy [see Eq. (11)]. The splitting of D_{xx} state is not observed for the reasons suggested above.

The comparison between the experimental data and theoretical predictions in Figs. 3 and 4, respectively, shows that the best possible agreement of the data is obtained for anisotropic splitting $E_d = 0.05 \text{ meV}$ and $\sim_{yy} = 0.04 \text{ meV}$. The order of magnitude of E_d is consistent with the quantum dot size $a_e = 45 \text{ A}$ and $a_h = 90 \text{ A}$ (i.e. = 2). It agrees with other results for II-V IQ D s where the hole con nem ent is weaker than that of electrons.¹⁵ For these parameters the predicted energy separation between the ground and excited states is 43 m eV which is som ewhat larger than the experimentally observed 33 m eV.

Fully quantitative description of the experimental results would require a more complicated theory taking into account all details of the band structure and con nement potential as well as the short-range contribution to the exchange interaction.^{16,17}




FIG.5: (Color online) PLE spectra of D_{yy} states for linearly polarized excitation and unpolarized detection. Left and right panels correspond to two orthogonal linearly polarized excitations.




FIG.6: Calculated PLE spectra for linearly polarized excitation and unpolarized detection. Left and right panels correspond to two orthogonal linear polarizations. The param eters used in the calculation are given in the caption of Fig. 4

In order to have a deeper insight into the ne structure of the D_{yy} state we have perform ed the PLE m easurements for the linearly polarized excitation and unpolarized detection. The experimental results are given in Fig.5. The theoretical PLE plots calculated for the same parameters as the spectra for circularly-polarized excitation are shown in Fig.6. The reasonable agreement between the theory and experiment is seen. We note that we do not introduce any spin relaxation in the calculations. The similarity in the PL intensity distribution obtained in the theory and in the experiment shows that under resonant excitation the spin relaxation time of the exciton-M n complex is much more longer than the lifetime of the exciton: no signi cant relaxation occurs dur-

ing the exciton lifetime. As shown in Figs. 3 and 5, this long spin relaxation time combined with the ne structure of the excited states permits to create selectively a given spin con guration of the exciton-Mn complex by tuning the polarization and wavelength of the excitation laser.

Let us note nally that the experimentally observed PLE intensity distribution for the higher energy state D_{xx} is almost uniform, therefore we conclude that the exciton-M n ion coupling is smaller for this state as compared to D_{yy} . We can thus conclude that the M n ion is located nearby the y axis. If we completely neglect electron-M n interaction, using Eq. (18) and the tted value $\gamma_{yy} = 0.04 \text{ meV}$ we deduce that the M n-ion is positioned at $y_0 = 0.3a_h$, $x_0 = y_0$.

V. CONCLUSION

In conclusion, we have perform ed a combined experim ental and theoretical study of the ne structure of exciton excited states in the QDs containing a single m agnetic ion. We have identi ed two regimes of uniaxial and anisotropic quantum dots where the qualitatively dierent level arrangement and PLE spectra are predicted. The theoretical results are compared with the experimental data on photolum inescence and photolum inescence excitation for an individual Mn-doped QD. All important experimental observations are reproduced theoretically. The comparison has made possible to determ ine the Mn-exciton interaction constants, QD anisotropy degree and to estimate the position of the Mn ion in the quantum dot.
