We describe a simple real space renormalization group technique for two dimensional classical lattice models. The approach is similar in spirit to block spin methods, but at the same time it is fundamentally based on the theory of quantum entanglement. In this sense, the technique can be thought of as a classical analogue of DMRG.We demonstrate the method - which we call the tensor renormalization group method - by computing the magnetization of the triangular lattice Ising model.

Introduction: The density matrix renormalization group (DMRG) technique has proved extraordinarily powerful in the analysis of one dimensional quantum system s. [1, 2] Thus it is natural to try to develop an analogous renormalization group method in higher dimensions. Such a method could solve many currently intractable problem s (such as the 2D Hubbard model).

Recent work has focused on generalizing DMRG to higher dimensional quantum system s. [3] But it is also natural to try to generalize to higher dimensional classical lattice models. While classical real space renormalization group methods (such as block spin methods [4]) have been around for many years, they have never achieved the generality or precision of DMRG.

In this paper, we address this problem in the two dimensional case. We use ideas from quantum inform ation theory to develop a numerical renorm alization group method that can e ectively solve any two dimensional classical lattice model. The technique - which we call the tensor renorm alization group (TRG) method - has no sign problem and works equally well for models with com plex weights.

A courate num erical methods based on transfer matrices [5, 6] have already been developed for 2D classical system s. The advantage of the approach described here is that it is a fully isotropic coarse graining procedure, sim – ilar in spirit to block spin methods. It is thus naturally suited to investigating universal long distance physics. A lso, on a more theoretical level, the method reveals the relationship between classical RG and quantum entanglement. Finally, if only for its sim plicity, we feel that the method is a useful num erical tool in two dimensions as well as a natural candidate for higher dimensional generalizations.

Tensor network models: The tensor renormalization group method applies to a set of classical lattice models called "tensor network models." [7] M any well known statistical mechanical models, such as the Ising model, Potts model, and the six vertex model, can be written naturally as tensor network models. In fact, as we show later, all classical lattice models with local interactions can be written as tensor network models.

To describe a tensor network model on the honeycom b lattice, one must specify a (cyclically symmetric) tensor T_{ijk} with indices i; j;k running from 1 to D for som e D. The corresponding tensor network model has a degree of freedom i = 1; ...; D on each bond of the honeycom b lattice. The weight for a con guration (i; j;k; ...) is given




FIG.1: A tensor network model on the honeycom b lattice.

by

$$e^{S(i;j;k;...)} = T_{ijk}T_{ilm}T_{jnp}T_{kar}....$$

where the product includes a tensor for each site of the lattice (Fig. 1). The partition function is the sum of all the weights:

In other words, the partition function is obtained by taking the product of all the tensors, contracting the pairs of indices on each bond.




FIG.2: A TRG transform ation on the honeycom b lattice.

The TRG m ethod: The tensor renorm alization group m ethod is a way to compute the partition function Z using a real space RG ow. We explain the m ethod in the case of the honeycom b lattice. Each coarse graining iteration is m ade up of two separate steps. The rst is approximate, and the second is exact (Fig. 2). The rst step is to nd a tensor S such that

(W e explain how to nd such a tensor S at the end of this section). The relation (3) is a very useful property. G eom etrically, it means that we can reconnect the lattice, making the replacement

wherever we like, without a ecting the partition function Z. Applying this to the bonds shown in Fig. 2a, we change the honeycom b lattice to the new lattice shown in Fig. 2b. The partition function is now given by contracting the S tensors on the new lattice.




FIG.3: A TRG transform ation on the square lattice.

The second step is now clear. We group together triplets of neighboring points replacing them by a single lattice point with a coarse-grained tensor T^{0} :

Here the tensor T⁰ is given by contracting over the three bonds of the triangle:

Making this replacement everywhere gives a new (coarser) honeycomb lattice (see Fig. 2c). This completes the coarse graining transformation. The end result is that the number of points in the lattice has decreased by a factor of 3 and T has been replaced by T^0 .

Iterating this procedure, one can compute the partition function of an arbitrarily large nite lattice. Therm odynam ic observables and correlation functions can be obtained by taking num erical derivatives of $F = \log Z$, or by evaluating the free energy of more general models where the tensors T_{ijk} vary from site to site. An additional feature is that the tensors T converge to a xed point tensor T -whose physical signi cance we explain in the next section. Them ethod is not limited to the honeycom b lattice and can easily be implemented on other lattices (see Fig. 3).

To complete the discussion, we address the issue of nding a tensor S which satis es30. The set step is to think of $_m T_{ijm} T_{klm}$ as a D² D² matrix M : M $_{lijk} = _m T_{ijm} T_{klm}$. It is also useful to think of the tensor S $_{lin}$ as a D² D matrix S $_{lijn}$. Then the problem of satisfying (3) is the problem of nding a D² D matrix S such that M = S $\overset{\circ}{S}$. In general, this factorization cannot be done exactly since the left hand side typically has rank D², while the right hand side has rank at most D.




FIG. 4: After (a) dividing R into triangles, (b) the partition function of each triangle can be written as a function (f a_n g; f b_n g; f c_n g) of the boundary spins.

However an approximate solution can be obtained as follows. The idea is to choose the matrix S that mini-S Šj; the optimal S can then m izes the error, M be found using the singular value decomposition of M . In more detail: rst one writes $M_{li;jk} = \sum_{n} s_n U_{li;n} V_{jk;n}$ (here, s_n are the singular values and U;V are unitary m atrices). Second, one truncates the m atrices U li;n; V jk;n keeping only those colum ns corresponding to the largest D singular values. The result are D² D matrices $\mathbb{U}_{\text{li};n}$; $\mathbb{V}_{\text{jk};n}$. Finally, one sets $S_{\text{lin}} = \frac{P}{S_n} \mathbb{U}_{\text{li};n}$. This gives the required factorization - provided that we adjust the phase ambiguity $U_{li;n}$! $U_{li;n}e^{i_n}$; $V_{jk;n}$! $V_{jk;n}e^{i_n}$ appropriately. In practice, it is often more convenient to ignore the phase adjustment issue and set S_{lin}^{A} = $\Pr_{P} \frac{\nabla_{Ii,n}}{\nabla_{Ii,n}}, S_{jkn}^{B} = \Pr_{S_{n}} \tilde{\nabla}_{jk,n} \text{ . The result is a factorization}$ $_{n} S_{lin}^{A} S_{jkn}^{B}$ $T_{ijm} T_{klm}$ where S^{A} and S^{B} dierby som e phase factors. The TRG procedure can be applied as before - the only di erence being that we have to keep track of two di erent tensors T^A ; T^B for the A and B gub lattines

W e will show in the next section that the error for this optim al decom position is independent of the number of iterations and can be made arbitrarily small by increasing D. Indeed, the error vanishes as exp(const $(\log D)^2$) - the same scaling behavior as the truncation error in DM RG. [2]

Physical picture: In this section we explain the physics behind the TRG method, and give a physical interpretation of the xed point tensor T. We begin by showing how arbitrary classical models in two dimensions can be thought of as tensor models on the honeycom b lattice. For concreteness we frame our discussion around the case of the square lattice Ising model, $Z = \int_{fig} \exp(K \int_{hiji} i j)$. Consider the partition function Z_R for some nite region R in the plane. One way to compute Z_R is to triangulate R, dividing it into triangles of size L much larger than the lattice spacing l (Fig. 4a).

Consider one of the triangles. In agine sum ming over all the lattice degrees of freedom within the triangle. The result will yield some number = $(f_{i_n} g)$ that depends on the values of $f_{i_n} g$ at the boundary of the triangle (Fig. 4b). It is convenient to separate out these boundary degrees of freedom into three groups $f_{a_n} g$; $f_{b_n} g$; $f_{c_n} g$ corresponding to the three sides a; b; c of the triangle.




FIG. 5: The tensor renormalization group transformation can be viewed as a two step change in the triangulation of R.

Denoting f $_{a_n}$ g schematically by , and similarly for f $_{b_n}$ g; f $_{c_n}$ g, we can think of as a three index tensor = .

It is useful to think about the tensor renormalization group transformation in this context. Recall that the p rst step is to nd tensors S satisfying $_{n} S_{jkn}$

 $_{\rm m}$ T_{ijm} T_{klm}. Thinking in terms of the triangles, the right hand side is simply the partition function of the rhombus obtained by gluing two triangles together. Thus, a solution S can be constructed by setting S equal to the partition function of one of the obtuse triangles obtained by dividing the rhombus in the other direction:

$$\overbrace{S} \equiv \overbrace{T} T$$

Thus, the rst step of the renorm alization transform ation process simply changes the triangulation as shown in Fig. 5b. The second step also has a simple interpretation. Examining the de nition of T^0 , it is not hard to see that T^0 is simply the partition function of a large equilateral triangle, obtained by gluing together three obtuse triangles:

$$\overbrace{\mathbf{T}}^{\mathbf{T}} = \overbrace{\mathbf{S}}^{\mathbf{S}}$$

Thus, the second step simply glues together triplets of obtuse triangles to form larger equilateral triangles as shown in Fig. 5c. In this way, the TRG method builds up larger and larger triangles.

H ow ever, there is one subtlety. As we build up larger and larger triangles, the corresponding tensors will have indices with larger and larger ranges, increasing from $2^{L=1}$ to $2^{P \ \overline{3}L=1}$ to $2^{3L=1}$ and so on. Yet, the TRG method insists on approximating these tensors by a tensor with a

xed range D . How can this approximation possibly be accurate?

To answer this question, we must explain the physical meaning of . Let be a tensor obtained from the partition function of a very large triangle. W riting out the labels ; ; explicitly, we can write as a function




FIG.6: The magnetization of the triangular lattice Ising model as a function of $= e^{2 J}$, obtained using the TRG method.

(f a_n g; f b_n g; f c_n g) of the spins on the three sides of the triangle. In fact, this function should be thought of as a wave function for a one dimensional quantum spin system with spins living on the boundary of a triangle. This interpretation comes from thinking of the original 2 dimensional classical model (e.g. the Ising model) as a (1 + 1) dimensional quantum model. We think of the direction parallel to the boundary of the triangle as space, and the (radial) direction perpendicular to the boundary as time. We in agine constructing a one dimensional transferm atrix/quantum H am iltonian H living on the boundary of the triangle, whose (radial) time evolution generates the two dimensional classical model in question. Then in this picture, the function (f a_n g; f b_n g; f c_n g) is the result of evolving H for a

long time (the triangle is large). Hence is simply the ground state of H – up to exponentially sm all corrections.

If we assume that the original classical model (e.g. the Ising model) is not critical, then is the ground state of a gapped Ham iltonian. G apped ground states in one dimension have an important property: they are only weakly entangled. More speci cally, it is known that the density matrix (x;L) of a region of size x converges to a xed density matrix 1 as x;L ! 1 . Moreover, the size of the m the eigenvalue m of 1 falls o rapidly with increasing m: m exp(const $\log(m^3)$). [8]

It is this property which guarantees the accuracy of the TRG method. Indeed, as a consequence of this property, one can factor into a product of three spin states on the three sides of the triangle,

$$(a; b; c) \qquad \begin{array}{c} X^{D} \\ T_{ijk} \quad \stackrel{i}{A} (a) \quad \stackrel{j}{B} (b) \quad \stackrel{k}{C} (c) \qquad (9) \\ ijk=1 \end{array}$$

with high accuracy. Such a factorization can be obtained by choosing ${}^{i}_{A}$; ${}^{i}_{B}$; ${}^{i}_{C}$ to be the ith largest eigenstates of the density matrices of sides A; B; C, and letting T_{ijk} be the matrix elements of the tensor (${}_{a}$; ${}_{b}$; ${}_{c}$) between these states. By the discussion above, the error of this representation is (1) independent of the size L of the triangle, and (2) decreases rapidly with increasing D ($\exp($ const ($\log D^{2}$))). Thus, even though the exact tensor has an exponentially large range, one can make a change of basis so that in that basis, can be accurately approxim ated by a tensor T_{ijk} whose indices have a xed range D. The TRG m ethod can be thought of as a numerical technique for (approximately) constructing this tensor T_{ijk} for larger and larger triangles. The xed point T is the value of this tensor in the limit of an in nitely large triangle.

The above analysis was based on the assumption that the classical model was not critical. If instead the classical model is critical, the associated quantum states are gapless ground states. Gapless ground states are more entangled then their gapped counterparts. The entanglement entropy S = Tr(log) of a region of size x in a system of size L grows logarithm ically with the region size, S = log x. [9] This means that the factorization (9) will always break down when the triangle is su ciently large. Thus, in principle the TRG method - like DMRG [2]-breaks down at criticality.

A simple example: In this section we demonstrate the method with a simple example; the triangular lattice Ising model: $Z = \int_{f g} \exp(J_{hiji} i_j)$. Note that the Ising model partition function can be written as a sum over domain wall con gurations where the domain walls live on the bonds of the honeycom b lattice. This domain wallm odel can be easily realized by a tensor network with D = 2. We think of the state i = 1 as denoting "no domain wall" and i = 2 as denoting "domain wall." Then the tensor with nonzero components

= $e^{2} J$ gives rise to the correct Boltzm ann weight.

Applying the TRG method to the above tensor, we compute the free energy per unit spin, $F = \frac{1}{N} \log(Z)$ in the therm odynam ic lim it N ! 1. The magnetization M can be obtained by taking numerical derivatives of F (though we need to use a more complicated tensor T to represent an Ising model with an external magnetic eld H). Increasing D, the computation rapidly converges to the exact result [10] except in an increasingly narrow interval around the critical point $_{\rm C} = 1 = \frac{1}{3}$ (Fig. 6).

This interval becomes so narrow that one can study the critical point itself. For example, the magnetization curve for D = 34 predicts an $_{\rm c}$ within 10 4 of the exact result. One can even estimate the critical exponent from the scaling behavior of the magnetization. We nd

= 0:12, not far from the exact value = 1=8. However, as explained earlier, the TRG m ethod (like DMRG) is best suited to studying system so criticality. An interesting question for further research is whether the TRG m ethod can be m odi ed so that it's (alm ost exponential) accuracy is uniform, both away from and near critical points.
