D iam agnetism of nodal ferm ions

Free nodal ferm ionic excitations are simple but interesting examples of ferm ionic quantum criticality in which the dynamic critical exponent z = 1, and the quasiparticles are well de ned. They arise in a number of physical contexts. We derive the scaling form of the diam agnetic susceptibility, , at nite tem peratures and for nite chem ical potential. From m easurem ents in graphene, or in $B_{i_1} \times Sb_x$ (x = 0.04), one may be able to infer the striking Landau diam agnetic susceptibility of the system at the quantum critical point. A though the quasiparticles in the mean eld description of the proposed d-density wave (DDW) condensate in high tem perature superconductors is another example of nodal quasiparticles, the crossover from the high tem perature behavior to the quantum critical behavior takes place at a far lower temperature due to the reduction of the velocity scale from the ferm i velocity v_F in graphene to $p = v_F v_{D D W}$, where $v_{D D W}$ is the velocity in the direction orthogonal to the nodal direction at the Ferm ipoint of the spectra of the DDW condensate.

I. IN TRODUCTION

In a class of quantum critical points (QCP), Lorentz invariance appears as an em ergent sym m etry, but in general the quasiparticle residue, as inferred from the oneparticle G reen's function m ay vanish. In rare cases, when the quasiparticle residue is nite, depending on the statistics of the excitations, the Lorentz invariant QCP is described by either a relativistic massless bosonic free eld theory (massless K lein Gordon action) or a relativistic massless fermionic free eld theory (massless Dirac action). Only in (1+1)-dimension are both descriptions identical due to transmutation of statistics. Though the theory has a relativistic form, the speed of excitations is usually about two orders of magnitude smaller than the physical speed of light. Due to uctuations on all length scales in a critical system, many physical quantities exhibit power laws and obey scaling in the vicinity of the QCP. Even in the simplest of such systems, there are surprises buried in their diam agnetic response because a magnetic eld is never a small perturbation: any perturbation that changes the spectra from continuous to discrete can not be considered sm all. Here, we hope to elaborate on this topic and present estim ates that may be tested in experiments.

For a class of tight binding models in the half led lim it, for example graphite or graphene, the energy vanishes at distinct points of the Brillouin zone known as the nodalpoints,^{1,2} and in the long wavelength and low frequency lim it the dynam ics are well described by D irac ferm ions obtained by linearizing the spectrum around the nodes. The nodal spectra can also arise from a condensate. An example is nodal ferm ionic quasiparticles of a particle-hole condensate in 1 = 2 angular m om entum channel, as in a singlet d-density wave (DDW), staggered ux phase, or an orbital antiferrom agnet.^{3,4,5}

The electrom agnetic charge is a conserved quantity for a tight binding model of an electron. This is also true if the order param eter is a particle-hole condensate, as in a DDW. In these cases, the electrom agnetic eld can be incorporated via the minimal gauge coupling. We

shall restict ourselves to such system s and not consider nodal Bogoliubov quasiparticles of a d-wave superconductor. The contrasting response of d-wave superconductor (DSC) and DDW is evident.⁶ The quasiparticles in a superconductor do not m inim ally couple to the vector potential A, but to the supercurrent ŕ′ 2eA~=~c), where ' is the phase of the superconducting order param eter, e is the electronic charge, and c is the velocity of light.

The e ect of the chem ical potential, , is extrem ely in portant, as it can introduce electron or hole pockets and render the linearized free D irac theory invalid. How ever, for small one can still use the linearized continuum theory; = 0 describes the vaccum of the relativistic massless theory and hence is critical. But, for a nite, one is dealing with a nite density of excitations. Thus, one is perturbed away from the criticality, and this should provide a cuto .

For the diam agnetic response at = 0 and zero tem perature (T = 0), one can use a simple quantum critical scaling analysis to nd the power laws satis ed by the m agnetization and the susceptibility.⁷ In this paragraph we shall set e = - = c = 1. From gauge invariance, the vector potential A has the same scaling dimension as the m om entum which is L^{-1} , where L is a length. Therefore the magnetic eld H has the scaling dimension L 2 or there is a length scale L $H^{1=2}$. One can immediately see that this length, which acts as a cuto at the quantum critical point of the free D irac ferm ions, is proportional to the Landau length. Since the hyperscaling should be valid for d = 2 and the dynam ic critical exponent z = 1, the singular part of the ground state energy density, 0, multiplied by the correlation volume, L $^{(d+z)}$, should be a universal num ber,⁸ that is, $_0$ H³⁼². Therefore, the m agnetization behaves as M $H^{\frac{1}{2}}$ and the diam ag- $H^{\frac{1}{2}}$. In the H ! 0 netic susceptibility behaves as lim it, diverges, which will be cut o by a number of physicale ects not contained in this argum ent, and the stability of the state m ay not be in question.

The diam agnetic sign cannot be obtained from the scaling argum ent. The energy levels in a magnetic eld

are bunched (discrete spectra) although the mean density of states is unchanged. The num ber of quasiparticles that can be accomm odated below any given energy depends on whether or not this energy coincides with an eigenvalue of the Landau spectrum or falls in between two eigenvalues. For the nonrelativistic case it is easy to see that on average the energy is increased, because near E = 0 we always start with an empty interval. For the relativistic continuum theory of nodal ferm ions where we have to impose an ultraviolet cuto , this is subtle and requires a proper regularization. Using the work of many authors involving -function regularization,⁹ we can show that the answers are indeed cuto independent and the energy is increased. This was also checked by considering a lattice version and Peierls substitution to incorporate the magnetic eld.¹⁰

We cannot apply the same scaling argument to free D irac fermions in (3 + 1)-dimensions because hyperscaling is violated. This case is best described by a mean

eld theory with logarithm ic corrections. It is known from explicit calculations that the singular part of the ground state energy density $_0$ H² logH .¹¹ A naive application of the above scaling argum ent gives only a regular contribution, $_0$ H², which is not supprising. Thus, we feel con dent that the quantum critical scaling analyses are indeed m eaningful.

Consider d = 2; some aspects of the nite temperature and nite chemical potential results can be understood from the notion of quantum criticality. From nite size scaling, the correlation length, (T), is proportional to the therm alwave length,

where A_0 is a universal number of the order of unity and v_F is the Ferm i velocity. Tuned to = 0, the quantum criticality will persist until (T) is the order of the lattice spacing a. Since v_F is large, one would naively expect H ¹⁼² to the singular diam agnetic susceptibility / persist over a wide tem perature range. In fact, is govemed by a balance between two length scales: the Landau length, $l_{B} = (\sim c=2eB)^{1=2}$, and (T). If (T) > l_{L} , then follows the power law indicating the quantum critical behavior, and in the opposite lim it we obtain linear 1=T. At T = 0, non-zero response, tunes the system away from criticality. For small one can still use the linearized spectrum , and this introduces another length scale, which is essentially the interparticle spacing $\sim_{\mathbf{Y}}$ = . Q uantum criticality of relativistic Ferm ions is experim entally relevant for graphene for which a linear spectrum has been established experim entally.¹² T hese quasiparticles are charged ferm ions and show anom alous integer quantum Hall e ect, as well as Shubnikov-de Haas oscillations.^{13,14,15} It is then natural to expect that, as T ! 0, graphene should have the signature of a diamagnetic \instability" consistent with quantum criticality described above. Similarly, the diamagnetic susceptibility of Bi₁ _xSb_x (x = 0:04) for which the linear dispersion of the fermionic excitations is known to be present¹⁶ remains unexplored. This should be approximately describable in terms of a (2 + 1)-dimensional Dirac theory with weak interlayer coupling.¹⁷ As mentioned above, it has been suggested that the pseudogap phase of the high T_c superconductors can be described by DDW, whose quasiparticle excitations for = 0 are Dirac fermions, as was recognized a long ago.⁴ O ur work is an extension of these early analyses of diamagnetism of nodal fermions to be

nite tem peratures and nite chem ical potential, which leads to interesting results.

In a set of m agnetization m easurem ents, 0 ng and his collaborators¹⁸ have uncovered unusual diam agnetism in the pseudogap state of the high tem perature superconductor $B_{12}Sr_2CaCu_2O_{8+x}$ (BSCCO). In the pseudogap regime, above the superconducting transition tem perature, the diam agnetic susceptibility diverges as

 $H^{(1)}$ =; $H^{(1)}$; $H^{(1)}$ =; $H^{(1)}$ = 0, where the electric exponent (T) is greater than unity over a very broad range of tem perature. Such a divergent susceptibility above a phase transition calls for new ideas, because the response in general should be linear. Only at a critical point, where there are uctuations on all scales, is it possible to obtain such a nonlinearity. In particular, it is known that for two-dimensional Kosterlitz-Thouless theory = 15 at criticality, $^{19} T = T_{KT}$, but the response is linear for any tem perature $T > T_{KT}$. To the extent that the critical region is su ciently wide, it is of course possible to obtain a large value of susceptibility, but not a divergent susceptibility, as seen in measurements where elds as small as 5 Gausswere used. Taken at its face value, experiments indicate a critical phase extending over a wide region of the pseudogap state.

Long ago it was suggested that a weakly coupled stack of X Y -system s could exhibit a oating phase in which the three-dimensional behavior at low temperatures converts to a oating power-law phase (a stack of decoupled layers) at intermediate temperatures and nally to the disordered phase at high temperatures.²⁰ It is now rigorously know n^{21} that if the coupling between the layers is Josephson-like (a likely scenario), a oating phase is ruled out even for arbitrarily long-range couplings. Very special, nely tuned, interlayer couplings are necessary to produce a oating phase, which appears to be unlikely.

A lthough we nd that a sizable diam agnetism sets in with the DDW gap over and above the conduction electron diam agnetism, our results cannot explain the data of O ng and his coworkers: (a) there is no nite temperature critical phase; (b) the relevant scales are vastly di erent. A s m entioned above, K osterlitz-T houless theory cannot account for a critical phase above T_c , though the order of m agnitude is reasonably close.²² W e hope that our calculated crossover behavior of the diam agnetic response w ill

be observable, at least in graphene or in $B_{i_1} \times Sb_x$.

The paper is organized as follow: in Sec. II we will describe the elective model for nodal fermions in two dimensions and outline the formalism for computing the grand therm odynamic potential. In Sec. III we will describe our results for two dimensions (2D). We inst describe the results for the case = 0 and then proceed to the discussion of € 0. In Sec. IV we consider weak interlayer coupling in the context of a three dimensional (3D) system. In Sec. V we consider numerical estimates of the elects that are experimentally relevant and in Sec. V I we conclude. There are two appendices that contain certain mathem atical details.

II. NODAL FERM IONS:TW O-D IM ENSIONAL SYSTEM S

A. Graphene

W hen linearized about the two inequivalent vertices of the Brillouin zone, the tight binding H am iltonian, H, de ned on a honeycomb lattice of a sheet of graphene involving only nearest neighbor hopping, with m atrix element, becomes in the continuum limit (lattice spacing a ! 0 such that at is nite)

where $_1$ and $_2$ are two species of two-component D irac ferm ions corresponding to two inequivalent nodes, and $v_F = \frac{1}{3}at=2\sim$ is the Ferm ivelocity; the spin index s is summed over. The sum over two inequivalent nodes can be written in a compact and Lorentz invariant form as

where $= \frac{y^0}{2}$ and $= \frac{1}{2}$ is now a four component spinor, ignoring the irrelevant spin indices. We are using a reducible representation of -m atrices form ed from the standard Pauli-m atrices 's:

The Landau level problem in the tight binding form ulation is a Hofstadter problem ²³ But, for weak enough m agnetic elds we can analyze the continuum model by incorporating them agnetic eld by minim alcoupling prescription. So, the ham iltonian of interest takes the form

where $l_B = (\sim c=2eB)^{1=2}$ is the magnetic length. We have introduced $= 2 \sim ev_F^2 = c$ for notational clarity. The same formalism can be applied to the nodal spectra of B $i_{\rm l}$ $_x \, Sb_x$ (x = 0:04).

B. d-density wave

The nodal spectra of the DDW is also a well studied problem $.^{4,5}$ The low energy quasiparticle H am iltonian for the DDW state is

As the order parameter breaks traslational invariance by a lattice spacing a, it is convenient to halve the Brillouin zone and form a two-component D irac spinor. Then, in the reduced Brillouin zone, the mean eld Ham iltonian is

The spin index s can again be dropped, as this will not enter in our calculation except for an overallmultiplicative factor.

At half-lling, = 0, there are 4 gapless nodal points at $(\frac{1}{2a}; \frac{1}{2a})$, the Dirac points. A non-zero value of

will open up ferm i pockets. The low-energy physics will be dom inated by these gapless ferm ionic excitations. We choose a single pair of nodal points, $(\frac{1}{2a}; \frac{1}{2a})$ and $\left(\begin{array}{c} \frac{1}{2a}; \\ \frac{1}{2a}\end{array}\right)$ and include the other pair of nodes into our

nal result. We take the x-axis to be perpendicular to the free-electron Ferm i surface and the y-axis parallel to it at one antipodal pair of nodes; sim ilarly, the x-axis is parallel to the free-electron Ferm i surface and the y-axis is perpendicular to it at the other pair. Linearizing the spectrum about the nodes, the dispersion relation is

It is now obvious that the form alism is identical to that described in the previous subsection provided we replace v_F by $(v_F p_{D\,D\,W})^{1=2}$ and rescale k_x ! $k_x \stackrel{P}{\longrightarrow} \overline{v_{D D W} = v_F}$ and $k_y ! k_y \stackrel{P}{\longrightarrow} \overline{v_F = v_{D D W}}$ to account for the DDW gap an isotropy.

C. Grand canonical potential

Here, D (") is the density of states (DOS), which in the presence of an applied perpendicular magnetic eld B, takes the following form : п

The presence of disorder broadens the sharp functions in D ("), how ever, we restrict our discussions to a clean system in this paper for sim plicity.

Here we assumed > 0 (electron doping), and thus the positive LL's are led only up to $n_c = Int[^2 = B]$ at T = 0 while all the negative LL's are plied (Int[] stands for the 'integer part'). Note that at nite T the therm alenergy can excite electrons across to arbitrarily high (positive) LLs, and thus the n-sum must include the whole of D irac cone, as show n explicitly in Eq. (19).

III. RESULTS: TW O D IM ENSIONS

A. Undoped system, = 0

Conside the half-lled system : = 0, hence $n_c = 0.4$ At any tem perature, the length scale of the critical uctuations is the correlation length (T). Thus, in order to observe the T = 0 critical behavior the largest length scale for the system must be this length. In the presence of a magnetic eld B, the response of the system will show critical behavior only when $(T) > \frac{1}{2}$. At T = 0, this condition is trivially satis ed, because the length scale of the critical uctuations is in nite, and we obtain

Here (s) = $\begin{bmatrix} P & 1 \\ k=1 \end{bmatrix} k^{-s}$ is the Riemann -function, N₀ = 3 (3=2)=8 0.312, B = e^{-2}m c, the Bohrm agreeton, with m the free electron mass. The scale $B_0 = m v_F^2 = B_0$ is a material dependent constant and has the dimension of a magnetic eld. The transition from the second expression to the third is an example of standard -function regularization of a divergent sum over n. The proof follows from the remarkable result due to R iem ann, 24 that

The logic is that the \divergent" sum is physically cut) o at some value of n and is not truly divergent, but a gauge invariant regularization is necessary. This is accomplished by the analytic continuation given by the R iem ann rejection in principle. Other regularizations are given in Refs. 4 and 10.

For reasons of physical transparency we shall often express our formulas in terms of an equivalent non-relativistic free electron gas, while keeping in m ind that the real parameters that enter our calculations, such as $v_{\rm F}$, N $_{\rm f}$, etc. bear no real relation to this free electron system with a circular Ferm i surface and two avors of spin. Thus, we have written

which is the standard, energy independent DOS of a twodim ensional (2D) non-relativistic Ferm i gas. Sim ilarly, we can express

It becomes clear from Eq. (27) that $_{\rm T}$ is a function of the ratio of the two fundam ental length scales $_{\rm T}$ =l_B, and thus it must have a scaling form.

In the limit $_{\rm T}$ $l_{\rm B}$, or equivalently b 1, it is the quantum criticality that dictates the response of the system, and Eq. (35) is not particularly useful. The m essage from Eq. (38) is transparent: for b 1 the rst term, $_0$, dom inates, causing the B $^{1=2}$ behavior in the susceptibility, while the rest of the term s in $_{\rm T}$ vanish exponentially. A sb is decreased, $_{\rm T}$ grows, modifying the non-linearity of in B. This behavior continues until b 1, that is, until (T) $_{\rm T}$ $\frac{1}{2}$. Finally, for b 1 the critical uctuations fail to describe the m agnetic response, and the susceptibility follows linear response. For b 1, can we keep only the rst two terms in Eq. (65); the next term is $\frac{1}{5}$ and hence negligibly sm all. The rst term exactly cancels $_0$ and we have,




FIG. 1: log[f(b)] as a function of logb. The numerical evaluation of Eq (34) is given by solid line, and the analytical expression for the large and sm all b lim it are given by empty and solid circles respectively. The inset shows the blownup crossover region (in linear scale). The two asymptotic lim its reproduce f (b) surprisingly well over alm ost the entire parameter regime.

For T \notin 0, the additional T-dependent part in Eq. (19) becomes important; see Eq. (A 5). Because we now have three dierent length scales: T, l_p and the expression for (and) will depend on their relative magnitudes. The most important regime from the perspective of criticality, l_p T, is particularly simple. In this case we can use similar approximations as in Eq. (38), yielding:

IV. THREE DIMENSIONS:EFFECT OF WEAK INTERLAYER COUPLING

M aterials where this 2D nodal ferm ion theory is applicable are layered (quasi-2D) systems, an exception being graphene, which is indeed atom ically thin. If we include weak interlayer coupling in a tight binding ham iltonian, the energy spectrum acquires an additional quadratic dispersion given by

The susceptibility now is just the previous zero tem perature result divided by '. This implies ${}^{}v_F = l_B t_? < {}^2$, which leads to a lower cuto in the magnetic eld, given by $B_c = {}^4t_?^2 \, c = (2e{}^{}v_F^2)$. For a given $t_?$, and $B > B_c$, $B^{1=2}$. When $t_?$ is vanishingly small, B_c is also vanishingly small and can be ignored. When $(t_2 \, k_z^2 \, {}^2 = {}^2 B \,)^2 > 1$ for any value of k_z , the result is more complicated and will be representative of a truly 3D system .

How ever, in 3D electrodynam ics one has to distinguish between B and H, which leads to another cuto . Following Ref. 4, we provide the appropriate form ulas for at = 0. In 3D electrodynam ics the magnetic induction B

V. EXPERIMENTAL RELEVANCE

We have established in Sec. III that the diam agnetic susceptibility undergoes a crossover as a function of T, from its zero tem perature power-law behavior ($B^{1=2}$) to high tem perature linear behavior (1=T). It is interesting to ask if this crossover is observable. Consider graphene; we take the experimental value of $v_F = 10^8$ cm /s and use Eq. (40) for the high-T regime. We obtain

using the mass density of graphite²⁸ $m_{3D} = 2.22 \text{ g=m}^3$, which agrees very well with the experimental results.^{28,29}

Upon lowering T, $_{2D}$ is strongly enhanced and the power-law region can be accessed for $_{\rm T}$ > $l_{\rm B}$. This implies that in graphene for B > 5:6 10 2 T² (G auss) we must use Eq. (38) instead of Eq. (40) for the estimation of $_{2D}$. In particular, in the T ! 0 limit we obtain




FIG. 2: Evolution of $_{2D}$ = ' $_{3D}^{m}$ (de ned in text) as a function of T for various values of B. It is calculated for graphene, using $v_F = 10^8$ cm/s, '= 3:35A and $_{3D}^{m} = 2.22$ gm =cm³

We demonstrate in Fig. 2 the behavior of $_{2D} = \frac{m}{_{3D}}$ as a function of T by numerically evaluating Eq. (32) to illustrate the aforem entioned crossover behavior.

Therefore, in the limit of H $$0.11$ Gauss graphite should become a perfect diam agnet (!), which, however, is a very small eld. If the condition, <math display="inline">_T > l_B$ is com – bined with the value of the scale H , we nd that when T \$1.5K\$, the dem agnetization e ect will be in portant.

In Sec. IIB we described the DDW phase of high $T_{\rm c}$ superconductors by the H artree-Fock theory of the nodal ferm ions in the copper-oxide layers. We shall estimate the strength of the diam agnetic susceptibility from the DDW order, using the follow ing experimental parameters for typical cuprates 18,30 $v_{\rm F}$ = 3 $\,10^{7}$ cm/s and `=12A, where $v_{\rm DDW}$ is estimated assuming a fully formed DDW gap W $_{0}$ $\,35$ meV which leads to the anisotropy in the velocity $v_{\rm F}$ = $v_{\rm DDW}$ $\,28$:6 if t = 250 meV .

In the linear response (1=T) regime, we obtain from Eq. (54),

This indicates that the diam agnetic susceptibility of DDW from nodal ferm ions may be measurable. The discussion above would im ply that DDW would become a perfect diam agnet when H $2:7 \ 10^5$ G, which, how-ever, is such a small eld that many other e ects will intervene, and one would observe H $^{1=2}$, but not perfect diam agnetism.

In the experim ent on BSCCO¹⁸ a T-dependent power law is observed over a wide range of tem perature in the small H limit. Moreover, at the smallest value of the magnetic eld in Ref. 18, H = 5 G, we get from the DDW calculations 3D 1:9 10⁴ in CGS units as T ! 0. This is orders of magnitude smaller than that found in the experiment. Therefore, the magnitude of the diam agnetic susceptibility of R ef. 18 can not be explained within a DDW fram ework alone. One must note how ever that as the tem perature is low ered, the system will generically enter from the DDW phase to a coexisting DDW and d-wave superconducting phase form uch of the param eter regim e.³¹ Thus it is clear that the superconducting diam agnetic e ects of the K osterlitz-T houless theory cannot be ignored.²² But of course none of these considerations can explain the observed critical phase, which requires new ideas.

VI. CONCLUSION

We have shown that the notion of quantum criticality, although restricted to non-interacting nodal ferm ions as elementary excitations, o ers interesting insights to diamagnetism of sem in etals. When the the chemical potential is zero, the system is inherently quantum critical, and we derived the scaling function for . The scaling form suggests that the non-linear behavior of as a function of B, due to quantum criticality, can persist up to a large enough tem perature, which m ay be accessible in m easurem ents in graphene. We have also discussed how tunes the system away from the quantum critical region. The root of the large m agnitude of the diam agnetic susceptibility in graphene or graphite is of course the large Ferm i velocity $v_{\rm F}$.

There are a number of di cult but obvious questions regarding the roles of electron-electron interaction and disorder. These could be topics for future work. We have seen that our simple picture of the DDW does not explain the remarkable experiments in the high temperature superconductors. We do not know if the generalization of the Hartree-Fock picture of the DDW to the six-vertex model where a power law high temperature phase was found³² will be able to explain these experiments. It is certainly worth exploring. We stress, for the reasons stated above, that these experiments are not fully explained by K osterlitz-T houless theory, as is sometimes.

It is clear that the Euler-M acLaurin sum mation approach to compute Landau diamagnetism for nonrelativistic ferm ions fails because of the non-analyticity due to massless D irac ferm ions in sem in etals. It is not known to us if there are any systems for which (3 + 1)dimensional quantum critical behavior log H is experimentally observable. The material B i₁ x Sb_x is lamellar, as is bism uth telluride, and is better described as a two-dimensional system with weak interlayer coupling. N onetheless, it would be interesting to study the diamagnetism of this material as a function composition.

Each individual LL sum fails standard convergent tests. The technique to deal with such sum s in the quantum critical regime is discussed in the text. The strategy in the other limit, where linear response holds, is to convert the LL sum s to express them as series in powers of 1=T, so that m eaningful conclusions could be drawn b about the small b lim it (equivalently, high T lim it) by considering leading order term s system atically. The procedure relies on -function regularization, details of which could be found in literature, but the purpose of this appendix is to provide a self contained description. Separating out the zero tem perature part $_0$ () and nite tem perature part $_{T}$ () we obtain Eq. (18) and Eq. (19) respectively.
