Branch-cut Singularities in Therm odynam ics of Ferm i Liquid System s.

The recently measured spin susceptibility of the two dim ensional electron gas exhibits a strong dependence on tem perature, which is incompatible with the standard Ferm i liquid phenom enology. Here we show that the observed temperature behavior is inherent to ballistic two dim ensional electrons. Besides the single-particle and collective excitations, the therm odynam ics of Ferm i liquid systems includes e ects of the branch-cut singularities originating from the edges of the continuum of pairs of quasiparticles. As a result of the rescattering induced by interactions, the branch-cut singularities generate non-analyticities in the therm odynam ic potential which reveal them selves in anom alous temperature dependences. Calculation of the spin susceptibility in such a situation requires a nonperturbative treatment of the interactions. As in high-energy physics, a mixture of the collective excitations and pairs of quasiparticles can be e ectively described by a pole in the com plex m om entum plane. This analysis provides a natural explanation for the observed tem perature dependence of the spin susceptibility, both in sign and m agnitude.

The temperature dependences of the thermodynamic quantities in the Ferm i liquid have been originally attributed to the smearing of the quasiparticle distribution near the Ferm i surface [1]. This yields a relatively weak, quadratic in temperature, e ect. A contribution of collective excitations, which in dimensions larger than one has a small phase space has been ignored. There is a lacuna in this picture. Both the single-particle and collective excitations are described by poles in the corresponding correlation functions. However, besides the poles there are branch-cut singularities originating from the edges of the continuum of pairs of quasiparticles. Such branch-cut singularities have not been given adequate attention in the theory of Ferm i liquid system s. In the Ferm i liquid theory, a rescattering of pairs of quasiparticles is considered for the description of the collective excitations which exist under certain conditions. This is not all that the rescattering of pairs does. Regardless of the existence (or absence) of the collective modes, the excitations near the edges of the continuum cannot be treated as independent as a consequence of the rescattering. The therm odynamics of Ferm i liquid systems is not exhausted by the contributions of the single-particle and collective excitations. In interacting systems, as a

result of the multiple rescattering, the branch-cut singularities generate anom alous tem perature dependences in the therm odynamic potential.

Motivated by recent measurements in the silicon m etal-oxide-sem iconductor eld-e ect transistors (Si-MOSFETs) [2], we study here the temperature dependence of the spin susceptibility, (I), in the two dim ensional (2D) electron gas in the ballistic regime. Experim ent indicates that in the m etallic range of densities and for tem peratures exceeding the elastic scattering rate, T > 1=  $_{\rm el}$ , the electrons in Si-M OSFET behave as an isotropic Ferm i liquid with moderately strong interactions. In particular, the Shubnikov-de H aas oscillations both without and with an in-plane magnetic eld indicate clearly the existence of a Ferm i surface [3, 4, 5]. The only observation [2] incompatible with the simple Ferm i liquid phenom enology is a surprisingly strong tem perature dependence of (T). This behavior occurs in a wide range of densities that rules out proximity to a T = 0quantum critical point as an explanation of the observed tem perature e ect. In this Report we show that such a temperature behavior of the spin susceptibility is inherent to 2D ballistic electrons. We explain the experim ent by m eans of anom alous linear in T term s [6] generated by the electron-electron (e-e) interactions in (T). In recent papers, linear in T terms have been studied intensely within perturbation theory [7, 8, 9, 10, 11]. However, these works predict the susceptibility increasing with tem perature, while the trend observed in the experim ent is opposite. Taken seriously, this discrepancy indicates that we encounter a non-perturbative phenom enon. Here we show that a consistent treatment of the e ect of rescattering of pairs of quasiparticles in dierent channels provides an explanation of the observed temperature dependence of .




FIG. 1: The diagram illustrating two rescattering events. Lines connecting the interaction amplitudes—are called a \section". Sections represent a propagation of a pair of quasi-particles between rescatterings. Depending on the direction of the arrows (om itted here) the section m ay represent the propagation of particle-hole (p-h) or particle-particle (Cooper) pairs.

How anomalous temperature terms are generated in spin susceptibility. Technically, the multiple rescattering of pairs of quasiparticles is represented by ladder diagrams where each section describes a propagation of a pair of quasiparticles between the rescattering events; see Fig. 1. The collective excitations reveal them selves as pole singularities in the ladder diagrams. When the pole enters into the continuum of two-particle excitations, collective excitation decay. Each of the intermediate sections in the ladder diagrams carries two branch-point singularities which reject the edges of the continuum of pairs of quasiparticles. Therefore the correlation function describing a free propagation of a pair of quasiparticles has a branch cut. The analysis of the

e ects of the branch-cut singularities on tem perature dependences in the therm odynam ic potential is the object of this Report. In the therm odynam ic potential the contribution of the processes of multiple rescattering is given by the so-called ring diagram s, i.e., a series of closed ladder diagram s. For the ladder diagram s, the constraints im posed by the conservation of the momentum and energy are most e ective because they are applied to a minimal number of quasiparticles. In this way, the dominant terms are generated in the thermodynamic potential. O therwise sum mations over a large number of intermediate states smear out the singularities generated by the rescattering processes.

We have to consider series of the ring diagrams in three di erent channels, i.e., in the particle-hole (p-h), the particle-particle (Cooper), and the 2k<sub>F</sub> -scattering channels. The rst two channels are standard for Ferm i liquid theory. The third one is mostly known in connection with the Kohn anomaly in the polarization operator [12]. We start by analyzing the anom alous tem perature term s in the p-h channel. W ithin Ferm i liquid theory, the e-e interaction amplitude depends on the angle between the incoming and outgoing directions of a scattered particle and  $^0$  and is commonly described in terms of the angular harm onics. To understand how the anom alous tem perature terms are generated in the spin susceptibility, let us assum e for a m om ent that the zero harm onic,  $_{0}$ , dom inates the interaction amplitude; =  $_{0}$ . In the case of a single harm onic, propagation of a p-h pair is described by the angular averaged dynamic correlation function  $S_0 = hS()i = != (! + )^2$  $(q_{\Psi})^2$ , where  $= g_B (1 + 0)H$  is the spin split energy induced by an externalm agnetic eld H and  $(1+_0)$  describes the Ferm i

liquid renorm alization of the g-factor. The function  $S_0$  is imaginary when (for a given momentum) the frequency lies within the continuum of the particle-hole excitations. The edges of the particle-hole continuum reveal them – selves in  $S_0$  as a branch-point singularities. Since the position of the branch cut j! + j <  $v_F$  q depends on the magnetic eld, the magnetization of the electron gas becomes sensitive to the analytical properties of the two-particle correlation function near the edge of the continuum. The series of ladder diagrams describing the rescattering of p-h pairs generates the following term in the magnetization (for derivation see Eqs. (12) and (13) in the Appendix):

where  $\frac{1}{2}=\frac{1}{2}+\frac{1}{2}$ ; we tem porarily put g B (1+0)=2 equal to one. Besides the branch-cut singularities originating from the particle-hole continuum, the expression in Eq.1 exhibits a pole generated by  $\frac{1}{2}+\frac{1}{2}+\frac{1}{2}=\frac{1}{2}$  (qx), which determ ines the spectrum of the collective excitations, i.e., the spin-wave excitations [14]. Note that the expansion, either in or in , destroys the subtle structure of the denom inator changing its analytical properties. O by iously, we encounter a non-perturbative phenom enon.

In the case of a weak magnetic eld, < T, the collective excitations and the continuum of particle-hole excitations are not well-separated. Therefore, calculations of the therm odynam ic quantities, e.g., magnetization, should be performed with care as the contributions from the collective and single-particle excitations are not independent. Performing the q-integration by contours in the complex q-plane (one should keep in m ind that the analytical properties in the !-plane di er from that in the q-plane), we not that this mixture of excitations is e ectively captured by a pole in the complex momentum plane. This nding is reminiscent of the Regge pole description of the scattering processes in high-energy physics [15]. For  $\theta$  0, the q-integral is non-vanishing only when the pole in the complex q-plane (a footprint of the spin-wave excitations) moves into the im aginary axis. This move occurs within an interval <! < =(1 + ). At small this interval has that, by the way, explains why in @M = @Ma width we cannot set to zero. Only after the q-integration, we

get for M an expression which (at non-zero T) is regular

We work with the dimensionless static amplitudes known in Ferm i liquid theory [13] as  $^k_n$ , while the propagation of a p-h pair is described by the dynam ic correlation function S ( ) = !=(! + qv\_F cos ); see Eq. 7 in the Appendix. Repulsion corresponds to  $^k_n$  > 0, and Pomeranchuk's instability is at  $^k_n$ ! 1.

where is the density of states (per spin) at the Ferm i surface. Expanding in , we obtain a linear in T correction in the spin susceptibility:

A comment is in order here. At rst glance, a linear in T term in (T) cannot be reconciled with the third law of therm odynam ics,  $S_{T!0} = 0$ , in view of the M axwell relation  $(@M = @T)_H = (@S = @H)_T$ . This observation is the core of the statem ent on the textbook level that the para- $^{1}$  T + const cannot exist at m agnetic behavior with su ciently low temperature; see e.g. Ref. [16]. The well known vanishing of the coe cient of them alexpansion at the absolute zero has the same origin. In this kind of argum entation, it is indirectly assumed that the therm odynam ic potential has a regular expansion in both of its argum ents around H; T = 0.<sup>z</sup> In fact, Eq. 2 dem on strates that the magnetization M = THm (H = T) has a strong dependence on the order of limits H;T! 0. We see from Eq.2 that M / HT when T > H; but for T < Hthe tem perature dependence disappears and M /  $H^2$ . The solution to the con ict with the third law of therm odynam ics is that the magnetic eld range over which M / H shrinks to zero as T ! O, and M acquires a non-linear in H behavior outside this range. At T! 0, which unavoidably brings us into the region T < H, the only indisputable condition imposed by the third law is  $\lim$  ited to vanishing of (@M = @T)<sub>H</sub>. Evidently, Eq. 2 complies with this requirement at T=H ! 0. Therefore, the existence of a linear in T correction in the spin susceptibility is legitim at and may persist down to T! 0, provided that T > H.

W hy spin susceptibility decreases with temperature. The spin susceptibility as given by Eq.3 contradicts the experiment. A coording to Eq.3 the spin susceptibility should increase with T, while in the experiment it decreases. Below we over a resolution to this puzzle. We would like rst to indicate a subtlety in the thermodynamic potential term with two rescattering sections (i.e., in the term proportional to  $^2$ ; see Fig. 2.0 by iously in the ring diagrams the number of sections is equal to the number of the interaction amplitudes). We show below




FIG . 2: The diagram s at the top present the ring diagram s in the electron-hole channel. Left diagram shows the twosection term which is controlled by the backward scattering; the m om enta in the four G reen's functions are along the sam e direction: 1;2  $+ k_F$  and 3;4 k<sub>F</sub>. The Green functions are numbered to keep track of them after the rearrangement in di erent channels. Right diagram at the bottom shows how the two-section term can be read in the 2k<sub>F</sub>-channel. Here the shaded areas represent the interaction amplitudes in the  $2k_F$  -channel. The lines inside the shaded areas are drawn to clarify the spin structure and to indicate the source of the relevant renormalizations. Left diagrams at the bottom show the result of twisting of the two-section term into the Cooper channel. In the series of the Cooper ladder diagram s obtained in this way only two sections (marked by numbered Green's functions) are responsible for the linear in T term in the spin susceptibility. The role of all other sections is to renormalize logarithm ically the e-e interaction amplitudes.

<sup>2</sup> in the spin susceptibility is heavthat the term ily dom inated by the scattering sharply peaked near the  $^{0}$  = (throughout the paper backward direction, the term "backward scattering" will be used to refer to this process). This fact leads to far reaching physical consequences, because the diagram with two rescattering sections dominated by backward scattering can be read in three di erent ways. Such a diagram can be twisted so as to also describe the rescattering in the Cooper channel or two sections in the 2k<sub>F</sub>-scattering channel; see Fig. 2 for explanations. Therefore, overlapping of all three channels takes place. In order to explain the sign of the e ect, it is necessary to simultaneously consider di erent channels and to avoid the double counting of the contributions generated by dierent channels. This is the central point in our calculation of (I).

Before proceeding further, let us outline the consequences of the overlapping of the three channels which takes place on the level of two rescattering sections. Instead of counting the term  $^2$  in the p-h channel, we count it within the Cooper channel where it eventually gets killed o by logarithm ic renormalizations of the interaction amplitudes. Therefore, we have to subtract the two-section term from  $_{\rm p\ h}$  in Eq. 3 which includes it along with higher order terms. As a result of this subtraction Eq. 3 has to be replaced by Eqs. (5) and (6) below. In the rest of this section we give the details of this procedure.

We are not aware of a similar discussion of the therm alexpansion coecient (as well as elastic constants) at low temperatures. In the context of the spin susceptibility the question has been raised by Misawa [17] who guessed (incorrectly) a non analytic form of the therm odynamic potential.

x In fact, an arbitrary number of rescattering sections appears in the C ooper channel after such twisting, but only two of them are used here for the extraction of the anom alous in temperature terms. The role of all other sections is to renormalize logarithmically the e-e interaction amplitudes in the Cooper channel. In the text, we refer the term \section" in the Cooper channel only to those of them that generate linear in T terms. This allows us to speak simultaneously about two sections and the renormalized e-e amplitudes without confusion.

(T = F) 2 ( ). We have checked that exactly the same result can be obtained by the calculation of two rescattering sections in the C opper channel, or in the  $2k_F$  -channel. In the calculation of the Cooper channel, we use the angular harm onics of the particle-particle correlation functions. Once again, despite the nontrivial dependence of these correlation functions on their harmonics indices, the result reduces to the backward scattering am plitude; details will be published elsewhere [18]. Moreover, this calculation yields the same one cient as in Eq. 4. In the case of the  $2k_F$  -channel the presence of ( ) in Eq. 4 is evident, but one has to check the coe cient. On the level of two rescattering sections the contributions generated in three channels coincide (i.e., in (2) allthree channels overlap), as we described above.

We now analyze the problem of the renormalizations of the linear in T terms. It is easy to check that unlike the case of one-dimensional electrons [19], the higher order terms in the  $2k_F$ -scattering channel are not important in 2D. Therefore, we will not discuss this channel fur-

ther and concentrate on the interplay between the other two channels. Up to this point, the interaction amplitudes have played a rather passive role in our calculations. The peak near the backward scattering direction has been generated by the dynam ic correlation functions describing the propagation of pairs of particles in each of the channels. The interaction amplitudes have simply supplied a featureless coe cient () in the two-section term. To understand the true role of the e-e interaction in the anomalous temperature corrections we have to abandon the central assumption of the microscopic Ferm i liquid theory that di erent sections in the ladder diagram s are independent. Indeed, when the rescattering is dominated by the backward scattering, a strong dependence of the interaction amplitude on its arguments in the p-h channel em erges from the logarithms in the Cooper channel (this is a weak version of the parquet known for one-dimensional electrons [19]). In view of this circum stance, in the case of two rescattering sections we have to take into consideration the dependence of the scattering am plitude (p; p+q+k; p+k; p+q) on the arguments q and k. We resolve the problem of the logarithm s by m oving the term with two rescattering sections to the Cooper channel where the logarithm ic renorm alizations originate. This move is possible because the terms with two sections in di erent channels coincide. Note also that as a result of moving the two-section term to the Cooper channel we avoid the double counting of the two-section term in three di erent channels. After this step, as we discussed earlier, the contribution to the spin susceptibility from the p-h channel becomes

We now consider the contribution to the spin susceptibility from the Cooper channel. The rescattering in the Cooper channel leads to the logarithm ic renorm alizations of the interaction amplitudes  ${C \atop n}$  (T) =  ${C \atop n}$  = (1+  $_{n}^{\text{C}}$  In  $_{\text{F}}$  =T) where  $_{n}^{\text{C}}$  are harmonics of the amplitude in the Cooper channel. At su ciently small temperatures, the repulsive amplitudes,  $\frac{C}{n} > 0$ , vanish as  $1 = \ln (_F = T)$ . (W e do not consider here the developing of the instability for the attractive amplitudes [18] as it is most likely blocked by the disorder in the system studied in Ref. [2].) Therefore, the linear in T term s generated in the Cooper channel are suppressed at low tem peratures. Com ing back to the discussion preceding Eq. 5, we now see that the logarithm ic renorm alization of the amplitudes in the term with two rescattering sections in the p-h channel results in full elim ination of this term at low enough temperatures. Therefore, for the repulsive e-e interaction when only zero harm onic is kept, the temperature dependence of the spin susceptibility is given by

In contrast to the previous calculations, this result provides the sign of the tem perature dependence of the spin susceptibility which coincides with that observed experimentally [2]. The expression in Eq. 6 has been obtained by sum mation of the ladder diagrams in two channels and taking into consideration the overlap of the two-section term. In this way we resolve the puzzle of the sign of the tem perature trend in (T).

We next note that the intervention of the Cooper renormalizations in the p-h channel is e ective only for the term with two rescattering sections. We have checked that the situation with a dominant role of the backward scattering is not general and it does not occur for term s with more than two rescattering sections. A direct calculation of the term with three interaction amplitudes (3) = (T = F)(123)(12) (2 1)d 1d 2d 3, performed with the use of the methods sketched above, shows that there is only a weak (logarithm ic) singularity near the backward scattering. This is far weaker than the sharp -function peak near the back- $^{0}$  = , in the case of two rescattering ward direction, sections. It is therefore safe to conclude that, unlike the case of the two-section term, the logarithm ic renormalizations are ine ective for three and more sections in the p-h channel.




FIG. 3: The experim ental data for n= expressed in K and depicted as a function of tem perature. is the spin susceptibility determ ined from H = 0:7T spin magnetization; n is the density of the 2D electron gas in Si-M O SFET. Numbers in the inset are density of the corresponding curves in units of  $10^{10}\,\mathrm{cm}^{-2}$ . Only a fragment of the data of Ref. [2] corresponding to the ballistic electrons is presented. [D ata courtesy of M.Reznikov (Technion, Haifa), used with permission.]

Relation to experiment. Finally, let us discuss the result of our analysis in connection with the measurement of the spin susceptibility in SiMOSFET [2]. In Fig. 3 the data for a quantity n= are presented, where n is the density of the 2D electron gas. We focus here on the curves corresponding to the ballistic range of the

densities. These curves exhibit a noticeable rise with 1:5K, which is too strong for the tem perature at T conventionalFerm i liquid theory; the conventionalFerm i liquid tem perature dependence will be invisible on scales used in the plot of Fig. 3. The data correspond to the range of densities and tem peratures where the transport is ballistic. The rising curves in this plot indicate that the spin susceptibility decreases with temperature. We assum e here that this tem perature dependence is due to given by Eq.6, which we multiply by the factor 4 to account for two valleys. At lower tem peratures the discussed e ect of the anomalous temperature corrections is cut-o by disorder. One can expand n= with respect to the tem perature corrections: (n= ) = T f ( ) ,where  $f() = {}^{2}=2 \ln (1+) + = (1+) \cdot The modica$ tion of the spin susceptibility by the Stoner factor (1 + 0)drops out from (n=). It is cancelled by the two factors ignored so far because in the de nition of  $(1 + _{0}) in$ the combination  $g_B (1 + 0) = 2$  has been put equal to one. Them ain advantage of the com b ination (n=) is that its tem perature dependence is determ ined by the dim ensionless interaction amplitudes only. In the discussed range of densities, parameter  $r_s$  is about 3 4 ( $r_s$  is the ratio of the energy of the e-e interaction to the kinetic energy). Therefore, one may expect the dimensionless interaction am plitudes to have a magnitude 1. Perhaps even a few leading harm onics may be involved. For n & 0 harm on ics enter in pairs,  $_{n} =$  $_{\rm n}$ , and consequently f ( ) should be slightly modi ed because of mixing between n; see Appendix for details. When the ampli-1 the function f ( ) is of order unity (e.g., for tude = 1:5 it is equal to 0:7). The slope of the curves (n= ) presented in Fig. 3 is also 1, i.e., of the sam e order of m agnitude. Together these facts support our conclusion that at low temperature the sign and the magnitude of the tem perature dependence of the spin susceptibility can be explained by the theory of the anom alous corrections presented in this Report. At temperatures comparable with the Ferm ienergy the logarithm ic suppression of the interaction amplitudes in the (2)-term should become ine ective. If so, when  $1 = \ln (F = T) \&$ the tem perature dependence will change sign leading to a non-monotonic spin susceptibility. Unfortunately, the tem perature range of the existing m easurem ent, T = F . 0:1, does not allow to verify this consequence of our theory.

To conclude, the therm odynam ics of Ferm i liquid systems is not exhausted by the contributions of the single-particle and collective excitations. These two types of the excitations are described by the poles in the corresponding correlation functions. However, the theory of Ferm i liquid systems is not complete without consideration of the branch-cut singularities. In interacting systems, as a result of the rescattering of quasiparticles, the branch-cut singularities generate non-analyticities in the therm odynamic potential which reveal them selves in anom alous temperature dependences. The observed tem-

perature dependence in the spin susceptibility of the 2D electron gas can be explained in this way. The mechanism determ ining the sign of the anom alous terms in the spin susceptibility discussed here may have implications for the physics near the quantum critical point at the ferrom agnetic instability.

## APPENDIX

Here we present the details of the calculation of the anom alous tem perature corrections to the spin susceptibility originating from the particle{hole (p{h) channel.}} The propagation of the pair of the quasiparticles with the opposite spin projections in the p{h channel is described (see x 17 in ref. 13 in the main text) by the two-particle correlation function [G G lq,!; = = (! ), where = p+q" p# = V\_F q . Here = 2h is the relative shift of the chemical potential equal to the Zeem an energy splitting; h = (g  $_{\rm B}$  =2)B . It is convenient to single out the dynam ic part of this correlation function:

In this work, the static part of [G G  $l_{\eta;!}$ ; is absorbed in the static Ferm i-liquid amplitudes  $^k$  and will be not considered further. The propagation of a p{h pair is described by the dynamic correlation function S ( ). (From now on, we will om it  $v_F$  in the product  $v_F$  q and consider q as measured in energy units.)

Let us st calculate the contribution from the two rescattering sections in the p {h channel to the anom alous term in the therm odynam ic potential:

Because the amplitudes with dierent harmonics  $_n$  and  $_m$  are involved, the propagation of the p{h pair is described by the angular harmonics of the two-particle correlation function,  $S_{n-m}=(d=2)S()\dot{e}^{(m-m)}$ , where

The expression under the integral in Eq. 17 is an odd function of q. This allows us to rewrite the q integral as a contour integral in the complex q plane. The contour consists of two lines going in the opposite direction above and below the real axis. M ore speci cally, the part of the contour below the real axis goes in the positive direction when !>0 and in the negative direction when !<0. Thus,

W hen there are no poles, or they are present but located on the real axis q, the integral vanishes. (The contour C can be deformed to a big circle where the function under the integral drops as  $1=\hat{q}$ .) However, the integral does not vanish if the poles are on the imaginary axis in the complex q plane. This occurs only for the frequency intervals discussed above. By deforming the contour and taking the residue we reproduce the Eq. 2 in the main text.

So far, only one harmonic in the scattering amplitude has been iterated within the ring diagram s. Moreover, for the purpose of clarity it has been assumed that zero harm onic amplitude o is dominant leading to Eq. 6 in the main text. When n & 0; harmonics enter in pairs because harm onic amplitudes for n are equal,  $_{\rm n}$  = n. All terms on the right-hand side start with  $\frac{3}{n}$ . The last term describes the modication of the temperature term in the spin susceptibility for non-zero harm onics because of the mixing of n and n; compare with Eq. 6 in the main text. At n = 1, the value 2f (n = 1) 0.6 whereas for n = 1;2;10 the corresponding values of n (n = 0.24;0:16;0:04.

A sim ilar analysis can be performed for the terms with three (ormore) interaction amplitudes. We check in this way that for the higher order terms in the p{h channel the scattering does not reduce to the backward scattering. Therefore, there is no overlap with the Cooper channel, and the intervention of the Cooper channel is irrelevant here.
