The relativistic statistical theory and Kaniadakis entropy: an approach through a molecular chaos hypothesis

Abstract. We have investigated the proof of the H theorem within a manifestly covariant approach by considering the relativistic statistical theory developed in [G. Kaniadakis, Phy. Rev. E 66, 056125, 2002; ibid. 72, 036108, 2005]. As it happens in the nonrelativistic limit, the molecular chaos hypothesis is slightly extended within the Kaniadakis formalism. It is shown that the collisional equilibrium states (null entropy source term) are described by a power law generalization of the exponential Juttner distribution, e.g.,  $f(x;p) = \frac{p}{1+2^{-2}} + \frac{p}{1+2$

# 1 Introduction

The Boltzmann's famous H theorem, which guarantees positive de nite entropy production outside equilibrium, also describes the increase in the entropy of an ideal gas in an irreversible process, by considering the Boltzmann equation. Roughly speaking, this sem inal theorem implies that in the equilibrium thermodynamic the distribution

equilibrium distribution [1]. In the special relativistic domain, the very srt derivation of this theorem was done by M arrot [2] and, in the local form, by Ehlers [3], Tauber and W einberg [4] and Chemikov [5]. As well-known, the H theorem furnishes the Juttner distribution function for a relativistic gas in equilibrium, which contains the number density, the temperature, and the local four-momentum as free parameters [6].

context of a nonextensive statistic mechanics (NSM) [7]. tization of a classical system has also been investigated In fact, the NSM has been proposed as a possible extension of the classical one, being a fram ework based on the deviations of Boltzm ann-Gibbs-Shannon entropic measure [8]. It is worth mentioning that most of the experimental evidence supporting a NSM are related to the power-law distribution associated with them any-particle system s [9]. M ore recently, based on similar arguments, Abe [10,11] and K aniadakis [12,13] have also proposed other entropic form ulas. In this latter ones, the -entropy em erges in the context of the special relativity and in the so-called kinetic interaction principle (KIP). In particular, the relativistic H theorem in this approach has also been investigated through a self-consistent relativistic statistical theory [14] and through the fram ework of nonlinear kinetics [15].

A ctually, this -fram ework leads to a class of one param eter deform ed structures with interesting mathematical properties [16]. In particular, the so-called Lesche stability was checked in the -framework [17]. It was also shown that it is possible to obtain a consistent form for the entropy (linked with a two-parameter deformations of logarithm function), which generalizes the T sallis, A be and Kaniadakis logarithm behaviours [18]. In the experim ental view point, there exist som e evidence related with the -statistics, namely, cosmic rays ux, rain events in m eteorology [16], quark-gluon plasm a [19], kinetic m odels describing a gas of interacting atoms and photons [20], fracture propagation phenomena [21], and income distribution [22], as well as construct nancial models [23]. Recently, this theorem has also been investigated in the theoretical front, some studies on the canonical quan-[24].

> From the mathematical view point, the -fram ework is based on -exponential and -logarithm functions, which is de ned by

The -entropy associated with -fram ework is given by

which recovers standard Boltzm ann-G ibbs entropy S = 0 (f) = R finfd<sup>3</sup>p in the lim it  $\,!\,$  0, i.e., the S  $_{=\,0}$  is obtained through the constraints on the constants a and b given by (see Ref. [12,13] for details)

Hereafter the Boltzmann constant is set equal to unity for the sake of sim plicity.

Previous works have already discussed some specic choices for the constants a and b, i.e., for the pair [a = 1=2, b = 0], the K aniadakis entropy reads [12,11]

In particular, for entropy (5) the H theorem has been proved in Ref. [13]. Here, we consider the choice [a = 1=2 (1+), b = a a ] w ith the -entropy given by[11]

In this paper, we intend to extend the nonrelativistic H theorem within the Kaniadakis framework to the special relativistic domain through a manifestly covariant approach. As we shall see, our approach does not consider the so-called deformed mathematics [13]. Rather, we show a proof for the H theorem based on similar arguments of Refs. [25,26], e.g., a generalization of the molecular chaos hypothesis and of the four-entropy ux.

## 2 Classical H Theorem

We rst recall the basis for the proof of the standard H theorem within the special relativity. As well known, the H theorem is also based on the molecular chaos hypothesis (Stosszahlansatz), i.e., the assumption that any two colliding particles are uncorrelated. This means that the two point correlation function of the colliding particles can be factorized

or, equivalently,

where p and  $p_1$  are the four-m omenta just before collision and the particles have four-m omentum p p = (E = c; p) in each point x x = (ct; r) of the space-time, with their energy satisfying  $E = c = \frac{p}{p^2 + m^2 c^2}$ . In order to complete the proof of the H theorem, we combine the Boltzmann equation with the four-divergence of the four-entropy ow, i.e.,

In this concern, it is possible to show that the relativistic K aniadakis entropy is consistent with a slight departing from \Stosszahlansatz". Basically, this means the replacement of the logarithm functions appearing in (8) by -logarithmic (power laws) dened by Eq. (2). In reality, it is worth mentioning that the validity of the chaos molecular hypothesis still remains as a very controversial issue [27].

#### 2.1 Generalized H Theorem

In order to investigate H theorem in the context of the K aniadak is statistics, we rst consider a relativistic raried gas containing N point particles of mass m enclosed in a volume V, under the action of an external four-force eld F. Naturally, the states of the gas must be characterized by a Lorentz invariant one-particle distribution function f(x;p), which the quantity f(x;p)d³xd³p gives, at each timet, the number of particles in the volumeel-ement d³xd³p around the particles space-time position x and momentum p. By considering that every in uence of a power law statistic must happen within the collisional term of Boltzmann equation (see also [25,26]), we assume that the temporal evolution of the relativistic distribution function f(x;p) is given by the following transport equation

where = 0;1;2;3 and @ = (c  $^1$ @<sub>t</sub>;r) indicates di erentiation with respect to time-space coordinates and C denotes the relativistic -collisional term. Following the same physical arguments concerning the collisional term

where d is an element of the solid angle, the scalar F is the invariant ux, which is equal to  $F = \frac{p}{(p p_1)^2 m^4 c^4}$ , and is the di erential cross section of the collision p+  $p_1 ! p^0 + p_1^0$ ; see Ref. [28] for details. All quantities are de ned in the center-of-mass system of the colliding particles. Next, we observe that C must be consistent with the energy, m om entum, and the particle number conservation laws, and its speci c structure must be such that the standard result is recovered in the lim it! 0.

Here, the -generalized form of molecular chaos hypothesis is also a di erence of two correlation functions

where primes refer to the distribution function after collision, and exp (f), In (f), are de ned by Eqs. (1) and (2). Note that for = 0, the above expression reduces to  $R_0 = f^0 f_1^0$  ff<sub>1</sub>, which is exactly the standard molecular chaos hypothesis. In the present fram ework, the four-entropy ux reads

where for = 0, the quantity  $c^{-1}S^{0}$  stands for the local K aniadakis' entropy density, as given by (6). Indeed, by taking the four-divergence of S , i.e.,

can be written in a more symmetrical form by using som e elem entary sym metry operations, which also take into account the inverse collisions. Let us notice that by interchanging p and  $p_1$  the value of the integral above is not modi ed. This happens because the scattering cross section and the magnitude of the ux are invariants [28]. The value of is not altered if we integrate with respect to the variables  $p^0$  and  $p_1^0$ . A lthough changing the sign of R in this step (inverse collision), the quantity  $d^3pd^3p_1=p^0p_1^0$ is also a collisional invariant [28]. As one may check, such considerations imply that the -entropy source term can be written as

As is well known, the irreversibility them odynam ics emerging from molecular collisions is quite obtained if (x) is positive de nite. This condition is quaranteed only when the integrand in (16) is not negative. Indeed, by introducing the auxiliary functions, namely  $z = \exp (\ln f +$ In  $f_1$ ) and  $y(z) = In f + In <math>f_1$ : The dierences  $z^0$  z and y<sup>0</sup> y can be positive or negative and these di erences have the same sign if the functions y is an increasing function. However, In f is an increasing function and then product

For the sake of completeness, let us derive the version of the Juttner distribution within the -statistic. Such an expression is the relativistic version of the -distribution [16], and must be obtained as a natural consequence of the relativistic H theorem. At this point, it is interesting to emphasize that such a distribution already has been introduced by K aniadakis through a variational problem in a selfconsistent approach; see Ref. [14] for details. The H theorem states that = 0 is a necessary and su cient condition for equilibrium. Since the integrand of (16) cannot be negative, this occurs if and only if

where the four-momenta are connected through a conservation law

which is valid for any binary collision. Therefore, the above sum of -logarithms remains constant during a collision: it is a sum mational invariant. In the relativistic case, the most general collisional invariant is a linear combination of a constant plus the four-momentum p; see Ref. [28]. Consequently, we must have

where (x) is a scalar, a four-vector, and p is the four-momentum. By using that  $\exp (\ln f) = f$ , we may rewrite (18) as

with arbitrary space and time-dependent parameters (x) and (x). Some considerations on the function f(x;p) are given as follows. First, this is the most general expression which leads to a vanishing collision term and entropy production, and reduces to Juttner distribution in the limit ! 0. However, it is not true in general that f(x;p) is a solution of the transport equation. This happens only if f(x;p) also makes the left-hand-side of the transport equation (10) to be identically null. Nevertheless, since (19) is a power law, the transport equation implies that the parameters (x) and (x) must only satisfy the constraint equation

Second, the above expression is also the relativistic version of the K aniadakis distribution [12]. Here, this was obtained through the dierent approach from the one used in Refs. [13,14].

As an example, let us now consider a relativistic gas under the action of the Lorentz 4-force

where q is the charge of the particles and F is the Maxwellelectromagnetic tensor. Following standard lines, it is easy to show that the local equilibrium function in the presence of an external electromagnetic eld reads

where U is the mean four-velocity of the gas, T (x) is the temperature eld, is the G ibbs function per particles, and A (x) the four-potential. A sphysically expected, note

to the well known expression [28,30]

### 3 Conclusions

In Refs. [25,26] we have discussed the H theorem in the context from the Kaniadakis and Tsallis statistics within the nonrelativistic and relativistic domain. Based on the generalization of the chaos molecular hypothesis and the entropic m easure, it was shown the proof of the H theorem in both domain. In this paper, by considering the sam e argum ents on the chaos molecular and entropy, and regardless of the deform ed m athem atics introduced in R ef. [13], we have studied a -generalization of the relativistic Boltzmann's kinetic equation along the lines de ned by the K aniadakis statistics. In reality, since the basic results were obtained through a manifestly covariant way, their generalization to the general relativistic domain may be readly derived. Finally, we also emphasize that our proof is consistent with the standard laws describing the microscopic dynamics, and reduce to the familiar Boltzmann proof in the lim it! 0.
