Stochastic dynam ics of a Josephson junction threshold detector

W e generalize the stochastic path integral form alism by considering H am iltonian dynam ics in the presence of generalM arkovian noise. K ram ers' solution of the activation rate for escape over a barrier is generalized for non-G aussian driving noise in both the overdam ped and underdam ped lim it. W e apply our general results to a Josephson junction detector m easuring the electron counting statistics of a m esoscopic conductor. A ctivation rate dependence on the third current cum ulant includes an additional term originating from the back-action of the m easurem ent circuit.

I. IN TRODUCTION

D etecting electron counting statistics has become a major experimental challenge in mesoscopic physics. First attempts to measure non-G aussian elects in current noise have revealed that the detection problem is quite subtle. In particular, the experiment¹ found that the third current cumulant was not described by the simple theoretical prediction,² but was masked by the in uence of the measurement circuit causing an additional \cascade" correction.^{3,4} R ecent experiments demonstrated a measurement of the third current cumulant without cascade corrections,⁵ and the detection of individual electron counting statistics.⁶ Stringent bandwidth requirements in measuring the third current a new approach.




FIG.1: Josephson junction (JJ) threshold detector: Sim plied electrical circuit with the JJ (marked with an X) and mesoscopic system inserted. The driving noise of the system creates uctuations of the center node voltage V, that can activate the JJ out of its supercurrent state, into its running dissipative state until it is recaptured.

A conceptually di erent way to measure rare current uctuations is with a threshold detector, $7^{,8}$ the basic idea of which is analogous to a pole vault: A detection event occurs when the measured system variable exceeds a given value. A natural candidate for such a detector is a m etastable system operating on an activation principle.9 By m easuring the rate of switching out of the m etastable state, information about the statistical properties of the noise driving the system may be extracted. A threshold detector using an on-chip conductor which contains a region of negative di erential resistance^{8,10} was proposed by the authors and shown to be capable of measuring large deviations of current. Tobiska and Nazarov proposed a Josephson junction (JJ) threshold detector, 7 the sim plest variant of which (see Fig. 1) operates essentially in a Gaussian regim e.¹¹ The third cum ulant contribution is sm all¹² and m ay be extracted using the asym m etry of the switching rate with respect to bias current, as has been dem onstrated in recent experim ents.^{13,14}

In this Letter we solve K ram ers' problem 9 of noiseactivated escape from a metastable state beyond the G aussian noise approximation and investigate how the m easurement circuit a ects threshold detection. Starting with general H am iltonian-Langevin equations which includes deterministic dynamics, dissipation, and uctuations, we represent the solution as a stochastic path integral of H am iltonian form 15,16 by doubling the num ber

of degrees of freedom. In the weak damping case, the dynam ics is dom inated by energy di usion, which we account for by a change of variables, enabling an e ectively two-dim ensional representation. We calculate the escape rate via an instanton calculation, and obtain a form al solution of K ram ers' problem .⁹ Applying these general results to a JJ threshold detector, we account for the inuence of the measurem ent circuit and ind that the cascade corrections are a consequence of the non-equilibrium character of the noise.¹⁷

II. HAM ILTON IAN -LANGEV IN EQUATIONS

In order to reform ulate and solve K ram ers' problem beyond G aussian noise, we introduce a theoretical fram ework that relies on a separation of time scales: Slow motion of a determ inistic system on a time scale T_0 is a ected by quickly uctuating noise sources with correlation time $_0$ T_0 . Quite generally, this situation can be described by H am iltonian-Langevin (HL) equations. For instance, in a two-dimensional phase space (p;q) the equations of motion are

where H (p;q) is the H am iltonian that generates deterministic motion, and $\rm I_q$ and $\rm I_p$ are white noise sources.

On the interm ediate time scalet, such that $T_0 t_0$, the sources are M arkovian and fully characterized by the generating function H ($_p$; $_q$) of their cumulants (irreducible m om ents): $h I_p^n I_q^m$ ii = $\mathfrak{g}_p^n \mathfrak{g}_q^m H$ (0;0).

W hile Langevin equations may be solved by standard methods in stochastic physics,¹⁸ the methods fail when applied to higher-order cum ulants. The reason is that slow variations of p and q a ect the noise sources and lead to cascade corrections,^{3,16} which cannot be obtained from linearized di erential equations (1). Follow – ing the steps of Refs. [15,16], we represent the slow evolution of the system by the stochastic path integral (SPI) $P = D \quad DR \exp(S)$, where the action S is given in the explicitly canonically invariant form as

Here R = (p;q) and = (p;q) are the sets of physical and canonically conjugated \counting" variables, respectively, and f::g denotes the Poisson bracket with respect to p and q. By xing R in the nalstate of (2) we obtain the probability distribution P (R), while xing the nal

variables turns the SPI into the ${\tt m}$ om ent generating function P ().

The large parameter $T_0 = 0$ 1 allows the saddlepoint evaluation of the SPI and thus requires solving H am ilton's equations of motion in the extended space.¹⁶ There always exists a trivial solution = 0 and R = fR ;H g+ hIi, where I (I_p ; I_q), that describes the \average" dynamics in physical space with a null action S = 0, giving the proper norm alization of the distribution P . In the context of the generalized K ram ers' problem, one has to nd a non-trivial instanton solution in (R) of Eq. (2), for which the SPI gives a rate of the noise activated escape from a localized state, / exp(S in).¹⁹

III. ENERGY DIFFUSION AND ESCAPE RATE

As an important example, let us consider quasiperiodic motion with the period T_0 0. We change variables to energy E = H (p;q) and \time" s = s(p;q),²⁰ accompanied by a new set of counting variables ($_E$; $_s$), which are de ned via $_p = _E @_pH + _s@_ps$ and $_q = _E @_qH + _s@_qs$. Using fE; H g = 0 and fs; H g = 1, we obtain fR; H g = $_s$. Fluctuations of the s variable increase the action without leading to escape, therefore they can be neglected by choosing $_s = 0$. In the weak damping regime, one can set s = t, so that $_p = q_E$ and $_q = _p_E$. The action for the energy di usion then reads,

The following intuitive argument supports this result. The energy balance equation $E_{-} = qI_p \qquad pI_l$ follows directly from the HL equations (1) and takes the form of

a Langevin equation. If $T_0 = 0$, then variables q and p change slow ly and can be considered as being e ective charges", which after following [16] leads to Eq. (3).

To leading order in weak damping we can replace the generator H in Eq. (3) with its average over the oscillation period hH i_E $(1=T_0)$ dtH, evaluated for xed $_E$ and E. Corrections in damping may be found by taking into account slow energy dissipation $E_{-}=$ ($_E$ H and $_{-E}=$ ($_E$ H, while averaging over the period T_0 . We are interested in the instanton solution $_E$ = $_{in}$ (E) with hH i_E = 0 in the initial and nal state. 10 Since the \backslash H am iltonian" hH i_E is an integral of motion, we obtain an important result for the escape rate,

which form ally solves K ram ers' problem for arbitrary M arkovian noise in the weak dam ping lim it. Below we apply the theory outlined here to the stochastic dynam ics of a Josephson threshold detector.

IV. JOSEPHSON THRESHOLD DETECTOR

The circuit in Fig. 1 shows the essential part of the detector comprised of the JJ with Josephson energy E $_J$, and the capacitor, C . The circuit is current-biased with I_B through them acroscopic conductor and by the system current I_S , which is to be measured. A coording to K irchho's law, the total bias current I_S + I_B is equal to the sum of the Josephson current $I = (E_J = _0) \sin$ where $_0 = \sim=2e$, and the displacement current $I_C = C \ V_-$. This leads to the equation of motion for the superconducting phase ,

where we used the relation $V = _0 -$.

In order to sim plify the following analysis and concentrate on our main message, we make a number of assum ptions, most of which will be relaxed later. First, we consider an ohm ic system and bias resistor, so that $hI_{S}i = J_{S}$ $G_{S}V$ and $hI_{B}i = J_{B}$ $G_{\rm B}~V$, where $G_{\rm S}$, $G_{\rm B}$ are the system and bias conductances, and the constant currents $J_S = G_S V_S$, $J_B = G_B V_B$ are just tunable param eters. The bias resistor, being a macroscopic system, creates G aussian N yquist noise hI_B^2 ii = 2T G B. W e further assume a high-impedance circuit, so that the back ow part of the bias current G B V and the N yquist noise m ay be neglected, $I_B = J_B$, which we refer to as the ideal detection scheme. Then Eq. (5) can be rewritten as a set of HL equations (1) for the phase variable and canonically conjugated momentum $p = {}_0Q$ (where Q = CVis the total charge on the capacitor)

Equations (6) describe the motion of a \particle" in the tilted periodic potential

stimulated by the dissipative part $I_S \quad J_S$ of the system's current. For later convenience, we de ne the normalized total bias current as $J = _0 (J_S + J_B) = E_J$. D issipation leads to relaxation of the JJ into one of its metastable states. In the supercurrent state, the phase is localized in one of the potential wells, so that hV i = 0. In the dissipative state, the phase drifts along the bias which generates the non-zero voltage drop V. In the remaining part of the paper we investigate noise activated escape from the localized state.

V. WEAK DAMPING REGIME

Here the system conductance is small, G_S $!_{pl}C$, so the phase oscillates with the plasm a frequency $!_{pl} = {}_J (1 \quad J \;)^{l=4}$, where ${}_J = (E_J = {}_0^2C\;)^{1=2}$. The energy relaxes slow ly with the rate G_S=C to the local potential minimum . We further assume the separation of time scales, 1= $_0$ maxfeV_S;Tg $\sim !_{pl}$, so that the noise source I_S is M arkovian. C om paring (6) and (1), we identify q= , I_p = $_0 (I_S \quad J_s)$ and I_q = 0, so the equations for the escape rate and \instanton line" read

where H is the generator of the cum ulants of the dissipative part of the system current, $I_S = J_S$, and $_0$ plays the role of an elective charge.

We rst consider the system in them al equilibrium with G aussian N yquist noise, hI_S^2 ii = 2TG_S, as a checkpoint of the theory. The cum ulant generator acquires the simple form H = $_0G_S - (_{in} -) + TG_S (_{in} -)^2$, where the rst term comes from the linear response of the system current I_S $J_S = G_S V$ to the potential $V = _0 -$, while the second term is the noise contribution. A veraging H over the period of oscillations, we observe that the term $h^{-2}i_E$ cancels, so that $_{in} = _0=T$. U sing Eq. (8) we obtain K ram ers' well-known form ula for the rate of them ally activated escape




FIG.2: The norm alized potential threshold $U\!=\!E_{\rm J}$ and dimensionless factors D $_1$ and D $_2$, are plotted versus the normalized current bias $J=_0(J_{\rm S}+J_{\rm B})\!=\!E_{\rm J}$. Inset shows the phase space plot of a trajectory for weak damping (thick line) which leads to the escape, and the separatrix (dashed line). The turning points $_0$ are shown by the dots.

where the potential threshold U is a function of normalized bias J. For the potential (7) one obtains $U=E_J = 2(1 \quad J^2)^{1=2}$ 2J accossJ, see Fig. 2. Limiting values are $U=E_J = 2$ for J = 0, while as J ! 1, $U=E_J \quad (4 \quad \overline{2}=3) (1 \quad J)^{3=2}$.

The above example shows that the argument of H is small. Indeed, we estimate - !_{pl}, so $e_{in} \sim !_{pl}=T$ 1 due to the separation of time scales. Therefore, for any system away from equilibrium we can expand hH i_E in Eq. (8), average the result over the period

of oscillations, and invert the series for $_{in}$. To second order in $_{in}$ we again obtain K ram ers' form ula (9) with the tem perature T replaced with the elective tem perature

To nd the third cum ulant correction to the K ram ers' form ula, we expand hH $(-_{\rm in})i_{\rm E}$ in $_{\rm in}$ and the voltage V, and collect all terms to next order in smallparameter $\sim !_{\rm pl}=T_{\rm e}$. Two terms which contain $hH_{\rm S}^3$ ii and $\varrho_{\rm V_S}hH_{\rm S}^2$ ii come with the factor $h^{-3}i_{\rm E}$.²¹ This factor vanishes to leading order in damping, because for xed energy — is an odd function of time over the oscillation period. Therefore, we evaluate the average $h^{-3}i_{\rm E}$ by taking into account slow variation of the energy. This is accom – plished by taking functional variations of the action to nd $_{\rm in}$ = $_0$ =T_e and E-= $_0^2$ G s $^{-2}$. We skip a number of straightforward steps (see Appendix) and present the result for the non-equilibrium escape rate

where the dimensionless factor $D_1(J)$ is a characteristic of the detector. Appearing in the integral (11b) is one of the turning points of the oscillating phase, 0, de ned by the solution of U (0) = E that is nearest the top of the potential. For the potential (7) $D_1(0) = =3$ and for strong bias J ! 1 we obtain $D_1(J) = 0.8(1 J^3)$. The parameter D_1 , evaluated numerically, is shown in Fig. 2.

The total third current cum ulant

is taken at V = 0 and contains a correction originating from the slow ly varying second current cum ulant. This contribution is analogous to the cascade correction^{3,4} directly observed in third cum ulant.¹ The correction is generally not sm alland m ay even change the sign of the total cum ulant. For instance, for system s far from equilibrium $hI_{\rm S}^{\rm n}$ ii = $F_{\rm n}$ hI_S i, where $F_{\rm n}$ are the dimensionless Fano factors, we obtain $hI_{\rm S}^{\rm s}$ ii_{tot} = $(F_{\rm 3} = 3F_2^{\rm 2}=2)hI_{\rm S}$ i.

VI. OVERDAM PED REGIME

In this regime the conductance is large, $G_s \qquad !_{pl}C$, and the dynamics is entirely due to slow phase relaxation with the rate $!_{pl}^2C = G_s$. Therefore, we can set p = m – and $_q = 0$, and neglect the rst term in the action (2), so that the action reads: $S = dt \not\models (_{0 p}; -)_{p} \not\in U$], where again H is the generator of the cum ulants of the dissipative part of the system current, $I_s = J_s$.

The following analysis is analogous to that of the weak damping regime. We rst expand H to second order in $_{\rm p}$ and nd from the equations of motion that -= T_e $_{\rm p}$ and $_{\rm p}$ = @ U=($_0^2$ T_e G_S). Substituting these results back to the action we immediately obtain K ramers' formula (9) with T replaced with T_e. Next we observe that the argument of H is small, namely e $_{0 \rm p}$ ~! $_{\rm pl}^2$ C=G_ST_e 1 due to the separation of time scales requirement. We collect all the terms to third order in this parameter and evaluate them perturbatively using the above results for $_{\rm p}$ and $_{\rm m}$ We nally obtain

where the total cum ulant $\ln I_S^3$ ii_{tot} is given by Eq. (12), and D₂ (J) is a dimensionless detector property. For the potential (7) it is given by D₂ = (1=6) (1+ 2J²) arccosJ (1=2)J (1 J²)¹⁼², see Fig. 2. Lim its are D₂ (0) = =12, and as J ! 1, D₂ (J) 0.25 (1 J⁵)⁼².

VII. DISCUSSION

We now remark on the application of our results to the detection of non-G aussian uctuations. It is evident from Fig.2 that D_{1;2} U=E_J as J ! 1. Therefore, in the strong bias regime the third cumulant contribution in (11) and (13) is suppressed compared to the K ram ers' term S₀ = U=T_e. But even for a relatively weak bias, when D_{1;2} 1, non-G aussian e ects are sm all. Indeed, it is easy to estimate the correction as (R_{wd}=Q)S₀, where the JJ quality factor Q = C !_{p1}=G_S > 1 in the weak damping regime (wd), and the ratio R_{wd} = ~!_{p1}=T_e < 1 due to the separation of time scales. Similarly, in the strong damping regime (sd), Q < 1, the correction is of order R_{sd}S₀, where R_{sd} = ~!_{p1}²C=G_S T_e < 1 due to the

separation of time scales. Since S_0 itself cannot be too large for the escape to be detected, in experiments one should try to saturate the above inequalities and use the asymmetry of the third cumulant (12) as a function of the current bias $J_{\rm B}$.

Next, we brie y discuss nonideal detection and nonlinear e ects. The nite conductance of the bias resistor G_B contributes to the total conductance of the circuit $G_{tot} = G_S + G_B$ and the Nyquist noise lhI_B^2 ii = 2T G_B adds to the total noise power. Therefore, in Eqs. (11-13) one has to replace G_S with G_{tot} and the e ective temperature with $T = (G_S T_e + G_B T)=G_{tot}$. The non-linearity of the system current leads to the correction $(p=2)(0)^{-2} \mathcal{C}_{V_S}^2 hI_S i$ to H, and thereby to an additional contribution to the total third cumulant, $lhI_S^3 ii_{tot} = lhI_S^3 ii 3T \mathcal{C}_{V_S} hI_S^2 ii + 3T^2 \mathcal{C}_{V_S}^2 hI_S i$, in both transport regimes considered above. Quite remarkably, this total third cum ulant is related via $lhI_S^3 ii_{tot} = 3C^2 G_{tot} hV^3 ii$ to the instantaneous uctuations of the voltage V.²²

We nally note that in the experiment of Ref. [13] the circuit corrections have not been observed, which we explain by a very bw impedance of the circuit, $G_S = G_{tot}$ 1, operating in the weak damping regime with $Q = C !_{p1} = G_{tot} = 2:5$. Indeed, in this case $T' = (G_S = 2G_{tot}) eV_S$ (assuming T = 0), therefore the circuit corrections are suppressed by a small factor $G_S = G_{tot}$. On the other hand, the rst term in Eq. (11a) is $S_0 = U = T$ and the second term can be estimated as ($G_{tot} = G_S$) ($R_{wd} = Q$) S_0 , where $R_{wd} = \sim !_{p1} = eV_S$ in this case. Therefore the relative contribution of the third cumulant to the total action increases by the factor $G_{tot} = G_S$, which makes it favorable to use a low-impedance circuit.

In conclusion, we have form ally solved K ram ers' problem of noise-activated escape from a metastable state for M arkovian non-equilibrium noise beyond the G aussian approximation. We have applied this result to the Josephson junction threshold detector and evaluated the third current cumulant contribution to the escape rate. The back action of the electrical circuit on the measured noise is entirely a non-equilibrium e ect, which leads to \cascade" corrections for the third cumulant. It would be interesting to apply our theory to the dynam ics of the Josephson bifurcation ampli er.²³

APPENDIX A

In this Appendix, we give the details of the derivation of Eq. (11). Starting with Eq. (8), we expand the gener-

ating function in the counting variable to third order,

Taking the assumptions in the text of an ohm ic system conductor, we replace hI_S $J_S i = G_S V$. The noise produced by the system conductor depends on the dynamically changing voltage drop V_S V (see Fig. 1), so we also expand the second current cum ulant in the voltage V, namely hI_S^2 ii = hI_S^2 ii $\theta_{r_S} hI_S^2$ iiV + :::, where we recall that V_S is the voltage across the system, and the coe cients above are evaluated at V = 0. U sing the Josephson relation V = $_0$, and averaging (A1) over the oscillation period at xed energy, we now need to nd the instanton line and solve the equation

As argued in the text, the instanton solution $_{\rm in}$ (E) is small for the JJ, so the series may be inverted to $\,$ nd to third order in $\sim\!\!!\,_{\rm pl}\!=\!\!T_{\rm e}\,$,

Inserting this instanton solution into the action, we obtain for the activation rate

However, to leading order in damping, the average $h^{-3}_{-3}i_E$ vanishes because – is an odd function of time

over the interval of one period. Therefore, we must evaluate this average to next order in the variation of energy over one period. Recalling that the action is $S = dt^0 [_E E = _0 + H (_E -)]$, the time dependence of the energy E may be found by taking the functional derivative $S = _E$ to nd $E = _0 @_E H$. Inserting the instanton solution $_{in} = _0 = T_e$, we obtain

so the energy is increasing.

At a given value of , the linear correction to $-^2$ due to energy dissipation is given by $-^2 = (2=m) E \cdot T$ herefore, we use dt -= d to write

where the integral starts from the turning point nearest to the top of the barrier, $= _0$. This is done because the escape of the JJ into the running state happens at the top of the barrier, so the last part of the trajectory before escape must be fully accounted for.

Integrating by parts, $d = E \int_{0}^{T_{0}} dt E_{-}$, we keep only the change in energy, and neglect the change in the turning point to this order. Using the result (A5), these approximations in ply that $d = \frac{2}{0}G_{s} dt(_{0})^{-2}$. Collecting results, we nd

Recalling the de nition $m = {}_{0}^{2}C$, and inserting (A7) into (A4), we recover our main result (11).
