M apping of Coulom b gases and sine-Gordon models to statistics of random surfaces

We introduce a new class of sine-Gordon models, for which the interaction term is present in a region dierent from the domain over which the quadratic part is dened. We develop a nonperturbative approach for calculating partition functions of such models, which relies on mapping them to statistical properties of random surfaces. As a specie application of our method, we consider the problem of calculating the amplitude of interference fringes in experiments with two independent low dimensional Bose gases. We calculate full distribution functions of interference amplitude for one-dimensional and two-dimensional gases with nonzero temperatures.

## I. INTRODUCTION

Sine-Gordon (SG) models and their Coulomb gas representations appear as a low energy e ective theory for m any types of physical systems. The so-called \bulk" SG model describes the Berezinskii-Kosterlitz-Thouless (BKT) transition in two-dimensional super uids 1, 2, 3] and the super uid to insulator transition of Cooper pairs in a chain of Josephson junctions [4]. The socalled \boundary "SG model [5] can be used to describe the Chakravarty-Schm id transition in a single Josephson junction with dissipation [6] and a quantum impurity problem [7] in one dimension (1D). Powerful theoreticaltechniques have been developed for studying such SG models including Bethe ansatz solutions [8], renormalization group analysis (see e.g., Ref. [3]), and functional renormalization group [9]. Recent theoretical work suggested that there is another class of SG models which is important for several kinds of physical systems. Such m odels can be described by the action

where the interaction term cos (2 ) is present in the spatial region! (or space-time region for quantum problem s), which is only a part of the domain over which the noninteracting part  $(\tilde{r})^2$  is de ned. This should be contrasted to the bulk SG models, in which the interaction term is present in the entire region , and to the boundary SG models, in which the interaction term is present on a line. We note that models with inhomogeneous g (x; ) can be considered using m ethods developed in the paper as well, but for concreteness we will consider only constant g: M odel (1) interpolates between the bulk and boundary SG models, and we will refer to it as the interior sine-Gordon (ISG) model. Here are a few examples of physical systems that can be described by such models. The rst example is the problem of "interwire coherence\[10] in which wires are brought together over a

nite length land separated on both ends. The costerm describes the correlated um klapp electron scattering in the two wires (+  $2k_{\rm F}$  scattering in one wire accompanied by  $2k_{\rm F}$  scattering in the other wire). The quantum

space-time action of this system has the form of Eq. (1) = [1;1] [0; ] and ! = [1;2;1;2] [0; ]. Another example comes from a system of quantum particles in one dimension (e.g., electrons or Cooper pairs in a wire, or ultracold atom sin a weak optical trap) with a periodic potential present in a nite region of the system. The costerm comes from the um klapp scattering on the external potential and is limited to the nite region in the interior of the system. The third example is the problem of distribution functions of interference fringe am plitudes (DFIFA) for a pair of independent low-dim ensional condensates [11, 12, 13]. Individual m om ents of the distribution function can be represented as a microcanonical partition function of Coulomb gases [14, 15, 16], with positions of Coulomb charges restricted to the part of the system from which interference patterns have been extracted. The latter is typically smaller than the total system size. For example, in the case of large 2D condensates we have = [1;1][ 1;1], and when the interference pattern is extracted from the area 1 1, [l=2;l=2]. The relation be-tween the DFIFA and the partition function of the ISG m odelwillbe outlined below and has also been discussed in Refs. [14, 15, 16].

In this paper we develop a nonperturbative approach to calculating partition functions of a wide class of SG m odels and Coulomb gases, which relies on the mapping of their partition functions to certain problems of statistics of random surfaces. We point out that our method does not rely on the existence of the exact solutions of SG models, but uses the structure of the multi-point correlation functions in the absence of interactions. We also note that a suitable extension of our method can be used to compute correlation functions of SG models in equilibrium and non-equilibrium situations. The particular strength of our approach is that it can be applied to study ISG models, which cannot be analyzed by other theoreticalm ethods. As a concrete application of our method we calculate DFIFA for both 1D and 2D condensates. We point out that earlier theoretical work on interference experim ents focused on 1D system swith periodic boundary conditions (PBC) [15]. While these boundary conditions are extremely articial from the point of view of realistic experiments, they allow one to relate the DFIFA to the quantum in purity problem [7] and use certain exact results about the latter [17]. Methods used in Ref. [15] can not be generalized either to the realistic case of open boundary conditions (OBC) (i.e., interference patterns extracted from the interior of a large system) or 2D systems, but these cases can be analyzed using the method discussed in this paper. We emphasize, however, that the main goal of this paper is to introduce an approach to the analysis of SG models and the problem of DFIFA is just one example that illustrates the power of the new

m ethod.

## II. MAPPING

The partition function corresponding to the action (1) is given by Z (g) = D e  $^{S (g)}$  = D e  $^{S (0)}$ . By expanding Z (g) in powers of g we arrive at the grand canonical partition function of the C oulomb gas [18]

Here,  $Z_{2n}$  is a microcanonical partition function of a classical two-component neutral C obumb gas of 2n particles, and G(x;y) is an interaction potential, which is proportional to G reen's function of the Laplace operator on : The most familiar case is when =  $\begin{bmatrix} 1 & 1 \\ 1 & 1 \end{bmatrix}$  and  $G(x;y) = \ln x$ 

To evaluate Z (g) nonperturbatively in g; we introduce an auxiliary function W ( ), which should be understood as a certain distribution function, and is de ned in such a way that its nth m om ent equals Z  $_{2n}$ :

One can use the Hankel transform ation [19] to compute Z (g) from W ( ) as

This equation equation can be veried using the Taylor expansion of the modied Bessel function  $\{ (x) \}$  and Eq. (3). Formulation of the auxiliary "problem of moments allows one to avoid calculating Z (g) order by order, and can be viewed as a tool to sum the perturbation series in Eq. (2) to all orders.

Function G(x;y) is real and symmetric, so it can be diagonalized on! by solving the eigenvalue equations

From a comparison of Eqs. (3) and (7) we obtain

Equations (8) and (9) have a simple physical interpretation. Consider f(x) to be the eigenmodes of the surface vibrations, tf the uctuating mode amplitudes, and if (f) if the noise power. In nite dimensional integral over ftfg variables can be understood as an averaging over uctuations of the surface. For a particular realization of noise variables ftfg; a complex valued surface coordinate at point x is given by  $h(x; ft_f g) =$  $_{\rm f}$  t  $_{\rm f}$  (x)  $^{\rm F}$   $\overline{\rm G}$  (f)=K = G (f)  $_{\rm f}$  (x)  $^{2}$ =2K :For each realization of a random surface ftfg; g(ftfg) is obtained as an integral (8), which can also be written as  $g(ft_f g) =$ ,  $d^2xe^{h(x;ft_fg)}$ : Hence Eq. (9) can be interpreted as the m apping between the partition function of the SG model (1) and the statistics of random surfaces subject to classical noise. This mapping is the central result of this paper.

In general,  $g(ft_fg)$  is a complex number, thus in general, is defined on a complex plane. Simplifications occur: if all eigenvalues G(f) are negative, then  $g(f \notin g) = g(ft_fg)$ ;  $g(ft_fg)g(f \notin g) = g(ft_fg)f$ ; and is always real and positive. Function W(f) can be computed efciently using Eq. g(f) and g(f) on the carbosimulations. In the first step one solves integral equations g(f) numerically to obtain eigenfunctions g(f) and eigenvectors g(f): Then one samples random numbers g(f) from the g(f) aussian ensemble, and plots the histogram of the results for g(f) for g(f) for g(f) and g(f) is a computation of only two integrals, and g(f) can be evaluated to arbitrary precision.

Note, that this simple numerical evaluation of W () allows one to extract Z (g) for all values of g using Eq. (4). While conventional large-scale M onte C arlo simulations [20, 21] can be used to extract properties of SG models, they require separate simulation for each value of g: Application of such methods to the calculation of DFIFA described below would also require analytic continuation of numerical results to imaginary values of g [15], which is numerically unstable. In addition, the mapping in Eqs. (8) and (9) does not only simplify numerical simulations, but can also be used to obtain analytical results (see below).

## III. APPLICATIONS TO INTERFERENCE OF LOW -D IM ENSIONAL GASES

We now apply a general form alism developed to a particular problem of the interference of low-dimensional




FIG. 1: Simpli ed setup of interference experiments with 1D Bose liquids (see, e.g., Refs. [11, 12]). Two parallel condensates are extended in the x direction. A fter atom s are released from the trap, clouds are in aged by the laser beam propagating along the z axis. Meandering structure of the interference pattern arises from phase uctuations along the condensates. The net interference amplitude A is de ned from the density integrated along the section of length L: For the analogous 2D setup, see, e.g., Fig. 2 of Ref. [14].

Bose gases [11, 12, 13, 14, 15, 16]. Typical experimental setup for interference of low-dimensional gases with open boundary conditions (OBC) is shown in Fig. 1. Two parallel condensates are extended in the x direction. After atoms are released from the trap, clouds expand predominantly in the transverse direction. After succient time of ight clouds overlap, and the laser beam propagating along the zaxis takes an absorption image. Fluctuations of the relative phase result in uctuations of the minima positions for dierent x: For each y; the image can be integrated along the x direction to obtain the integrated fringe amplitude A: One experimental image can be used to extract information for dierent values of L: Many images are still required to obtain distribution functions for each L:

For two identical 1D clouds higher moments of the fringe amplitude A can be written as [14]

Here is the density, L is the imaging length, h is the healing length, and C is a constant of the order of unity. For OBC  $Z_{2n}$  is given [14] by Eq. (2) with = [ 1;1] [0; ] (and periodic boundary conditions in ) and ! = [0;1] (and xed ). Equation (10) has been derived neglecting the shot noise, which arises due to a nite number of particles in the interfering clouds [16, 22]. In what follows, we will be interested in the distribution functions W ( ) of a positive variable =  $\hbar$   $\hat{J} = \hbar \hat{J} =$ 




FIG. 2: Distribution functions of the normalized interference amplitude W ( $\sim$ ) at T = 0 for 1D gases with open boundary conditions, shown for Luttinger parameters K = 2 (dashed); K = 3 (dotted); and K = 5 (solid): The inset shows a comparison between open (solid) and periodic (dashed) boundary conditions for K = 5.

 $Z_{2n}=Z_2^n=R_1$   $W(\sim)\sim^n d\sim$ : For zero temperature  $Z_{2n}$  depends only on the Luttinger parameter K; which describes [23, 24] the long-distance behavior of boson correlation functions, given by  $ha^y(x)a(0)i = (h=x)^{1=2K}$ . For bosons K ranges from K=1 (strong interactions) to K=1 (weak interactions). For 0 BC and zero temperature G(x;y) equals  $G(x;y)=\log x$  y; while for PBC considered in Ref. [15],  $G^{per}(x;y)=\ln \frac{1}{2}\sin x$  y; W hile  $A_0$  depends on E; for zero temperature distribution E (E) does not depend on E; but depends only on E. For nonzero temperature, E E0 depends on E1 and the therm allength E1 E2 E3 where E3 is the sound velocity: E3 (E3; E3) E4 E5 is the sound velocity: E3 (E4; E5) E5 in E5 is the sound velocity: E4 (E5) and E5 is the sound velocity: E5 (E6; E7) is the E9 in E9.

For 2D, one can use a similar approach to describe the contrast distribution at nite temperature below the BKT transition. (2) are defined on a square ! = [0;1] [0;1] with G (x;y) = ln jx yj:

In the lim it K ! 1; one can expand the exponent of Eq. (8) in the Taylor series. Then =  $g(ft_f g)g(f \notin g)$ is linearly related to roughness, or mean square uctuation of the surface, as de ned in Ref. 25]. For PBC the noise has a 1=f power spectrum, since G per (x;y) = f=1 f=1 (cos2 fx cos2 fy +  $\ln \frac{1}{2} \sin jx \quad yj = 0$  $\ln 2$ sin 2 fx sin 2 fy)=f: This results in the Gumbel statistics of the roughness [15, 16, 25, 27]:  $W_G$  (~) =  $e^{x}$ ); where  $x = K (\sim 1)$ K exp(x and = 0.577is the Euler constant. This provides the analytical proof of the conjecture made in Ref. [15], that the distribution function in this case is given by one of the extrem e value statistical distributions, the Gumbel function [26].

In what follows we perform simulations of W () with




FIG. 3: D istribution functions of the normalized interference am plitude W (~) for a 1D Bose gas with open boundary conditions at nonzero temperature and K = 5:Dierent curves correspond to ratios K  $_{\rm T}$  =L = 1 (solid); K  $_{\rm T}$  =L = 1 (dotted); and K  $_{\rm T}$  =L = 0:25 (dashed):  $_{\rm T}$  is the thermal correlation length, K is the Luttinger parameter, and L is the imaging length.

up to N =  $10^6$   $10^7$  realizations of  $ft_fg$  and sm oothen the data. We use a nite value of  $f_{max}$  and check for convergence with  $f_{max}$ ; typically 30:h i is always kept within 1% from its expected value. For most of the presented results, all eigenvalues G (f) are negative, and Eq. (9) can be directly applied. Special care should be taken of the 1D case with nonzero temperatures, since one of the eigenvalues can be positive. This situation can be handled by subtracting a sulciently large positive constant C from G (x; y; T=L); which makes all eigenvalues negative. A coording to Eqs. (2) and (3), this leads to rescaling of by a factor  $e^{C=K}$ ; which can be easily taken into account.




FIG. 4: Distribution functions of the normalized interference amplitude W (~) for a two-dimensional Bose gas with the aspect ratio of the imaging area equal to unity and open boundary conditions. Temperature is below the Berezinskii-K osterlitz-Thouless (BKT) transition temperature. Dierent curves correspond to  $(T) = {}_{c}(T_{c}) = 1$ =4 (the BKT transition point, solid), (T) = 1=6 (dashed line), and (T) = 1=10 (dotted line). Above the BKT transition temperature the distribution function is Poissonian (dot-dashed line).

In Fig. 2 we show distribution functions of the norm alized interference am plitude W (~) at T = 0 for 1D gases with OBC for various K: The inset shows a comparison between OBC and PBC for K = 5: In Fig. 3, we show distribution functions of the normalized interference am plitude for a 1D gas with OBC at nonzero temperature and K = 5: For  $_T K = L$ 1 distribution is Poissonian [14, 15, 16] and wide, while for K 1 and  $_{T}K = L$ is very narrow. Evolution of the full distribution function of the visibilities as L is varied can be used to precisely m easure the therm allength  $_{\rm T}$ ; and to extract the tem perature. As seen in Fig. 3, at T & 0 the distribution function has characteristic features, i.e., it is generally nonsym m etric and can have a m in im um . These features can be used to distinguish the intrinsic noise due to uctuations of the phase from technical noise. Finally, in Fig. 4 we show distribution functions of the normalized interference amplitude for a 2D gas with an aspect ratio of imaging area equal to unity and OBC below the BKT tem perature. Above the BKT tem perature, distribution functions becom e Poissonian for L is the correlation length. In 2D one cannot describe the crossover at L sim ilar to 1D, since the action which describes the uctuations of the phase is not quadratic in this region, and Eq. (2) does not hold.

## IV. CONCLUSIONS

To sum marize, we introduced a class of sine-Gordon models, for which an interaction term is present in a spa-

tial region di erent from the dom ain over which the noninteracting part is de ned. We developed a general mapping of such sine-Gordon models and related Coulom b
gases to statistical properties of random surfaces, which
can be used to calculate their partition functions nonperturbatively. As a specie application of our approach,
we considered interference experiments with two independent low-dimensional Bose gases. We calculated full
distribution functions of the interference amplitude for
1D and 2D gases with open boundary conditions and
nonzero temperatures. Full distribution functions of interference fringe visibilities can be used for therm om etry.
