Is it possible to experim entally verify the uctuation relation? A review of theoretical motivations and numerical evidence

Foreword

The statistical mechanics of nonequilibrium stationary states of dissipative systems and, in particular, the large deviations of some specic observables attracted a lot of interest in the past decade. The literature on this problem is enough our and it is impossible to give here a comprehensive list of references.

Part of this interest concentrated on the uctuation relation, which is a simple symmetry property of the large deviations of the entropy production rate (related to the dissipated power). The uctuation relation is a parameterless relation and is conjectured to hold in some generality. The discovery of this relation [1] motivated many studies: and experiments specifically designed to its test have been reported on turbulent hydrodynamic ows [2, 3, 4] and Rayleigh-Benard convection [5], on liquid crystals [6], on a resistor [7], on granular gases [8].

Unfortunately, despite this great experimentale ort, the situation is very confused, more than ten years after [1]. After many debates, numerical simulations established that the relation holds very generally for reversible chaotic dissipative systems: while experiments gave promising results but revealed also some diculties in the interpretation of the data that generated many controversies.

Indeed, the apparent generality of the uctuation relation led to the idea that it could be tested \blindly" just by measuring the uctuations of the injected power in some dissipative system. On the contrary, experience revealed that to test this relation one has to face many disculties, and that each experiment has to be interpreted by considering its own speci cities.

M oreover, when applying the theory to a real physical system, one should obviously keep in m ind that the real system does not coincide exactly with the mathematical model we use to describe it. So that, even if we expect that the theory will work for the mathematical model, its application to the description of the experiment might require further e orts.

The aim of this paper is to review some of these disculties, discovered in more than one decade of trials, in the hope that new experiments will be performed allowing to clarify many aspects that are still poorly understood.

However, before turning to this discussion, it is important to review the theoretical developments that generated the current interest in the uctuation relation. Indeed, this relation is the most accessible prediction of a much more deep theory, and discussing this theory in some detail will be very useful for the interpretation of the experiments.

Iw ill focus on the stationary state (or G allavotti-C ohen) uctuation relation. There are other uctuation relations, such as the (E vans-Searles) transient uctuation relation, the Jarzynski equality, and the C rooks uctuation relation, which hold in much more generality. These relations have found many interesting applications in dierent elds, for instance biophysics of large molecules. However they are not directly related to the ideas discussed here. A review of these relations is beyond the scope of this paper.

Everywhere in the paper I will only discuss the main ideas, giving references to the original literature for more detailed discussions.

1 W hy should we test the uctuation relation?

1.1 De nitions

To begin, we will x some notations. We will consider a dynamical system described by a set of state variables $x = (x_1; x_1)$; and evolving according to the equation of motion x = F(x). A trajectory of the system generated by an initial datum x_0 will be indicated by x(t), while segments of trajectory of duration will be indicated by x(t), i.e. x(t) = fx(t); the proof of the state x, x_0 , x_1 , x_2 we will indicate the average over a segment of trajectory by

and sometimes we will use the shorthand notations 0 (t) 0 (x (t)), and 0 0 [x (t)], so that

1.2 The uctuation relation

The uctuation relation was rst introduced in [1]. There, a system of Lennard-Jones (like particles subject to a dissipative force (inducing shear ow) and to a therm ostatting mechanism was investigated. The aim was to test the conjecture that the nonequilibrium stationary state reached by the system after a transient could be described by a probability distribution over the segments of trajectory x (t) having the following form 1 :

In the latter expression, $_{u}$ [k] (t)] is the expansion factor over the trajectory, related to the sum of all positive Lyapunov exponents computed on the segment $_{p}$ x (t) (see Appendix A for a precise de nition of all these quantities). The normalization factor is $Z = _{x(t)} _{u} ^{1} [k]$ [k]. The proposal (3) originated from earlier studies of chaos and turbulence [9] and from periodic orbit expansions [10]

C learly a discretization in the \space of trajectories" x (t) is needed to give a precise m athem atical sense to the expression (3). This problem is highly non trivial: a theory leading to an invariant m easure of the form (3), based on m arkov partitions to discretize phase space, m as developed in [11, 12, 13, 14, 15, 16, 17, 18, 19], see also [20, 21, 22, 23, 24] and in particular [25, 26] for less technical discussions and [27] for a nice recent review of this problem. In this context the m easure (3), seen as a m easure on phase space² (m), is called Sinai-Ruelle-Bowen (SRB) m easure.

The system studied in [1] was described by reversible equations of motion. Then, it is straightforward to show [1, 17, 18, 19] that, if Ix (t) is the time-reversed of x (t),

using the symmetry properties of the Lyapunov exponents under time-reversal, i.e. $_{i;+}^{P}$ $_{i}[Ix(t)] = _{i;+}$ $_{i}[x(t)]$, see Appendix A.

In (4) the phase space contraction rate $[k(t)] = \bigcap_{i=1}^{p} [k(t)]$, equal to m inus the sum of all Lyapunov exponents, appeared. This quantity can be easily measured in a numerical simulation, as it is possible to show (Appendix A) that

i.e. (x) is m inus the divergence of the right hand side of the equation of m otion. Its average is $_+$ h (x)i = h [x (t)]i. An in nitesimal volumed x will evolve according to $\frac{d}{dt}dx = (x)dx$.

It is possible to compute the probability of observing a value [x(t)] = Pf[x(t)] = g.U sing (4) and [x(t)] = [x(t)], we get

 $^{^1}$ The expression (3) has to be intended in the following sense: if one is able to generate M segments $x_i(t)$; i=1; of trajectory of duration with uniform probability, then the average of an observable 0 [k(t)] which is a functional of the trajectory can be computed as $\sum_{i=1}^{M} 0$ $[k_i(t)]$ fx i(t) g= $\sum_{i=1}^{M} fx_i(t)$ fx i(t) g. The time-reversibility of the dynam ics and the assumption (3) imply that P () should verify the symmetry relation (6), which is a stream ple of a uctuation relation and was observed to be true in the numerical simulation of [1].

Som e rem arks are in order at this point.

- 1. Eq. (3), and consequently (6), are the leading contributions to the probability for ! 1, but for nite corrections are present.
- 2. As it will be discussed in detail in the following, if [k(t)] is unbounded a more complicated analysis is required; thus it is convenient for the moment to restrict the attention to systems such that [k(t)] is bounded.
- 3. It can be proven that $_{+}$ 0 under very general hypotheses [28]. Moreover, if $_{+}$ = 0 the SRB measure (3) reduces to the volume measure³ and the system is at equilibrium. The relation (6) reduces to P () = P (). Thus in the following we will assume that $_{+}$ > 0 and in this case the system will be called dissipative [25, 27]. In this case volumes will contract on average and the SRB measure will be concentrated on a set of zero volume in phase space.

Under these hypotheses, de ning the normalized variable $p = [x(t)]_{+}$, we expect that for large the probability of p will be described by a large deviation function, i.e. that⁴

As is bounded, p is also bounded and for ! 1 we have pj < p; the value of p can be easily identified as we expect that $_1$ (p) = $_1$ for pj > p, i.e. deviations bigger than p have zero probability $_1$ in the lim it $_1$ 1.

Using (6) and (7) we get the following relation [17, 18, 19]:

De ning the large deviation function $_1$ (p) = $\lim_{t \to 1} \frac{1}{t} \log \mathbb{P}$ ([x (t)] = p $_+$)], and p as the maximal value of pj for which $_1$ (p) > $_1$, we have

We will refer to the proposition above as the uctuation relation. The two conditions that is large and that p is bounded are often misconsidered but are very important and should not be forgotten [19] if one wants to avoid erroneous interpretations of (8).

By looking at the sketchy derivation in (6), one realizes that the uctuation relation can be extended in the following way. Consider an observable $0 \ [x \ (t)]$ that is even or odd under time reversal, i.e. $0 \ [x \ (t)] = 0 \ [x \ (t)]$, and the normalized variable $q = 0 \ [x \ (t)] = 0 \ [x \ (t)] = 0 \ [x \ (t)]$

stationary state. Consider the joint probability P (p;q) exp $_1$ (p;q). One can show [29, 30] that

and the sign in (9) must be chosen according to the sign of 0 under time reversal. Eq. (9) can be extended to any given number of observables having denite (eventually dierent) parity under time reversal.

The uctuation relation attracted a lot of interest after [1] because it is a parameter-free relation that might hold in some generality in nonequilibrium systems. For this reason in the last decade it has been numerically tested on a lot of dierent models, often with positive result, and sometimes with negative or confusing results. In experiments the situation is complicated by the presence of many noise sources and by the diculty to not a good modellization of the system under investigation.

One should keep in m ind that, at least in this context ⁶, the main theoretical motivation to study the uctuation relation, that was already at the basis of the work [1], is to obtain some insight on the measure

describing stationary states of nonequilibrium system. This is clearly a very large class and it is possible to not nonequilibrium systems displaying any kind of strange behavior. We wish to identify a class of nonequilibrium systems such that the uctuation relation holds in their stationary states.

1.3 The \transient uctuation relation"

Subsequently after [1], it was noted that an apparently similar uctuation relation holds in great generality. Namely, we can consider, instead of segments of trajectory drawn from the stationary state distribution, segments originating from initial data extracted from an equilibrium distribution (e.g. the microcanonical one). In other words, we extract initial data according to an equilibrium distribution and then evolve them using the dissipative equation of motion. If the equations of motion are reversible, it is possible to show that, if x(t); t 2 [0;] is the trajectory starting from $x_0 = x(0)$ extracted with the equilibrium distribution one has [31]

The latter relation has been called transient uctuation relation and is very easy to prove: it follows from the de nition of , see Appendix B. It holds in great generality, not only for the microcanonical ensemble but form any other equilibrium ensembles, see [32] for a review 7. The fundamental dierence between (10) and (8) is that in the former trajectories are sampled according to the equilibrium distribution of their initial data, while in the latter they are sampled according to the nonequilibrium stationary state distribution 8.

Then one can ask whether the uctuation relation (8) can be derived starting from (10). Naively one could take the limit! 1 of (10), claim that the initial transient is negligible and assume that (10) holds also for the stationary distribution. However, this is not at all trivial. Depending on the properties of the system, the probability $P_{\rm eq}$ m ight not converge to a well dened probability distribution in the limit! 1, or the convergence time might be very large (practically in nite), and so on.

Even if $^{1}\log P_{eq}$ (p $_{+}$) converges fast enough to a smooth limiting function $^{e_{1}}$ (p), which will verify the uctuation relation by (10), the latterm as be different from the true function $_{1}$ (p) describing the stationary state [33]: indeed the measure (3) is concentrated on a set of zero volume in phase space if $_{+}$ > 0, and making statements on a set of zero measure starting from a set of initial data extracted according to the volume measure might be very difficult. We will give examples in section 4.

Understanding in full generality what are the conditions that allow to extract the uctuation relation (8) from the transient relation (10) seems to be a dicult task and is for the moment an unsolved problem. To simplify the problem and try to understand its main features, we can, following [17, 18], restrict our attention to a class of simple dissipative systems for which the uctuation relation can be rigorously proved whithout making reference to (10), but directly from the invariant measure (3).

1.4 A nosov systems and the uctuation theorem: a proof of the uctuation relation

In [17,18] a proof of the uctuation relation was given for A nosov systems. The rigorous mathematical proof for A nosov maps (discrete time) is in [19], while the proof for A nosov ows (continuous time) has been given in [34].

A nosov system s are paradigm s of chaotic system s. A precise m athem atical de nition is in Appendix C. Roughly speaking, they are de ned by a compact manifold M (phase space) and a smooth (i.e. at least




Figure 1: A pictorial representation of an Anosov system . In the vicinity of a point x 2 M $\,$ it is possible to draw two families of manifolds M s,u . The manifolds passing through x are the stable and unstable manifolds of x, M $^{s,u}_{x}$. Under the action of S, the manifolds M $^{s,u}_{x}$ are mapped into the manifolds M $^{s,u}_{Sx}$ passing through Sx. A point y 2 M $^{u}_{x}$ is mapped into a point Sy whose distance from Sx is larger by a factor , while a point z 2 M $^{s}_{x}$ is mapped into a point Sz which is closer to Sx by the same factor .

twice di erentiable) map S(x) acting on $x \ge M$ (the dynamics), having the following properties, see Fig. 1 for an illustration:

- (1) A round each x 2 M $^{\rm s}$ it is possible to draw two smooth surfaces M $^{\rm u}_{\rm x}$ and M $^{\rm s}_{\rm x}$ such that points y 2 M $^{\rm s}_{\rm x}$ approach x exponentially while points y 2 M $^{\rm u}_{\rm x}$ diverge exponentially from x under the action of S (existence of the stable and unstable m anifolds);
- (2) the rate of convergence (divergence) on the stable (unstable) manifold is bounded uniformly on M (uniform hyperbolicity);
- (3) the surfaces M $_{x}^{s,u}$ vary continuously w.r.t. x, and the angle between them is not vanishing; under the action of S the surfaces M $_{x}^{s,u}$ are m apped into the corresponding M $_{S\,x}^{s,u}$ (sm oothness of the stable and unstable m anifolds);
- (4) there is a point x which has a dense orbit in M (the attractor is dense). In this case the system is called transitive.

In particular, 1) ensures that the system is chaotic; 2), 3) ensure that the system is smooth enough so that the measure (3) is well de ned; and 4) ensures that the attractor is dense on M so that there are no regions of nite volume that do not contain points visited by the system in stationary state. Note that as M is compact and S(x) is smooth, it follows that [x(t)] is smooth and bounded, as we assumed above.

For A nosov system s it can be shown, by explicitly constructing a M arkov partition [11, 12, 15, 24], that, if the initial data are extracted from the uniform distribution over M (i.e. the m icrocanonical distribution), the system reaches exponentially fast a stationary state described by the m easure (3), which is called Sinai-Ruelle-Bowen (SRB) measure. The function $_1$ (p) exists and it is analytic and convex for $p_1 [11, 12, 15]. If the system is transitive, dissipative (<math>_+ > 0$) and reversible, $p_1 = p_2 = p_1$ and $p_2 = p_2$ are uncutation relation [17, 18] in the form (8). This is the Gallavotti-Cohen uncutation theorem.

M oreover, in this case the function $^{1} \log P_{eq}$ (p $_{+}$) converges to the limiting large deviation function $_{1}$ (p) describing the stationary state and satisfying the uctuation theorem.

1.5 Stochastic systems (in brief)

A Itematively, one can consider a stochastic model for a dissipative system. This was rst done by K urchan [35], who considered a Langevin system in presence of a dissipative force. He showed that Eq. (10) holds also in this case for any nite time, and studied the conditions under which it converges to a well defined limiting distribution. It turns out again that the main requirements are some smoothness properties (see also [36] for a discussion) and the existence of a gap in the spectrum of the Fokker-Planck operator. The latter requirement implies that the probability distribution describing the system converges exponentially fast to the equilibrium distribution and that correlation functions decay exponentially, and can be considered as the counterpart of chaoticity in Langevin systems. In the context of stochastic systems, the uctuation relation was also derived by Lebow itz and Spohn for discrete M arkov processes [37]. Extensions and different perspectives were given by M aes [38], C rooks [39], B ertini et al. [40, 41], D errida et al. [42], D epken [43]. The discussion of the stochastic case would require much more space but is beyond the scope of this paper.

1.6 The chaotic hypothesis: a class of nonequilibrium stationary states verifying the uctuation relation

The general features that are behind all the existing derivations of the uctuation relation are the following:

- 1) Reversibility: the equations of motion should be reversible. This is the sym metry that is at the basis of the uctuation relation, as it is clear from the derivation in (4), (6);
- 2) Smoothness: the system must be smooth enough, and in particular the phase space contraction rate is assumed to be smooth and bounded; this ensures that p is well de ned⁹ and bounded and that it exists a value p such that $_1$ (p) = $_1$ for pj > p;
- 3) Chaoticity: the system must be chaotic in the sense of having at least one positive Lyapunov exponent (for determ inistic systems) or of having a gap in the spectrum of the Fokker-Planck operator (for Langevin systems); chaoticity in plies that the stationary state is reached exponentially fast and that the function $\log P_{eq}$ (p₊) converges to a limiting distribution 1 (p);
- 4) \E rgodicity" (or transitivity): by this we mean that the attractor should be dense in phase space, i.e. that the system must be able to visit any nite volume of its phase space in stationary state. The reason why this property is important will be discussed below. This property can be checked, for instance, by looking at the Lyapunov spectrum, see [44, 45] and references therein.

All these ingredients seem to be important for the uctuation relation to hold. It is worth to remark that properties 1)-4) cannot, obviously, be directly tested in an experiment. As often in physics, we are here making hypotheses on the mathematical properties of a model that we assume is able to describe the system under investigation. From these hypotheses, we then derive some consequences, in the form of relations between observables (e.g. the uctuation relation), and only the latter are accessible to the experiment.

As far as I know, for all investigated models satisfying 1)-4) the uctuation relation has been successfully veri ed. On the other hand, exam ples are known of systems violating at least one of the conditions above and for which the uctuation relation does not hold. If one of the requirements above is violated a case-to-case analysis is needed.

However, it is likely that experimental systems are described by models that violate some of the requirements above, in particular the smoothness and ergodicity requirements. It is then interesting to investigate in more detail what happens in these cases to see if, under less restrictive hypotheses, we can still draw some general conclusions on how the uctuation relation will be modified.

In this context, a chaotic hypothesis has been proposed by Gallavotti and Cohen [17, 18]: it states that, even if hypothesis 1)-4) cannot be proven to be satis ed in a strict mathematical sense, for the purpose of

com puting the averages of som e particular observables of physical interest, still the system can be thought as an Anosov system and its invariant measure can be assumed to be given by Eq.(3).

It is worth to stress that, even if we accept the chaotic hypothesis, we should take care in drawing consequences from it. The violation of one of the hypotheses above will be observed if one chooses a suitable observable, e.g. by probing motion in extreme regimes (for example, looking at very large deviations of , in a sense to be made precise below). Thus, in applying the chaotic hypothesis to a given system, one must take into account its peculiarities to avoid contradictions, in the same way one uses the ergodic hypothesis for equilibrium systems: see [27] for a review.

In the following, we begin by reviewing the evidence in favor of the validity of the uctuation relation for system that do not violate hypothesis 1)-4) in a substantial way; at the same time we will discuss some discustives that are encountered when trying to experimentally verify the uctuation relation. Then we will discuss some classes of systems in which one among 1)-4) is not true and discuss what m ight happen in these cases.

2 Veri cation of the uctuation relation in reversible, sm ooth and chaotic systems

First of all, we wish to discuss the discuss that are intrinsically present if one wishes to test the uctuation relation. At the end of this section, we will review the numerical simulations that attempted to verify the uctuation relation in systems that are not proven to satisfy requirements 1)-4) of section 1.6, but at least do not seem to violate them in a substantial way.

So let us assume for the moment that the system under investigation veriles the hypotheses of the uctuation theorem (for instance, it is a reversible Anosov system), but we want to test the uctuation relation numerically (to debug our program).

The main problem is that to test Eq. (8) we need to observe (many) negative uctuations of for large . To be precise, one should construct the function $(p) = \frac{1}{2} \log P$ (p $_+$) and check that it is independent of in a given interval of p. If this interval contains p = 0, one can test the uctuation relation in this interval. This is very important to guarantee that preasymptotic e ects can be neglected.

In general, will be proportional to the number of degrees of freedom (it is extensive). The system has to be dissipative, i.e. the average $_+$ must be positive, otherwise the uctuation relation is trivial. This means that the maximum of P () (or equivalently of the function (p) de ned above) will be assumed close to $_=$ $_+$ (or p = $_+$ = 1). 2.1 Entropy production rate

In m any m odels of dissipative system s it turns out, by explicit computation, that the phase space contraction rate is given by the power dissipated into the system divided by its temperature, i.e. it can be identified.

with an entropy production rate [47]. This is crucial to de ne an experimentally observable counterpart of the phase space contraction rate, if one wants to test the uctuation relation.

The theoretical discussion of this identication is beyond the scope of this paper. So we will take a more practical point of view. A ssume, as in section 1.6, that we are able to build a model that we believe is able to describe the experimental system we wish to investigate. We can then compute the phase space contraction rate for this particular model. If this quantity turns out to be measurable in the experiment, we can use it to perform a test of the uctuation relation. O therwise, if the phase space contraction rate does not correspond to an observable quantity, we cannot use this system to test the uctuation relation. However, this seems not to be the case at least for the models that have been considered in the literature: it always turned out that the phase space contraction rate could be identied with a measurable entropy production rate [47].

A coepting this identi cation, we can now give a quantitative estimate of the probability in (12) in a physical example. Consider an experiment done on a resistor; we apply a eld E and measure the current J owing trough the resistor. The dissipated power is E J and the entropy production is E $J=k_B T$, where T is the temperature of the resistor. We average this quantity over a time to obtain

It is clear that the probability of observing a spontaneous reversal of the current must be very small. Let us estimate it using equation (12). We consider a resistor with R = 1 k , a current I = 1 m A , and an observation time = 1 s, at temperature T = 300K and with a microscopic time (i.e. the time between two collisions of electrons in the resistor) $_0$ 10 $_0^{13}$ s. which is clearly too small to be observed in an experiment.

N evertheless, Eq. (12) suggests som e possible strategies to enhance negative uctuations: 1) reduce the observation time; 2) consider a smaller system; 3) reduce 0. Unfortunately, 1) is limited by the fact that the uctuation relation holds only for large , i.e. 0; so we can reduce , but at best we can use if we do not want to observe nite e ects [48, 49]. Note also that in experiments is strongly constrained by the acquisition bandwidth. In any case, given that in our example N₀ 10° , even with = $_0 = 10^{\circ}$ we will not gain much. Reducing the system size is a very good idea (but might be di cult in experiments): for this reason numerical simulations to test the uctuation relation are usually done for systems of N < 50particles. However, in some cases we might be interested in large systems if we want to test the chaotic hypothesis, as the deviation from Anosov behavior might be more evident in small systems. Finally, we m ight try to reduce the entropy production in the system. This can be done by reducing the strength of the applied eld (the electric eld in our example). There is a problem however: in the lim it of small dissipation, the uctuation relation reduces to the G reen-K ubo relations that are well known from linear response theory [50, 51]. Therefore our experimental test of the uctuation relation will reduce to a trivial test of linear response theory, up to 0 (E²) corrections. We will discuss the relation between uctuation relation and G reen-K ubo relations in the following section.

2.2 Gaussian uctuations and the Green-Kubo relation

The fact that the uctuation relation reduces to G reen-K ubo relations in the small E limit is disturbing for the purpose of testing the former, but is an important check of the consistency of the theory. Indeed, a good statistical theory of nonequilibrium stationary states should reduce to linear response theory in the limit of small dissipation. The relation between the uctuation relation and G reen-K ubo relations has been discovered in [29, 30]: in the following we will closely follow the original derivation of [29].

2.2.1 The large deviation function of close to equilibrium

C lose to equilibrium the istantaneous entropy production rate has the form (t) = EJ (t) [51, 52], as discussed above, where E is the driving force and $J = J = (k_B T)$ is the conjugated ux, see Eq. 2.3 Sum mary and a review of numerical results

We have seen that even in the case of systems that are guaranteed to verify the uctuation relation, a num erical or experim ental test m ight be dicult. This is due to the fact that:

if we wish to verify the uctuation relation indipendently of linear response theory, we have to apply a large eld, such that the nonlinear terms in (19) are visible for p=0; otherwise, if the function p=0, the uctuation relation reduces to the G reen-K ubo relation;




Figure 2: Two examples of the function $_1$ (p) measured in a numerical simulation [49]. Open circles: $_1$ (p). Filled squares: $_1$ (p) + p + . There are no free parameters. A Gaussian t close to p = 1 is reported as a full line. Deviations from the Gaussian are seen close to p = 0. In the inset an enlargment of the region where circles and square overlap, allowing for a test of the uctuation relation, is reported. It was checked [49] that in this interval of p the function (p) did not depend on , so that it is equal to the true limiting function $_1$ (p). (Left) N = 8 Lennard-Jones particles in d = 2 subject to a constant force (electric eld) with periodic boundary conditions and with a reversible Gaussian therm ostat. (Right) Similar system with N = 20 and d = 3. See [49] for details on the simulation.

however, if E is large, j (0) j/ \vec{E} is also large, and the probability to observe negative events becomes very small;

the system size must be small, otherwise again j (0) j/N is large: this can pose problems if we expect the uctuation relation to hold only for large enough N;

the time m ust be large enough for having an interval of p where the function (p) does not depend on ; but if is too large, again negative values of p are less probable and the interval m ight not contain p=0.

Despite these di culties, many attempts were made to test the uctuation relation in numerical simulations of smooth enough, chaotic and reversible systems which were not guaranteed to strictly satisfy the requirements of section 1.6 [1, 48, 53, 54, 55]. Unfortunately in most of these tests the distribution P() was found to be Gaussian. However these works were very useful for the development of the theoretical concepts discussed in the previous section, that were largely motivated by the numerical results.

In [49] it was noted that, using Eq.s (19) and (20), it turns out that the non G aussian term in (19) is proportional to $J_1^{(3)}E^3$ (p $I_1^{(3)}$; this suggested that, keeping xed E to have a small I_1 , one could increase the non G aussian tails of I_1 (p) by increasing $J_1^{(3)}$, which is related to the nonlinear part of the transport coe cient. In a uid of Lennard-Jones like particles, the nonlinear response is observed to increase on lowering the temperature: this fact was exploited in [49] where it was possible to verify the uctuation relation in a numerical simulation on a non G aussian I_1 (p), see gure 2. Note that even if the parameters were carefully chosen, the nite corrections to the function I_1 (p) had to be taken into account to extract the correct asymptotic behavior for large I_1 . In particular in the case of asymmetric distribution the rst order correction for large I_1 is a shift of p. Thus one can reduce the error by shifting p in such a way that the maximum of I_1 (p) is assumed in p = 1, as we expect in the limit I_1 ! 1. See [49, 55] for a detailed discussion.

This problem is specied of systems which admit a natural equilibrium state and are driven far from equilibrium by some perturbation, such as a Lennard-Jones uid. There are however systems (e.g. the Navier-Stokes equations) such that one cannot reach an equilibrium state by tuning some parameter. For these system there is no obvious linear response theory, and a test of the uctuation relation is stringent even if the distribution is found to be Gaussian. In the case of a reversible version of the Navier-Stokes equations (to which the chaotic hypothesis can be applied), successful numerical tests of the uctuation relation were performed in [56, 57, 58].

The num erical results cited above strongly support the claim that the chaotic hypothesis can be applied to systems verifying the requirements of section 1.6. Moreover a new very ecient method to sample large deviations has been proposed in [59] and applied to test the uctuation relation in some systems belonging to this class, with very promising results.

3 The e ect of singularities: non-sm ooth system s

Despite these successes, a number of simulations performed using dierent ensembles found apparent violations of the uctuation relation, see e.g. [60] and references therein. These violations where later recognized to be due to the presence of singularities of the Lennard-Jones potential used in the simulation, that were a ecting the measurements in a subtle way [61, 62, 63]. In a system of particles interacting through a Lennard-Jones potential, the potential energy can be arbitrarily large if two particles are close enough to each other. If energy is conserved, this cannot happen, but it can happen, for instance, if only the kinetic energy is kept constant. This is why violations were observed only when using the isokinetic therm ostat.

Consider the power injected into the system by the external forcing, W (t), and the heat per unit time, Q (t), dissipated by the therm ostat. Energy conservation in plies Q (t) = W (t) E-(t), where E = K + V is the total energy. Thus if the latter is conserved, Q = W , while if kinetic energy is constant, Q (t) = W (t) V-(t), where V (t) is the potential energy in the system . The entropy production rate, (t), can be de ned as W (t) = W (t)=T or as Q (t) = Q (t)=T; there is no a priori reason for choosing one of the two de nitions. The di erence is a total derivative that has zero average in stationary state, so the average $_+$ is una ected by the choice.

If one considers a m icroscopic model of the system, it turns out that the phase space contraction rate, as computed from the equations ofmotion, can be given by any of the two denitions above, depending on which metric one uses to measure distances in phase space. In fact, the phase space contraction rate is dened with respect to a given metric (x)dx and if one switches from (x) to (x)e $^{'(x)}$ the phase space contraction rate is changed by $^{\prime}$, see Appendix A. For instance, in the case discussed above, the phase space contraction rate is given by W (t)=T if one considers the contraction of the measure (p;q)dpdq = e $^{V(q)}$ (K (p) 3N T = 2)dpdq, (p;q) being the momenta and positions of the particles, and by Q (t)=T if one considers the contraction of the volume measure dpdq.

What is the elect of the total derivative V-? If we consider the integrated variables,

If V (q) is a bounded function, \dot{y} (q) j B, the di erence vanishes as 1= for large . This happens uniform ly on phase space and it follows that the large deviation functions of W and Q are equal. Thus, for what concerns asymptotic statements such as the uctuation relation, the two de nitions are equivalent. The uctuation relation does not depend on the measure one chooses to compute the phase space contraction rate, as anticipated in section 1, as long as is smooth and bounded.

3.1 The e ect of an unbounded total derivative

Let us now see what happens if the function V is not bounded. The e ect of an unbounded total derivative term was rst discussed in [61] and [64, 62]. Extensions were discussed in [63, 65, 36, 66]. Here we will follow




Figure 3: The case of exponential tails. In this case $_{\mathbb{W}}$ (p) = $\frac{(p-1)^2}{4}$ veri es the uctuation relation for $_{+}$ = 1, and A = 1, hence P (v) = e $_{-}^{\mathbb{V}}$. The corresponding function $_{\mathbb{Q}}$ (p) coincides with $_{\mathbb{W}}$ (p) only for p 2 [1;3], and does not verify the uctuation relation for p > 1 [62, 7].

and extend the derivation in [63]. As part of the computation is unpublished, all the details are given in Appendix D.

In brief, total derivative term s w ith superexponential tails are irrelevant, while exponential tails give a nite m odi cation of $_{\mathbb{Q}}$, and subexponential tails give $_{\mathbb{Q}}$! 0 for all $p_{\mathbb{Q}}$. This m akes evident that total derivatives m ight have a dram atic e ect.




Figure 4: The case of power-law tails. $_{\rm W}$ (p) is as in Fig. 3, while f (v) = 2 log (v), i.e. P (v) $_{\rm V}$ 2 . The function $_{\rm Q}$ (p) is reported for = 3;10;30. In this case for ! 1 , $_{\rm Q}$ (p) ! 0. The uctuation relation (right panel) is veri ed only for small p at small . For = 30 one has p > 0 and the uctuation relation is never veri ed. Note the similarity with the curves in Fig.3 of Ref. [4].

A ssum e for instance that in the previous example the function $_{\mathbb{W}}$ satis es the uctuation relation. If V has exponential tails, from Eq. (34) it follows that the function $_{\mathbb{Q}}$ satis es the uctuation relation only for $p_{\mathbb{Q}}$ min (p $_{\mathbb{Q}}$ p), while for large p the function $_{\mathbb{Q}}$ (p) $_{\mathbb{Q}}$ (p) const, see Fig. 3 for an example. Even worse, in the case of subexponential or power-law tails, $_{\mathbb{Q}}$ satis es the uctuation relation only for $p_{\mathbb{Q}}$ p, with p ! 1 for ! 1. Thus for large enough the uctuation relation is violated for all p, see Fig. 4, and $_{\mathbb{Q}}$ (p) $_{\mathbb{Q}}$ (p) ! 0. It is interesting to remark that if $_{\mathbb{W}}$ is convex, $_{\mathbb{Q}}$ is not if the tails are subexponentials.

The case of exponential tails is particularly relevant because in m any cases v / V(q), the potential energy, whose distribution has tails e V , i.e. exponentials. Cases in which the tails are subexponentials m ight be also relevant for experiments: for instance the anomalous tails in [4,5,8] m ight be explained by this computation.

3.2 Removing unbounded total derivatives

The conclusion of the previous section is that terms that are apparently small may a ect dramatically the large deviations of in presence of singularities. Still the two denitions of entropy production rate seem a

priori equivalent from a therm odynam ic point of view, and have the same average $_{+}$ and the same m oments $h^{k}i$ for any nite k (the moments being related to derivatives in p=1 of $_{1}$ (p)).

How can we identify a priori the correct microscopic de nition of , satisfying eventually the uctuation relation? A possible prescription has been discussed in [63] and is based on the proof of the uctuation relation for continuous-time systems given in [34]. The proof is based on a Poincare's section mapping the continuous-time ow into a discrete-time map. One considers a set of timing events: for instance, in a system of hard spheres, the times at which two particles collide, or, similarly, in Lennard-Jones systems, the times at which the total potential energy equals a suitable value V_0 . In such a way the low is reduced to a map, and the proof of the uctuation theorem for maps [19] can be applied. However, the Poincare's section, i.e. the denition of timing events, has to be chosen carefully, in such a way that the resulting map is an Anosov map. This has been rigorously done for Anosov ows in [34].

For realistic systems this is clearly very discult. Anyway, it seems very natural, if the system has singularities, to choose the timing events in such a way that singularities are avoided. For instance, if the potential energy V (t) of the system can become in nite in some points of phase space, one can choose the timing events t_n by V (t_n) = V_0 . In the example of the previous section, Eq. (28), the two de nitions of become equivalent on the Poincare's section. More generally, if singularities are avoided by the Poincare's section, all possible de nitions of the phase space contraction rate (t) dier by a bounded total derivative which gives no contribution in the limit ! 1.

In this way we can remove the ambiguity on the denition of , at least in the \lim it ! 1. Note that this prescription does not guarantee that the phase space contraction for the discrete-time system is bounded. The possible values of the latter quantity are given by

ter quantity are given by

and if (t) is not integrable close to a singularity $_n$ can be unbounded. This happens clearly if (t) / (t $_n$) , < 1, for a singularity $_n$ 2 [$_n$; $_n$; $_n$]. In most interesting applications, e.g. driven Lennard-Jones systems in contact with a thermostat, it is possible to show that $_w$ is bounded on all phase space, so that the singularities come only from the total derivative and are obviously integrable as in (28). In these cases the prescription on the Poincare's section is enough to remove singularities, and if the system veri es the conditions 1), 3), 4) of section 1.6, i.e. it is reversible, chaotic and has a dense attractor, the uctuation relation is expected to hold from the chaotic hypothesis.

3.3 A proposal for data analysis in presence of singular terms

To sum m arize, singularities m ight have in portant e ects but these can be controlled, follow ing the com putation and the prescription of the previous sections.

First of all we note that the presence of unbounded terms is manifested by anomalous tails in $_1$ (p), exponentials or possibily subexponentials. It might also be manifested by the fact that $_1$ (p) is not convex. A to the tails of the measured $_1$ (p) allows to guess the behavior of the tails of the singular term, as the behavior of $_1$ (p) for large p is the same as the behavior of f (v) for large v.

A ssum e that we have perform ed an experiment or a numerical simulation whose output is a very long time trace (t), t2 [0;T], where one has chosen a denition of (t) in terms of work, heat, etc. The usual procedure to verify the uctuation relation is to x a time delay , and integrate (t) over subsequent segments of the trajectory to obtain values of = ${}^{1}\frac{R_{t_0}}{t_0}$ (t)dt. One then constructs the histogram P () and the function 1 (p) which is used to test the uctuation relation.

In presence of singularities, the procedure must be modi ed as follows:

One de nes in a suitable way 5 a set of timing events on the trajectory, t_{n} , such that (t) is not singular for $t=t_{n}$, and that the average dierence between two subsequent timing events is nite, $_{0}=ht_{n+1}$ t_{n} i<1.

One xes a delay k and constructs values of

Then one constructs the histogram $\mathbb{R}(k)$ and the large deviation function k (p) = $k^{-1}\log P_k$ (p +), where k = k i; the latter can be used to test the uctuation relation in the lim it k ! 1.

If the system is reversible, chaotic and has a dense attractor, the function $_k$ (p) should have a nite lim it that will be convex and verify the uctuation relation (8) for large k, according to the chaotic hypothesis.

Then, to check the consistency of the analysis, one can recompute the original large deviation function $_1$ (p). Indeed a guess on the tails of the function $v_{i;f}$ can be done by looking at the tails of the function $_1$ (p), because as we discussed above the two functions have the same tails. Using this guess, one can apply the formulas of section 3.1 and check the self-consistency of the analysis.

The analysis of this section has been con med in some cases by numerical simulations [48, 49, 67], and experimentally [7], and seems promising to interpret recent experiments on turbulent systems [4, 5].

Unfortunately, if is not integrable between two timing events, i.e. (39) is not bounded, at present no general statement can be made. However this seems to be a very pathological case which should not be realized in most physical examples.

4 On the convergence of the transient uctuation relation to the stationary state uctuation relation

As we discussed in the introduction, even if it may seem that the transient uctuation relation implies the uctuation relation for stationary state in the limit ! 1, this is not the case in general. The transient uctuation relation holds in greater generality than the stationary state uctuation relation. In this section wew illdiscuss some examples that will high light the importance of the properties of chaoticity and transitivity (i.e. the property that the attractor is dense in phase space) to ensure the validity of the uctuation relation.

For a system of particles one can for instance de ne as timing events the instants where a (suitably de ned) \collision" takes place. If one is able to identify the source of singularities, i.e. what is the term in the phase space contraction rate that gives unbounded contributions to , better Poincare's sections can be eventually constructed.

As we said in the introduction, chaoticity is important because it guarantees that initial data sampled with respect to the volume measure produce trajectories converging fast enough to the stationary state. Indeed, in experiments the system is often prepared at equilibrium, then the driving force is turned on and the system is let evolve toward the stationary state. If convergence to the stationary state is not fast enough, the observed trajectories might not be representative of the real stationary state, and confusing results may be obtained.

4.1 Exam ples of systems such that P_{eq} does not converge to the stationary state distribution

4.1.1 A sim ple exam ple

A very simple example in which the distribution $P_{\rm eq}$ does not converge to the stationary state distribution has been given in [33]. In this example the transient uctuation relation holds for any nite time , including the ! 1 limit, for $P_{\rm eq}$, but the real stationary state distribution trivially violates the uctuation relation.

The model describes a free particle evolving in two dimensions under the action of a constant force E and of a thermostatting force keeping its kinetic energy constant. If p is the momentum of the particle, its mass is 1 and we $\times p^2 = 1$, the equation of motion are

and introducing the angle by $p \to E = E \cos$, where $E = E \sin w$ we can write the equation for :

The dissipated power is given by W (t) = E p(t) = E cos (t) and is equal to the entropy production rate, the \temperature" p^2 being equal to 1. Note that W (t) = d—d is the phase space contraction rate for Eq. (42).

The equation of motion (42) with initial datum 0 is easily solved,

The distribution $P_{\rm eq}$ () is computed imposing uniform distribution over the inital data $_{0}$. Then, inverting (44) to express s_{0} as a function of $\,$, we have

The stationary state corresponds to = 0, then s = 0 and = E; thus the distribution

trivially violates the uctuation relation.

4.1.2 A nother simple example

In the previous example the stationary state function $_1$ (p) does not exist because $P_{\rm st}$ is singular. One might argue that this pathology is responsible for the dierence between $_1$ and $_1^e$. However this is not the case. Consider as an example $_1^{16}$ a system whose state variable is an independent pair (x;) with evolving according to (42), and x describing a reversible A nosov system. The phase space contraction rate is

with $P_{\rm eq}$ given by (45). Given that both $P_{\rm eq}$ and $P_{\rm eq}^{\rm x}$ verify the transient uctuation relation (10), it follows easily that $P_{\rm eq}$ () veri es the same relation for any nite and consequently the limit distribution $e_1^{\rm eq}$ (p) = $\lim_{n \to \infty} \frac{1}{n} \log P_{\rm eq}$ (p) veri es the uctuation relation. Conversely, the distribution in stationary state is

and, given that $P_{st}^{\,\,x}$ veri es the uctuation relation, it is easy to see that the relation is not veri ed by $P_{st}(\,\,)$, neither for nite nor in the lim it ! 1 (this statement can be checked for instance assuming that $P_{st}^{\,\,x}$ is a Gaussian).

To sum marize, in this example the distribution $^1\log P_{\rm eq}$ () converges fast enough to a limiting distribution $^{\rm e}_{\rm l}$ (p) verifying the uctuation relation. The true distribution $_{\rm l}$ (p) = lim $_{\rm l}$ $_{\rm l}$ $^{\rm l}$ log $P_{\rm st}$ () exists, is analytic, but is different from $^{\rm e}_{\rm l}$ (p) and in particular does not verify the uctuation relation.

This example shows that the limiting procedure involved in passing from the transient uctuation relation to the stationary state uctuation relation is very subtle. In this example nothing seems to go wrong, all the functions are smooth and convergence is fast, but the true stationary state distribution is dierent from the limit of the distribution P_{eq} . This kind of subtlety is peculiar to systems that do not display a chaotic behavior at least on some subset of the state variables 17 , and might be very dicult to detect in a numerical experiment.

4.2 Hidden time scales

The strange behavior of the examples above can be related to the existence of a hidden very large time scale 18 . This time scale can be revealed by adding a small noise term of variance " to Eq. (42). In presence of the noise, the system is able to explore the full phase space and the uctuation relation holds in stationary state for any nite". However, in the limit "! 0, the time needed is " e^{l} ". For " the uctuation

relation is violated, while for "it is recovered. Clearly in the limit"! 0, "! 1 and the uctuation relation is violated for all in stationary state [68].

As a simple example we consider a two-state system described by a spin variable $s_t \ 2 \ f \ 1$; 1g. The initial spin is chosen from P (s_0) / $e^{h s_0}$, then the transition rate K $(s_t; s_{t+1})$ is proportional to $e^{h s_{t+1}} \ ^{J(s_t; s_{t+1})}$, where J(+;) = 1 and J = 0 otherwise, i.e. $J(s;t) = s_{t+1}$. Then the probability of a trajectory $s = (s_0;)$ is given by

ie. the dynam ical system ¹⁹ corresponds to a one-dimensional Ising chain where only pairs (+;) give a contribution 1 to the energy.

De ne the time reversed trajectory s = (s; 0); then

For in nite the transition (+;) is forbidden: therefore, in stationary state only the trajectory s = (+;+; ;+) is possible. Thus P) = (2h) and it does not verify the uctuation relation, as in the exam ples discussed above. Note that transient trajectories of the form (; ;+; ;+) are allowed, if initial data are extracted according to P (s₀) / e^{hs_0} , and the relation (52) holds for these transient trajectories. Then the transient uctuation relation holds for P $_{eq}$ also for = 1 at any nite , and in the lim it ! 1 . This is exactly the same situation we already discussed in section 4.11.

The lim it of very large but nite is particularly interesting: in this lim it, the Ising chain (51) develops a large correlation length. Consider a segment of trajectory of length 'beginning with +. The segment (+; ;+) has probability O (1). Segments ending in the state have at least one interface (+;) which can be everywhere in ', then their probability is 'e . Therefore if one wants to observe a jump (+;) the segment of trajectory must have length 'e . This is the time we need to wait if we want to observe a jump to the state which is needed to observe the uctuation relation. We conclude that if e the uctuation relation will be violated, while if e it will be veried.

In the \lim it ! 1, the \lim e scale diverges and this is why the uctuation relation is violated also in the \lim it ! 1: the \lim its ! 1 and ! 1 cannot be exchanged [68].

4.3 Transitive Axiom C attractors

The system (48) is a particular case of a more generic situation in which the motion of the system on its attractor can be described by a transitive Anosov system. If the system is reversible, and there is a unique attractor A_+ and a unique repeller A (i.e. an attractor for the time-reversed dynamics), the system is called an Axiom C system. Details can be found in [45, 44].

An extended version of the chaotic hypothesis is that, if the attracting set is not dense in phase space, the system can be regarded as an Axiom C system, i.e. the motion on the attracting set is described by an Anosov system, at least for the purpose of computing the physically interesting quantities. The SRB measure describing the stationary state will be given by an expression similar to (3), with the expansion rates computed on the attractor, times a \delta function" enforcing the constraint that the system is on the attractor.

¹⁹The reason why we call (51) a dynam ical system is that the SRB measure becomes a Gibbs measure for an Ising chain when computed on a Markov partition. Therefore (51) is one of the simplest measures of the form (3). A Iternatively one can think to this system as a Markov process.

In such systems, the phase space contraction rate can be written as in (48):

where $_{\rm A}$ (x) describes the phase space contraction rate on the attractor, while $_{\rm 2}$ (x) describes the part which is orthogonal to the attractor. One could then be interested in measuring the uctuation of $_{\rm A}$ (x) to test the extended chaotic hypothesis, that implies that P ($_{\rm A}$) veries the uctuation relation. Unfortunately, in general the attractor will be a complicated manifold and the explicit construction of $_{\rm A}$ (x) might be impossible. In particular, while (x) is related to the entropy production rate, it is not obvious to relate $_{\rm A}$ (x) to an experimentally accessible quantity.

A possible strategy to access $_{A}$ (x), that works under some additional hypothesis, has been proposed in [45, 44]. Unfortunately for the moment a numerical veri cation of this proposal is not possible due to prohibitive computational costs [49], so we will not discuss this matter in more detail here.

4.4 Sum mary

We discussed some examples in which the transient uctuation relation holds but the stationary state uctuation relation is violated. This is due to the fact that (a subset of the) system is not chaotic, and might be related to a diverging \hidden" time scale whose existence can be revealed by adding a small noise [68].

5 Irreversible system s

In the previous section we discussed some possible violation and/ormodi cation of the uctuation relation for systems that violate the requirements of smoothness, chaoticity and ergodicity/transitivity. The last ingredient which is required, as discussed in section 1.6, is the requirement of reversibility. This requirement is crucial: indeed, we see from Eq. (6) that the uctuation relation compares the probability of trajectories x (t) having positive entropy production rate with the probability of their time reversed Ix (t) having negative entropy production rate. If the system is not reversible, nothing guarantees that the latter exist: the entropy production could be always positive and obviously Eq. (6) does not make sense in this case.

5.1 Reversible and irreversible models

W e will now discuss some examples [45, 69, 70] in which one can construct two models, one reversible and the other irreversible, that seems to describe the same physical system. We will see that the result for the large deviation function of the global entropy production rate, $_1$ (p), is very dierent. We will then discuss in what sense the two models might be equivalent.

5.1.1 Reversible Gaussian thermostat and constant friction thermostat

A class of reversible models which is believed to describe nonequilibrium systems are based on Gaussian thermostats. Consider a system of particles described by their position and momenta $(p_i;q_i)$ with equations of motion

Here V (q) is the potential energy of interaction between particles, and F (q) represents an external driving force that does not derive from a potential and injects energy into the system . The Gaussian multiplier (p;q) is defined by the condition that the total energy H (p;q) = $\frac{p_i^2}{2m} + V (q), \text{ or the kinetic tem perature } T (p) = \frac{1}{N \text{ d}} P_{i,m}^{p_i^2}, \text{ are constant. In the form er case one has}$

M odels belonging to this class are often used to model electric conduction 20 , shear ow, heat ow, and so on, see e.g. [51] for a review. The equations (55) are reversible, the time reversalbeing simply I (p(t);q(t)) = (p(t);q(t)).

The phase space contraction rate for this equation is easily computed and gives

where W (p;q) is the power injected by the external force. This result is an example of the identication between phase space contraction rate and entropy production rate we already discussed²¹.

The Gaussian multiplier (p;q) is a quantity O(1) in the thermodynamic limit, and we expect its uctuations to be O(1=N). Therefore, in the thermodynamic limit, we can replace (p;q) by its average = h (p;q)i, in the equation of motion (55):

But if we do this, the new equations are not reversible! M oreover, the phase space contraction rate is now (p;q) = N d and is always positive, so certainly the uctuation relation does not hold for this quantity. We can ask whether the phase space contraction rate of the reversible equations, given by (57) and identified with the entropy production rate, still verifies the uctuation relation if studied using the irreversible equations of motion (58). This is not the case. We have, from the de nition of H,

U sing this relation, Eq. (57) becomes

The rst term is always positive. For large N , the second term averaged over a time is roughly equal to $\frac{1}{hT}\frac{H}{(p)i}$ and will vanish for ! 1 if H is bounded²². Therefore the integral of (p;q) in (57) is always positive for large , and the uctuation relation cannot hold for this quantity.

We conclude that the large deviations of (p;q) are dierent in the two cases, and in the irreversible case do not verify the uctuation relation.

This is not surprising, since (p;q) is a global quantity, and it is well known in equilibrium statistical mechanics that global quantities can have very dierent behavior if computed in dierent ensembles²³.

Instead, the two equations (55) and (58) m ight be equivalent for the purpose of computing properties of local observables, i.e. quatities that depend only on the particles which are in a small box inside the system, in the therm odynam ic lim it. In this case the equivalence m ight hold also for large deviations. We will discuss this point in the following sections.

 $^{^{21}}$ N ote that if instead of xing the total energy we x the kinetic temperature, the value of and change by a term proportional to $\frac{1}{T(p)} \frac{dV}{dt}$. Thus these two ensembles produce equivalent uctuations of , in the them odynam ic limit, only if the potential V is not singular. In presence of singularities (e.g. for a Lennard-Jones potential) one has to apply the prescription discussed in section 3 to remove the singular term. This has been shown in [48]. A discussion of the discussion that one has to face to give a mathematical proof of the equivalence is in [71].

5.1.2 Turbulence and the N avier-Stokes equations

A nother interesting example is the case of the Navier-Stokes equations. These equations are not reversible. However, it has been conjectured in [69, 23] that the Navier-Stokes equations might be equivalent, in some situations, to reversible equations. The equivalence is in the same spirit discussed in the previous section.

Num erical results supporting this conjecture have been given in [56, 57, 58], where the validity of the uctuation relation has been num erically veri ed for the reversible equations.

Note that, an argument similar to the one discussed in the previous section [70] leads to the same conclusion, that the uctuation relation cannot hold for the global entropy production in irreversible Navier-Stokes equations.

5.1.3 The granular gas

The case of granular gases is particularly illustrative. A granular gas is a system of macroscopic particles (typically of radius R $1\,\mathrm{m}$ m and mass m $1\,\mathrm{m}$ g) in a container of side L interacting via inelastic collisions (typically with restitution coe cient r 0.8 0.9) and having a large kinetic energy $\frac{1}{2}\mathrm{m}$ hv 2 i m gR, where g is the acceleration due to gravity. Energy is injected into the system by shaking the box or vibrating one of its sides. This system behaves like a gas of hard particles but dissipation is present due to the inelasticity of the collisions.

The rst experim ent on such a system [8] considered a window of smaller side 'inside the box and measured the ux P of kinetic energy entering the window during a time lapse . The latter seemed to verify a uctuation relation at least for small p = P = hP i. Note that the kinetic energy ux can be written as

$$P = E + D ; (61)$$

where E = E() E(0) is the variation of kinetic energy inside the window, while D is the energy dissipated into the window by inelastic collisions during time.

A very reasonable model for the inelastic collisions between particles [72, 73, 65, 70] is to assume that the velocity component parallel to the collision axis is rescaled by r, in such a way that the relative variation of kinetic energy in the collision is $1 r^2 > 0$. In such a model, the dissipation D is always positive, and phase space always contracts so that 0. It was then recognized [72] that, as D 0 in this model, the uctuation relation cannot hold for P. Indeed, if E were bounded, the large deviation functions of P and D would coincide implying that the probability of observing a negative uctuation of P is zero for large. However, E is not bounded, and its probability distribution has an exponential tail, see the discussion in [65]; the method described in section 3 can be applied and shows that even if D 0, P can have negative uctuations. This explains why such uctuations were observed in [8]. The apparent validity of the uctuation relation observed in [8] is probably explained by the smallness of the interval of p that was accessible to the experiment, in such a way that the function $\frac{1}{2}$ (p) appeared as linear in p.

The conclusion is that the uctuation relation does not hold for the quantities D (obviously) and P (by (61) and the results of section 3), at least if the model for inelastic collisions used in [72, 73, 65] is accepted.

One can easily construct a model of reversible inelastic collisions, in which in a collision particles can gain or loose energy, such that on average energy is lost but the dynamics is reversible 24 . Such a model should give similar results for average quantities but will give a dierent result for the large deviations of P and D, which will now probabily verify the uctuation relation.

5.2 The time scale for reversibility

D i erent models, reversible or irreversible, give di erent results when one computes large deviations of global quantities, and in particular the uctuation relation holds for the reversible models but does not hold for the irreversible ones.

If we want to investigate the uctuations of the global entropy production rate, we have to ask, given a physical system on which we are performing a measurement, what is the more appropriate mathematical model, between the reversible and the irreversible ones, to describe its properties?

Let us discuss this problem for the granular gas we modeled above. It is reasonable that the real system is described, at an atom ic level, by reversible equations of motion (i.e. the New ton equations for the atom s constituting the macroscopic particles). In a collisions, the atom s interact in such a way that kinetic energy of the particles is dissipated by heating the two particles. Morover sound waves can be emitted as the experiment is performed in \sin^{25} . Thus, in principle, it can happen that two particles, while colliding, absorb a sound wave and/or cool spontaneously in such a way that the kinetic energy is augmented by the collision. Clearly, the probability of such a process is very small: it is of the order of exp(N), where N $1\theta^3$ is the number of atom s constituting a particle 26 . Thus, on the experimental time scale $_0 \exp(N)$ one can safely neglect this possibility, the system is well described by the model in which velocity are rescaled by r at each collision, and the uctuation relation does not hold. However, if one could in agine to wait for a time $_0 \exp(N)$, the uctuation relation should be observed to hold. In this case the violation of the uctuation relation is related to a mechanism very similar to the one discussed in section 42, i.e. it is related to an \hidden' diverging time scale (the time scale on which reversibility of the collisions can be observed).

When the time scale needed for observe reversibility is not larger that the experimentally accessible time scales, the system should be well described by reversible models.

5.2.1 A proposal for an experim ent on granular gases

An example of this procedure was discussed in [74]. We considered a two dimensional granular gas contained in a box; the bottom of the box is vibrated while the other sides are xed. This geometry is dierent from the one considered in [8] where the whole box is vibrated.

In this situation, a temperature prole is established in the system; kinetic energy is injected at the bottom and starts to ow trough the system towards the top of the box, being dissipated in the meanwhile by inelastic collisions. The energy dissipated by collisions is again always positive, and obviously cannot satisfy the uctuation relation.

However, one can look to a di erent quantity, namely the ow J of energy through a small portion of the system located between two lines at height h, h + . This quantity is not always positive and cannot be expressed as a positive quantity plus a total derivative, as we did for P in (61). We argued that, in a suitable quasi-elastic limit [74], see also [75], the portion of the system between h, h + can be thought as being equivalent to a system of elastic hard particles in contact with two therm ostats at dierent temperatures T_+ , T_- . This system can be described by a reversible model [74]. This analysis predicts that the uctuation relation should hold for J at least in a suitable quasi-elastic limit. It should be possible to verify experimentally (or at least numerically) this prediction.

5.3 Ensemble equivalence

As we discussed in the previous section, if one looks at global quantities (e.g. in a numerical simulation), the result might depend on the details of the model which is assumed to describe well the system under investigation. In particular, the choice between a reversible and an irreversible model should be motivated by a careful analysis of the involved time scales.

However, this is not so natural. In fact, one of the main results of equilibrium statistical mechanics is that the relation between the interesting observables (pressure, density, energy, ...) are independent of the particular ensemble one chooses to describe the system. And indeed, in a real experiment, it is very dicult to distinguish between the system under investigation and the surrounding environment, and to make a

detailed model of the interaction between them. For instance, one would clearly like that the result does not depend on the details of the particular device one uses to remove heat from the system, and so on.

To avoid such di culties, one should consider the system under investigation as a subsystem of a larger system, including the therm ostats, and show that the relations between the interesting observables of the subsystem do not depend on the details of the model one chooses to describe the whole system. This would also justify the use of phenomenological models like (55), (58), which are clearly unphysical as one assumes that there is a \viscous" term acting on each atom of the uid.

Proving equivalence of ensembles in nonequilibrium is much more dicult than in equilibrium, because in the former case dynamics is important in de ning the ensembles: as the SRB measure (3) explicitely depends on the dynamics of the system. For this reason no exact results are available, but only conjectures [76, 22, 23] and arguments supporting them [71, 77], see in particular [77] for a detailed discussion.

The equivalence between two di erent nonequilibrium ensembles can be de ned as follows. We consider as an example the two models (55), (58); the equations of motion depend on a number of parameters, such as the density of particles, the interaction potential V (q), the external forcing F (q) etc.; having xed these parameters, the model (55) depends on the value of the energy E = H (p;q), while (58) depends on the value of . The corresponding ensembles E_E , E are the collection of the SRB distributions that describe the stationary states of (55), (58) at dierent E or , respectively.

Consider now a volume V_0 inside the container V in which the model is dened, and a set $O(V_0)$ of observables O_{V_0} (p;q) that depend only on the positions and momenta of the particles inside V_0 .

The equivalence of E_E , E means that in the lim it N; V! 1 at xed N=V it is possible to establish a one-to-one correspondence between elements of E_E and E such that the averages of all observables 0 2 0 (V_0) are equal in corresponding elements.

In the case of the two ensembles de ned by (55), (58), the equivalence is supported by the concentration argument discussed above, namely that for N; V! 1 the uctuations of (p;q) in the isoenergetic ensemble vanish, see [71, 77] for more detailed discussions.

5.3.1 A local uctuation theorem

Given the de nitions above, it is natural to try to de ne a local entropy production rate and prove for this quantity a local uctuation theorem. In the example (55), (58), a possible de nition is a local version of (57):

Then, the equivalence conjecture (64), applied to the average of O_{V_0} (p;q) = e V_0 (p;q) (that generates the probability distribution of V_0), in plies that the large deviations function V_0 (p) is the same in the two ensembles, in the thermodynamic limit. In principle this function can satisfy the uctuation relation (8) even if one of the two ensembles is irreversible. This would be a very interesting result. Unfortunately, from

the theoretical point of view the problem is very dicult. A tentative theory has been discussed in [78] and a num erical veri cation on a simple model of coupled maps has been reported in [79].

In numerical simulations of more realistic models, see e.g. [54], the results are much more dicult to interpret. As we discussed in section 2, even in the case of a \perfect" system (i.e. smooth, reversible, and transitive) the veri cation of the uctuation relation is very dicult as long as the number of particles is bigger than 20. Taking the limit of N! 1 means that one should look at a subsystem of 10 particles in an environment of, say, 1000 particles, and this, at present, has prohibitive computational costs. Moreover if the volume V_0 is too small, as required by numerical simulations, one has to take into account nontrivial terms in the entropy production rate, related to the uxes (of particles, energy, entropy) across the surface of V_0 , see [74] for a tentative discussion of this problem.

On the other hand, looking at local quantities is very natural in experiments, see e.g. [2, 3, 5, 8]. However the interpretation of these experiments is not clear for the moment (see [77] for a tentative interpretation of [2]), especially because the relation between the measured quantities and the local entropy production is not straightforward. The presence of large tails in the measured distributions suggests also that unbounded terms are a ecting the measurements; it would be very interesting to try to apply the analysis described at the end of section 3 to these data.

5.4 Sum m ary

The uctuation relation cannot hold, even locally, if the time scale to observe reversibility exceeds the experimentally accessible time scale. Nevertheless, there are system that might be well described by reversible equations of motion, if this time scale is not too large. In these cases the uctuation relation should hold. Clarifying this issue is clearly of fundamental importance to interpret experiments on real nonequilibrium systems.

It is worth to note that even if the uctuation relation does not hold due to irreversibility, this does not mean that the chaotic hypothesis does not apply. If the system is chaotic and smooth enough, still the stationary state should be described by the SRB measure (3). It would be very interesting to derive from the chaotic hypothesis, using the measure (3), other relations, independent of reversibility, that could be tested in experiments.

6 Conclusions

To conclude, we will brie y sum marize the main points discussed in this paper.

- 1. The chaotic hypothesis states that the uctuation relation will be generically veri ed by models that are reversible, smooth, chaotic and transitive.
- 2. For such models, numerical simulations have con med the validity of these predictions.
- 3. A test of the uctuation relation, even in models verifying the hypotheses above, is made dicult by the necessity of observing negative values of p. In particular, one should check that the function $(p) = \frac{1}{2} \log P$ (p_+) is independent of for $p \ge P$. The interval P must contain the origin.
- 4. Negative uctuations can be enhanced by reducing the system size N, the observation time, or the strength of the applied eld. The observation time cannot be reduced arbitrarily because the uctuation relation holds only for $_0$, $_0$ being the characteristic decorrelation time of the system. Eventually we can eliminate some nite corrections, e.g. by shifting p in such a way that the maximum of (p) is assumed in p = 1.
- 5. If the applied eld is so small that the system is close to equilibrium, and if the distribution turns out to be Gaussian over the whole accessible interval in p, we are not verifying the accusation relation, because in this case it is equivalent to the Green-Kubo relations.

- 6. It is important to check not only that $_1$ (p) $_1$ (p) $_1$ (p) $_1$ but also that the proportionality constant is $_1$. The linearity in p could simply be due to the smallness of the accessible interval P.
- 7. The presence of singular terms in (non-smooth systems) can change dram atically the behavior of (p). These terms manifest in anomalous large tails; in these cases the function (p) might not be convex. If these terms are present, one should remove them by applying the procedure discussed in section 3.
- 8. For systems that are not chaotic or not transitive any kind of strange behavior can (and has) been observed. For this reason a test of the uctuation relation is interesting: it supports the validity of the chaotic hypothesis, i.e. that the system is chaotic and transitive (but obviously does not prove these properties).
- 9. If one looks to the global entropy production rate, the uctuation relation will not hold for irreversible systems.
- 10. However, it is possible that dierent models which are globally reversible or irreversible, might be equivalent when observed on a local scale. If this is the case, a local uctuation relation might hold independently of the model (reversible or irreversible) one chooses to describe the system on large scale.
- 11. This is very important for the interpretation of experiments. If the results were found to depend strongly on the details of the model, one would have to take into account all the details of the system, including the therm ostat, etc.

Hopefully new experiments will be able to clarify the many open problems, in particular the last point.
