Few-Body E ects in Cold Atom s and Lim it Cycles

Physical system s with a large scattering length have universal properties independent of the details of the interaction at short distances. Such system s can be realized in experiments with cold atom s close to a Feshbach resonance. They also occur in m any other areas of physics such as nuclear and particle physics. The universal properties include a geometric spectrum of three-body bound states (so-called E m ov states) and log-periodic dependence of low-energy observables on the physical parameters of the system. This behavior is characteristic of a renorm alization group limit cycle. We discuss universality in the three- and four-body sectors and give an overview of applications in cold atom s.

1. IN TRODUCTION

The E ective Field Theory (EFT) approach provides a powerful fram ework that exploits the separation of scales in physical system s. Only low energy (or long-range) degrees of freedom are included explicitly, with the rest param etrized in terms of the most general local (contact) interactions. This procedure exploits the fact that a low energy probe of momentum k cannot resolve structures on scales smaller than R $1=k^1$. U sing renorm alization, the in uence of short-distance physics on low energy observables is captured in a small number of low energy constants. Thus, the EFT describes universal low energy physics independent of detailed assumptions about the short-distance dynam ics. A llphysical observables can be described in a controlled expansion in powers of kl, where l is the characteristic low energy length scale of the system. The size of 1 depends on the system under consideration: for a nite-range potential, e.g., it is given by the range of the potential. For the systems discussed here, l is of the order of the elective range r_e or the van der W aals scale l_{vdW} .

E ective Field Theories can be obtained by applying a renormalization group (RG) transformation to a (more) fundamental theory. The RG transformation integrates out high momentum modes from the fundamental theory and leads to a description of low-energy physics in terms of low-energy degrees of freedom only. It can be understood as a change of the resolution scale of the EFT. The transformation generates a ow in the space of coupling constants that determine the elective Lagrangian L. If the RG transformation is continuous, this ow can be expressed by a differential equation for the

coupling constants g:

$$\frac{\mathrm{d}}{\mathrm{d}}g = (g); \tag{1}$$

where is the ultraviolet cuto which corresponds to the inverse resolution scale. The function (g) determ ines the behavior of g under the RG transform ation. The RG equation (1) can have m any types of solutions. The two sim plest ones are (a) renorm alization group xed points and (b) renorm alization group limit cycles. Fixed points are ubiquitous in condensed m atter and particle physics. They play an important role, e.g., in critical phenom ena and the scale dependence of coupling constants in high energy physics. Renorm alization group limit cycles have been suggested by K en W ilson already in 1971 [1], but their phenom enological importance has only been realized very recently.

An important signature of a limit cycle is the appearance of a discrete scaling symmetry, the invariance of physical observables under changes of the resolution scale by a discrete scale transformation with a preferred scaling factor . The prime example of a RG limit cycle is the E move ect [2] for 3-body systems with large S-wave scattering length a. V italy E mov discovered that in the limit a = 1 there can be in nitely many 3-body bound states (trimers) with an accumulation point at the scattering threshold [2]. These trimers are called E mov states. One remarkable feature of E mov states is that they have a geometric spectrum with preferred scaling factor ² 515:

where is the binding wavenum ber of the branch of E mov states labeled by n . The E mov e ect is just one example of the universal phenom ena characterized by the discrete scaling symmetry in the 3-body system [2]. These universal properties persist also for nite values of the scattering length as long as a l. For a review of these phenom ena, which we refer to as E mov physics, see Ref. [3].

For a generic system, the scattering length is of the same order of magnitude as the low-energy length scale 1. Only a very speci c choice of the parameters in the underlying theory (a so-called ne tuning) will generate a large scattering length. Nevertheless, system s with large scattering length can be found in many areas of physics. Examples are the S-wave scattering of nucleons and of ${}^{4}\text{H}$ e atom s. For alkali atom s close to a Feshbach resonance, a can be tuned experimentally by adjusting an external magnetic eld. This is particularly interesting, since it allows to experimentally test the dependence of physical observables on the scattering length.

In this talk, we discuss some applications of an EFT for few-body systems with large scattering length a 1[4]. In this theory, the lim it cycle is manifest in the RG behavior of the 3-body interaction which makes it ideally suited to study the E move ect and its consequences for other 3-body observables.

2. THREE-BODY SYSTEM W ITH LARGE SCATTERING LENGTH

We rst give a very brief review of the EFT for few-body systems with large scattering length a, focusing on S-waves. A more detailed treatment is given in Ref. [3].

For typical momenta k 1=a, the EFT expansion is in powers of 1=a so that higher order corrections are suppressed by powers of 1=a. We consider a 2-body system of non-relativistic bosons (referred to as atom s) with large scattering length a and mass m. At su ciently low energies, the most general Lagrangian may be written as:

where the C₀ and D₀ are nonderivative 2-and 3-body interaction terms, respectively. The strength of the C₀ term is determined by the scattering length a, while D₀ depends on a 3-body parameter to be introduced below. The dots represent higher-order terms which are suppressed at low-energies. Form on enta k of the order of the inverse scattering length 1=a, the problem is nonperturbative in ka. The exact 2-body scattering am plitude can be obtained analytically by summing the so-called bubble diagrams with the C₀ interaction term. The D₀ term does not contribute to 2-body observables. A fter renorm alization, the resulting am plitude reproduces the leading order of the well-known e ective range expansion for the atom -atom scattering am plitude: f_{AA} (k) = (1=a ik)¹; where the total energy is $E = k^2 = m$. If a > 0, f_{AA} has a pole at k = i=a corresponding to a shallow dim er with the universal binding energy $B_2 = 1 = (m a^2)$. Higher-order interactions are perturbative and give the momentum -dependent terms in the elective range expansion.

We now turn to the 3-body system. At leading order, the atom -dim er scattering am plitude is given by the integral equation shown in Fig. 1. A solid line indicates a single

atom and a double line indicates an interacting two-atom state (including rescattering corrections). The integral equation contains contributions from both the 2-body and the 3-body interaction terms. The inhom ogeneous term is given by the rst two diagrams on the right-hand side: the one-atom exchange diagram and the 3-body term. The integral equation simply sums these diagrams to all orders. A fler projecting onto S-waves, we obtain the equation

for the o -shell atom -dim er scattering am plitude with the inhom ogeneous term

The rst term is the S-wave projected one-atom exchange, while the second term comes from the 3-body interaction. The physical atom -dimer scattering amplitude f_{AD} is given by the solution T evaluated at the on-shell point: $f_{AD}(k) = T(k;k;E)$ where $E = 3k^2 = (4m)$ $1 = (m\hat{a})$. The 3-body binding energies B_3 are given by those values of E for which the hom ogeneous version of Eq. (4) has a nontrivial solution.

Note that an ultraviolet cuto has been introduced in (4). This cuto is required to insure that Eq. (4) has a unique solution. All physical observables, however, must be invariant under changes of the cuto, which determ ines the behavior of H as a function of [4]:

where $s_0 = 1.00624$ is a transcendental number and is a 3-body parameter introduced by dimensional transmutation. This parameter cannot be predicted by the EFT and must be taken from experiment. It is evident that H () is periodic and runs on a limit cycle. When is changed by the preferred scaling factor $= \exp(=s_0)$ 22:7, H returns to its original value. Note that the denition of the 3-body parameter is not unique. The parameter from Eq. (6) arises naturally in the EFT description, while the parameter

from Eq. (2) is de ned via the 3-body E mov spectrum in the limit $a ! 1 \cdot B$ oth de nitions are related by a constant factor: = 2:62 [3].

In sum m ary, two parameters are required in the 3-body system at leading order in l=a: the scattering length a (or the dimer binding energy B_2) and the 3-body parameter or

[4]. The EFT reproduces the universal aspects of the 3-body system st derived by E mov [2] and is a very e cient calculational tool to calculate those properties.

3. APPLICATIONS TO COLD ATOM S

We now turn to some applications of this EFT to system s of cold atom s. First we discuss universal scaling functions. Since only two parameters enter at leading oder, di erent 3body observables show correlations. These correlations must appear in all 3-body system s with short-range interactions and large scattering length. In the left panel of Fig. 2, we display the scaling function relating the trimer excited and ground state energies $B_3^{(1)}$ and $B_3^{(0)}$, respectively [5]. The data points give various calculations using realistic ⁴H e potentials while the solid line gives the universal prediction from EFT.Di erent points on this line correspond to di erent values of . The sm all deviations of the potential calculations from the universal curve are mainly due to e ective range corrections and can be calculated at next-to-leading order in EFT [6]. The calculation corresponding to the data point far o the universal curve can easily be identied as problem atic. In the right panel of Fig. 2, we display a similar correlation between the triton binding B_t and the spin-doublet S-wave neutron-deuteron scattering length $a_{nd}^{(1=2)}$ from nuclear physics taken from [7], which is known as the Phillips line. The dash-dotted and dashed lines give the results excluding and including the leading corrections in 1-a, respectively. It is evident that nuclear and atom ic system s show the sam e universal scaling behavior. W hile these system s have very di erent structure at short distances, all that m atters here is that 1 but not the details of the mechanism leading to the large scattering length. jaj

There are also observable features directly related to the occurence of a limit cycle in the 3-body system. The discrete scale invariance is manifest in the log-periodic dependence of 3-body observables on the scattering length a. This dependence can be tested in experiments with cold atom s close to a Feshbach resonance.² For this purpose we consider 3-body recombination, which is the process when three atom s scatter to form a dimer and the third atom balances energy and momentum. This is one of the main loss processes for trapped atom s and condensates of atom s near a Feshbach resonance. The event rate

per unit time and unit volume can be parametrized as = ³, where is the density of the atom s and is the recombination constant.

Unfortunately, heavy alkali atom s, such as Rb and Cs, form many deeply-bound diatom ic m olecules. Therefore, E mov states are resonances rather than sharp states, because they can decay into a deep m olecule and an energetic atom. The presence of deep m olecules also a ects other 3-body observables, but using unitarity their in uence can be accounted for by one real parameter [9]. This parameter describes how much probability is lost by scattering into the deep bound states. For = 0 the observables are not modiled, while for = 1 all probability is lost into the deep states. The consequences of the limit cycle become totally washed out for > 1. The 3-body recombination coe cient was rst calculated in Refs. [10, 11, 12]. Analytical expressions for as a function of a, , and have been obtained in Refs. [9, 3].

In a recent experiment with cold 133 Cs atoms, the Innsbruck group has presented the rst experimental evidence for E mov physics [13]. They used a Feshbach resonance to control the scattering length of 133 Cs atoms. Since inelastic 2-body losses were energetically forbidden, the dominant loss mechanisms were inelastic 3-body losses. By varying the external magnetic eld, they were able to change the scattering length from 2500 a

through 0 to $+ 1600 a_0$, where a_0 is the Bohr radius. They observed a giant loss feature at a magnetic eld that corresponds to the scattering length a = 850(20) a, They also m easured the 3-body recombination rate for positive values of a reached by increasing the magnetic eld through a zero of the scattering length. They observed a local minimum in the inelastic loss rate at a magnetic eld that corresponds to a scattering length of 210(10) a₀. Their data could well described by the universal expressions from Refs. [9, 3], therefore giving the rst indirect evidence for E mov states in cold atoms [13].

In the left panel of Fig. 3, we com pare the universal prediction for negative scattering length at T = 0 with the Innsbruck data for the loss coe cient K $_3$ = 3 at T = 10 nK $= 0:945 = a_0$ and = 0:06, one obtains a good t. Both parameters are [13]. For by the position of the E mov resonance and well determ ined by the resonance: by the height of the peak. The positive scattering length data from Ref. [13] are shown in

the right panel of Fig. 3. One com plication here is that the lowest tem perature that was reached for positive a was 250 nK. To take account the therm all elects properly would require knowing the 3-body recombination rate as a function of the collision energy. We compare the universal expression for T = 0 with the data for T 250:::400 nK [13]. For $= 0:707 = a_0$ and = 0.06, one obtains a good t to the data above a 400 a. However, the value of is not well determ ined by the data and only the upper bound

< 0.2 can be given [13].

for positive and negative scattering length need W e note that the values of and not be the same in the present case since both regions are divided by a nonuniversal region with small scattering length. Moreover the universal expressions are rigorously only valid for jaj $l w ith l = l_{vdW}$ 200 a for Cs atom s. Therefore the minimum

around $a = 210(10) a_0$ is outside the region of validity of the universal theory.

4. SUM M ARY & OUTLOOK

We have discussed the universal properties of few-body system s with large scattering length a 1. In the 3-body system these properties include the E move ect and a discrete scaling symmetry leading to log-periodic dependence of 3-body observables on the scattering length. These features can be understood as manifestations of a RG limit cycle in the 3-body system. Moreover, we have presented an EFT that is designed to exploit the separation of scales in few-body systems with large scattering length. In this EFT, the limit cycle is manifest through the RG behavior of the 3-body interaction required for proper renormalization. The EFT is very general and has applications in few-body systems from atom ic to nuclear and particle physics. As an example, we have shown universal scaling functions for ⁴He atoms and the Phillips line. Furthermore, we have discussed the recent 3-body recombination data for cold ¹³³Cs atoms by the Innsbruck group that provided the rst evidence of E mov states in cold atoms [13]. Future challenges include the extension of the EFT to the four-body system [14, 15] and the proper calculation of nite tem perature e ects [16, 17, 18].
