# The Study of Shodks in Thre-States D riven-D i usive System s: A M atrix P roduct A pproadh

#### Abstract

W e study the shock structures in three-states one-dim ensional drivendi usive system $\mathrm{s} w$ ith nearest neighbors interactions using a m atrix product form alism. W e consider the cases in which the stationary probability distribution function of the system can be written in term $s$ of superposition of product shock $m$ easures. W e show that only three fam ilies of three-states system $s$ have this property. In each case the shock perform $s$ a random walk provided that som e constraints are ful lled. W e calculate the di usion coe cient and drift velocity of shock for each fam ily.

## 1 Introduction

D uring recent years, m uch attention has been paid to the study of out of equilibrium low-dim ensional di usive particles system s [1, 2]. T hese system s are kept far from equilibrium by m aintaining a steady state particle current. $T$ his results in various criticalphenom ena including boundary-induced phase transitions, phase separation and spontaneous sym $m$ etry breaking. For instance the evolution of shocks in these system $s$ is an indication for the phase separation phenom enon. M acroscopically these shocks are special solutions of nonlinear hydrodynam ic equations for coarse-grained quantities like the density of particles. N evertheless in order to understand the structure of the shocks and also the nonlinear nature of them it is necessary to study the $m$ icroscopic dynam ics of these system $s$ in details.
A sim ple tw o-states lattioe gas m odel, which show s a variety of interesting criticalphenom ena including shock form ations, is the P artially A sym m etric Sim ple Exclusion P rocess (PASEP) w th open boundaries. In the PA SEP the particles are in jected into the system and also extracted from the boundaries while hop in the bulk of a discrete lattice [3]. Recent investigations show that for the PA SE P

[^0]w ith open boundaries (and even on an in nite lattioe) a traveling shock w ith a step-like density pro le $m$ ight evolve in the system provided that $m$ icroscopic reaction rates are adjusted appropriately [4, $5,6,6,7,8,9]$. The shock position in this case perform sa random walk while re ects from the boundaries. It is also known that for the PASEP multiple shocks can evolve in the system provided that speci c constraints are fill lled. It tums out that the PA SEP is not the only tw o-states lattice gasm odel in which the dynam ics of the single shock under the H am iltonian of the system is a random walk. There are also tw o other system s of this kind i.e. the $B$ ranching-C oalescing $R$ andom $W$ alk ( $B C R W$ ) and also the A sym $m$ etric $K$ aw asaki-G lauber $P$ rocess (A K G P). T he steady state probability distribution functions of these three system $s$ are know $n$ to be $m$ ade of supenposition of product shock $m$ easures [9].
In the context of one-dim ensionalout of equilibrium reaction-di usion system $s$, the $M$ atrix P roduct Form alism (MPF) has show $n$ to be one of pow erfultechnics in order to study of both the steady state and also the dynam ical properties of these system s [2]. A ccording to this approach the probability distribution function of the system at any time (including the steady state) can be written in term $s$ of the $m$ atrix elem ent (for open boundary conditions) or trace (for periodic boundary conditions) of products of som e non-com $m$ uting operators. At large tim es these operators are time independent while they can be time dependent at nite tim es. For the system $s w$ ith nearest neighbors interactions these operators satisfy an algebra which can have nite or in nite-dim ensional representations. For the three above $m$ entioned system $s$, it has been show $n$ that the conditions for the existence of a single traveling shock $w$ ith random walk behavior in the system are exactly those for the existence of a tw o-dim ensional representation for their quadratic algebras [10]. On the other hand, it is well known that the quadratic algebra of the PA SEP has also an $n$-dim ensional representation given that som e extra constraints on the boundaries and bulk rates are held [11, 12]. It tums out that these constraints are exactly those for the existence ofn 1 consecutive shocksw ith random walk dynam ics in the system. In this case the steady state probability distribution function of the PA SEP can be expressed in term s of superposition of n 1 shocks.
In this paper we consider the $m$ ost general three-states reaction-di usion system w th nearest neighbors interactions and open boundaries. The system is de ned on a lattice of length $L$. Throughout this paper, we assign the letters $A, B$ and E to these states. The E's are associated w ith the em pty sites or holes in the system while A's and B's are associated with particles of di erent types. W e de ne the total density of particles as the sum of the densities of particles of type A and B at each site. $W$ e also assum $e$ that the density of A particles in a given site is proportional to the density ofB particles at the sam esite. In term s of the totaldensity of the particles and the density of vacancies, the three-states system is basically a two-states system. In present work, we rstly investigate the conditions under which the stationary probability distribution function of the three-states system can be expressed in term s of superposition of single shocks. O ur approach w ill be based on the M PF.From the M PF point of view, one can sim ply try to $m$ ap the resultant algebra of the three-states system into that of three tw o-states above $m$ entioned $m$ odels and nd the constraints on the $m$ icroscopic reaction rates under which this $m$ apping is possible. T his guarantees that the resultant algebra of the three-states system has a tw o-dim ensional representation which in tums indicates that the steady state distribution of the
system can be written in term s of supenposition of single shocks. In the case ofm apping the quadratic algebra of the three-states system into the PASEP's algebra, the constraints are su cient for expressing the stationary probability distribution of the system in term s of superposition ofm ultiple shocks.
Secondly we study the dynam ics of a single product shock $m$ easures in the three-states system $s$. The dynam ics of a single product shock $m$ easure in tw ostates system $s$ has already been studied and as we mentioned in the PASEP, the BCRW and the AKGP the shock perform sa random walk given that some constraints are satis ed. For our three-states system the conditions under which the quadratic algebra of the system has a two-dim ensional representation are exactly those for the product shock $m$ easure to have a random walk dynam ics. W e obtain the di usion coe cient and the shock drift velocity in each case.
$T$ his paper is organized as follow s: In section 2 we brie y review the basic concepts of the MPF especially for two and three states system. The quadratic algebras of the PASEP, the BCRW and also the AKGP are review ed in section 3. W e also review the constraints under which their quadratic algebras have tw o-dim ensional representations. In section 4 wem ap the quadratic algebra of the $m$ ost general three-states system (in term $s$ of the total density of the particles and the vacancies) to the quadratic algebras of these three $m$ odels and nd the constraints under which the $m$ apping is possible. The dynam ics of the shock is discussed in section 5. The results and conclusion are brought in the last section.

## 2 The M atrix P roduct Form alism (M P F)

In this section we review the basic concepts of the M PF introduced in [3]. Let us de ne $P(C ; t)$ as the probability distribution function of any con guration $C$ of a $M$ arkovian interacting particle system at the tim $e t$. The tim e evolution of $P(C ; t)$ can be written as a Schrodinger equation in im aginary tim e

in which $H$ is a stochastic $H$ am ittonian. The $m$ atrix elem ents of the $H$ am iltonian are the transition rates between di erent con gurations. For the onedim ensional system $s$ de ned on a lattice of length $L$ with nearest neighbors integrations the H am iltonian H has the follow ing general form

For two-states system s $I$ is a $2 \quad 2$ identity $m$ atrix and $h$ is a 49 m atrix for the bulk interactions. The $m$ ost general form for the bulk H am iltonian of a
tw o-states system in the basis $(00 ; 01 ; 10 ; 11)$ is given by

In the stationary state we have HP (C) $=0$. Let us de ne the occupation num ber $i_{i}$ where ${ }_{i}=0$ if the site $i$ is em pty and $i=1$ if it is occupied by a particle. A coording to the M PF the stationary probability distribution P ( $f i g$ ) is assum ed to be of the form

$T$ he function $Z_{L}$ in (5) is a norm alization factor and can be obtained easily using the norm alization condition. T he operators D and E stand for the presence of a particle and a vacancy at each site. These operators besides the vectors hW $j$ and FV i should satisfy the follow ing algebra

The operators E and D are auxiliary operators and do not enter in the calculation of physicalquantities.
For three-states system s the $H$ am iltonian $H$ is given by (2). In this case I is a 33 identity m atrix, h is a $9 \quad 9 \mathrm{~m}$ atrix for the bulk interactions and $\mathrm{h}^{(1)}\left(\mathrm{h}^{(r)}\right)$ which stands for the particle input and output from the left (right) boundary is a 3 m atrix. O ne should note that by requiring the conservation law for the probabilities the m atrix h has only 72 independent elem ents. $T$ he boundary $m$ atrioss $h^{(1)}$ and $h^{(r)}$ have also 6 independent elem ents each. Introducing the
basis $(00 ; 01 ; 02 ; 10 ; 11 ; 12 ; 20 ; 21 ; 22)$, in which 0,1 and 2 stand for a hole, a particle of type A and a particle of type B respectively, we have

for the boundaries. A s we m entioned the conservation of probabilities in (7) requires $x_{i i}=\quad{ }_{j \in i} x_{j i}$ for $i_{i} j=1 ; \quad ; 9$. At the left boundary the particles of kind $A$ and $B$ are in jected into the system $w$ th the rates 1 and 2 respectively. $T$ hese particles can also leave the system from there $w$ th the rates 1 and 2 . There are also possibilities for changing the particle types at this boundary. The particles of type A (B) are converted to the particles of type B (A) w ith rate 3 ( 3 ). T he sam e processes can also take place at the right boundary for the particles of type A and B i.e. the particle in jection (w ith the rates 1 and 2), the particle extraction ( $w$ ith the rates 1 and 2 ) and also the particle type conversion (w ith the rates 3 and 3 ). In the three-states case let us de ne som e new notation. W e introduce two occupation num bers, $i$ and $i$, for each site of the lattice, where $i=1$ if the site $i$ is occupied by a particle of type $A$ and 0 otherw ise. Sim ilarly, $i=1$ if the site $i$ is occupied by a particle of type B and 0 otherw ise. A s the particles are assum ed to be sub jected to an excludedvolum e interaction, only one of $i$ and $i$ can be nonzero and the con guration of the system $C$ is uniquely de ned by the set of occupation numbers $f$ i; $i g$. A ccording to the M PF the stationary probability distribution $P$ ( $f i ; i g$ ) for an open system is assum ed to be of the form

$T$ he function $Z_{L}$ in (10) is again a norm alization factor and can be obtained easily using the norm alization condition. T he operators E, A and B stand for the presence of a vacancy, a particle of kind $A$ and a particle of kind $B$ at each site. T hese operators besides the vectors hW jand JV i should satisfy the


A s before the operators E, A and B are auxiliary operators and do not enter in the calculation of physical quantities. U sing the H am iltonian of the system given by (7)-(9) and (11) the quadratic algebra associated w ith the $m$ ost general three-states reaction-di usion $m$ odel can be obtained. In order to calculate the $m$ ean values of the physicalquantities, such as the $m$ ean density of particles at each site, one should either nd a m atrix representation for the algebra or use the com $m$ utation relation of the algebra directly.
In the next section we will review the two-states system s in which the H am iltonian of the system develop a single product shock $m$ easure as a random walk provided that the reaction rates fill 11 som e constraints.

## 3 Shocks in two-states system s

In (9] exact traveling wave solutions are obtained for three fam ilies of onedim ensionaltw o-species reaction-di usion $m$ odels $w$ ith open boundaries. It has been show $n$ that for these $m$ odels the stationary probability distribution functions can be w ritten as a linear com bination ofB emoullishock $m$ easures de ned on a lattice of length $L$ as

provided that som e constraints on the reaction rates are fiul lled. In (12) 1 and 2 are the densities of particles at the left and the right dom ains of the shock position k respectively. The tim e evolution of (12) generated by the H am iltonian of the above-m entioned $m$ odels is given by

which is a simple single-particle random walk equation for the position of the shock k . The shock positions hops to the left and to the right w th the rates $\mathrm{d}_{1}$ and $d_{r}$ respectively. In the follow ing we brie y review the PASEP, the BCRW and the AKGP and the conditions under which we have an exact traveling shock solution for the $m$ odel [9]. These $m$ odels are de ned on an integer lattice of length $L$, each site of the lattice i ( $1 \quad$ i $\quad$ L) is either em pty or occupied by at $m$ ost one particle. By applying the standard M PF and de ning the operators D and $E$ as the operators associated w th the existence of particles and vacancies, one nds the follow ing results for the above $m$ entioned $m$ odels: For the PASEP the non-vanishing rates in (4) are $!_{32},!_{23}$, , , and . The auxiliary operators E and D are real num bers proportionalto unity in this case. It is known that the H am iltonian of the PA SEP has an eigenvector $w$ ith zero eigenvalue which can be w ritten in term sof supenposition of single product shock $m$ easures. The non-vanishing rates together $w$ ith these densities should satisfy the follow ing conditions


In the bulk of the lattice the shock position hops to the left w ith the rate
 The shock velocity and the shock di usion coe cient will then can be read as $v_{s}=d_{r} \quad d_{1}$ and $D_{s}=\left(d_{r}+d_{1}\right)=2$. It has also been shown that under the conditions (15) the algebra (14) has a tw o-dim ensional representation [10]. The n -dim ensional representation of (14) describes the stationary distribution of the PA SEP w ith $n \quad 1$ consecutive shocks. It has been show $n$ that an $n$-dim ensional irreducible representation for any nite $n$ exists provided that the follow ing constraint is satis ed by the bulk and the boundary rates

while the density of the particles at the right hand side of the shock position is zero $2=0$. The shock position hops to the left and right w ith the hopping rates $d_{1}=\left(\begin{array}{ll}1 & 1\end{array}\right)!32+!_{14}$ and $d_{r}=!_{43}={ }_{1}$. The shock drift velociy and di usion coe cient are then $v_{s}=d_{r} \quad d_{1}$ and $D_{s}=\left(d_{r}+d_{1}\right)=2$. U sing the standard MPF the quadratic algebra of the BCRW is obtained to be

It has been shown that the steady state probability distribution function of the BCRW de ned by (5), can be described by a two-dim ensional representation of (19) given that the conditions (18) are fill led [10].

For the A K GP , the non-vanishing param eters in (4) are $!_{12},!_{13},!_{42},!_{43},!_{32}$, and. The particles are allowed only to enter the system from the rst site w th the rate and leave it from the last site of the lattice w ith the rate. In this case we have $1=1$ and $2=0$. There are no additional constraints on the rates for this $m$ odel. The dynam ics of shock $m$ easure generated by the H am iltonian of the system will be a sim ple random walk on the lattioe and the shock position hopping rates are $d_{1}=!_{13}$ and $d_{r}=!{ }_{43}$. T he shock drift velocity and di usion coe cient can now be easily calculated. It has also been shown that the quadratic algebra of the AKGP given by

has a two-dim ensional representation. The stationary state of the system can be w ritten in term s of supenposition of product shock $m$ easures (12).
In the follow ing section, by de ning the total density of particles, we $m$ ap the quadratic algebra of our three-states system into (14), (19) and (20). We nd the conditions under which such $m$ apping is possible.

## 4 M apping of algebras

In what follows we consider the $m$ ost general three-states system consists of tw o species of particles and vacancies and look for the constraints under which the steady state probability distribution function of the system can be written in term $s$ of superposition of product shock $m$ easures. It tums out that the dynam ics of such product shock $m$ easure under the $H$ am iltonian of the system is a random walk under the sam e constraints. In the $m$ ost general case in a three-states system, the particles belong to tw o di erent types A and B and the vacancies which willbe denoted by E. W e de ne the totaldensity of particles as the sum of the densities ofA and B particles at each lattioe site. W e assum e that at any given site of the lattice the $m$ ean occupation value of the particles of type $A$ is alw aysproportionalto the m ean occupation value of the particles oftype $B$. From the MPF point of view, this means that the operator A, associated w ith the presence of an A particle at a given site, should be proportional to the the operator $B$ which is associated w ith the presence of a $B$ particle i.e. $A=\frac{1}{r} B$ in which $r$ is a real and positive param eter. $T$ his im plies that the operators $A$ and $B$ commute with each other but not necessarily $w$ ith $E$ which in tum $m$ eans the stationary probability for occurrence of any con gurations of type EEEAAABABABBBABEE does not depend on the exact position of $A$ 's and B's in each block surrounded by E's rather to the num ber of them. We should em phasis that such constraint does not result in a trivialtw o-statesm odel even at the $m$ icroscopic level (see [13] for instance). N ow by de ning the total density of particles operator $D$ as $D=A+B$ the associated quadratic algebra
of the three-states system (11) can be written in term s of the tw o operators D and $E$ and the auxiliary operators $E, A$ and $B . W$ e also assum e that $A=\frac{1}{r} B$ and de ne $D:=A+B$. U nder these assum ptions one nds a quadratic algebra in term of the four operators D , D , E and E. T his algebra can be regarded as an associated quadratic algebra of a two-states system with open boundaries. N ow the question is "what do we get if we try to m ap this quadratic algebra into the quadratic algebras associated with the PASEP, the BCRW and that of the AKGP ?". Such m apping will indeed im pose som e constraints on the reaction rates of the three-states system. T he rst result is that the quadratic algebra of the three-states system can have two-dim ensional representations by im posing extra constraints. This means that the stationary distribution of the threestates system, when it is described in term $s$ of the total density of particles and the density of vacancies, can be w ritten in term $s$ of superposition of single product shock m easures. M oreover, if the total density of the particles has a step-function structure, it will evolve sim ilar to a random walker in continues tim e under the H am iltonian of the system. In the follow ing, we m ap the algebra of the three-states system in term s of D and E into (14), (19) and (20) and investigate the outcom es. A s we m entioned, this will im pose som e conditions on the reaction rates of our three-states system i.e. $\mathrm{x}_{\mathrm{ij}}{ }^{\prime}$ 's introduced in (7) and also the boundary rates in (8) and (9). T he constraints (15) and (18) in the case of $m$ apping into the PASEP's and the BCRW 's algebra w ill then be applied to the total density of particles and the new ly de ned boundary rates. These constraints will guarantee that the dynam ics of (12) will be a sim ple random walk and that the steady state of the system can be written in term $s$ of supenposition of these shocks.

## 4.1 $M$ apping into the PA SEP's algebra

H ere we introduce the conditions underw hich the quadratic algebra of the threestates system can be mapped into (14). O ne should note that the quadratic algebra of the PASEP does not contain any quadratic term $s$ of types $E^{2}$ or $D^{2}$. Since we have de ned $A=\frac{1}{1+r} D$ and $B=\frac{r}{1+r} D$; therefore, the quadratic algebra of the three-states system should not contain the quadratic term s of types $A^{2}, B^{2}$ or $E^{2}$. This im poses som e constraints on the $m$ atrix elem ents of (7). On the other hand, in order to have a quadratic term of type D E one should only have the quadratic term s of types A E and BE.A $1 l$ other combinations of $A, B$ and $E$ should also be elim inated in the quadratic algebra of the three-sates system. By applying these constraints we have found that the m ost general H am iltonian of the three-states system (7) should have the follow ing form in order to be m apped into (14)
in $w h i c h x_{i i}=P_{j \in i} x_{j i}$ for $i=2 ; \quad$;9. Allof the boundary rates (9) and (9) are non-zero in this case. $W$ e assum e that the auxiliary operators $D$ and $E$ are proportional to real numbers $d$ and $e$. In this case one nds that $d=e . B y$ de ning e $:=!_{32} \quad!_{23}$ one can see that the algebra of the three-states system can be m apped into (14) provided that

T he conditions in (15) should now be applied to the totaldensity of the particles and the new boundary param eters de ned in (24).
In [13] the authors have introduced a three-states system w ith a H am iltonian sim ilar to (21) and show $n$ that the dynam ics of a single product shock $m$ easure under this H am iltonian will be a random walk provided that the constraints sim ilar to (22)-(24) are ful lled. It should be m entioned that since (14) has also nite-dim ensional representations, m ultiple shock structures $m$ ay evolve in this system under the condition (16). M apping the quadratic algebra of the threestates system into the PA SEP'salgebra not only con m s the results obtained in [13] but also prove the possibility ofevolving $m$ ultiple shocks in the sam e system which has not been studied before. O ne should also note that the m odels studied in [14] and [15] are special cases of the system studied here.

### 4.2 M apping into the BCRW 's algebra

In order to m ap the quadratic algebra of the three-states system into (19) we de ne the total density operator $D$ and rew rite the algebra in term $s$ of the two operators D and E as before. Nevertheless, the auxiliary operators are not assum ed to be real num bers is this case. O ne should note that the quadratic algebra of the BCRW does not contain any quadratic term of type $\mathrm{E}^{2}$. This $m$ eans that all of the entries in the rst colum $n$ of (11) should be equal to zero. A ll other com binations of A , B and E are allowed; therefore, the m ost general

H am iltonian should have the follow ing form
in which, for the conservation of the probability, $x_{i i}$ 's are de ned so that the sum of the elem ents of each colum $n$ is zero. The reason that the entries of the rst row in (25) are taken to be equal to zero com es from the fact that it gives a linear com bination of operators w ith positive coe cients equal to zero. $T$ his cannot be true unless the coe cients (reaction rates on the rst row) are zero. W e now can $m$ ap the quadratic algebra of the three-states system into (19) provided that the nonzero param eters of the BCRW 's algebra are de ned as follow s

T he last constraint in (28) indicates that there is no particle in jection from the right boundary. T he conditions given by (18) should now be applied to the total density of particles and new ly de ned param eters in (26) and (28). These conditions and de nitions are enough for w riting the steady state probability distribution function of the m odel in term s of two-dim ensional representation of the algebra.

### 4.3 M apping into the A K G P 's algebra

In the case ofm apping the quadratic algeb ra of our three-states system into the AKGP's algebra, the H am iltonian of the three-states system (7) should have the follow ing form

Since (20) does not contain any quadratic term $s$ of types $D^{2}$ and $E^{2}$, the quadratic algebra of the three-states system should not contain the term sA ${ }^{2}$, $\mathrm{B}^{2}, \mathrm{AB}, \mathrm{BA}$ and $\mathrm{E}^{2}$; therefore, the rst, the fth , the sixth and the last two colum ns of (29) are chosen to be zero; how ever, all other com binations of A , B and $E$ are allowed in this case. In order to $m$ ap the quadratic algebra of the three-states $m$ odel in term $s$ of the operators $D, E, D$ and $E$ into the AKGP's algebra given by (20) the nonzero param eters in (29) should be related to the nonzero param eters of the AKGP as follow s

These conditions are enough in order to w rite the steady state of the three-states system in term s of tw o-dim ensionalm atrioes which satisfy (20).

## 5 D ynam ics of shock

Let us represent a product shock $m$ easure $w$ th the shock position on the site $k$ for our three-states system as follow s

in which $I A\left({ }_{r A}\right)$ and $I B\left(r_{r B}\right)$ are the densities of $A$ and $B$ particles on the left (right) hand side of the shock position respectively. A ccording to our assum ption that the density of A particles is alw ays proportional to that of $B$ particles, one should have ${ }_{B}=r_{I A}$ and $r_{B}=r_{r A} \cdot N$ ow de ning the total density of particles on the sides of the shock position as 1 and $r$, we have ${ }_{1}=(1+r)_{1 A}$ and $r=(1+r)_{r A}$. Sketch of such shock $m$ easure can be seen in gure 1). In the rst case ( $m$ apping the quadratic algebra of the three-states system into that of the PASEP) the shock (33) has a random walk dynam ics under (21) provided that the constraints (22)-(24) are satis ed. In this case we obtain

in which we have used (17) and the boundary rates , and are de ned according to (24). These boundary rates besides the total density of particles satisfy the follow ing constraint

The shock position hops to the left and the right $w$ th the rates $\frac{1}{1} \frac{1}{r} W_{32}$ and ${ }_{1}^{x} W_{32}$ respectively.
In the second case ( $m$ apping the quadratic algebra of the three-states system to that of the BCRW ) the shock (33) perform s a random walk again under (25)
provided that (26)-(28) are ful led. The total density of the particle on the right hand side of the shock is zero. The shock position in this case hops to the left and to the right w ith the rates $(1 \quad 1)!{ }_{32}+{ }_{1}!{ }_{34}$ and ! ${ }_{43}={ }_{1}$ respectively in which ! ${ }_{32},!_{34}$ and ! ${ }_{43}$ are de ned in (26). The totaldensity of the particles on the left hand side of the shock 1 , the boundary param eters and , besides the non-zero param eters de ned in (26) should now satisfy the follow ing constraints

In the third case of $m$ apping the quadratic algebra of the three-states system to the algebra of the AKGP the shock (33) perform s a random walk under the H am iltonian (29). In this case the total density of the particles of the left hand side of the shock position is equal to unity while it is zero on the right hand side of the shock position. The shock position hops to its leftm ost (rightm ost) site $w$ ith the rate $\mathrm{w}_{13}\left(\mathrm{w}_{43}\right)$. There is no need to introduce any extra constraints $m$ ore than those in (31) in this case.

## 6 C oncluding rem arks

In this paper we have considered the m ost general H am iltonian for the M arkovian three-states system $s$ (tw o species of particles besides the vacancies) $w$ ith open boundaries. From the MPF point of view, the quadratic algebra of this system is generated by three operators A, B, and E associated w ith the existence of two species of particles and the vacancies. W e have then assum ed that the density of particles are proportional to each other. By de ning the total density of the particles as sum of the densities of the particles, this algebra transform $s$ into a quadratic algebra in term $s$ of the total density operator D and E. Now this algebra can be treated as the quadratic algebra of a twostates system. W e have shown that under certain conditions this algebra can be m apped to the quadratic algebras of the PA SEP, the BCRW and that of the AKGP. Such $m$ apping has two im m ediate results: The stationary state of our three-states system can be written in term s of supenposition of product shock $m$ easures and that the dynam ics of a single product shock $m$ easure given by the H am iltonian of the system is sim ply a random walk.
O ne can sim ply check that the conditions which are neoessary form apping the algebra of the three-states system into the PA SEP's algebra, are exactly those introduced in [13] but obtained from di erent approach. In [13] the authors have introduced a single product shock $m$ easure and found the conditions under which it has a sim ple random walk dynam ics under the H am iltonian (14). In this paper we have shown that (14) is not the only way one can de ne the H am iltonian in order to have such property. There are actually two other ways which have been introduced and studied here. In the sam e reference the authors have only studied the dynam ics of a single shock. W e have shown that, at least for the case ofm apping the algebra of the three-states system into the PASEP's algebra, m ultiple shocks can evolve in the system.
O ne should note that the procedure introduced in this paper is not the only w ay one can w rite the quadratic algebra of a three-states system in term sof the
two operators D and E. It is worth studying the case where the operators A and $B$ are not proportionalbut related to each other. O ur approach can also be generalized to the system $s$ w ith $m$ ore than three states at each lattioe site. $T$ his is under our investigations [16].
