Investigations of Pairing in Anyon System s

A bstract

W e investigate pairing instabilities in the Ferm i-liquid-like state of a single species of anyons. W e describe the anyons as Ferm ions interacting with a Chem-Sim ons gauge

eld and consider the weak coupling lim it where their statistics approaches that of Ferm ions. We show that, within the conventional BCS approach, due to induced repulsive C oulom b and current-current interactions, the attractive A haronov-B ohm interaction is not su cient to generate a gap in the Ferm ion spectrum.

The possibility of superconductivity in anyon system s is of general interest. The mean eld theory approach to system s with a single species of anyons developed by Fetter, H anna and Laughlin and other authors [1] argued that a nite anyon density induces a background statistical magnetic eld and a Landau level picture of the ground state and the ensuing energy gap and superconductivity emerged. There are also alternative scenarios for anyon superconductivity where the background statistical magnetic eld is absent, the ground state of the anyon system resembles that of a Ferm i liquid and the superconductivity is realized in the conventional BCS mode. This occurs in a system which contains two species of anyons of opposite charges with respect to the statistical gauge eld and which therefore have opposite fractional statistics [2, 3, 4, 5, 6] (we denote this as (+) pairing). There, the statistical background magnetic elds cancel and it has been found that the Aharonov-Bohm interaction is attractive enough to generate the pair form ation.

Recently, it has been noted that system s with a single species of anyons and a Ferm i-liquid-like ground state are also of interest [7]. A nyons are described as Ferm ions interacting with a Chem-Sim ons gauge eld so that in the weak coupling lim it their statistics approaches that of Ferm ions. The Ferm i-liquid state is achieved when the mean background statistical magnetic eld is cancelled by an external magnetic eld. A pairing instability in such system s (which we denote (+ +)) has been suggested as an explanation of the even denom inator states in the fractional quantum H all e ect. It has been conjectured in [7] that the A haronov-B ohm interactions (with coupling constant 1=) which give the Ferm ions fractional statistics are su cient to drive a superconducting pairing instability. In this Letter we shall show that this is not the case. W hen the back-reaction of the gap in the Ferm ion spectrum to the interaction potential is taken into account, the BCS gap equation has only the trivial solution. W e conclude that, if there is such an instability in this system, it must occur outside of the weak-coupling BCS scenario or else be driven by other interactions. It is also worth noting that in the physical systems of interest is small (for example in [7] = 1=2), and strong coupling e ects could lead to the gap form ation (in that scenario there would be a critical where pairing takes place). In that case, we observe that (as was previously found for the (+) case [6]) the coe cient of the Chem-Sim ons term is renorm alized as ! '-4 , where ' is the angular momentum of the Cooper pair which, because of Ferm i statistics, must be an odd integer. Thus, the H all conductivity and fractional statistics of quasiparticles and m agnetic vortices are modi ed by the gap. Due to no-renorm alization beyond one loop arguments [8] for the Chem-Sim ons term we expect that the latter result is valid beyond our large perturbation theory. To get an even denom inator H all conductance, 2 k should be a half-odd integer.

It is interesting to compare the (+ +) case with the (+ -) case where it has been shown [6] that A haronov-B ohm interactions do lead to pairing and form ation of an energy gap, which even proves to be param etrically larger than the simplest BCS gap. At the tree level these cases are equivalent: both contain only long-ranged A haronov-B ohm interaction (which might be both attractive and repulsive, depending on the angular m on entum of the anyon pair [4, 6]). Bare C oulom b and m agnetic currentcurrent interactions are absent, but will be generated by the radiative corrections. The di erence between the (+ -) and (+ +) cases stem s from di erent back-reactions of the gap form ation on the elective interaction between anyons.

Since the (+) pairs are neutral with respect to the statistical gauge eld, their presence in the ground state does not lead to a M eissner e ect (i.e. generation of a London m ass) for the statistical gauge eld. M oreover, since at zero temperature all anyons are bound in pairs, there are no free charge carriers in the system, and therefore, no D ebye screening. This in turn results in the fact that radiatively

induced C oulom b and m agnetic current-current interactions are short ranged (topologically m assive), whereas the A haronov-B ohm interaction remains long ranged and, therefore, dominant [6]. In the equal charge case, on the contrary, the formation of (+ +) pairs of course leads to both D ebye and M eissner screening, and all interactions become short ranged. Thus the interaction which causes anyon pairing will in turn be completely changed by this very pairing. Note that the values of the D ebye and London m asses are de ned only by the density of the free charge carrens in the former case and that of the superconducting fermions in the latter one. If there is a gap in the Fermionic spectrum these two are de ned by the density of anyons in the system, and for zero temperature have nothing to do with the magnitude of this gap, inrespectively how small it is. They can therefore have an important in uence on the gap equation. The purpose of this paper is to consider a self-consistent picture of this feedback. W e will demonstrate that for large k (2 =k is the statistics param eter) there is no gap in the Fermionic spectrum, contrary to the result in [7]. For simplicity we will consider the zero-tem perature case.

W e start with the lagrangian

where the statistical coupling is taken positive and large, and (k) is the (quasi)particle (anyon) dispersion law below taken to be (k) = $k^2 = 2m$ _F. The tree-level potential has pure A haronov-B ohm form and reads in the radiation gauge ($Q_iA_i = 0$)

where $p = p(\cos ; \sin)$, $p^0 = p^0(\cos ^0; \sin ^0)$, $= ^0$. This potential leads to the formation of bound pairs of anyons with non-zero angular momentum [4]. Substituted into the standard BCS gap equation

it gives rise to the exponentially suppressed gap, which depends nontrivially on the momentum [6]

The largest gap is achieved for P-wave pairing

Taking into account the back-reaction of the gap on the renormalization of the potential leads to drastic changes in these tree-level conclusions. In the case of (+) pairing it removes the exponential suppression of the gap [6]

which demonstrates the existence of a new universality class for the superconducting order parameter.

Now we will show that in the (+ +) case the result is quite the opposite: the only solution of the renormalized gap equation is = 0.

To nd the gap in proved potential we need to know the polarization operator (herew ith we will be interested in the static lim it, when there is no energy transfer through the gauge line, and we will restrict ourselves to the static loop correction, as in the large lim it the contribution of higher loops will be suppressed). In the radiation gauge we nd [9]

1) $_{00}(q) = i\frac{m}{2}$, for all jqj< $2p_F$. Indeed, in the case of the single charge plasm a the D ebye screening does not depend on whether or not the Ferm ions are bound in the pairs.

2) $_{ij}(q) = i (q)_{ij}: (q = 0) = \frac{r}{4} _{ij}$. The nonzero value of $_{ij}(q = 0)$ indicates the appearance of the magnetic London mass of the statistical photon (M eissner effect). Note that this London mass does not depend on the value of the gap, exhibiting thus a nonanalytic behavior, as for the case of the absent gap (q = 0) = 0. This is of no surprise, since we know that the value of the London mass is determined by the density of superconducting Fermions, and at zero temperature all Fermions are superconducting however sm all the gap. When q = jqj increases (q) decreases, and for large $q = v_F$ it approximately equals (q) ' $(\frac{r}{qv_F} + \frac{q^2}{24 m})_{ij}$, where the last term in the brackets is the magnetic response of the norm alm etal.

3) $_{0i}(q = 0) = \frac{1}{4} "_{ij}q_{j}$, where ` is the angular momentum of the pair. This leads to the same renorm alization of the Chem-Sim ons coupling as those institution in [6] $_{ren} = -4$, but it is worth recalling that now, after the formation of the BCS pairs, the A haronov-B ohm interaction is short ranged, and this renorm alization does not lead to a considerable enhancement of the A haronov-B ohm attraction and in what follows we will neglect it in the large lim it. Since there is no corrections to the Chem-Sim ons term in the ordinary free plasma, for q = v_F or v_F or

The full gauge propagator is in the matrix notations

where D_0 is the bare propagator, the only nonzero component of which is

The behavior of the functions D $_{0;1;2}$ is depicted on Fig1. Note, that for

the propagators D_{1,2} increase with increasing q. This very unusual behavior of a propagator would be forbidden in the relativistic case, and is a net e ect of the nite density of anyons, presence of the gap in their spectrum, and the form of the bare gauge propagator (dom ination of the Chem-Sim ons term in it). It makes the most in portant region of the transferred momenta $q^2 = (p p^0)^2$ in the gap equation (3) to be q' q₀, as opposed to the standard case where this region was q' $(\frac{1}{p})p_F$ q₀.

Note, that despite allour interactions are short ranged in the sense, that all D_i are nite (and non-zero) at q = 0, the magnetic interaction still contains the factor of $1=q^2$ from the tensor structure $D_{ij} = iD_1_{ij} = \frac{q_iq_j}{q^2}$ (this is a rem iniscent of the gauge symmetry of the original lagrangian (1)). Therefore, the corresponding potential for the current-current interaction in the '-wave pairing (cf. (2,4))

The two others interactions, Coulom b

vanish in this limit, and are, therefore, subdom inant with respect to the currentcurrent interaction.

Let us stress that taking into account the back-reaction of pairing onto the potential between anyons results in weaking of the attractive part of the potential, and appearing of the strong repulsive part. So we conclude, that the gap should be suppressed even stronger that it was at the tree level (see (5)) and the ratio $=_{\rm F}$ is the sm allest parameter in the theory.

It can be seen that param etrically the RPA in proved gap equation reads [9]

where the set term in the curly brackets is the contribution of the magnetic currentcurrent interaction, the second one is that of the Coulomb interaction (these two come from the small momentum transfer in the gap equation (3), $\dot{p} p^0 j q$), and the last one is the contribution of the A haronov-B ohm interaction (it comes from the large momentum transfer in the gap equation, $\dot{p} p^0 j q_0$ for which it has essentially the bare form). We see, that only the trivial solution = 0 satis es (12), provided the constraint $<_{\rm F} e^2$ is full led. Therefore we conclude, that within the simplest BCS picture there is no pairing in the Ferm i liquid of anyons of the sam e charge.

It also seems unlikely that for pairing at large angular momenta ' the system might become superconducting due to the Kohn-Luttinger e ect [10]. Indeed, as we showed, the most important region of the transferred momentum in the gap equation (3) is q = q, where the net interaction is repulsive, what makes the improved gap equation (12) to have no non-trivial solutions. To smear out this repulsion one needs very large angular momenta,

which look implausible.

The arguments presented above, of course, do not rule out the general possibility of the superconductivity in these systems. There might be other, more complicated mechanisms of pairing, like gapless superconductivity [11]. Besides that, as we mentioned above, for real physical systems the value of the statistics parameter is rather small, so these systems correspond to the strong coupling regime. For example, for 2 the statistics of anyons is close to that of bosons, and the system of equally charged anyons in this case will behave like the XY model, for which the long-range order exists [12]. All these should be a subject of further investigations.
