CRITICAL BEHAVIOR OF THE ANTIFERROMAGNETIC HEISENBERG MODEL ON A STACKED TRIANGULAR LATTICE

W e estim ate, using a large-scale M onte C arlo simulation, the critical exponents of the antiferrom agnetic H eisenberg m odel on a stacked triangular lattice. W e obtain the following estimates: $= 2.011 \pm 0.014$, $= 585 \pm 0.009$. These results contradict a perturbative 2 + R enormalization G roup calculation that points to W ilson-F isher O (4) behaviour. W hile these results m ay be coherent with 4 results from Landau-G inzburg analysis, they show the existence of an unexpectedly rich structure of the R enormalization G roup

ow as a function of the dimensionality and the number of components of the order parameter.

1 IN TRODUCTION

There is at present a satisfactory understanding of the critical behaviour of physical systems where the rotation symmetry group O(N) is broken down to O(N-1) at low temperatures. Several theoretical tools are available to estimate the critical exponents and there is good agreement between these estimates. The W ilson-F isher we point which describes the critical physics can be smoothly followed between two and four dimensions: for N 3 the 2+ and 4 renormalization group expansion merge in a continuous manner.

The situation is much more complicated when the rotation symmetry is fully broken in the low-temperature phase. A prominent example is found in the so-called helim agnetic systems where H eisenberg spins are in a spiral arrangement below the critical temperature. It is an interesting question, both theoretically and experimentally, to know the corresponding universality class. A widely studied prototypical model is the antiferrom agnetic H eisenberg model on a stacked triangular lattice, which is simple and display commensurate helim agnetic order below a transition point T_c . There is little consensus in the literature regarding critical phenomena associated with this model [1].

This topic has been investigated by use of a D = 4 renormalization group calculation [2]. The corresponding G inzburg-Landau theory for a N - component vectorm odel involves two N -component bosonic elds. It is found that for N large enough the transition is second order and not governed by the H eisenberg O (2N) W ilson-F isher xed point but by a di erent xed point which is also non-trivial for D < 4. For smaller N, this new xed point disappears and there is no stable xed point which is an indication for a uctuation-induced rst-order transition. The dividing universal line between second-order and rst-order behaviour is found to be N_c(D) = 21.8 23.4 + O (²). The rapid variation of N_c leaves us rather uncertain about the fate of the case D = 3. C learly m ore inform ation is needed about the N_c(D) line in the (num ber of components-dimension)-plane.

A D = 2 + renorm alization group study has been performed for a system of H eisenberg spins [3] by use of a non-linear sigm a model de ned on a hom ogeneous non-symmetric coset space 0 (3) 0 (2)=0 (2). It was found that near two dimensions the system undergoes a second order transition which is governed by the 0 (4) usual W ilson-F isher xed point. In fact the symmetry 0 (3) 0 (2)=0 (2) is dynamically enlarged at the critical point to 0 (3)

0 (3)=0 (3) and 0 (3) 0 (3) is 0 (4). This m is match between the expansions near four dimensions and near two dimensions is quite unusual and does not happen in the well-studied <math>0 (N) ! 0 (N 1) critical phenomena. As a consequence, the D = 3 case remains elusive and a direct study in three dimensions is called for.

Some prelim inary M onte Carlo (MC) simulations have shown evidence [4, 5, 6, 7] for a continuous transition in the case of the H eisenberg antiferrom agnet on a stacked triangular lattice. The exponents found are not compatible with those of the O (4) vector m odel in three dimensions. W e did a large-scale simulation with m uch better statistics than previous attempts. As a consequence we are able to pin down the transition temperature in a very precise m anner and to obtain reliable estimates of critical exponents.

We thus focus on the classical spin model de ned by the classical Heisenberg Hamiltonian:

The exchange interaction J_{ij} is nonzero ($J_{ij} = 1$ in what follows) between nearest-neighbors of a stacked triangular lattice and the spins are threecomponent unit vectors. The classical ground state is found by m inim izing the Fourier transform J(Q) of the couplings J_{ij} . The spins adopt a planar arrangement on a three-sublattice structure with relative angles 120 degrees.

2 The simulation

W em ade two successive sets of M onte C arb simulations of this model, using slightly asymmetric lattices (with periodic boundary conditions) of shape L^2L_z , where L is the linear size inside the planes, and $L_z = 2=3L$ the stacking size.

The rst set of simulations was run on a CM -2 8K massively parallel computer. We made runs on lattices of size 12^2 8 (with a total of 600 000 M onte C arlo sweeps of the lattice), 24^2 16 (with a total of 1 500 000 sweeps) and 48^2 32 (with a total of 1 570 000 sweeps). In the rst case we used the Heat-Bath algorithm, in the later two cases we used an Hybrid O verrelaxation algorithm [9] where each Heat-Bath sweep is followed by an energy conserving sweep. The next set of simulations was run on CRAY vector

computers on lattices of size 18^212 ; 24^216 ; 30^220 ; 36^224 and 48^232 with 4 to 8 10^6 Hybrid O verrelaxation sweeps. Both simulations concentrate in the immediate vicinity of the transition.

Let us note by S_a the total spin per site for sublattice $a\ (a\ 2\ [1;2;3])$, we measured the magnetization :

the susceptibility:

and the fourth-order cum ulant:

Our strategy to extract the critical exponents was rst to estimate the value of the critical temperature $_{c}$, as the point where B_{L} () is L independent and then to estimate the exponents from the following set of equations:

The extrapolation, from the value used for the sinulation, to $_{\rm c}$ is done using the Ferrenberg-Swendsen technique [10]. This technique is invaluable to extrapolate in a neighborhood of size $1=L^{1=}$ (W e understand that, when used blindly outside such a tight range, it may give wrong results). An alternative strategy would be to evaluate exponents from the nite size scaling of the maxima of $_{\rm L}(), M_{\rm L}(), \frac{0}{0}B_{\rm L}()$ and $\frac{0}{0} \ln M_{\rm L}()$. It would however require to perform simulations at four values, close to the four (L dependent) points where this quantities reach their maxima, otherwise accuracy would be lost. The statistical analysis is done with respect to 20 bins, using rst-order bias-corrected jackknife (see e.g. Ref.[11] and references therein). The rst 20 % of each run is discarded for therm alization.

From simulations of lattices of increasing sizes $L_1 < L_2 < :::$ converging estimators of $_c$ are obtained by solving the equations:

Table 1: Critical tem perature and critical exponents estim ates, using equations 9, 5, 6, 7 and 8 respectively. First two lines are CM -2 data, next lines the CRAY data. The rst column gives the linear sizes of the lattices used. The two numbers inside parenthesis are the estimated statistical errors, direct and induced, on the last digits of the number on their left.

The results can be found in the second column of Tab.1. Within our statistical accuracy all estimates are compatible, there is neither any clear lattice size dependence, nor any discrepancy between the two sets of runs. Our nalestimate is (the quoted error is deliberately on the safe side)

We use this value to compute $_{L}(_{c}), M_{L}(_{c}), \frac{\theta}{\theta}B_{L}()$ and $\frac{\theta}{\theta} \ln M_{L}()$ in order to estimate = , = and . Results can be found in Tab.1. We quote separately the estimated \direct" statistical errors computed from the dispersion of the results from the 20 bins, and the errors induced by the

uncertainty on the determ ination of $_{\rm c}$, computed as the (absolute value of the) dimension between the values obtained using our best estimate of $_{\rm c}$ and the values using the one standard deviation estimate from Eq.10. The last line in Tab.1 gives the results of linear ts of the CRAY data for $\ln(_{\rm L}(_{\rm c}))$, $\ln(_{\rm e}^{0}B_{\rm L}(_{\rm c}))$ and $\ln(_{\rm e}^{0}\ln M_{\rm L}(_{\rm c}))$ respectively. The results of the ts are stable against om itting the smallest lattice data. The 2 is equal to 1.5, 3.7, 1.9 and 4.5 respectively (we expect 2 4). Such values mean that linear ts give good representation of the data for L 18 (with the current accuracy).

Our nal numbers are = 2:011 :014, D 2 = 2:011 :019, = :585 :009. We observe that hyperscaling is veri ed within errors, and is very small (j j :01). The value for is clearly not compatible with the value for the O (4) xed point [13] (:75).

Published M onte C arb results for are 53 :02[4], :53 :03[5], :55 :03[6]and :59 :02[7]. O ur results are in good agreem ent with the m ost recent results (and with the result :57 :02 from a model of commensurate H eisenberg helim agnet[8]). The methods of analysis are quite dimerent. Ref.[7] uses data taken in a wide region around the transition point and adjust the values of the critical exponents using the old fashioned \data collapsing" method. This method has the disadvantage to give much weight to points with large value of ($_{\rm c}$)L¹⁼. We extract the exponents directly from data reweighted to $_{\rm c}$. We have also a much higher statistics: we use 8 10^6 heat-bath + energy-conserving sweeps whereas [7] uses 6-20 times 20000 sweeps of a less e cient algorithm. Our estimated statistical error on the determ ination of $_{\rm c}$ is one order of magnitude smaller than the one in ref.[7].

3 Conclusion

Let us st sum marize the know ledge obtained from perturbative RG studies as a function of the dimensionality and the number of components of the order parameter.

i) There is a universal line $N_c(D)$ separating a rst-order region from a second-order region near D = 4. Its slope is known from RG studies[2] as well as the critical value N_c for D = 4.

ii) Large-N studies[12] indicate that the stable $\,$ xed point found above N_{c} (D)

persists sm oothly in the region N = 1 and 2 < D < 4. iii) Sm oothness along the D = 2 vertical axis can be shown by studying the nonlinear sigm a model suited to the N-vector model: it is built on the hom ogeneous space O (N) O (2)=O (N 2) O (2) [14]. One nds a single stable xed point for all values of N 3. In the large-N lim it the exponents from this sigm a model are the sam e as those of the linear model.

If we believe in the perturbative RG results, then necessarily the universal line $N_c(D)$ can only intersect the horizontal axis N = 3 between D = 2 and D = 4. The simplest hypothesis is then that the plane (N, D) is divided in two regions by the line $N_c(D)$. This line may intersect the N = 3 axis at a critical dimension D_c . Our M onte-C arbo results thus in ply that D_c is between three and four dimensions since we observe a continuous transition at D = 3. A possibility would be that the critical behaviour we observe is described by the xed point found in the neighborhood of D = 4.

However one has to note that the sigm a model approach shows that this xed point is 0 (4) for N = 3. This is clearly ruled out by our data. The sim plest scenario suggested by i-iii above is wrong. It may be that the whole sigm a model approach breaks down since perturbative treatment of a sigm a model neglects global aspects. Previous studies indeed have performed, as usual, only perturbation theory for spin-wave excitations[3]. One may invoke the peculiar vortices present in the model[16] since $_1$ (SO (3)) = Z_2 that form bops in D = 3 as responsible of the breakdown of the sigm a model. However vortices are also excluded from the perturbative calculations near D = 4 and thus it would be di cult in this case to believe in what is found perturbatively. It may be also that the xed point found in 2 + expansion is destabilized by some operators containing high powers of gradients [15].

W e have thus obtained the critical behaviour of a m agnet with a canted ground-state. This calls for a deeper understanding of the R enormalization G roup behaviour of canted systems since there is no obvious relationship between the dierent perturbative approaches, contrary to the case of collinear vector m agnets. We note for the future that it would be interesting to obtain the critical behaviour of the XY canted systems, much more relevant to the experimental situation.


