Various condensed m atter H am iltonians in term s of U (2/2) operators and their sym m etry structures

A bstract

We rew rite various lattice H am iltonian in condensed m atterphysics in terms of U (2/2) operators that we introduce. In this representation the symmetry structure of the models becomes clear. Especially, the Heisenberg, the supersymmetric t-J and a newly proposed high-Tc superconducting H am iltonian reduce to the same from H = t $_{< jk>}$ $_{ac}$ X $_{j}^{ac}$ X $_{k}^{ca}$ ($1)^{F}$ (c) . This representation also gives us a system atic way of searching for the symmetries of the system .

I INTRODUCTION

Recently the study of strongly correlated electrons on a lattice has become one of the central problems in solid state physics in connection with high- T_c superconductivity. In this paper we concentrate on the sym metry structures of those H am iltonians which have been proposed as models of high- T_c superconductivity, that is, the Hubbard, Heisenberg, t-J models and a new model recently proposed by F.Essler, V.Korepin and K.Schoutens (EKS model) [1].

The innovation made here is the introduction of (C li ord) operators. The lattice H am iltonians are usually described by c_j which form a basis of the fundam ental representation of U (2). It is known that 4 realand in aginary components of $c_{j''}$ and $c_{j\#}$ (see (2.1)) form a 4-dimensional C li ord algebra [2]. Through multiplications of the 's one can construct a maximal set of 16 independent operators which form U (2/2) algebra [3, 4]. Then it is natural that the U (2/2) symmetry of the system should manifest itself if we express the model in terms of these U (2/2) operators.

The U (2/2) operators are explicitly given in terms of the t-and X-operators in Sec. II. Both of them are the generators of the U (2/2) superalgebra in dierent bases which is essentially generated by the 4-dimensional Cli ord algebra.

W ith the U (2/2) operator representation some of the symmetry structures of the models become transparent. This representation also gives a

system atic m ethod of nding out the sym m etries of the system.

Supergroup U (M /N) is quite important in condensed matter physics. It is a unitary transformation of the states assigned to each site. Indeed the Heisenberg model has U (2) symmetry, t-J model U (1/2) and the new model U (2/2). Notice here that these models with U (M /N) symmetry are all solvable at least in one-dimension. If we want a solvable multi-band model we may need a higher U (M /N) [3].

Now let us specify the models we deal with explicitly. The rst one is the Hubbard model.

where operator c_j (c_j c_j ; j=1 L) de ned on each site (L: total number of lattice site) satisfy anti-commutation relation

The number operator n_j is de ned by $n_j={}^P\quad n_j\quad (n_j=c_j^+\ c_j$) and is the chemical potential.

In what follows $^{P}_{< jk>}$ implies the sum mation over the nearest neighbors in which the pairs (j;k) and (k;j) have to be counted once each so that the sum mand can be always considered as sym metric under interchanging j k.

If we set the chem ical potential to be U=2, the system has the SO (4) sym metry [5, 6]. This condition is satis ed at half-lling [7]. One of the subgroups of SO (4) is the spin SU (2) formed by the spin operators S =

A nother subgroup of this SO (4) sym m etry is the pairing sym m etry recently pointed out by C.N. Yang and S.C. Zhang [6].

Next we consider the Heisenberg model de ned by

where we have used the notation S_j $S_k = {P \choose = x_N, z} S_j S_k$. Notice that H_{t-J}^{eff} acts on the Hilbert space where no double occupancy of sites are allowed. In other words the true t-J H am iltonian is $H_{t-J} = P H_{t-J}^{eff} P$ where P is the Gutzwiller projection operator; $P = {Q \choose j=1} P_j = {Q \choose j=1} (1 - n_j, n_j)$. Setting = (2z) = 2t = J with z the number of the nearest neighbor sites of each site, we get the U (1/2) supersymmetric t-J model[8].

There are close relations among the above three models, that is, H $_{\rm H~ubb}$: reduces to H $_{\rm H~eisen}$: in the strong coupling lim it (U=t>> 1) at half-lling[9] and also reduces to H $_{\rm t~J}$ in the large U lim it in a certain sense[10]. But the supersymmetric t-J model (2t= J) itself can not be obtained from H $_{\rm H~ubb}$:

The nalexample is the EKS model[1]. This model describes strongly correlated electrons on a general d-dimensional lattice as a new exactly solvable model for high- $T_{\rm c}$ superconductivity. This model has many interesting

features but here we focus our attention on its sym m etry structure U (2/2).

In the above de nitions of the Ham iltonians we have included the chem ical potential term only if such a term contributes to bringing the system higher symmetries.

II VARIOUS HAM ILTONIANS IN TERMS OF U (2/2) OPERATORS [2]

At each site we introduce the -operators

which satisfy f_j ; $_k g = 2$ $_{jk}$. We further introduce $_j^5 = _j^1 _j^2 _j^3 _j^4$ and $_j = [_j;_j] = (2i)$. Then (as we see explicitly in (2.7)) the 16 operators $t_j = (1_j;_j;_j;_j^5;_j^5)$ form the superalgebra U (2/2) where $_j$ and $_j^5 _j^5$ are the Ferm ioperators while 1_j , $_j$, and $_j^5$ Bosonic operators. Notice here that the local t_j can also form U (4), U (3/1) and U (1/3) but the global

 $t = \int_{j=1}^{P} t_j$ form s only U (2/2). W ith these operators the H am iltonian becomes [11] (om itting constant terms)

In the above expression, noting that and corresponds to 0 (4) vector or tensor indices, some 0 (4) invariances of the models are transparent as we specify in Sec. III, that is, if there are no un-contracted indices or , the term is 0 (4) invariant.

Next we consider the following 16 herm it ian matrices T (1; ; iA; 5) (=) which correspond to a 4 4 matrix representation of t_j or matrix of the fundamental (de ning) representation of U (2/2) with tr(TT) = 4 .

Here i's are 2 2 Pauli-matrices, I and O are 2 2 unit and zero matrices respectively. Note here that and iA take the form of the Fermiblock matrix while the others Bose block matrix (see P. Freund in [4]). Again, notice that T can form U (4) etc. other than U (2/2) though the glogal t form only U (2/2). Now the X_j^{ac} operators are defined as another different basis of the same U (2/2) algebra, or a linear combination of the t_j 's;

where T_{ca} is the (c;a) element of the 4 4 m atrix and E instein's sum rule (as we will use in what follows implicitly) is implied. Notice that a;c = 1;2 correspond to the Bose sector while a;c = 3;4 to the Ferm i sector. As clear from the de nition, X_j^{ac} forms an U (2/2) algebra as t_j does, which is very similar to the U (N) algebra;

where [,] represents commutator() or anti-commutator(+) the latter occurring only if both operators are ferm ionic[12].

 X_j^{ac} is essentially the Hubbard projection operator [3]. Especially at each site we can set $(X_j^{ac})_{mn} = m_{anc}$ which is helpful in the actual calculation.

W ith the X operators, EKS, supersym m etric t-J[13], and H eisenberg (J = 2t) m odel becom e

where F (b) = 0 (F (f) = 1) with b = 1;2 (f = 3;4) and H $_{\text{H eisen}}$: is the Heisenberg modelwritten not in terms of the S-spin operator but in terms of the -spin operator. We have introduced two projection operators PF and P_B , P_F for the two singly occupied states $c_{j\pi}^+$ Di , $c_{j\#}^+$ Di and P_B for the nonor doubly-occupied states $\mathring{D}i$, $c_{j''}^{\dagger}c_{j\#}^{\dagger}\mathring{D}i$;

In the above expression, we can see clearly the fact that the supersym metric t-J m odel and H eisenberg m odels correspond to certain subsectors of the EKS m odel as pointed out in [1]. In addition, noting that various subelements of X ac form U (M/N), several U (M/N) invariances of the models manifest them selves as we discuss more extensively in Sec. III.

III SYSTEM ATIC ANALYSIS OF SYM M ETR ES OF THE M ODELS

If we want to search for the sym metry of the system in question described by a one-band lattice H am iltonian as in our models, a general form of sym metry operators can be written as

where V;T;A;P or x are complex numbers with $T_1 = T_1$.

Calculating the commutation between S or S and the Hamiltonian in question, we can not the conditions which have to be satisfied by the coefcients V;T;A;P or x to render the operator S or S to be the symmetry of the system.

4 and 6 m ay need some explanation. Here we have assumed the lattice constant to be 1 m erely for simplicity. ~ denotes the d-dimensional vector whose elements are all and \tilde{j} is the d-dimensional integer vector which implies one site on the lattice. Then for the nearest neighbors j; k the relation $T_j^{14} + T_k^{23} = T_j^{13}$ $T_k^{24} = e^{i \tilde{j}} + e^{i \tilde{k}} = 0$ holds[14]. The above 6 generators form SO (4) SU (2)_S SU (2)_Y [6] whose generators are $\binom{12}{3}$; $\binom{34}{4}$; $\binom{14}{4}$; $\binom{34}{4}$; $\binom{$

By a sim ilar analysis (though it is clear from (2.3)) we not the sym metry operators for H $_{\rm H~eisen}^{\rm S}$; global $(S;\sim)$ and local $_{1}^{5}$. The rst 6 operators form O (4) SU (2) $_{\rm S}$ SU (2) $_{\rm Y}$ and, combined with $_{5}^{5}$ and 1, are enlarged to form U (2) $_{\rm S}$ U (2) whose generators are $((S;(1 \quad _{5}^{5})=2);(\sim;(1+ \quad _{5}^{5})=2))$. But

on the $P_{\rm F}\,$ restricted H ilbert space for this m odel this reduces to the U (2)s sym m etry.

For other models, the following commutation rules hold.

Noting that X ac with a;c = 1;2;3;4, P X acP (or X ac with a;c = 1;3;4), $P_F X ^{ac}P_F \text{ (or X }^{ff^0} \text{ with } f;f^0 = 3;4), \text{ and } P_B X ^{ac}P_B \text{ (or X }^{bb^0} \text{ with } b;b^0 = 1;2)}$ form U (2/2), U (1/2), U (2)_S and U (2) respectively where X = $^P_{j=1} X_j$, the sym m etries of the models are clear.
