Bosonization of the Low Energy Excitations of Ferm i Liquids

Abstract

We bosonize the low energy excitations of Ferm i Liquids in any number

of dimensions in the limit of long wavelengths. The bosons are coherent

superposition of electron-hole pairs and are related with the displacem ents of

the Ferm i Surface in some arbitrary direction. A coherent-state path integral

for the bosonized theory is derived and it is shown to represent histories of

the shape of the Ferm i Surface. The Landau equation for the sound waves is

shown to be exact in the sem iclassical approximation for the bosons.

The attempts of description of ferm ionic systems by bosons date to the early days of second quantization. In the early 50's Tomonaga [1], generalizing earlier work by Bloch [2] on sound waves in dense ferm i systems, gave an explicit construction of the Bloch waves for systems in one spacial dimension. His work was subsequently generalized by many authors [3] who derived an explicit ferm i-bose transmutation in one-dimensional systems. These works uncovered deep connections in relativistic eld theories (both ferm ionic and bosonic) and with condensed matter systems.

The success of the bosonization approach in one dimension is related to phase space considerations. Even for non-interacting ferm ions two excitations with arbitrarily low energies, m oving in the same direction move at the same speed (the Fermi velocity) and, hence, are alm ost a bound state. Consequently, even the weakest interactions can induce dram atic changes in the nature of the low lying states. These e ects are detected even in perturbation theory and result in the presence of marginal operators. In dimensions higher than one, phase space considerations change the physics of the low-lying states and there are no marginal operators left. This observation is at the root of the stability of the Landau theory of the Ferm i liquid [4]. It is, thus, hardly surprising that very few attempts have been m ade to generalize the bosonization approach to dimensions higher than one. The earliest serious attempt at bosonization in higher dimensions was carried out by Luther [5]. Luther constructed a generalized bosonization formula in terms of the uctuations of the Fermi Sea along radial directions in momentum space. Interest in the construction of bosonized versions of Ferm i liquids has been revived recently in the context of strongly correlated system s [6]. I hat particle hole excitations have bosonic character is well known since the early days of the Landau Theory, e.g. the sound waves (zero sound collective modes) of the Ferm i Surface of neutral liquids or plasm ons in charged Ferm i Liquids [7]. Haldane [8] has recently derived an algebra for the densities for a Ferm i Liquid in a form of a generalized K ac-M oody algebra (which is central to the construction in one dimension) (see also ref. [9]).

The main point of this article is to derive a description of the Ferm i Liquids as the physics of the dynam ics of the Ferm i Surface. The main reason to believe that the Ferm i

Surface is a real dynam ical entity is based on the following observation: the total energy of an interacting electronic system can be written as an integral in momentum space of the form $[10] E = {}^{P}{}_{R} E_{R}$. For the case of Ferm i Liquids, E_{R} has a discontinuity at the Ferm i Surface (exactly as for the case of the occupation number [11]). We can think of this discontinuity as due to the difference of energy density across the Ferm i Surface [12]. Hence, we can de nean energy per unit area of the Ferm i Surface, i.e. a surface tension. It readily follows that this surface tension is proportional to the quasiparticle residue and therefore it vanishes for Non-Ferm i Liquid behavior. From this point of view we see the Ferm i Surface as a drum head where the elementary excitations are the sound waves (and in particular the zero sound) which propagate on it. In this paper we will derive an elective bosonized theory for the dynam ics of these excitations.

Our starting point to approach this problem resembles the microscopic approaches for the foundations of Ferm i Liquid Theory [7]. However, instead of working with the dynamics of the response functions, we will work directly with the dynamics of operators as in the standard procedures of bosonization in one dimension. Our main result is the derivation of a bosonized theory of the uctuations of the shape of the Ferm i Surface. The main ingredients of our construction are an elective algebra for the local (in momentum space) of particle-hole operators valid in a Hilbert space restricted to the vicinity of the Ferm i Surface and a boson coherent state path-integral constructed from these states. In particular, we get a bosonized version of Landau's theory of the Ferm i Liquid in all dimensions, at zero temperature and at very low energies. The coherent-state path integral can be viewed as a sum over the histories of the shape of the Ferm i Surface, a bosonic shape led. For the case of the Landau ham iltonian we not that resulting bosonic action is quadratic in the shape leds. We not sound modes.

For simplicity we will consider a system of interacting spinless ferm ions (the spin index can be introduced without problems in the formalism). The density of ferm ions at some point r in the d dimensional space at some time t, is given by

where c_k^V and c_k are the creation and annihilation operator of an electron at some momentum k which obey the Fermionic algebra, $c_k^V; c_{k^0} = c_k; c_k, v$ where f::g is the anticom mutator and all other anticom mutation relations are zero. In the Fermi Liquid theory [7] the operator which appears in the r.h.s. of (1) determines the behavior of the system. We will concentrate on this operator which we will denote by

In particular, $n_0(K)$ is the number operator in momentum space. As in the standard approaches for the Ferm iLiquid theory we will concentrate our interest in regions close to the Ferm i Surface $(K K_F)$ and consider the long wavelength uctuations around these regions $(q \ ! \ 0)$.

The equal time commutation relation between the operators de ned in (2) is easily obtained. In the long wavelength \lim it (q! 0) we get

We are interested in the behavior of systems with a Hilbert space restricted to the vicinity of the Ferm i Surface. We do not the Hilbert space to be the led Ferm i Sea in the thermodynam ic limit $\mathfrak{F} S >$ and the tower of states obtained by acting nitely on it with local ferm ion operators. We will replace this commutation relation by a weaker identity valid in the restricted Hilbert space. Furthermore, we will make the explicit assumption that we are both in the thermodynamic limit (the momenta form a continuum) and that the Ferm i Surface is macroscopically large ($\mathfrak{p}_{\mathbb{F}}$! 1). Since the vectors \mathfrak{k} are at the Ferm i surface, \mathfrak{q} are very small compared to the the Ferm imomentum, in the restricted Hilbert space it is possible to replace the r.h.s. of (3) by their expectation value in the Filled Ferm i Sea $\mathfrak{F} S >$, namely,

where is the chemical potential, $_{\rm K}$ is the one-particle fermion spectrum (from which the Hilbert space is constructed) and ${\bf v}_{\rm K}={\bf r}_{\rm K}$ the velocity of the excitations. The terms ignored in (3) vanish as $\frac{1}{{\bf k}_{\rm F}^2}$ as the size of the Fermi Surface diverges. These are exactly the same assumptions that enter in the construction in one-dimension. Notice that the state ${\bf F}$ S > , which is used to normal-order the operators, is not necessarily the ground state of the system of interest. However, this approach will succeed only the true ground state belongs to the restricted space.

Hence, within this approximation the commutators of the operators n_q (K) become c-numbers, namely,

where we drop the last term in the rhs. of (3) because its matrix elements near the Ferm i Surface are down by powers of $\frac{1}{k_F}$ (the leading term being zero). We now do not be operator

where the sgn (q) is +1 if q is outside the Ferm i Surface and 1 if it is inside the Ferm i Surface. Observe that (6) is not well de ned at q = 0 which requires special care. We will come back to this issue below. The adjoint of (6) is sim ply,

where we used, from the de nition (2), that $n_q^{\gamma}(K) = n_q(K)$.

M oreover, from the commutation relations (5) we easily obtain,

all other com m utators vanish.

Eq. (8) and (9) show that the elementary excitations have bosonic character, electron-hole pairs, and are created and annihilated close to the Ferm i Surface by these operators, moreover, they span the Hilbert space of low energy. But we need an interpretation for these excitations. It is natural now to do not be coherent state [13]

where the sum (and all other sums that follow are restricted to be close to q! 0). Observe that from the denition (7) we have $a_q^y(K) = a_q^y(K)$ and therefore $u_q(K) = u_q(K)$. Using this property and the commutation relation (9) we not

which, together with (8), leads us to the eigenvalue equation,

It is easy to see that $u_q(K)$ is the displacement of the Ferm i Surface at the point K in the direction of q. Indeed, suppose we change the shape of the Ferm i surface at some point K by an amount u(K). The occupation number changes up to leading order by $\ln_0(K)i = \frac{e^{\ln_0(K)i}}{e^{i}}u(K) = v_K$ ($_K$)u(K) which is precisely the quantity which appears in (13). Hence, the coherent states of eq (10) represent deformed Ferm i Surfaces parametrized by the bosonic eld $u_q(K)$.

Next we de neam any-body state which is a direct product of the coherent states de ned above,

It is also possible to nd the resolution of the identity for this Hilbert space,

and we conclude, as expected, that they are overcomplete [14].

In order to study the dynam ics of these modes we can construct, from (17) and (18), a generating functional as a sum over the histories of the Ferm i Surface in terms of these coherent states in the form $Z = {}^R D^2 u$ expfiS [u]g where S is the action whose Lagrangian density is given by (h = 1),

where V is the volume of the system. Using (13) we write the Lagrangian density in the form

Notice that this action is quadratic in the elds and, therefore, the sem iclassical approximation is exact. The sem iclassical equations of motion for this action are given by the saddle point equation derived from L, namely,

is a partial integral equation. Observe that the vectors \tilde{k} are at the Ferm i Surface and, therefore, the above equation only depends on the solid angle, , and the velocity $\tilde{v}_{\tilde{k}}$. We can therefore integrate over the magnitude of \tilde{k}^0 and use that the density of states at the Ferm i Surface is given by, $\tilde{N}(0) = \frac{P}{\tilde{k}}(0)$. Therefore, in the thermodynamic limit we replace (23) by,

with $F_{k,k^0} = N$ (0) f_{k,k^0} : Eq (26) is the Landau equation of motion for sound waves (the collective modes) of a neutral Ferm iLiquid where f_{k,k^0} is the scattering am plitude for particle-hole pairs [7].

To understand the reason for this result we rewrite the Ham iltonian H in terms of the original operators (2). Using (6) and (7) we nd,

which gives the the change in the energy up to second order in the deviations n(K) of the Landau theory of the Ferm i Liquid when the Ferm i Surface changes from K_F to $K_F + K_F$ (). Observe that this Ham iltonian is interacting in terms of the original electrons. Recall that in one dimension the bosonized theory is also quadratic (in the absence of relevant operators).

We conclude therefore that our bosons represent sound waves which propagate around the Ferm i Surface at zero temperature. The solution of eq (26) will give the possible values for the frequencies of oscillation for these modes and they will depend essentially on the Landau parameters of the theory. The Landau equation, eq (26), yields solutions which represents both stable collective modes (\sounds") as well as solutions with imaginary frequency which represent the decay of these modes in the particle-hole continuum. The presence of this second type of solutions implies that the path integration must also be done over unstable con gurations. This behavior is a direct consequence of the phase space. Notice that in one dimension these unstable solutions are absent and only the collective mode is left.

In sum mary, in this paper we have shown that it is possible to bosonize the particle-hole elementary excitations of a Fermi Liquid in any number of dimensions consistently with the Landau Theory. We have shown that the bosons are coherent superposition of particle-hole pairs close to the Fermi Surface. We also have shown that the coherent states associated with these excitations are related with sound waves which propagate in the Fermi Surface. Our approach gives for simple Hamiltonian models, in the semiclassical limit, the Landau equation which describes the propagation of these sound waves.
