Products of R andom M atrices for D isordered System s

Abstract

P roducts of random transfer m atrices are applied to low dimensional disordered systems to evaluate numerically extensive quantities such as entropy and overlap probability distribution. The main advantage is the possibility to avoid numerical dimension. The method works for arbitrary disorder distributions at any temperature. 75.10 N r, 05.50.+ q, 02.50.+ s

Products of random transferm atrices are a powerful tool for the study of low dimensional system s [1]. Up to now they have been mainly used to evaluate free energies and correlation functions. From a form algoint of view, the other therm odynam ical quantities can be obtained by dimensional the free energy with respect to suitable parameters. However, in most of the cases, one has only numerical solutions and, expecially at low temperatures, a very high precision is required for a precise dimension. In practice, it is very dimensional to estimate quantities such as the entropy or the specific cheat even in a one dimensional disordered system.

The purpose of our letter is to introduce a new numerical method to evaluate thermodynamical quantities directly from the products of random transferm atrices avoiding numerical dimension. The method is motivated by the papers of Masuiet al. [2,3] on the study of the number of metastable states in one and two dimensional Ising disordered systems. As specific example we shall discuss the overlap probability distribution P (q) for zero and nite temperature for a one dimensional Ising chain. The method can be extended to higher dimensional systems with short range interactions.

An Ising chain consists of N Ising spins with nearest neighbour interactions in an external eld. The interactions and/or the local eld are random quenched variables. At zero tem – peratures the only states which are in portant are the metastable states in which the spin $_{i}$ is aligned with the totalm agnetic eld h acting on it. If we denote by $_{i}$ the spin con guration in the metastable state , the overlap between pairs of states is $q = (1=N)^{P}_{i}$ $_{i}$ $_{i}$ $_{i}$ where and denote a pair of metastable states, and the sum is extended to all the N spins. In general q depends on the realization of disorder and on the pair of states. The number of metastable states with a given overlap can be obtained from [4,5]

where H 1 and H 2 are the ham iltonian of two identical replicas of the system. The step – functions ensures that only the m etastable states are counted. The G ibbs weight exp (H) has been introduced to select the energy of the m etastable states. For any given value of the sum Eq. (1) will be dominated by metastable states of de ned energy. In the same way any given value of ! selects metastable states of de ned overlap. Due to the function in Eq. (1), the parameter is not necessary related to the temperature, but it can be seen as a Lagrange multiplier.

N $_N$ (!;), the number of m etastable states of a chain of length N for a given value of and !, can be written as a sum over the energies and overlaps

For large N the sum is dominated by the saddle point energy E $^{\rm 0}$ and overlap q^0 , so that we can write

Equation (1) can be written as a product of random matrices, so that the O seledec theorem ensures that in the therm odynam ic lim it the quantity in Eq. (3) is the same for alm ost all realizations of disorder [6,1]. Consequently one has the Legendre transform

where the bar denotes the average over the realizations of disorder. Here (!;) is the energy per spin and q = q(!;) the overlap selected by the chosen value of ! and . In particular the average overlap is obtained as [5]

and is the value of q where $\lim_{N \leq 1} (1=N) \ln N_N (q;)$ reaches its maximum value.

The key point is that not only $(1=N)\ln N_N$ (!;) but also q(!;) and (!;) can be computed directly from a product of transfer matrices.

We shall denote by S_i $(\frac{1}{i}; \frac{2}{i})$ the pair of spins at the same site in two replicas of the system. Equation (1) can then be written as a chain sum over S_i , i.e. as a product of the matrix $hS_{i+1}\hat{N}_i\hat{F}_i$. From Eq. (1) it is easy to see that \hat{N}_i obeys the recursion relation

with an initial matrix \hat{N}_0^0 with all elements equal and with their sum equal to unity. Here E_i is the energy of the spin $_i$. The matrix $\hat{N}_{i\ 1}^0$ is obtained by rescaling $\hat{N}_{i\ 1}$ by the factor $n_{i\ 1}$ given by the sum of all its elements. This ensures that the sum of the elements of $\hat{N}_{i\ 1}^0$ is one.

The matrix \hat{N}_i gives the number of metastable states of a chain of i spins for all the possible congurations of S_i and S_{i+1} . Thus the logarithm of the number of metastable states per spin, averaged over the disorder, is

The value of q and is obtained from the derivative of N_N (!;) with respect to ! and , respectively. These can be expressed in term s of the matrices derivative of $\hat{N_i}$. The matrix $\hat{O}_{i\ 1}^0$ is related to $\hat{O_{i\ 1}}$ as

where o_i is the sum of the elements of \hat{O}_i .

From the renorm alization Eq. (10) follows that the value of q for the chosen value of ! and is given by the weighted average of o_i as

The m ethod can be generalized to nite tem peratures. In this case we have to count all the states, and not just the m etastable ones. Thus W e should thus elim inate the -functions in the above equations. M oreover, in this case 1 is the tem perature of the system .

In the absence of the -functions, which relates the states in i 1, i and i+1, we can use a simpler algorithm [7]. The equations are form ally the same, but with matrices replaced by vectors. Therefore, in analogy with the zero temperature case, we introduce the vector N $_{i}$ (S $_{i+1}$) which now obeys the recursion relation

where the initial vector N $_{0}^{0}$ (S₁) has all the elements equal to one. At each iteration the vector is normalized so that the sum of the elements of N $_{i 1}^{0}$ (S_i) is one. To evaluate q and we introduce the vectors of the derivatives of N $_{i}$ (S_{i+1}) with respect to ! and , respectively. For example, taking the derivative with respect to ! of Eq. (12) leads to the vector O $_{i}$ (S_{i+1}) = (Q=Q!)N $_{i}$ (S_{i+1}) obeying the recursion relation

with initial condition O $_0^0$ (S $_1$) = 0. The vector O $_i$ and O $_i^0$ are related by

where as above n_i and o_i are the sum of the elements of N_i (S_{i+1}) and O_i (S_{i+1}), respectively. The average energy is evaluated in a similar way. The speci c heat and susceptibility can also be computed with this method by introducing the matrix or the vector of second derivative.

We have analyzed only Ising chains, but our arguments apply to any formally one dimensional system and can be easily generalized to two and three dimensional systems by considering strips and bars, respectively. The numerical calculation becomes, however, very heavy since the dimension of the transfermatrices and vectors grows exponentially with the transversal dimension of the system.

Let us apply thism ethod to the Ising chain in a random eld described by the ham iltonian

where h_i is a random local eld. W ithout loosing in generality we can take J = 1. It is known [8,9] that if h_i are distributed with probability distribution

$$P(h_i) = p(h_i h) + (1 p)(h + h)$$

The parabolic shape of $\lim_{N \le 1} (1=N) \ln N_N$ (q;) means that the overlap probability distribution P (q) is selfaveraging and equal to a -function on the average value q. This is a general result for one dimensional system s with short range interactions [7]. We conclude by noting that since for T ! 0 the probability distribution P (q) remains a -function [7], the lim it T ! 0 is not singular and the results of the zero tem perature method perfectly reproduce those of the T ! 0 lim it of the nite tem perature method.

In conclusion we have described a method to evaluate all therm odynamical quantities in terms of products of random transfer matrices avoiding numerical dierentiation. The method can be used, in principle, also for two and three dimensional systems. The method is not restricted to spin systems, but it can be used in any other problems which involves products of transfer matrices, e.g. directed polymers.
