Scattering M atrix and Excitation Spectrum

of the Hubbard M odel

ABSTRACT

We consider the one-dimensional Hubbard model at half lling. We show that both excitation spectrum and S-matrix are determined by the SO (4) symmetry of the model. The complete set of excitations is given by the scattering states four elementary excitations, which form the fundamental representation of SO (4). We evaluate the exact S-matrix, which satis es the Yang-Baxter relation. The results for the repulsive and attractive Hubbard model are related by an interchange of spin and charge degrees of freedom.

Strongly correlated electronic system s are currently under intense study in relation with high- T_c superconductivity. The two-dimensional Hubbard model is in the very center of these investigations. It is believed to share important features with its one-dimensional analog^[1]. A very interesting problem is the separation of spin and charge in the Hubbard model in one^[2,3] and two dimensions^[4]. In one spatial dimension the Hubbard model can be solved exactly by means of the Bethe Ansatz^[5]. The Hubbard ham iltonian is given by the following expression

Here $c_{j;}^{y}$ are canonical ferm ionic creation operators on the lattice, j labels the sites of a chain of even length L, labels the spin degrees of freedom, U is the coupling constant, and $n_{j;} = c_{j;}^{y} c_{j;}$ is the number operator for spin on site j. The ham iltonian (1) is invariant under a SO (4) = SU (2) SU (2)/Z₂ algebra^[6{8}]. The two SU (2) algebras are the spin SU (2) with generators

and the -SU (2) algebra with generators

All 6 generators commute with the ham iltonian (1). Below we rst give a complete classi cation of the excitation spectrum of the repulsive Hubbard model by means of its SO (4) symmetry. The results are such that the spin and charge degrees of freedom completely separate from one another on the level of the elementary excitations. We then determine the exact two-particle S-matrix, which is of importance in the study of transport properties^[9]. The S-matrix is SO (4) invariant and satis es the Yang-Baxter relation, which implies the 2-particle reducibility of the N-body scattering matrix. We conclude with a discussion of excitation spectrum and S-matrix of the attractive Hubbard model. Detailed derivations of the results presented in this letter can be found in [10].

Let us now turn to a classi cation of the excitation spectrum over the repulsive half-led ground state (U > 0). In them any previous works on this problem (m ost notably [2,3,11]) the correct dispersions form any excitations were obtained. However, the Lie-algebraic structure of the excitation spectrum was not fully revealed. We classify all excitations with respect to representations of the SO (4) symmetry algebra. The spectrum is described by the scattering states of four elementary excitations only. Two of the elementary excitations carry spin

but no charge. This means that they transform in the spin- $\frac{1}{2}$ representation of the spin-SU (2), and are a singlet with respect to the -SU (2). The resulting SO (4)-representation is denoted by $(\frac{1}{2};0)$. We shall call these two excitations spinons (They are similar to the two elementary excitations in the spin- $\frac{1}{2}$ H eisenberg XXX antiferrom agnet at zero m agnetic eld^[12(14]). Energy and momentum of these particles are expressed in terms of a spectral parameter . It plays the same role as the rapidity for the case of relativistic particles. Energy $_{\rm s}$ () and momentum p_s()

Here J_n (!) are Bessel functions. This dispersion relation was obtained in [2,11].

The other two elementary excitations carry charge e but no spin. They are called holon and antiholon and form the $(0;\frac{1}{2})$ -representation of SO (4), i.e. they transform in the spin $-\frac{1}{2}$ representation of the -SU (2) (3) and are a singlet with respect to the spin-SU (2) (2). The momentum of holon and antiholon di ers by as ^y does not commute with the momentum operator but changes the momentum by . The holon carries charge + e, where e is the charge of the electron. Energy and momentum are param etrized by the \bare" momentum k^h of the holon, and sin (k^h) plays the role of the spectral param eter. Energy and momentum are given by^B

The antiholon can be obtained from the wave function of the holon by applying the operator $^{\rm y}$. Its energy and momentum are found to be

The spectrum of all excitations of the repulsive half-lled Hubbard model is given by the scattering states of the four elementary excitations listed above. The proof of this is similar to the proof of the corresponding statement in the spin $\frac{1}{2}$ Heisenberg XXX antiferrom agnet^[12(14]. The basis of the proof is a theorem of [15], which states that (i) All Bethe Ansatz states with N $_{\#}$ < N $_{\#}$ below (or at) half-lling are lowest weight states of the SO (4) symmetry algebra, and (ii) The set of states obtained by acting with the SO (4) raising operators on the Bethe states is complete, i.e. it forms a basis of the electronic Hilbert space. This theorem implies that a complete set of excitations over the ground state is obtained by constructing excited states by means of the Bethe Ansatz and then act on these with the SO (4) raising operators. A complete set of B ethe Ansatz excitations can be constructed by using the zero-temperature limit of the Therm odynamic B ethe Ansatz^[16]. Like in the XXX-antiferrom agnet^[12,13] elementary excitations always occur in pairs. This is due to the Z_2 -factor, which projects out all representations of SU (2) SU (2) with half-odd integer quantum number: $S^z + z = N_{\#} + \frac{L}{2}$ (L is even). A coordingly there are no one-particle excitations, and m ore generally no excitations with and odd number of particles (spinons or holons/antiholons) in the half-lied Hubbard m odel.

In order to construct the two-particle scattering matrix a complete knowledge of all excitations in the two-particle sector is necessary. In the two-particle sector there exist three kinds of excitations: Scattering states of two spinons (forming the representation (1;0) (0;0)); Scattering states of two holons (in the representation (0;1) (0;0)); and nally scattering states of one holon and one spinon (forming the $(\frac{1}{2};\frac{1}{2})$ representation of SO (4)). Bethe states in the Hubbard model are parametrized by sets of spectral parameters fk_jg ; fⁿg; fⁿg, which are subject to the following sets of coupled algebraic equations^[16]

Here L = 2 odd is the even length of the lattice, I_j , J^n , and J^{0n} are integer or half-odd integer num bers, N_e is the total num ber of electrons, $M^0 = \prod_{n=1}^{1} M_n^0$, (x) = 2arctan(x), and

The spectral parameters ⁿ, ⁰ⁿ are the real centers of complex roots (\strings" of lenght n) of the Lieb-W u equations (see [16]), M_n and M_n⁰ are the numbers of -strings of length n and ⁰-strings of length n in a speci c solution of the system (7). The integer (half-odd integer) numbers in (7) have the ranges

where $t_{mn} = 2m \inf ; ng_{mn}$. Each set of \integers" $fI_jg; fJ^ng; fJ^ng$ is in one-to-one correspondence with a set of spectral parameters, which in turn unambiguously species one eigenstate of the ham iltonian (1). Thus the ground state and all excited states can be constructed by specifying sets of \integers" in (7) and then taking the therm odynam ic lim it, in which (7) reduce to coupled integral equations (see e.g. [5,2,3,11]). The half-lled ground state is obtained by taking $M_1 = \frac{L}{2}$ and $N_e = L$ in (7) ($M_n = 0.8n_2; M_n^0 = 0.8n$) and lling all vacancies for the \integers" I_j and J^1 symmetrically around zero^[5]. This amounts to lling the Ferm i seas of spectral parameters k_j between and , and of ¹ between

1 and 1. The ground state is an SO (4) singlet (0;0).

The scattering states of two spinons are similar to the the XXX -antiferrom agnet^[12{14]. The lowest weight state of the spin-triplet ($S = 1, S^z = 1, = 0$) is obtained by diminishing the number of down spins by one as compared to the ground state $M_1 = \frac{L}{2}$ 1. This enlarges the allowed range of \integers" J¹ (10) by one, so that we end up with two holes in the Ferm i sea of the ¹. We denote the corresponding spectral parameters by ^h₁ and ^h₂. Energy and momentum of this state are given in term s of the two spinons according to $E_{ST} = {}_{s}({}_{1}^{h}) + {}_{s}({}_{2}^{h})$ and $P_{ST} = p_{s}({}_{1}^{h}) + p_{s}({}_{2}^{h})$. The lowest weight theorem cited above guarantees that not only $S^{z} = 1$ but that also S = 1. The two other states of the triplet can be obtained by application of S^{y} .

The S = 0; = 0 spin-singlet scattering state of two spinons is constructed by choosing $M_1 = \frac{L}{2}$ 2 and $M_2 = 1$. This introduces again two holes in the ¹-distribution. In addition there is one -string of lenght 2 present. The allowed range of \integers" for the 2-string (10) is 0 only. Solving the equation (7) for the spectral parameter ⁽²⁾ we nd ⁽²⁾ = $\frac{\frac{h}{1} + \frac{h}{2}}{2}$. Energy and momentum of the singlet are the same as for the triplet.

The scattering state of a spinon (with spin up) and a holon can be constructed from the Bethe Ansatz by choosing $N_e = L - 1$ and $M_1 = \frac{L}{2} - 1$, which introduces one hole in the distribution of the k_j 's and the ⁻¹'s respectively. We denote the corresponding spectral parameters by k^h and ^{-h}. The spin of this excitation is $S = \frac{1}{2} = ; S^z = -\frac{1}{2} = z^z$. Accordingly it carries charge + e. Energy and momentum are given by $E_{sc} = -s(-h) + -h(k^h)$ and $P_{sc} = p_s(-h) + p_h(k^h)$. The other three states of the SO (4) multiplet can be obtained by applying S^y , ^y, and both.

The scattering state of two holons with = 1; z = 1; S = 0 (charge triplet) is constructed by making two holes in the distribution of k_{j} 's ($N_{e} = L$ 2). We denote the corresponding spectral parameters by k_{1}^{h} and k_{2}^{h} . Energy and momentum of this state are given by $E_{CT} = {}_{h} (k_{1}^{h}) + {}_{h} (k_{2}^{h})$ and $P_{CT} = p_{h} (k_{1}^{h}) + p_{h} (k_{2}^{h})$. The other two states of them ultiplet are obtained by applying y .

The charge singlet S = 0; = 0 = z scattering state is characterized by taking $N_e = L$, $M_1 = \frac{L}{2}$ 1 and $M^{01} = 1$ (insertion of a bound state of two k's and one ⁰). This introduces again two holes in the k_j Ferm i sea, and in addition there is a so-called ⁰-string present. The spectral parameter of the ⁰-string is determined by the system (8) to be

Energy and momentum of the -singlet are } \mathbb{E}_{CS} = \ _{ah}(k_1^h) + \ _{h}(k_2^h) \text{ and } \mathbb{P}_{CS} = \ p_{ah}(k_1^h) + \ p_{h}(k_2^h) \text{. This completes our discription of all two-particle states.} \end{array}$

We now turn to the evaluation of the two-body scattering matrix. In Quantum Mechanics the scattering matrix can be extracted from the asymptotics of the wave-function of the scattering state^[17]. The scattering of the collective excitations described above is a quantum mechanical problem. However, the ground state is highly nontrivial, as are the many-body wave functions given by the Bethe Ansatz. In [18] it was explained how to modify the rules of quantum mechanical scattering theory in order to obtain the correct scattering matrix for Bethe Ansatz solvable models ([18] deals with the derivation of Zam olodchikov's S-m atrix starting from the Bethe Ansatz). The same method has been applied to the case of the XXX Heisenberg model^[12{14]} (see also [19]). More precisely, the method of [18] perm its the evaluation of the logarithm ic derivative of the S-m atrix, and thus the S-m atrix up to an overall constant factor. We have xed this factor by considering the in nite U limit of holon-holon scattering. In this lim it the S-m atrix must reduce to the one of free ferm ions, which is equal to 1. This allows us to solve the problem of xing the constant factor in the S-m atrix of the XXX - antiferrom agnet: the S-m atrix for that m odel is given by the expression (11). The com plete S-m atrix for the Hubbard m odel is 16 16 dim ensional and blockdiagonal. The block describing scattering of two spinons (with spectral parameters $\frac{h}{1}$ and $\frac{h}{2}$) is 4 4 matrix of the form

The physical region is de ned as > 0 (only then scattering takes place). As a function of the variable the S-m atrix (11) coincides with the S-m atrix of the spin- $\frac{1}{2}$ H eisenberg antiferrom agnet. This does not hold as a function of the momentum. The 4 d block describing the scattering of two charged particles (holons/antiholons) with spectral parameters sin (k_1^h) and sin (k_2^h) is

where $=\frac{\sin(k_1^h) \sin(k_2^h)}{2U} > 0$. The block describing the scattering of one spinon on one holon/antiholon is purely diagonal

The last block describes the scattering of one holon/antiholon on one spinon and is given by the same expression (14), where now $=\frac{\sin(k^h)^{-h}}{2U} > 0$. The complete S-m atrix satisfies the Yang-Baxter equation, which implies that the many-body scattering matrix factorizes into the product of two-body S-m atrices. C learly the S-m atrix rejects the SO (4) symmetry of the model. The analytical structure of the S-m atrix is as follows: The allowed strip for rapidities is jim (^h)j U, and jim (k^h)j 2U. The S-m atrix has poles in the complex rapidity plane, but all of them are unphysical and do not correspond to bound states.

The structure of elementary excitations in the attractive Hubbard model is as follows: there is a total of four elementary excitations, grouped into doublets of the spin and -SU (2) respectively. The chargeless spin-carriers have the dispersion

which up to the shift of m on entum by $\frac{1}{2}$ is the same as for the holon in the repulsive case. The spinless charge-carriers (one particle, one hole) have the dispersions^[20]

which are (up to a constant in the momenta) the same as the spinon dispersions in the repulsive case. The S-m atrix in the attractive case coincides with the one for the repulsive case as a function of the unform ising parameter . There also exists a naive argument for the relation of attractive and repulsive H ubbard m odel by an interchange of charge and spin degrees of freedom. It is a well known fact that attractive and repulsive H ubbard m odel are connected by the particle-hole transformation (for spin-up only)

under which the ham iltonian (1) transforms according to H (U) ! H (U). The transformation (17) electively interchanges spin and charge degrees of freedom, e.g. transforms the spin-SU (2) (2) into the -SU (2) (3) and vice versa.

In this letter we classi ed the excitation spectrum and the Scattering matrix of the one-dimensional Hubbard model by means of its SO (4) symmetry. This emphasizes the importance of symmetries in systems of strongly correlated electrons. The S-matrix is an

in portant tool in the study of transport properties^{9]}. The classi cation of elementary excitations into spinons (which carry spin but no charge) and holons/antiholons (which carry charge but no spin) gives a precise meaning to spin-and charge separation in one and twodimensional models of correlated electrons. In integrable models the S-matrix is often proportional to the R-matrix. In [21] a R-matrix for an embedding of the Hubbard ham iltonian in a commuting family of transfer matrices was derived. This R-matrix, which belongs to a fundamental model (where L-operator and R-matrix are essentially identical^[19]), is dierent from our S-matrix. It would be interesting to search for a dierent embedding of the Hubbard ham iltonian, using a SO (4) invariant R-matrix proportional to our S-matrix. The L-operator for such a construction would have to be dierent from the R-matrix.
