THE ROKHSAR-KIVELSON MODEL OF QUANTUM DIMERS AS A GAS OF FREE FERM ION IC STRINGS

Abstract

The 2 + 1-dimensional quantum dimer model on a square lattice, proposed by Rokhsar and K ivelson as a theory of layered superconductivity, is shown to be equivalent to a many-body theory of free, transversely oscillating strings obeying Ferm i statistics. A Jordan-W igner construction for string eld operators is presented. Topological defects are shown to be linearly con ned in pairs by dynam ical strings. Exact upper and lower bounds are placed on the ground-state energy and the string tension. It is argued that the system is in a spin- uid phase and that there is no gap in the excitation spectrum.

1 Introduction

In the last few years, progress has been m ade in exactly solving statistical and quantum m odels in a total of three dimensions. Some cases of the six-edge statistical m odel in three dimensions¹, the U (1) lattice gauge m agnet² and the quantum dimer m odel on a hexagonal lattice³ in 2 + 1 dimensions have been solved exactly.

In this article, the Rokhsar-K ivelson model (RKM) on the square lattice⁴ will studied from a similiar point of view. This system is a quantum dimermodel on a square lattice, proposed as an elective theory of layered superconductors. It is found that, like the system's solved in references 1,2,3, the RKM is a system of non-interacting Fermionic strings. While the one-string problem is not, unfortunately, exactly solvable, it can be understood physically without much e ort. More general models with a \diagonal" coupling or with dynamical holons⁴ are not accessible to the techniques used here.

It is found here that the behaviour of the RKM without the \diagonal" term is qualitatively similiar to that of the quantum dimermodel on the hexagonal lattice; topological defects (holons) are conned into pairs, but there is no gap in the spectrum and no long-range order. The ground state can be thus be thought of as a spin uid. It can be shown that dimer congurations are the ground states of a particular H eisenberg model invented by K lein⁵. Presumably introducing further interactions in this H eisenberg model gives a system whose low-lying states are described by the RKM.

It is perhaps appropriate at this point to review some of the history and issues surrounding the RKM and related problem s. Rokhsar and Kivelson's model has two parameters; a \resonance" coupling J and a \diagonal" coupling V. These are coe cients of two di erent terms in the Ham iltonian. They were able to solve the m odel at V = J where they found that the ground state was a superposition of every possible dimer state. For V > J they showed that the ground state was a spinstaggered" state with spontaneous breaking of rotational and translation invariance. They suggested that for $V < J a \ spin-liquid$ " state with no long-range order should appear. They also argued that a \valence-bond-solid" or \column" phase should appear for V < 0. In this phase so-called column con gurations dom inate, leading to a four-fold degeneracy of the ground state Later, D om bre and K otliar, who exam ined mean eld theory for the Hubbard model and Read and Sachdev⁶, who studied SU (N) generalizations of square-lattice H eisenberg antiferrom agnets form ally sim iliar to the RKM, did not nd a spin-liquid phase, but did nd a valence-bond-solid phase appeared⁷. The RKM model was then examined directly by Fradkin and Kivelson⁸ who used dilute gas methods for the V = 0 case and Sachdev, who studied the same problem num erically⁹. Fradkin and Kivelson argued that the V = 0 ground state was a valence-bond-solid state. Sachdev found that the susceptibility of the order parameter for valence-bond-solid formation was divergent with the volume, and therby suggested that such a solid form ed for all V < J. Read and Sachdev later extended their analysis to antiferrom agnets on hexagonal lattices and argued that valence-bond-solid form ation took place there as well¹⁰. For at least som e H eisenberg m odels, the ground state is a valence-bond solid¹¹. In reference 3, it was shown that a hexagonal-lattice quantum dimerm odel was in a gapless uid phase¹².

It will be shown here that the ground state of the square-lattice RKM at V = 0 is a uid and not a solid. The absence of long-range order is consistent with Rokhsar and K ivelson's original picture of superconductivity. There do appear to be power-law correlations which may explain Sachdev's results⁹.

In this paper, the string form ulation is arrived at through the use of a generalization of the Jordan-W igner transform ation due to Dotsenko and Polyakov for the three-dimensional Ising model¹³. In previous solutions^{1,2,3} antisym metrized string wave functions were used to diagonalize the H am iltonian. The main reason for presenting the more form al Jordan-W igner construction here is that some readers may nd it more straightforward as well as more interesting from a mathematical point of view.

The RKM will rst be converted to a triangular-lattice problem which resembles the neutralU (1) lattice gauge m agnet^{2,14,15}. Next, the H ilbert space will be m apped into that of strings with an in nitely short-range, in nitely repulsive interaction. The interaction is removed by quantizing the strings as Ferm ions. The eigenfunctions and eigenvalues of the RKM can thereby be written in terms of the one-string eigenvectors and eigenvalues. The one-string problem is not exactly solvable, but physical arguments indicate its low-lying spectrum is that of a 1 + 1-dimensional massless quantum eld theory of D irac particles. It is argued that the spectrum of the full RKM is gapless. A linear potential exists between topological defects, due to the formation of dynamical strings. Exact upper and lower bounds are found on both the ground-state energy and the string tension.

2 The Rokhsar-Kivelson Model

The sites of a two-dimensional lattice will be labeled by pairs of integers $(y^1; y^2) = y$ and bonds (y; i) connecting y to $y + \hat{i}$. A spin state $\hat{j}_s(y; i) > \hat{j}_s$ dened on each bond, by s(y; i) = 1=2 when a dimerispresent at (y; i) and s(y; i) = 1=2, when no dimeris present at (y; i). A dimer represents a -valence bond between two nearest-neighbor copper atom s^{16} . The Ham iltonian of the RKM is⁴

Here (y;i) = (1=2)(x(y;i)), $i^{y}(y;i)$, where x, y and z are the usual Pauli matrices. The Ham iltonian density applied to a plaquette (square) changes that plaquettes's state according to the nule:

with all other states annihilated. The RKM is a U (1) lattice gauge theory 2,14,15 ; H commutes with the Gauss' law operator de ned at a site y, adjacent to four links l

The Ham iltonian is identical to that of the model discussed in reference 2, though the Gauss' law condition (2) is dimension. The gauge-invariant W ilson loop operator de ned on a closed contour of consecutive links $C = fl_1; l_2; ...; l_p g$ is

A topological defect is a site y at which no dimers are attached. Such defects are characterized by

In reference 4 a second \diagonal" term was added to the Ham iltonian, namely

In this paper, only the V = 0 case will be considered.

3 Reduction to a Triangular Lattice

The RKM can be reduced to a spin model on a triangular lattice. The triangular lattice will be drawn as a square lattice with extra diagonal bonds. Upon making this reduction, 90° rotational invariance is no longer manifest. Consider the bonds (y;2), with $y^1 + y^2$ odd. These are half the bonds parallel to $\hat{2}$. The occupation state at each of these bonds is a redundant degree of freedom. All such bonds may be contracted to points, leaving a triangular lattice. To see this, consider the possible dim er con gurations around one such bond:

The middle bond is now contracted to a point (Fig.1). The sites of the triangular lattice will be labeled by $x = (x_1; x_2)$ and the bonds connecting x to $x + \hat{1}$, connecting x to $x + \hat{2}$ and connecting x to $x - \hat{1} - \hat{2}$ by (x;1), (x;2) and (x;3) respectively. The state at each bond is represented by a spin $j_5(x;i) > .$ Next apply the unitary transform ation which ips the spins at all horizontal bonds $a_x - x(x;1)$ (i.e. occupied bonds at (x;1) are now replaced by empty bonds and vice-versa). The possible con gurations at a site of the triangular lattice are now :

This H commutes with g(x) de ned in (9). It interchanges states on triangles according to:

A typical con guration of the square lattice is shown in Fig. 2. The basis states of the H ilbert space are strings extending across the lattice. Two strings never overlap on any link.

The strings are not arbitrary paths. Any unit segment of string on a vertical bond (that is, a bond in the 2-direction) or on a bond at a 45° (that is, a bond of string parallel to $\hat{1}$ $\hat{2}$) must be attached at the top to a segment of string on a

horizontal bond (in the 1-direction), coming from the left, unless the vertical bond is on the boundary. In addition, a segment of string on a vertical or 45° bond must be attached at the bottom to a segment of string on a horizontal bond, going o to the right. Three in possible con gurations for two adjacent segments of a single string are:

The strings interact though a short-range, in nitely strong repulsive interaction at links. System s of Bosonic strings with such \hard-core" repulsion in 2+1 dimensions are equivalent to system s of free Ferm ionic strings^{2,3}.

A ssume the original lattice of the RKM has the shape of a rectangle of vertical dimension 2N and horizontal dimension L, where L is odd. Select for contraction those links (y;2) for which $y^1 + y^2$ is an odd number. Then the resulting triangular lattice has the appearance shown at the bottom of Fig.1. It is possible to see that all but one site of the left boundary $x^1 = 1$ of the triangular lattice is an endpoint of exactly one string. There are therefore N strings attached to this boundary (it contains N + 1 sites). The site which is not an endpoint of a string is that at the bottom of the left boundary (it is possible for a string to pass though this site, but not end there). Sim iliarly, all but one site of the right boundary $x^1 = L$ of the triangular lattice is an endpoint of the right boundary. The number of strings is conserved by the H am iltonian. W ith this choice of boundary condition, the top and bottom boundaries place no restriction on the shape a string may take.

If the system were in a valence-bond-solid phase, the ground state would be spontaneously broken. It would be dom inated by one of the four column con gurations shown in Fig.3. On the triangular lattice the column con gurations become those shown in Fig.4. It will be argued here, that such symmetry breaking does not take place (provided there is no diagonal term (6) included in the Ham iltonian). The argument hinges on the string spectrum being gapless. In fact, a much simpler argument can be made against valence-bond-solid formation. Consider any plaquette containing two dimers in a column con guration. The state of this plaquette is completely free to uctuate. There is no preference for the two dimers on this plaquette to be aligned along the 1-direction or the 2-direction. The con guration of each of the other plaquettes containing two dimers can also uctuate. The solid cannot maintain its integrity and must melt.

4 The One-String Problem

Each string is made of segments attached end-to-end. A string con guration is described by a sequence of num bers X (k), each an integer or half-integer, de ned below. The midpoint of each segment has 1-coordinate $x^1 = n=2 + 1=2$, n even, while the endpoints have 1-coordinates $x^1 = n=2 + 1=2$, n odd. In this way, both midpoints and endpoints of segments are labeled by the horizontal coordinate n. The num ber X (k) is an integer or half-integer equal to the value of x^2 at the midpoint of the segment of string at $x^1 = k + 1=2$. Clearly n = 2k. The eigenstates of the one-string H amiltonian in the Schrodinger picture are wave functionals S [X] = S [X (1); ...; X (k); ...; X (L)]. Though the links (x;1) with $x^1 = L$ do not exist on the triangular lattice, the num ber X (L) is still needed. The purpose of X (L) is to specify how the string ends at the right boundary. These string wave functionals vanish for any choice of [X] which does not correspond to a string. De ne the raising and lowering operators on this space of wave-functionals by

The string con guration is next m apped into a one-dimensional spin con guration fs(n)g, s(n) = 1. A spin at odd n is down unless the string segment at $x^1 = n=2$ is parallel to $\hat{2}$. A spins at even n is down, unless the string segment whose m idpoint is $x^1 = n=2$ is tilted at 45° , i.e. parallel to $\hat{1}$ $\hat{2}$. The one-string H am iltonian is equivalent to a spin-chain H am iltonian under an inner-product-preserving transform ation A:

Certain restrictions must be placed on spin con gurations if they are to be identi ed by (13) with string con gurations. They are:

- 1. the spins s(n) and s(n + 1) cannot both be +1,
- 2. the spins s(21) and s(21+2) cannot both be +1,

The spin-chain Ham iltonian which describes the string is

where is taken to in nity to enforce the above restrictions 1 and 2. Notice that the last term breaks the invariance under translation by one lattice spacing (this invariance is also broken by the boundary conditions). The number of up spins is xed by virtue of the fact that the spin chain has a global U (1) invariance:

The Hamiltonian (14) describes spinless Fermions which can hop from site to site, with strong nearest-neighbor and next-to-nearest-neighbor repulsion. The Fermion elds are constructed through the Jordan-W igner transform ation¹⁷:

These obey $[\begin{array}{c} y \\ n \end{array}; \\ m \end{array}]_{+} = \\ n,m \end{array}$, with all other anticom mutators vanishing. The lling fraction must be 1=4 by virtue of the boundary conditions (this is consistent with (15)). Ferm ions separated from each other by more than two lattice spacings have the usual hopping dispersion relation $E_k = 2J \cos k$, hence a Ferm i sea form s in the ground state of (14). If the second term in (14) is ignored, the low -lying excitations are one-dimensional massless D irac particles¹⁷. It will be argued that this is true for the system (14) as well.

The additional repulsive interactions in (14) should not produce a gap above the Ferm i sea. There are two reasons why this should be so. The rst of these is that a repulsive short-range interaction cannot form bound states in the Ferm i uid. Secondly, the spin-chain is parity-invariant (in the sense that a spin at a given site is coupled in the same fashion to its left neighbor as its right neighbor), so that the left and right D irac sectors should be uncoupled, which is inconsistent with a gap. However, I do not have a proof of this claim.

The Ham iltonian (14) cannot be solved exactly, but it should be possible to study its spectrum by numerical methods. It is possible, however, to nd exact upper and lower bounds for its ground-state energy. While this can actually be done for the nite open chain, I will do so only for the ground-state energy per unit length in the therm odynam ic limit.

For simplicity, assume that the H am iltonian (14 is put on lattice of length L with periodic boundary conditions, i.e. $i_{n+L}^i = i_n^i$. Consider the H am iltonian

on such a lattice and where, as before, is taken to in nity. The number R is the range of the potential and can be any non-negative integer (The R = 0 case is the XX chain¹⁷). For a speci ed lling fraction f = N =L, the ground-state energy per site of h₁ and h₂ will be shown to be lower and upper bounds, respectively, of the ground-state energy per site of h. In addition the ground-state energy per site of h_R can be explicitly calculated for any lling fraction. This model was considered recently by G om ez-Santos, who noted that for particular llings its solution is a Luttinger liquid¹⁸.

It is straightforward to nd all the eigenstates and eigenvalues of h_R . Consider the one-up-spin eigenstates. These states are labeled by wave number k = 2 p=L where p = 0; :::;L 1:

where the sum is over 1 $n_1 < n_2 < \leq n$ L.A state of the form (19) is an eigenstate of h_R if and only if it is an eigenstate of the XX model (free Ferm ions) and satis es the condition that $(n_1; :::; n_N) = 0$ if for some r, n_{r+1} n_r R. Thus any eigenstate of h_{R+1} is also an eigenstate of h_R with the same eigenvalue. A state of the form (19) is an eigenstate of h if and only if it is an eigenstate of the XX model and satis es the condition that $(n_1; :::; n_N) = 0$ if either :

- 1. n_{r+1} n_r 1, for any r,
- 2. n_{2p+1} n_{2p} 2, for any p.

These conditions in ply that any eigenstate of h_2 is also an eigenstate of h and any eigenstate of h is also an eigenstate of h_1 . The simplest way to calculate $_{R}$ (f) is to notice that h_{R} is just a free Fermion problem (XX chain) on an elective lattice of size $L^{0} = L$ NR = L(1 fR). The elective lling fraction is

Now L_0^0 (f⁰) is by de nition, the ground-state energy of the free Ferm ion problem on a lattice of size L^0 and lling fraction f⁰. The ground-state energy per site of h_R at lling fraction f m ust therefore be

The ground-state energy density the free Ferm i problem on a large lattice with this lling fraction is

In the therm odynam ic limit, the energy per site of the string on a lattice on dimensions N L is given by = (1=4)=2. From (22) and (23) the inequality (20) becomes

5 The N-String Problem

The solution of the N-string problem is essentially the same as in references 2 and 3. First the one-string Ham iltonian is found. Then the product of N one-string eigenfunctionals is antisymmetrized in each X (n). This gives an eigenfunctional of $H_1 + \dots + H_N$, where H_k is the Ham iltonian for the k^{th} string. It is in fact an eigenfunctional of the full Ham iltonian, since it is guaranteed to vanish whenever strings overlap.

A ntisym m etrization can \break up" som e of the strings; it leads to choices of [X] which are not continuously connected strings. The wave functionals autom atically vanish whenever this is the case.

Let S_N be the permutation group of N objects. Given N strings, there are N values of X (k) for each k, which will be labeled X¹(k); ...;X^N(k). Permutations s_k " S_N will act by sending the values of X (k) to X $s_1(1)$ (k); ...;X $s_k(N)$ (k). The antisymmetrized product of N string wave functionals quantum numbers (which are the momenta of Fermions in each string) f g_j for j = 1; ...; N is

The argument [X] is then restricted to a fundamental region F in which there is no overlapping of strings:

This proceedure is consistent because $S_{f g_1 :::f g_N}$ [X] vanishes just outside F, where links from di erent strings touch. W ith this restriction, H₁+ :::+ H_N can be identi ed with H_s, and hence with the RKM Ham iltonian and $S_{f g_1 :::f g_N}$ [X] are indeed the correct eigenstates. The energy eigenvalues are

The reader who is not entirely convinced of the results of this section can nd a more complete discussion of many-string theory in reference 3.

6 String Field Theory

A more form alm ethod of converting the RKM to a many-string problem is the string-Jordan-W igner transformation, similiar to that discussed for the three-dimensional Ising model¹³.

Let [X] = [X(1); ...; X(k); ...; X(L)] be a set of links $l_1; l_2; ...$ connecting the left boundary to the right boundary. These links do not necessarily constitute a string con guration consistent with the rules discussed in Section 3, but are assumed to be a connected path, such that, for each k = 1; ...; L there is a unique X(k). String eld operators will be de ned for each [X].

A contour [X] is shown in Fig.5. Let the set of links of the form (x;1), (x;3), but not (x;2) below [X] on the triangular lattice be called D. The links of D are shown as dotted lines in Fig.5. The string-destruction operator at [X] is

Sim iliarly, the string-creation operator at [X] is

The string elds satisfy certain anticommutation relations. The y's anticommute among them selves, as do the 's:

for any two contours [X] and [Y]. A special case of (31) is

In addition to (31), the string elds satisfy

Suppose [X] and [Y] are two contours which cross at the points x, z, such that [X] is everywhere below [Y] (Fig.6). By cutting both contours at x, z, and then

switching and re-attaching the pieces two new contours, [Z] and [U], are obtained. The string-eld γ operators satisfy

Notice that if [X] and [Y] are string contours satisfying the rules of Section 3, the contours [Z] and [U] will not satisfy these rules.

States produced by applying products of operators y [X] to the zero-string state Z : (satifying [X] Z : = 0) are the second-quantized versions of (26).

For each [X] de ne a vector j[X] >, such that < [X] j[X] > = 1 and if $[X] \in [Y]$, < [X] j[Y] > = 0. These vectors constitute an orthonormal basis of a vector space V. The states which correspond to the special string con gurations satisfying the rules of Section 3 span a subspace W. The mapping A de ned in (12) is a linear transformation from W to the spin-chain H ilbert space, which preserves inner products. The Ham iltonian (10), with the constraint (8) enforced, is

where h is the spin-chain H am iltonian de ned in equation (14).

The ground state is the antisymmetrized product of ground-state string wave functionals, with the coordinates ordered as discussed previously. By (28) and (24), the ground state E_0 energy must satisfy

Correlations in the ground state of an individual string have only power law behaviour, as the spectrum of the spin chain is relativistic and gapless. Thus the ground state of the RKM has power-law correlations, and is neither a colum nar nor a staggered state⁴. An excitation of the RKM can be made by exciting a single string. C learly the gap is zero.

7 Static D efects

An important issue is how the system behaves when topological defects are introduced. In models of copper-oxide-layer superconductors, defects are charged excitations and their con nement implies Cooper pairing with a short coherence length. Only static defects will be discussed here. The square lattice is bipartite with two geom etrically distinct kinds of sites, namely red sites with $x^1 + x^2$ even and black sites with $x^1 + x^2$ odd. Since the Ham iltonian (1) commutes with the Gauss's law operator (2), defect locations are xed. A red defect becomes a site where a string ends at the right, whereas a black defect becomes a site where a string begins at the left. Free boundary conditions for dimers on the square lattice dictate in ply that there are an equal number of red and black defects.

An isolated defect on a red site becomes one of the congurations



on the triangular lattice, while an isolated defect at a black site becomes one of the con gurations

The red defects and black defects behave like positive and negative charges, respectively in a con ning U (1) gauge theory¹⁹. If a string is removed by placing a red defect at the left boundary and a black defect is placed at the right boundary, then the lowest energy state is identical to the ground state with no defects, minus the energy of one string. Since the individual strings have a negative energy per unit length (because the lling fraction in the spin chain is greater than zero), the defects are pined by a physical \string hole" with positive energy per unit length. This energy is minus the ground-state energy of one string. The red defect and the black defect are thus bound by a constant attractive force through the form ation of this electric string. The string tension is de ned to be the asymptotic energy per unit seperation on the original square lattice. Since the seperation of the defects on the square lattice is L, the string tension is (which satis es the bounds (24). The system should be rotational-invariant at large distances (since the gap is zero) so the string tension will only depend on the seperation of two defects, if that seperation is large.

8 Conclusions

It has been shown that the RKM is equivalent to a gas of transversely oscillating \hard" strings. A qualitative analysis shows that the energy spectrum is gapless, indicating a uid phase. D effects are con ned by dynam ical strings. Further num erical work on the spin chain (14) describing a single string should reveal further properties, such as the precise values of the string tension and ground-state energy.

The physical excitations are probably closed strings. A closed string excitation is produced by disturbing one of the strings in the ground state (the string \sea")

along a nite region of its length, then antisymmetrizing and ordering the string coordinates.

It seems likely that for the range of diagonal coupling J = V = 0 there is a uid phase, with a phase transition to a valence-bond solid for some negative V.













