Tem perature D erivative of the Super uid D ensity in the Attractive H ubbard m odel.

A bstract

Based on extensions of the grand-canonical Quantum Monte-Carlo algorithm to incorporate magnetic elds, we provide numerical data conming the existence of a Kosterlitz-Thouless transition in the attractive Hubbard model. Here, we calculate the temperature derivative of the super uid density, $\frac{e^{-D_s(\cdot)}}{e}$, to pin down the transition. The latter quantity is obtained from the difference in internal energy of systems which differ by a phase twist =2 in the boundary condition along one lattice direction. Away from half-band lling, $\frac{e^{-D_s(\cdot)}}{e}$ shows a response which increases with lattice size at the transition temperature. In contrast, such a signal is not observed for the case of a half-band lling.

Num erical simulations of the attractive Hubbard Hamiltonian [1, 2, 3], indicate that this ferm ionic lattice model has an s-wave superconducting ground state in two-dimensions. A nite-size scaling analysis (up to one hundred sites) of the s-wave pair-pair correlation functions has provided some evidence that the model has a nite-temperature Kosterlitz-Thouless (KT) [4] transition to a superconducting state away from half-band lling [3]. Based on extensions of the grand-canonical Quantum Monte-Carlo (QMC) algorithm, we present numerical data which clearly con rm the conjecture of a KT transition. Our approach relies on the calculation of the tem perature derivative of the super uid density, $\frac{\theta\ D_s(1)}{\theta}$, where is the inverse temperature. In the framework of such a KT transition, D $_{\rm S}$ () shows a universal jump at the transition temperature [5]. Hence, $\frac{\rm @~D_{\,\rm S}\,()}{\rm @}$ in the therm odynam ic lim it behaves like a D irac delta-function at the transition temperature, and even on nite-sized clusters is expected to yield a very clear signal. Compared to previous estimations of the T = 0 super uid density, via ux quantization [6] or linear response [7], the method described here leads to numerical results which exhibit a peak at $T_{K\ T}$ which grows as the size of the system increases. This provides a clear signal of the KT transition. Such signatures of the KT transition have already been observed in classical [8] as well as in quantum XY models [9]. In this letter it is shown that, for the attractive H ubbard m odel, $\frac{\theta - D_s(\cdot)}{\theta}$ is given by the dierence in internal energy of systems which dier by a phase twist =2 in the boundary condition along one lattice direction. The internal energies are extracted from nite temperature quantum Monte-Carlo (QMC) data on cluster sizes ranging from 4 4 to 8 8. Comparison of the data for dierent lattice sizes, strongly supports the existence of a K T transition away from halfband lling.

The attractive Hubbard ham iltonian we consider is given by:

Here, $c_{i,}^y$ creates an electron with z-component of spin on lattice site i, $a_{x,y}$ are the lattice vectors of unit length, $a_{x,y} = \frac{hc}{e}$ is the ux quantum, and L is the linear length of

the square lattice. The ferm ionic operators obey periodic boundary conditions in both lattice directions. The above H am iltonian thus describes an attractive H ubbard m odel on a torus. The phase factors in the kinetic energy term account for the presence of a magnetic eld of ux threaded through the center of the torus. Through a canonical transform ation, one may remove the phase factors in (1). However, under this canonical transform ation, the x-boundary acquires a phase twist exp (2 i = 0) [10]. Hence, the threaded magnetic eld acts merely as boundary elect.

Let us now consider the free energy,

and expand it up to second order in = $_0$ around = 0. This yields:

Here, D_s ()=2 2 corresponds to the super uid density n_s in units where the hopping t = 1 [11]. The above equation m ay be transformed to give:

The left hand side of the above equation is just the di erence in internal energy: E () E (= 0). The right hand side contains the term we are interested in; namely the temperature derivative of the super uid density. For an in nite lattice, the jump in the super uid density at $T_{K\,T}$ implies that

For a nite-size lattice, the delta-function peak scales as the number of sites N [8].

To determ ine which values of are most appropriate for our calculations, we consider the T = 0 lim it. At zero temperature, the attractive Hubbard model is expected to

show o -diagonal long-range order (ODLRO), and thus ux quantization [12]. Hence, the quantity

scales in the therm odynam ic lim it to a periodic function of period $_0$ =2. Furtherm ore, a non-vanishing energy barrier is to be seen between the ux m in in a at = 0 and = $_0$ =2 [10, 12]. Thus, the maximal response in E $_0$ () E $_0$ (= 0) should lie at = $_0$ =4. The super uid density, which corresponds to the curvature of the E $_0$ () E $_0$ (= 0) function at = 0 or = $_0$ =2 [12, 7], may be approximated by:

The above relations hold for the bose condensation of free charge two bosons on a square lattice. Numerical evidence for the validity of equation (7) for the quarter-led and half-led two-dimensional attractive Hubbard model may be found in reference [6].

Due to the above considerations, we have computed the quantity:

as a function of tem perature and lattice size. E (R) yields at nite-tem perature information on $\frac{\theta - D_s(\cdot)}{\theta}$ (4) and at T = 0 converges for increasing lattice size to the super uid density (7). Considering both R = 0 R = $_0$ =2 yields a cross-check for nite size effects since both values of R converge to the same results only in the thermodynamic limit. As mentioned previously, the internal energies E () were calculated through the use of the nite tem perature QMC algorithm [13,14]. We carry out a discrete Hubbard–Stratonovitch (HS) transformation of the on-site interaction term in (1). A fter integration of the fermionic degrees of freedom, one obtains for the attractive Hubbard model:

where s denotes a HS con guration and M is an L L m atrix. For = 0 or $= _{0}=2$ (i.e. antiperiodic boundary in the x-direction), M is real and thus no sign problem occurs. On the other hand, for $= _{0}=4$, M is complex and thus, (detM (s))² is equally complex. Hence, this value of the ux yields a sign (or in our case a phase) problem.

This phase problem inhibits us of reaching very low temperatures. Another problem we encountered, is that of xing the chemical potential. Since we are interested in the di erence of two internal energies at a given particle number (8), the chemical potential has to be determined very precisely. Apart from the half-lled band case where = 0 a brute force search for the desired chemical potential is numerically too expensive. We thus carried out at least three simulations with chemical potential corresponding approximately to the desired lling and the energy data to the form: $A + Bx + Cx^2$. The energy corresponding to the desired lling is then extrapolated from the t. Thus, one data point in the E(R) curve corresponds to at least six independent simulations.

Figure 1 plots E (R) for both considered values of R (see equation (8)), and for the half-led attractive Hubbard model at U=t=4 as a function of the temperature. The data points at T = 0 were obtained with the projector QMC algorithm (PQMC) [15]. Here, we consider three lattice sizes: 4 4,6 6 and 8 8. At exactly half-band lling, the attractive H ubbard m odelm ay be m apped onto the repulsive H ubbard m odelby carrying out a particle-hole transform ation in one spin sector. Under this transform ation, one notices that the s-wave pair-pair (charge-charge) correlations of the attractive modelm ap onto the transverse (z-component) spin-spin correlations of the repulsive model. In the strong-coupling lim it, the repulsive Hubbard model may be mapped onto the Heisenberg m odelwhich shows no KT transition [16]. Hence, the strong-coupling attractive Hubbard model at half-band ling shows no KT behavior. In the intermediate coupling regime, the numerical data of gure 1, equally display no sign of a KT transition. Consider the R = 0=2 curves. For this value of R, there is a bum p appearing approximately at 0.2t. However, this structure fails to scale with increasing lattice size but rather appears to be suppressed. A similar, but less pronounced structure may be seen in the two largest lattice sizes of the R = 0 curves.

Let us now turn to three-quarters band lling. Our QMC data are plotted for R=0 (R=0.5) in gure 2a (2b). For the considered coupling (U=t=4) and band-lling (N=0.75), we were unable to reach inverse temperatures higher than N=7 due to severe phase problem s. Again, the data points at N=0 were obtained with the PQMC algorithm [15]. Figures 2a and 2b show a striking di erence between the 4 4 and 8 8

clusters. The slope of the E(R) curves become very large for the 8-8 cluster size in the temperature region 7 < t < 5 [17]. Finally, the available data, are compatible with the onset of a Dirac delta-function type response in E(R) for both considered values of R at approximately T-0:1t. This temperature value compares favorably with the KT transition temperature obtained from a nite-size scaling analysis of the pair-pair correlation functions [2].

In conclusion, extensions of the grand-canonical QMC algorithm have allowed us to calculate the temperature derivative of the super uid density for the half and three-quarters led attractive H ubbard m odel at U=t=4. Comparing the numerical results for both band llings provides convincing evidence that the three-quarters led attractive H ubbard m odel at U=t=4 has a KT transition to a superconducting state. In contrast, no signature of the KT transition is found at half-band lling.

- [17] An accurate scaling of the peak height as a function of the lattice size is out of reach in the present approach due to the phase problem we encounter for values of $= \ _0 = 4. \, \text{At} < \ n > = \ 0.75 \, \text{, we did not consider the 6} \quad \text{6 lattice since for this lattice}$ size $< \ n > = \ 0.75 \, \text{does not correspond to a well de ned particle number in the S}_z = 0$ Hilbert space. Hence, the PQMC algorithm may not be unambiguously applied to obtain the T = 0 data point.

 - b) Same as gure a) but we consider: E (= $_0$ =4) E (= $_0$ =2).



$$E({\Phi\over\Phi_0}=0.25)-E({\Phi\over\Phi_0}=0)$$



$$E({\Phi\over\Phi_0}=0.25)-E({\Phi\over\Phi_0}=0.5)$$


