Crossover from Ferm iLiquid to Non-Ferm iLiquid Behavior in a Solvable One-D im ensional Model

A bstract

We consider a quantum many-body problem in one-dimension described by a Jastrow type wavefunction, characterized by an exponent and a parameter. In the limit = 0 the model becomes identical to the well known $1=r^2$ pair-potential model; is shown to be related to the strength of a many body correction to the $1=r^2$ interaction. Exact results for the one-particle density matrix are obtained for all when = 1, for which the $1=r^2$ part of the interaction vanishes. We show that with increasing , the Fermi liquid state (at = 0) crosses over to distinct -dependent non-Fermi liquid states, characterized by elective \temperatures". PACS No. 71.10 + x

appear frequently in quantum m any-body problem s. In one dimension, m any-body H am iltonians with pair-potentials of the form $1=r^2$ (or its periodic equivalent $1=\sin^2 r$), where $r=(u_a-u_b)$, have exact ground state wave functions of the Jastrow form [2-5]. It has been proposed that variational wave functions of this type give reasonably good descriptions of models for strongly interacting fermions [6-11]. It is therefore of interest to investigate the properties of such wave functions as exactly as possible. Of particular interest is the question whether such a wave function describes how interaction can change a Fermi liquid into a non-Fermi liquid state.

In the solution of the $1=r^2$ m odel, the param eter in Eq. (1) is related to the strength of the $1=r^2$ pair potential; in particular, =1 corresponds to the free ferm ion case. Unfortunately, the exact density matrix for this model can be obtained only for a few special values of [2,12], so the question of the nature of crossover from the free ferm ion to the interacting non-Ferm i liquid state can not be addressed exactly in this model. In the present work, we consider a one-dimensional wave function of the above form which can be considered as a generalization of the wavefunction corresponding to the $1=r^2$ model. In addition to the parameter , our model contains an additional parameter which we show to be related to the strength of a many body correction to the $1=r^2$ interaction. We obtain the one-particle density matrix for this model exactly for all , for the particular case of =1. Thus =0 represents the free ferm ion case. We show that with increasing , the Ferm i liquid state is destroyed by an elective non-zero \temperature" induced by interaction.

The exact density matrix of the $1=r^2$ model was obtained [2] by exploiting the analogy of the wave function with the eigenvalue distribution of random matrices [13]. The wavefunction we consider is motivated by our recent generalization of the conventional Wigner-Dyson-Mehta random matrices, for describing transport in disordered systems [14]. We consider the wavefunction given by Eq.(1) with

characterized by a single parameter . Here $\#_4$ (x;p) is the Jacobi Theta function [15], $p = e^{-2}$, and ! has the dimension of $1 = [length]^2$. For = 0; V (u) $= \frac{1}{2} ! u^2$; and the wavefunction reduces to the well known solution of the $1 = r^2$ pair potential. The case = 1 then represents a free Ferm ion problem (with the choice of Fermi statistics), with the one-particle density matrix given by $\sin[Dr] = (r)$; D being the density of particles. The parameter \deforms'' the harmonic well into a weakly conning $[lnu]^2$ term for large enough u, as shown in gure 1. We will show that this deformation leads to a qualitative change in the density matrix; for = 1 this corresponds to a change from a Fermi liquid to a non-Fermi liquid state.

In order to understand the role of the param eter , let us concentrate for the m om ent on the small (2) lim it where the second term in Eq. (2) can be neglected, and the H am iltonian corresponding to the above wave function has a simple form. In this lim it, to leading order in , the Schrodinger equation (in units where $h^2=2m=1$) can be written as,

Note that for = 0, the Ham iltonian reduces to the $1=(u_k-u_j)^2$ pair potential, with energy E=!N+N(N-1)] [2,3]. For = 1; with the choice of Ferm i statistics, this becomes a free Ferm ion problem. However, for \pm 0, a many-body correction term survives even for = 1. Nevertheless, the density matrix for = 1 can still be found exactly for all . We will show that it corresponds to a non-Ferm i liquid state, playing the role of an elective temperature.

The exact density matrix corresponding to the wave function de ned by eqns. (1) and (2) for N ! 1 and for all , as obtained by exploiting the analogy of the present problem with the random matrix model recently constructed for describing transport in disordered systems [14], is given by

 $\#_1$ (x;p) is a JacobiTheta function [15] and f () is a known function of . For simpler form for the density matrix is obtained

In the lim it ! 0, in terms of the density at the origin $D_0 = \frac{1}{2} \left(\frac{!}{\cdot}\right)^{1=2}$; this reduces to the free Ferm ion density matrix $(u \quad v) = \sin D_0 \quad (u \quad v) = (u \quad v)$: These oscillations are the characteristic signature of a normal Fermi system; its Fourier transform | the momentum distribution | is the familiar step function. On the other hand for increasing , these oscillations begin to die out, destroying the Fermi liquid behavior. The Fourier transform of (u;v) would involve two external momenta and this makes comparison

with the Fermi liquid momentum distribution dicult. We shall instead consider the Fourier transform of (u;0); $n_k={R_+ 1 \atop 1}$ du e^{iku} (u;0). With the change of variable $y=\sinh^{-1}(2\ D_0u)$; we have

For small enough we can replace sinhy by y within the sine function, and cothy by 1=sinhy. The resulting distribution is given by

where $n[x] = 1 = [e^x + 1]$ is the Ferm i function. As expected, this reduces to the step of the free ferm ions when = 0: Moreover, we not from the explicit expression (8) that plays the role of an elective \temperature".

In sum mary, we have considered a one-dimensional quantum many-body problem described by a Jastrow type wave function characterized by an exponent and a parameter . We show that our model is a generalization of the $1=r^2$ pair-potential model considered by Calogero and Sutherland, which is obtained in the limit = 0:W e obtain the exact one-particle density matrix for all for the case = $1 \text{ where the } 1=r^2 \text{ interaction vanishes}$. For = 0, and the choice of Ferm i statistics this becomes a free ferm ion problem, and we recover the step function for the momentum distribution. For $6 \cdot 0$, an interaction term survives for the case = 1 and the resulting momentum distribution is smeared out, destroying the Ferm i Liquid. The explicit expression for the momentum distribution as a function of for small shows that the destruction of the Ferm i liquid state occurs as increasing interaction induces an increase in the elective \text{tem perature} in this regime.
