Universality of Period Doubling in Coupled Maps

A bstract

We study the critical behavior of period doubling in two coupled one-

dim ensionalm apswith a single maximum of order z. In particurlar, the e ect

of the maximum-order z on the critical behavior associated with coupling is

investigated by a renormalization method. There exist three xed maps of

the period-doubling renormalization operator. For a xed map associated

with the critical behavior at the zero-coupling critical point, relevant eigen-

values associated with coupling perturbations vary depending on the order z,

whereas they are independent of z for the other two xed maps. The renor-

malization results for the zero-coupling case are also con med by a direct

num ericalm ethod.

Universal scaling behavior of period doubling has been found in one-dimensional (1D) maps with a single maximum of order z (z > 1),

$$x_{i+1} = f(x_i) = 1$$
 A  $\dot{x}_i \dot{f}_i$   $z > 1$ : (1)

For all z>1, the 1D m ap (1) exhibits successive period-doubling bifurcations as the non-linearity parameter A is increased. The period-doubling bifurcation points  $A=A_n(z)$  (n=0;1;2;:::), at which the nth period doubling bifurcation occurs, converge to the accumulation point A (z) on the A axis. The scaling behavior near the critical point A depends on the maximum-order z, i.e., the parameter and orbital scaling factors, and , vary depending on z [1{4}. Therefore the order z determines universality classes.

Here we study the critical behavior of period doubling in a map T consisting of two identical 1D maps coupled symmetrically:

where f(x) is a 1D map (1) with a single maximum of even order z (z = 2;4;6;:::) at x = 0, and g(x;y) is a coupling function. The uncoupled 1D map f satisfies a normalization condition, f(0) = 1, and the coupling function g obeys a condition, g(x;x) = 0 for any x.

The quadratic-maximum case (z = 2) was previously studied in Refs. [5{9]. In this paper, using the renormalization method developed in Ref. [9], we extend the results for the z = 2 case to all even-order cases and investigate the dependence of the critical behavior associated with coupling on the order z.

The period-doubling renormalization transformation N for a coupled map T consists of squaring  $(T^2)$  and rescaling (B) operators:

Here the rescaling operator B is:

$$B = \begin{bmatrix} B & & 0 & C \\ B & & & C \\ 0 & & & A \end{bmatrix};$$

because we consider only in-phase orbits ( $x_i = y_i$  for all i).

Applying the renorm alization operator N to the coupled map (2) n times, we obtain the n times renormalized map  $T_n$  of the form,

Here  $f_n$  and  $g_n$  are the uncoupled and coupling parts of the n times renormalized function  $F_n$ , respectively. They satisfy the following recurrence equations [9]:

$$f_{n+1}(x) = f_n(f_n(\frac{x}{-})); \qquad (6)$$

$$g_{n+1}(x;y) = f_n(f_n(\frac{x}{-}) + g_n(\frac{x}{-};\frac{y}{-}))$$

where the rescaling factor is chosen to preserve the normalization condition  $f_{n+1}(0) = 1$ , i.e.,  $f_n(1) = 1$ , i.e.,  $f_n$ 

A critical map  $T_c$  with the nonlinearity and coupling parameters set to their critical values is attracted to a  $\ \ \,$  xed map T under iterations of the renormalization transformation N ,

Here (f;g) is a xed point of the renormalization operator R with = 1=f(1), which satis es (f;g) = R (f;g). Note that the equation for f is just the xed point equation in the 1D map case. The 1D xed function f varies depending on the order z [4]. Consequently only the equation for the coupling xed function g is left to be solved.

However it is not easy to directly solve the equation for the coupling xed function. We therefore introduce a tractable recurrence equation for a \reduced" coupling function of the coupling function g(x;y) [9], defined by

Di erentiating the recurrence equation (7) for g with respect to y and setting y = x, we have

$$G_{n+1}(x) = [f_n^0(f_n(\frac{x}{-})) \quad 2G_n(f_n(\frac{x}{-}))]G_n(\frac{x}{-})$$

Then Eqs. (6) and (11) de ne a \reduced" renormalization operator  $\mathbb{R}$  of transforming a pair of functions (f;G):

We look for a xed point (f;G) of R, which satis es (f;G) = R (f;G). Here G is just the reduced coupling xed function of g (i.e., G (x) = 0g (x;y)=0y $j_{y=x}$ ). As in the quadratic-m aximum case (z = 2) [9], we not three solutions for G:

Here the rst solution, corresponding to the reduced coupling xed function of the zero-coupling xed function g(x;y) = 0, is associated with the critical behavior at the zero-coupling critical point, whereas the second and third solutions dependent on the order z are associated with the critical behavior at other critical points [9].

Consider an in nitesimal reduced coupling perturbation (0; (x)) to a xed point (f;G) of  $\mathbb{R}^2$ . We then examine the evolution of a pair of functions, (f(x);G(x)) + (x) under the

reduced renormalization transformation R. In the linear approximation we obtain a reduced linearized operator L of transforming a reduced coupling perturbation:

Here the prime denotes a derivative. If a reduced coupling perturbation (x) satis es

$$(x) = [\Gamma] (x); (17)$$

then it is called a reduced coupling eigenperturbation with coupling eigenvalue (CE)

We rst show that CEs are independent of the order z for the second and third solutions (14) and (15) of G (x). In case of the second solution G (x) =  $\frac{1}{2}$ f  $^{0}$ (x), the reduced linearized operator  $\Gamma$  becomes a null operator, independently of z, because the right hand side of Eq. (17) becomes zero. Therefore there exist no relevant CEs. For the third case G (x) =  $\frac{1}{2}$  [f  $^{0}$ (x) 1], Eq. (17) becomes

When (x) is a non-zero constant function, i.e., (x) = c (c:non-zero constant), there exists a relevant CE, = 2, independently of z.

In the zero-coupling case G(x) = 0, the eigenvalue equation (17) becomes

Relevant CEs of Eq. (19) vary depending on the order z, as will be seen below.

An eigenfunction (x) can be separated into two components, (x) =  $^{(1)}$ (x) +  $^{(2)}$ (x) with  $^{(1)}$ (x)  $a_0 + a_1x + \frac{1}{2}z^2x^2$  and  $^{(2)}$ (x)  $a_{z}$ <sub>1</sub> $x^z$ <sup>1</sup> +  $a_z$ <sub>2</sub> $x^z$  +  $^{(2)}$  and the 1D xed function f is a polynomial in  $x^z$ , i.e., f (x) = 1 +  $c_z$ x<sup>2</sup> +  $c_z$ x<sup>2</sup> +  $^{(2)}$  Substituting the functions , f and f  $^{(0)}$  into the eigenvalue equation (19), it has the structure

We note that each  $a_1$  (l=0;1;2;::) in the rst and second terms in the right hand side of Eq. (19) is involved only in the determination of coecients of monomials  $x^k$  with k = l + m z and k = (z + 1) + m z (m = 0;1;2;:::), respectively. Therefore any  $a_1$  with l = z + 1 (in the right hand side) cannot be involved in the determination of coecients of monomials  $x^k$  with k < z + 1, which implies that the eigenvalue equation (20) is of the form

where M  $_1$  is a (z 1) (z 1) m atrix,  $^{(1)}$  ( $a_0$ ;:::; $a_{z 2}$ ), and  $^{(2)}$  ( $a_{z 1}$ ; $a_z$ ;:::): From the reducibility of the matrix M into a sem i-block form, it follows that to determ ine the eigenvalues of M it is su cient to solve the eigenvalue problems for the two submatrices M  $_1$  and M  $_2$  independently.

We st solve the eigenvalue equation of  $M_1$  (  $^{(1)}$  =  $M_1$   $^{(1)}$ ), i.e.,

Note that this submatrix M $_1$  is diagonal. Hence its eigenvalues are just the diagonal elements:

$$_{k} = M_{kk} = \frac{f^{0}(1)}{k} = ^{z \cdot 1 \cdot k}; \quad k = 0; \dots; z \quad 2:$$

Notice that all k's are relevant eigenvalues.

Although  $_k$  is also an eigenvalue of M, ( $_k$ <sup>(1)</sup>;0) cannot be an eigenvector of M, because there exists a third submatrix M  $_3$  in M [see Eq. (21)]. Therefore an eigenfunction  $_k$  (x) in Eq. (19) with eigenvalue  $_k$  is a polynomial with a leading monomial of degree k, i.e.,  $_k$ (x) =  $_k$ <sup>(1)</sup>(x) +  $_k$ <sup>(2)</sup>(x) =  $_k$ x<sup>k</sup> +  $_z$   $_z$   $_z$   $_z$  +  $_z$   $_z$  where  $_z$  0.

W e next solve the eigenvalue equation of M  $_2$  (  $^{(2)}$  = M  $_2$   $^{(2)}$ ), i.e.,

Consider an in nitesimal coupling perturbation  $g(x;y) \models "'(x;y)]$  to a critical map at the zero-coupling critical point, in which case the map T of Eq. (2) is of the form,

where the subscript A off denotes the critical value of the nonlinearity parameter A and " is an in nitesimal coupling parameter. The map T for " = 0 is just the zero-coupling critical map consisting of two uncoupled 1D critical maps  $f_A$ . It is attracted to the zero-coupling xed map (consisting of two 1D xed maps f) under iterations of the renormalization transformation N of Eq. (3).

The reduced coupling function G(x) of g(x;y) is given by [see Eq. (10)]

G (x) = " (x) "

Then " (x) corresponds to an in nitesimal perturbation to the reduced zero-coupling xed function G (x) = 0 of Eq. (13). The nth image  $_n$  of under the reduced linearized operator  $\Gamma$  of Eq. (16) has the form,

since the irrelevant part of n becomes negligibly small for large n.

The stability multipliers  $_{1m}$  and  $_{2m}$  of the  $2^n$ -periodic orbit of the map T of Eq. (25) are the same as those of the xed point of the n times renormalized map  $N^n$  (T) [9], which are given by

$$f_{1m} = f_n^0(\hat{x}_n); \quad f_n^0(\hat{x}_n) = f_n^0(\hat{x}_n) \quad 2G_n(\hat{x}_n):$$

Here  $(f_n; G_n)$  is the nth in age of  $(f_A; G)$  under the reduced renormalization transformation  $\mathbb{R}^r$  [i.e.,  $(f_n; G_n) = \mathbb{R}^r$   $(f_A; G)$ ], and  $\hat{x}_n$  is just the xed point of  $f_n(x)$  [i.e.,  $\hat{x}_n = f_n(\hat{x}_n)$ ] and converges to the xed point  $\hat{x}$  of the 1D xed map f(x) as n ! 1. In the critical case (" = 0),  $_{2n}$  is equal to  $_{1n}$  and they converge to the 1D critical stability multiplier  $= f^0(\hat{x})$ . Since  $G_n(x)$  '  $[\Gamma_2^n G](x) = \Gamma_n(x)$  for in nitesimally small  $\Gamma_n(x)$  has the form

where  $e_k = 2_k (x)$  (k = 0; :::; z = 2) and  $e_{z | 1} = 2_{z | 1} f^0(x)$ . Therefore the slope  $S_n$  of  $a_{z;n}$  at the zero-coupling point (" = 0) is

$$S_n = \frac{\theta_{2,n}}{\theta_{n,n}} / \frac{\chi^2}{e_k^n} + e_{z,1} 2^n \text{ for large n:}$$
 (30)

Here the coe cients  $fe_k$ ; k=0;:::;z 1g depends on the initial reduced function (x), because k's are determined only by (x). Note that the magnitude of slope  $S_n$  increases with numbers all  $e_k$ 's (k=0;:::;z 1) are zero.

We choose monomials  $x^1$  (l=0;1;2;:::) as initial reduced functions (x), because any smooth function (x) can be represented as a linear combination of monomials by a Taylor series. Expressing (x) =  $x^1$  as a linear combination of eigenfunctions of  $\Gamma_2$ , we have

$$(x) = x^{1} = {}_{1 1}(x) + {}_{z 1}f^{0}(x) + {}_{z 1}f^{0}(x) = {}_{1}f^{0}(x) = {}$$

where  $_1$  is non-zero for l < z - 1 and zero for l = z - 1, and all  $_n$ 's are irrelevant components. Therefore the slope  $S_n$  for large n becomes

$$S_{n} \stackrel{\$}{\stackrel{>}{\sim}} e_{1} \stackrel{n}{_{1}} + e_{z} \stackrel{1}{_{2}} 2^{n} \text{ for } 1 < z \quad 1;$$

Note that the growth of  $S_n$  for large n is governed by two CEs  $_1$  and 2 for l < z - 1 and by one CE  $_1 = 2$  for l = z - 1.

We numerically study the quartic-maximum case (z=4) in the two coupled 1D maps (25) and con muther renormalization results (32). In this case we follow the periodic orbits of period  $2^n$  up to level n=15 and obtain the slopes  $S_n$  of Eq. (30) at the zero-coupling critical point (A;0) (A = 1:594 901 356 228:::) when the reduced function (x) is a monomial  $x^1$  (l=0;1;:::).

The renormalization result implies that the slopes  $S_n$  for  $l \ z \ 1$  obey a one-term scaling law asymptotically:

$$S_n = d_1 r_1^n : (33)$$

We therefore de ne the growth rate of the slopes as follows:

$$r_{1,n} = \frac{S_{n+1}}{S_n}$$
: (34)

Then it will converge to a constant  $r_1$  as  $n \, ! \, 1$ . A sequence of  $r_{1,n}$  for  $(x) = x^3$  is shown in the second column of Table I. Note that it converges fast to  $r_1 = 2$ . We have also studied several other reduced-coupling cases with  $(x) = x^1 (1 > 3)$ . In all higher-order cases studied, the sequences of  $r_{1,n}$  also converge fast to  $r_1 = 2$ .

When 1 < z 1, two relevant CEs govern the growth of the slopes  $S_n$ . We therefore extend the simple one-term scaling law (33) to a two-term scaling law:

$$S_n = d_1 r_1^n + d_2 r_2^n$$
; for large n; (35)

where  $j_{1}$  j>  $j_{2}$  j: This is a kind of multiple-scaling law [11]. Eq. (35) gives

$$S_{n+2} = t_1 S_{n+1} \quad t_2 S_n;$$
 (36)

where  $t_1 = r_1 + r_2$  and  $t_2 = r_1 r_2$ . Then  $r_1$  and  $r_2$  are solutions of the following quadratic equation,

$$r^2$$
  $t_1 r + t_2 = 0$ : (37)

To evaluate  $r_1$  and  $r_2$ , we set obtain  $t_1$  and  $t_2$  from  $S_n$ 's using Eq. (36):

$$t_{1} = \frac{S_{n+1}S_{n} \quad S_{n+2}S_{n-1}}{S_{n}^{2} \quad S_{n+1}S_{n-1}}; \quad t_{2} = \frac{S_{n+1}^{2} \quad S_{n}S_{n+2}}{S_{n}^{2} \quad S_{n+1}S_{n-1}};$$
(38)

Note that Eqs. (35)-(38) are valid for large n. In fact, the values of  $t_i$ 's and  $r_i$ 's (i=1;2) depend on the level n. Thus we denote the values of  $t_i$ 's in Eq. (38) explicitly by  $t_{i,n-1}$ 's, and the values of  $r_i$ 's obtained from Eq. (37) are also denoted by  $r_{i,n-1}$ 's. Then each of them converges to a constant as n ! 1:

$$\lim_{n \to 1} t_{i,n} = t_i; \quad \lim_{n \to 1} r_{i,n} = r_i; \quad i = 1;2:$$
(39)

The two-term scaling law (35) is very well-obeyed. Sequences  $r_{1,n}$  and  $r_{2,n}$  for (x) = 1 are shown in the third and fourth columns of Table I. They converge fast to  $r_1 = 3$  ( = 1:6903:::) and  $r_{2,n} = 2$ , respectively. We have also studied two other reduced-coupling cases with  $(x) = x^1$  (1 = 1;2). It is found that the sequences  $r_{1,n}$  and  $r_{2,n}$  for l = 1(2) converge fast to their limit values  $r_1 = 2$  (2) and  $r_2 = 2$  (1); respectively.
