Spectrum and Thermodynamics of the 1D Supersymmetric t-J $\text{M odel w ith } 1 \text{=} r^2 \text{ Exchange and H opping}$

We derive the spectrum and therm odynam ics of the 1D supersymmetrict-Jm odel with long range hopping and spin exchange using a set of maximal spin eigenstates. This spectrum con must be recent conjecture that the asymptotic Bethe-ansatz spectrum is exact. By empirically determining the spinon degeneracies of each state, we are able to explicitly construct the free energy.

The explicit construction of low dimensional models with Jastrow ground-state wavefunctions has attracted considerable recent interest [1{6}]. In one dimension, Shastry and
Haldane [5,6] have demonstrated that the ground-state of the 1D Heisenberg model with a

1=r² exchange interaction is a Gutzwiller state for the half led in nite-U Hubbard model.
Haldane has shown how the spectrum of this model can be written in terms of a generalized
type of Jastrow wavefunction with excitations of novel statistics [7].

Kuram oto and Yokoyam a [8] have recently extended these results to include holes, demonstrating that the corresponding 1D supersymmetric t-J model is also characterized by a Gutzwiller ground-state. Most recently, Kawakamihas obtained an asymptotic Betheansatz (ABA) solution for the model, based on the observation that the ground-state wave-function is a product of two-body functions [9]. Assuming factorizability, he derived the spectrum of the system, which was conjectured to be exact. The low-energy critical behavior of the model has been identified as a Luttinger liquid [10,11]; the spin and charge excitations are described independently by c = 1 conformal eld theories.

In the case of the $1=r^2$ B ose gas [12], and the Shastry-Haldane $1=r^2$ Heisenberg chain [7], the ABA has been shown to furnish the correct spectrum, despite the long-range nature of the interactions. A remarkable feature of these models is that excited states are obtained from the ground-state by introducing zeros into the Jastrow wavefunction, in a manner reminiscent of Laughlin's description of quasiparticles in the fractional quantum Halle ect. This motivates us to examine the $1=r^2$ supersymmetric t-J model in a similar vein. Here, we show how this philosophy can be used to construct the excited state Jastrow wavefunctions of the $1=r^2$ supersymmetric t-J model and indeed, the spectrum con ms Kawakami's conjecture. In addition to the spectrum, we are able to obtain the spin degeneracies of each state, permitting us to write the the free energy in closed form.

The Ham iltonian for the one-dimensional t-J model is given by

where we implicitly project out any double occupancies. We take $t_{ij} = J_{ij} = t = d^2$ (i j) where

 $d(n) = \frac{N}{n} \sin(n)$ is the chord distance consistent with periodic boundary conditions on N lattice sites [13].

States in the Hilbert space can be represented by spin and hole excitations from the fully-polarized up-spin state P i [14]. If we let Q denote the number of holes and M denote the number of down-spins, then S_z is given by $S_z = (N - Q) = 2 - M$. The wavefunctions are given by

where the am plitude (x;y) is sym metric in x $(x_1;x_2;:::;x_M)$, the positions of the down-spins, and antisym metric in y $(y_1;y_2;:::;y_Q)$, the positions of the holes. $S_x = c_x^y {}_{\#}c_x {}_{\#}$ is the spin-lowering operator at site x and $h_{y_i}^y = c_{y_{i^*}}$ creates a hole at site y_i .

We can construct a general class of states corresponding to states of uniform motion and spin polarization. To describe these states, we generalize Kuramoto and Yokoyama's Jastrow ground-state [8] as follows

Here, J_s and J_h govern the (uniform) momenta of down-spins and holes respectively. J_s and J_h take on either integral or half-integral values as appropriate to insure that $_G$ has the correct periodicities under $x \ ! \ x \ + \ N$ and $y_i \ ! \ y_i + \ N$.

The H am iltonian can be broken up into four parts, $H = T'' + T^{\#} + H^{0} + H^{int}$, where T'' ($T^{\#}$) is the up (down) spin transfer operator, H^{0} is the spin exchange operator and H^{int} is the diagonal interaction term. When H acts on $_{G}$, T'' only a ects the y variables and H^{0} only a ects the x variables. As a result, these operators are easy to treat and yield only two and three body terms when appropriate conditions on J_{s} and J_{h} are met [5,6,8].

However, because $T^{\#}$ exchanges pairs of x and y_i , this term must be treated dierently. In general, it is not true that $T^{\#}j_G i = T^{\#}j_G i$ because $T^{\#}$ does not commute with the spin raising operator. This dieulty was overboked in earlier work [8]. To deal with $T^{\#}$, we use

an alternate representation for j $_G$ i in terms of up-spins and holes. Let us introduce the N M Q coordinates u $(u_1;u_2;:::;u_{N-M-Q})$ which give the location of the up-spins. W avefunctions in this representation are given by the spin rotated version of Eq. (2) where the x are replaced by u and M is replaced by N M Q.Making this transform ation, we nd

where the set of N coordinates (x;y;u) exhausts the entire lattice. A is a constant independent of the spin and hole coordinates. Using this identity, the down-spin transfer operator gives

and can thus be treated in a sim ilar manner as T. The result gives two and three body terms in the variables u and y. These terms can then be converted into sums over the x and y variables by making use of the fact that (x;y;u) runs over the entire lattice.

When the separate terms that contribute to the Hamiltonian are combined, we not that the two body terms drop out and the three body terms combine to give constants. As a result, $_{\rm G}$ with totalmomentum $P=\frac{2}{N}\left(J_{\rm S}M+J_{\rm h}Q\right)$ is an exact eigenstate of H with energy

The cancellation of the many body terms, and thus this result, is only valid under the conditions jJ_s N=2j N=2 (M+Q=1)=2 and jJ_h J_sj (M+1)=2. For a given S_z , the minimum energy is given when J_s and J_h are as close to N=2 as possible. The ground state is given when S_z is either 0 or 1=2 and is a singlet whenever possible [8]. When Q=0 this reduces to the result for the Heisenberg chain [5,6]. These energy levels have also been found by Ha and Haldane [15],

where $J_{\parallel} = J_{h}$ N + (M + Q + 1)=2 and $J_{\#} = J_{h}$ J_{s} (M 1)=2. From these energy levels we not the spin and charge velocities to be identical to the previous results [8,15].

To investigate the other excited states of the system, we introduce zeros into the wavefunction by premultiplying it with polynomials of $X = \exp(2 \text{ ix } = \mathbb{N})$ and $Y_i = \exp(2 \text{ iy}_i = \mathbb{N})$. The wavefunctions thus take the following modilled K alm eyer-Laughlin form [16]:

where $_{\rm s}$ and $_{\rm h}$ are completely symmetric under pairwise interchange of their arguments. These states will be termed \fully-polarized spinon states". Loosely speaking, the polynom ials $_{\rm s}$ and $_{\rm h}$ can be regarded as spin and charge quasiparticle wavefunctions respectively.

When the Hamiltonian acts on this wavefunction, once again all three-body terms combine to give constants. However, in this case, some two-body terms remain and we are left with the eigenvalue equation

Here we denote W (X;Y) $(X_1:::X_M;Y_1:::Y_{Q+M})$ and @ W @=@W . In deriving this, we have shifted $_S$ by the ground state con guration, Q W $^{N=2}$. As a result, E_0 is given by Eq. (6) with $J_S = J_h = N = 2$. We require that jdegree $_S$ j N = 2 (M $_S = 2$), jdegree $_S$ h j $_S = 2$ (M + Q $_S = 2$) and jdegree $_S$ j $_S = 2$, which is to hold for each variable X or Y_1 independently.

The rst term, H_1 , does not m ix $_s$ and $_h$ and has been solved by Sutherland [12]. However, H_2 m ixes $_s$ and $_h$ and H_3 does not act sym metrically on $_s$. As a result, they are harder to deal with. We follow Sutherland and start by choosing the following sym metric basis functions:

where the quantum numbers $fn_1; ::: ; n_{M+Q} g$ and $fm_1; ::: ; m_Q g$ are taken to be in increasing order and fP g and $fP_i g$ denote permutations of the indices. These quantum numbers are integral or half-integral as required by periodic boundary conditions.

In this basis, labeled by the two sets of quantum numbers fn g and fm $_i$ g, the H am iltonian, considered as a matrix, can be shown to be upper-triangular. Eigenvalues are found by reading the diagonal-elements labeled in terms of the quantum numbers fn g and fm $_i$ g [17]. The result simplies when written in terms of a conjugate set of quantum numbers $fJ_1; J_2; ...; J_{M+Q} g$ and $fI_1; I_2; ...; I_Q g$ dened by

where fn g and fm $_{i}$ g must satisfy the conditions speci ed before. This translates into the conditions jJ j (N M + 1)=2 and JI_{i} j (M + Q)=2. The energy is

where the pseudom om enta, p, are given by the following equations:

The above equations correspond to the asymptotic Bethe-ansatz equations obtained by Kawakami [9]. Our result thus con ms that the ABA spectrum is exact.

Here the resulting fp g and fq $_i$ g must lie between and . The set of M + Q distinct quantum numbers J is in ascending order and governs the spin excitations. We restrict them to take values in the range [(N M 1)=2; (N M 1)=2] to guarantee that they generate fully spin-polarized states. There are N M values in this range, of which M + Q are occupied and $2S_z$ are empty. A spin conguration can be represented by a sequence of N M digits such as $fSg = (0111001011)_s$, where 1 represents an occupied quantum number and 0 an unoccupied quantum number. These empty values are identified as spinons [7]; a sequence of $2j_r$ consecutive zeros corresponds to a symmetric bound-state of $2j_r$ spinons, thereby creating an excitation of spin j_r with spin degeneracy $2j_r + 1$. On these physical grounds, we anticipate a spin degeneracy in the therm odynam ic limit given by

where n (j) is the number of sequences of zeros of length 2j. The set of Q distinct quantum numbers I_i , in ascending order and taking values in the range [(M + Q)=2; (M + Q)=2], governs charge excitations.

To complete the study of the model and con mour interpretation of the quasiparticle degeneracies, we looked at exact diagonalization of small systems (N 10 with holes). As an example, the low-lying states of the N = 10, Q = 2 model is shown in Fig. 1. We sum marize the numerical result as follows:

- 1. The spectrum described in terms of the real pseudom omenta fp g and fq_ig span the full set of energy levels of the system.
- 2. The real pseudom om entum states are all highest weight states when fp q 6
- 3. The spin degeneracy rule is obeyed for all internal sequences of zeros.

Certain small corrections to the spin degeneracy rule apply when there are zeros at either end of fSg which we shall not enumerate here, and which are not important in the therm odynamic limit [17].

Finally, we may use the spectrum generated by the \first lly-polarized spinon states" and the supermultiplicity rule to obtain the free energy of the model in the thermodynam ic lim it. Besides the \particle-state" solutions of equations (12) and (13), we have to take into account the \hole-state" solutions [18]. At thermal equilibrium, the distribution functions of these solutions are determined by minimizing the free energy functional [19,20], F = TS = N = Q, with the constraint that each \fully-polarized spinon state" described by quantum numbers fJ g and fI_ig is associated with a spin degeneracy W_S as given in (14), where is the chemical potential. Following the standard methods of Takahashi [19], minimizing the free energy for a given quantum number distribution gives the following free energy

Here $_0$ (p) = $\frac{1}{2}$ t(p² $\frac{^2}{3}$) + and a = $\frac{1}{6}$ t 2 + $\frac{1}{2}$. In the limit of half lling, ! 1, s ! t(p² 2)=4, and the free energy reverts to the form obtained by Haldane for the corresponding Heisenberg model [7,21]. For general , elimination of c (p) yields the result

We have veried that high tem perature expansion of this free energy in powers of correctly reproduces the rst two non-trivial terms in the high tem perature perturbation theory.

From the free energy, it is not clear whether we may make a unique identication of the statistics of the spin and charge excitations. We note that the S=1=2 spinon excitations always combine into a state with a symmetric spin wavefunction, thus 2S spinons form a state with total spin S. In the limit of zero doping, the free energy is that of spin less fermions [7,21]. We can equally well regard the spinon excitations as S=1=2 fermions in a state with

a fully antisym m etric spatial wavefunction; or alternatively, as hardcore S = 1=2 bosons in a fully sym m etric spatial state.

In summary, we have derived the spectrum of the 1D t-J model with $1=r^2$ long-range exchange and hopping by the introduction of zeros into Jastrow ground-state wavefunctions. Our solution con $m \le K$ awakam i's conjecture that the ABA provides the exact spectrum, suggesting that despite the long-range nature of the interactions, two-body scattering dominates the long-wavelength physics. By interpreting multiple occupancy of momentum states in the spinon wavefunction as symmetric bound-complexes of spinons, we have been able to determine the degeneracies of the states needed to construct the free energy. Further work is required to determine the integrability conditions of this model. There are also several possible generalizations: most notably, SU (N) generalizations and the appealing possibility of Jastrow-integrable impurity models.
