OPTICAL ABSORPTION IN C₇₀ AND C₇₆: EFFECTS OF SYMMETRY REDUCTION

Abstract

Optical absorption spectra of C₇₀ and C₇₆ are calculated by a tight binding model with a long ranged Coulomb interaction. The spectrum of C₇₀ is in overall agreement with the experiment of molecules in a solution. The variations of the spectral shape are discussed relating with the symmetry reduction from C₇₀ to C₇₆.

1. Introduction

Recently, fullerenes C_N with hollow cage structures have been intensively investigated. M any optical experiments have been performed, and interesting properties due to electrons delocalized on molecule surfaces have been revealed. They include the optical absorption spectra of C_{60} and C_{70} [1], and the large optical nonlinearity of C_{60} [2,3]. In order to analyze the optical properties of C_{60} [2,3].

erties, we have studied the linear absorption and third harm onic generation of C_{60} by using a tight binding m odel [4] and a m odel with a long range C oulom b interaction [5].

The purpose of this paper is to extend the calculation of C_{60} [5] to higher fullerenes: C_{70} and C_{76} . The main purpose is to bok at how the optical absorption changes as the sym metry of the molecule reduces from C_{60} and C_{70} to C_{76} . We start from a tight binding model with a long ranged Coulomb interaction. The Coulomb interaction is the form of the Ohno potential with the onsite and long range interaction strengths. We also consider the broadening of the optical spectra due to lattice uctuations by using the bond disorder model.

W e shall report calculations in the following way. In the next section, our model and its meaning are explained. Calculation method is also described shortly. In x3, we report about C_{70} . The calculated absorption spectrum is shown, and comparison with experiments in a solution is made. W e will conclude that there is an overall agreement. Then, in x4, we turn to C_{76} . W e will discuss how the symmetry reduction appears in the spectrum. The summary is given in the last section.

2. Modeland form alism

W e use the following ham iltonian to consider optical spectra of C $_{\rm 70}$ and C $_{\rm 76}$:

The rst term of Eq. (2.1) is the tight binding model:

where t is the hopping integral; c_i ; is an annihilation operator of a -electron with spin . If t depends on the bond length, the results do not change so strongly, because m ain contributions come from the strong C oulom b potential. E ects of zero point vibrations and therm al uctuation of the lattice are described by the bond disorder m odel which is the second term of Eq. (2.1):

Here, $t_{i;j}$ is the Gaussian disorder potential at the bond hi; ji. We can estimate the strength of the disorder (standard deviation) t_s from the results by the extended Su-Schrie er-Heeger model [6]. The value would be t_s 0.05 0.1t. This is of the sim ilar magnitude as in the fullerene tubules and conjugated polymers. We shall treat interactions among -electrons by the following model:

where $r_{i;j}$ is the distance between the ith and jth sites and

is the O hno potential. The quantity U is the strength of the onsite interaction, V m eans the strength of the long range C oulom b interaction, and r_0 is the average bond length.

The m odel is treated by the H artree-Fock approximation and the single excitation con guration interaction m ethod (single C I), as we used in the previous paper [5]. All the quantities of the energy dimension are shown in the units of t. Parameters of the C oulomb interaction are changed within $0 \quad V \quad U \quad 5t$, and we search for the data which reproduce overall features of experiments of C₆₀ (shown in Ref. [5,7]) and C₇₀. The absorption spectra become an isotropic with respect to the orientation of the m olecule against the electric eld as reported in the free electron m odel (H uckel theory) of C₇₀ [8]. We average the anisotropy by rotating the m olecule. The averaged data can be compared with experiments of m olecules in solutions [1]. We also include the lattice uctuation elects by averaging over bond disorder potentials as well. Sam ples of the orientation of the m olecule and the disorder potential are changed 100 times. The good convergence is checked by com paring with the results of the sam ple num ber 50.

3. Optical absorption in C $_{70}$

Fig. 1(a) shows the molecular structure of the C_{70} . It has the rugbyball structure with the D_{5h} symmetry. The absorption spectrum is calculated for the Coulomb potential strengths U = 4t and V = 2t, and the bond disorder $t_s = 0.09t$. The same parameter set has been successful for C_{60} when the calculation is compared with the experiment [7].

Fig. 2(a) shows the calculated optical absorption. Fig. 2(b) shows the experimental data of C_{70} in a solution taken from [1]. The abscissa is scaled

by using t = 1:9eV. The optical gap near 1:0t accords well with the experiment. The small peaks around 1:8tm ay correspond to those of the experiment in the similar energy region. Commonly, there is a dip of the optical absorption at about 2:0t in the calculation and experiment. There is a maximum at 2:8t in the two data. Therefore, we conclude that there is an overall agreement between the calculation and the experiment. We note that the quantum lattice uctuation elects are also simulated well by the bond disorder model.

4. Optical absorption in C₇₆

There have been two possible structures for C_{76} which satisfy the isolated pentagon rule [9]. They have D_2 and T_d symmetries. Owing to the NMR experiment [10], them olecular structure has been identified. There is only the molecule with D_2 symmetry. The structure is shown in Fig. 1 (b). We calculate the optical absorption taking account of the bond disorder $t_s = 0.09t$, and C oulom b interaction strengths U = 4t and V = 2t. As far as the authors know at present, there are not detailed experimental data which can be compared with the calculation. However, the calculation will be helpful for experimental developments.

Fig. 3 shows the calculated results. The average by the rotation has been performed. The optical gap is about 0:7t and this is smaller than 1.8t of C₆₀ and that of C₇₀. There are two broad large features around 1:5t and 2:5t with ne structures. We could say that several small peaks around 1:5t and 2:6t in the C₇₀ data become fragmented to form the two wide features in the C₇₆

data. There is still a dip near 2:0t as in C $_{70}$. The position of the dip does not change so much. These variations could be regarded as owing to the symmetry reduction from C $_{60}$ and C $_{70}$ to C $_{76}$.

5. Sum m ary

We have considered optical spectra of higher fullerenes: C_{70} and C_{76} . We have mainly looked at how the optical absorption changes as the symmetry of the molecule reduces from C_{60} and C_{70} to C_{76} . In the report about C_{70} , we compared the data averaged over the molecule orientation with experiments in a solution. We have concluded that there is an overall agreement about the energy dependence in the optical spectrum. In the report of C_{76} , we have discussed how the symmetry reduction appears in the spectrum. As we proceed from C_{60} and C_{70} to C_{76} , several peaks merge into two large broad peaks owing to the symmetry reduction.
