## G eneralized t-j M odel<sup>1</sup>

## A bstract

By param eterizing the t-jm odel we present a new electron correlation model with one free param eter for high-tem perature superconductivity. This model is of SU $_{\rm q}$  (1;2) symmetry. The energy spectrums are shown to be modulated by the free parameter in the model. The solution and symmetric structures of the H ibert space, as well as the Bethe ansatz approach are discussed for special cases.

Strongly correlated electronic systems are believed to be important in studying the phenomenon of high-tem perature superconductivity [1,2]. An appropriate starting model suggested by Anderson is the t-j model [3,4]. The model describes the behavior of electrons on a discrete lattice with Ham iltonian including nearest-neighbour hopping (t) and antiferrom agnetic exchange (j). And the Hilbert space admits no double occupancy of any single site. As the two dimensional systems may share features of one dimensional systems [5], the t-jmodel in one dimension has been extensively investigated. The model is shown to be integrable and supersymmetric when j = 2t [6,7]. Nevertheless, the phenomenon of high-tem perature superconductivity greatly depends on detailed material. While in supersymmetric t-jmodel there is no non-trivial free parameters left. By taking into account some physical considerations, in this letter we present a generalized t-jmodel. The interest is that this model degenerates into a integrable one with a free parameter q and q-deformed supersymmetric symmetry.

Electrons on a lattice are described by canonical Fermi operators  $c_j^+$  and  $c_j^-$  satisfying anti-commutation relations given by

where = ";#; j = 1; ;L and L is the total number of lattice sites; cannihilates an electron of spin at site i. The Fock vacuum  $\mathfrak{D}i$  satis es  $c_i$   $\mathfrak{D}i = 0$ . As the double occupancy is not allowed, there are three possible electronic states at a given lattice site i:

The Ham iltonian of supersymmetric t-jmodel on a lattice of L sites is given by the following expression:

are the local generators of the supersym m etric algebra SU (1;2) and

are the number operators of holes, spin-up electrons and spin-down electrons at site i respectively. It is direct to prove that  $H_{tj}$  commutes with the total operators of SU (1;2) on lattice.

In param eterizing the usual supersymmetric t-jHam iltonian (2), we reasonably distinguish the interactions between spin up (down) electrons and between holes. Therefore the coupling constants of  $n_i^+ n_{i+1}^+$  and  $n_i^- n_{i+1}^-$  are different to the one of  $n_i^0 n_{i+1}^0$ .

We also suppose that the chemical potentials of spin up (down) electrons and holes are dierent. The terms for chemical potential is then of the form

where c and c are them ical potentials of a hole and an electron respectively. A counting to the no double occupancy condition,

In addition we consider the nearest-neighbour interactions between electrons with opposed spin direction. For an electron  $c_j^+$  located at site j, the general form of the interaction is  $n_{j-1}n_j+n_jn_{j+1}$ , where takes " and takes # and vice versa. If we impose the saturation condition on it, the interaction only contributes one term to the H am iltonian. W ithout loss of generality, we can assume that the interaction between opposed direction spin electrons is

which may be in a sense considered as the rst order expansion of Cooper pair in coordinate space. In the following, we will see that this term plays an important role in resumption of symmetry of the system.

Based on the analysis above and accounting to suitable boundary conditions, we present a modi ed t-jH am iltonian with parameters:

where ; ; ; are free parameters. This Ham iltonian no longer possesses the SU (1;2) symmetry and is not integrable in general. To recover the broken symmetry in some contents we note that the generators  $X_i$ , ; = 0;+; in (3) are also the trivial representations of the q-deformed algebra  $SU_q(1;2)$ . Therefore a reasonable candidate for symmetry imposed on the system is  $SU_q(2)$ . Before studying the symmetry of the system, we give some preliminary knowledge of  $SU_q(1;2)$ . This algebra is spanned by generators  $X_i$ ; = +; ;0. They satisfy the following algebraic relations:

As a quantum algebra,  $SU_q(1;2)$  has non-trivial H opf algebraic structures with operations coproduct, counit and antipode. Here we only give the coproduct expressions:

The co-product operator are algebraic isom orphism, (ab) = (a) (b); 8a;b2  $U_q(1;2) \cdot X^{0+}$  and  $X^{+0}$  are the algebra elements in the sense that

Their co-product representations  $(X^{+0})$  and  $(X^{0+})$  are obtained by the actions of co-product operator . It is not dicult to show that operators de ned by equation (12) satisfy the same relations (10) as X.

Now we return to study what conditions will be imposed on the parameters appearing in Hamiltonian (9), when the system enjoys the symmetry of quantum group  $SU_q(1;2)$ . De ne

where  $H_1 = X^{++} X$  and  $H_2 = X^{00} + X$ . The operator  $X^{0+} (X^{+0})$  can also be represented in terms of  $X^{+}$  and  $X^{0} (X^{+})$  and  $X^{0}$ . These operators satisfy the  $SU_q(1;2)$  algebraic relations (10).

It is easy to show that the bosonic operators X commute with the H am iltonian (9) for arbitrary parameters , , and . Therefore we only need to calculate

Sim ilarly, the vanishing condition for commutator  $[X^{0+};H]=0$  im poses the conditions = and = . Taking = =  $q^{-1}$  and = =  $q^{-1}$  in (9) we get a parameterized H am iltonian with q-deformed symmetry  $SU_q(1;2)$ ,

The calculations to check that the other operators commutes with  $H_{tj}^{q}$  is tedious but direct. Therefore the modiled t-jHamiltonian (18) is of  $SU_{q}(1;2)$  symmetry. It has a free parameter q. When q approaches one it becomes the usual t-jHamiltonian (2).

This generalized t-jm odel is again integrable. Sim ilar to the case of supersym m etric t-jm odel [6], it can be exactly solved in term s of the algebraic B ethe ansatz. The sym m etry algebra is now  $SU_q$  (1;2). M oreover, the usual coordinate B ethe ansatz also gives complete energy spectrum s and eigenstates of the generalized m odel by using the sym m etry algebra operators. The detailed exact solutions and phase diagram analysis are to appear in our paper [10]. In this letter we calculate the model at a few lattice sites, so as to show the sym m etric structures of the H ilbert space and the roles played by the free param eter q.

First we consider the case L = 2. The Ham iltonian is sim ply

By j iwe denote ji ji for ; = +; ;0. The ferrom agnetic states "" = j""i and  $_{\#\#}$  = j##i are eigenstates of H with energy q. The two-hole state  $_{00}$  = j00i is also an eigenstate with energy q  $^1$ . For con guration of one spin up electron and one spin down electron, the state is of the form  $_{\#\#}$  = aj"#i+ bj#"i. a and b are constants. The Schrodinger equation



The one spin down electron and one hole case also gives two eigenstates



with respect to energy E  $_{\rm 1}$  and E  $_{\rm 2}$  .

Therefore there  $9 (= 3^L = 3^2)$  independent states. A coording to the tensor decom position of the  $SU_q(1;2)$  algebra representation space, there are two invariant spaces. The eigenstates in the same invariant space can be exchanged by using the co-product operators of the algebra. One of the invariant subspace is constituted of states "",  $\frac{1}{n_\#}$ ,  $\frac{1}{0}$ ",  $\frac{1}{0}$  and  $\frac{1}{n_\#}$  with energy q. They satisfy the following exchange diagram



The left four states give rise to another invariant eigenstate space of energy  $q^{1}$ ,



W here the inverse action of (X ) is (X ) for  $\theta = +; 0$ .

For L = 3 there are 27 independent eigenstates. They decompose to four invariant subspaces of the algebra  $SU_q(1;2)$ .

From above calculations of nite lattices it is obvious that the energy spectrum s various with the parameter q. For L=3 the energy gap between ground and set excite states is changed from 1 to  $q+q^{-1}$  1. And when q is taken be minus some energy levels are reversed.

Now we analyze the spectrum in this special case. First we note that k=0 and k=1 should be ruled out since they give vanishing Bethe ansatz function. Second, one can divide the possible in pulses k into two parts,  $I: (\frac{1}{L}; \frac{2}{L}; \frac{(L-1)}{L})$  and  $II: (+\frac{1}{L}; +\frac{2}{L}; \frac{2}{L}; \frac{(L-1)}{L})$ . By rede ning  $K_j=2$   $k_j$ ,  $k_j$  2 II, one can show that they give the same Bethe wave functions as  $k_j$  2 I. Therefore, we have only L=1 possible in pulses and L=1 independent wave vectors. On the other hand, for the conguration with L=1 spin-up and one spin-down electrons, there exit L=1 independent states. While the Bethe ansatz

gives only L  $\,^{1}$  states. The m issing state can be compensated by using the SU $_{\rm q}$  (1;2) algebra operator X  $\,^{+}$  acting on the all spin-up state. This state has the same eigenenergy as the all spin-up state because X  $\,^{+}$  and H  $_{\rm tj}^{\rm q}$  are commutative.

From this simple special case, we see that the Bethe ansatz equation can give all the energy spectrum, but not complete states. This had been pointed out in other integrable models [8, 9]. It is worthy to note that Bethe ansatz states are the highest weight states on which the symmetric group acting gives all complete states. For other congurations, this conclusion is also true.

For the cong uration with one hole and L  $\,$  1 spin-up electrons, we can similarly write down the wave function,

These give L  $\,$  1 independent states. The m issing state can be obtained by using the operator X  $^{0+}$  acting on the ferrom agnetic states.

One can again see that the symmetry of the system helps in making up the missing states in Bethe ansatz approach. Hence investigating the symmetry of integrable system is not an articial technique. It is the basis in studying the completeness of the Hilbert space of the system and discussing related physical properties. For detailed Bethe ansatz solutions of this generalized t-jmodel see [10].
