# AN ADE O CLASSIFICATION OF M IN IM AL INCOMPRESSIBLE QUANTUM HALL FLU ID S<sup>y</sup>

## INTRODUCTION AND THE GENERAL CLASSIFICATION PROBLEM

The quantum Hall (QH) e ect¹ is observed in two-dimensional electronic systems (2DES's) subjected to a strong, uniform, transverse external magnetic eld. Experimentally, such systems are realized as inversion layers that form at the interfaces of heterostructures (e.g., GaAs/Al<sub>x</sub>Ga<sub>1x</sub>As) in the presence of an electric eld (gate voltage) perpendicular to the structures. To develop an idea of the orders of magnitude involved in QH systems, we recall that sample sizes are typically of a few tenths of a mm times a few mm, whereas the charge carrier densities, n = n<sub>electron</sub> n<sub>hole</sub>, are of the order of  $10^{11}$ /cm², and the magnetic elds, B<sub>c</sub>, range from about 0:1T up to 30T. Moreover, experiments are performed at very low temperatures, T, typically between  $10^{m}$  K and  $100^{m}$  K. An important quantity characterizing QH systems is the lling factor: denoting by  $_{0}$  = h=e = 4:14  $_{0}$ 1 T cm² the magnetic ux quantum and by B<sub>c;?</sub> the component of the magnetic eld B<sub>c</sub> perpendicular to a 2D ES, the lling factor is defined by  $_{0}$  = n  $_{0}$ =B<sub>c;?</sub> .

Two basic facts characterize the QH e ect. First, the Hall (or transverse) resistance  $R_{\rm H}$ , as a function of l=, exhibits plateaux at heights which are rational multiples of  $h=e^2$ . Second, with the quantization of  $R_{\rm H}$ , one observes a near vanishing of the longitudinal (or magneto-) resistance  $R_{\rm L}$ . Strictly speaking, this is true only if measurements are carried out in a stationary state and on large distance scales, that is, on scales larger than the phase-coherence length of the constituents of the

system s. For QH system s, the phase-coherence length is of the order of 100 m (a so-called \m esoscopic" length scale). For a general account of \quantum interference uctuations" in disordered, m esoscopic system s, see Ref. 2; and, in particular, for som e results in m esoscopic QH system s, see Ref. 3.] The near vanishing of  $R_L$  indicates the absence of dissipative processes in the corresponding QH system s which, in turn, is interpreted as the presence of an energy gap above the ground-state energy in these m any-body system s (so-called incompressibility). Incompressibility is a crucial input to our analysis and, in these notes, we use the term quantum Hall uid to denote a QH system which exhibits incompressibility. Next we brie y review the main logical steps that lead to the general classic cation problem of QH uids.

G auge Sym m etry and  $\hat{\mathbf{t}}(1)$ -Current A lgebra. For de niteness, let us consider a QH uid which is con ned to a domain of the (1;2)-plane, and let the external magnetic eld, B c, be along the 3-axis, i.e., B c =  $(0;0;B_c)$ . Furtherm ore, let us assume that the spins of the constituent electrons and/or holes are aligned with the strong eld B c. For an analysis of QH uids including the spin degrees of freedom, see Refs. 4-6.]

We denote by Z (A) the partition function (at T = 0) of a 2DES con ned to a space-time domain = R and coupled to an external electromagnetic eld with associated potential 1-form A =  $^P_{\ \ =0}^2$  A (x)dx , where A = A tot; A c; with  $\theta_1 A_{c;2}$   $\theta_2 A_{c;1}$  = B c xed. Exploiting the U (1)-gauge symmetry of non-relativistic Schrodinger quantum mechanics and the incompressibility (R = 0) of Q H uids, one can show 4 that, in the limit of large distance scales and low frequencies (scaling limit), the elective action of a Q H uid (i.e., the logarithm of Z (A)) takes the universal asymptotic form

where  $_{\rm H}=R_{\rm H}^{-1}$  is the Hall conductivity of the uid, A ^ dA =  $^{\rm P}$  " A @ A is the abelian Chem-Sim ons form , and B  ${\rm T}:$  (A  ${\rm j}_{\rm L}$ ) denotes a \boundary term " depending only on A  ${\rm j}_{\rm L}$ , the restriction of A to the boundary space-time @ . Since the Chem-Sim ons term in Eq. (1) exhibits a boundary U (1)-gauge anomally, the gauge invariance of the total elective action, S  $^{\rm as}$  (A), constrains the form of the boundary term B  ${\rm T}:$  (A  ${\rm j}_{\rm L}$ ). The cancellation of the gauge anomally of the Chem-Sim ons term can be achieved by introducing a set of N  $_{\rm L}$  and a set of N  $_{\rm R}$  chiral U (1) boundary currents whose coupling to the external electromagnetic eld A  ${\rm j}_{\rm L}$  is given by N  $_{\rm L=R}$  electric charges which can be arranged in a \charge vector"  ${\rm Q}_{\rm L=R}$  with N  $_{\rm L=R}$  components. Physically, these left/right chiral boundary systems (CBS's) describe gapless, chiral electric currents of electrons/holes circulating at the edge of a QH sample. Denoting by W  $_{\rm L=R}$  ( ${\rm Q}_{\rm L=R}$ ; A  ${\rm j}_{\rm L}$ ) the electric action for these CBS's, the boundary term B  ${\rm T}:$  (A  ${\rm j}_{\rm L}$ ) is given by

$$B:T:(A_{j_0}) = W_L(Q_L;A_{j_0}) W_R(Q_R;A_{j_0}) + G:I:(A_{j_0}); \qquad (2)$$

where  $G:I:(A_{\frac{1}{2}})$  stands for a possible gauge-invariant boundary term . Then gauge-anomaly cancellation implies that the Hall conductivity  $_H$  is given by

where (n; m) denotes the Euclidean scalar product of two vectors n and m. For details, see Refs. 4-6; and for related points of view on the role of edge currents in QH uids, see the works in Ref. 7.

Quantum Hall Lattices. The vectors  $Q_L$  and  $Q_R$  are not the only data encoding the physics of an incompressible QH uid in the scaling limit. Excitations above the ground state of the QH uid are described by unitary representations of the  $\hat{u}$  (1)-current algebras. Am ong all possible unitary representations ('  $R^{N_{L=R}}$ ) only a subset, in fact, a lattice, will be realized in a QH uid. Combining known properties of these representations with the physical requirement that the spectrum of local excitations of CBS's be generated by excitations with the quantum numbers of electrons and holes (i.e., by excitations with electric charges—e that obey Ferm i statistics and are relatively local) one infers that the additional data needed to characterize the scaling limit of a QH—uid is a pair of odd, positive integral lattices—L and R: L=R is generated by  $N_{L=R}$  vectors  $q_{(1)}$ ;:::; $q_{(N_{L=R})}$  describing distinct one-electron or one-hole excitations above the ground state. A general vector q in L=R represents a multi-electron/hole excitation of the QH—uid. In such a basis, L=R is fully specified by its integral G ram matrix  $K_{L=R}$

Ferm istatistics of the elem entary charge carriers in plies the oddness of the lattice  $_{L=R}$  (i.e., in any basis of  $_{L=R}$ , at least one basis vector has an odd squared length). The vectors in  $_{L=R}$  do not necessarily labelall physical excitations of the Q H uid. Indeed, any vector in the dual lattice  $_{L=R}$  (generated by the vectors  $h^{(j)} = {}^{P} {}^{N}{}_{L=R}$  (K  ${}^{1}{}_{L=R}$ )  ${}^{ji} {}^{q}_{(i)}$ ,  $j=1;\ldots;N_{L=R}$ ) describes a (multi-)quasiparticle excitation which is relatively local to all electrons and holes in the system . However, in general, such an excitation has fractional electric charge and anyonic statistics. It is the  $N_{L=R}$  -dimensional analogue of the celebrated Laughlin vortices.

The vector  $Q_{L=R}$  assigns an electric charge to every boundary excitation. Hence it is a linear functional on the lattice  $_{L=R}$ , i.e., an element of the dual lattice  $_{L=R}$ , and  $Q_{el}(q) = Q_{L=R}$  q is the electric charge, in units of e, of the excitation labelled by q. Thus  $1 = Q_{el}(q_{(i)}) = Q_{L=R}$   $q_{i} = (Q_{L=R})_{i}$ , for every basis vector  $q_{(i)} > Q_{L=R}$ . This means that  $Q_{L=R}$  is what m athem aticians call a visible vector in  $_{L=R}$ . This has an all in portant consequence:

Eq. (3) then gives the rational quantization of the Hall conductivity  $_{\rm H}$ , in units of  $e^2$ =h, as observed in QH uids.

A pair (;Q) is called a quantum Hall lattice and represents the geometrical data characterizing a QH uid. Classifying universality classes of QH uids thus amounts to classifying pairs of QH lattices ( $_{\rm L}$ ;Q $_{\rm L}$ ) and ( $_{\rm R}$ ;Q $_{\rm R}$ ).

## CLASSIFICATION OF QUANTUM HALL LATTICES

A lattice which is the orthogonal direct sum of several sublattices is called decom posable (otherwise indecom posable). QH uids corresponding to decom posable or indecom posable QH lattices are called composite or elementary uids, respectively. For a composite QH uid consisting of two components, we have  $_{\rm H}=_{\rm H}^1+_{\rm H}^2$ , where  $_{\rm H}^{\rm i}=_{\rm H}^{\rm i}=_{\rm H}^2+_{\rm H}^2$ , where  $_{\rm H}^{\rm i}=_{\rm H}^2+_{\rm H}^2$ , with  $_{\rm H}^0\in_{\rm H}^2=_{\rm H}^2$ ; i=1;2. In the following, we focus our attention on indecom posable QH lattices. We note that QH uids consisting of electrons (L) and holes (R) are composite and thus will not appear explicitly in the subsequent classication. Moreover, since the discussions of the two chirality subsectors (L and R) are analogous, we may focus on, say, the left one. We now drop the index L from our notation.

Writing  $_{H} = (n_{H} = d_{H})e^{2} = h$ , with  $gcd(n_{H}; d_{H}) = 1$ , Eq. (3) tells us that, for some positive integer 1, called the level of the Q H uid,

$$ld_{H} = detK ; and  $ln_{H} = Q K Q^{T} ;$  (5)$$

where K is the cofactor (or adjoint) matrix of K, ie., K  $^1 = ^1$  K. Next we state two general classication results on quantum Hall lattices (for proofs, see Ref. 6).

First, for a given Hall fraction  $_{\rm H}$  and two positive integers 1 and N $_{\rm o}$ , one can prove that there are only nitely many inequivalent QH lattices (;Q) with  $_{\rm H}$  =  $(Q;Q)e^2=h=Q$  K $^1Q^Te^2=h$ ; =  $Id_H$ , and dim N $_{\rm o}$ .

Second, one can show that the m in im al, non-trivial fractional charge, e , associated with a Q H lattice (; Q) is given by

where is som e integer dividing the level 1. In particular, if  $d_H$  is even, one can prove that the charge parameter has to be a multiple of 2 and the level 1 a multiple of 4. Thus, for the observed Q H uids with  $_H$  h= $_{\rm e}^2 = \frac{1}{2}$ ;  $(\frac{3}{2})$ , and  $\frac{5}{2}$ , a model-independent prediction is that e is a fraction of e=4: e = (2=) e=4!

Next we focus our attention on m in im al Q H lattices which are characterized by the property that their levels satisfy l = 1. There are several basic facts (for proofs, see Ref. 6) about the corresponding universality classes of m in im allelementary Q H

uids which make these classes particularly attractive from a theoretical, as well as from a phenomenological, point of view:

- (M 1) For the fractions  $_{\rm H}$  = 1=(2p+1)e<sup>2</sup>=h; p = 1;2;::, one can easily show that the fam ous Laughlin uids  $^9$  do correspond to the unique m in imal indecom posable Q H lattices (;Q) where: is one-dimensional, it is generated by a vector  $\mathbf{q}_{(1)}$  with length squared  $(\mathbf{q}_{(1)};\mathbf{q}_{(1)})$  = 2p + 1 = K  $_{11}$  = K , the visible vector Q is given by Q =  $\mathbf{p}^{(1)}$  where  $\mathbf{p}^{(1)}$  = 1=(2p+1)  $\mathbf{q}_{(1)}$  is generating the dual lattice , and  $_{\rm H}$  h=e<sup>2</sup> = Q;Q) = 1=(2p+1).
- (M 2) If l=1 then  $d_H=\det K$  has to be odd. Experim entally, there is ample evidence for the \odd-denom inator rule". For one-layer (or one-component) systems, the only l=1 m by established exception to this rule is a QH l=1 uid with l=1 m by l=1 less l=1 for a discussion of even-denom inator QH l=1 uids, see Refs. 5 and 6.] Furtherm ore, the following relationship holds between the numerator l=1 of the Hall conductivity l=1 and the dimension l=1 uids of the indecomposable QH lattice:

(M 3) For m inim alQH uids, one can prove a charge-statistics theorem: for such uids, the (anyonic) statistical phases, (p) = (p; p) = p  $K^1 p^T$ , of (quasiparticle) excitations, labelled by p 2, are completely determined by the single quantity of their (fractional) charges,  $Q_{el}(p) = (Q; p) = Q$   $K^1 p^T$ . [In non-m inim alQH uids, there are anyons which have the same fractional charges but dierent statistical phases!] Experimentally, there is evidence that the observed odd-denom inator QH uids exhibit leamentary anyons with fractional charges given by  $e = e=d_H \cdot Eq \cdot (6)$  then suggests that e = 1, which is a property automatically satisfied by minimalQH uids where e = 1 = 1!

Conway, Sloane, and Sloane  $^{13}$  have compiled a classication of all positive integral quadratic forms K associated with an indecomposable (even or odd) lattice—for a range of determ inants given by 1—det K 25 and for lattice dimensions up to a limit ranging from 18 (for = 1) to 7 (for = 25). This classication involves over 100 odd lattices of odd determ inant. When combined with a systematic study of visible vectors Q in the associated dual lattices—, it yields, for a physically interesting range of Hall conductivities—H, all possible minimal indecomposable Q H lattices (; Q) of dimension N = dim—N (H), where the dimensions N (H) depend on the limits in Ref. 13 and satisfy (7). We summarize our results in Table 1 below, where the dimensions N (H) are indicated in square brackets to the right of each fraction—H, except for fractions with  $n_{\rm H}=1$  for which the Laughlin—uids are unique (see (M 1)).

In Table 1, m in in al indecomposable QH lattices (or, equivalently, universality classes of m in in alelementary QH uids) are specified in terms of explicit matrix and vector realizations of the pairs (K;Q). For a general discussion of the geometry of

QH lattices making use of gluing theory, see Ref. 6.] The results are presented relative to lattice and dual lattice bases in and , respectively, which make the symmetries of the corresponding QH uids most manifest.  $^4$   $^6$  The general results of Refs. 13 and 6 show that most QH lattices in the range of determinants and dimensions specied above have a Gram matrix of the form

which we abbreviate by writing fO  $f^{1;s_1}X_1;^{t_2;s_2}X_2g_N$ , where C  $(X_i)$  denotes the Cartan matrix of a simply-laced simple Lie algebra,  $X_i$ , with non-trivial center, i=1;2. For i=1;2;  $X_i$  is one of the following algebras:  $A_{n-1}=su(n);$   $n=2;3;\ldots;$   $D_n=so(2n);$   $n=4;5;\ldots;$   $E_6$ , or  $E_7$ .  $[E_8$ -sublattices do not appear in elementary QH uids! For the Cartan matrices we use the explicit forms given, e.g., in Ref. 14.] Furthermore, in (8), O stands either for an odd integer, O=2p+1;  $p=1;2;\ldots;$  or for an odd, two-dimensional integral quadratic form with G ram matrix  $O=\frac{a}{b}$  b c, abbreviated by  $a^bc;$  N=rank K=dim. The quantities  $\underline{t}_i$  and  $\underline{s}_i$  denote (rank  $X_i$ )-dimensional integral vectors of the form  $\underline{t}_i=(0;\ldots;0;$   $1;0;\ldots;0)$ , where 1 stands in the  $t_i^{th}$  place indicated by  $t_i^{t,s}X_i$ , and similarly for  $\underline{s}_i$ ; i=1;2. [The vectors  $\underline{s}_1$  and  $\underline{s}_2$  are understood to be absent if dim O=1.] Finally, if  $t_i$  or  $s_i=0$  then  $\underline{t}_i$  or  $\underline{s}_i=\underline{0}$ .

A particularly interesting subclass of m inim al indecom posable Q H lattices is formed by what we call maximally symmetric lattices. A maximally symmetric Q H lattice has the property that the neutral sublattice of (which lies in the orthogonal complement of Q, i.e.,  $Q_{el}(p) = Q$   $K^1$   $p^T = 0$ , for p = 2) is a direct sum of  $A_n$ ;  $D_n$ , and  $E_{n \in 8}$ -lattices, and nothing else. In particular, they have dim O = 1 and, relative to the dual bases chosen in (8), their visible vectors are always of the form Q = (1;0;:::;0). One can show  $^{4}$   $^{6}$  that the corresponding maximally symmetric Q H uids exhibit K ac-M cody algebras at level 1 associated with the Lie algebras X  $_1$  and X  $_2$ .

In Table 1, we use round brackets (0  $f^{1;s_1}X_1;^{t_2;s_2}X_2$ )<sub>N</sub> to indicate maximally symmetric QH lattices, thereby distinguishing them from all other possible minimal indecomposable QH lattices (with N N ( $_{\rm H}$ )) for which we use square brackets [:::] $_{\rm N}$ . Moreover, for maximally symmetric QH lattices, we do not display the vectors Q explicitly.

It seems natural to call maximally symmetric QH uids \generalized Laughlin uids" because they can be constructed from Laughlin's 1=(2p+1)- uids by \adding symmetries and iterating". Let

sim ilarly to (8). Then one easily proves the following relations for

where  $_{H}^{0} = (_{-}^{0})e^{2} = h$ , with  $_{-}^{0} = \det K_{-}^{0}$  and  $_{-}^{0} = Q_{-}^{0} K_{-}^{0} Q_{-}^{0T}$ , and accordingly for the unprimed quantities; see also (5).

We note that, for a given value of  $_{\rm H}$ , one can construct all maximally symmetric QH lattices, in arbitrary dimension, reproducing that value of  $_{\rm H}$ . In Table 1, all minimal, maximally symmetric QH lattices are given for the physically relevant range of Hall conductivities 1=7  $_{\rm H}$   $h=e^2=n_{\rm H}=d_{\rm H}$  3 with  $n_{\rm H}$  12 and  $d_{\rm H}$  17, and all QH lattices that can be constructed on the basis of the classication in Ref. 13 are displayed. For additional results, see Refs. 5 and 6.

A step towards a comparison of our results with phenomenological data obtained in one-layer (or one-component) QH system s<sup>10</sup> is made, in Table 1, by indicating in bold type all experim entally observed fractions. Moreover, Hall fractions for which there is some evidence are typed in bold and enclosed in brackets. All other fractions (plain) have so far not been established experimentally in one-layer systems. A discussion of our results can naturally be organized by collecting QH lattices of the sam e \sym m etry type " into \structural fam ilies"; see Refs. 5 and 6. M oreover, in these references, detailed discussions of physical in plications of our results above and of further complete investigations of some more general classes of QH lattices than the m in im alones are given, as well as comparisons with the standard Haldane-Halperin 15 and Jain-Goldman 16 hierarchy schemes. Here we only mention that Table 1 comprises the Laughlin 1=(2p+1) – uids, the \basic" Jain uids<sup>17</sup> (corresponding to the A-type uids with  $_{\rm H} < \frac{1}{2} {\rm e}^2 = h$ !), and the two two-dimensional hierarchy uids with  $_{\rm H} = \frac{4}{11} \, {\rm e}^2 = h$  and  $\frac{6}{17} \, {\rm e}^2 = h$ . All other (universality classes of) QH uids given in Table 1 do not seem to have appeared previously in the literature. Evidence that some of these \new "QH uids m ight actually have been observed in some experiments will appear in Refs. 5 and 6.
