M icroscopic Analysis of the Non-D issipative Force on a Line
Vortex in a Superconductor: Berry's Phase, Momentum Flows
and the Magnus Force

A bstract

A m icroscopic analysis of the non-dissipative force F_{nd} acting on a line vortex in a type-II superconductor at T=0 is given. We not examine the Berry phase induced in the true superconducting ground state by movement of the vortex and show how this phase introduces a Wess-Zum ino term in the hydrodynamic action S_{hyd} of the superconducting condensate. Appropriate variation of S_{hyd} gives F_{nd} and variation of the Wess-Zum ino term is seen to contribute the Magnus (lift) force of classical hydrodynamics to F_{nd} . Because our analysis is based on the true superconducting ground state, we are able to con mand strengthen earlier work by Ao and Thouless which examined the Berry phase arising in an ansatz for the many-body ground state. We also determine F_{nd} through a microscopic derivation of the continuity equation for the condensate linear momentum. This equation yields the acceleration equation for the super ow and shows that the vortex acts as a sink for the con-

densate linear m om entum . The rate at which m om entum is lost to the vortex determ ines the non-dissipative force $F_{\rm nd}$ and the result obtained agrees identically with the Berry phase calculation. The M agnus force contribution to $F_{\rm nd}$ is seen in both calculations to be a consequence of the vortex topology. A prelim inary discussion is given regarding nite temperature extensions of the Berry phase calculation, with emphasis on its relevance for the sign anomaly occurring in Halle ect experiments on type-II superconductors in the ux ow regime.

I. IN TRODUCTION

As is well-known, the mixed state of a type-II superconductor is characterized by the partial penetration of magnetic ux into the superconductor in the form of ux lines, or vortices. E orts to understand the dynamical behavior of such vortices have persisted for alm ost 30 years, and though much progress has been made, a number of basic issues continue to be controversial. A vortex in a type-II superconductor is acted on by 3 classes of forces: (i) pinning forces due to lattice defects; (ii) dissipative forces due to coupling of the vortex core to the lattice; and (iii) a non-dissipative force F_{nd} due to an applied magnetic eld H ext, an electric eld E generated by the vortex motion, and the hydrodynam ic pressure of the surrounding condensate of superconducting electrons. A lready in the classic models of Bardeen-Stephen (BS)1 and Nozieres-Vinen (NV)2, the form of Fnd is controversial. The debate centers around whether F nd includes a contribution from the M agnus (lift) force of classical hydrodynamics which acts on a solid body moving through a uid which circulates about it3. Both models: (1) are macroscopic/phenomenological in character, based on Maxwell-London electrodynamics, classical thermodynamics, and physical intuition; (2) assum e strongly type-II superconductors so that the non-local character of BCS superconductivity can be approximated by a local dynamics; (3) assume T = 0 so that normal electrons are only present inside the vortex core whose radius is equal to the zero temperature coherence length $_{0}$; and (4) the applied magnetic eld satis es H $_{\mathrm{c}_{1}}$ < H $_{\mathrm{ext}}$ that vortex-vortex interactions can be ignored. The vortex is assumed to be immersed in an applied transport current $J = sev_s$, where s is the superconducting electron density far from the vortex; e is the electron charge; and $v_{\rm s}$ is the velocity of the applied supercurrent with respect to the lattice rest frame. In the BS model, the non-dissipative force (per unit length) is due to the Lorentz force, $_{\rm s}$ h! ($v_{\rm s}$ 2)=2. Here h is P lanck's constant; 1 is the vortex winding number whose sign speci es the sense of the condensate super ow about the vortex (which is threaded by a single ux quantum $_0$ = hc=2e). In this paper it will be assumed that all vortices are rectilinear (viz. line) vortices whose axis

lies along 2. In the NV model, F_{nd} is the sum of the Lorentz force and the M agnus (lift) force $_{s}$ m K v_{L} 2, where m is the electron mass; K = h! = 2m is the circulation of the condensate near the vortex core; and v_{L} is the translational velocity of the line vortex with respect to the lattice. The discrepancy in the form of F_{nd} in the two models leads to dierent predictions for the Hall angle in the ux ow regime 4 . Recent work by Ao and Thouless 5 (A & Th) has renewed interest in this controversy concerning F_{nd} . These authors argue that the correct form for F_{nd} is the NV-form, $F_{nd} = _{s}h!$ ($v_{s} = v_{L}$) 2=2, and that the M agnus (lift) force contribution arises from a Berry phase induced in the many-body ground state by the vortex motion. Their analysis is based on an ansatz for the many-body ground state and so it might be objected that their result concerning the presence of the M agnus force is a consequence of their ansatz and not an actual property of the true superconducting ground state. Thus it is of considerable interest to see if F_{nd} can be determined on the basis of a microscopic analysis in which the superconducting dynam ics is treated exactly.

In this paper, two calculations of the non-dissipative force F_{nd} will be provided which are based on the microscopic formulation of the superconducting dynamics due to Bogoliubov⁶. This approach is powerful enough to treat problems with spatial inhom ogeneities as occur when a vortex is present in the superconductor. In Section II, F_{nd} will be determined by working with the true superconducting ground state in the case where a vortex is present. We rest show how this state is constructed from the exact solutions of the Bogoliubov equations in the presence of a vortex. This state is seen to develop a Berry phase as a consequence of the vortex motion. Our approach in this subsection is a significant generalization of one used previously to determ ine the intrinsic orbital angularm on enturn in ${}^3He\{A$ for a spatially uniform orbital texture 7 . The Berry phase is calculated and found to agree with the result of Ref. 5 in the case of a neutral super uid. A discussion of why the approximate calculation of A & Th has produced the exact result is also given. In the case of a charged super uid, gauge invariance requires a correction to the Berry phase obtained in Ref. 5; however this correction will be seen to not in uence the nal result for F_{nd} . It is then shown how the Berry phase induces a Wess-Zum ino term in the action describing the hydrodynamic degrees of freedom

of the superconducting condensate. Variation of the hydrodynam ic action with respect to the vortex trajectory gives F_{nd} which is found to have the NV-form. This calculation also shows that the M agnus force contribution to F_{nd} is a consequence of the Berry phase induced by the vortex motion. As our calculation is based on the true superconducting ground state, we see that the result of A & Th is not a consequence of their ansatz, but a real property of type-II superconductivity. In Section III, F nd is determined via a microscopic derivation of the acceleration equation for the super ow. We not the expected contributions o the vortex due to spatial variation of the chem ical potential, and to the electric and magnetic elds present. But by carefully tracking the e ects of the vortex topology on the dynamics, we also nd a singular term that describes the disappearance of linear momentum into the vortex, and which represents the non-dissipative force acting on the vortex. We nd that this force is also given by the NV-form of F_{nd}, in agreement with the Berry phase calculation of Section II. As NV have show n², the terms in the acceleration equation acting o the vortex lead to a ux of linear momentum in towards the vortex and corresponds to their determination of F_{nd} . By keeping track of topological e ects, we will see that the rate at which linear momentum is appearing inside the vortex is exactly equal to the rate at which it is owing in towards it so that linear momentum conservation is maintained in the combined condensate-vortex system as expected. We close in Section IV with a discussion of our results; and with preliminary remarks concerning nite temperature elects and their possible consequences for the sign anomaly occurring in Halle ect experiments on type-II superconductors in the ux ow regime. Two Appendices are also included: Appendix A indicates how the Berry phase appears in a propogator formulation of the Adiabatic Theorem; while Appendix B gives a microscopic derivation of the gauge invariant Wess-Zum ino term which is independent of the Berry phase calculation given in Section II, and also obtains the hydrodynam ic action for the superconducting condensate.

II. BERRY 'S PHASE AND THE NON-D ISSIPATIVE FORCE $F_{N\,D}$

This Section is organized as follows. In Section IIA we construct the true superconducting ground state in the case where a single vortex is present and derive an expression for the Berry phase induced in this state by the vortex motion in terms of the Berry phase induced in the eigenstates of the Bogoliubov equation (in the presence of a single vortex). In Section IIB the Berry phase in the true superconducting ground state is evaluated. In Section IIC we show how this Berry phase induces a topological Wess-Zum ino term in the action describing the hydrodynamic degrees of freedom of the superconducting condensate. Variation of the hydrodynamic action with respect to the vortex trajectory gives $F_{\rm nd}$ and it is seen in the course of evaluating this variation that the Berry phase induced Wess-Zum ino term is responsible for the occurrence of the classical Magnus (lift) force in $F_{\rm nd}$.

A.Constructing the Ground State

Our starting point is the Bogoliubov equation⁶. This formulation of the quasiparticle dynam ics is capable of handling the spatial inhomogeneities introduced by a line vortex which for the time being is assumed to be xed at the origin (in the lattice rest frame). As in the models of BS and NV, we will: (i) assume T = 0 so that the physical behavior of the superconductor is captured by the superconducting ground state; (ii) approximate the non-local character of the BCS superconducting ground state by a local dynamics which is, strictly speaking, only true for strongly type-II superconductors (it is not anticipated that non-locale ects will qualitatively modify our results); and (iii) assume H $_{\rm c_1}$ < H $_{\rm ext}$ so that vortex-vortex interactions can be ignored and we can focus on a single vortex. We adopt cylindrical coordinates (r, , z) with the z-axis along the vortex axis. In the presence of a line vortex, the gap function takes the form (r) = $_{0}$ (r) exp [i] so that the phase of (r) is not a single valued function of position. As the eld point rencircles the gap (r) =2 (m ore generally, (r) = $_0$ (r) exp[i!] so that! the vortex axis,

where ! is an integer known as the vortex winding number). The gap amplitude $_0$ (r) goes linearly to zero at the origin and approaches a constant value far from the vortex. In the presence of a magnetic eld H = r A, the Bogoliubov equation is

Here $E_f = p_f^2 = 2$ is the Ferm i energy (h = m = c = 1 unless explicitly stated otherwise); n is an index which labels the spectrum of H_{BOG} ; U_0 (r) is the pinning potential which will henceforth be set equal to zero so that we are dealing with a clean type-II superconductor. As is well-known, equation (1) has positive and negative energy solutions (relative to the Ferm i surface) which are related as follows: if $(u_n \ v_n)$ is (the adjoint of) a solution of equation (1) with energy $E_n > 0$, then $(v_n \ u_n)$ is (the adjoint of) a solution of equation (1) with energy $E_n < 0$. The two-component elementary excitations built up from the solutions of equation (1) will be referred to as Nambu quasiparticles (NQP) and quasi-holes (NQH). Let $a_{n;1}^y$ create a positive energy $(E_n > 0)$ NQP and $a_{n;2}^y$ create a negative energy $(E_n < 0)$ NQP. Introducing the two-component eld operator (r) for a NQP, we expand it in terms of the solutions of eqn. (1)

As we shall see in the following sub-section, adiabatic motion of the vortex produces a Berry phase 10 in the solutions of eqn. B.Calculating the Berry Phase

Berry¹⁰ showed that when a quantum system is coupled to an adiabatically-evolving environment and the system is initially prepared in an eigenstate of the t=0 H am iltonian H [R (0)] (the adiabatic coupling of the system to its environment enters through the set of parameters R (t) = (R₁(t); n (t)R) which appear explicitly in the system H am iltonian H [R (t)]), that the time development of this state acquires a non-integrable phase B (t) now known as the Berry phase

In Appendix A we show how the Berry phase arises in a propogator approach to the Adiabatic Theorem which will be useful for our discussion in Section IIC. In our case, the quantum system is the two-component NQP eld; the environment is the superconducting condensate described by the gap function (r); and the adiabatically-varying parameters correspond to the vortex position $r_0(t) = (x_0(t); y_0(t))$. To determine in eqn. (9) we must obtain the eigenstates of H_{BOG} for a given vortex position. These states were rst considered by C aroliet. al. 12, and a detailed solution for the bound and scattering states was given by B ardeen et.al. These eigenstates take the form

Here hk_z is the z-com ponent of the quasiparticle m om entum; 2 is required to be an odd-integer to insure single-valuedness of the eigenstate \hat{r}_n ; tan $(r) = (y - y) = (x - x_0)$; and $r = \frac{q}{(x - x_0)^2 + (y - y_0)^2}$. The spinor \hat{f}_n (r) has been exam ined in Ref. 9 analytically for

a simple model of the gap function, and numerically via a variational method. We will not require its detailed form below. To simplify the notation, we have collected the quantum numbers specifying the eigenstate into the single label n. At this point it is necessary to recall a basic property of BCS superconductivity. Specically, that the global sym metry corresponding to changing the phase of the LQP eld operator is spontaneously broken. Because of this, the ground state becomes in nitely degenerate and is parameterized by a phase angle few ref. 13). The phase few and particle number N become canonically conjugate observables and two representations are possible for the many-body states. In one representation, particle number is well-deed, but fis not; while in the second, fis well-deed, but particle number is 1^{4} . Our calculation corresponds to the latter case where them any-body states do not contain a deen ite number of particles. Because of this, a calculation of ground state properties will require what amounts to a normal ordering prescription. An example of the kind of normal ordering we have in mind is the xing of the Fermi energy through the requirement that the expectation value of the particle number operator in the ground state equal the number of electrons present: $\frac{P}{k} 2v_{k}^{2} = N$. Because our calculation of is based on a ground state in which particle number is

not well-de ned, a similar kind of normal ordering is necessary and can be implemented straightforwardly.

It is extremely important to realize that this form of f(r) insures that only one ux quantum threads the vortex¹⁵. Thus our normal ordering choice, eqn. (19), is xed by the requirement that the ux through the vortex agree with our assumption = hc=2e. (In the following subsection the ground state Berry phase will be related to the occurrence of a Wess-Zum ino term in the hydrodynamic action. For an independent derivation of this Wess-Zum ino term which does not rely on the above normal ordering prescription, see Appendix B.) With this choice of normal ordering

for ! = 1, as assumed in our calculation. Thus we see that the true superconducting ground state does in fact develop a Berry phase as a consequence of the vortex motion. We are able to obtain this Berry phase and we see that the approximate calculation of Ref. 5 has produced the exact result in the case of a neutral super uid. For a charged super uid, the gauge invariant form of the Berry phase must be used which adds the $\ensuremath{\mathblue{A}}_0$ "—term to the ground state Berry phase. It is clear from our calculation that, in the case of a neutral super uid, the Berry phases are ultimately due to the azim uthal symmetry of the vortex which requires the eigenstates of the Bogoliubov equation to be eigenfunctions of the z-component of orbital angular momentum. Examination of the ansatz of A & The shows that it is such an eigenfunction and so has the essential—dependence necessary for a proper determination of the Berry phase in the case of a neutral super uid. Because we have worked with the true superconducting ground state it is clear that the gauge invariant Berry phase and its physical consequences, to be discussed below, are true properties of

the superconducting ground state when a moving vortex is present, and not the result of a speci c ansatz wavefunction.

C . B erry's P hase, the H ydrodynam ic A ction and F $_{\mbox{\scriptsize nd}}$

Here (x) is the eld operator for a Landau quasiparticle with spin; H = r A is the microscopic magnetic eld and its associated vector potential; $H_{\rm ext}$ is an applied magnetic eld; $E = (r A_0 + 0A = 0t)$ is the electric eld produced by the vortex motion; g > 0 is the (attractive) coupling constant; and repeated indices are summed over. We see that the Berry phase induced in the superconducting ground state by the vortex motion has found its way into S_{hyd} . Such contributions to low energy elective actions by Berry phases are well-known and the induced term is referred to as a Wess-Zum ino term 19 . Wess-Zum ino term s are topological in origin and in our case it is the vortex topology which is responsible for the occurrence of such a term in S_{hyd} . We are interested in a super ow

This is the principal result for Section II and is seen to agree with the result of Ao and Thouless⁵ which was based on an ansatz for the many-body ground state. In this section we have worked with the true superconducting ground state (in the presence of a vortex) and found that the Berry phase generated in this ground state is responsible for producing a Magnus (lift) force on the vortex as argued by Ao and Thouless⁵, and that F_{nd} is given by the NV-form. In the following section we will focus on the momentum ows occurring in the superconductor and from this analysis we will be able to determ ine the non-dissipative force on the vortex. The result obtained in Section III will be found to be identical to the result in eqn. (37).

III. LIN EAR MOM EN TUM FLOW ANALYSIS AND F $_{\mbox{\scriptsize N}\mbox{\scriptsize D}}$

In this section we will exam ine the ow of linear momentum in a superconductor when a moving line vortex is present. Our microscopic analysis will be based on the Bogoliubov equation. In the rst subsection we will re-write the Bogoliubov dynamics in a pseudorelativistic notation which proves convenient for calculational purposes. In Section IIIB we work out the continuity equation for the condensate linear m om entum at T = 0. This equation is seen to contain a source term which is shown in Section IIIC to be non-vanishing and follows from the non-invariance of the measure in a path integral description of the NQP dynamics under a phase transformation of the NQP eld operator. In Section IIIC we evaluate the variation of the measure to obtain an explicit expression for the linear m om entum source term. In Section IIID we show that the continuity equation is simply the acceleration equation for the super ow. The topological character of the vortex is seen to lead to a transfer of linear m om entum from the condensate to the vortex which corresponds to the non-dissipative force F $_{\rm nd}$. Our analysis shows that the result found for F $_{\rm nd}$ from tracking the momentum ows agrees exactly with the result of the Berry phase calculation. The contribution to F_{nd} rooted in the topology of the vortex and manifesting in the noninvariance of the measure is further seen to contribute the classical M agnus (lift) force to

F_{nd}.

The result of the last subsection is the separation of the 3+1 NQP dynam ics into a collection of independent 1+1 dynam ical subsystems to be referred to as \hat{q} -channels. This arises from the eikonal approximation made for the eigenstates of H_{BOG} near the Ferm i surface in terms of wavepackets with mean momentum $p_f\hat{q}$. By construction, both positive and negative energy eigenstates (viz. above and below the Ferm i surface) carry mean momentum $p_f\hat{q}$.

in agreem ent with our Berry phase calculation. It is clear from eqns. (66), (67) and (69) that the origin of this force is the vortex topology and that the M agnus force contribution to $F_{\rm nd}$ arises from the non-invariance of the path integral measure. Our result is also consistent with Ref. 2 which showed that the rst 3 terms on the RHS of eqn. (78) lead to a ux of

linear momentum in towards the vortex at the rate ($_{\rm s}$ h!=2)($_{\rm v_s}$ $_{\rm r_0}$) 2 which is exactly equal to the rate at which we not it appearing on the vortex. This topology driven ow of linear momentum from the 3+1 dimensional condensate onto the 1+1 dimensional vortex is a particular example of the Callen-Harvey mechanism of anomaly cancellation 24 (see below).

IV .D ISCUSSION

In this paper we have exam ined the non-dissipative force Fnd acting on a line vortex in a type- Π superconductor at T = 0. Our analysis throughout has been m icroscopic and is based on the dynamics inherent in the Bogoliubov equation. In the rst half of this paper we have veri ed and strengthened an earlier result of A o and T houless which argued that F nd contains a contribution from the Magnus (lift) force familiar from classical hydrodynamics and which they argued was a manifestation of a Berry phase induced in the many-body ground state by the vortex motion. We have been able to determ in the Berry phase induced in the true superconducting ground state and nd that the result of Ref. 5, which is based on an ansatz for the many-body ground state wavefunction, agrees with the exact result in the case of a neutral super uid. For a charged superconductor, gauge invariance requires an \earthbb{A}_0"-term to appear in the ground state Berry phase. This correction is seen however to not e ect the nal result for F nd. It is clear from our calculation that, in the case of a neutral super uid, the ground state Berry phase is ultim ately a consequence of the topology and axial sym m etry of the vortex. This requires the energy eigenfunctions to be eigenstates of the z-com ponent of the angular m om entum. Exam ination of the ansatz of Ref. 5 shows that it has captured this essential property of the true superconducting ground state, and as a consequence, their calculation produces the exact result in the case of a neutral super uid. A lthough our paper is clearly based on the BCS theory of superconductivity, the fact that the Berry phase is ultimately a consequence of the topology and axial symmetry of the vortex leads us to suspect that vortices in non-BCS type-II superconductors will likely induce Berry phases in their corresponding ground state. One would thus expect a similar M agnus force contribution to F_{nd} in non-BCS type-II superconductors as well. By deriving the action for the hydrodynam ic degrees of freedom of the superconducting condensate from the microscopic Bogoliubov dynamics we are able to see how the ground state Berry phase m anifests itself as a Wess-Zum ino term in this action 25. Variation of the hydrodynam ic action with respect to the vortex trajectory gives the non-dissipative force acting on the vortex. This variation also shows that the Wess-Zum ino term is responsible for producing the M agnus force contribution to F_{nd} . This calculation substantiates the discussion given by Ao and Thouless which again captures the essential issues involved. In the second part of this paper we have exam ined Fnd by exam ining microscopically the continuity equation for the condensate linear mom entum. We show that this equation leads to the acceleration equation for the super ow and by being careful to track the e ects of the vortex topology, are able to see that a ux of linearm om entum ows from the 3+1 dim ensional condensate onto the 1 + 1 dim ensional vortex where it appears at a rate equal to $(sh!=2)(v_s production v)$ (per unit length). The sink terms in the continuity equation for the condensate linearm om entum are seen to arise from the topology of the vortex. This topology related transfer of quantum num bers (in our case, linear m om entum) from a higher dim ensional system S_1 in which a lower dim ensional system S_2 is embedded is an example of the Callen-Harvey mechanism of anomaly cancellation²⁴. Specically, linear momentum is not conserved in either the condensate or the vortex, but is conserved in the combined system. In our case, the issue of anomaly cancellation simply describes the linear momentum transfers expected between the condensate-vortex subsystems. It should be stressed that our calculational procedure is able to keep track of the more subtle momentum transfers that are a consequence of the vortex topology. Both calculations yield the same result for the non-dissipative force and verify the presence of the M agnus force in F_{nd} which is seen to be a manifestation of the vortex topology.

It is straightforward to calculated the Berry phase for the many-body excited states. Positive energy NQP excitations are created with $\frac{y}{n}$ and positive energy NQP excitations

We see that a 2-uid picture naturally develops in the Berry phase in which the contribution from the superconducting condensate is given by the ground state Berry phase obtained in Section II together with a contribution exc from the elementary excitations present. Because the Berry phase gives the orbital angular momentum along the vortex axis present in the energy eigenstates, we see that the total orbital angularm om entum (along the vortex axis) in an excited state receives contributions from the condensate and the elementary excitations. From eqn. (8) we see that the orbital angular momentum associated with the elementary excitations is opposite to that of the condensate so that the orbital angular mom entum of the excited states is less than the orbital angular momentum in the ground state (viz. $_{\rm M~B}$ <). Because experiments are done at $\,$ nite temperature, it is clearly of interest to generalize our T = 0 analysis of $F_{\rm nd}$ to $\,$ nite temperature. An important question is the e ect of tem perature on the Berry phase contribution to the hydrodynam ic free energy, and, consequently, of the e ect of tem perature on the M agnus force contribution to F_{nd} . Naively, one would expect this would lead to a therm alaverage of the Berry phase given in eqn. (80). As we have just seen, $_{\rm M~B}$ < so that a therm alaverage of $_{\rm M~B}$ is expected to decrease with increasing tem perature. Thus one would naively expect the M agnus force contribution to F_{nd} to correspondingly decrease with temperature. We should also mention that since depends on the superconducting electron density which decreases and eventually goes to zero with increasing temperature, whereas exc increases with increasing temperature, it becomes clear that the thermal average of $_{\rm MB}$ should change sign as a function of tem perature. Because of the anticipated connection between the thermal average of $_{
m M\ B}$ and the M agnus force contribution to F_{nd}, such a sign change will lead to a sign change \hat{z} , and in the Magnus force contribution to F_{nd} . Thus $F_{nd} = (sh! = 2)(v_s)$ (T) \underline{r}_0)

(T) changes sign with temperature. Such a temperature dependence for (T) will act, in general, to change the sign of the Hall angle in a Hall e ect experiment on a type-II superconductor in the ux ow regime 26. Such a sign change in the Hallangle as a function of temperature has been observed²⁷ and the fact that neither the BS or NV models can explain this sign change is the reason for this e ect being known as the \sign anomaly in the Halle ect" in superconductors. Further work on the temperature dependence of the Berry phase contribution to F_{nd} is in progress and is clearly of interest to e orts aim ed at understanding the sign anomaly in the Halle ect. We will report on this work elsewhere. Volovik²⁸ has argued that, for temperatures satisfying k_BT broadening of single particle states bound to the vortex will lead to creation of excitations trapped on the vortex as a consequence of spectral ow and that this mechanism e ectively w ipes out the M agnus force contribution to F_{nd} which has been found to be present at T = 0. A lthough Volovik's analysis is dierent from ours, it is clear that at these temperatures, the im portant excitations for a therm alaverage of $_{\rm M\ B}$ will come from excitations bound to the vortex so that the remarks above regarding a weakening of the Magnus force contribution to F_{nd} are qualitatively in agreement with Volovik's result. It should be mentioned that Volovik does not discuss the possibility of the M agnus force contribution to F nd changing sign with tem perature, nor of its possible consequences for Halle ect experiments on type-II superconductors in the ux ow regime. A o et. al. 29 have described a nite temperature calculation of the non-dissipative force and argue that the T = 0 form of this force is preserved for T 6 0 and that the only e ect of tem perature is to replace the zero tem perature superconducting electron density with its nite temperature form.

APPENDIX A: THE ADIABATIC THEOREM AND BERRY'S PHASE

In this appendix we provide a derivation of the Adiabatic Theorem being careful not to overbook the appearance of the geometric/topological phase discovered by Berry¹⁰. Our analysis focuses on the appearance of the Berry phase in the propogator (viz. time development operator) for the wavefunctions as this is the relevant object for our analysis in Section II. For a standard treatment of the Adiabatic Theorem along these lines (minus the Berry phase), see Messiah³⁰.

As in our discussion of Section II, we consider a quantum system coupled to an environment which is evolving adiabatically. The derivation of the Berry phase given above assumes an electrically neutral system. For a system composed of electrically charged particles such as the electron gas in a superconductor, the Berry phase must be generalized in a manner consistent with the gauge symmetry underlying electrom agnetism. This is because the hydrodynamic action $S_{\rm hyd}$ must be gauge invariant, and the Berry phase induced in the superconducting ground state indicates where $S_{\rm hyd}$ (as seen in Section IIC). The appropriate generalization has been given by Aharanov and Anadan¹¹. We will simply quote their result as the correct form can be guessed straightforwardly from knowledge of how the Berry phase transforms under a time dependent gauge transform ation,

Here K_0 and v_s are defined as in Section IIIA (=); and G^1 $G_1^1 + G_{s1}^1 + G_{s2}^1$ contains 3 contributions which are gauge invariant and are (respectively) rst order in time

derivatives of the gap phase, rst order in space derivatives (of the gap phase), and second order in space derivatives. Putting these results together gives

We stress that the calculation of the Wess-Zum ino term given in this Appendix is independent of the Berry phase calculation given in Section IIC and thus acts to con m its result, which is that $S_{\rm hyd}$ contains a gauge invariant term m rst order in time derivatives of the gap phase. The occurrence of this term in S appears to have been overlooked in Ref. 18.
