PolymerCollapse on Fluctuating Random Surfaces

Abstract

The conform ations of interacting linear polymers on a dynamical planar random lattice are studied using a random two-matrix model. An exact expression for the partition function of self-avoiding chains subject to attractive contact interactions of relative strength 1=c, 0 < c < 1, is found as a function of chain length L and c. The number of con gurations L^ae^{bL} as L_p! 1 is determined, showing that a chain undergoes a third-order collapse transition at $c = \frac{2}{2}$ 1; the universal scaling laws are found.

1 Introduction

A long polystymene chain m olecule in a solvent undergoes a coil(to(globule transition [1] at a nite tem perature T = due to attractive polym er(polym er interactions. M any approxim ate theoretical techniques have been developed to describe this and other processes of m acromolecular folding [2]. In this letter exact results for this problem of polym ers, m odeled by self-avoiding chains with contact interactions, will be given on the ensemble of two-dim ensional sim plicial lattices with random uctuations of the local intrinsic curvature which appear in the study of two-dim ensional quantum gravity [3, 4]. This ensemble represents an annealed average over a certain class of fractals. The advantage is that statistical mechanics problem s are offen exactly solvable in this case using random matrix models [4], which yield expressions for the therm odynam ic and som e of the geom etrical quantities of interest. M oreover it is intuitively plausible, and found to be the case in all of the many solved examples, that the phase structure of such statistical systems is is the sam e as on a xed lattice but with weaker transitions when one averages over uctuating lattices. A lthough a simple structureless polym erw ill be studied here, the sam e techniques could be extended to more complicated polym ers types.

A two-dimensional simplicial lattice is obtained by gluing, pairwise along edges, A squares each of edge length , so as to form a surface with spherical topology say. A polymer chain of L links walks isotropically on the edges of squares, cannot cross itself (excluded volume), but can occupy a given edge any number of times (gure 1); the latter represent contacts. The partition function is a sum over all possible simplicial lattices and con gurations of a polymer on such lattices with a weight for contacts. The temperature is found exactly in this model and represents a third-order collapse transition. One is therefore led to predict that on a xed two-dimensional lattice (e.g. honeycomb), with the rules of contact given in Fig.1, the transition will be rst or second order.¹ The universal exponent a, de ned by the number of congurations as L ! 1, $L^{a}e^{bL}$, changes from a = 5=2 at T > to a = 3=2 at

¹Som e previous exact results [5] on xed lattices have used a di erent de nition of contact, forbidding entirely con gurations a' and b' of Figure 1; a contact occurs when two non-adjacent parts of the polymer com e within one lattice spacing. This could make a di erence in the collapsed regime since the polymer can be much more com pact if multiple occupation of an edge is allowed (type a' in Figure 1). Such multiple occupation necessarily occurs, for example, in the high-tem perature expansion of the lattice 0 (n) model with action S \mathfrak{S}

T = .For T < it was not possible to determ ine a. The universal behaviour around <math>T = is described in terms of a reduced temperature T L¹⁼⁶.

2 Matrix Model.

The self-avoiding walk on uctuating random surfaces was described using a one-m atrix m odel by D uplantier and K ostov [6]. In order to include an attractive interaction whenever contacts occur consider a two-m atrix m odel with herm itian N xN m atrices and ,

As usual, the Feynm an diagram representation of the expansion in g generates graphs dual to simplicial lattices and as N ! 1 those of genus zero dominate. is a chemical potential conjugate to the number of polymers n, each of length L, ie the surfaces are built from ⁴ vertices dual to squares while the polymers from matrices. The last term in in the action TrV (;) represents a hole of length 2L in the surface with one point on the boundary marked; one can visualize the polymerby sew ing up the hole starting at them arked point. Each possible hole and each possible location of the marked point give a di erent polymer con guration. The polymer is connected into the surfaces by so that c represents a polymer-lattice Boltzm ann weight, while the polymer-polymer (contact) weight ² has been normalised to one. Thus 0 < c < 1 sets the tem perature scale, with c = 1 being in nite tem perature.

where the sum is over genus zero surfaces and H is the number of con gurations with n polymers, each of length L with w polymer-contacts, on all surfaces of area A. Since H grows as $const^{A}$ there exists a critical $g = g_{c}$ at which large area surfaces become signi cant and a universal continuum limit can be established [4].

The matrix model (1) can be solved in the large N limit by the method of orthogonal polynomials [7]. The polynomials $P_i() = i + jQ = j + are such that$

one can nd a closed set of equations for $r_i s_i q_i t_i$ and f which can be solved for f. In the large N lim it one can de ne a continuous variable x = i=N and functions $f_i = N f(x); r_i = N r(x);$ etc. and these equations are explicitly:

Substituting eqs. (7) and (8) into eq. (10) gives an equation (the 'string equation' in quantum gravity) for f. will be evaluated shortly for large N.

The critical point for continuum surfaces is idential ed by setting = 0 (no polymers) and noting the singularity in the solution for f (1) of the quadratic equation (10) as g is varied, yielding $g_c = \frac{1}{12}$ and $f_c = 2c=(1 \ c^2)$. Dening $g = g_c (1 \ ^2)$, where is the lattice spacing, is the renormalised 2D bosm obgical constant' conjugate to renormalised surface area $A = A^2$. In the limit ! 0, couples to universal continuum surfaces (A nite) and surfaces nite in lattice units (A = 0). The partition function will have a part regular in , usually representing the latter surfaces, and a non-analytic part representing the form er. 3 PolymerCollapse.

First the case of a single polymer will be addressed, when eq.(12) is appropriate and one studies the expectation value of Tr(2L) in this theory, i.e. Z expanded to rst order in , $Z = Z_0 + Z_1 + ,$

where $G / L^a e^{b(c)L}$. D expite m any attempts the author has not m anaged to derive the asymptotic form (16) for all c. It is generally expected how ever that the number of con gurations has the form of G as L ! 1, which num erical evaluation of (15) con rm s. Figure 2 plots (c) obtained from

for large but nite L | corrections to the right hand side above are 0 ().

 $G = \lim_{L \to 1} Z_1^0(L;c;0)$ is a kind of wavefunction renorm alisation which represents the e ects of surfaces of zero renorm alised area, A O(2); it does not depend upon u or 0 on the other hand u represents an induced free energy per unit length of the polymer due to uctuations of the nite A surfaces; it is non-analytic in from eq.(12). The behaviour of (c) thus governs the interesting geometrical properties of the polymer. In particular, g_2 seem s to show a transition to (c) = 0 at c = 0.4, which will be verified shortly. Physically, as c is reduced the polymer favours polymer-polymer rather than polymer-solvent bonds and so the induced free energy falls. Below a certain $c_c = 0.4$ the polymer collapses entirely and is only connected into the surface by a small number of polymer-solvent bonds. This is the coil-to-globule transition on uctuating random surfaces. The polymer-polymer contacts also induce free energy per unit length but at a lower order in , and it will be necessary to choose a di erent scaling law for L in order to see this contribution near $c = c_c$.

In order to $nd c_c$ exactly, determ ine the universal exponent a, and the details of the phase transition, it is useful to rew rite Z_1^0 as

As the continuum limit is approached it is expedient to rescale $p \cdot p^d$ for some exponent d. Expanding in one has

Consider rst the high temperature $c ! 1 \lim it.$ It is known from the c = 1 solution [6] that d = 1=2, so this ansatz will be used in the high temperature (coil) phase. Writing c = 1 for small , the coe cients a_i can be found as power series' in ; in particular $a_2 = 0$ () and one nds from (18)

the answer of Fig. 2. The partition function itself is then

using eq.(12). Large area A ! 1 corresponds to ! 0, in which case the universal power exponent is a = 5=2. If c is reduced by a nite amount from one, a_2 is nite and the resultant oscillatory behaviour means that is no longer possible to neglect the higher orders in p as ! 0. Nevertheless one expects the form (21) to persist down to $c = c_1$.

Fortunately there is one other value of c where a_2 vanishes, given by $c = \frac{p}{2}$ 1; a_3 also vanishes at this point indicating that this is the collapse temperature. A non-trivial scaling solution is obtained with the scaling laws $c = \frac{p}{2}$ 1+ $^{1=3}$, $L = l = ^2$, and d = 1 (note that polym er length scales as area now). In this case one derives from (18)

At $= 0, Z_1$, while now analytic in , in this case seems to represent nite A surfaces. A = 0 surfaces $| A = 0 (^2)$ more precisely $| are characterised by the fact that a nite number of derivatives with respect to can remove their contribution, since each derivative brings down a factor of A. But <math>Z_1$ (= 0 cannot be removed by di erentiating. It can be interpreted as a surface dense with polymer whose area is proportional to the polymer length; for sm all 1 di erentiating does remove its contribution. It is tempting to extrapolate into the collapsed phase ! 1 also, but the above scaling laws do not seem to be consistent since Z_1 becomes a saddle point integral with the result Z_1 (3 =1)exp(1). This cannot be correct because Z_1 should be monotonically decreasing with .

If polymers are present with fugacity one must go back to eq.(12) and modify it accordingly. From eq.(8) and eq.(10) one has

In order that the new terms contribute to the scaling part of the equation, but do not disturb the critical condition for continuum surfaces, $g_c = \frac{1}{12}$ to leading order in , one must tune

The wavefunction renormalisation G of Z₁ has been absorbed in and a renormalised fugacity dened, of dimension ⁵⁼². When 60 the singularity at $g = q_c$ (=0) is now shifted by an O (²) term, = c say, which therefore couples to renormalised area A. c represents the free energy of the polymer system per unit A on nite surfaces. The positive root of eq.(24) is the correct one since u ! + p + z as ! 0. A singularity in u appears when $2u = {}^{2}1^{3=2}e^{1u}$. Then u() is singular at = c. Finally, it would be interesting to study the possibility of inter-polymer aggregation in the low temperature phase.
