## Bosonization on the lattice: the emergence of the higher

harm on ics

## Abstract

A general and transparent procedure to bosonize ferm ions placed on a lattice is presented. Harmonics higher than  $k_F$  in the one-particle G reen function are shown to appear due to the compact character of real electron bands. Quantitative estimations of the role of higher harmonics are made possible by this bosonization technique. 71.27+ a, 71.28+ d, 73.20 D x

B osonization m ethods have provided us with a thorough understanding of the physics of 1+1 dimensional model systems in several branches of Theoretical Physics as, for example, C ondensed M atter<sup>1,2</sup>. The earliest implementation of such techniques dates back to the sixties, when Luttinger<sup>3</sup> proposed his model, which was subsequently solved partially by M attis and Lieb<sup>4</sup>. Ten years later, Luther and Peschel, and M attis<sup>5,6</sup> m ade the picture more concrete by combining their rened version of bosonization with known results for some m odels previously solved by Bethe ansatz. Soon afferwards, and independently, a similar boson-ferm ion equivalence was also obtained by C olem an<sup>7</sup> in the context of the Sine-G ordon m odel. Perhaps the most pictorial representation of a ferm ion in terms of bosons has been given by M andelstam<sup>8</sup>. A coording to it, ferm ions should be understood in a purely bosonic theory as soliton operators interpolating between di erent particle vacua. R eciprocally, the generic behavior of electron liquids in 1+1 dimensions is such that all the excitations of the Ferm i sea can be classi ed into a set of boson operators.

The paradigm of a theory which can be solved by means of bosonization is the Luttinger model. This is a one dimensional model, in which electrons interact only through density operators of denite chirality. The total H am iltonian can be expressed as a quadratic form of two boson elds with opposite chiralities, and this fact renders the model completely integrable. There are, however, some assumptions in the Luttinger model which make of it an approximate description of the physics of real electrons. The most important of them are made by considering a perfect linear dispersion relation for the original electrons, and by supposing that the two branches (corresponding to the two diment Ferm ipoints) can be articially extended ad in nitum in both directions (see g. 1(a)). Obviously, the in nite collection of states deep inside the Ferm isea is not present at all in a real physical situation, and the hypothesis that they do not modify the essential properties learned from Luttinger's model becomes crucial.

Let us explain with more detail som e of the complications which appear in real condensed matter systems and which blur the sharp picture brought about by the bosonization of the Luttingermodel. First, the dispersion relation for one species of free non-relativistic fermions

is simply a parabola, (p) =  $p^2 = 2m$ , which is bounded from below, but not from above (g. 1(b)). Second, when these form erly free electrons are placed in a lattice and interact with the periodic substrate potential of the atom s, the dispersion relation becomes also bounded from above, and peaks, in the simplest case, at the Bragg point so that we are left with a compact band of width D (see g. 1(c)). The aforem entioned phenom ena bear two related e ects. One is the appearance, due to the compact character of the band, of chirality breaking processes, which m is both branches. This is tantam ount to say that one can not divide the physical electron eld operator into right and left m oving pieces unam biguously. The other e ect is the curvature of the band. We argue that in most cases the rst e ect is the most relevant one because it is the source of the appearance of higher harmonics in electron correlation functions, while the second one gives rise to harm less renorm alizations of the parameters. In the case of the electron G reen function, for instance, together with the naive frequencies  $k_F$  one expects higher modulations at  $3k_F$ ,  $5k_F$ , etc:

An underlying assumption of the bosonization technique is that only long wavelength uctuations of the density of particles a ect the physics of the problem. One is therefore allowed to average all magnitudes over distances much larger than the average distance among particles,  $r_s$  '  $1=k_F$  | in particular, the commutation relations and expectation values of density operators. We proceed now to describe qualitatively the elects of a nite density of electrons on the accuracy of the mapping of electrons to bosons.

For interm ediate densities, when k is placed approximately in the middle of the band, its curvature is very small and we can linearize it around the Ferm i points with a high degree of accuracy. On the other hand, chirality-breaking processes have high energy and can be disregarded as a rst approximation.

At low densities,  $k_{\rm F}$  is close to the bottom of the band. In this case, the discrete character of the particles is in portant, because the length scale set by  $r_{\rm s}$  is large. One

should add that the processes which break the chirality have low energies and need to be taken into account. They show up in the form of higher harm onics in the electron correlation functions.

At high densities the Ferm i wave-vector is close to the top of the band, and due to particle-hole symmetry the qualitative discussion in the former item applies.

The issue of the energence of higher ham onics is not new, and has been considered before mainly in connection with the e ects of the curvature of the dispersion relation. A quite original point of view, due to Haldane<sup>9</sup>, rephrases the problem as the incorporation of the discrete nature of the particles into the bosonization program. In either case, it becomes clear that the boson-ferm ion transcription valid within the Luttinger model should be corrected to take into account more realistic dispersion relations. In particular, if we consider a compact dispersion relation and give up the perfect division between left and right movers of the Luttinger model, hybridization e ects between the two chiral elds will appear giving rise to higher ham onic modulations in the electron correlation functions. Up to date, though, there has been no attempt to understand what is technically the source of such hybridization and, thereafter, to propose a system atic way of correcting the original boson expression of the ferm ion operator.

The purpose of the present paper is to incorporate the compact character of the band |i.e. the chirality-breaking processes | into the bosonization technique in a non-perturbative, and essentially exact, way. Our goal is to set up a scheme that perm its to study quantitatively the role of higher harmonics. These might be relevant for the physical behavior of some experimental devices, e.g.: quantum wires<sup>10;11</sup>. It is our belief that our procedure places bosonization in the doorway of quantitative computations of response functions of onedimensional systems in Condensed M atter.

We begin with a rem inder of the main lines of the simple bosonization program, where the assumption of an in nite linear dispersion relation of the two electron branches becomes essential. In the Luttinger model the electronic spectrum of the \free" Ham iltonian is that

represented in g.1(a). There are two types of ferm ion modes, say  $a_k; a_k^+$  and  $b_k; b_k^+$ , for the respective right and left branches of the spectrum. It is well-known that the only excitations supported by the Ferm i sea of g.1(a) are density uctuations of the form

There are obviously other uctuation processes in which electrons are transferred from one branch to the other, but in the Luttinger model they amount to the introduction of a conserved quantum number J. The important point is that the above currents satisfy the commutation relations

where L is the length of the dimension in which the electrons are con ned. The linear dependence of the commutators (4) can be rigorously proved under the hypothesis of an in nite linear dispersion relation as shown in g.1(a). It allows us to de ne boson creation and annihilation operators

These oscillators can in turn be assembled into two chiral boson elds

Here  $N_R$  and  $N_L$  are the normal ordered charges for the respective channels. This boson codi cation of the electron excitations is only half of the boson-ferm ion equivalence. It can also be shown that the ferm ion eld may be expressed in terms of the above boson elds. In particular, a correct representation for the two ferm ion chiralities is

These are the expressions for the soliton (ferm ion) annihilation operators found by M andelstam. They have the virtue of satisfying the equal-time canonical anticom mutation relations of ferm ion operators. Finally and more important, the representation (8) reproduces the form of the ferm ion correlators

At this point we undertake the analysis of how this program has to be modi ed when a more realistic, compact dispersion relation is considered in the description of the electronic system. Electrons usually feel the background periodic potential of the atom ic lattice. This substrate potential changes their parabolic dispersion relation into a band (gs. 1 (b) and 1 (c)). D expite the fact that in such case no natural distinction between right and left modes can be made, we want to keep the separation into two di erent branches for computational purposes. In fact, even in the case of a compact spectrum of the kind shown in g. 1 (c) the static electron correlator still shows two di erent modulations corresponding to the left and right branches. Suppose, for instance, that we write the mode expansion for the ferm ion

This is exactly the same expression that one obtains for the static correlator in the Luttinger model. However, as we are going to see, the bounded character of the spectrum of boson excitations requires appropriate modi cations in the intermediate steps which lead to (12) within the bosonization approach.

It is worthwhile to remark that the particular energy values of the electron modes are irrelevant for the purpose of computing the static correlators. The only important point is that the Ferm i sea comprises now a connected set of states from  $k = k_F$  to  $k = k_F$ . Given that we do not have an in nite dispersion relation anymore, we would like to write tentatively the set of chiral currents

The rst exercise in order to test the bosonization procedure is to check the linear dependence of the commutator of currents with like chirality:

It is important to realize that in these sums all the subindices run from 0 to . For this reason, one can see that for su ciently small values of k the rst sum in (14) has L=(2)

tim es k m ore contributions than the other. This agrees with the linear dependence in (4). However, in the case of a band less than half-lled, when  $k > k_F$  there are not enough excitations of the Ferm i sea and the commutator remains equal to  $L=(2)k_F$ , up to a value of  $k = k_F$ . From that value it begins to decrease linearly and reaches 0 at k = . This picture is valid, as we have said, for values of  $k_F$  between 0 and =2. When the band is more than half-lled we get a similar form of the commutator but with linear growing up to

 $k_{\text{F}}$  and later linear decrease from  $k_{\text{F}}$  to  $% k_{\text{F}}$  .

W e m ay pause at this point and think of the physical reasons for this deviation of the commutator from a perfect linear dependence. They can indeed be found by looking at the very essence of the commutation performed above. As a matter of fact, the value of the commutator is a measure of the number of available one-particle excitations over the Ferm i sea. In the case of a band less than half-lled, for instance, it is clear that for small values of momentum transferk there is no problem in exciting L=(2) k electrons from below the Ferm i level to states above it. When  $k > k_F$ , though, we cannot continue pulling out right modes once we reach the bottom of the band and the number of available excitations is less than L=(2) k. This argument explains also why the actual number remains constant and equal to L=(2) k<sub>F</sub>, up to a momentum transfer  $k_F$ .

However, this clear interpretation of the functional dependence of the commutator also shows that the present picture is physically incorrect. In fact, it is only our articlal division between right and left modes what has prevented us from considering another set of adm issible one-particle excitations for  $k > k_F$ . These correspond to the transfer of electrons below the Ferm i level in the range [ $k_F$ ;0] to states above the Ferm i level in the right branch. O bviously, there is no reason for not considering these excitations on the same footing than those taken into account before within the same branch. Bearing this in mind, it seems m ore natural the de nition of the currents

It is clear that the correct counting of excitations leads to a situation in which form on entum transfer  $k = 2k_F$  the number of them equals the maximum value  $L = (2 \ ) 2k_F$ , including the extrem e process in which an electron slightly below the Ferm i level is transferred above it at the other Ferm i point. This value  $L = (2 \ ) 2k_F$  is also the cuto for the commutator. The correct physical picture says, then, that the commutator should be a linear function growing up to  $L = (2 \ ) 2k_F$  at  $k = 2k_F$ , remaining constant until  $k = 2k_F$  and then linearly decreasing to 0 at k = .

The most important e ect of the lattice is, therefore, to replace the commutators in (4) by a bounded function in the interval [0; ], which we will call L=(2) f (k), i.e.:

f (k) is depicted in gure 2. This in turn modi es the properties of the bosons that one can build from the currents (15). The correct de nition of boson creation and annihilation operators should be now

in order to preserve the canonical commutation relations (6). We want to maintain at this point the relation that exists in the Luttinger model between the elds  $_{L}(x)$ ;  $_{R}(x)$  and

with the only di erence that now r is the lattice derivative. The two boson elds

are chiral, in the sense that  $_{R}$  (x), for instance, creates excitations in the forward direction and destroys them in the backward direction. Their properties, though, are non-standard, since they account in their structure for the niteness of the num ber of modes of the lattice. O ver very large distances, we should expect from them the same behavior found in the Luttinger model. This is guaranteed by the fact that the function f (k) is linear in k for small values of the argument. O ver smaller distances, though, we start to feel the e ects of the discreteness of the num ber of particles.

The above considerations are exemplied by the computation of the correlator

W e aremainly interested in the behavior of the correlator at large values of x. The evaluation of I in this regime still appears to be unfeasible, but in the limit of small  $k_F$  (compared to ) we may consider the elects of the integration over large values of k as irrelevant. We can then approximate I by

At small values of  $k_F$  = the in uence of the cuto can be disregarded and we get the asymptotic expansion for the correlator

The rst term corresponds to the right-handed piece of the electron propagator (12), while the rest are contributions which arise from the structure of the boson eld operators over distances corresponding to the mean separation among particles.

The main conclusion which follows from the evaluation of (20) is that the boson representation (8) of the two ferm ion chiralities cannot be correct, since it produces spurious contributions to the electron propagator as shown in (24). We stress again the fact that the electron propagator is given in any event by the expression (12). It suggests that the left-right chiral decomposition is still at work in the free theory of g. 1 (c), showing no other harm onics than those at  $k_F$  and  $k_F$ . The structure of the higher order contributions in (24), in particular the modulation at  $2k_F$ , shows that the boson representation (8) can be conveniently corrected in order to cancel out spurious terms in the ferm ion propagator. A ctually, it is not a coincidence that the subdom inant order in (24) is just the opposite of the dom inant contribution from

it is not di cult to see that the use of (26) and (27) reproduces the correct expression of the electron propagator (12), provided that  $c_1 = C^{-1}$ . The form of the corrections in (26) and (27) coincides with what has been advocated by other authors<sup>9</sup>. Here, we have accomplished a quantitative derivation of them, precise enough to determ ine the coe cients of the series within a given model. Our argumentation also claries conceptually that it is the bosonization method what introduces the higher harmonic contributions, as in (26) and (27), though in some instances | like that of the free electron system | the only modulations in the electron propagator are at  $k_F$  and  $k_F$ .

We follow at this point the standard bosonization procedure, by which the boson representation of the ferm ion operators remains unchanged after switching the interaction. Thus, we are in the position to make explicit statements regarding the structure of the electron propagator in the interacting theory. In general there are couplings in the interacting ham iltonian which mix explicitly the two chiral parts of the electron eld. This mixing has to be considered alongside with the underlying chiral mixing already present in the boson representation. The interplay between them gives rise, in addition to the standard  $k_F$  m odulation, to  $3k_F$  and higher order m odulation terms in the electron propagator, as we are going to see in what follows. It is worth to mention that the signal of the  $3k_F$  m odulation has been observed numerically by 0 gata and Shiba<sup>12</sup> in the strong coupling lim it of the one-dimensional Hubbard m odel.

Let us take, for the sake of simplicity, a simple g-ology model consisting of forward scattering terms of  $g_2$  and  $g_4$  type<sup>1</sup>

As is well-known, in the boson representation this ham iltonian is diagonalized by the canonical transformation

By in plementing this transform ation to free boson elds in the computation of the fermion propagator we get

 $d_1$ ,  $d_2$  and  $d_3$  are known constants whose explicit value is not relevant for the purpose of the current discussion. The important issue here is that the  $2k_F$  oscillation, which translates into a  $3k_F$  oscillation of the electron propagator, does not cancel out anym ore. Only when  $\sinh = 0$  (free case) the cancellation takes place. As we advanced previously, the higher harm onic oscillations show up explicitly in the interacting ferm ion propagator. In the long distance  $\lim it$  and for > 0, of the two terms in the last line of (32) the second one is actually the most relevant as its exponent turns out to be smaller than that of the rst.

To summarize, we have found in this paper that the natural way to understand the emergence of higher harmonics in non-standard bosonization formulas is the consideration of a compact dispersion relation for the fermions in one dimension. As a paradigm of this situation we have taken an electron system on the lattice. In our approach, we have obtained the higher harmonics within a purely kinematical framework. In this fashion we have followed the standard bosonization procedure where the boson representation is rst proposed for the free theory and, subsequently, the interacting theory is solved without changing the bosonization prescription.

As it is apparent from (26) and (27), our bosonization formulas are quantitative in the sense that we obtain explicit values for the amplitudes associated to higher harm onic term s. The extension of the present work to more complicated interacting ferm ion systems and to ferm ions with spin is currently under study.
