# P hase D iagram sfor D eform able Toroidal and Spherical Surfaces w ith Intrinsic O rientational O rder

#### Abstract

A theoretical study of toroidal m em branes $w$ th various degrees of intrinsic orientational order is presented at m ean- eld level. T he study uses a sim ple G inzburg-Landau style free energy functional, which gives rise to a ridh variety of physics and reveals som e unusual ordered states. The system is found to exhibit $m$ any di erent phases $w$ ith continuous and rst order phase transitions, and phenom ena including spontaneous sym m etry breaking, ground states $w$ th nodes and the form ation ofvortex-antivortex quartets. T ransitions betw een toroidal phases w ith di erent con gurations of the order param eter and di erent aspect ratios are plotted as functions of the therm odynam ic param eters. $R$ egions of the phase diagram $s$ in $w$ hich spherical vesicles form are also shown.


## I. IN TRODUCTION

The bilayer uid $m$ embranes, which can form spontaneously when molecules with hydrophobic and hydrophilic parts are introduced to water, are a popular topic of research. In theoretical studies of such $m$ em branes, it is usual to work on length scales m uch larger than the $m$ olecular size, so that they can be considered as continuous surfaces; tw o-dim ensional curved spaces em bedded in Euclidean three-space. Features com $m$ only inconporated into $m$ athem aticalm odels of $m$ em branes include bending rigidity (disa nity for extrinsic curvature), Gaussian curvature modulus g (disa nity for intrinsic curvature), spontaneous curvature due to $m$ em brane asym $m$ etries, and for closed surfaces, constraints of constant volum e, constant area and constant di erence in area betw een the inner and outer layers. In recent years, interest has grow $n$ in $m$ em branes whose $m$ olecules have orientational order w ithin the surface. For instance, a sm ectic-A liquid crystalm em brane, whosem olecules have aliphatic tails which point in an average direction norm al to the local tangent plane of the $m$ em brane, can undergo a continuous phase transition to sm ectic-C phase, in which the tails tilt. T he tilt is described by a two-com ponent vector order param eter w ithin the surface, given by the local therm al average of vectors parallel to the tails, pro jected onto to local tangent plane. Ifsuch a m em brane has intrinsic (G aussian) curvature, its orientationalorder is frustrated, since a parallel vector eld cannot exist in a curved space. O rdering is further frustrated on a closed surface of spherical topology (genus zero), as an intrinsic vector eld $m$ ust have topological defects whose indices sum to the Euler num ber of the surface; in this case, two. ie. there must be at least tw o vortioes in the order param eter eld on a sphere. $T$ he order param eter eld vanishes at these defects to avoid in nite gradients. The defects are energetically costly but topologically unavoidable. The energetics of a sm ectic-C , genus zero m em brane were studied by M acK intosh and Lubensky in [7]. There are other types of orientational order. N em atic order is sim ilar to vector order except that its order param eter is locally invariant under rotations through $180^{\circ}$. Hence nem atics can form defects of index $\frac{1}{2}$. H exatic order is locally invariant under rotations through $60^{\circ}$, as this is the molecular
bond' angle. The notion $m$ ay be generalized to uid phases $w$ ith n-atic orientationalorder being locally invariant under rotations through $\frac{2}{n}$ and form ing defects of index $\frac{1}{n}$. If a vector ( $m$ onatic') is represented by an arrow then we $m$ ay picture an $n$-atic as an $n$-headed arrow or an $n$-spoked wheel. In this paper, theoretical ndings on $n$-atic uid $m$ em branes of toroidal topology are presented. As the torus has genus one and Euler num ber zero, it is possible to arrange an intrinsic vector eld on a torus w ithout topological defects. (ie. furry tori can be brushed sm ooth.) Therefore it appears plausible that $n$-atic $m$ em branes $w$ ith large order param eter coupling com pared with bending rigidity m ay energetically favour a toroidal topology to a spherical one. The object of em barking on this research was to con m or refute this hypothesis. A s w illbe dem onstrated, it tums out to be true, although the arrangem ents of ordering in the toroidal surface are far $m$ ore diverse than expected.

Throughout this paper, a num ber of approxim ations are used. O ne approxim ation is the use ofm ean eld theory. That is, no them al uctuations are considered. So the con guration adopted by the system is assum ed to be that which $m$ inim izes its free energy. A lso, the low est Landau level approxim ation is em ployed in constructing the order param eter eld, as discussed in section VI. The validity of these approxim ations is investigated in section X. Both of these approxim ations give rise to apparent phase transitions betw een separate, clearly de ned states of the system, som e of which $m$ ay in fact be blurred by therm al uctuations and higher Landau levels, to the point where they disappear. It should therefore be understood that, where reference is $m$ ade to phase transitions, it is in the context of $m$ ean eld theory and the low est Landau level approxim ation. Before studying the them al physics, it will be necessary to introduce som e tensor caloulus. This is needed to describe the behaviour of an $n$-atic eld living within a two-dim ensional curved space, as well as the intrinsic and extrinsic elastic properties of the space (ie. the $m$ em brane) itself. In the absenœ of intrinsic ordering (ie. under the in uence of the $m$ em brane's elasticity alone), one $m$ ight expect the equilibrium shape of a toroidal vesicle to be axisym $m$ etric. H ow ever, such
a vesicle is only neutrally stable $w$ th respect to one particular $m$ ode of non－axisym $m$ etric deform ation．This $G$ oldstone $m$ ode is discussed in section $V$ ，in which a further approxim a－ tion is introduced，lim iting the range of vesicle shapes to be explored．In the sections that follow，the ground－state con gurations and energies of the order param eter eld are calcu－ lated for each of these shapes，sub ject to the low est Landau level approxim ation．A though som e of these shapes are never energetically favoured，the behaviour of the eld living on them is of interest，if only academ ic．Finally，in section $\mathbb{X}$ ，the total free energy（consisting of order－param eter eld and $m$ em brane elasticity parts）is $m$ inim ized $w$ ith respect to vesicle shape，to nd the equilibrium con guration of the system as a function of tem perature and the other them odynam ic param eters．The result is a set of phase diagram s for various values of $n$ ，which contain phases of vesicles $w$ ith di erent shapes and ordering．The shapes should be experim entally observable，although the intrinsic ordering is m ost likely not．

## II．VALUES OF N

$n$ is the order of rotational sym $m$ etry．A s stated earlier，the uid $m$ embrane is locally invariant under rotations through $\frac{2}{n}$ ，and the $n$－atic eld $m$ ay be represented by a set of n －spoked wheels tessellating．C learly $n$ is integer．Furthem ore，it $m$ ust be one of the set of num bers for which regular $n$－gons tessellate．That is，$n 2 f 1 ; 2 ; 3 ; 4 ; 6 \mathrm{~g}$ ．These are the values of $n$ which Park et．al．studied in［⿴囗⿱一一 ］．H ow ever，consider a triangular $(n=3)$ lattice $w$ ith long－range orientational，but no positional order；the $n=3$ analogue of a hexatic lattioe． Bonds between neighbouring $m$ olecules lie at angles which are integer $m$ ultiples of ${ }_{3}$ ．Its sym $m$ etry properties in the absence of positional order are therefore indistinguishable from its dual lattice，the hexatic，and it $w$ ill form defects of index $\frac{1}{6}$ ，in preference to the $m$ ore energetically expensive index $\frac{1}{3}$ defects．To convince oneself of this，it $m$ ight be helpful to attem pt to draw a lattioe which has $120^{\circ}$ rotational sym $m$ etry，but does not have $60^{\circ}$ rotational sym m etry．This is only possible if one keeps strict account of the positions of the lattice sites and polygons（ie．in the absence of dislocations）．The follow ing research is
therefore conducted forn $2 \mathrm{f} 1 ; 2 ; 4 ; 6 \mathrm{~g}$.

## III. N O TATIO N

The 2D curved surface is em bedded in Euclidean 3-space. If is a two-dim ensional coordinate of a point $P$ on the surface then $R()$ is the position vector of $P$ in the embedding space relative to som e origin. C oordinate-dependent unit basis vectors $\mathrm{e}_{\mathrm{a}}$, where a takes the values 1 and 2 to label the coordinates, are de ned in the directions of $@_{a} R$. A coordinate-invariant $m$ etric tensor is de ned on the $R$ iem annian 2-space, w ith com ponents $g_{a b}=@_{a} R$ b ${ }^{[R R}$, from which the area of the closed surface is calculated:

where $g$ detg. Indioes are raised and low ered by the $m$ etric and its inverse, $9^{26}$, in the standard $m$ anner. The extrinsic curvature tensor has com ponents $K a b=N \quad{ }_{a} \oiiint_{b} R$, where $N$ is a unit vector nom al to the surface. (N B.D ot products are evaluated in $R^{3}$.) Its trace, $K_{a}^{a}$, is the total curvature'. Readers $m$ ay be fam iliar $w$ ith the $m$ ean curvature which is half of this quantily. The intrinsic or $G$ aussian curvature is given by $K=\operatorname{det} \underline{\underline{K}}$.

As an example, the above quantities are calculated for a sphere of radius $R$, using spherical polar coordinates ( ; ). The $m$ etric tensor $m$ ay be represented by a m atrix:

A ny continuous, doubly differentiable surface has tw o principal radii of curvature, $R_{1}$ and $R_{2}$ at each point. These are the radii of curvature of the geodesics passing through that point which have respectively the greatest and least curvature as m easured in the E uclidean em bedding space. It can be shown []] that these two geodesics are alw ays perpendicular. If the particular coordinate
basis used corresponds to these tw o perpendicular directions, then the curvature tensor w ill be diagonal, and given by

O foourse, on a sphere, curvature is constant. Therefore $K_{a}^{b}=\frac{b}{R}$ where the sign convention denotes the direction of the nom al. H ow ever, it should be noted that, w ithout one index raised, the com ponents are not constant:
$C$ learly, on a sphere, $m$ ean curvature is $\frac{1}{R}$ and $G$ aussian curvature is $\frac{1}{R^{2}}$.
Recall that the intrinsic $n$-atic order in the system is orientational, not positional, and that it is locally invariant under rotations through $\frac{2}{n}$. A s this orientationalorder is intrinsic to a 2-dim ensionalspace, in can be represented by a com plex order param eter in the follow ing way. Let be the local angle betw een $e_{1}$ and the orientation of ordering. For vector order, this orientation is easily de ned. For instance, in a sm ectic-C membrane, it is the direction of a m olecule's aliphatic tail pro jected onto the local tangent plane of the $m$ em brane. H ow ever, in a nem atic liquid crystal, $m$ ay take one of tw $o$ values for each $m$ olecule, depending on which end of the m olecule one chooses to $m$ easure from. For our punposes, it does not $m$ atter which of these two values is assigned to at each point. For bond-angle orientationalorder, eg. hexatic, there is an n-fold am biguily in the de nition of but again, it does not $m$ atter which of the $n$ orientations is chosen. It is conventional in this case to de ne at a given $m$ olecule as the angle betw een the basis vector $e_{1}$ and the line joining that molecule to its nearest neighbour. H aving de ned , the order param eter is given by

where < > denotes a therm alaverage. N ote that has the appropriate rotational invariance, since a rotation of the orientation of ordering through an angle w ithin the surface is rep-
resented by a rotation of through $n$ in the A rgand plane. H ence rotating the orientation of ordering through $\frac{2}{n}$ corresponds an identity transform ation in the com plex plane.

## IV.THEMODEL

The model used is identical to that in [0]. There is zero spontaneous curvature as the bilayers considered are sym $m$ etric, and no constraint on bilayer area di erence. The vesicle's volum e is also unconstrained since sm all solvent $m$ olecules $m$ ay di use freely in and out, so long as the solvent is very pure; containing no free ions, which w ould lead to osm otic pressure. The membrane's area A is xed by the num ber of constituent molecules. The free energy functional

## V.THECURVATURE ENERGY TERMS

Above the continuous transition to the disordered phase, vanishes and only the last two term $s$ in the firee energy Eq. 4.1) survive. These constitute the $H$ elfrich $H$ am iltonian, describing the elastic energy of a constant area $m$ em brane.

The intrinsic curvature energy, being proportional to the integral of $G$ aussian curvature, is a topological invariant, according to the $G$ auss $B$ onnet form ula

where is the Euler num ber of the closed surface [4]. For an orientable surface, $=2(1 \mathrm{G})$, where $G$ is the surface's genus; ie. how many handles' it has. H ence the intrinsic curvature energy is zero for a torus and 4 G for a sphere.

where is a constant vector which param eterizes the conform altransform ation G]. A sphere has total curvature energy 8 and its shape is not changed by such a transform ation. T his is not true for tori. A $n$ axisym $m$ etric, circular cross section torus $m$ ay be deform ed by a conform al transform ation. A s a consequence of the circular cross-section, a com ponent of parallel to the sym $m$ etry axis serves only to change the torus's size. Hence there rem ains only a one-param eter fam ily of non-trivial conform al transform ations. W ith lying in the sym $m$ etry plane, the surface is deform ed into a non-axisym $m$ etric tonus such as the one in Fig. (1), and as increases in $m$ agnitude, the asym $m$ etry increases until, in the lim it, the torus becom es a perfect sphere with an in nitesim al handle.

The handle, although in nitesim al, m ust contain an intrinsic curvature energy of 4 G and nite total curvature energy. A circular, axisym m etric tonus of aspect ratio (ratio of radii of generating circles) has total curvature energy

whidn is a m inim um at $\quad=\frac{P}{2}$, the $C$ li ord tonus, and in nite at $=1$, where the tonus becom es self-intersecting. W illm ore con jectured 7] that C li ord's torus and its conform al transform ations have the absolute m inim um curvature energy of any surface of toroidal
topology; a conjecture that is di cult to prove, as the $m$ ost general toroidal surface cannot easily be param eterized: tori can even be knotted. A ccordingly, this paper will not explore the whole of phase space. The discussion w ill be restricted to axisym m etric, circular cross-section tori and their conform al transform ations, w ith the assum ption that these are close to the ground state shapes. To be consistent, the ground-state genus-zero shape is approxim ated by a sphere: the deviations from sphericity calculated in 目] are not included.
VI.THE LOW EST LANDAU LEVELAPPROXIMATION

$w$ here $p$ takes integer values from $n$ to $n$. These fiunctions form an altemative basis set to that used in 2] and are linear combinations of that set. They are given in [G] in a di erent gauge. The functions have 2 n zeros, which are topological defects of index $\frac{1}{n}$. The $(2 n+1)$-fold degeneracy re ects the freedom of the defects to lie anyw here on the surface at no energy cost to order ${ }^{2}$.
B.A xisym m etric Torus

U sing a Fourier series truncated after frequency $m_{\text {max }}$ creates a ( $2_{m a x}+1$ )-dim ensionalparam eter space to explore in the num erical $m$ inim ization. So CPU tim e increases very rapidly with max . A second num ericalm ethod was also used, which involved num erically lintegrating' Eq. (7.6) forward in from 0 to $0_{0}+2$ and $m$ inim izing the resultant discontinuities in $f_{p}$ and its derivative, $w$ ith respect to the initial conditions and. This $m$ ethod is $m$ ore accurate than the $R$ ayleigh $R$ itz $m$ ethod but $m$ ore di cult to use since, depending on the starting conditions, it may nd a non-ground-state solution. H ow ever, it was useful in establishing the accuracy of the upper bounds. U sing $\max =7$, 0 was found to an accuracy of $0.05 \%$ in the worst case.

In F ig.(3), ( $)$ is plotted for $0 \quad \mathrm{p} \quad \mathrm{n}, \mathrm{w}$ th data points at increm ents of 0.5 in and cubic spline interpolation. T he states are labelled $n_{p}$. O ne might have guessed that $n_{0}$ would be the ground state in each case. A nd indeed, for large aspect ratios, when the torus is alm ost cylinder-like, the $\mathrm{p}=0$ states do have the low est energy. These states are even functions of , being larger at $=$ than at $=0$ where there is $m$ ore absolute intrinsic curvature, and do not vary $w$ ith . ie. The eld does not tw ist $w$ ith respect to the coordinate lines as increases. H ow ever, for sm aller, statesw th non-zero p are energetically favoured.

Before explaining the reason for this, it is necessary to describe these states. Fig. (4) depicts a selection of states for $n=2$ on a C li ord tonus. The nem atic-order eld is represented by sets of double-ended lines directed along the orientations of order in the surface of the torus. $T$ he length ofeach line isproportionalto j jat that point. N ote how ever that the three-dim ensional view s of the toroidal surface cause the lines to be foreshortened at oblique angles to the line of sight.


F IG .4. Various Landau levels of the $n=2$ (nem atic) order-param eter eld on a C li ord torus. States are labelled $n_{p}$ and show $n$ in plan view and side view and dependence is given graphically.

Two view s are shown of each eld on the toroidal surface, as well as a graph of $f()$. N ote that positive p states have a large eld on the bottom of the torus and sm allon the top, and vioe versa for negative $p$. This asym $m$ etry becom es $m$ ore pronounced $w$ ith increasing p , w ith increasing n , and w th decreasing . As stated earlier, ordering is frustrated by intrinsic curvature. A nd the net am ount of intrinsic curvature on the torus is constant. But as decreases, the curvature is redistributed. It becom es m ore negative around the hole and $m$ ore positive around the outside of the torus, w ith the top and bottom rem aining fairly at. So this is where the eld prefers to reside and be parallel. A though in Eq. (7.5) non-zero p states appear to tw ist w ith respect to the coordinate basis as increases, the basis itself tw ists on the top and bottom of the tonus as the hole is circled. The two tw ists cancel. N ote that the diagram of the $22_{2}$ state depicts a eld which is as parallelas possible on the top 'lace' of the tonus. O f course, the eld on the inner and outer 'rim s' still contributes to the free energy so, as increases, the ground-state value of $p$ decreases by a series of transitions'. This is clear in Fig.(3). These should not be regarded as true phase transitions, since the low est Landau level approxim ation breaks dow n com pletely at these points. A s a crossover betw een eigenvalues is approached, the true state is a m ixture of the two states.

It should be em phasized that the tori studied here are true, curved tori, em bedded in 3-space. They should not be confused with a at torus, which is a plane w ith opposite edges identi ed, for which the above energetics w ould not apply. T he tw o have the sam e topology, but di erent local geom etries.

## C. $N$ on-A xisym m etric Torus

W hen $\quad 0$, the Landau levelequation (Eq.(7.1)) becom es much m ore com plicated and its variables are no longer separable. H ow ever, $R$ ayleigh $R$ itz variational $m$ ethod is again possible, as

but the trialw avefunctions are now com plex, periodic functions of tw o variables. T hus, synthesizing them with a truncated, two-dim ensional, com plex Fourier series up to frequency ${ }_{m \text { max }}$ produces an ( $8_{\text {max }}^{2}+8$ max $^{(1)}$ )-dim ensional space of variational param eters to be nu$m$ erically explored. H ence ground-state functions of the coordinates with high frequency com ponents cannot viably be found. This is unfortunate since conform ally transform ing an axisym $m$ etric tonus w ith the coordinate system described above, leaves the coordinates very unevenly distributed over the surface, with most of the interval from 0 to 2 in and covering only the sm all handle' part of the torus and only a sm all range covering $m$ ost of the area. T his problem is partly solved by a coordinate transform ation (; )! (;)which preserves the $m$ etric's diagonalization, where

although this still leaves som e high frequency com ponents in the distribution of the coordinates on the handle. $U$ sing these coordinates, Eq.(7.9) is very com plicated but two special cases are already know n :
$W$ hen $=0$, the tonus is axisym $m$ etric and $o w a s$ found by the $m$ ethod in section V IIB.
$W$ hen $=\frac{1}{R_{0}(+1)}$, where $R_{0}$ is the radius of the $s m$ all generating circle, the torus becom es a sphere with an in nitesm al handle. Hence $0=\mathrm{n}$ and the ground-state function is that of a sphere $w$ ith all $2 n$ zeros at the handle.

U nfortunately, the problem is too com puter-intensive to produce any usefiul results for inter$m$ ediate values of $. U^{\operatorname{sing}}{ }_{m a x}=3$ and perform ing the $m$ inim ization in a 98 -dim ensional param eter space took a considerable am ount of CP U tim e per data point. At this level, no states of interm ediate were found to have a low er eigenvalue than the know $n$ axisym $m$ etric or spherical states. Som e bocalm inim a were found but these are very likely to be artifacts of the varying reliability of the upper bound, which was high by around 10\% for $=0$ and
$60 \%$ in the spherical lim it. M ore research on this problem is planned. But for the $m$ om ent, it is necessary to work w ith the ansatz that:

A spherical vesicle exists when its total free energy is lower than that of an axisym $m$ etric torus.

An axisym $m$ etric tonus exists when its total free energy is low er than that of a sphere and its eld energy alone is lower than that of a sphere.

A non-axisym $m$ etric tonus exists otherw ise.

## V III. THE ${ }^{4}$ TERM

## A. A xisym m etric Torus

It was noted earlier that $p$ and $p$ are degenerate to quadratic order in . So, from Eq. 6.5), is a linear combination of $p$ and $p$, where $p$ has the ground-state value for the given aspect ratio. The relative proportions of the two states are determ ined by the ${ }^{4}$ term in Eq. 4.1). Let

The gauge invariance and axial sym m etry of the problem allow us to choose the phases ofboth $a_{+}$and a . Hence is determ ined by a m inim ization with respect to just one param eter.

For som e values of and p, it is found that $=p^{1} \frac{1}{2}\left(a_{+}+a\right)$. So the top' and bottom' states $\infty$-exist and, although each is fairly parallel on its own side of the tonus, the two do not $m$ esh $m$ oothly where they $m$ eet. C onsequently, there are $2 p$ defects each of index $\frac{1}{n}$ around the torus's outer 'rim ' and 2 p of index $\frac{1}{\mathrm{n}}$ round the inside of the hole: a total of 4 p defects. Hence as varies and $p$ jum ps betw een integer values as described above,
vortex-antivortex quartets are form ed or destroyed. Let these sym $m$ etrical states be labelled $\mathrm{n}_{\mathrm{p}}^{\mathrm{s}}$. The $4_{3}^{\mathrm{s}}$ state for $={ }^{\mathrm{P}} \overline{2}$ is represented in F ig. (5) .

The eld is represented by crosses of four lines, directed along the orientations of order in the surface of the cli ord torus. $T$ he length of each line is proportional to $j j$ at that point although the three-dim ensional view of the toroidal surface causes the lines to be foreshortened at oblique angles to the line of sight. $N$ otice that 3 of the 6 defects of index $\frac{1}{4}$ are visible in the side view (where $j j!0$ ), and that the eld rotates through $\frac{n \mathrm{p}}{\mathrm{n}}=\frac{1}{4}$ of a tum around the hole.

For other values of and p, where the overlap between $p$ and $p$ is large and hence the defects in the eld becom e expensive, the up-down sym m etry is spontaneously broken,
so that $=p$ or $=p \cdot$ Let these broken-sym metry states be labelled $n_{p}^{B} \cdot A$ varies, there are transitions between S and B states, which, unlike the transitions betwen states of di ering $p$ described in section VIIB, $m$ ay be regarded as true phase transitions $w$ ithin $m$ ean- eld theory, although they $m$ ay beblurred by the inclusion of uctuations. A sa rule of thum b, the ${ }^{4}$ term chooses $S$ or $B$ on the basis of which covers the surface $m$ ore uniform ly.

## B. Sphere

It was explained in section VIIA that the spherical Landau levels are degenerate w ith respect to the positions of the vortices. The ${ }^{4}$ term lifts this degeneracy and $m$ akes the vortioes repel. Hence, follow ing Park et al. 目], the ground state con guration is taken to be that of highest sym $m$ etry. So, when $n=1$ the two zeros are antipodal. $W$ hen $n=2$, the zeros lie at the comers of a regular tetrahedron and, when $n=6$, at the comers of an ioosahedron. The values of $J_{\text {(sph) }}(n)$ were found using these con gurations. For $n=4$, the defects lie at the comers of a cube whose top face has been rotated through $45^{\circ}$ relative to the bottom face. The distance between these two faces is then varied to minim ize $J$. The optim al separation is found to be very close to the length of a side of the original cube.

## IX.THE PHASE DIAGRAMS

The minim ized free energy of the sphere is now com pletely determ ined. Expressing it as a fraction of the bending rigidity gives an equation relating just four dim ensionless com binations of them odynam ic param eters:

W hen Eq.(92) is $m$ in $\dot{m}$ ized $w$ ith respect to , som e of the physical ridnness of the problem is lost, asm any of the interesting phases and all the broken sym $m$ etry states occur on toriof aspect ratios which are not the energetic optim um . H ow ever, other interesting features arise, as w ill.be seen in the phase diagram s in $F$ igs. (G)-(G), which result from a phase space restricted to only axisym $m$ etric tori, and show contours of constant as well as lines of rst order and continuous phase transitions. The phases are labelled w ith the notation introduced earlier.

The diagram s are plotted in the plane of the two independent com binations of therm odynam ic param eters in Eq. 92). In each case, to the far right of the diagram is the high-tem perature phase, forwhich $=0$. In this phase, only the curvature energy is nonvanishing so the aspect ratio is ${ }^{\mathrm{P}} \overline{2}$; the C li ord tonus. N ote that the continuous transition, at which ordering arises, occurs not at $r=0$, but is suppressed by the $m$ anifold's curvature to $r=r_{c}$, as de ned in section $N$ for the $C$ li ord torus. $N$ ote that $r_{c}$ depends on aspect ratio, aspect ratio depends on and depends on $r_{c}$. This non-linearity is the cause of
the rst-order phase transitions. Consider for instance the $n=1$ diagram (Fig.(G)). A vesicle with sm all is easily deform ed by the $1_{0}^{S}$-state ordering to large aspect ratios at low tem peratures. At large aspect ratios, $r_{c}$ is close to zero. A s the tem perature rises, dim inishes, and can no longer hold the aspect ratio so far from the C li ord torus. A s the aspect ratio falls, ordering becom es m ore di cult. T here com es a tem perature at which the torus jum ps down a rst order phase transition to the Cli ord torus, where $r_{c}<r$. At higher values of , the transition is continuous. The $n=1$ phase diagram has a tri-critical point at $\frac{A r}{C}=13: 68$ and $\frac{C^{2}}{A u} \quad 0: 98$. For higher values of $n$, the rst order transition persists for all values of , and $m$ eets the continuous transition at a multi-critical point. The continuous transition here is between the high-tem perature phase and the $\mathrm{n}_{\mathrm{n}}^{\mathrm{S}}{ }_{1}$ phase, for which $<{ }^{\mathrm{P}} \overline{2}$ since the gradients in F ig. (3) are positive close to the C li ord torus.

The free energy (Eq. 4.1)) has now been $m$ inim ized with respect to the order param eter eld's con guration and $m$ agnitude and $w$ ith respect to the toroidal aspect ratio. It rem ains only to m inim ize w ith respect to topology, according to the prescription given in section VIIC. F igs. (19)-(13) show the resulting phase diagram $s$, which include spherical, and axisym $m$ etric and non-axisym $m$ etric toroidal phases of vesicles. $N o$ contours are show $n$ in these gures. The positions of the transitions vary with - , and transition lines are show $n$ forvarious values of th is quantity. Figs. (19)-(13) should therefore each be regarded as several phase diagram s superim posed.

The $n_{n}^{S}{ }_{1}$ phases do not persist when this larger phase space is explored, except for $6_{5}^{S}$, forwhidh 0 is less than the sphere value of 6 , when is close to ${ }^{P} \overline{2}$. T he diagram s are each divided into shaded and unshaded regions by a heavy line. In the shaded regions, vesicles are either spheres or non-axisym m etric tori while, in unshaded regions, either spheres or axisym m etric torioccur.

Consider rst the $n=1, n=2$ and $n=4$ phase diagram s. A transition line, whose position depends on $\xrightarrow{G}$ separates tori from spheres. N ote that for $\xrightarrow{G}>\quad 2$, the transition
line is closed, w ith spheres on the inside and toriof one sort or another on the outside, while for $-\frac{6}{}<\quad 2$, the line is open, w ith spheres on the high-tem perature side and axisym m etric tori on the low -tem perature side. This magical value of 2 is the critical value of - at which spheres would becom e tori if the $m$ odel described curvature energy alone and did not include term s in. N ote that in these three phase diagram s the separatrix (the $-=2$ transition) has a vertical limb at the value of $\frac{A r}{C}$ at which ordering rst form $s$ on the sphere, ie. at $r=r_{c}^{\text {sphere }}$.

The $n=6$ diagram in $F$ ig. (13) is a little $m$ ore com plicated since there are two distinct phases of ordering on axisym $m$ etric tori. A gain, the diagram is divided into shaded and unshaded regions. The shaded region is now split into two parts. The part on the right contains spheres if $\epsilon<\quad 2$, and non-axisym $m$ etric tori otherw ise. The part on the left contains spheres on the high $\frac{C^{2}}{A u}$ side of the transition line (whose position depends, of course, on - ${ }^{-}$) and non-axisym $m$ etric tori on the other side. The un-shaded region, which contains axisym $m$ etric tori and spheres, is also divided into two parts. The part in the top left of the diagram behaves as described above for the other phase diagram s . The other part may (depending on - ) contain a closed transition line, which, unlike the other closed transition lines we have $m$ et, has spheres on the outside and axisym $m$ etric tori, of sm all aspect ratio and $\sigma_{5}^{S}$ eld con guration, on the inside.

The four phase diagram of $F$ igs. (10)-13) $m$ ay sem com plicated but they are easily understood if one rem embers that: a) they are several diagram s superim posed, and b) the regions in which spherical vesicles exist become sm aller as ${ }_{\mathrm{G}}$ increases, since spheres have $m$ ore intrinsic curvature than tori. Having established from these diagram $s$ that an axisym $m$ etric torus exists in a certain region, its aspect ratio $m$ ay be found from $F$ igs. (6)-(g).

It should be $m$ entioned that the curves de ning the edges of the shaded regions in Figs. (10)-(13) have been slightly sm oothed by hand to rem ove pixcellation which arose from num erical rounding errors.

X.VALIDITY OF THE APPROXIMATIONS

Som e order-ofm agnitude calculations are now presented to give an indication of the regim es of validity of the various approxim ations used.

## A. Low est Landau Level A pproxim ation

The Landau levels form a com plete set of orthogonal functions in which to expand the order param eter; $={ }^{P}{ }_{p} a_{p} p$. Each eigenfunction $p$ has an eigenvalue $p$ de ned by Eqs. (62) and (6.4). region than this, in order to clarify the qualitative features of the diagram s , for whidh the calculation at this level of approxim ation is a useful guide. It should be noted that, at transitions' from one lowest Landau level con guration to another, ( $\left.\begin{array}{lll}1 & 0\end{array}\right)!0$, so the approxim ation m ust break dow $n$ here, as noted in section VIIB. A lso, in the large- phases below the rst-order transitions, $r_{c}$ is higher, so the system is far from the low est Landau level regim e. These phases are included in the diagram s in order to show the rst-order transitions.

## B. M ean Field Theory

For this order-ofm agnitude analysis, let us treat tw o parts of the free energy separately: rst we w ill dem and that uctuations in the $H$ elfrich $H$ am iltonian $m$ ay be neglected in the absence of orientational order, then, within this xed, non- uctuating environm ent, it will be required that the term $s$ in satisfy the $G$ inzburg criterion for the validity ofm ean- eld theory.

In a sim plistic calculation, good over only a short range, the $M$ onge gauge is used to param eterize a locally horizontal surface, de ning its $z$-coordinate as a function of $x$ and $y$. $K$ eeping term sof second order in $z$, and expanding $z$ in plane-w ave m odes: $z \quad A^{\frac{1}{2}}{ }^{P} \quad q_{k} e^{i k x}$ gives

so, for uctuations to be negligible on the scale of the system size requires $\frac{1}{4^{2}}$. This is intuitively obvious; that a large bending rigidity is required to com bat uctuations. In fact, this sim ple calculation on a atish surface is over-stringent, since intrinsic curvature, as exists in closed surfaces, reduces the size of uctuations 10].

The $G$ inzburg criterion is now com puted for the $G$ inzburg-Landau part of the free energy. This is a com parison between the size of the discontinuity in speci cheat at the phase transition, calculated $w$ ith $m$ ean- eld theory, and the size of the divergence in speci $c$ heat due to $G$ aussian uctuations. C lose to the transition, r goes approxim ately linearly w ith tem perature $T$. ## D. The Shapes

C lose to the ordering transition, is very sm all, so the order cannot deform the torus far from $C$ li ord's aspect ratio ${ }^{\mathrm{P}} \overline{2}$, or the genus-zero shape far from a sphere, so the vesicle shapes used in this theoretical investigation are undoubtedly good. This it willdo where it is large, at the expense of an increased curvature where is sm alleg. at the defects. This pay-o is unavoidable, since the integral of intrinsic curvature is topologically xed. Hence spherical vesicles are slightly deform ed
by the in-plane order, into rounded polyhedra, whose vertioes are at the order param eter's vortices. This is the e ect which has been ignored in this paper. T he sam e process w ill also occur in tori, especially in those parts of the phase diagram swhere ordering is predicted to deform the torito large aspect ratios. In general, onem ight expect that the larger the aspect ratio, the w orse the approxim ations of circular cross-section and axisym $m$ etry. B ut nature is on our side here. Since, in these large-aspect-ratio tori, is alw ays in the $\mathrm{n}_{0}^{\mathrm{S}}$ con guration, which has no vortioes, and becom es very uniform for large aspect ratios. So, although this approxim ation results in som e quantitative inaccuracies, they are likely to be sm all. A lso, they m ust change the free energy of the torus and the sphere, if not by the sam e am ount, then at least in the sam e direction. So the phase diagram smay not have exactly the right num bers, but they do have $m$ ore-or-less the right shape.

## X I. C O N C LU S IO N

It is clear that orientational order in a toroidal geom etry is a sub ject ridh in physical diversity, and deserving of further study in condensed matter theory. A lso, introducing orientational order into the surface is an interesting way of stabilizing a torus against the $m$ assless $G$ oldstone $m$ ode of conform al transform ations, w ithout resorting to spontaneous curvature or a constraint ofconstant volum e orbilayer area di erence. A s far as experim ental veri cation is concemed, the principal results of this paper are embodied in the nal four phase diagram s. The approxim ations used in their derivation $m$ ay result in quantitative inaccuracies, but the $m$ ain qualitative features of these diagram s are predicted to be seen in experim ent in the future. At present an experim ental realization is som ew hat di cult, due to the fragile nature of laboratory-produced vesicles.
