Statistical Theory of 2-D im ensional Quantum Vortex Gas: N on-C anonical E ect and G eneralized Zeta Function

Abstract

The purpose of this paper is to present a quantum statistical theory of 2dimensional vortex gas based on the generalized H am iltonian dynamics recently developed. The quantized spectrum is evaluated for a pair of vortex on the basis of the sem iclassical quantization rule. This is used to evaluate the partition function for a dilute vortex gas. A remarkable consequence is that the partition function and related quantities are given in terms of the generalized R iem ann zeta function. The topological phase transition is naturally understood as the pole structure of the zeta function.

Introduction

The study of vortex defects in two dimension has revealed many interesting properties which have had a wide variety of applications in condensed matter physics. For example the super uid ${}^{4}\text{H}$ e plays an in portant role in understanding the properties of the physics of vortex defects. A part from the quantum uid such as ${}^{4}\text{H}$ e, it has long been known that in classical hydrodynam ics the equation of motion for the center of vortices form sa H am illionian system, (e.g. K inchno equation) [1] where the uid under consideration is assumed to be in an electively two-dimensional incompressible uid. In our recent papers we have developed a novel theory of vortex motion occurring in the two-dimensional quantum condensates, namely, the super uid liquid H elium [2] as well as the H eisenberg spin model [3]. This theory shows that the vortex motion is described by the generalized H am iltonian dynam ics, which indicates the deviation from the conventional canonical form. Here we have used the time dependent Landau G inzburg (LG) equation (action) to derive the elective action for the motion of center of vortices. The LG action is described by the complex order parameter eld which is naturally introduced through the use of the coherent state path integral for the quantum condensates.

On the other hand, it is well known that the assembly of vortices occurring in the XY – m odel and the sim ilar two-dimensional condensates reveal the topological phase transition, known as the Kosterlitz Thouless (KT) transition [4]. This shows the occurrence of dissolution of vortex-antivortex pairs at some nite temperature. This implies also the vortex pair excitations as the uctuation out of a state with quasi long range order in two-dimensional XY and super uid models.

The purpose of this paper is to study the quantum statistical mechanics of 2-dimensional vortex gas on the basis of the generalized H am iltonian dynam ics that is developed in the previous two papers. Speci cally we are concerned with the statistical properties of vortex-antivortex pairs. We are rst concerned with the quantization of a vortex pair by using the Bohr-Sommerfeld quantization scheme. By using the resultant quantized spectra for a vortex pair, we next evaluate the statistical partition function for a vortex pair in a dilute

gas limit. We get a remarkable consequence that the partition function is given in terms of the generalized R iem ann zeta function. As the characteristic property of the zeta function we see that the topological phase transition of KT type is naturally explained by the pole structure of the zeta function.

Basic Form ulation

We start with a concise review of the previous results for the later discussion. The basic standpoint is that the center of vortices $(x_i; y_i)$ X_i are regarded as canonical conjugate like variables. The elective action for the center of vortices is given by

Here the rst term is called the canonical term and the coe cients $A_{i}; B_{i}$ are given in terms of the \density function", say , together with the function $_{i}$ log $j \times X_{i} j^{1}$) whereas the second term represents the elective Ham iltonian for the motion of vortex centers which has the well known log potential form :

and hence the equation of motion for the vortex centers becomes

where G is the metric tensor and denotes the strength (charge) of the vortex. C represents the chemical potential or self-energy that is given by a sum of the self-energy of isolated vortices. The tensor G coincides with the symplectic form (two-form) and it is derived from the elective action !

where each submatrix g is given by the density function etc. through the coe cients A $_{i}$; B $_{i}$ in (1) and the concrete form for these is given in term of the overlap integrals between the gradient of as well as the functions as has been done in the previous papers for the bose uid and H eisenberg spin model. Thus the physical meaning of these terms suggests the e ect of nite size of vortices. We see that

 g^0 represents the diagonal and g the o -diagonal term of the matrix g 12 respectively with respect to the vortex indices. W e can introduce the poisson bracket using the tensor G :

In the more concrete form ,

The second term of LHS can be understood to mean that g causes the anom abus e ect. Note that the above formulation can be regarded as an important generalization of the classical K inchho equation $\underline{x} = fx$; H g_{PB} and $\underline{y} = fy$; H g_{PB} , with the H am iltonian has the same logarithm ic form, whereas fA; B g_{PB} denotes the usual Poisson bracket. The quantization is carried out by simply replacing the generalized PB by the commutator: $fx_i; y_j g ! [k_i; y_j]$. Furtherm one to be mentioned is the following fact: The equation of motion for the case that g vanishes is rewritten as

This equation suggests that the canonical equation of motion (K inchho equation) is alternatively regarded as the balance equation of two type \forces", the one is the right hand side, that represents the force derived from the \potential function" H_e and the other is the left hand side, that represents the velocity of the i-th vortex in a literal sense times the vorticity vector $\langle g_0 \tilde{K} \rangle$, where \tilde{K} m eans the unit vector perpendicular to $\langle x; y \rangle$ plane. The latter corresponds to the so-called M agnus force. [5].

Quantized Spectra for a Vortex pair

We shall now treat the system of two vortices whose charges are opposite each other, that is, $_1 = _2$ and quantize it. The most interesting quantity is the quantized energy spectrum for the vortex pair, which will be used to evaluate the statistical function of the vortex gas. In order to carry out this, we rst consider the case that the non-canonical e ect is om itted and its e ect will be taken into account as a perturbation. By having this in mind, we shall introduce the \center of mass" and \relative" coordinates as

where $(x_i; y_i)$ is the coordinate of the center of i-th vortex. The elective H am iltonian which is derivatived previously becomes

where the Ham iltonian is changed to positive de nite. 2 Hence we obtain the equations of motion as follows:

From the rst set of equations, it follows that Q and P become constant of the motion, which means that the center of vortices is at rest. On the other hand, from the second set of equation it follows that the orbit in the (p,q) plane forms a circle: $p^2 + q^2 = constant$.

W e shall carry out by using Bohr-Som m erfeld quatization, nam ely,

where n = integer and the factor the factor $\frac{1}{2}$ is added, which corresponds to the zero point energy. ³ Physically speaking, the above quantization rule suggests the quantization of the angular m on entum carried by a vortex pair. In this way, if we note that the unperturbed orbit C for the relative motion becomes a circle of radius, say, R, the quantization for non-perturbed case is calculated as

Hence the radius R takes a quantized value; $R_n^2 = \frac{2h}{g^0}n$ with n integers. In the above expression, g_0 takes $g_0 = m_0$ (bose uids), $g_0 = J h$ (spin uid). Next, if the o -diagonal term is taken account of as perturbation,

Here the value of can be written as the function of R. Qualitatively, this becomes small as the size of the vortex small and it tends to a constant value as ! 1 (the explicit evaluation

m ay be given in the separate paper) [6]. In this way, R_{n^0} should be determined from the self-consistent equation, in other words, the quantum number n changes to the modi ed value n^0 , which may be written as

If we assume that the elect of is su ciently small and hence put $(R_{n^0}) = \sim = constant$, then we have the simpler form for the quantum condition:

If we substitute (22) into (13), we get the energy spectra for the relative motion:

Sum marizing the above result, the angular momentum quantum number does not take integer values.

Partition Function of D ilute Vortex G as

Now we investigate statistical mechanics of two-dimensional gas of vortices with strength (charge) in the medium of \charge" neutrality and each vortex interacts through log potential. The therm odynamical quantities are obtained through the partition function $Z = Tre^{-H_e}$, where 1=kT and T is the temperature and k denotes the Boltzm ann factor. The trace means the sum over all possible states the system is allowed to take. Here we restrict ourselves to a special situation: namely, the chemical potential C, which is necessary to create a pair of vortex of plus and minus charge, is very large. In this extrem e situation, the vortex system can be treated as a dilute gas consisting vortex pairs. In this

lim it, it su ces to treat only one pair of vortices to consider the partition function. This is easily evaluated to be

Here (s; a) is de ned by

which is just a generalized form of R iem ann zeta function (in m athem atical literature, this is called \H urw itz zeta function"). [8] The conventional zeta function is obtained by setting $\sim = 0$. Remarkable is that diverges at the point at s = 1; namely, function has a simple pole at s = 1. This pole singularity causes the divergence of the free energy at nite tem perature; $\frac{2}{4} = 1$, namely, the critical tem perature is given by $T_c^0 = \frac{2}{4k}$. This fact suggests that a phase transition occurs at this tem perature. We shall also exam ine the susceptibility due to these pair, which is given by

where $< R^2 >$ represents the m can square separation of the each dipole pair, which becomes

The above expression shows up the following remarkable consequence; the pole of (29), namely, $\frac{2}{4}$ 0 1 = 1, de nes another transition temperature: If the temperature approaches to T_c from the below, the mean separation between the pair diverges at this temperature. We see that this position corresponds to nothing but the temperature T_c of the KT transition at which a dipole pair is made to dissociate. Note that this temperature is just half of T_c^0 noted in the above. The free energy or partition function itself remains nite at this temperature, namely, this feature is seen from the formula

which is nite. In the above argument we assume that the position of pole and hence the transition temperature is not a ected by the presence of shift of quantum number by an amount of ~, which follows from the theorem concerning the Hurwitz zeta function.

Sum m ary

To sum marize the present result is that after having calculated the energy spectra including the e ect of the non-canonical term coming from the speci c nature of quantum vortices, we have shown that the topological phase transition of K T type is characterized by the pole structure of the generalized R iem ann zeta function. Up to our know ledge, this fact has not been known by anyone previously, which suggests that characteristics of statistical therm odynam ics of vortex gas ism ade clear by exploiting the speci c properties of zeta function. In this connection, we note the appearance of two di erent transition temperatures; T_c and T_c^0 . It seems puzzled to have two di erent transition temperatures, but it should be noted that the present theory is based a rather naive assumption, that is, only one vortex pair is considered and no correlation, which arises from the other vortex pairs, is not taken into account. If we incorporate this correlation in a proper manner, we may have a correct value of the temperature for the topological phase transition. As the other problem s we must consider the case that the noncanonical term has dependence of the quantum num ber n which is shown by the self-consistent nature of the B ohr-Som merfeld equation. The details of these discussion will be given elsewhere.
