# Iterated M oire M aps and B raiding of C hiral P olym er C rystals

In the hexagonal colum nar phase of chiral polym ers a bias tow ards cholesteric tw ist com petes with braiding along an average direction. W hen the chirality is strong, screw dislocations proliferate, leading to either a tilt grain boundary phase or a new $\backslash \mathrm{m}$ oire state" w ith tw isted bond order. Polym er trajectories in the plane penpendicular to their average direction are described by iterated $m$ oire $m$ aps of rem arkable com plexity.

[^0]A notable feature of biologicalm aterials is the profusion of long polym er m olecules with a de nite handedness. DNA, polypeptides (such as poly- -benzyl-glutam ate) and polysaccharides (such as xanthan) can all be synthesized with a preferred chirality. Long polym ers in dense solution often crystallize into a hexagonal colum nar phase. $W$ hen the polym ers are chiral this close packing into a triangular lattioe com petes with the tendency for the polym ers to tw ist $m$ acroscopically [1] as in cholesteric liquid crystals. Sim ilar to the tw ist grain boundary phase of chiralsm ectics [2], $m$ acroscopic chirality can proliferate when screw dislocations enter the crystal. Like ux lines in a type II superconductor, dislocations only appear provided the free energy reduction from the chiral couplings exceeds the dislocation core energy. If the chirality is w eak, a defect free hexagonalcolum nar phase persists, as in the $M$ eissner phase of superconductors.

In this letter we explore the e ect of chirality on the hexagonal colum nar phases [3] of long polym ens in detail. We neglect for sim plicity heterogeneity along the polym er backbones and work w th a two com ponent displacem ent eld penpendicular to the local polym er direction. The usual chiral term relevant for cholesteric liquid crystals produces the polym er tilt grain boundary phase, sim ilar to the sm ectic-A phase [2]. We nd, as well, an additional term in the free energy which favors the rotation of the bond order along the average polym er direction. This term leads to braided polym ers with tw isting describable by a sequence ofm oire pattems.

U sing continuum elastic theory we estim ate the critical values of the chiral couplings above which screw dislocations enter. On a m ore m icroscopic level, we propose a set of lock-in m oire textures which should be especially low in elastic energy. These states are entangled and self-sim ilar, and lead to tortuous polym er paths of rem arkable com plexity, rem in iscent of chaotic dynam ical system s.

W hen polym er nem atics crystallize the arealpolym er density in a plane perpendicular to the average direction $m$ ay be approxim ated as

$w$ here the $f G g$ are the six sm allest reciprocal lattice vectors of a triangular lattioe. $W$ e take the average polym er direction here and throughout to be $\hat{z}, \mathrm{w}$ th $\mathrm{G} \quad \hat{z}=0$. Each plane wave is modulated by a spatially varying magnitude and phase (x) = $j$ (x) jexpfiG $\forall(x) g$, where $u$ is a two-dim ensional displacem ent eld. In addition, we have a nem atic order param eter, $\hat{\mathrm{n}} \hat{\mathrm{z}}+\mathrm{m}$ and, in the case of a triangular lattice of polym ers, a bond eld 6 which $m$ easures the bond-orientational order in the xy-plane, modulo $2=6$. Under a global rotation about the $x$-axis or $y$-axis by an angle $x$ or $y$

 leading to a position dependent change in the phase of (x). To insure rotational invariance, derivatives of ( $x$ ) m ust be accom panied by the elds 6 and $x$ [4] and we are led to the Landau free energy

C rystalline order arises forb su ciently negative so that h if 0. D ue to the third order term, this transition will, in general, be rst order.

To this free energy we add tw o m ore pieces. It is convenient, but not essential, to im agine that the hexagonal colum nar density w aves arise from a phase w ith localnem atic order as well as six-fold bond order penpendicular to the director axis. This $\backslash \mathrm{N}+6$ " phase has been studied by Toner [5]. A though the present experim ental evidence for $\mathrm{N}+6$ order in polym er nem atics is sketchy, such phases seem highly likely in colum nar system $s$, in analogy w ith the hexatic order expected for vortex lines in high tem perature superconductors [6]. In the absence of chirality we have the usual elastic energies of the nem atic eld and the bond angle eld,
where the $f K_{i} g$ are Frank constants, and $K_{A}^{j j}$ and $K_{A}^{?}$ are hexatic sti nesses parallel and perpendicular to $\hat{z}$. For long chain polym ers $\mathrm{K}_{1} \quad \mathrm{~K}_{2} ; \mathrm{K}_{3}$ [7].

Finally, we add those chiral tem s which respect the nem atic sym $m$ etry. If there is no preferred direction along the polym ers then the free energy $m$ ust be invariant under A! f . A dditionally, since changes in $\sigma$ are $m$ easured $w$ th respect to the $\hat{\mathrm{n}}$ axis, under nem atic inversion, 6 ! ${ }_{6}$, and the vectorv $r_{6}$ changes sign. U nder spatial inversion f $!$ fi, $6!6$ and hence $w!v$. The chiral free energy density $F$ contains two distinct term s invariant under nem atic inversion but which change sign under parity [8],
w th $=K_{2} G_{0}$ and ${ }^{0}=K_{A}^{j j}$ of $_{0}$. The rst term often leads to cholesteric tw ist w ith period $2=\Phi$ along a line perpendicular to the plane in which the nem atic director lies. The second induces tw ist into the bond-order param eter 6 w ith period $2=\Phi$ along $\hat{2}$. The consequences of this additionalchiral coupling is the $m$ ain sub ject of this paper. $T$ he total free energy is $F={ }^{R} d^{3} r \mathbb{F}_{d}+F_{\circ}+F$ ]. N ote the close sim ilarity between (2)-(4) and the $G$ insburg-Landau theory of a superconductor in a magnetic eld. The elds in and 6 are \gauge elds" m inim ally coupled to the com plex order param eters $f(x) g$ by the constraint of rotational invariance. There are two distinct $\backslash m$ agnetic" elds and ${ }^{0}$. B urgers vectors of dislocations in a hexagonalcolum narphase lie in the xy-plane, and there are three generic types [3]: a screw
dislocation, an edge dislocation w ith tangent along $\hat{\mathrm{z}}$, and an edge dislocation lying in the xy-plane. The latter defect requires aligned polym er ends which we neglect in this paper. $T$ he rem aining dislocations $m$ ust lie in a plane spanned by their Burgers vector $\widetilde{5}$ and $\hat{z}$, which am ounts to choosing dislocation complexionswith $\quad x y=y x$ where the dislocation density tensor $i$ is the density of dislocations $w$ ith tangents along the -direction $w$ ith B urgers vectors pointing in the idirection [6].

Proceeding as in $\left[9,6\right.$ ] we introduce a new eld wis $\mathrm{a}_{\mathrm{i}}$ aw ay from any dislocations. The non-com $m$ utivity of the derivatives of $u$ is represented by the dislocation density,
@ $\mathrm{w}_{\mathrm{i}}=\quad \mathrm{i}$. O ne can solve for $\mathrm{w}_{\mathrm{i}}$ in term s of the dislocation density i and nd the equilibrium displacem ent eld in the presence of crystaldefects [10]. In term s of the ne$m$ atic and bond order eld non-com $m$ utivity ofderivativesm eans $2 @_{z} \quad 6 \quad r_{2} \quad \mathrm{P}=\operatorname{Tr}[]$. T he energy per unit length of a screw dislocation is nite, while that of an edge dislocation lying along the $\hat{2}$ direction diverges logarithm ically w ith system size [11]. T he screw dislocation energy depends on the dim ensionless param eter $=\left(K_{3}{ }_{2}^{2}={ }_{z}^{4}\right)^{1=4}$, where ? and $z$ are short distance cuto $s$ in the perpendicular and paralleldirections, respectively. W e estim ate $\quad 1$ for polym er crystals which is the condition that the response to chirality be sim ilar to that of Type II as opposed to Type I superconductors [2]. In this lim it the free energy per unit length of a screw dislocation is $f_{s}=\left({ }^{3=4} K_{3}^{1=4} b^{2}\right)=\left(2^{\mathrm{P}} \overline{2}\right.$ ? $)$, where b is the length of the $B$ urgers vector.

If the chirality is strong and ${ }^{0}$ we expect the polym er analogue of the RennLubensky tw ist-grain-boundary state [2]. Each of these tilt grain boundaries (TGB) is com posed of a parallel array of screw dislocations lying, say, in the xz-plane, pointing along the x -axis and uniform ly spaced along $\hat{z} \mathrm{w}$ ith spacing d . A s ilhustrated in F igure 1 this dislocation texture causes a discrete rotation $=\tan ^{1}(b=d)$ in the average polym er direction. The spatialintegralofr, I isnon-zero, while the integralof@ 6 vanishes. The TGB state appears when the chiralcoupling exceeds the criticalvalue $\mathrm{c}_{\mathrm{c}}=\mathrm{f}_{\text {screw }}=\mathrm{b}$. The di raction signature is sim ilar to that of the sm ectic-A phase: if the pitch axis is $\hat{y}$ so that
the polym ers lie, on average, in the xz-plane, the structure function would consist of tw o B ragg circles with radius $2=a$ lying in a $q_{k} q_{-}-p l a n e$ and centered on $q=(0 ; 2 \stackrel{p}{=} 3 a ; 0)$ $w$ here $a_{0}$ is the lattice constant and tw o B ragg spots at $q_{y}=\quad 4 \stackrel{p}{=} \overline{3} a_{0}$. These features should have w idths $\quad 2=d$ along $g_{y}$ where $d^{0}$ is the spacing betw een tilt grain boundaries. If the rotation angle between successive crystalline regions were a rational fraction of 2 , the Bragg circles would break up into a sequence of B ragg spots spaced around the circle. A though a precise determ ination of $d$ and $d^{0}$ w ould require $m$ ore detailed energetic calculations, we estim ate, follow ing [2], that d $\quad d \quad P \overline{a_{0}=q_{0}}$.

The second chiral coupling ${ }^{0}$ has no analogue in chiralsm ectics. To nd a con guration of screw dislocations which exploits this form of chirality we search for a dislocation texture which produces a displacem ent depending only on $z$. T he only texture which does not produce divergent elastic energy is one in which the only non-zero com ponents of i are $x x=y y[6,10]$. A honeycom b array of screw dislocations, on average, produces this dislocation texture. $W$ e now nd that for a single such grain boundary $r$ ? $n$ vanishes far from the boundary while $\oint_{\mathrm{z}} 6$ does not. This sort of grain boundary thus causes a net tw ist of the hexatic order param eter 6 while im posing no net $r$ ? 1 . $W$ hen ${ }^{0}$ and the chirality is large, screw dislocations penetrate for ${ }^{0}>{ }_{c}^{0}=2 f_{s}=b$. By choosing the rotation angle across the honeycom b dislocation netw ork to produce a high density of coincidence lattioe sites [12], we produce especially low strain energies across the boundary. The superposition of triangular polym er lattices below and above the boundary form sa $m$ oire pattem. T he superposition ofm any such $\backslash m$ oire sheets" along the $z$-axis braids the polym ens w ith deep m inim a in the energy at certain lock-in angles. Figure 1 ilhustrates the $m$ apping of polym ens across the $m$ oire plane, for a rotation angle $2 \quad 13: 2 \mathrm{w}$ th a particularly dense set of coincidence lattice sites. P olym ers in the low er half-space (circles) $m$ ust be connected to the closest available polym er in the upper half-space (crosses) to $m$ inim ize bending energy. $N$ ote that the $m$ ap has a discrete translational sym $m$ etry, in the sense that any coincidence site could be a center of rotation. Especially sim ple
$m$ oire $m$ aps arise for rotation angles $n=2 \tan ^{1}[\bar{\beta}=3(2 n+1)], n=1 ; 2 ;:::$. It can be show $n$ that all such angles are irrational fractions of 2 [10] so that the structure never repeats upon iteration. A round each coincidence point there are $n$ concentric rings of helical polym ers $T$ he lattice of coincidence points is also a triangular lattice, but w ith a spacing $a_{n}=a_{0} \overline{1+3(2 n+1)^{2}}=2$, where $a_{0}$ is the original lattice spacing. The geom etrical origin of such energetically preferred lock-in angles has no analogue in chiralsm ectics. The exact choice of lock-in angles and spacing betw een $m$ oire planes $m$ ust again be settled by detailed energetic calculations.

U pon two iterations of the $m$ oire $m$ ap separating three regions of polym er crystal, the rst coincidence lattice is rotated w ith respect to the second coincidence lattice by precisely the angle of rotation $n$. Thus the com posite coincidence lattice is the \coincidence lattice of coincidence lattioes", w ith lattice constant $a_{n}^{2}=a_{0} . M$ oire $m$ aps iterated $p$ tim es lead to triangular com posite coincidence lattioes w ith spacing $a_{n}\left(a_{n}=a_{0}\right)^{p 1}$, i.e. to ever sparser lattioes of xed points with intricate fractal structure in between them. Figure 2 show $s$ the pro jected polym er paths for $p=3$ and $n=1$. In contrast to the $T G B$ state polym ers forp 1 are highly entangled and wander far from straight line tra jectories. T he polym er con gurations and the dislocations leading to them are show $n$ in $F$ igure 3 for $n=1$. Near the $m$ oire planes both 6 and $r$ ? $r$ are nonzero. The center polym er is a xed point of all the $m$ aps. A ny such xed polym er has a halo of others tw isting around it. In this special tube, the nem atic order param eter takes on the texture of a double tw ist cylinder as found in the low-chirality lim it of blue phases [13]. T he m oire state takes advantage of both double tw ist energies and the new chiral coupling ${ }^{0}$. C losely related states are possible in the chiral $N+6$ phases. Textures of vortex lines in Type II superconductors, sim ilar to $F$ igure 3, $m$ ay arise when the A brikosov ux lattige is sub jected to a strong supercurrent parallel to the eld direction [10].

In the inset to $F$ igure 2 we show a random selection of polym er paths pro jected onto the xy -plane representing 99 iterations of the m oire m ap. Though these polym ens are
clearly in uenced by the exceptionalcenter point which is a xed point of all 99 m appings, there are still paths of great com plexity such that polym ers wander far from their original positions. In a defect-free hexagonalcolum nar phase the $m$ ost intense $B$ ragg spots appear in the $q_{z}=0$ plane at the vertices of a hexagon $w$ ith radius $G=4 \xlongequal{P} \overline{3} a_{0}$. The braided crystal described by the iterated $m$ oire $m$ ap should exhibit a $B$ ragg ring at $\dot{\text { ¢ }} \dot{j}=G$ in the $q_{z}=0$ plane. $T$ he ring should be very shanp along $q_{1}$, and of idth $2=d^{d}$ along $\phi_{\mathbf{L}}$, $w$ here $d^{0}$ is the spacing betw een $m$ oire planes. $W$ e estim ate that $d^{0} \quad a_{1} \quad P \overline{a_{0}=G_{0}}$. A $s$ in the Renn-Lubensky state [2], rationalm oire rotationswith angle $=2 \mathrm{~s}=\mathrm{t}$, where s and t are relatively prim e integers, would cause the B ragg rings to break up into $t$ spots spaced out around the ring, w ith additional structure along of .

The phase diagram in $F$ igure 1 sum $m$ arizes our conclusions. T he hexagonal colum nar phase is like the $M$ eissner phase of $T$ ype II superconductors. The two chiralcouplings and
${ }^{0}$ cause screw dislocations to penetrate the crystal above critical strengths $c$ and ${ }_{c}^{0}$, in m uch the sam ew ay as vortioes enter T ype II superconductors above the low er critical eld $H_{c 1}$. The TGB phase predicted here for chiralpolym ers is sim ilar to that already observed experim entally in chiral sm ectics [2]. The braided $m$ oire state is qualitatively new, and its experim ental observation would be of considerable interest. Surprising little is known about the intricate tra jectories produced by iterated $m$ oire $m$ aps show $n$ in $F$ igure 2. T hese could be studied experim entally via neutron di raction in hexagonal colum nar crystals with a dilute concentration of deuterated polym er strands. $N$ um erical studies of the local fractaldim ension and Lyapunov exponent are currently in progress.
