## Superconducting Coherence in a Vortex Line Liquid; Simulations with Finite

## Abstract

We carry out simulations of a lattice London superconductor in a magnetic eld B, with a nite magnetic penetration length. We not that superconducting coherence parallel to B persists into the vortex line liquid. We argue that the length scale relevant to this e ect is =  $^2_0$ =8  $T_m$ . 74.60 Ge, 64.60-i, 74.40.+ k

In high  $T_c$  superconductors, thermal uctuations are believed to melt the ground state vortex line lattice at temperatures well below the mean eld H  $_{c2}$  line [1,2]. The resulting vortex line liquid has received intense theoretical and experimental study. In particular, recent \ ux transformer" experiments [3,4] on YBCO show that superconducting coherence parallel to the applied magnetic eld B exists over very long length scales well into the vortex liquid.

To investigate the uctuating vortex line system, numerical simulations have been carried out. These have either involved a simplied model of vortex line interactions [5], or have used the approximation [6{8] that the bare magnetic penetration length ! 1, so that the magnetic eld B inside the superconductor is uniform. Such ! 1 simulations [8] show a sharp transition within the vortex line liquid, corresponding to the onset of coherence parallel to B. While this ! 1 model is suggested by the large values of = 0 in the high  $T_0$  materials, it may fail close to  $T_0$ , where the correlation length may exceed the nite bare; thus the nite model may display dierent critical behavior from the  $1 1 ext{limit}$ . To investigate this possibility, we present here new simulations of a system of uctuating vortex lines, in which we include the elect of magnetic screening on the vortex interactions [9], due to a nite  $1 ext{limit}$  we investigate the presence of superconducting coherence within the vortex line liquid, and discuss the length scale relevant for this elect.

Our model is a discretized lattice superconductor in the London lim it [10]. For sim plicity, we consider isotropic couplings. Following Carneiro et al. [7], a duality transformation maps this model onto one of interacting vortex lines, with Hamiltonian

Here n  $(r_i)$  ( = x, y, z) is the integer vorticity through plaquette at site  $r_i$  of a cubic m esh of points, and G (r) is the lattice London interaction, with Fourier transform

The coupling is  $J_0 = {2 \atop 0} = (16^{-3})^2$ , with 0 the ux quantum, and 0 the spacing of the discrete mesh, which we identify with the bare coherence length that determ ines the size of

a vortex core. Henceforth we measure lengths in units of  $_{0}$ , and temperature in units of  $J_{0}$ . Periodic boundary conditions in all directions are taken.

To test for superconducting coherence, we consider the helicity modulus (q) (where  $\theta$ ), defined as the linear response coefcient giving the supercurrent j induced by a transverse perturbation in the vector potential of the externally applied magnetic eld,  $A^{\text{ext}}(q)^{\wedge}$ ,

We have earlier derived [11] an expression for (q) in a continuum London superconductor. The generalization to the lattice superconductor is

where , , are a cyclic permutation of x, y, z, and  $Q^2 = 2$  2 cosq as q, q = 0.

In the absence of vortices,  $(q) = [J_0^2]Q^2 = (1 + {}^2Q^2)$  describes the total screening of the M eissner state. W ith vortices, an expansion in powers of  $Q^2$ ,

leads to an expression for (q) at small q, in terms of a renormalized coupling  $[J^2]_R$  and penetration length  $_R$ ,

To see the meaning of and  $_{\rm R}$ , note that the current j (q) produced by  ${\rm A}^{\rm ext}$  (q), induces a magnetic vector potential due to Ampere's Law, which in our units

is  $[J_0^2]Q^2$   $A^{\rm ind}(q) = j(q)$ . The change in the total magnetic eld due to the external perturbation is therefore given by  $A^{\rm tot}(q) = A^{\rm ind}(q) + A^{\rm ext}(q)$ , or

Thus a fraction 1 of  $A^{\rm ext}(q)$  penetrates into the material; the remaining fraction is screened out, on the length scale  $_{\rm R}$ . Equivalently,  $_{\rm R}$  is the length on which uctuations in magnetic eld decay to equilibrium. For a perfect M eissner elect,  $_{\rm R}$  = 1, and  $_{\rm R}$  agrees with the usual denition of the London penetration length [12]. We therefore interpret  $1=\frac{2}{R}$  as the density of superconducting electron pairs in direction  $^{\rm c}$ , even in the more general case of a partial M eissner elect in the mixed state. Although  $_{\rm R}$ 0 will have the same from Eq.(6) in both the superconducting and the normal metal state (with ordinary uctuation diamagnetism), a transition will be signaled some singularity in and  $_{\rm R}$ 0. We focus now on  $_{\rm R}$ 0.

Consider a uniform applied  $H = H \hat{z}$ .  $_x(q_y)$  and  $_y(q_z)$  then describe the response to external elds  $H_z(q_y)$  and  $H_x(q_z)$ , which represent compression and tilt perturbations of H, respectively. Correspondingly one nds [11]

where these susceptibilities are evaluated at the applied eld H. Since the high  $T_c$  m aterials display strong uctuation diam agnetism even in the normal state, it is unclear whether or not  $x_{N_c}$  will display a pronounced feature at the superconducting transition.

For behavior along 2 however, parallel to H , the criteria for a superconducting transition is more clearly dened.  $_z$  ( $q_x$ ), describes the response to an external eld  $H_y$  ( $q_x$ ), representing a combined shear and tilt perturbation of the uniform applied H 2. In Ref. [11] we showed that for the vortex line lattice one has  $_z$  = 1 and a perfect M eissner screening. For a normal vortex line liquid however,  $_z$  = 1  $dB_x$ = $dH_x$  1. Thus the transition to the normal state is signaled by a discontinuous jump in  $_z$  from unity. Expressed in terms of the expansion coecients of Eq.(5), we have superconducting coherence along the eld provided  $n_0$  = 0; for the normal state,  $n_0$  > 0.

For our M onte Carlo simulation, we start with a xed density f = B = 0 of straight vortex lines parallel to  $\hat{z}$ , giving the ground state con guration for an internal eld B  $\hat{z}$ . Following Cameiro et al. [7], we update the system, heating from the ground state, by adding elementary closed vortex rings (a square ring of unit area) with random orientation and position. These excitations are accepted or rejected according to the standard M etropolis algorithm. This provides a complete sampling of phase space for the vortex variables  $n(r_i)$ , subject to the constraints that vorticity is locally conserved, and the average internal eld,  $B = (0 = V)^P_i n(r_i) = f_0\hat{z}$ , is constant.

Our simulations are for the case f=1=15, whose ground state on a cubic mesh is a close approximation to a perfect triangular lattice. We choose =5, comparable to the vortex line spacing,  $a_v$   $1=\frac{p}{f}=3.87$ . We study system sizes  $L_2=30$  in the xy plane, and  $L_z=15$  and 30 parallel to H . Each data point is typically the result of 5;000 sweeps to equilibrate, followed by 8 16;000 sweeps to compute averages, where each sweep refers to  $L_2^2$   $L_z$  attempts to add an elementary vortex ring.

In Fig.1 we show a sample of our data, plotting  $hn_y(q_x)n_y(\ q)i$  vs.  $q_x$ , for various T, and  $L_z=30$ . Fitting to Eq.(5) through O (Q  $^4$ ) yields the solid curves, and determines the parameters  $n_0$  and  $n_1$ . Eq.(7) then gives the couplings , which we plot vs. T in Fig.2. We see that  $_{x,y}$  decrease towards zero at  $T_m$  ' 12, while  $_z$  decreases at  $T_c$  ' 2:0. We also show our results for  $L_z=15$ .

In Fig.3 we show intensity plots of vortex correlations within the same plane perpendicular to B,

where  $q_? = (q_x; q_y)$ , for various T, and  $L_z = 30$ . Below  $T_m$  we see sharp B ragg peaks of a vortex line lattice. Above  $T_m$  we see behavior characteristic of a liquid.  $T_m$  is thus the melting transition. Since the discrete mesh of our simulation acts like a periodic pinning potential for vortices,  $T_m$  also coincides with a depinning of the vortex lines. We believe that the drop in  $x_{Ty}$  at  $T_m$  is more a result of this depinning, rather than a direct result of

melting. We expect from Eq.(10) that  $x_{xy} = 1$   $dB_x = dH_x$  is nite above  $T_m$ , but this value is too small for us to determ ine accurately.

W ith respect to coherence along H , we expect a discontinuous jump in  $_z$  from unity to  $1 \ dB_x=dH_x \ 0$  at  $T_c$ . The nite width of the decrease observed in our data is a nite size e ect; we see that the transition sharpens as  $L_z$  increases. We therefore estimate  $T_c$  '2:0, well into the vortex line liquid. This is the main result of our simulations.

Recent ux transformer experiments on YBCO [3,4] show that there is a temperature  $\T_{th}$ " below which vortex line correlations parallel to H become comparable to the thickness of the sample.  $\T_{th}$ " is clearly above the  $\T_{irr}$ " where resistivity transverse to H vanishes. Resistivity parallel to H however appears [4] to vanish at  $\T_{th}$ ". A similar conclusion concerning vortex line correlations may be inferred from the measurements of Ref. [13], where the onset of pinning by twin grain boundaries is shown to occur distinctly above a sharp rst order melting transition. If we identify  $\T_{th}$ " with our  $\T_{c}$ , and  $\T_{irr}$ " with our  $\T_{m}$ , our results are in complete accord with these experimental indings.

We have also tried to compute the lengths  $^2_R$ , using Eq.(8) and our tted  $n_0$  and  $n_1$ . However the factor  $(n_1 \quad n_0 \quad ^2) =$  that appears in Eq.(8) is, in the region of the transition, the quotient of two small numbers each with large relative error. We were therefore unable to obtain meaningful results for  $_R$ .

Although we have simulated with  $L_z$ , one can still question whether our results represent the true therm odynam ic limit. In particular, in Refs. [3,4], it was found that  $T_{th}$  decreased towards  $T_{irr}$  as sample thickness  $L_z$  increased. This is also consistent with our results for z in Fig.2, where there is some suggestion that, in addition to a sharpening of the transition as  $L_z$  increases,  $T_c$  also decreases. It is therefore important to note that there is another length in the problem [2]

For our simulation, we have  $30 = L_z$  (T<sub>m</sub>) ' 410.

It has been argued [14] that determ ines the length on which phase correlations C (r)

he<sup>i[ (r) (0)]</sup>i decay in the vortex line lattice; however these same calculations show that in the vortex liquid, the decay length of C (r) is comparable to the spacing between vortex lines  $a_v = L_z$ . Thus this analysis of C (r) does not indicate why should be an important length above  $T_m$ , where we continue to see superconducting coherence.

A nother possibility is suggested by Nelson's analogy [1] between vortex lines and the imaginary time world lines of 2D bosons. Nelson argued that there should be a Kosterlitz-Thouless (KT) super uid transition of the analog bosons. For  $L_z$  su ciently large, this KT transition would occur at a  $T_c < T_m$ , and so would be pre-empted by the formation of the vortex line lattice. But for  $L_z$  small enough,  $T_c > T_m$ , and one has a new state intermediate between the vortex line lattice and the normal vortex line liquid [15]. We now restate our earlier calculation [11] of this  $T_c$  in order to show that the length which distinguishes between these two possibilities is  $(T_m)$ .

As shown by Pollock and Ceperley [16], the 2D boson super uid density can be expressed in terms of the \winding number" W which is the net spatial distance traveled by the ensemble of bosons as they travel down the time axis of their world lines. One has  $_{\rm s}^{\rm boson} = {\rm m} \, T_{\rm boson} \, hW^2 \, i = 2h^2$ . According to the KT theory, the 2D super uid transition occurs at a universal value of  $_{\rm s}^{\rm boson}$ , which translates into the condition  $hW_{\rm c}^2 \, i = 4 = 1$ . In terms of vortex lines, W just measures the net vorticity transverse to H [11]. We thus have [17]

This is precisely the same correlation as enters  $_z$ , and comparing with Eq.(7) we can write  $_z=1$  (  $(T)=L_z)hW_y^2i$ . Thus  $_s^{boson}$  /  $hW_z^2i=0$  implies  $_z=1$ ; the normal boson uid corresponds to a vortex line liquid with coherence along H .  $_s^{boson}>0$  implies  $_z<1$ ; the boson super uid corresponds to the normal vortex line liquid [18].

We have shown [11] that for a normal vortex line liquid,  $hn_y(q_x)n_y(q_x)i = f^2L_?^2L_zT=c_{44}(q_x)$ , where  $c_{44}(0)=(B^2=4)dH_x=dB_x$  is the tilt modulus, and f=B=0. Thus we conclude that  $hW^2i=hW_x^2+W_y^2i=2hW_y^2i=(8L_zT=\frac{2}{0})dB_x=dH_x$ . This yields

For large B  $H_{cl}$ ,  $dH_x=dB_x$  ' 1. Thus for  $L_z<(4=)$  ( $T_m$ ), one has  $T_c>T_m$  and hence a vortex line liquid with superconducting coherence along H , intermediate between the vortex line lattice, and the normal vortex line liquid. Only for  $L_z>(4=)$  ( $T_m$ ) will this intermediate state disappear [19]. For YBCO, with  $T_m$  ' 90 K, one has ( $T_m$ )' 1400 m, much thicker than the samples ( 50 m) in Refs. [3,4,13].

We note that for B  $H_{cl}$ ,  $(T_m)$  is a factor  $B=H_{cl}$  larger than the \entanglement" length originally proposed by Nelson [1] as the criterion for the 2D boson super uid transition. This is because the notion of super uidity, as measured by W, does not precisely correspond to the geometric notion of line entanglement. If just as many lines wander to the right as wander to the left, one has W=0, although the lines may still be quite twisted and geometrically entangled.

Finally, we note that for our model, Eqs.(12,14) would predict  $T_c = (8 \ J_0 = L_z)T_m$  ' 25, much higher than the observed  $T_c$  ' 2.0. We believe that this results from a breakdown of the boson analogy near our observed  $T_c$ , due to the proliferation of them ally excited closed vortex rings, and intersections between vortex lines, such as cause the transition in a B = 0 model. To conclude, we not from simulations with  $L_z$  ( $T_m$ ) (as is the case for recent experiments) that superconducting coherence parallel to H persists into the vortex line liquid state. We argue that this elect should vanish once ( $T_m$ )  $L_z$ .
