## Viscosity of Quantum Hall Fluids

#### A bstract

The viscosity of quantum uids with an energy gap at zero temperature is non-dissipative and is related to the adiabatic curvature on the space of at background metrics (which plays the role of the parameter space). For a quantum Hall uid on two dimensional tori this viscosity is computed. In this case the average viscosity is quantized and is proportional to the total magnetic ux through the torus.

C lassically, the elastic modulus and viscosity are tensors of rank 4, which relate the stress tensor T to the strain tensor e and strain-rate tensor  $\underline{e}$  [1]. In the lim it of small strain-rates

where d is the dimension of con guration space. The elastic modulus tensor  $= \frac{1}{2} \frac{\text{@T} (e;0)}{\text{@e}} \text{ is symmetric in all its indices. Classical Newtonian uids [2]}$ 

o er no resistance to shear; so, all shear modes are soft and has rank one.

The term  $^{P}$   $\underline{e}$  in Eq. (1) is the viscosity stress tensor [2]. For New tonian uids, T and  $\underline{e}$  are sym m etric tensors, and consequently, = = [1, 3]. W ith respect to substitution of indices ( ) 7 ( ), the viscosity tensor splits into sym m etric and anti-sym m etric parts, =  $^{S}$  +  $^{A}$ , where

The symmetric part, being associated with dissipation, is a denite quadratic form on the space of 2-tensors (strain-rates). If a uid is isotropic, then

$$S = + ; (3)$$

where and are the two viscosity constants [2]. If the uid is also incompressible, may be put to zero with no loss. This is the normal situation in Newtonian uid mechanics. The anti-symmetric part of the viscosity tensor describes non-dissipative response. One normally assumes that it is absent because of no compelling evidence to think otherwise.

Quantum uids can have a ground state which is separated by a nite gap from the rest of the spectrum. At zero tem perature such a uid will have a non-dissipative

response, with  $^{S} = 0$ . The anti-sym m etric part  $^{A}$  m ay or m ay not vanish at zero tem perature. For instance,  $^{A}$  vanishes for systems with time reversal sym m etry (and this m ay be viewed as a consequence of 0 nsager relation [4]).

Quantum uids with energy gap and broken time reversal symmetry will, in general, have A 6 0 at zero temperature. A quantum Hall uid with a full Landau level gives such an example. The viscosity tensor at low temperature could then be dominated by the non-dissipative part A. The study of the non-dissipative viscosity bears analogies with the Quantum Halle ect [5], the Magnus force in superconductors [6], and even with gravity [7]. Like the Hall conductance, and the Magnus force, the (non-dissipative) viscosity is related to the adiabatic curvature [8] and to topological invariants [9]. The connection with gravity comes about because the adiabatic curvature relevant for viscosity is a 2-form on the space parameterizing at background metrics. In other words, the viscosity stress tensor can be viewed as describing the response of the system to certain adiabatic deformations of the metric.

Let us rst recall a general fact from the theory of adiabatic response [10]. Consider a fam ily of H am iltonians H (X) which depend smoothly on a set of parameters  $X = fX_1; \ldots; X_n g$  (X denotes a point in parameter space while x denotes a point in con guration space). Let j (X) i be a (normalized) non-degenerate state of H (X), with energy E (X). Let X (t) be a path in parameter space which is traversed adiabatically; X— is the velocity along the path. We assume throughout that the state stays non-degenerate along the path.

By the principle of virtual work,  $\frac{H}{X}$  is the observable corresponding to the generalized force related to X [11]. A diabatic response theory says that, in the

adiabatic lim it,

where  $_{ij}$  is the (anti-sym m etric) adiabatic curvature [8]:

If H is time reversal invariant, then  $_{ij} = 0$  [8]. The anti-symmetry of implies no dissipation: there is no change in energy if the system is taken along a closed loop in parameter space.

In the special case where j i is a (norm alized) multiparticle state corresponding to N non-interacting ferm ions in the single particle (norm alized) states j' i with energies E  $\cdot$  (X ) (all depending sm oothly on parameter X ) one has

To apply all this to viscosity one needs to identify appropriate parameters so that  $\frac{\theta H}{\theta X_j}$  is related to the energy-m omentum tensor and X— to the rate of strain. We shall argue that this is done by at metrics (metrics with constant coe cients).

Consider a uid con ned to a given domain in d dimensional Euclidean space. The planar parallelogram shown in Fig. 1 is an example for d = 2. A uniform deformation is represented by the (symmetric) tensor of constant strain [1]

where  $x^0$  is a linear transform ation of x. In two dimensions the deformation space of at metrics is three dimensional. A two dimensional subspace is associated with transformations that preserve the volume, and the transverse direction may be associated with scaling.

One can view deform ations as changing the domain while keeping the underlying Euclidean metric xed. An equivalent point of view is to consider a deform ation of the metric, while keeping the domain xed with g = I + 2e [1]. The deformed metric is not Euclidean in general but always has constant coe cients and therefore at. Convenient coordinates on the corresponding parameter space will be introduced later.

Let H (g) denote the Ham iltonian on a domain D in d-dimensional space associated with metric tensor g with constant coe cients g viewed as external parameters. By the principle of virtual work [11],  $\frac{H}{e} = 2 \frac{H}{g}$  is the observable associated with total stress tensor,  $\frac{R}{D}$  T (x) dvol(x). (The total stress has dimension of energy, while the stress has the dimension of pressure). For example, for a free particle of mass m in D the kinetic energy is

and the total stress is the observable

This is rem in iscent of general relativity where the (local) energy-m om entum tensor is related to the variation of the action due to (local) deform ation of the metric.

A diabatic deform ations of the strain give the quantum version of Eq. (1):

The elastic modulus tensor  $=\frac{1}{2}\frac{e^2E}{eee}$  is manifestly symmetric in all its indices. The adiabatic curvature plays here the role of non-dissipative viscosity. For hom ogeneous uids the viscosity tensor and the adiabatic curvature are related by

where V is the volume of the uid. The adiabatic curvature has units of Planck constant h. This is analogous to the situation in the quantum Halle ect where the adiabatic curvature (= conductance) has units of  $e^2$ =h.

Let us illustrate these ideas on a concrete example. Consider two dimensional Quantum Hall uid on a torus, such as in Fig.1, with opposite sides identified. Explicitly, let Q be the unit square in configuration space: (x;y) = 0, (x;y)

The Landau Ham iltonian describes the kinetic energy of a charged (spinless) particle in a constant magnetic eld, and Aharonov-Bohm gauge elds. It is given by

where  $D_x = iQ_x + 2$  (By + 1 + B=2),  $D_y = iQ_y + 2$  (2 + B=2); 1 and 2 are associated with two Aharonov-Bohm uxes, and the integer B is the number of magnetic ux quanta through torus. (Note that in our units 1 is the unit of quantum ux, hc=e.) We impose the usual magnetic translation boundary conditions [12]:

The (single particle) ground state is B-fold degenerate with energy E=2 B=V independent of and . The ground state of a full Landau level has energy E=2 B<sup>2</sup>=V and is separated by a gap from the rest of the spectrum. (For a non-relativistic spinning electron, described by Pauli equation, one has E=0). It follows

from Eq. (10) that the only non-zero component of the elastic modulus tensor is  $_{\rm V\,V}=2$  B  $^2={\rm V\,^3}$  corresponding to nite compressibility. All other components of vanish, as they should, for a uid; the two shearmodes are soft.

An orthonormal, smooth, family of single particle states that span the lowest Landau level is in fact given by theta functions [13]:

where  $y = y + '=B + _1=B + 1=2$  and '= 0;:::;B 1.

A little computation shows that the component of the adiabatic curvature in Eq. (6), which corresponds to the 'th state, is:

(cf. [14]). The basic equations of transport (the main result of this letter) follow from Eqs. (6,10) and (16):

There is a single transport coe cient related to viscosity and it is  $B = \begin{pmatrix} 4 & 2 \\ 2 \end{pmatrix}$ . The interpretation of this result is as follows. Consider two dimensional Hall uid on a surface of a cylinder. Compressing it in the radial direction (or in the axial direction) results in a twist rate of one boundary circle relative to the other. And vice versa: a shear of the two boundary circles results in a compression rate of the radial direction and stretching rate of the axial direction.

It may be instructive to compare these transport equations, Eq. (17), with the transport equations for the Hall conductance for Landau levels on the torus. These too follow from Eqs. (4) and (16). Namely,

The generalized force in this case is the current operator  $\frac{\text{@H}}{\text{@}}$ , and the generalized velocity — is the electrom otive force. By Eq. (18) the conductance of a full Landau level is 2 in our units and  $\text{e}^2$ =h in ordinary units.

Comparing the conductance and viscosity one sees that the viscosity increases linearly with magnetic eld, while the conductance is independent of it, and that the conductance is constant on the ux space while the viscosity is  $_2$ -dependent.

To appreciate the geometric signi cance of Eq. (17) we will look at the space of parameters (V; ; ) m ore thoroughly. The modular group SL (2; Z) acts naturally on this parameter space as a sym metry group of the family of Landau Hamiltonians H (V; ; ), Eq. (13). To describe this action explicitly let us note rst that an element M =  $\frac{B}{A}$   $\frac{a}{A}$  2 SL (2; Z) provides an isometry between metrics g (V; ) c d and g (V;  $\frac{a}{A}$ ) with  $\frac{a}{A}$  =  $\frac{a+b}{c+d}$  by the formula

We can therefore consider M as a unitary operator in the Hilbert space. Then operator M H (V; ; ) M  $^1$  coincides up to a gauge transform ation with H (V;  $^0$ ;  $^0$ ), where

The last form ula shows, in particular, that the family of Landau Hamiltonians H (V; ;0) is SL (2; Z)—invariant and the corresponding parameter space is nothing else but the moduli space of elliptic curves. It is a 2—sphere with two conical points and one puncture. It can be conveniently represented by the fundamental domain of SL (2; Z)—action on the upper half plane of complex variable , Fig. 2 [13]. It coincides with the parameter space of at metrics on a torus of xed area. This is

an analog of the Aharonov-Bohm ux torus in the theory of Hall conductance.

The geometric signi cance of the viscosity in Eq. (17) is now apparent: the rst term in Eq. (16) is the invariant area form on the upper half plane of complex variable. Similar to the Hall conductance, which is constant in the ux space, the viscosity is proportional to the area form in the moduli space of elliptic curves.

In the Halle ect, the conductance is associated with a topological invariant – Chem number, which is an integer. This integer comes from integrating the curvature over parameter space. In the case of Eq. (18) this integer is 1. For the viscosity the situation is almost the same. Integration of the adiabatic curvature over the moduli space (or fundamental domain F of the group SL (2; Z)) gives

where we have used the fact that the area of the fundam entaldom ain is =3. Though not an integer in general, this is still a topological invariant -Chern number (in the orbifold sense) of the ground state bundle on the parameter space. (It is not an integer because the parameter space is not a smooth compact manifold in this case).
